The ornamental design for a tarot card reading cloth, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a tarot card reading cloth showing the new design;

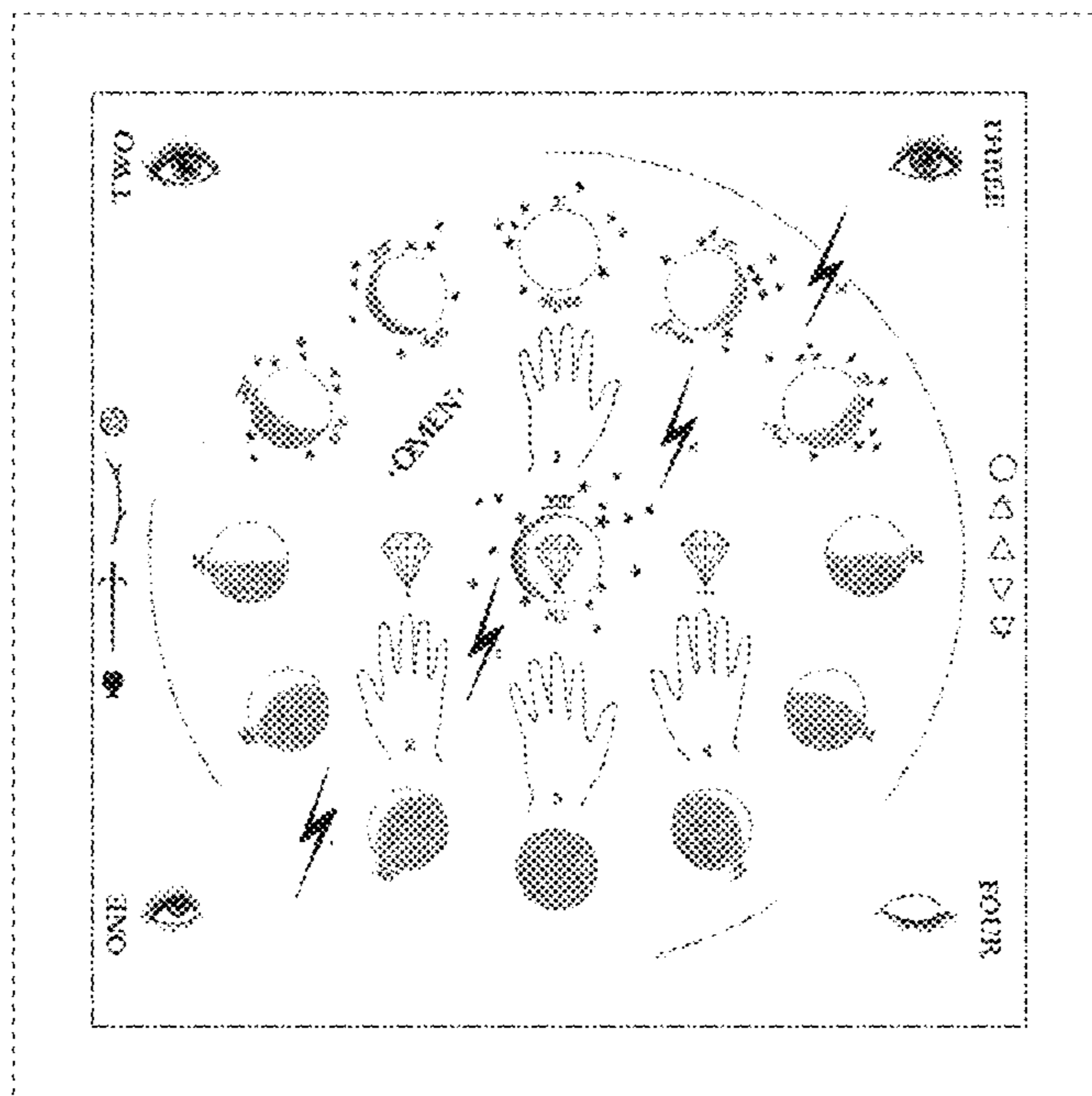

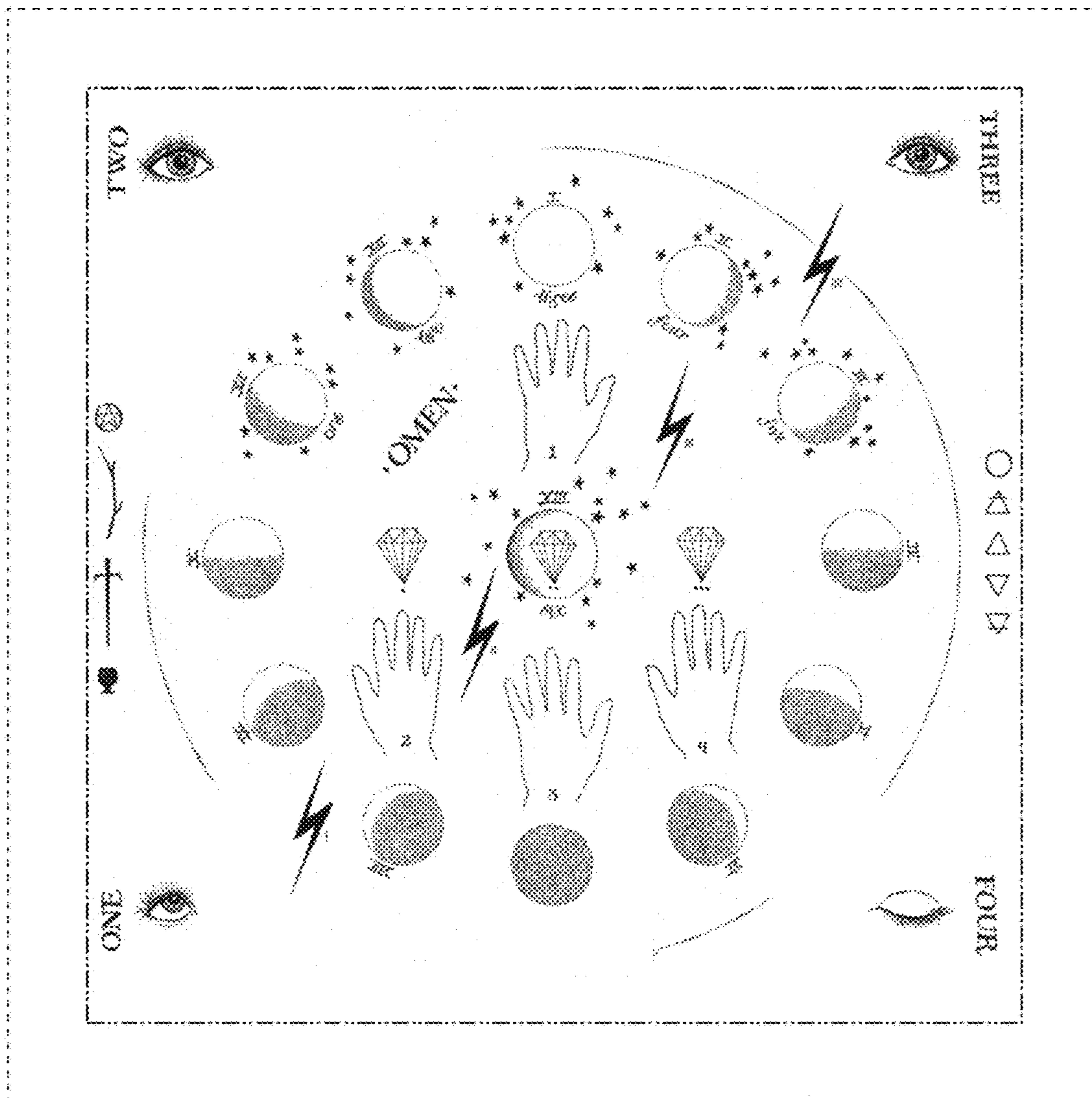
