**DESCRIPTION**

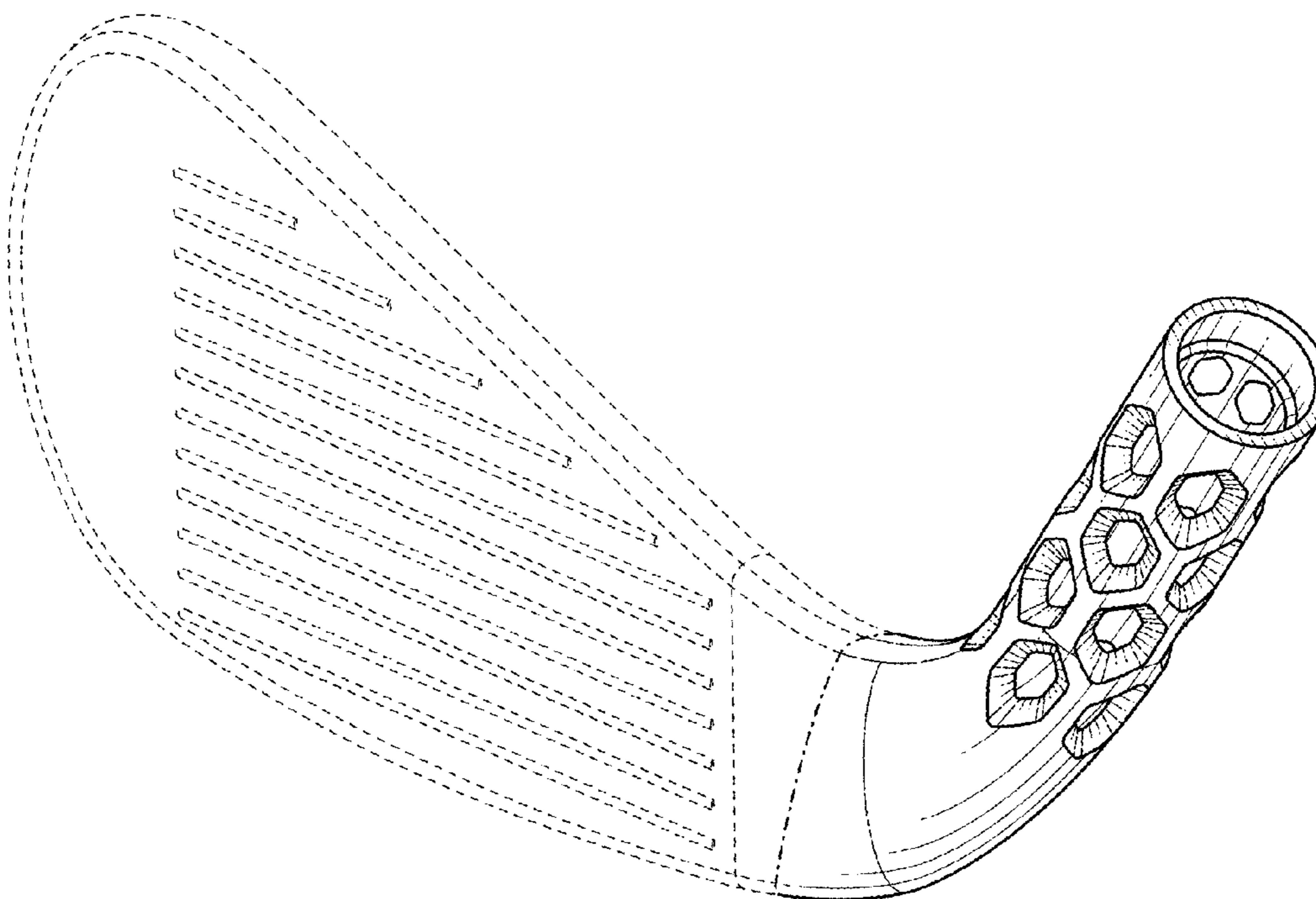
FIG. 1 is a front perspective view of a first embodiment of the golf club hosel as claimed herein;

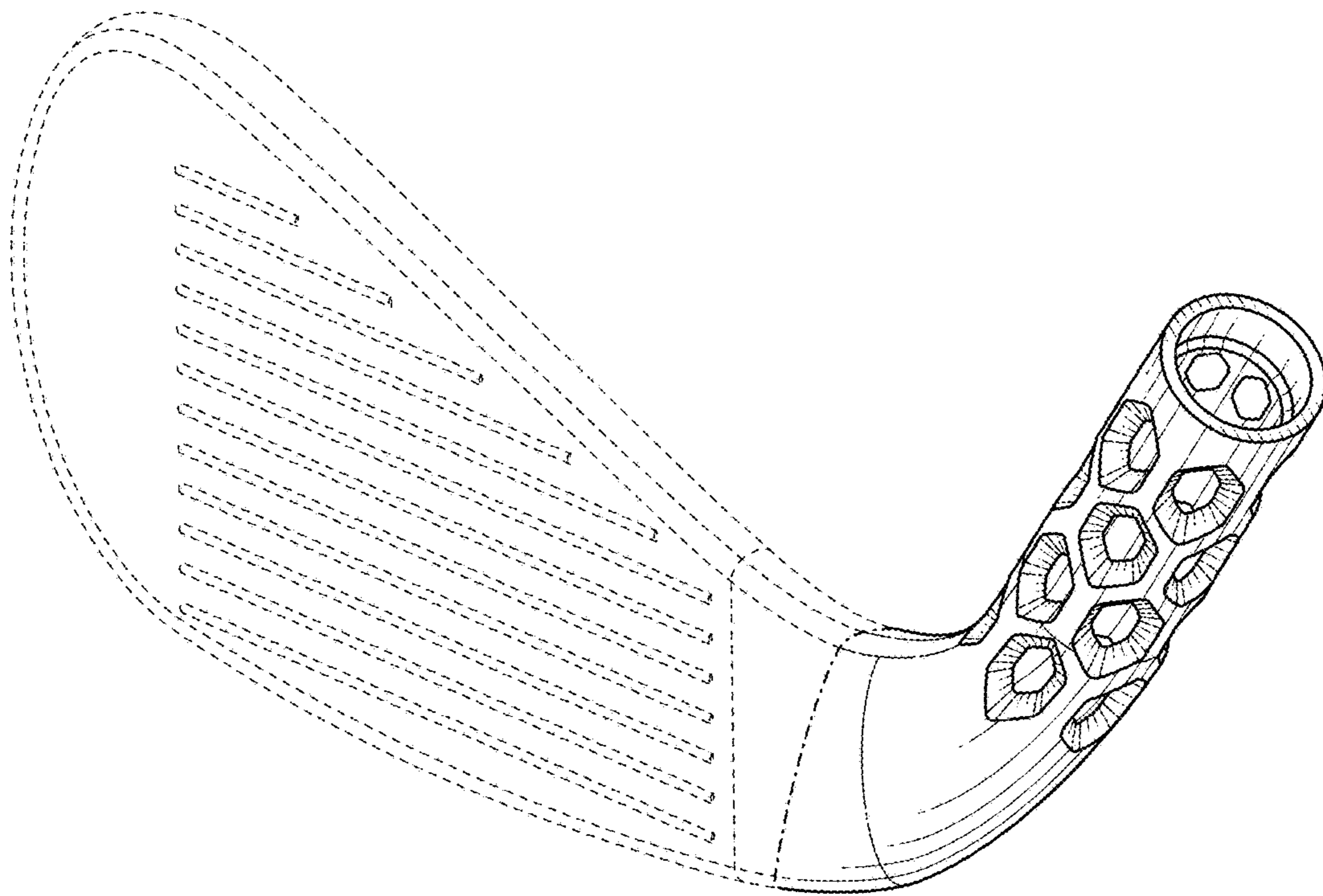

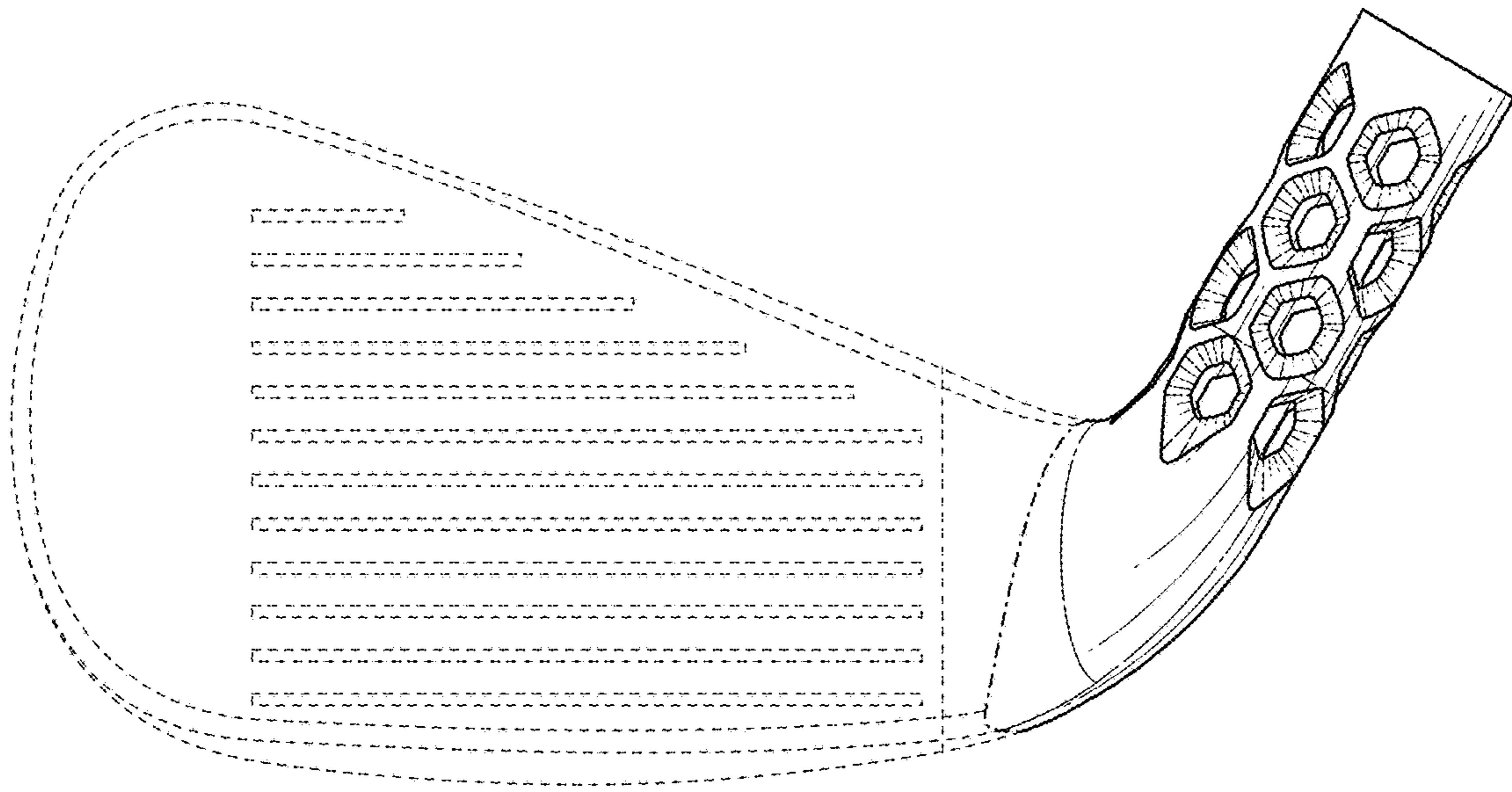

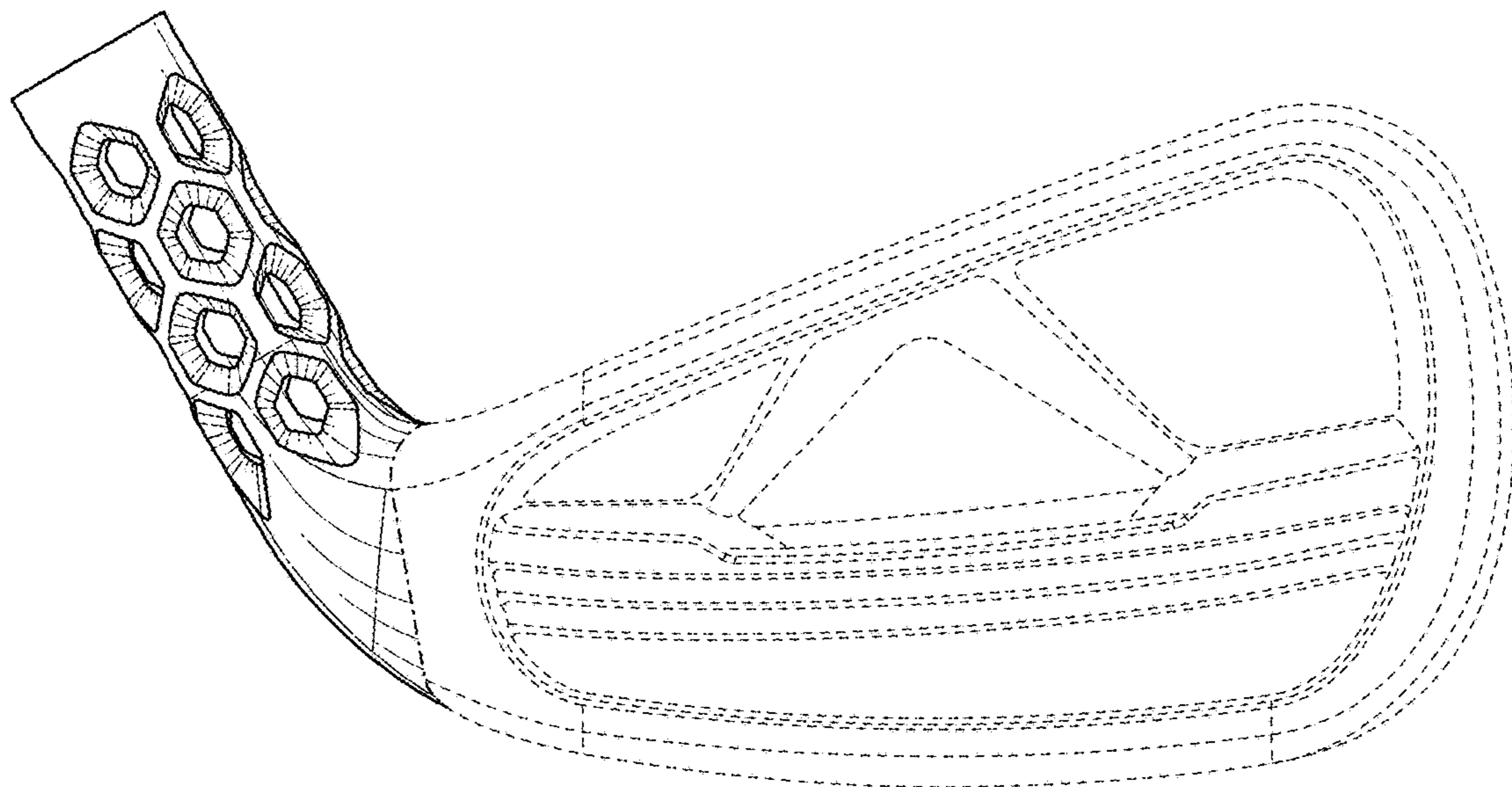

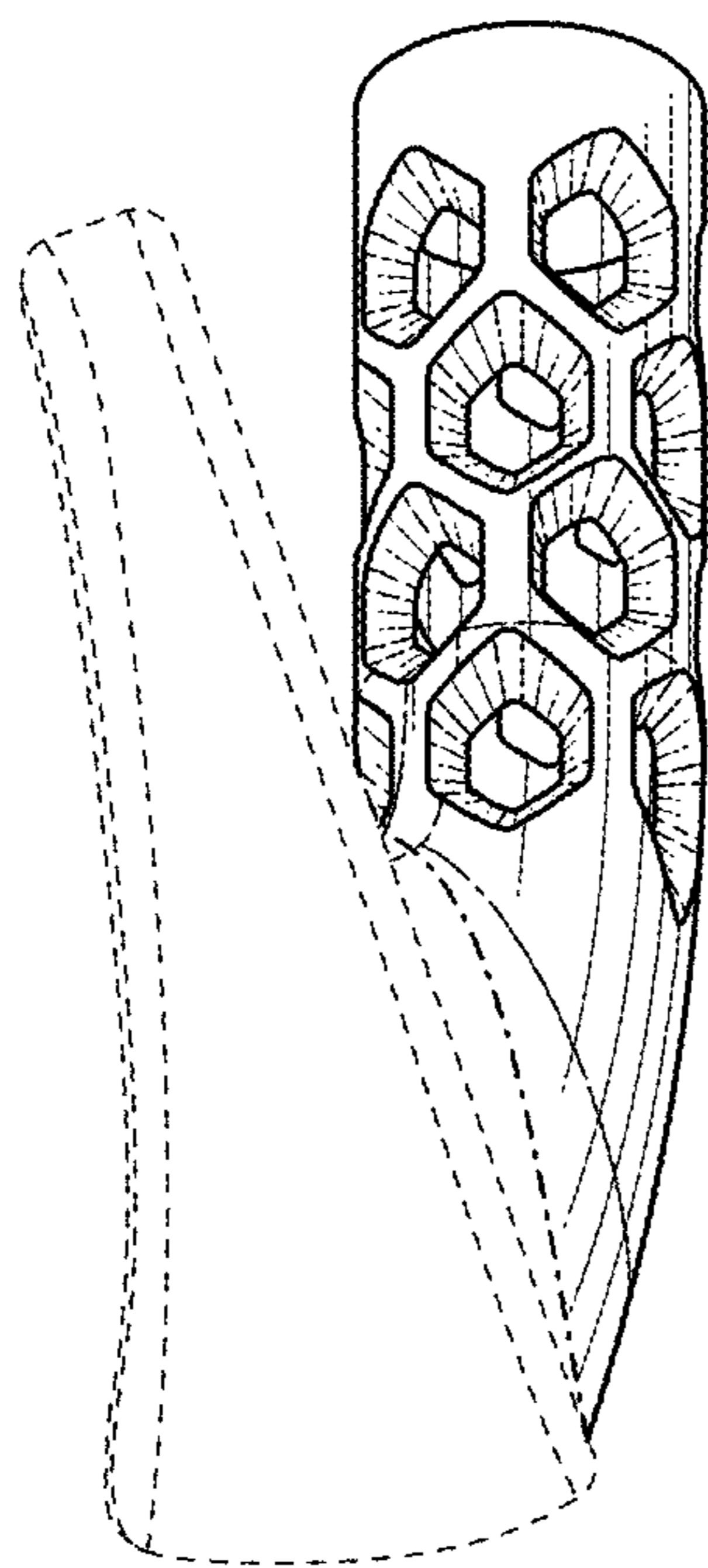

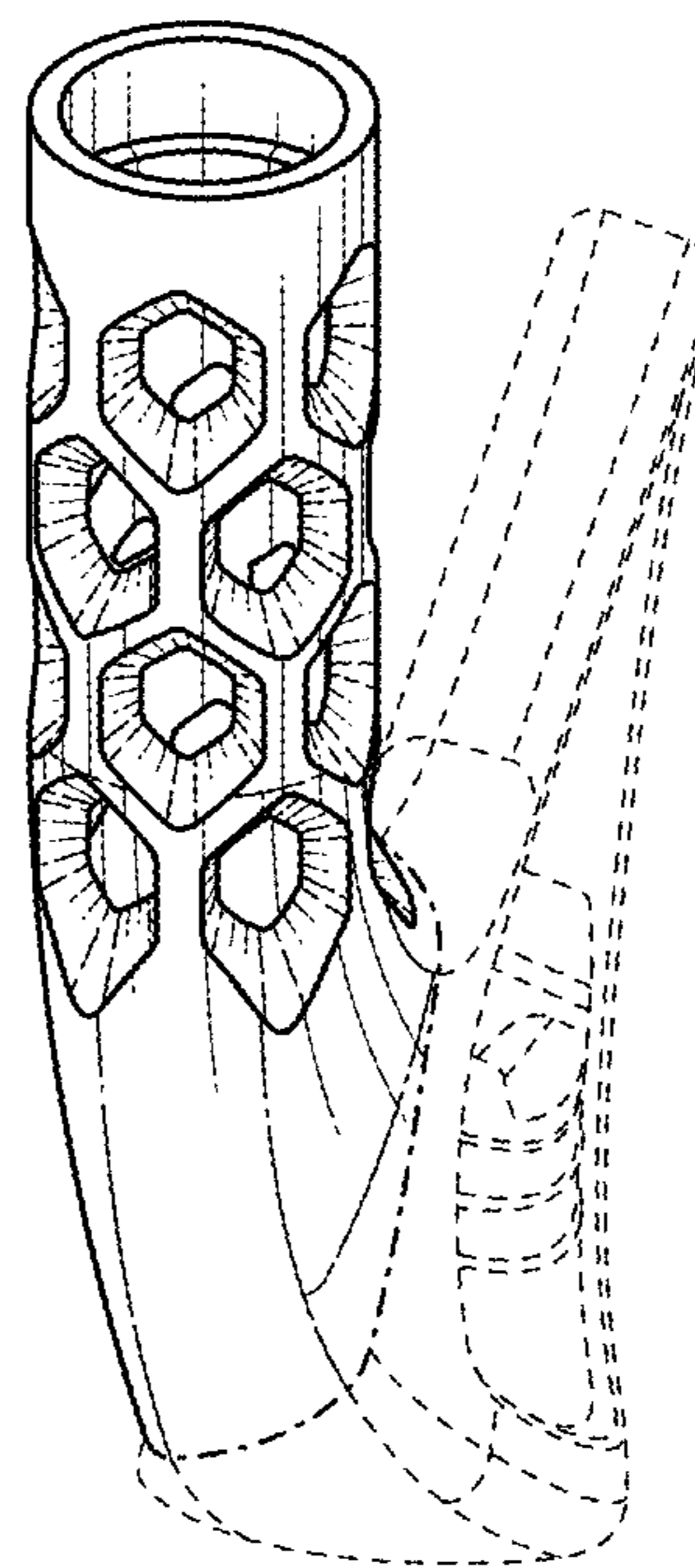

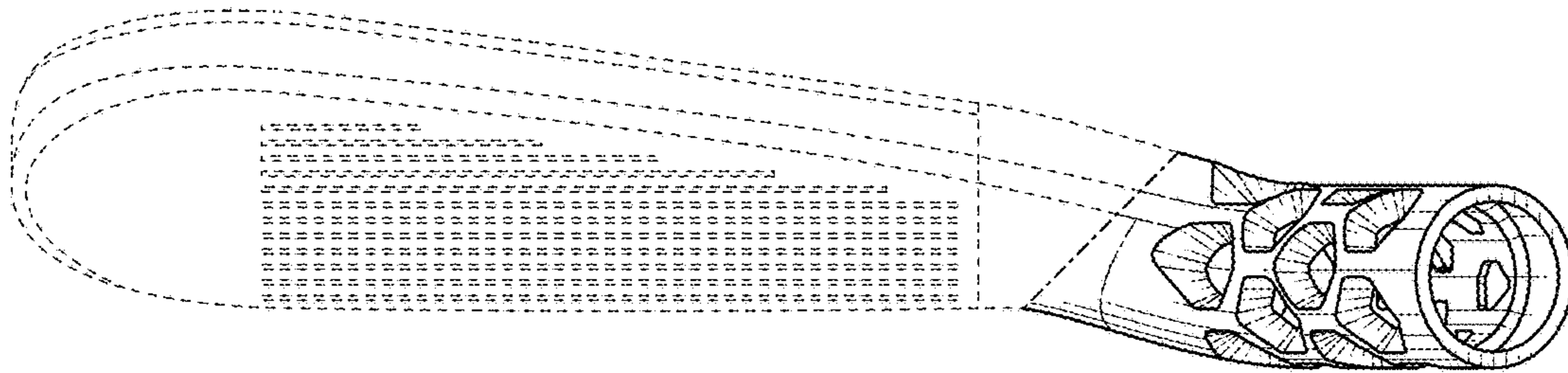

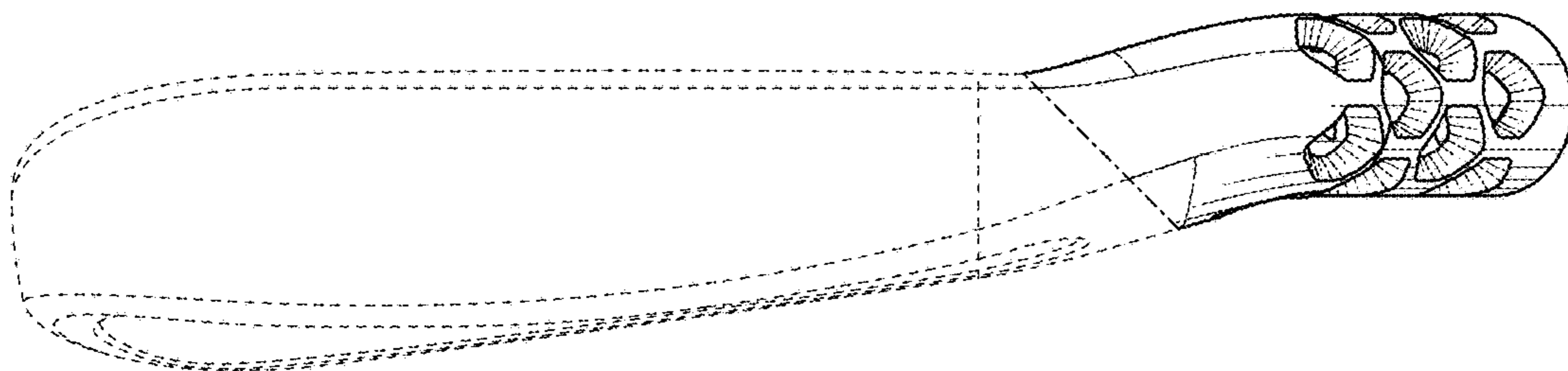
