(57) **CLAIM**

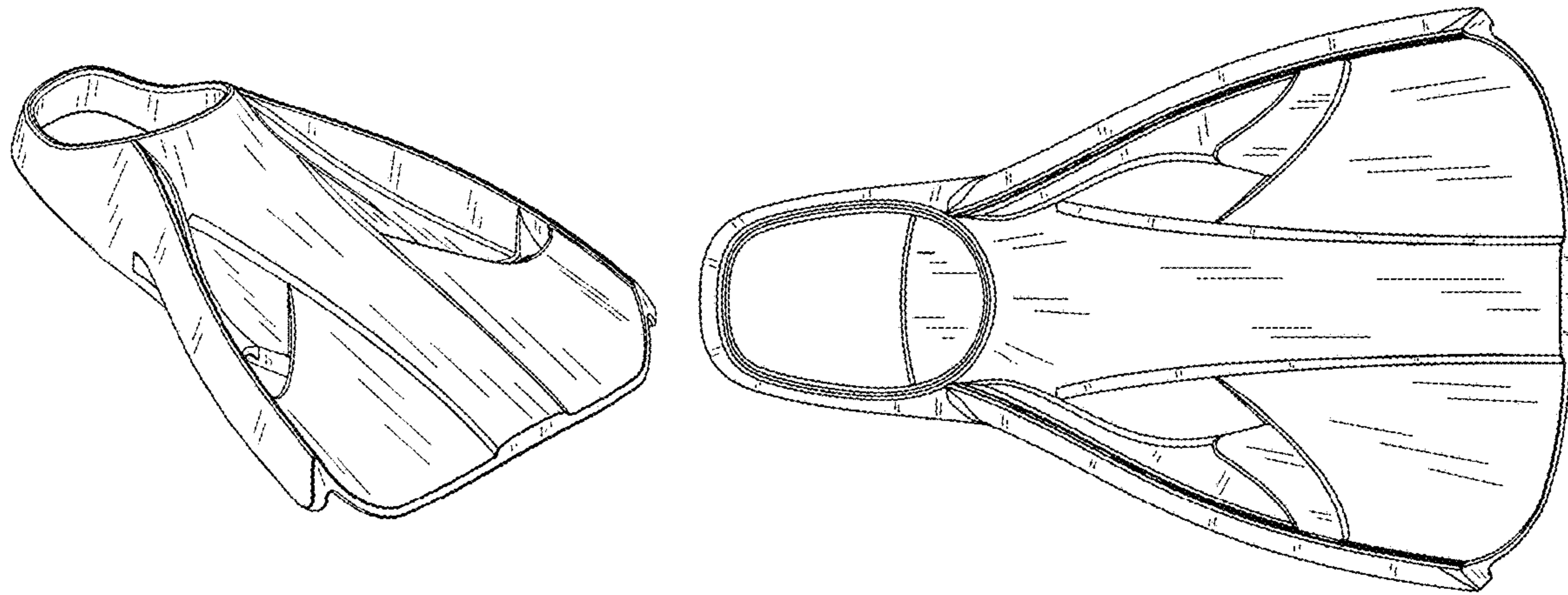
We claim the ornamental design for a swim and scuba fin, as shown and described.

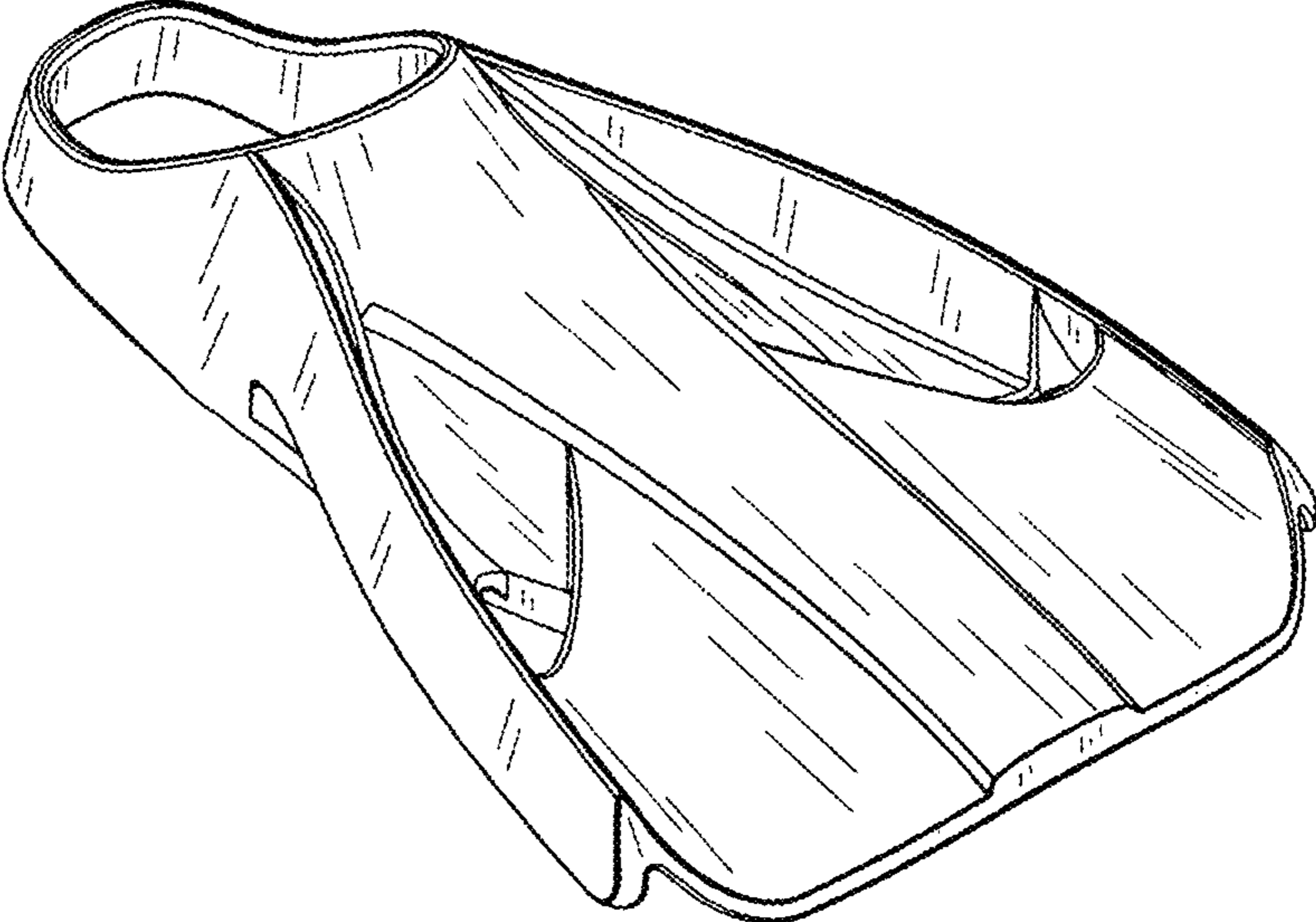

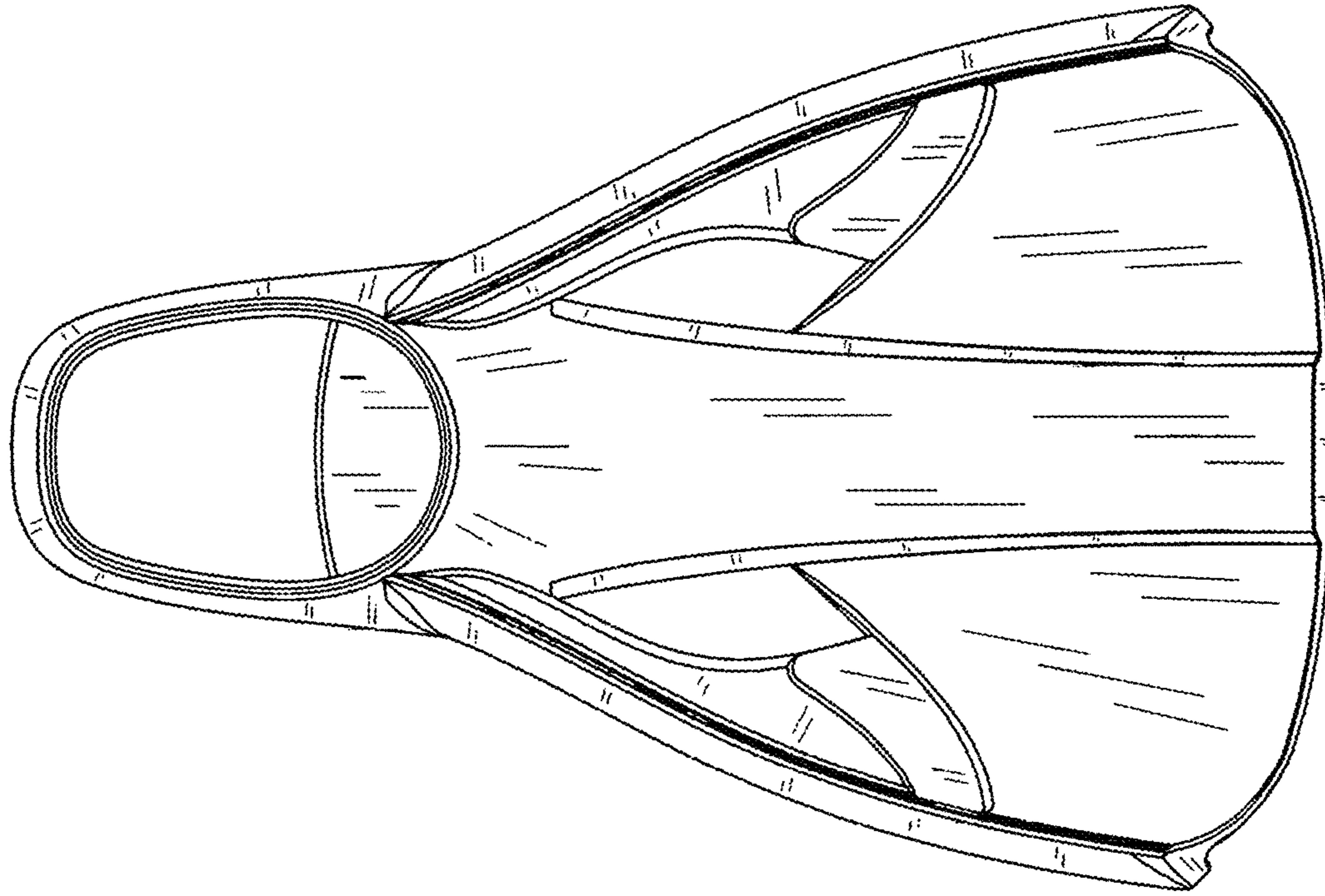

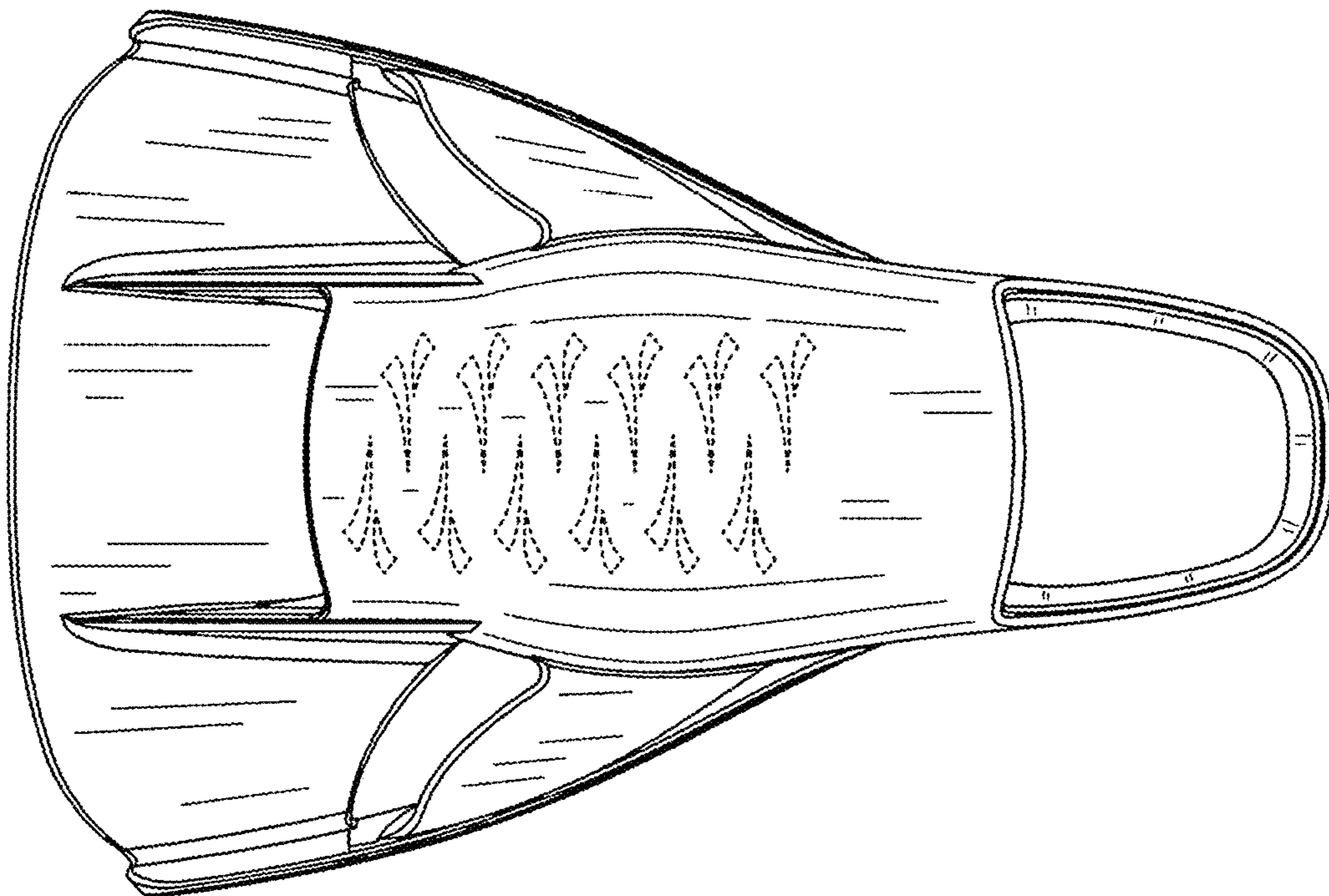

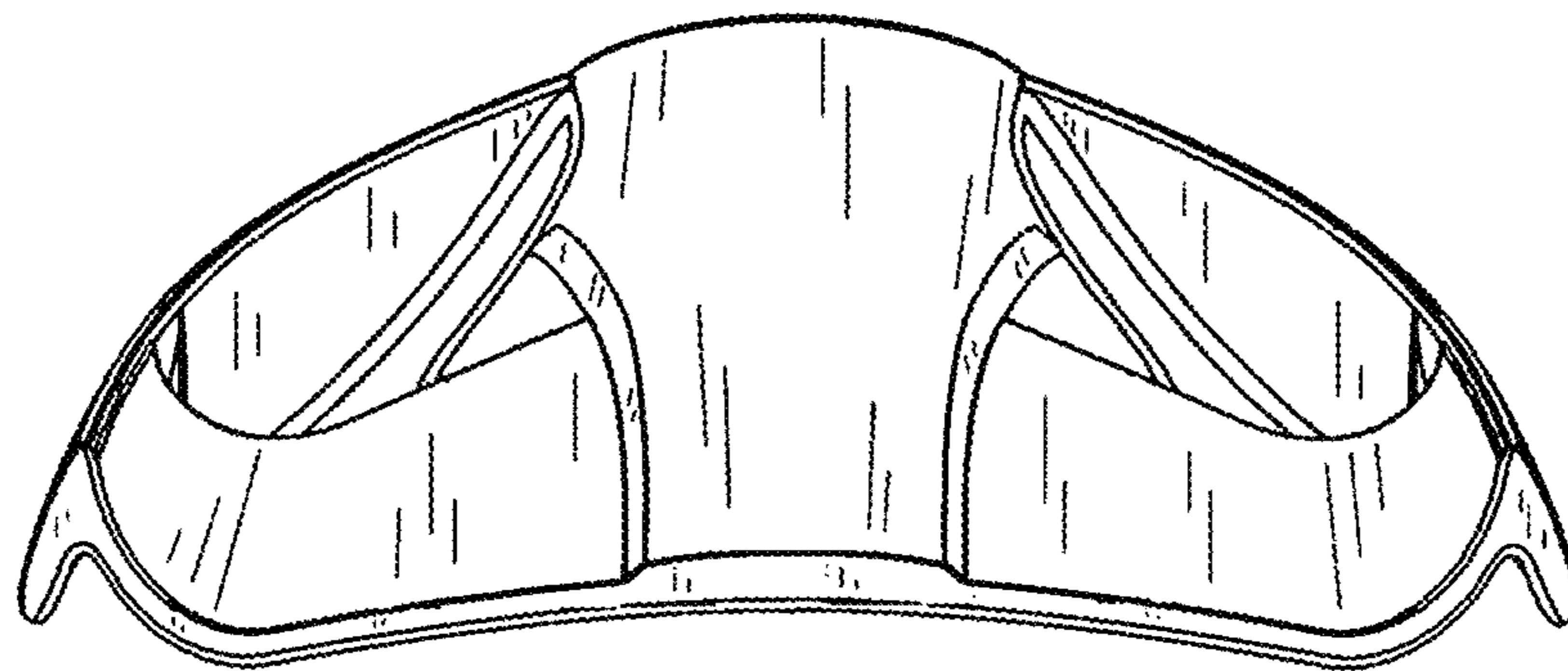

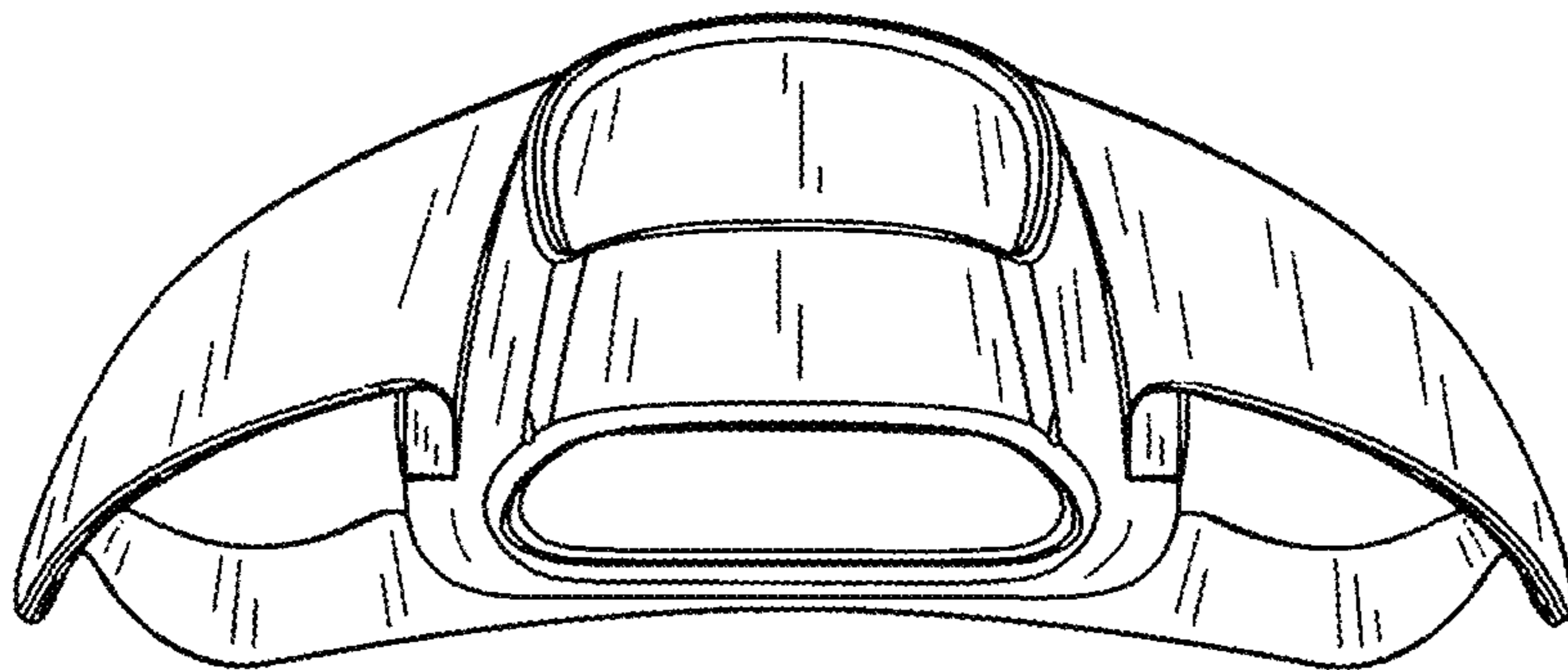

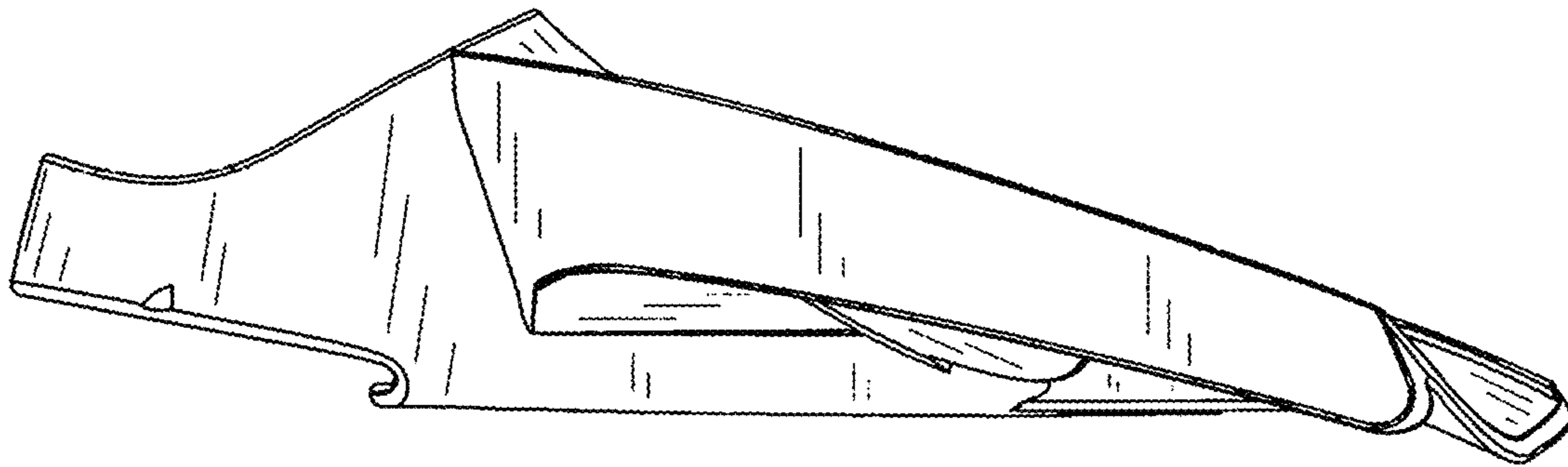

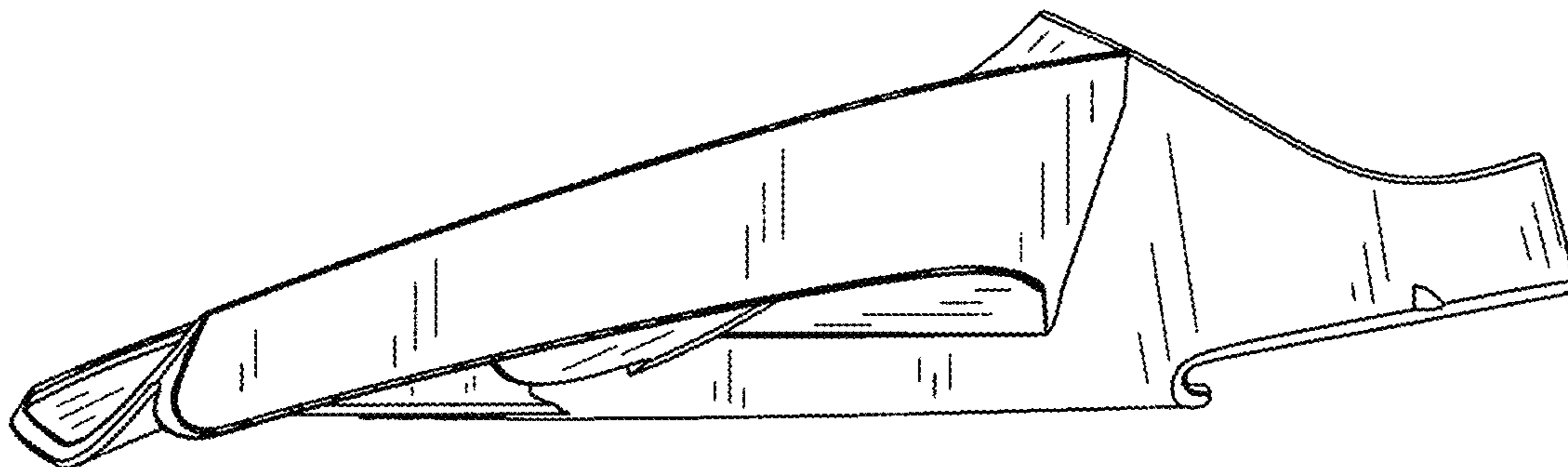
