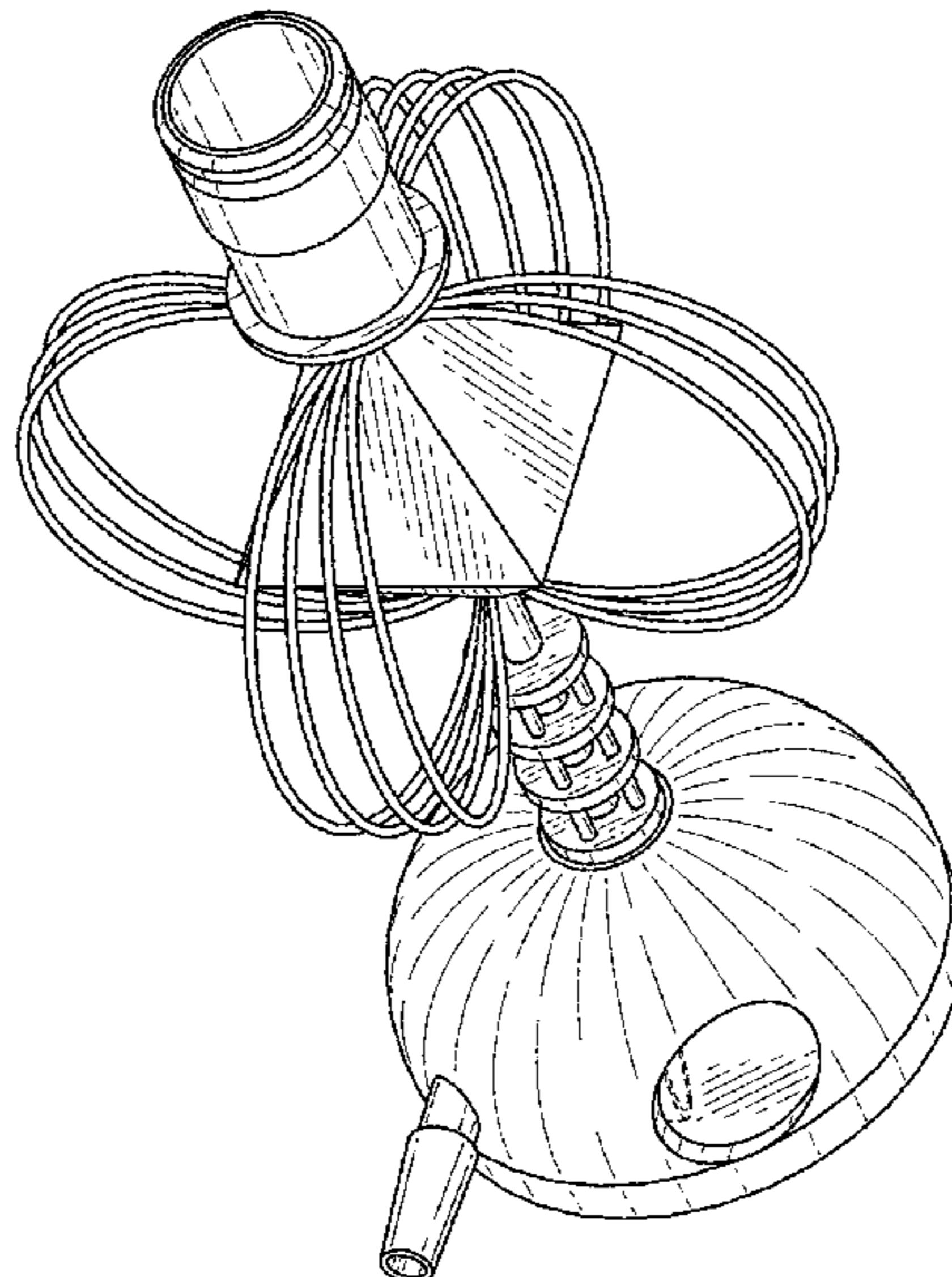
(57) **CLAIM**

I claim the ornamental design for a visual flow indicator rotating nebulizer, as shown and described.

DESCRIPTION

FIG. 1 is a rear view of the visual flow indicator rotating nebulizer
FIG. 2 is a left side view of the visual flow indicator rotating nebulizer
FIG. 3 is a front view of the visual flow indicator rotating nebulizer
FIG. 4 is a right side view of the visual flow indicator rotating nebulizer
FIG. 5 is a top perspective view of the visual flow indicator rotating nebulizer; and,
FIG. 6 is a bottom perspective view of the visual flow indicator rotating nebulizer.
The broken lines in the drawings illustrate portions of the visual flow indicator rotating nebulizer that form no part of the claimed design.

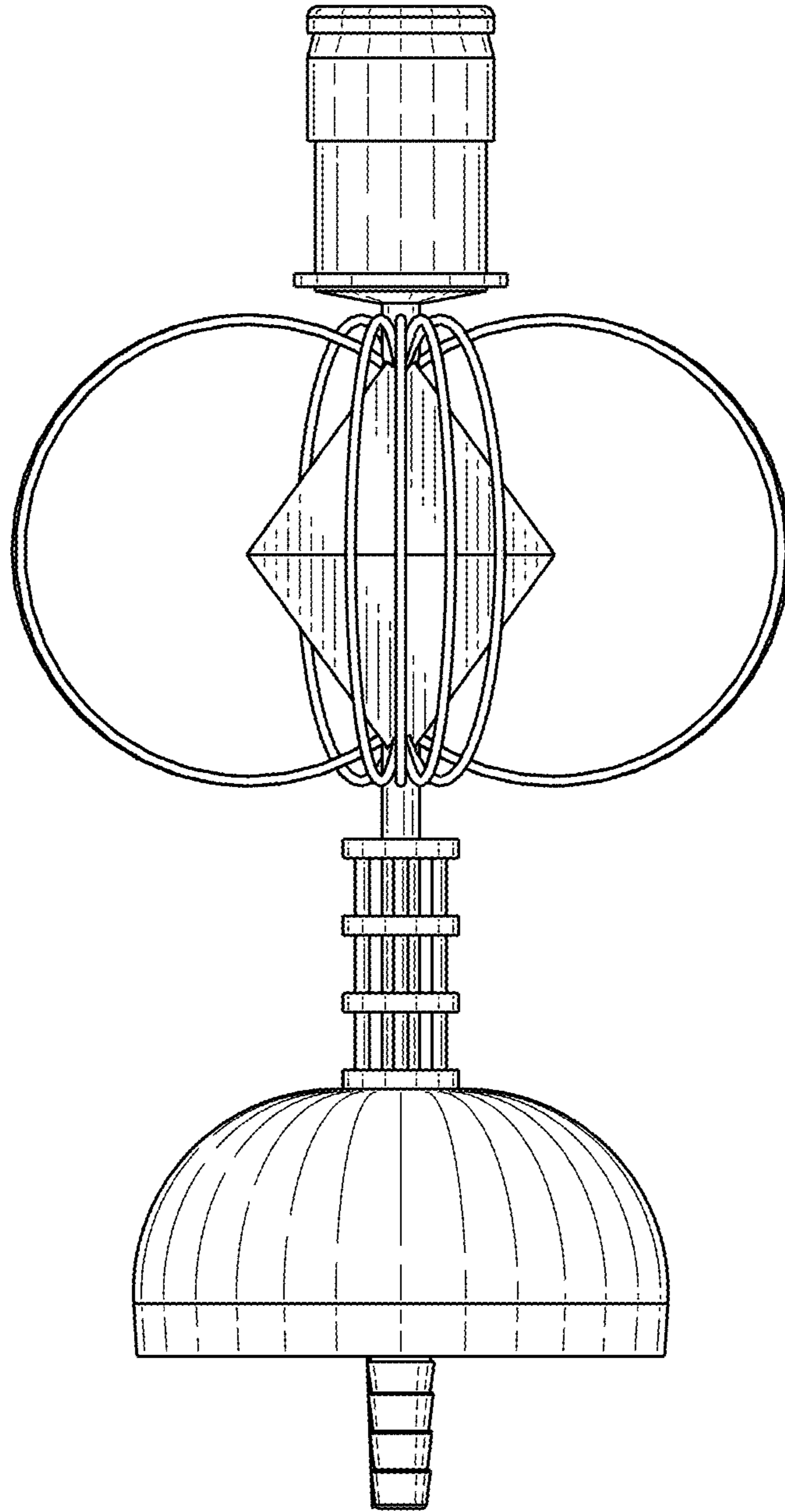

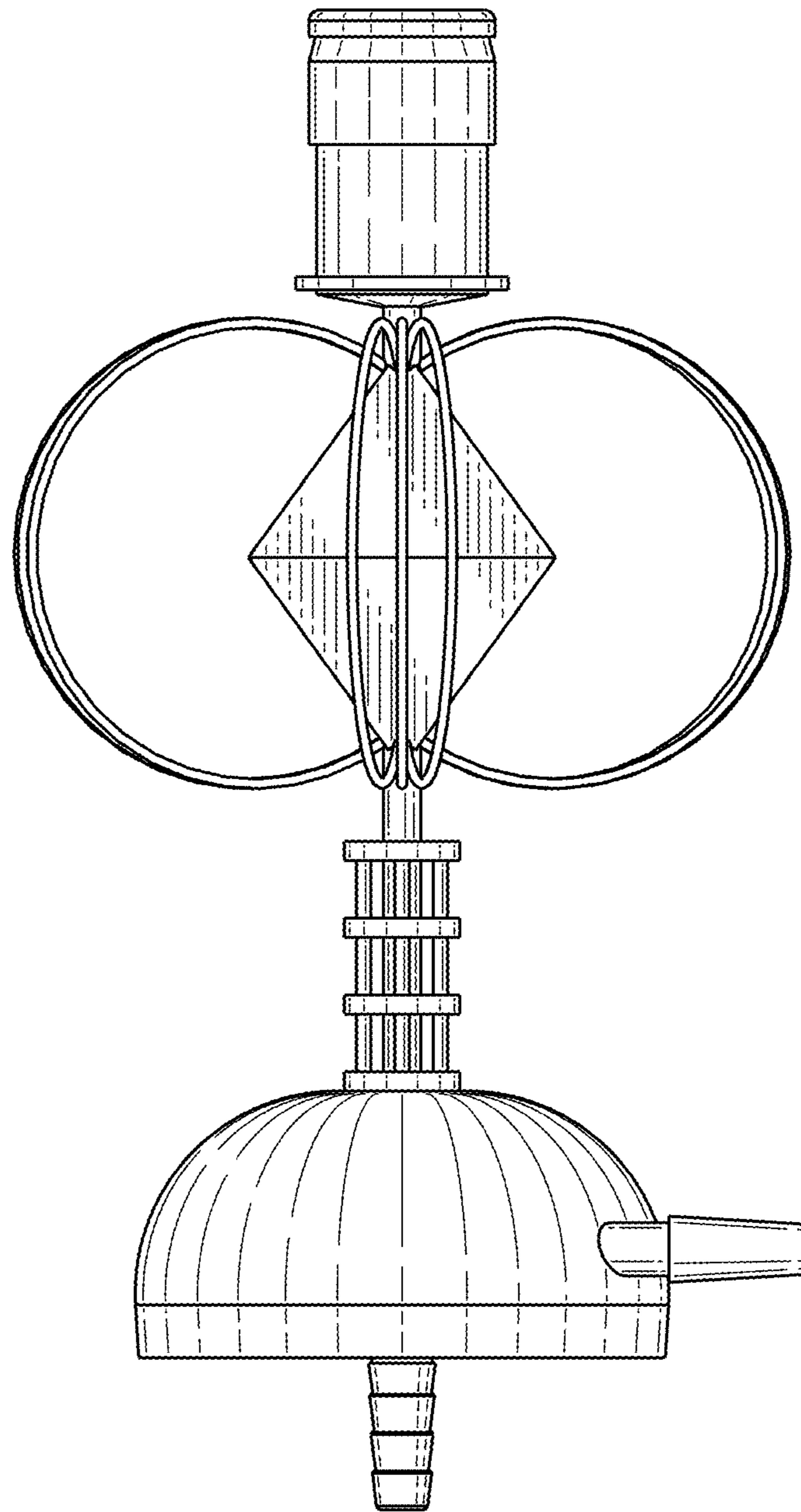

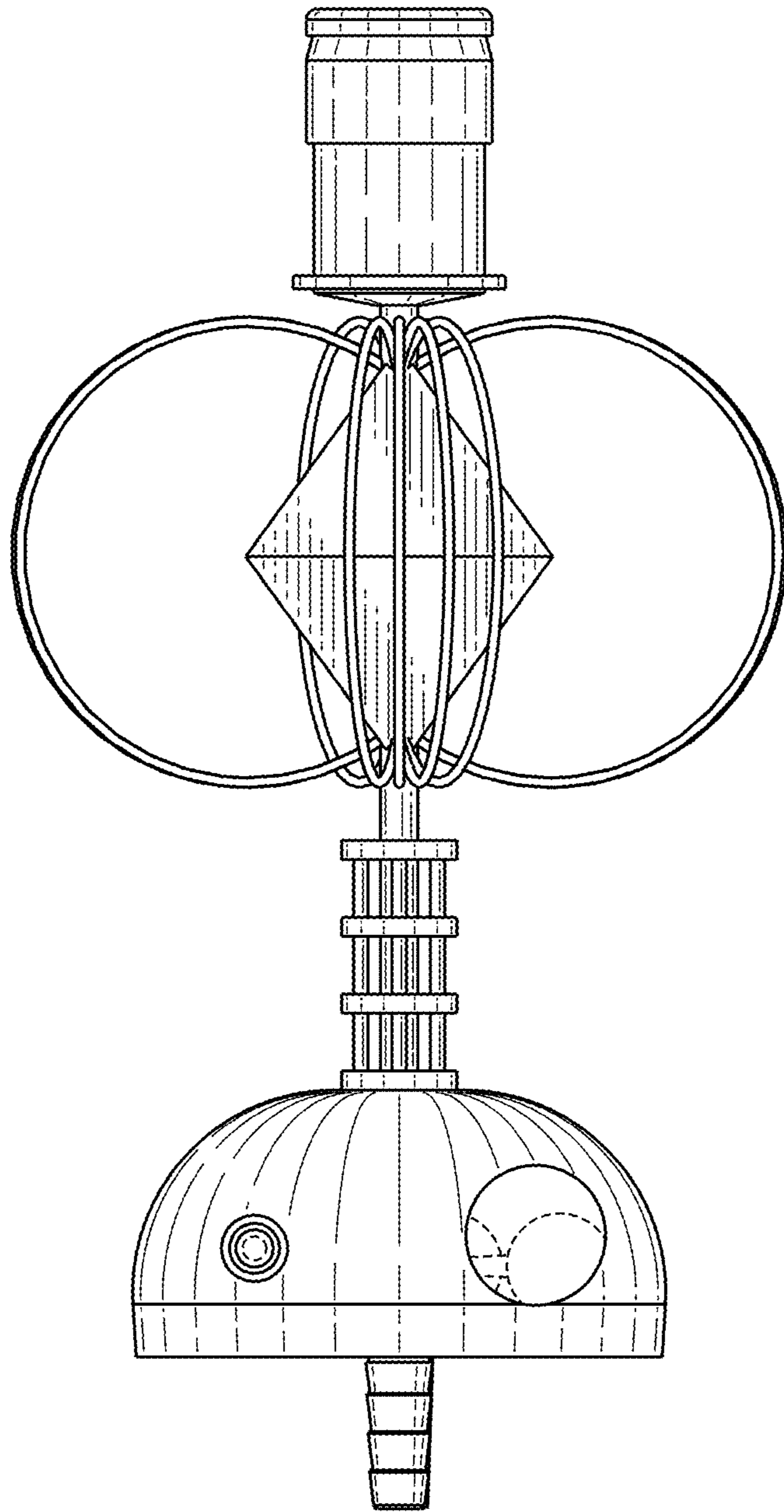

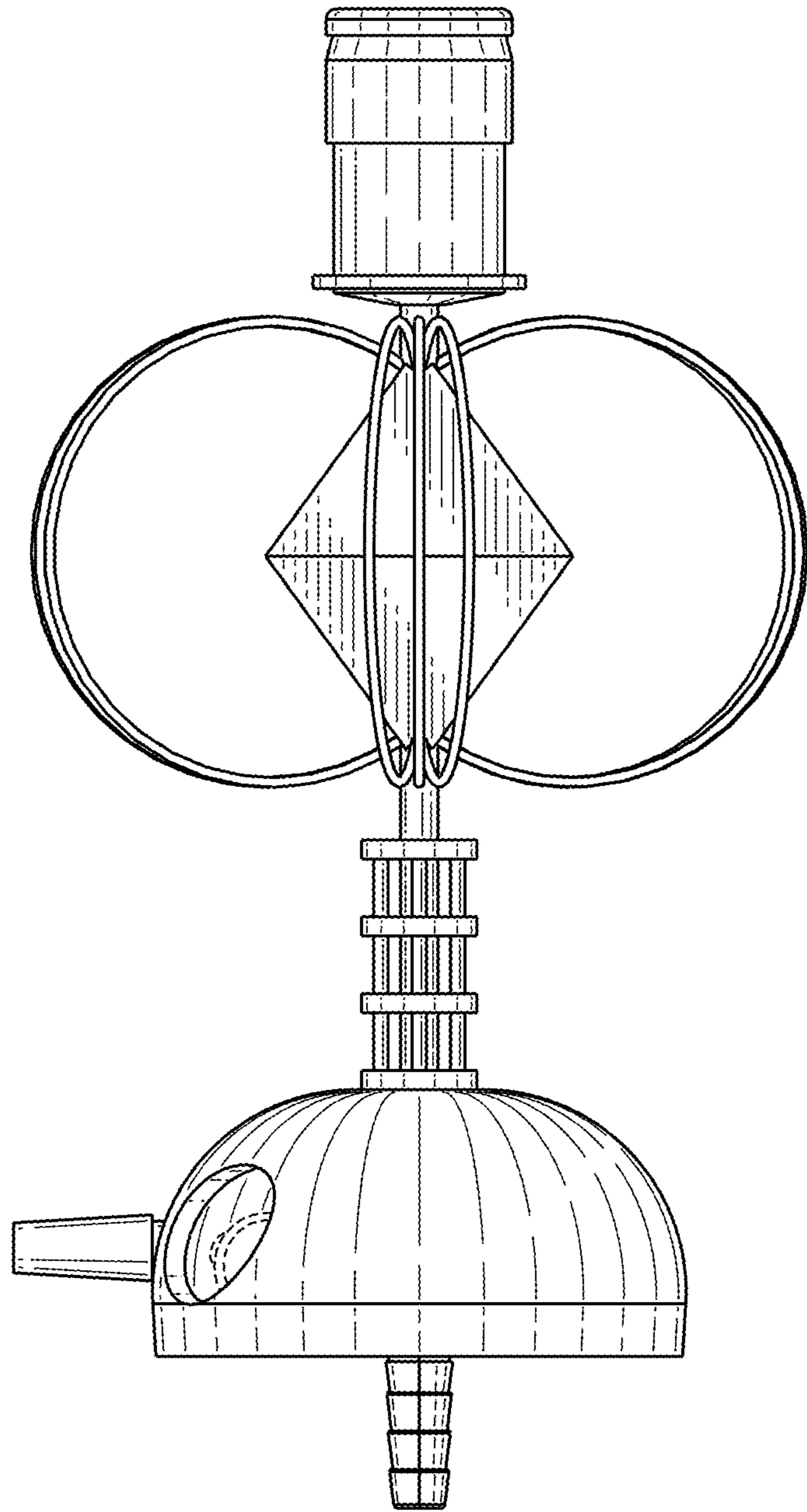

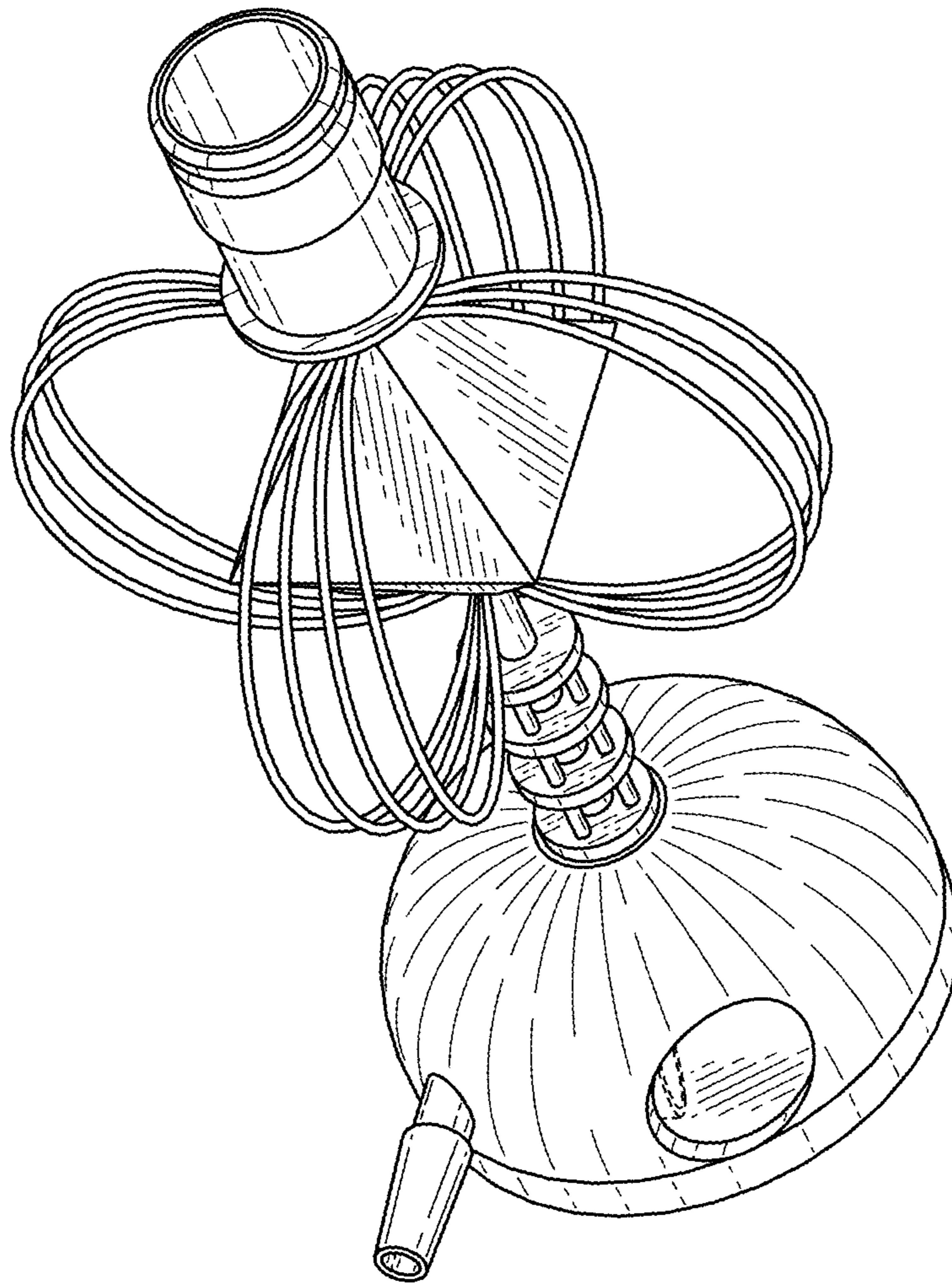

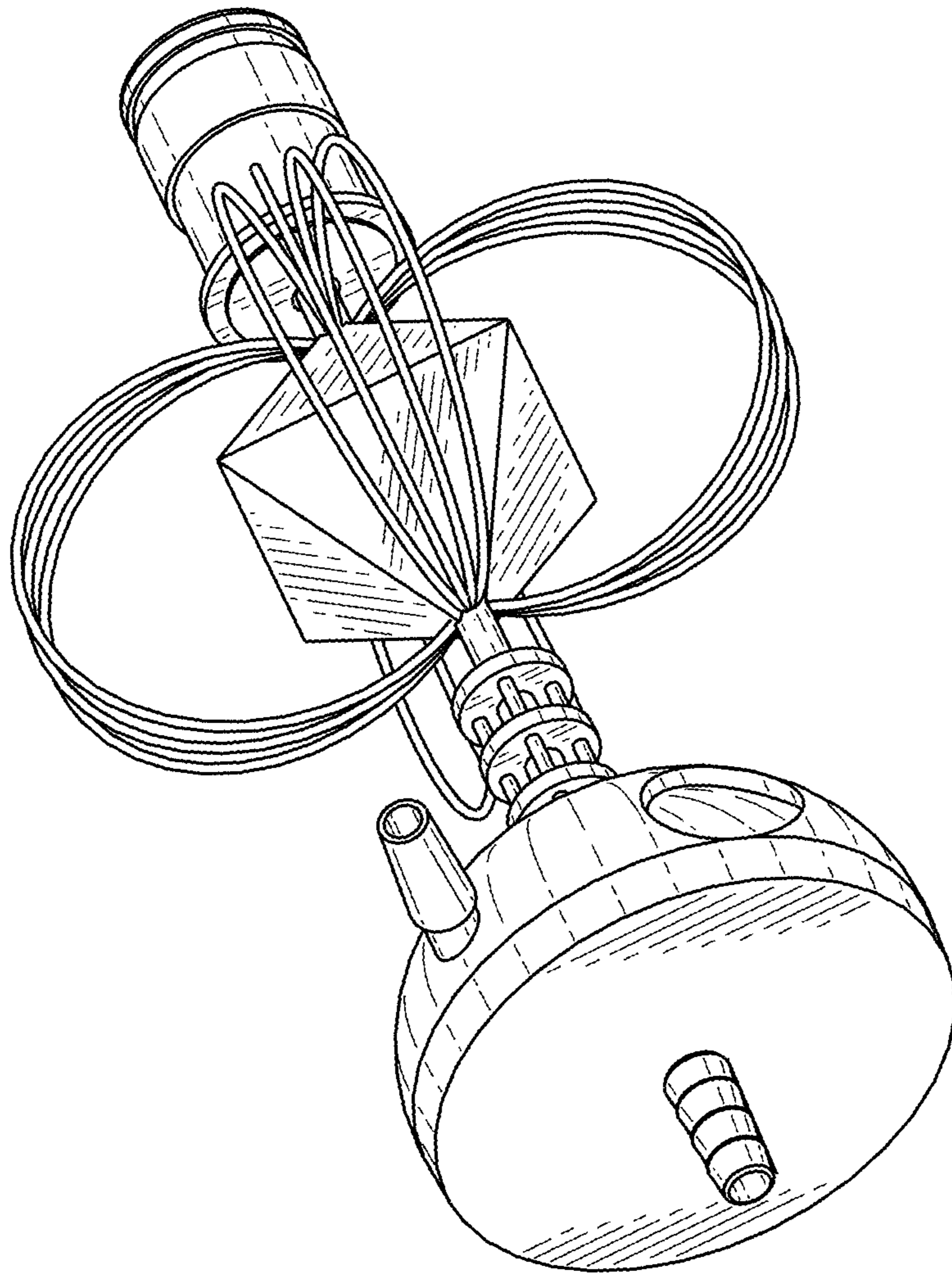
