The ornamental design for a pincer style suture removal device with interlocking tabs, as shown and described.

DESCRIPTION

FIG. 6 is a bottom plan view of the present design;

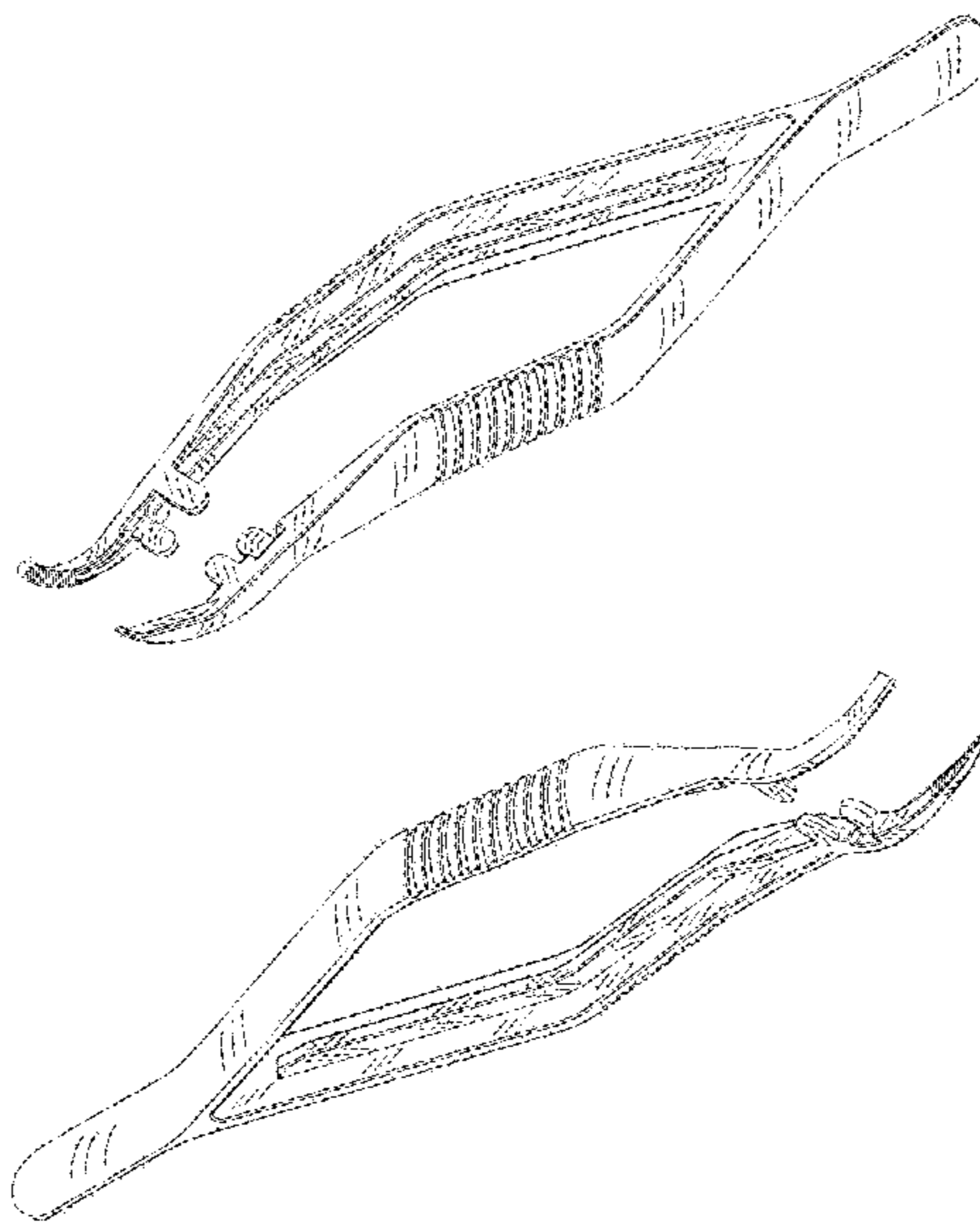
FIG. 7 is a front perspective view of the present design; and,

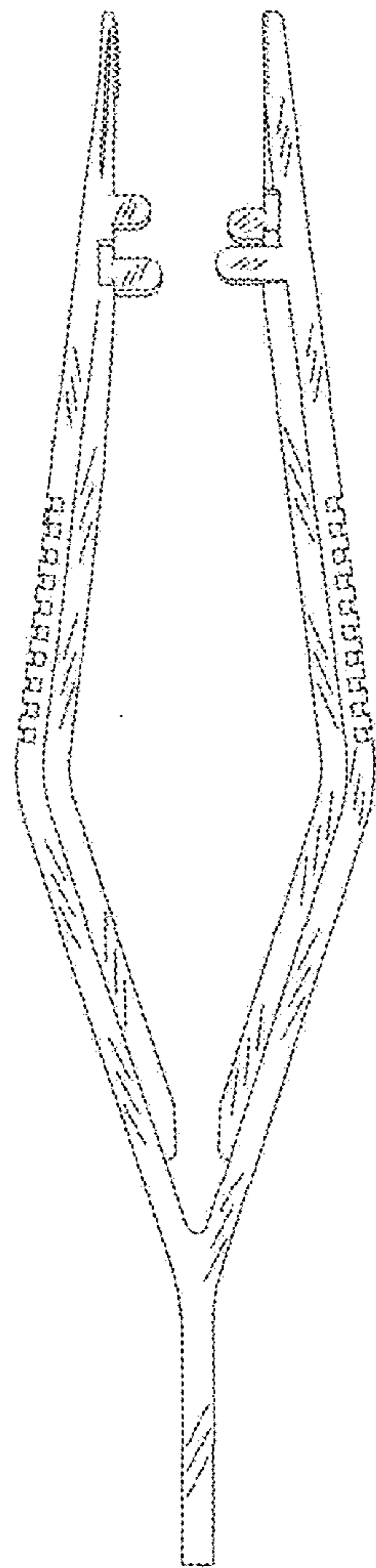

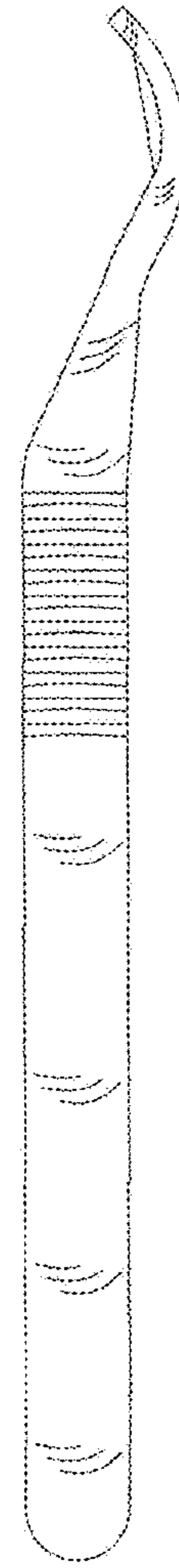

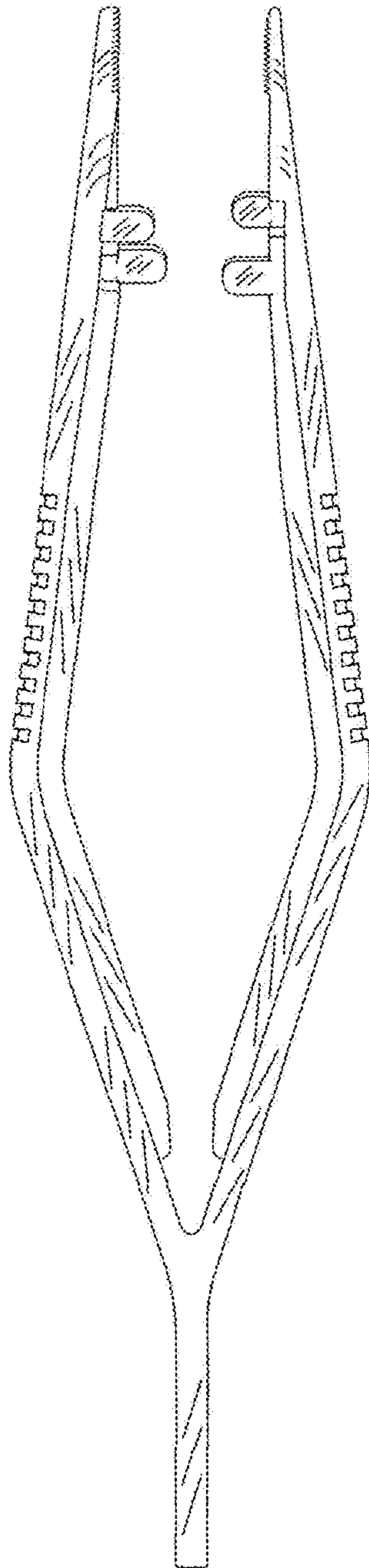

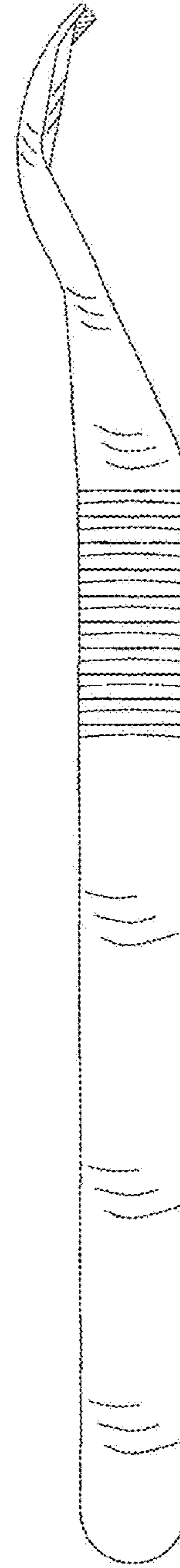

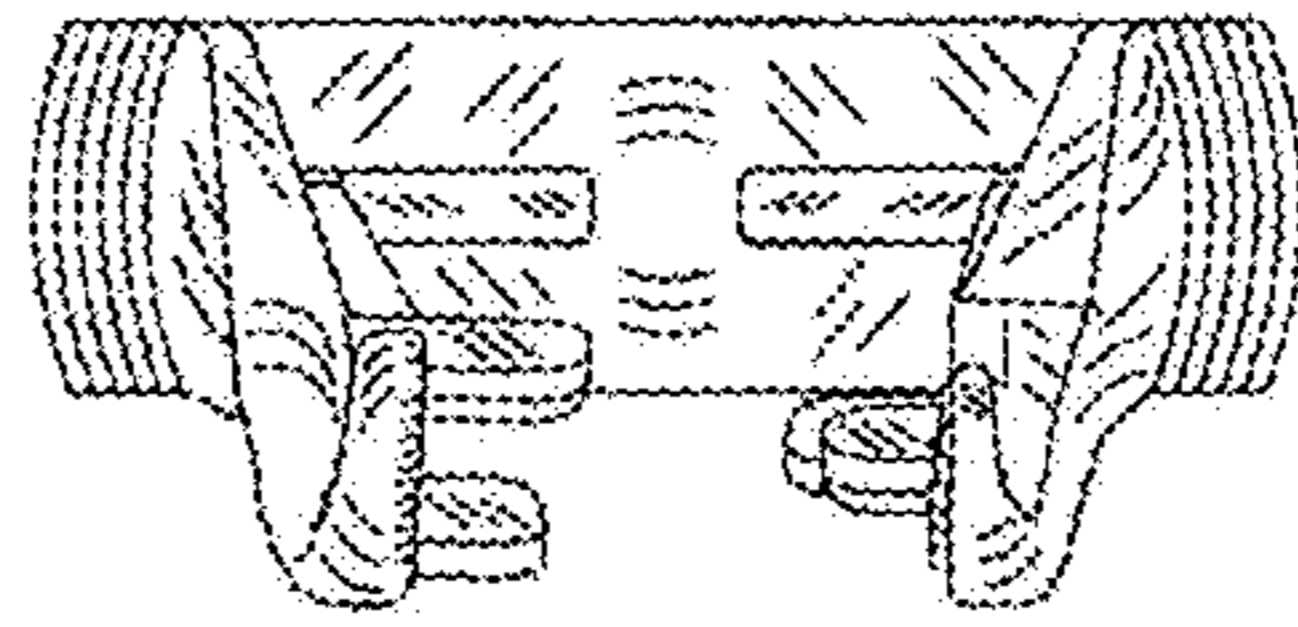

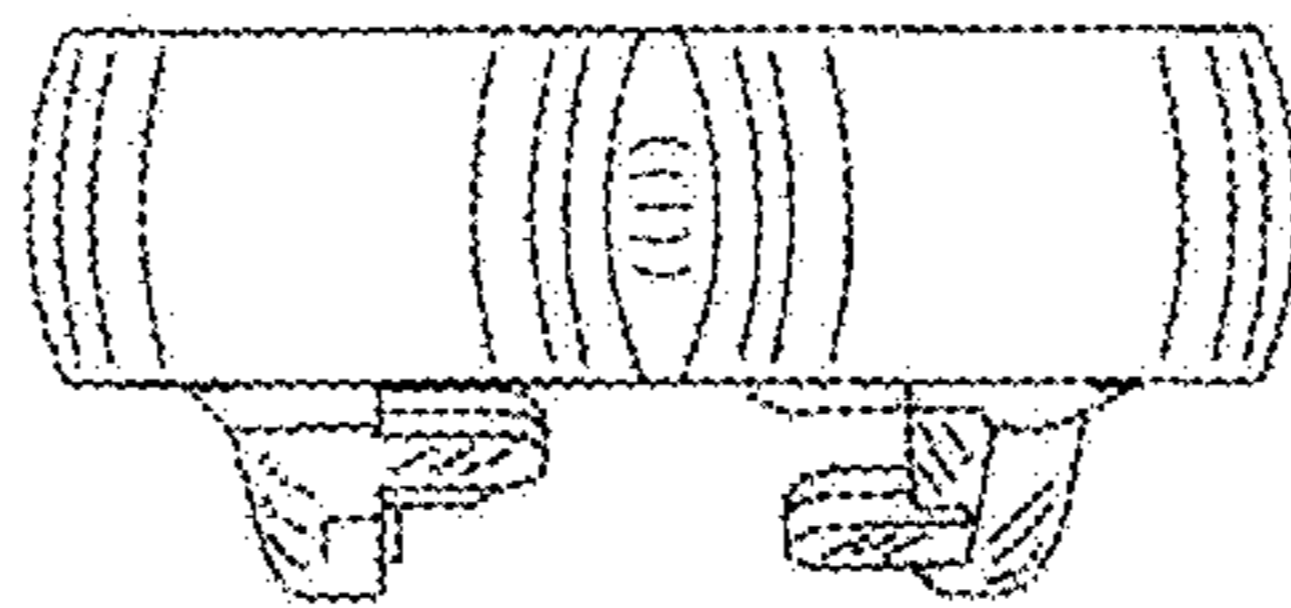
