FIG. 5 is a right side view of the optical forceps of FIG. 1.

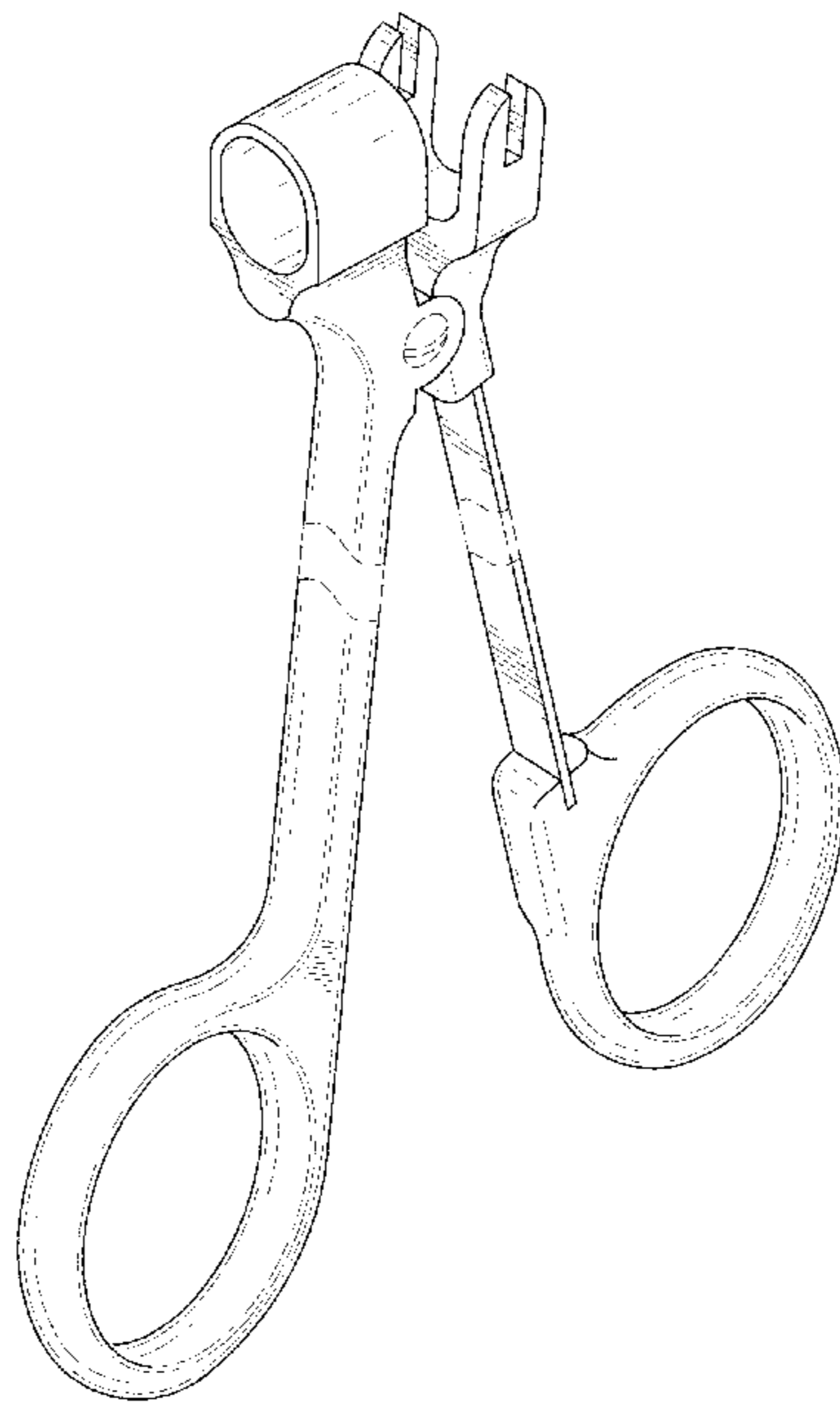
FIG. 6 is a top view of the optical forceps of FIG. 1; and,

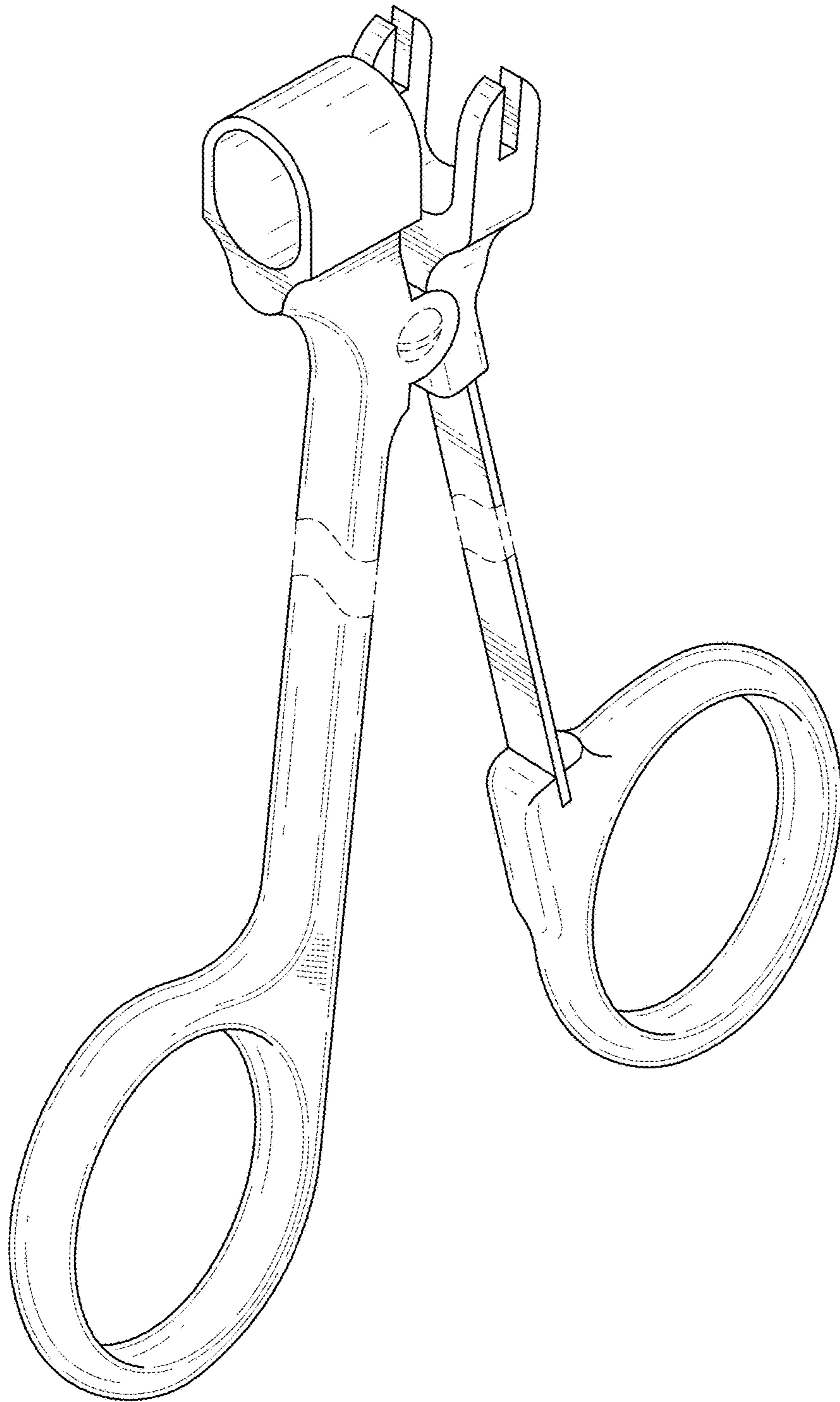

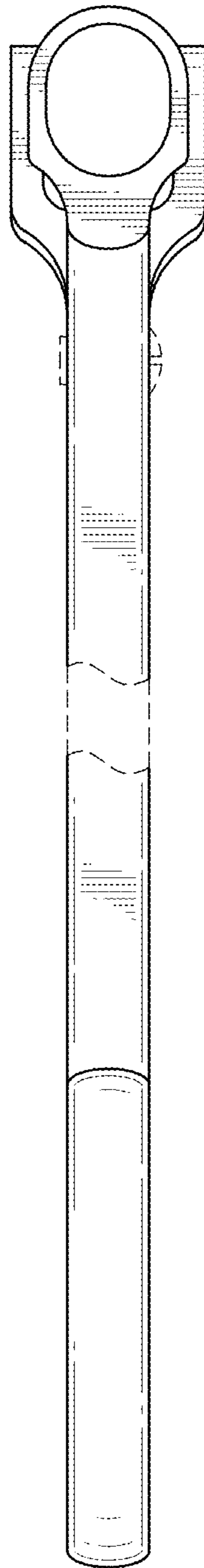

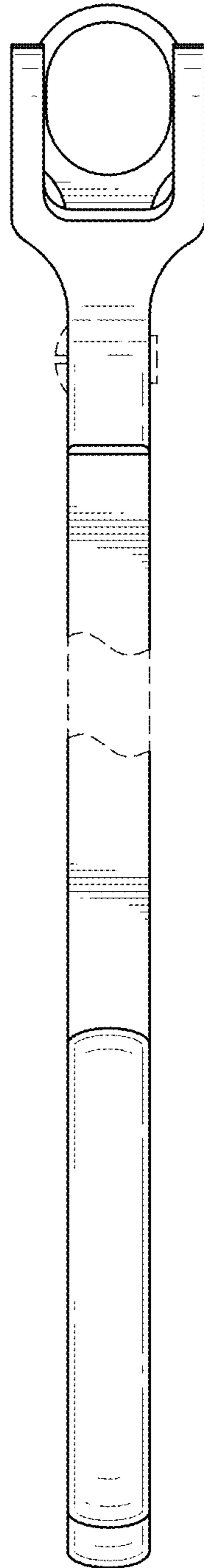

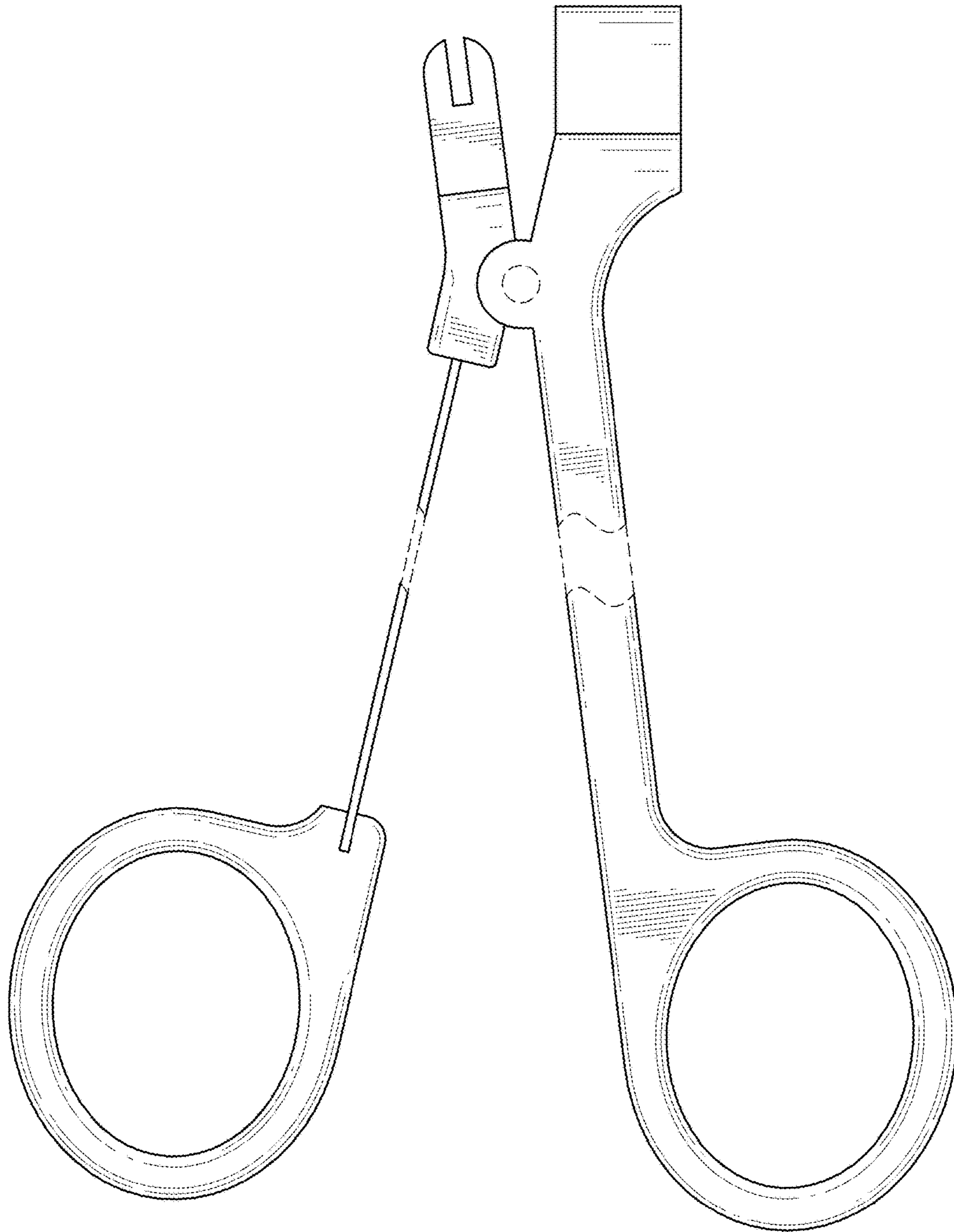

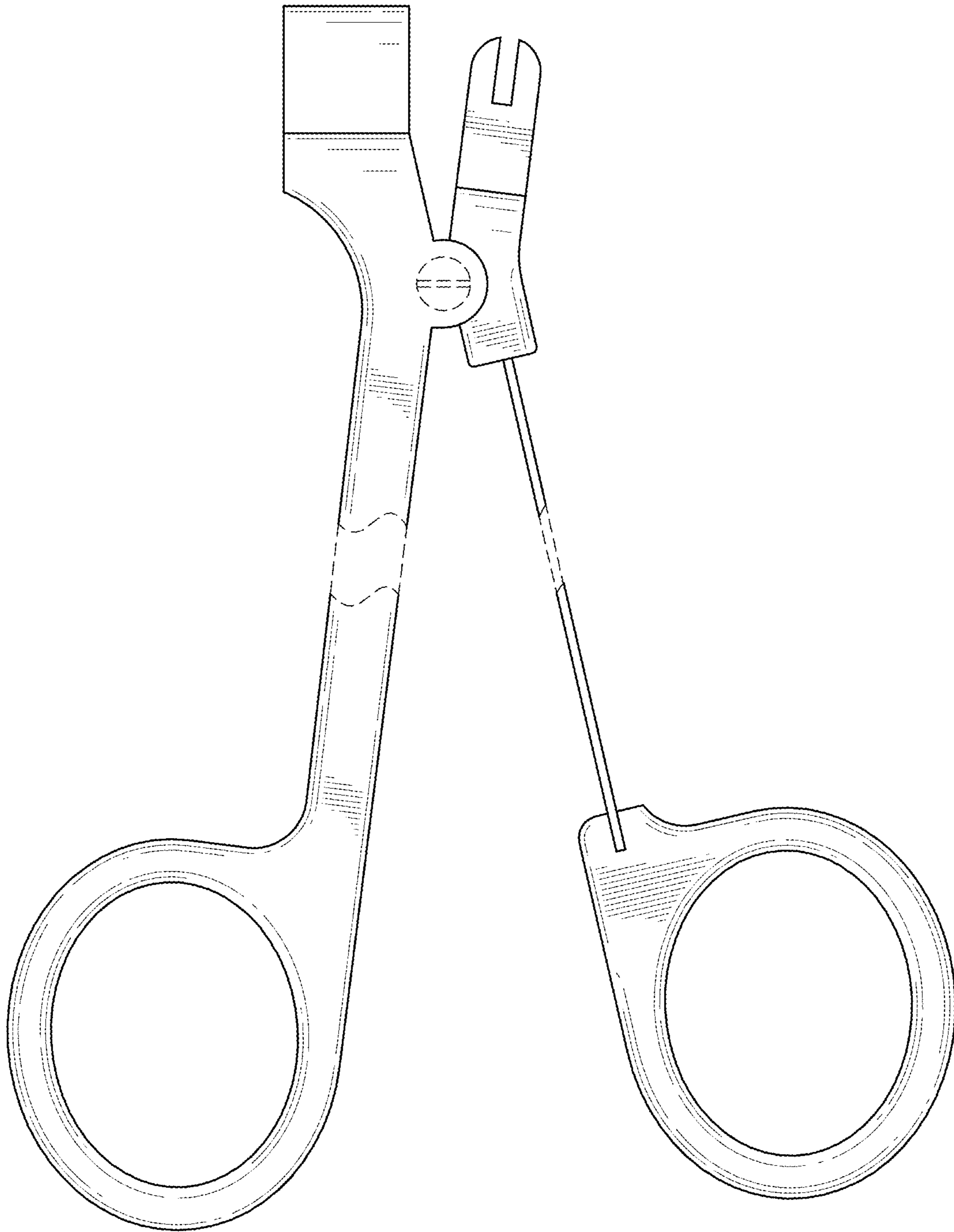

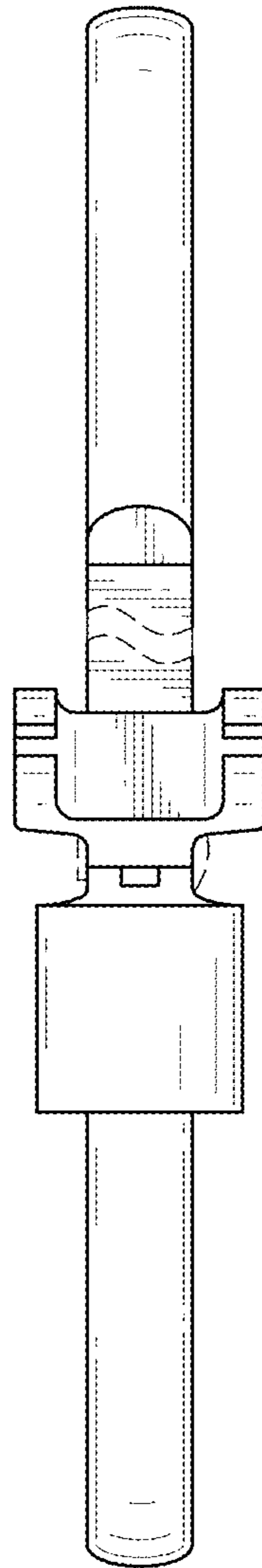

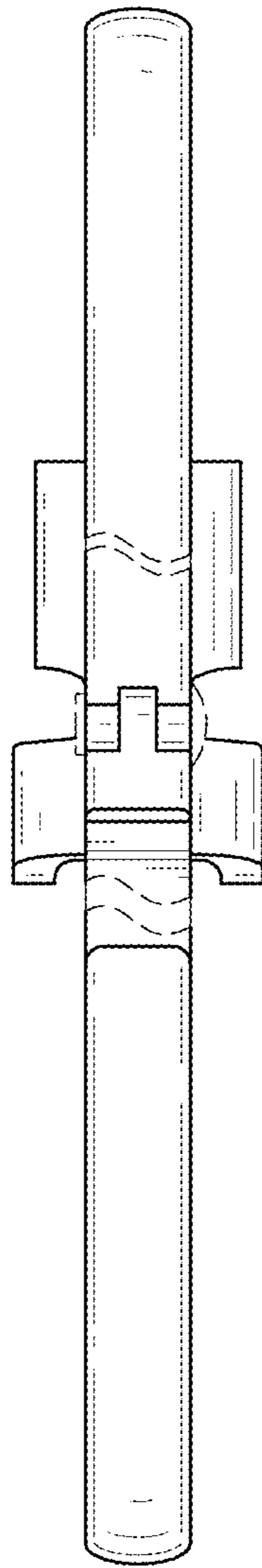
