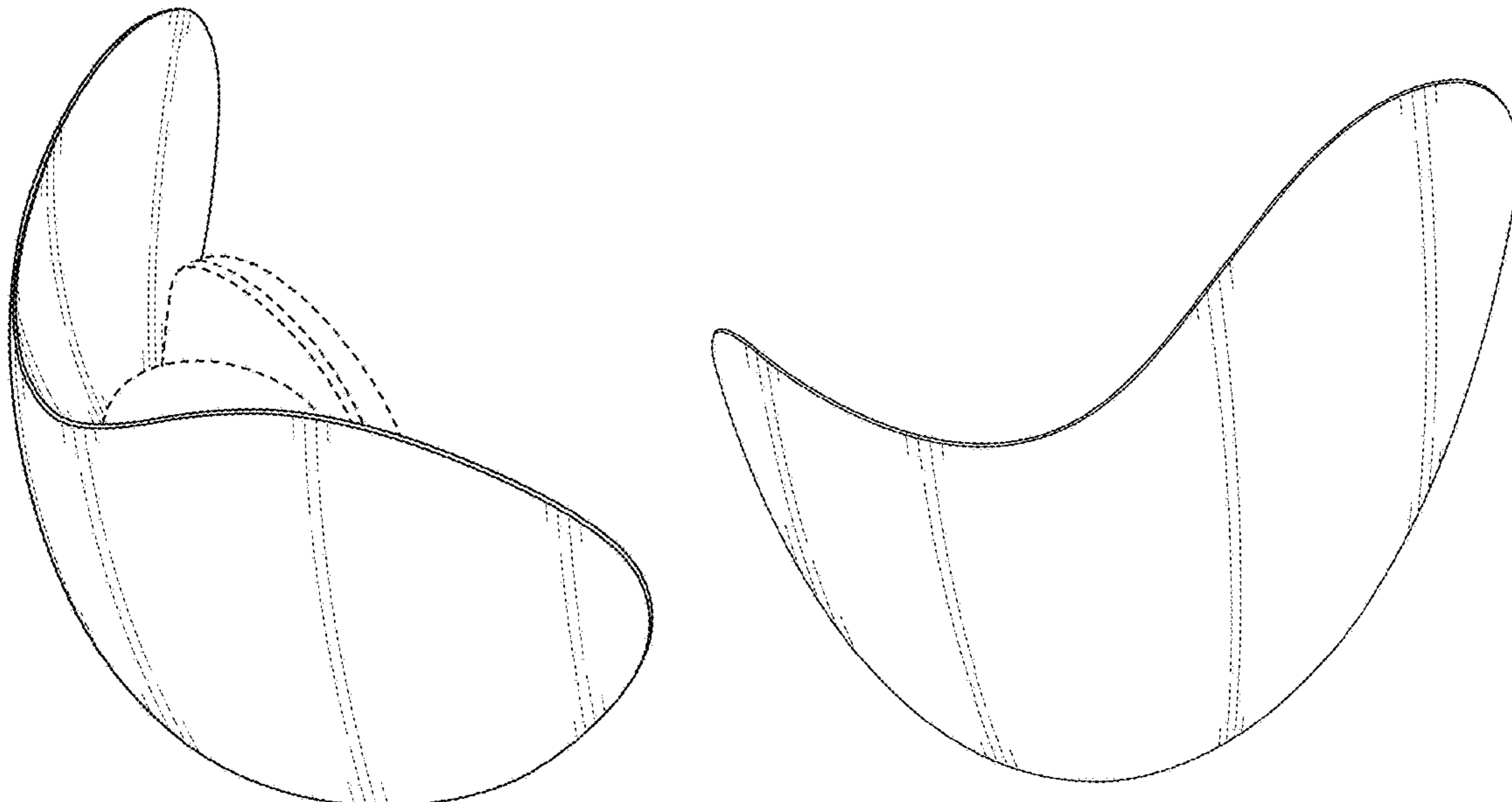
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top and left side perspective view of the light fixture showing my new design;

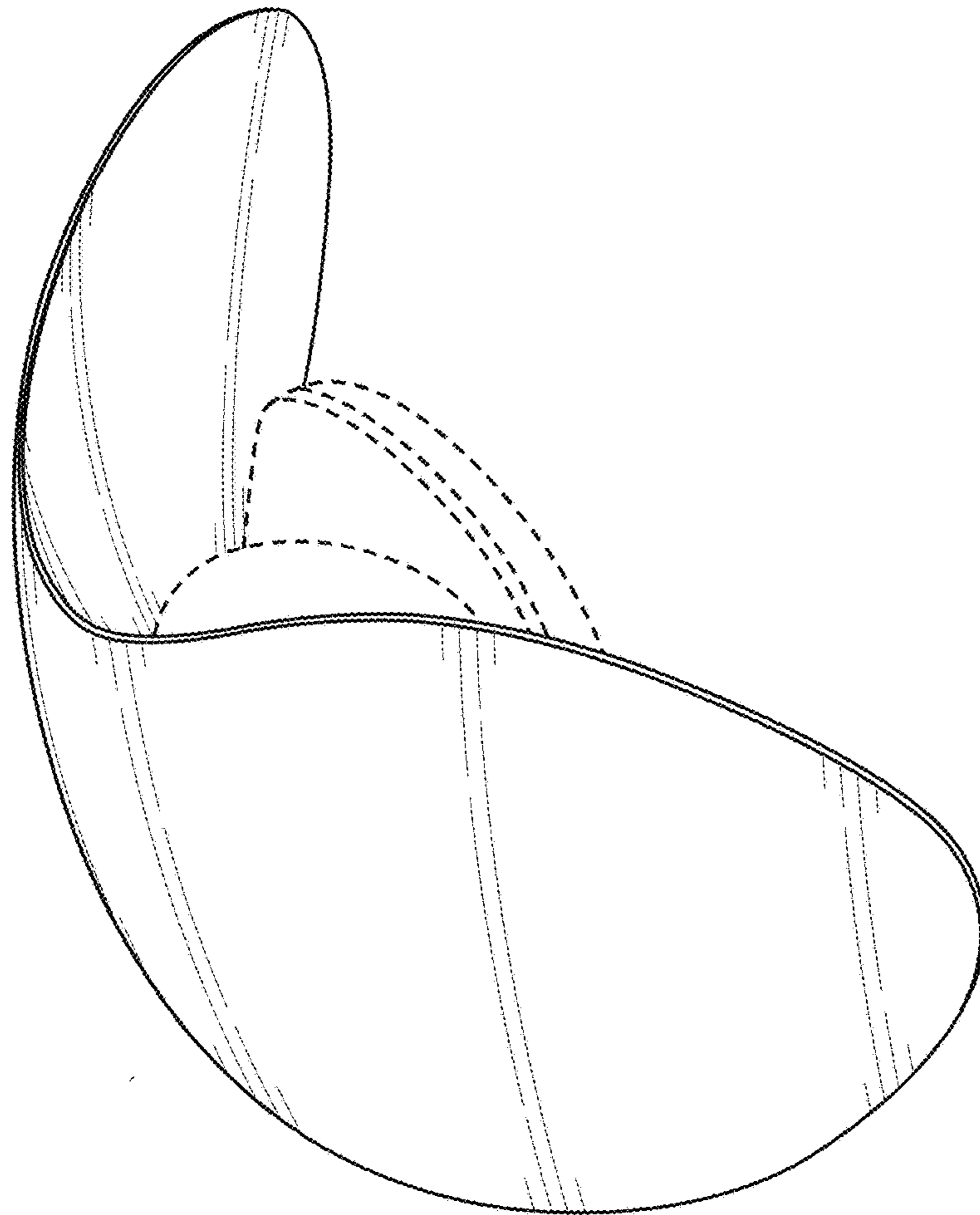

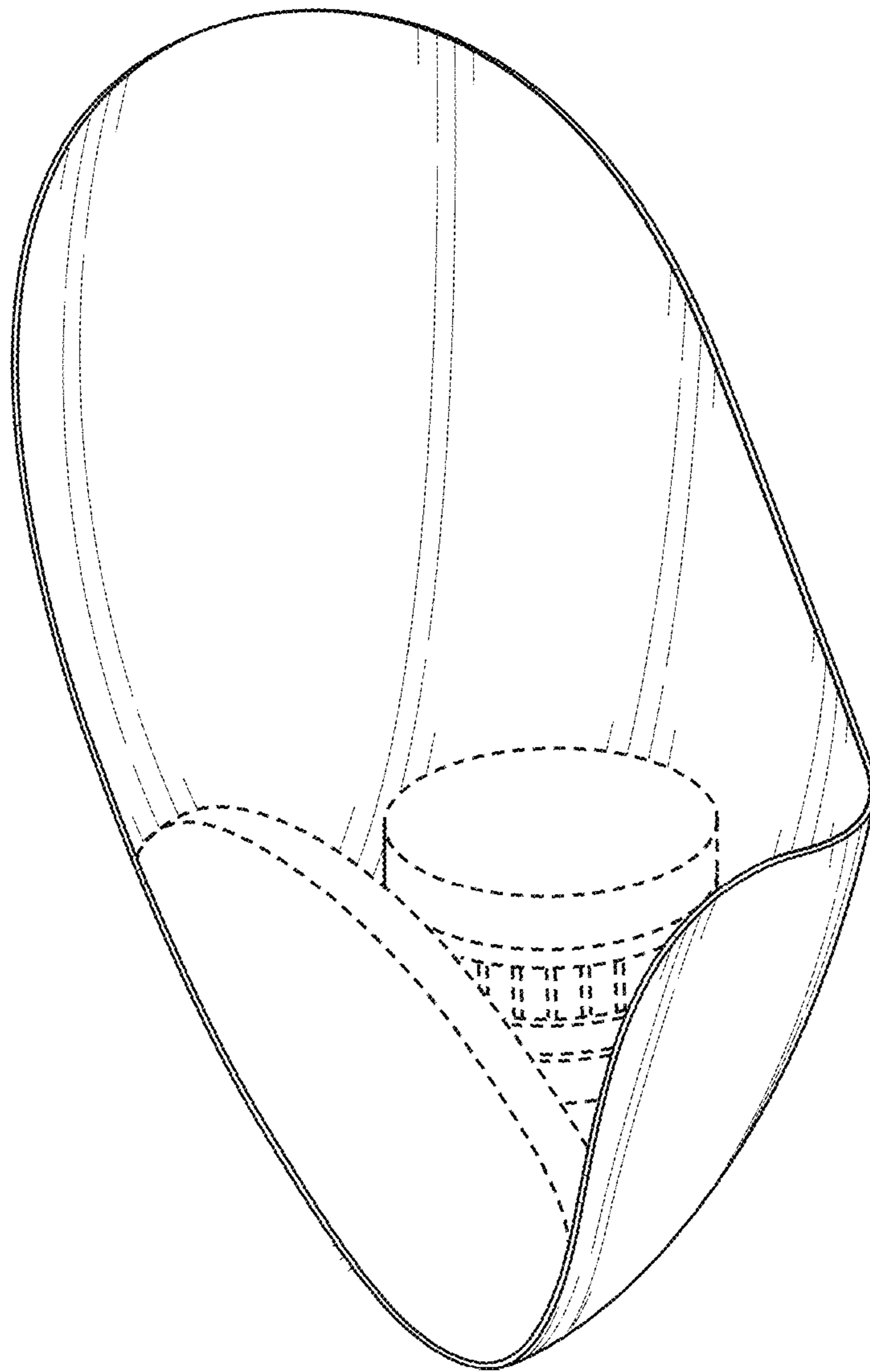

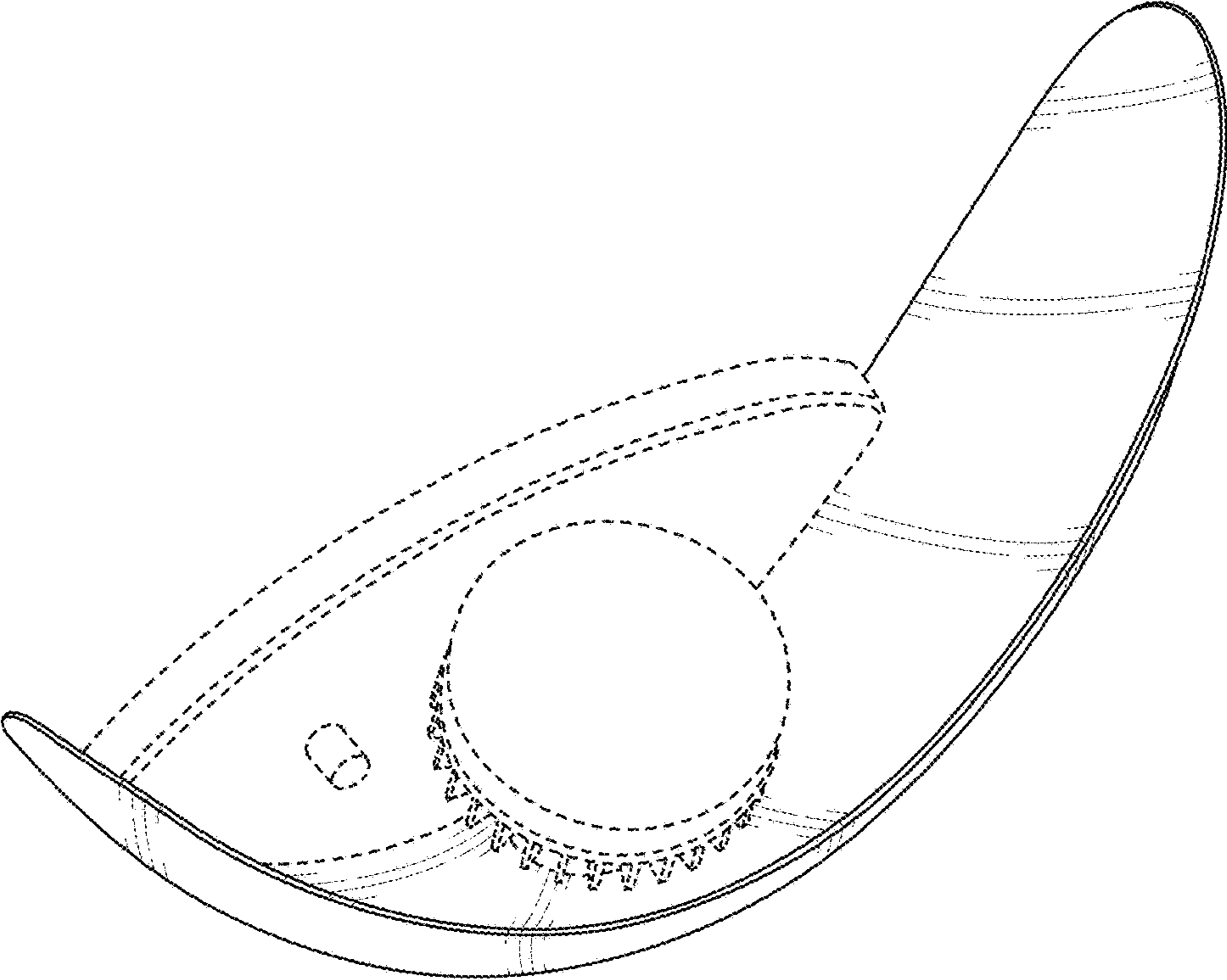

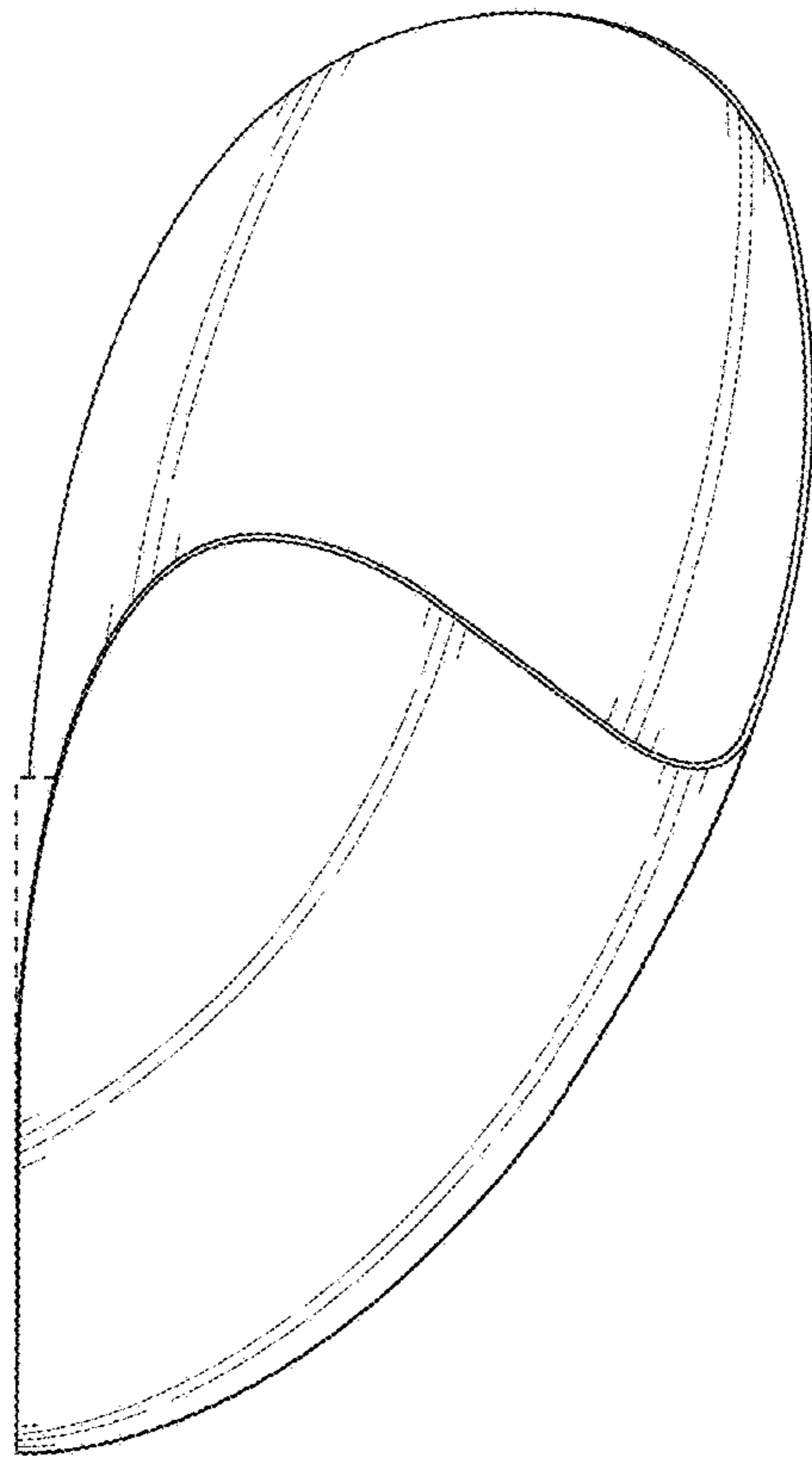

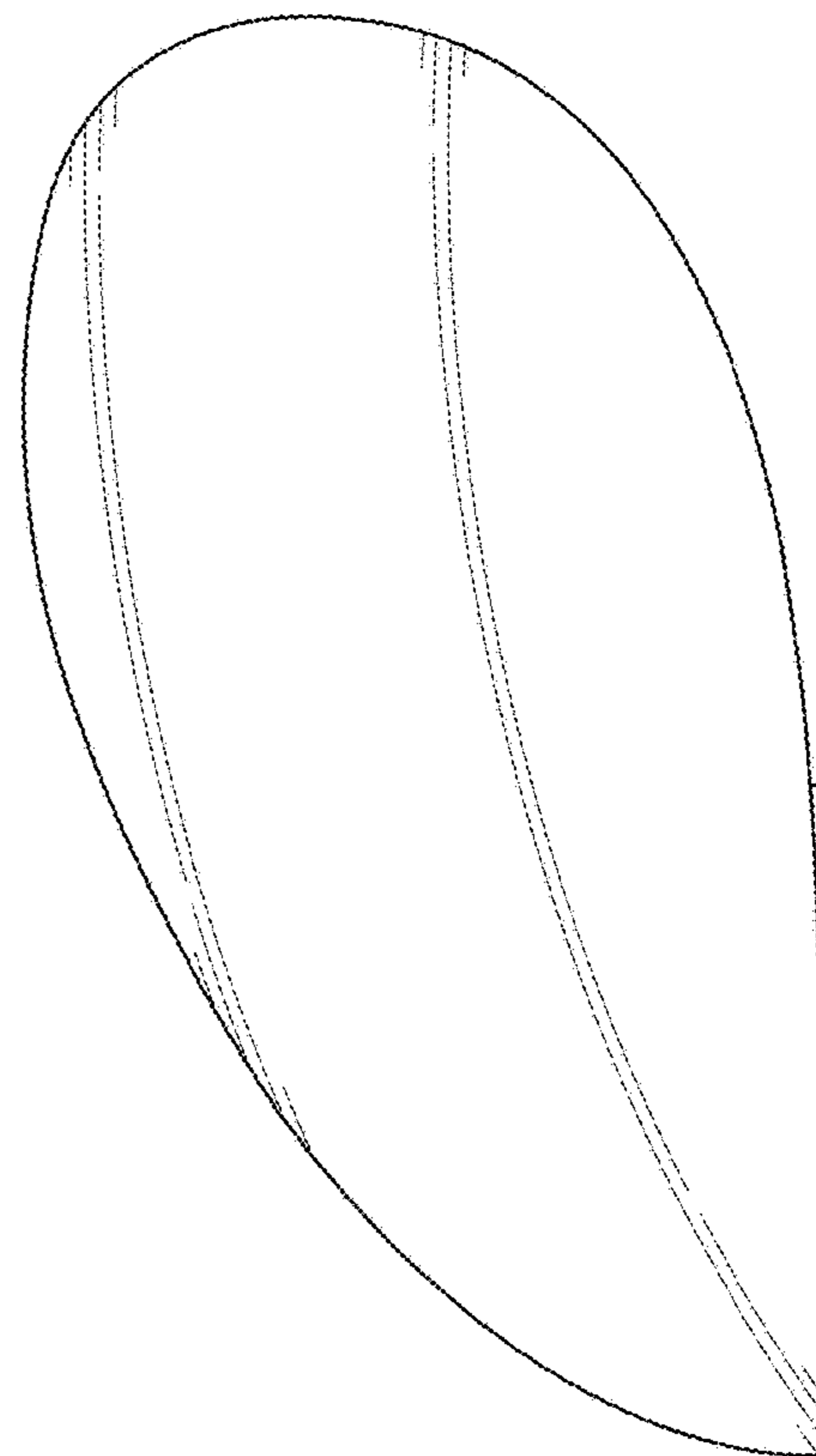

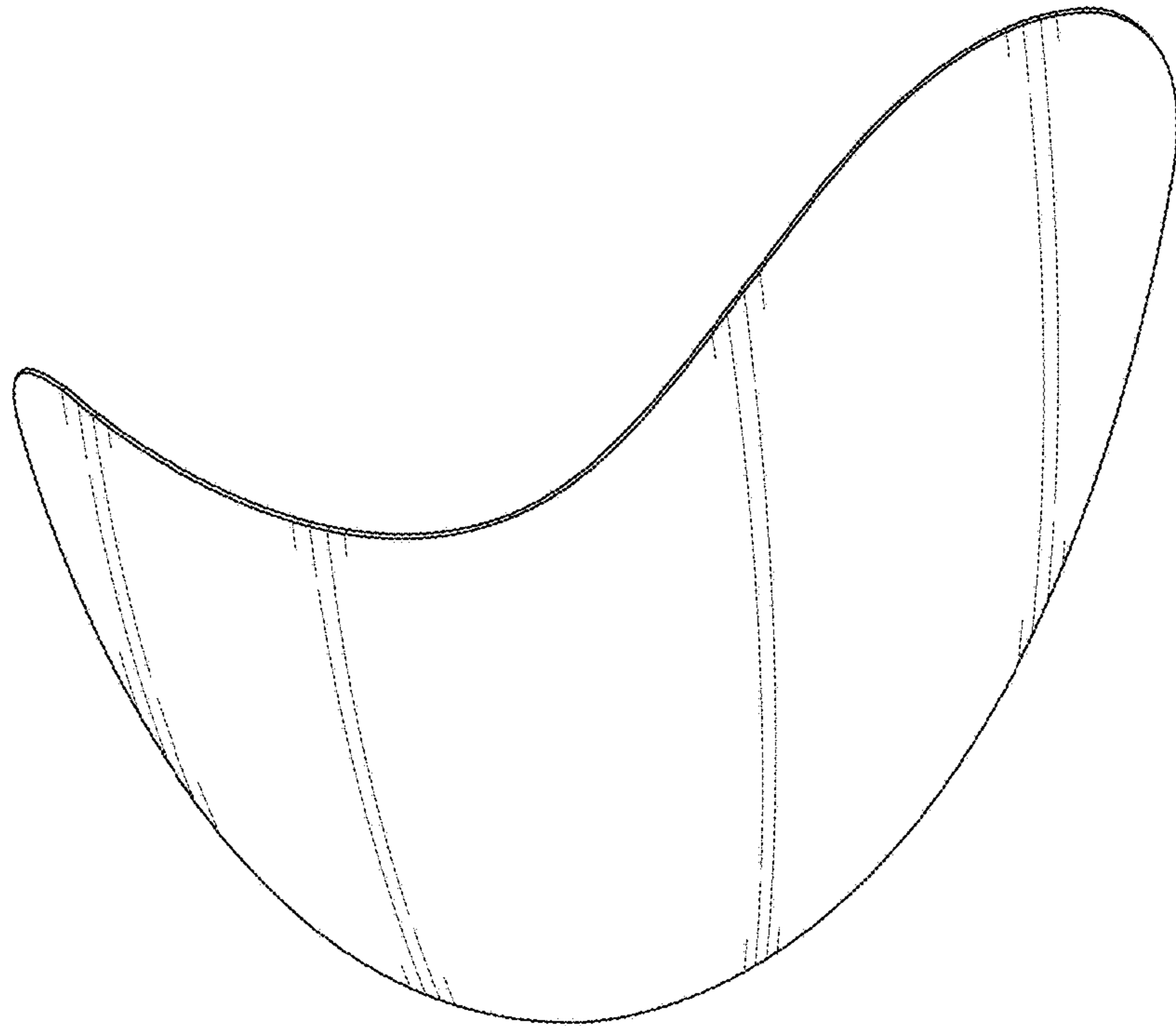

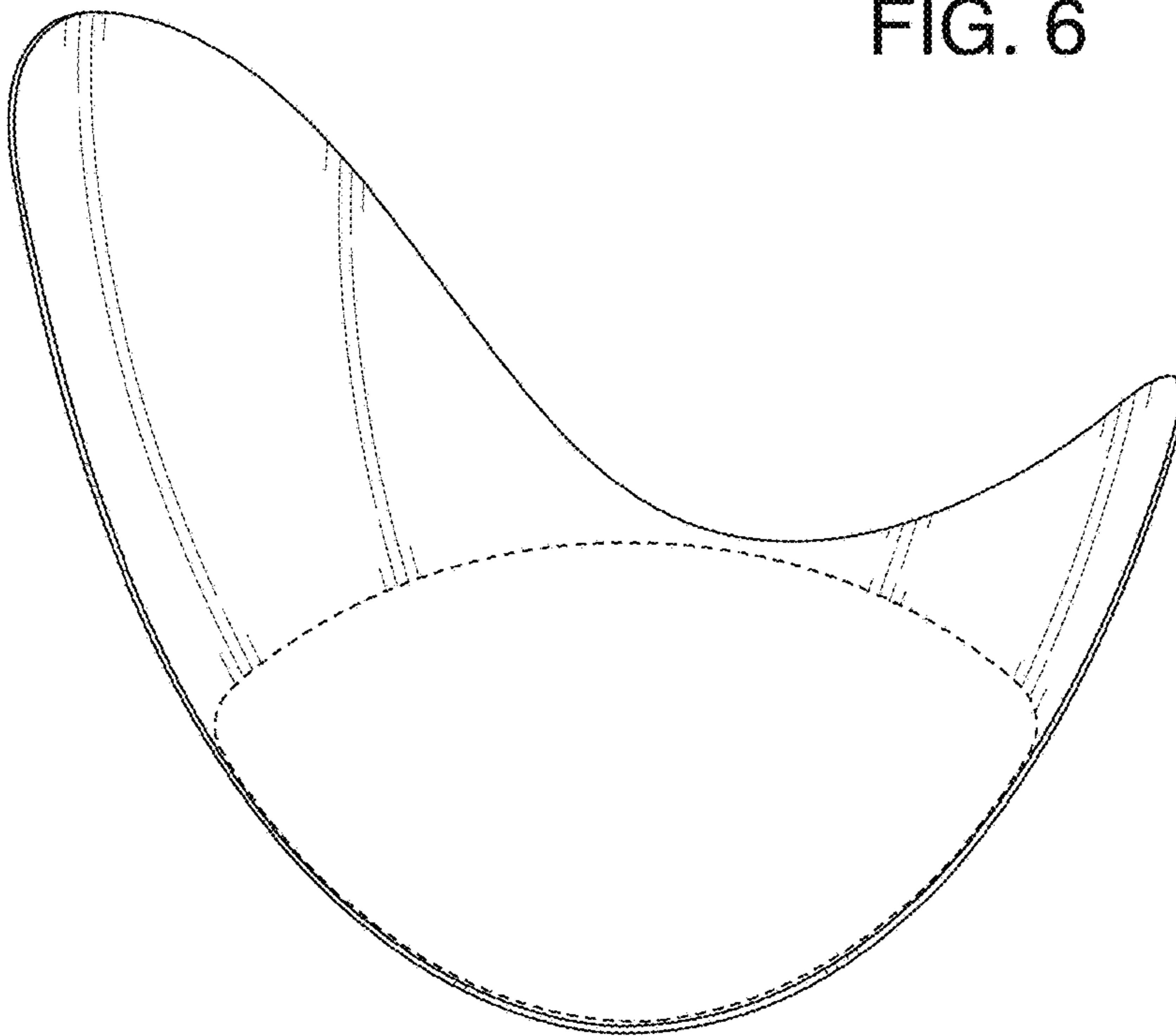

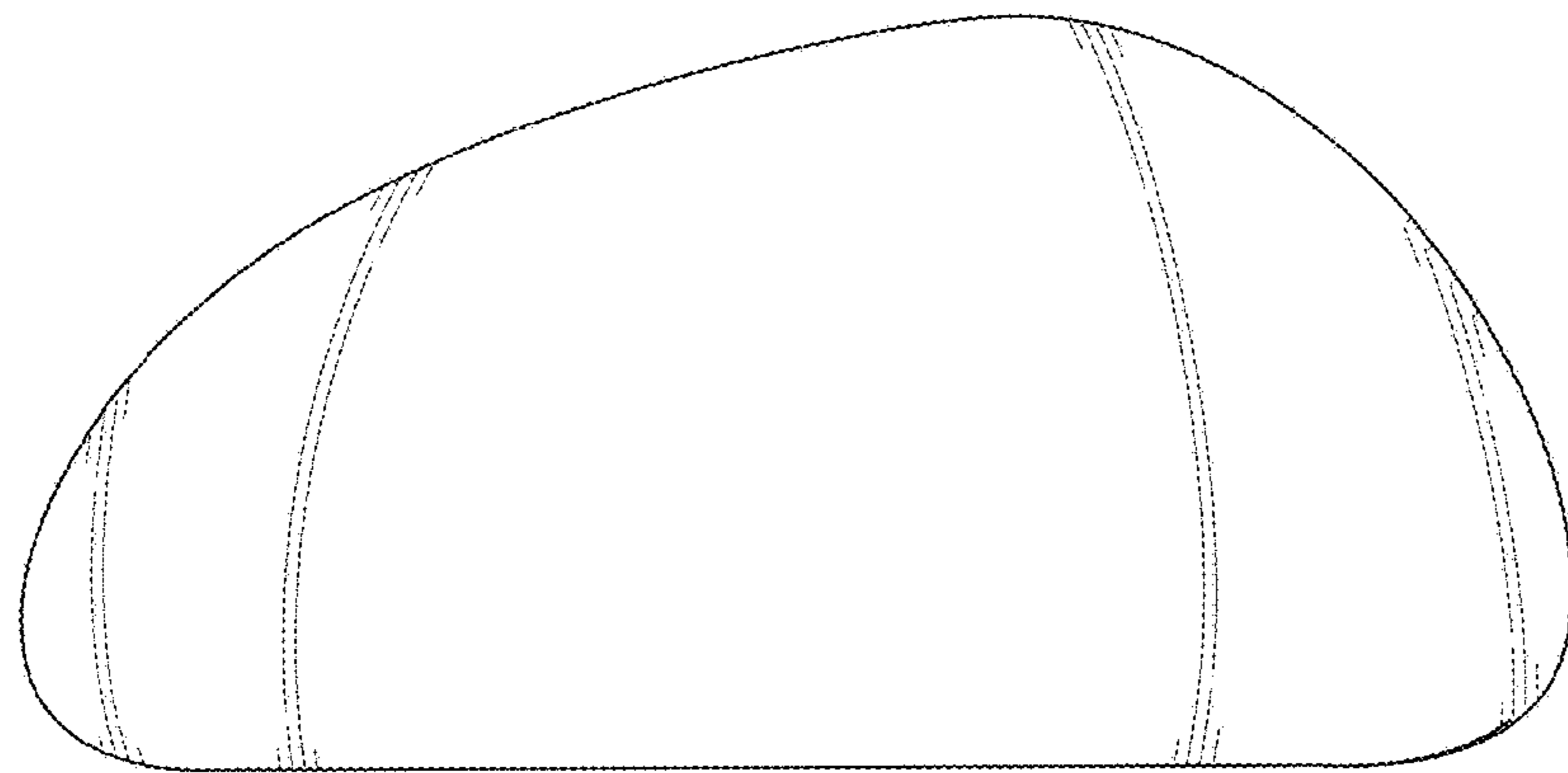

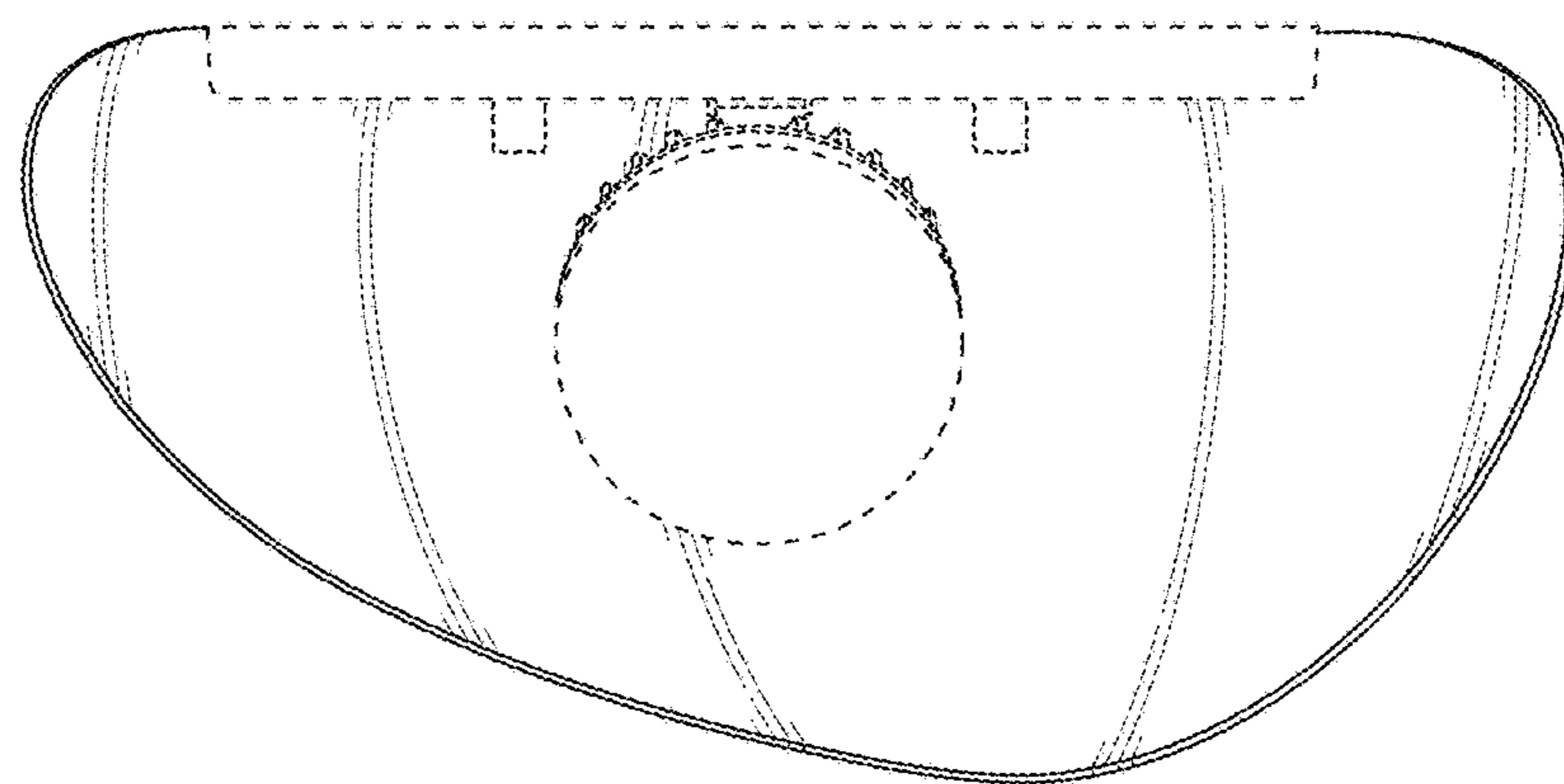
