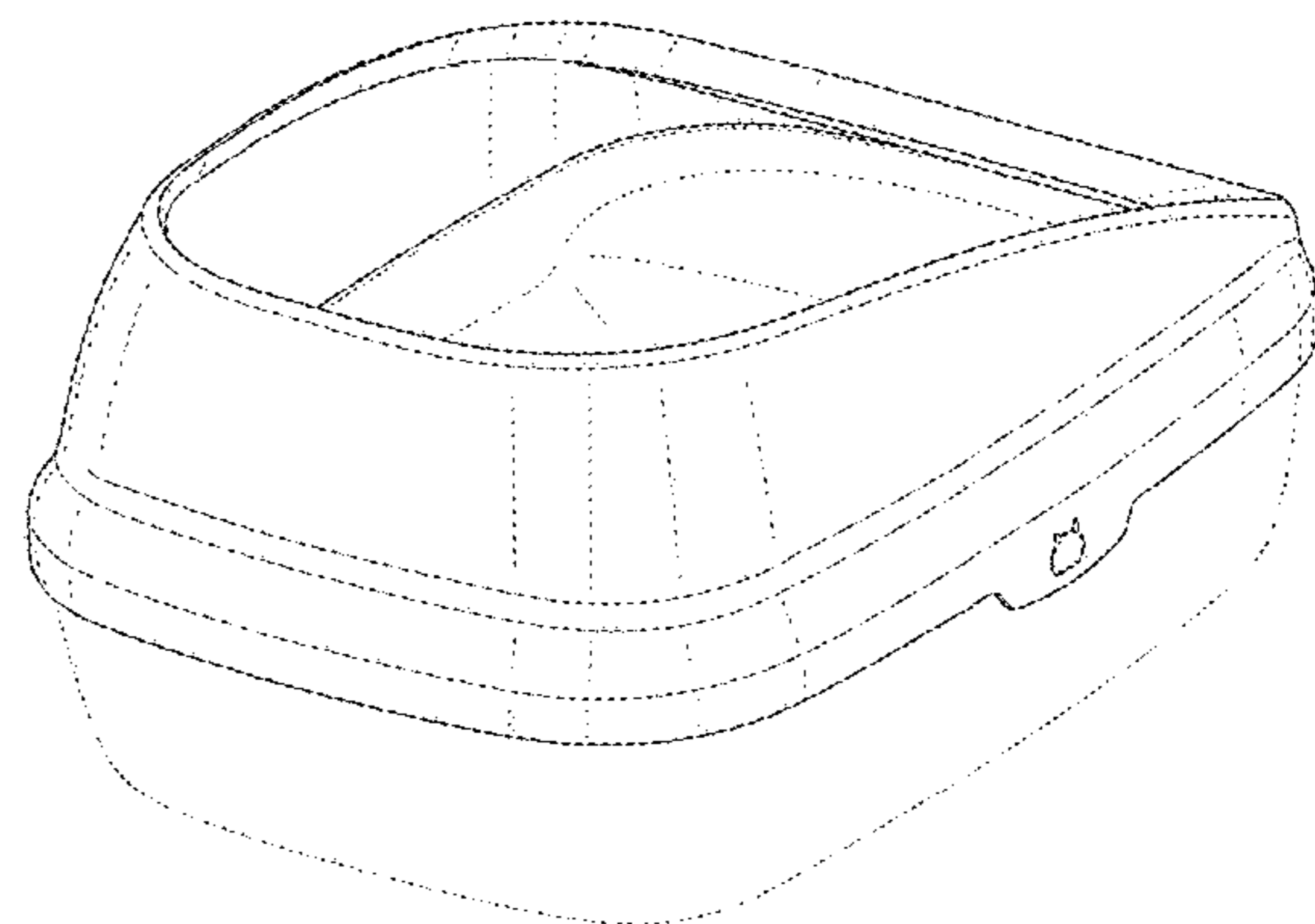
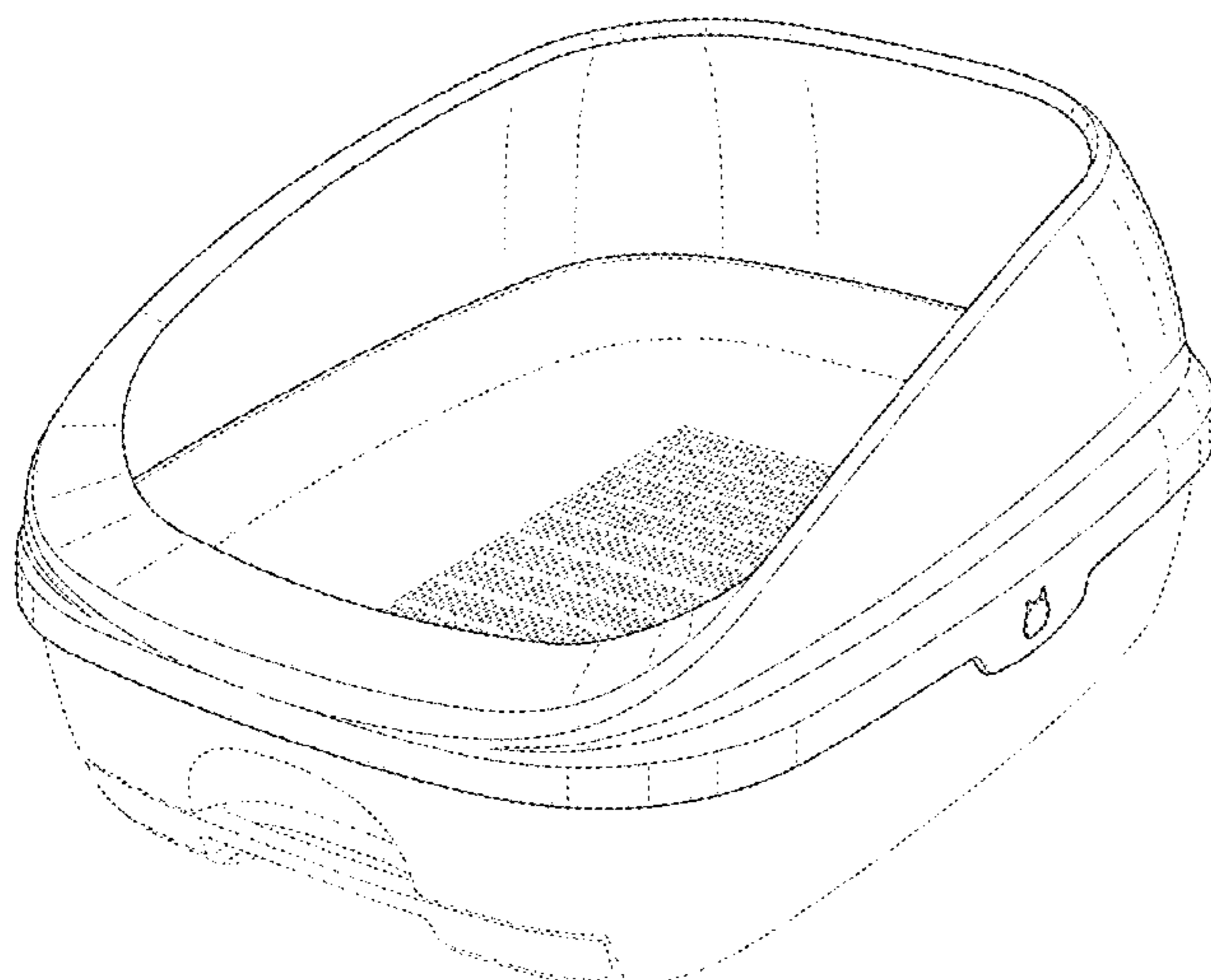
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of a pet toilet showing our new design;  
FIG. 2 is a front view thereof;

FIG. 4 is a left side view thereof, a right side view is a mirror image of the left side view;

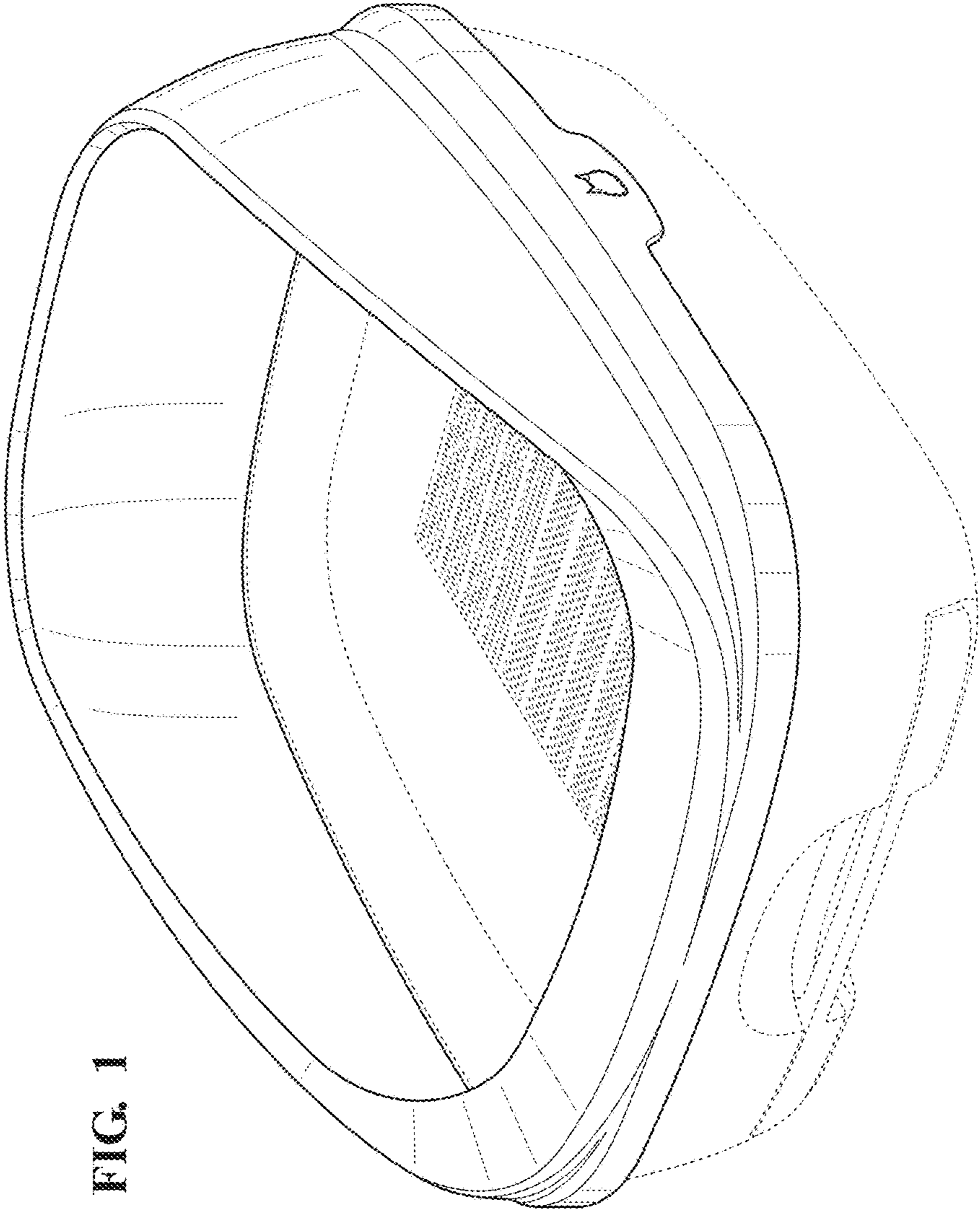

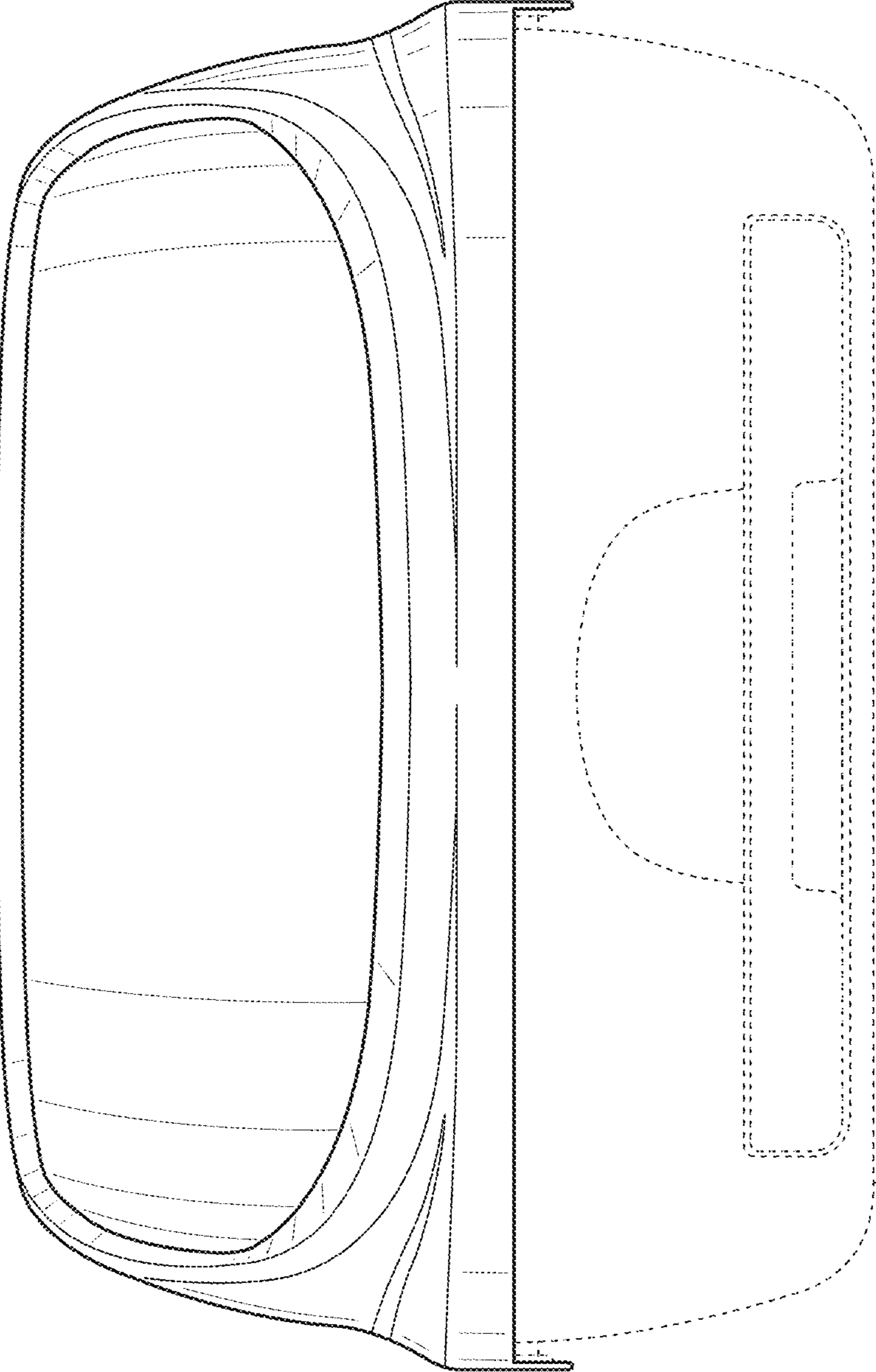

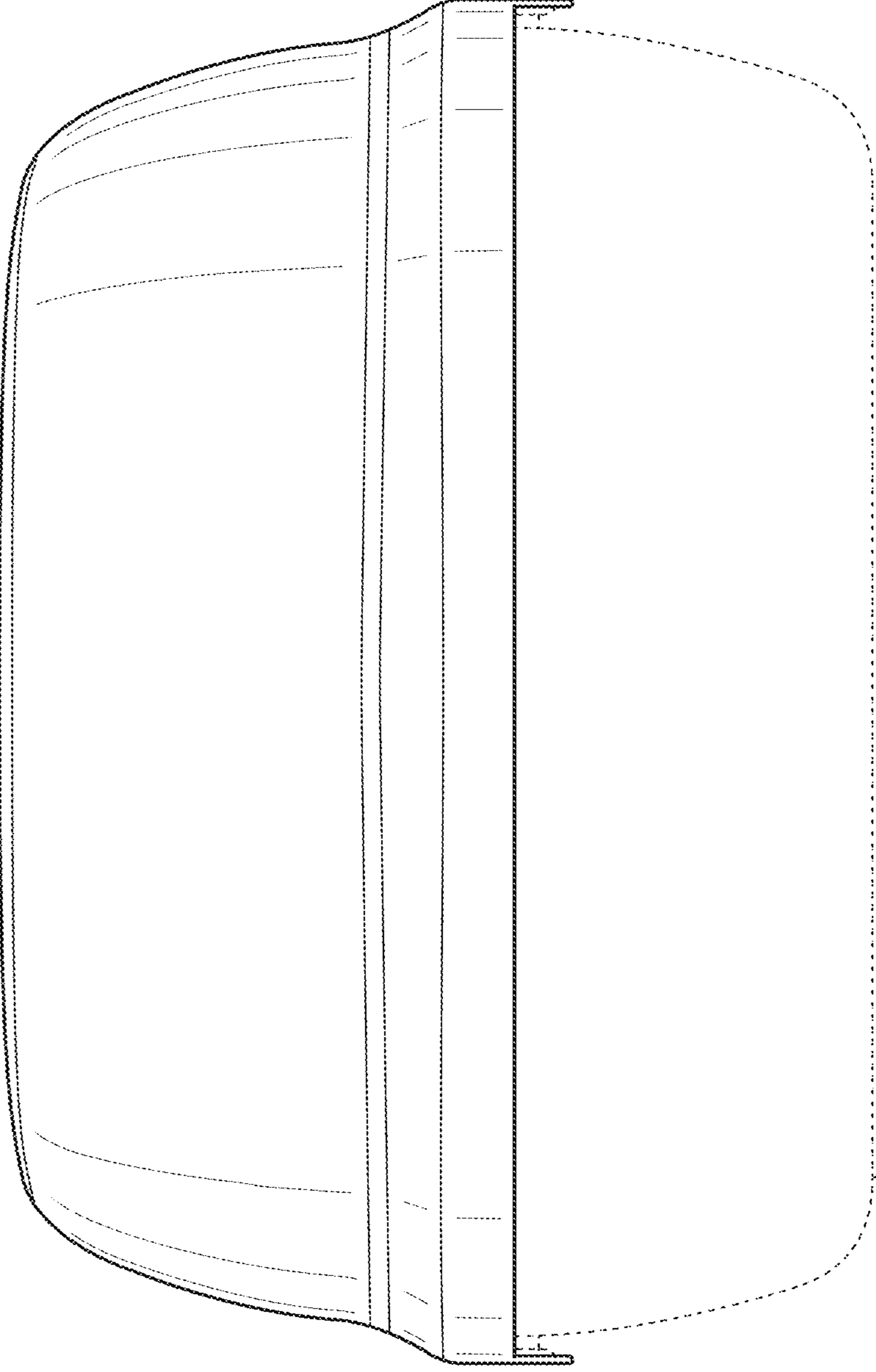

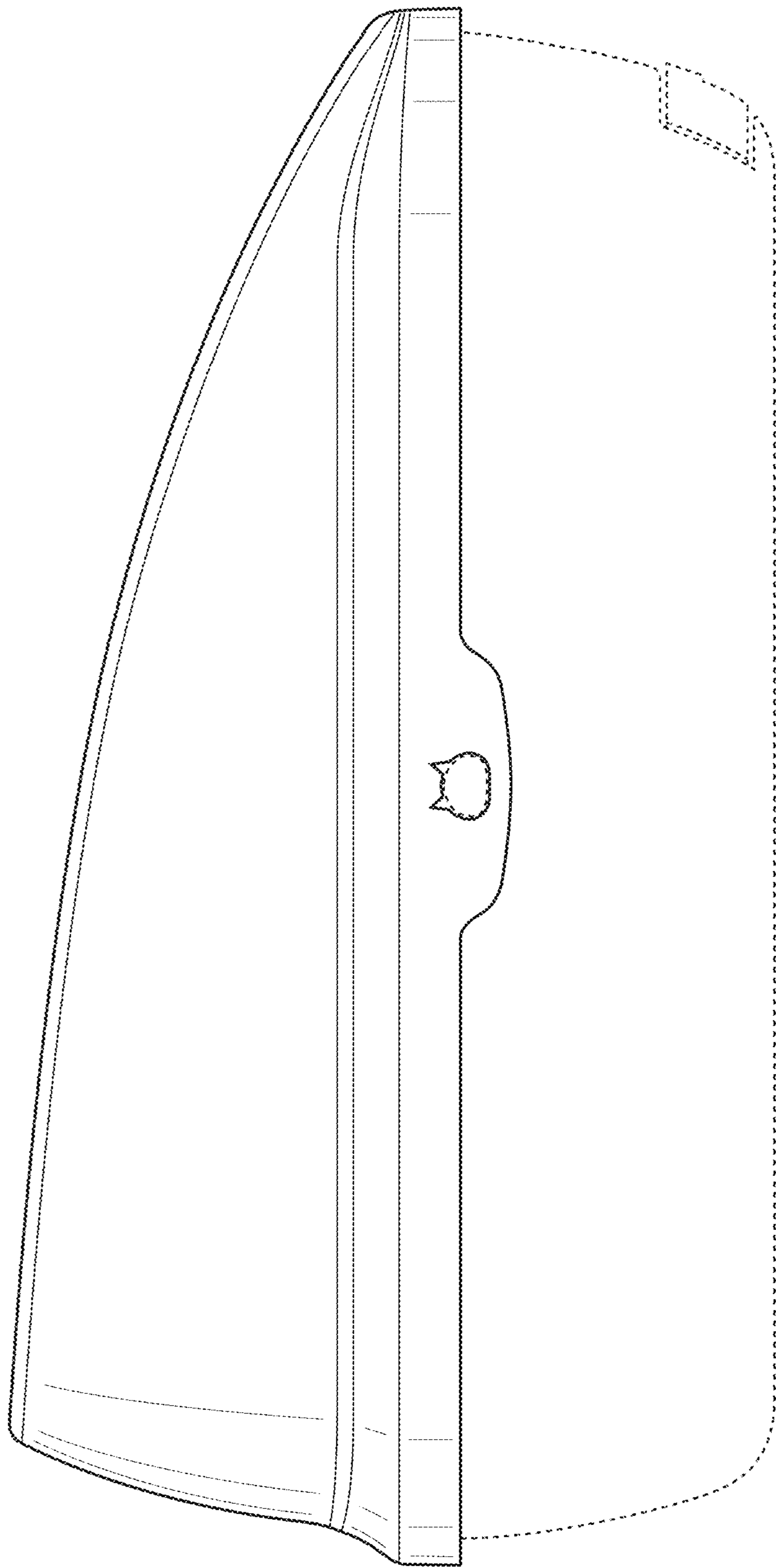

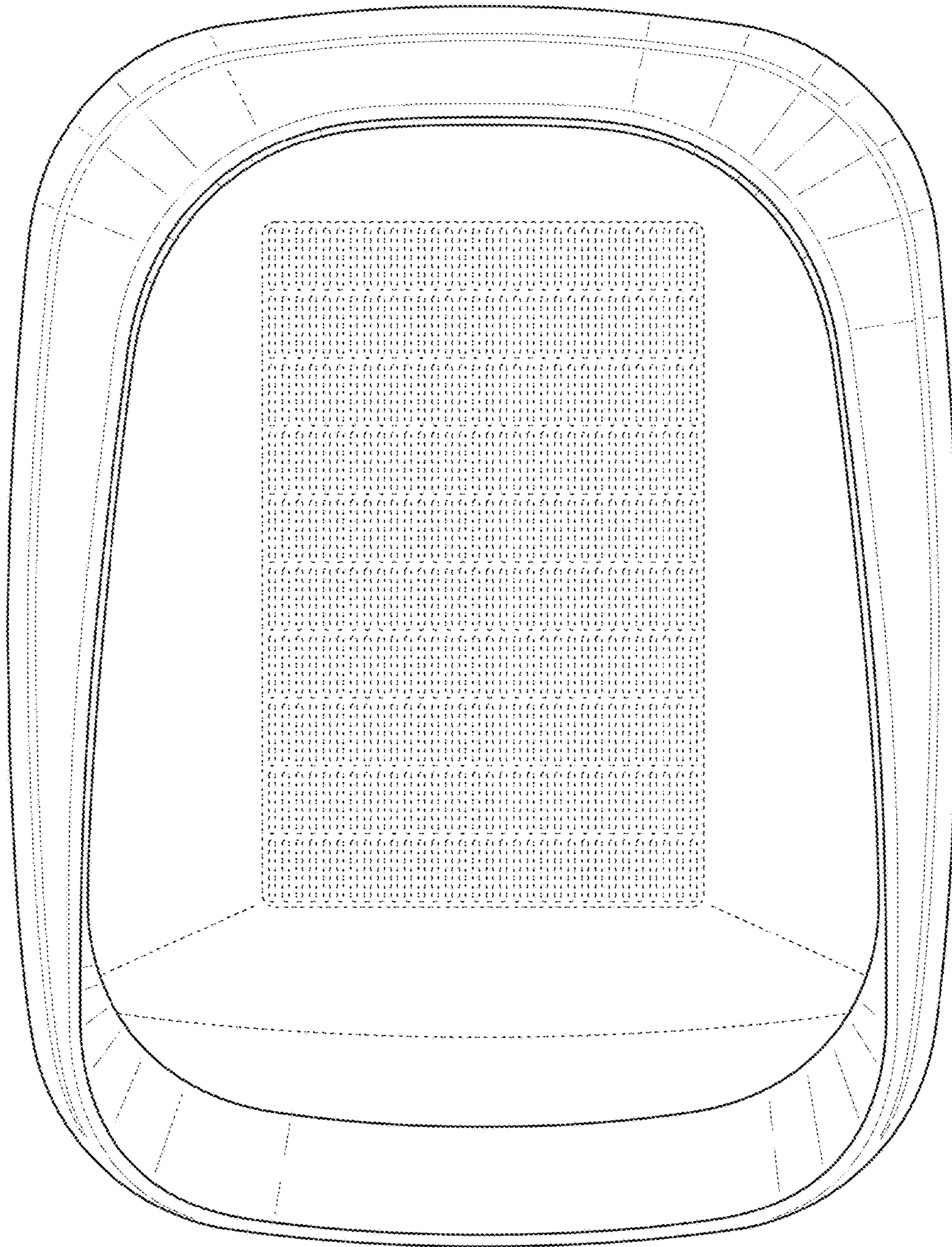

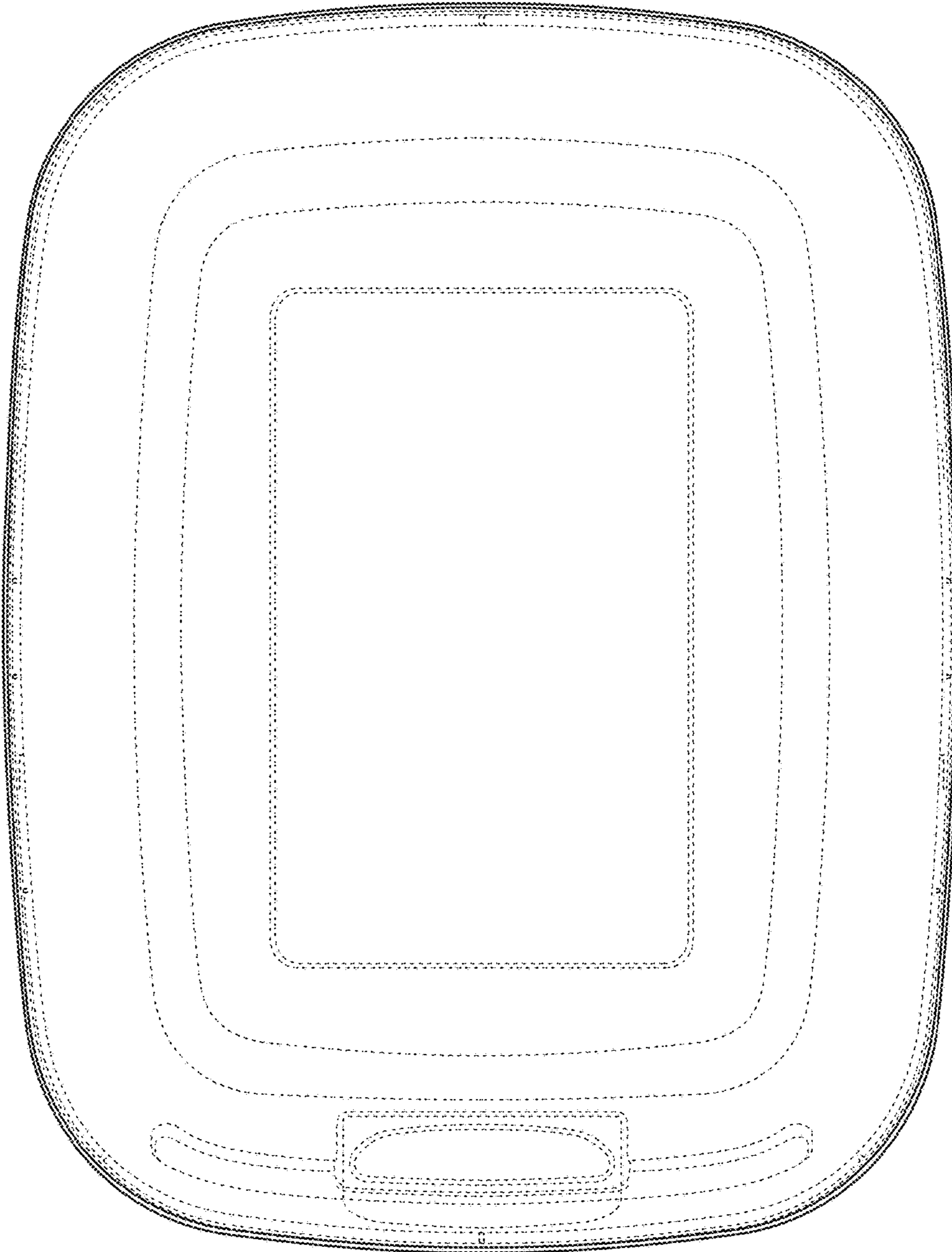

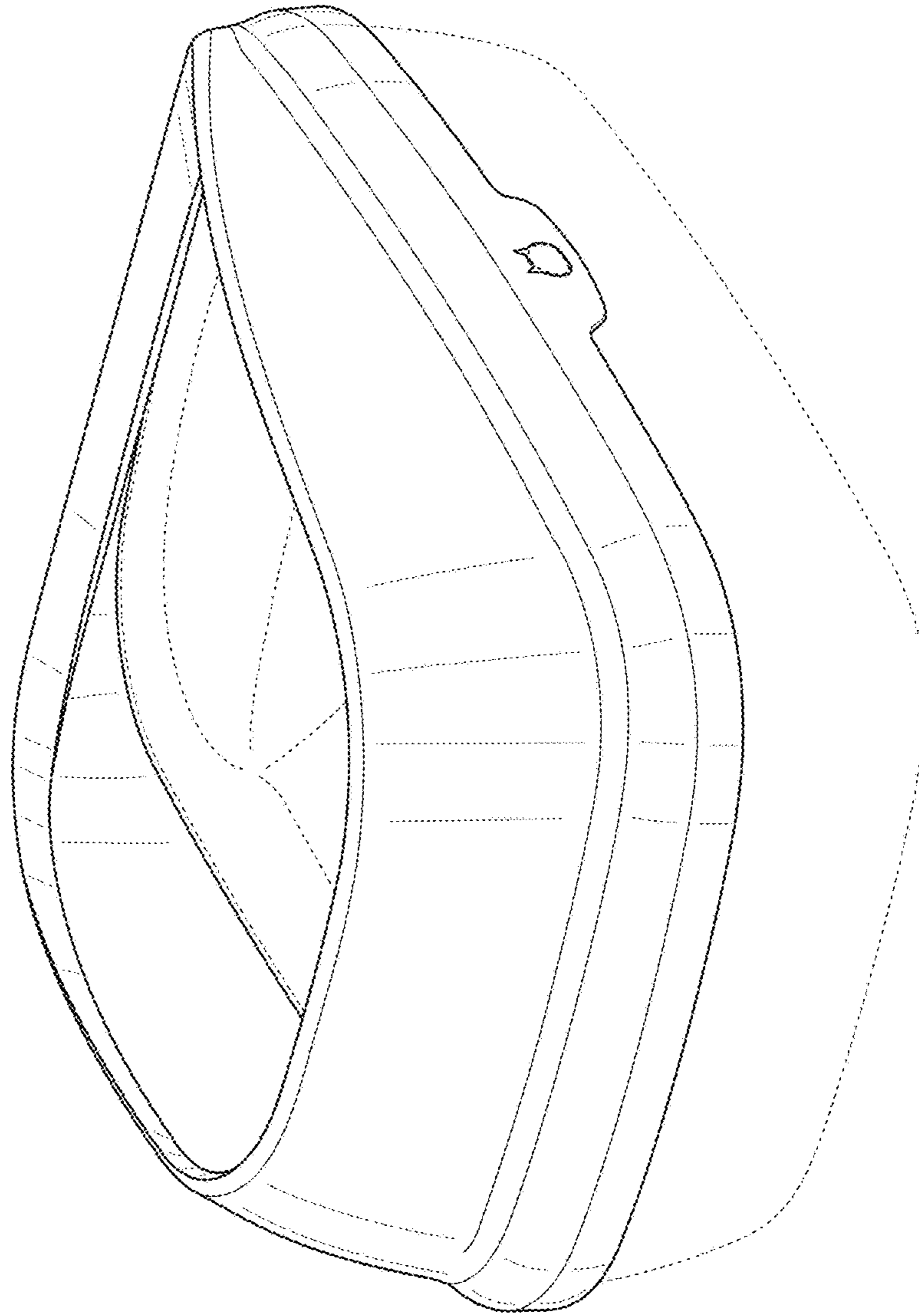
