DESCRIPTION

FIG. 1 is a front elevation view of pants, showing my new design;

FIG. 2 is a rear elevation view thereof;

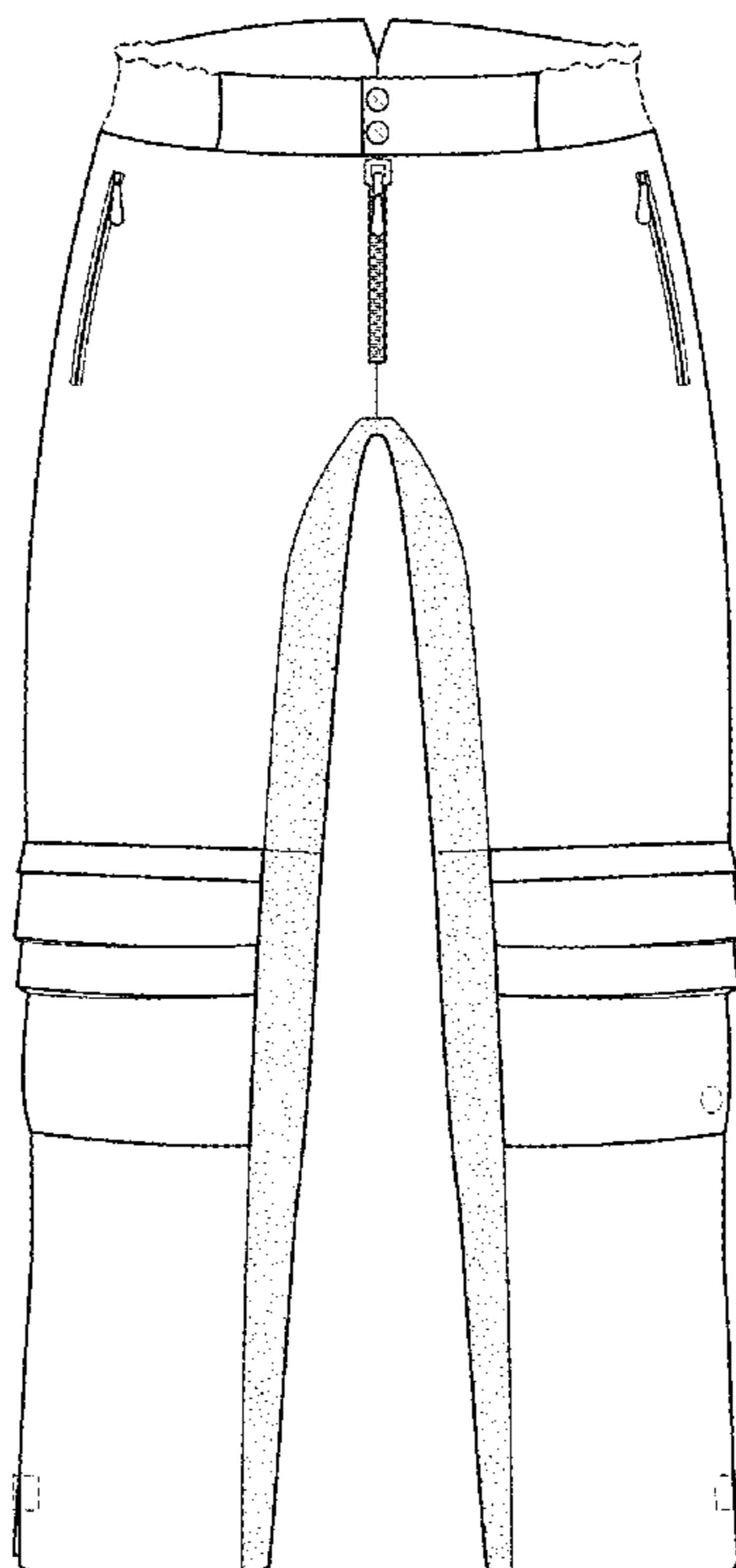
FIG. 3 is a side elevation view thereof;

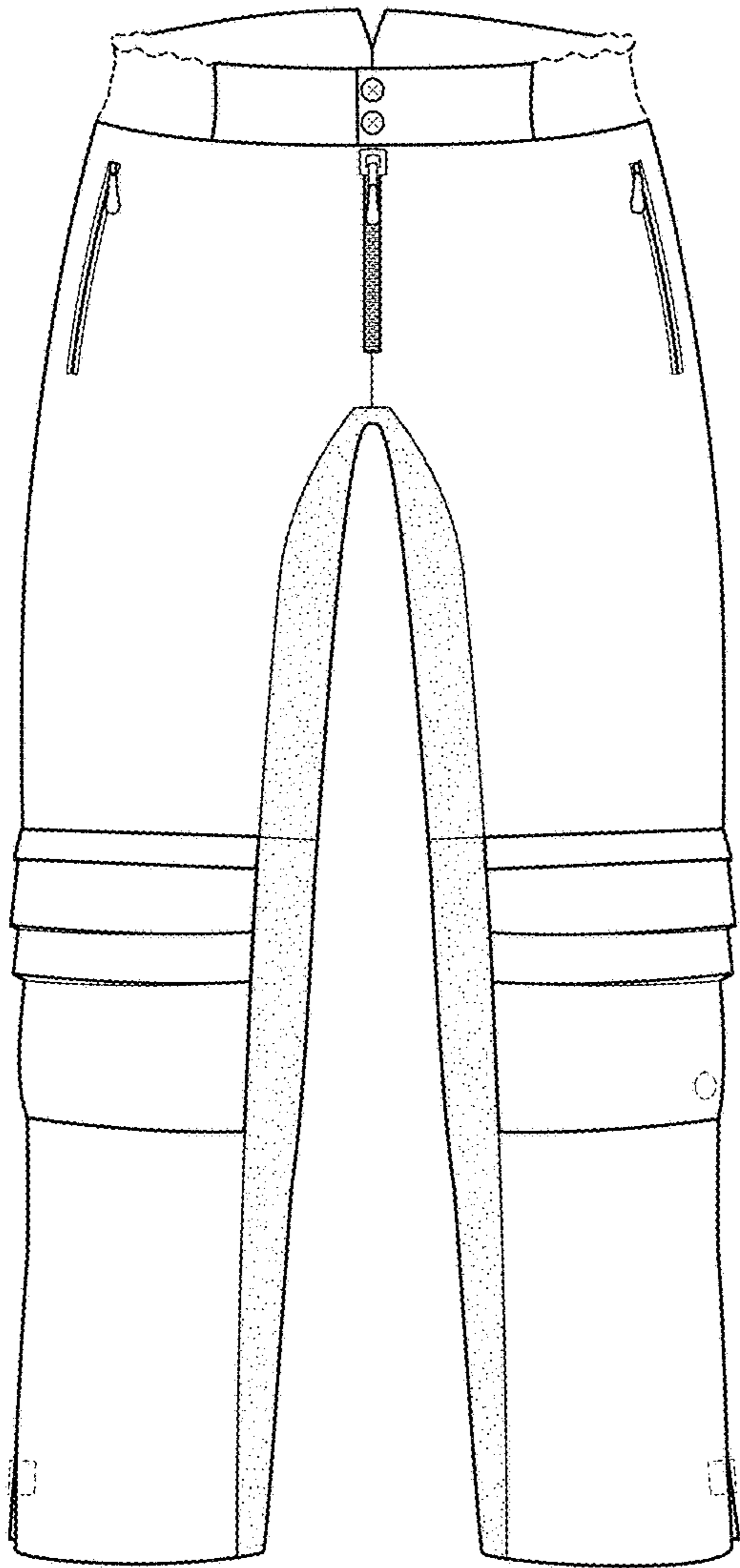

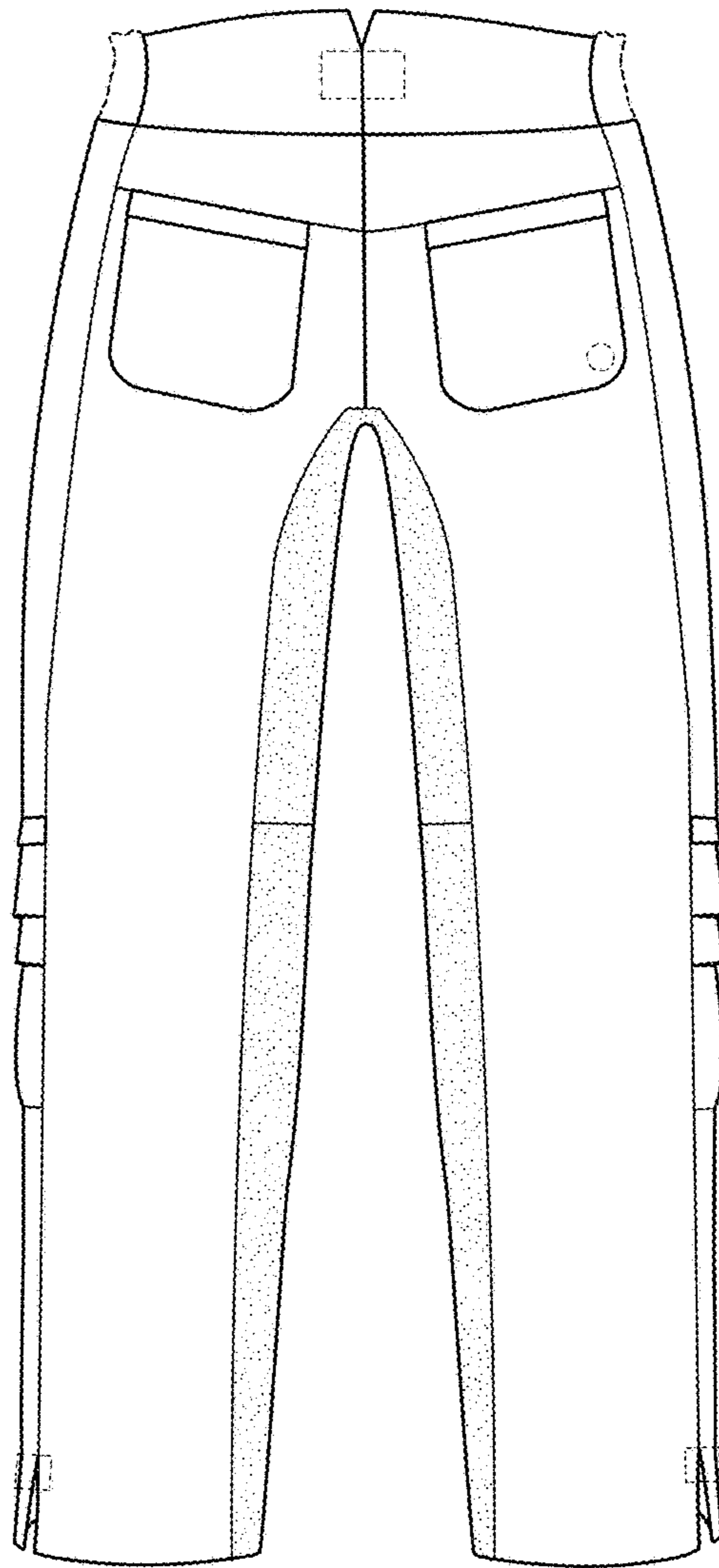

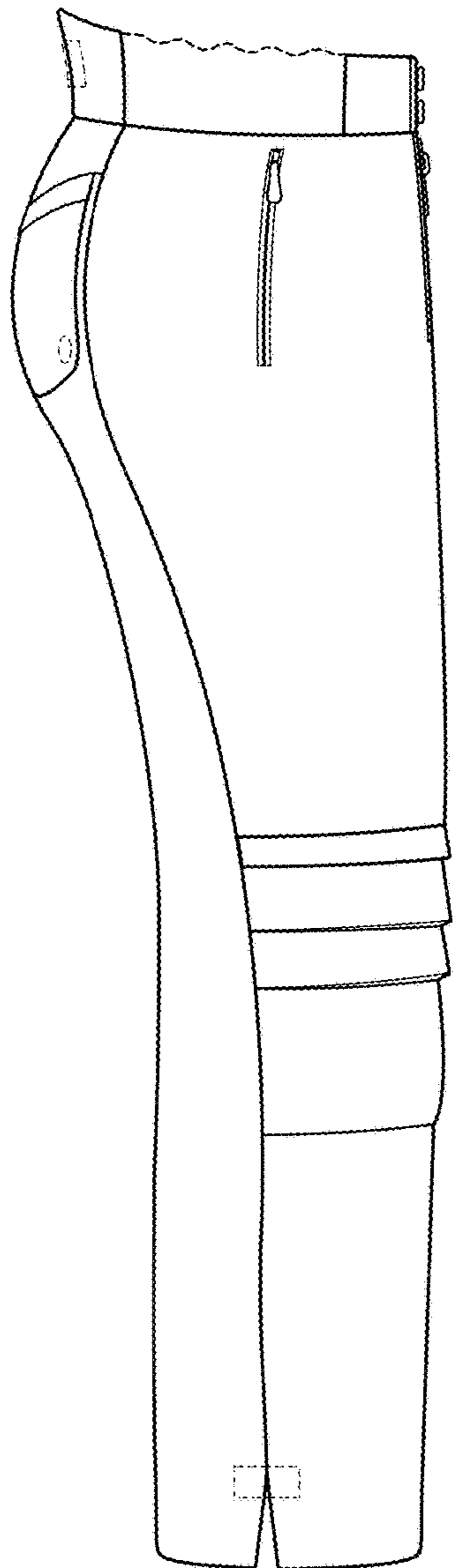

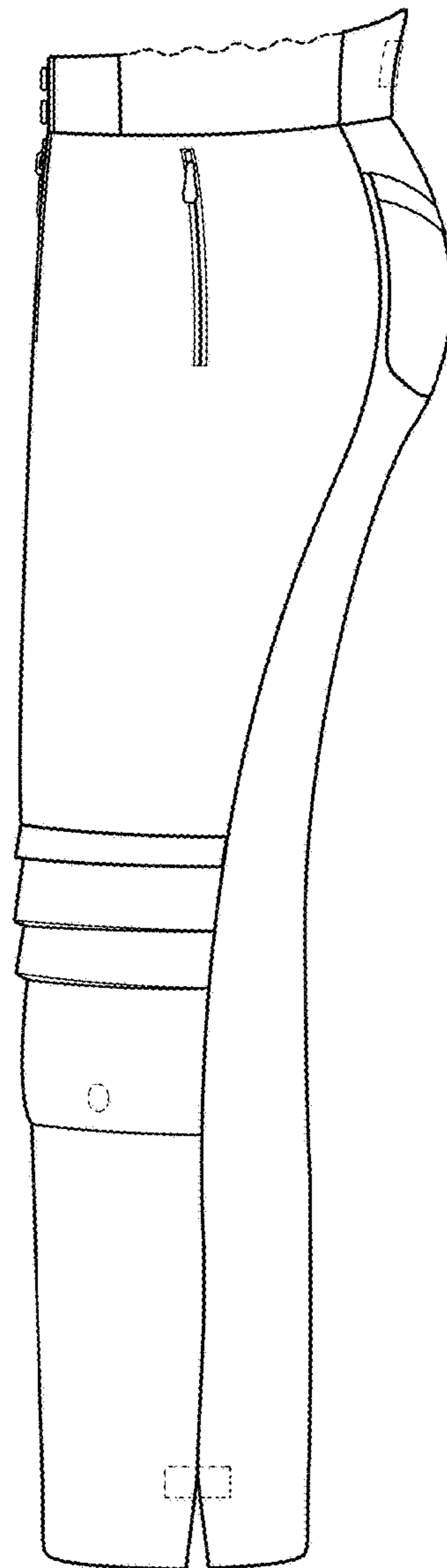

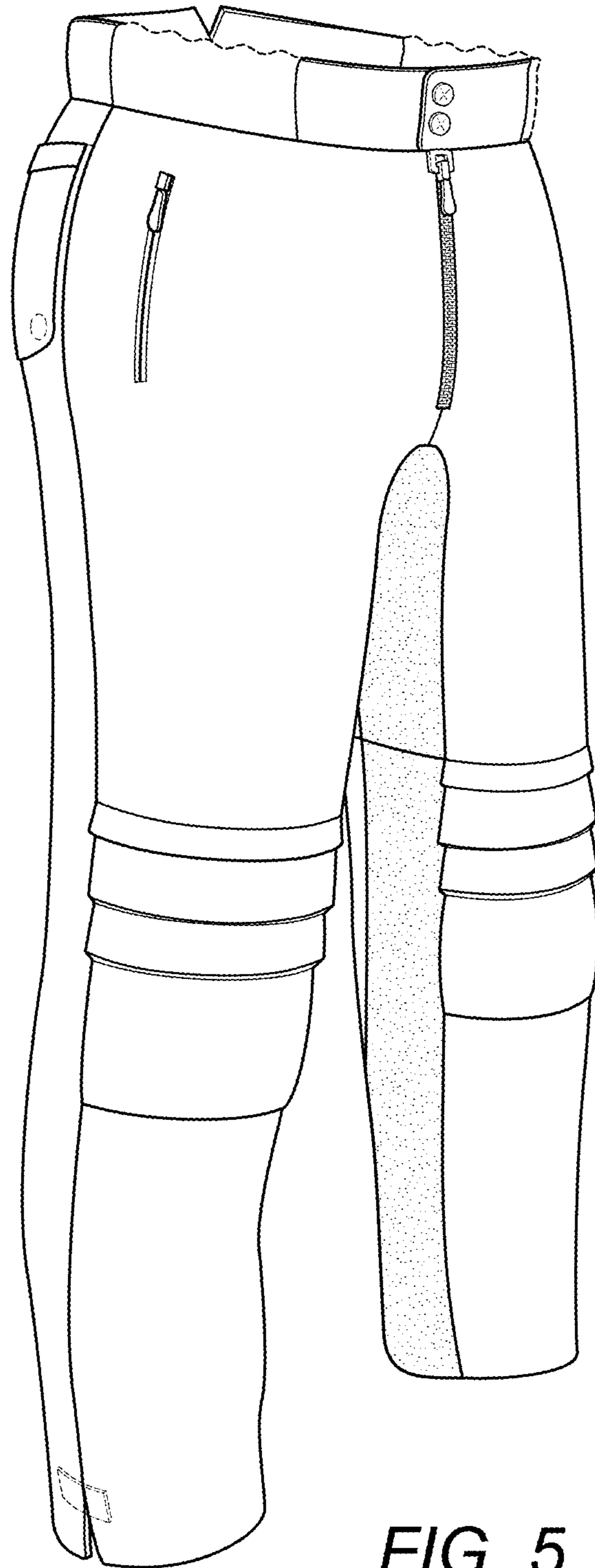
