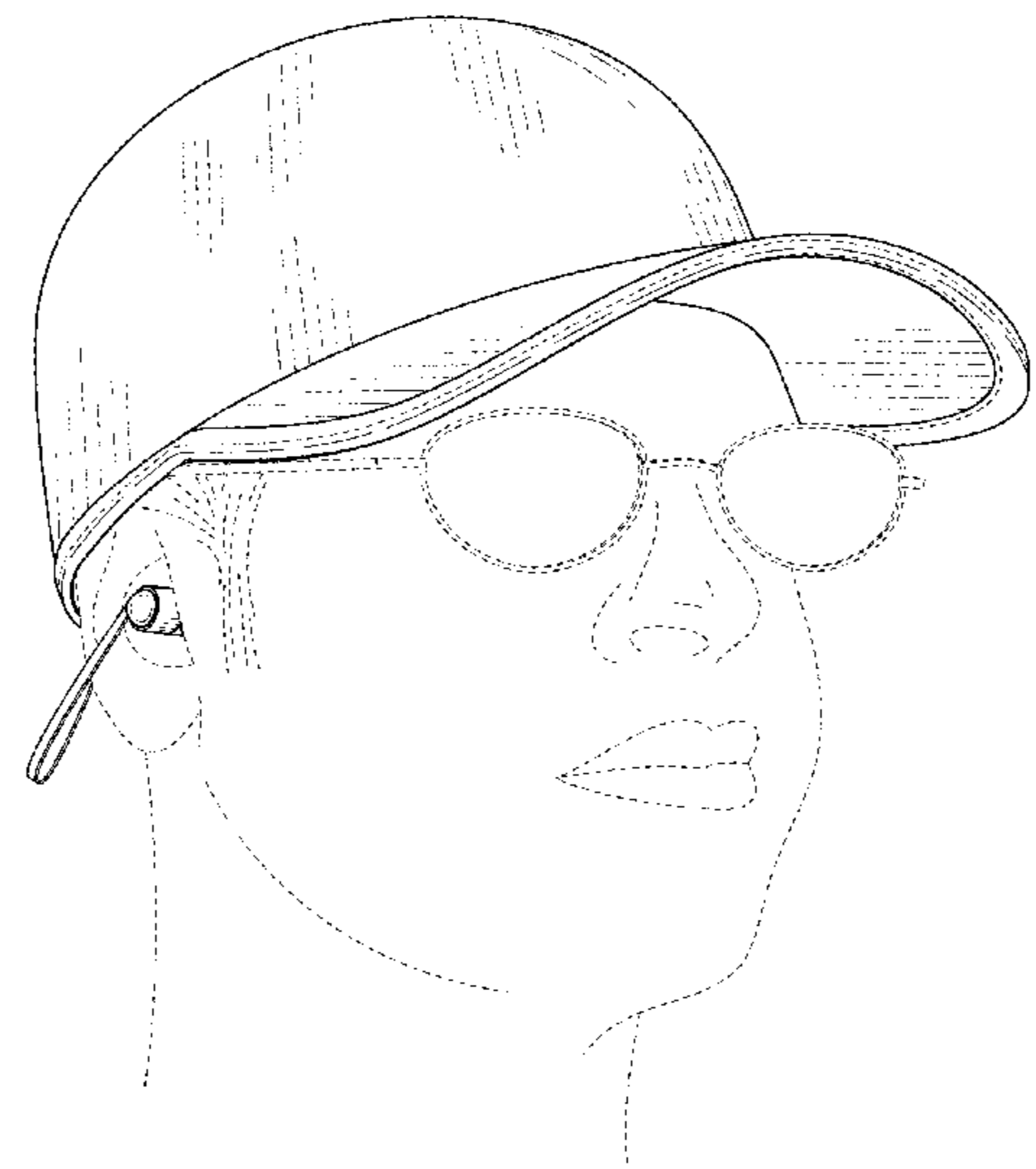

(57) **CLAIM**
The ornamental design for a hat with earphones, as shown and described.

DESCRIPTION
FIG. 1 is a perspective view of a user wearing a first embodiment of a hat with earphones;
FIG. 2 is a top perspective view of the first embodiment of a hat with earphones;
FIG. 3 is a first side elevation view thereof;
FIG. 4 is a second side elevation view thereof;
FIG. 5 is a front elevation view thereof;
FIG. 6 is a rear elevation view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof;
FIG. 9 is a perspective view of a user wearing a second embodiment of a hat with earphones;
FIG. 10 is a top perspective view of the second embodiment of a hat with earphones;
FIG. 11 is a first side elevation view thereof;

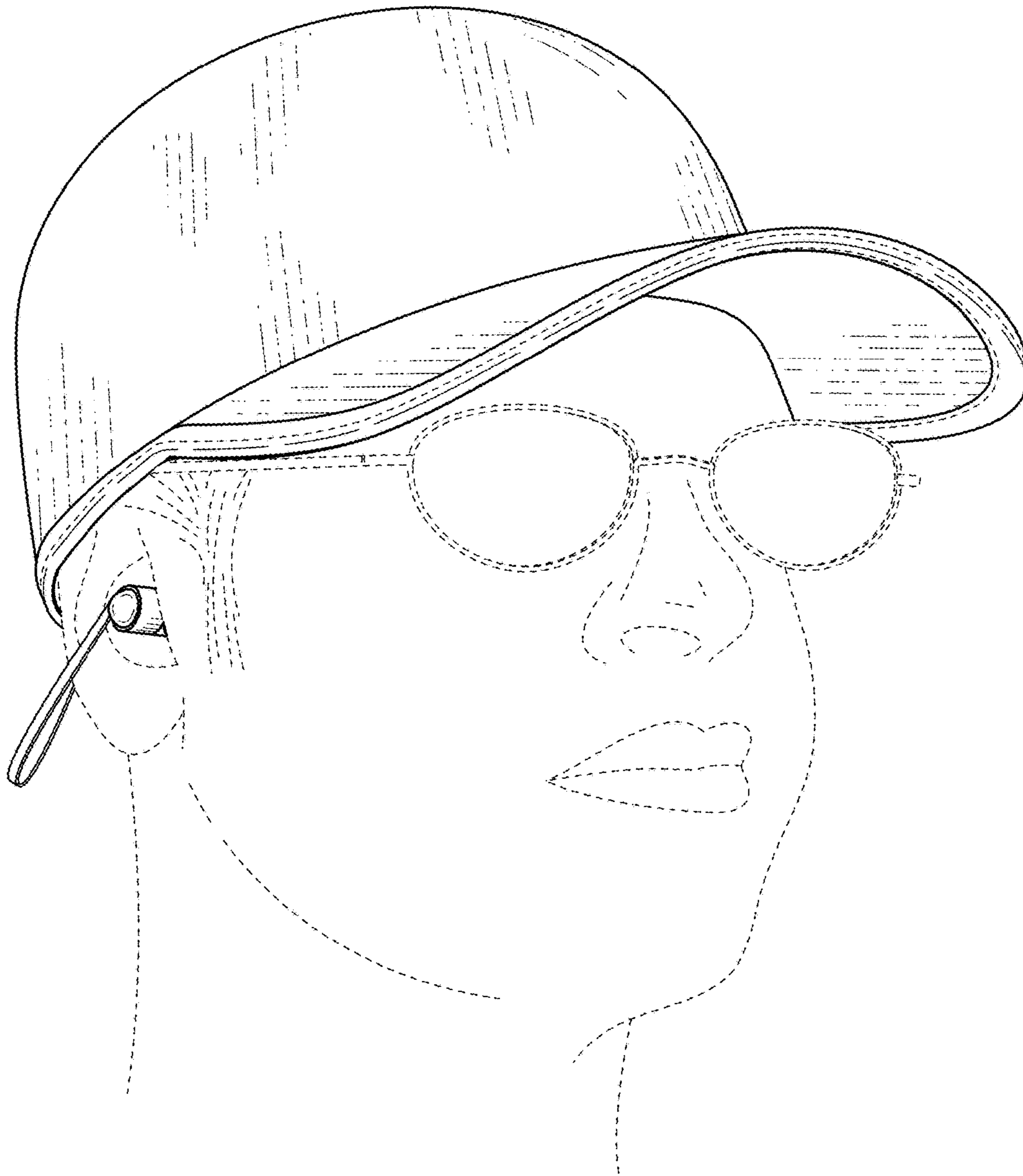

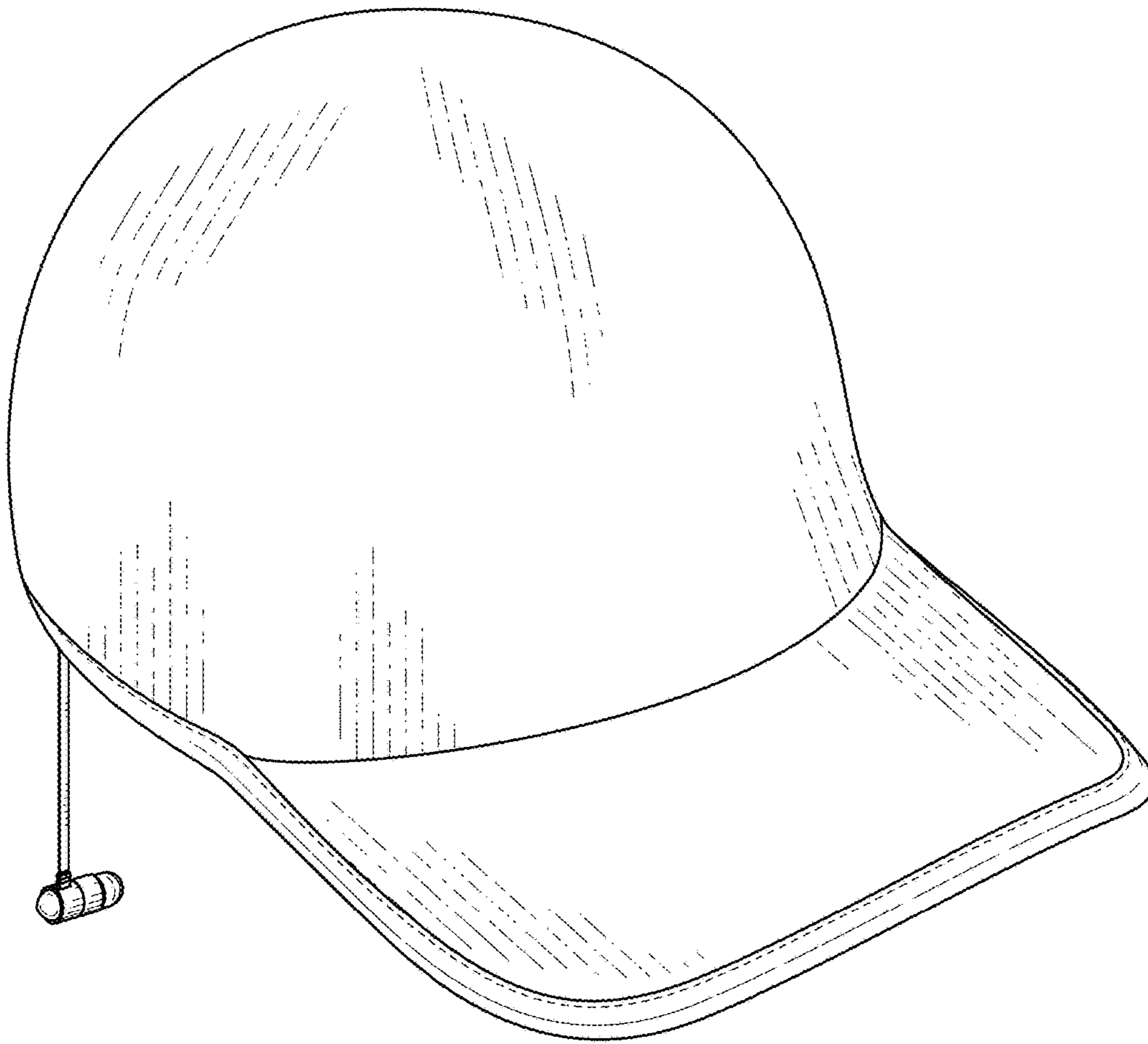

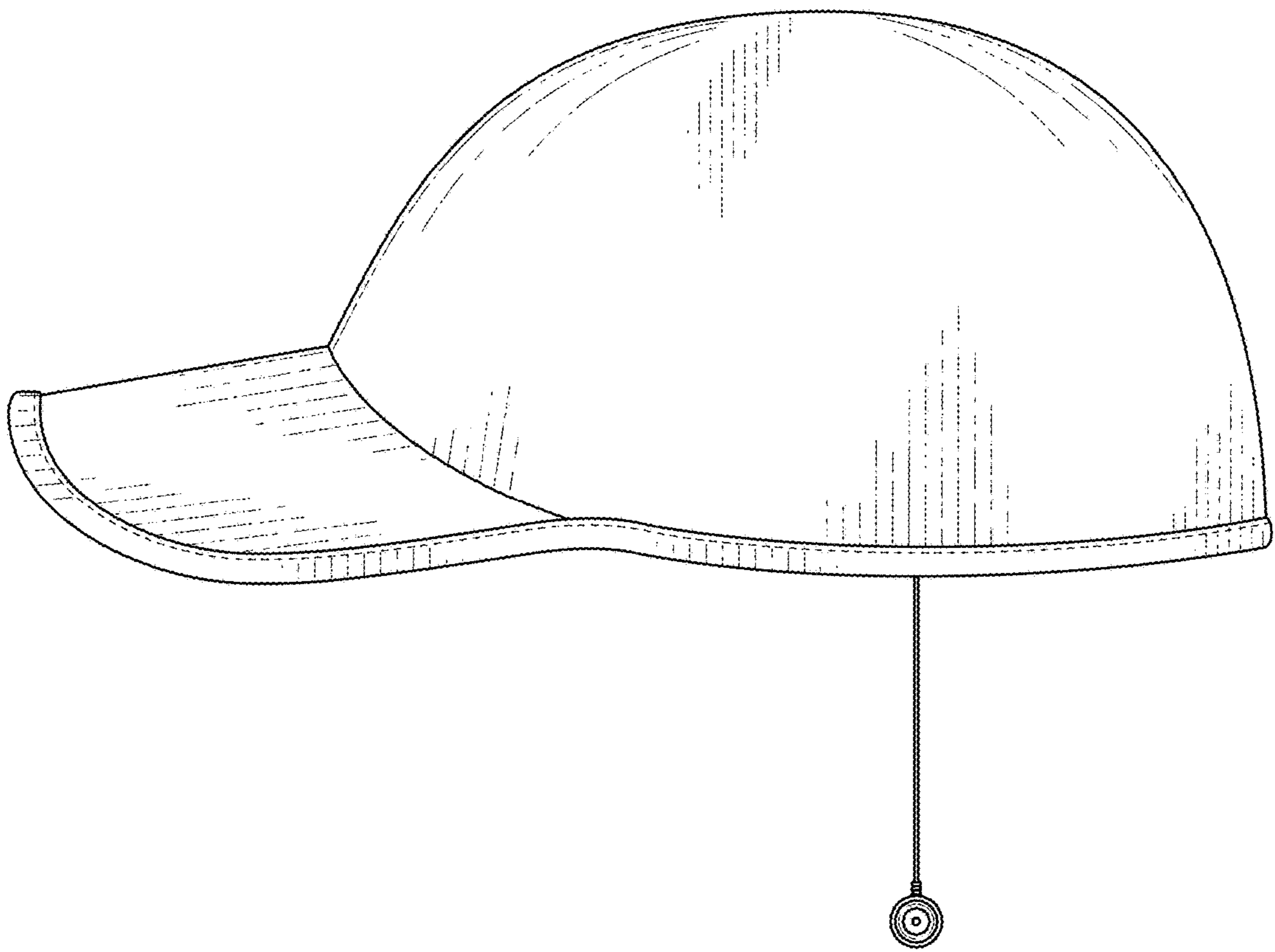

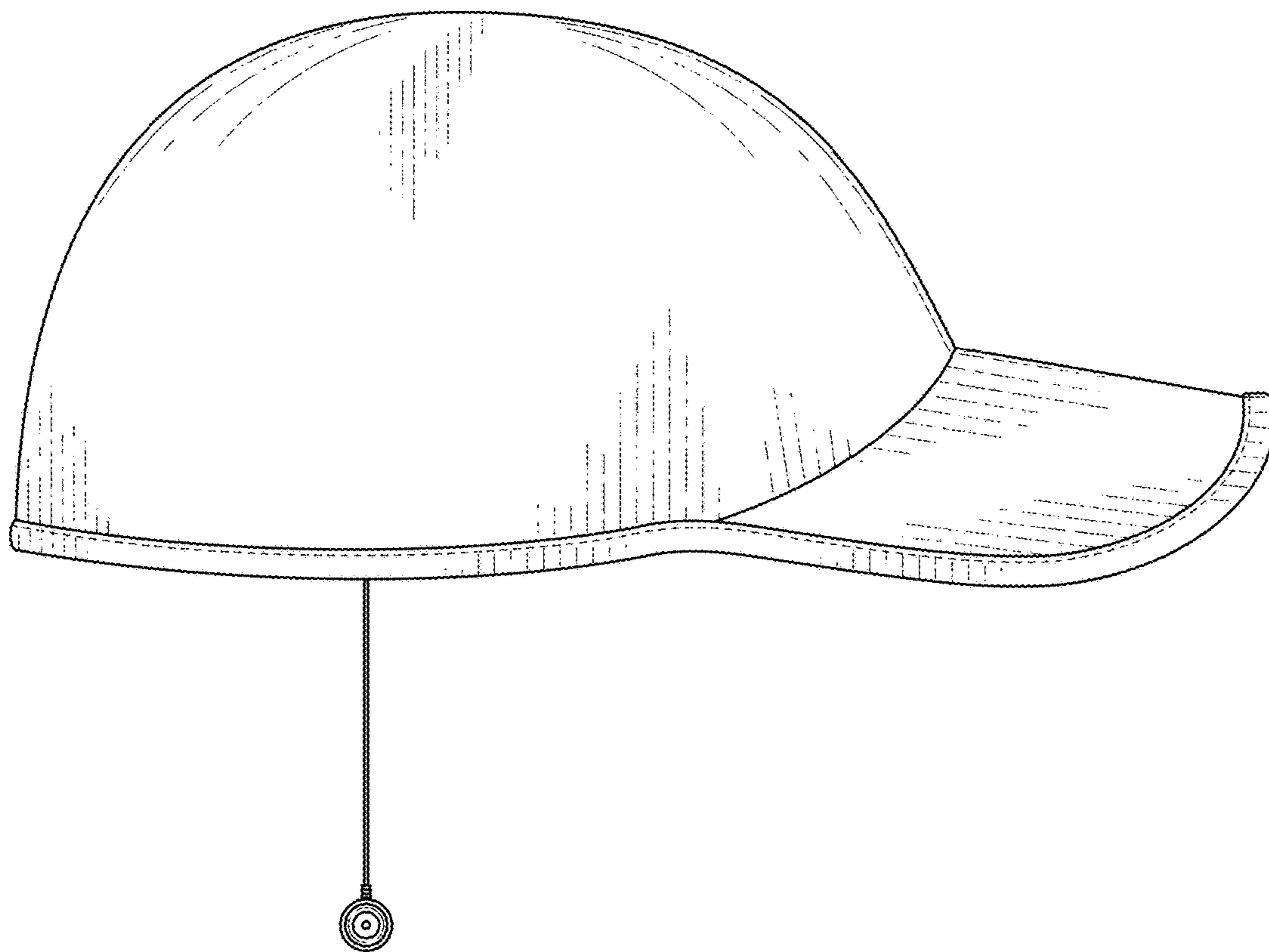

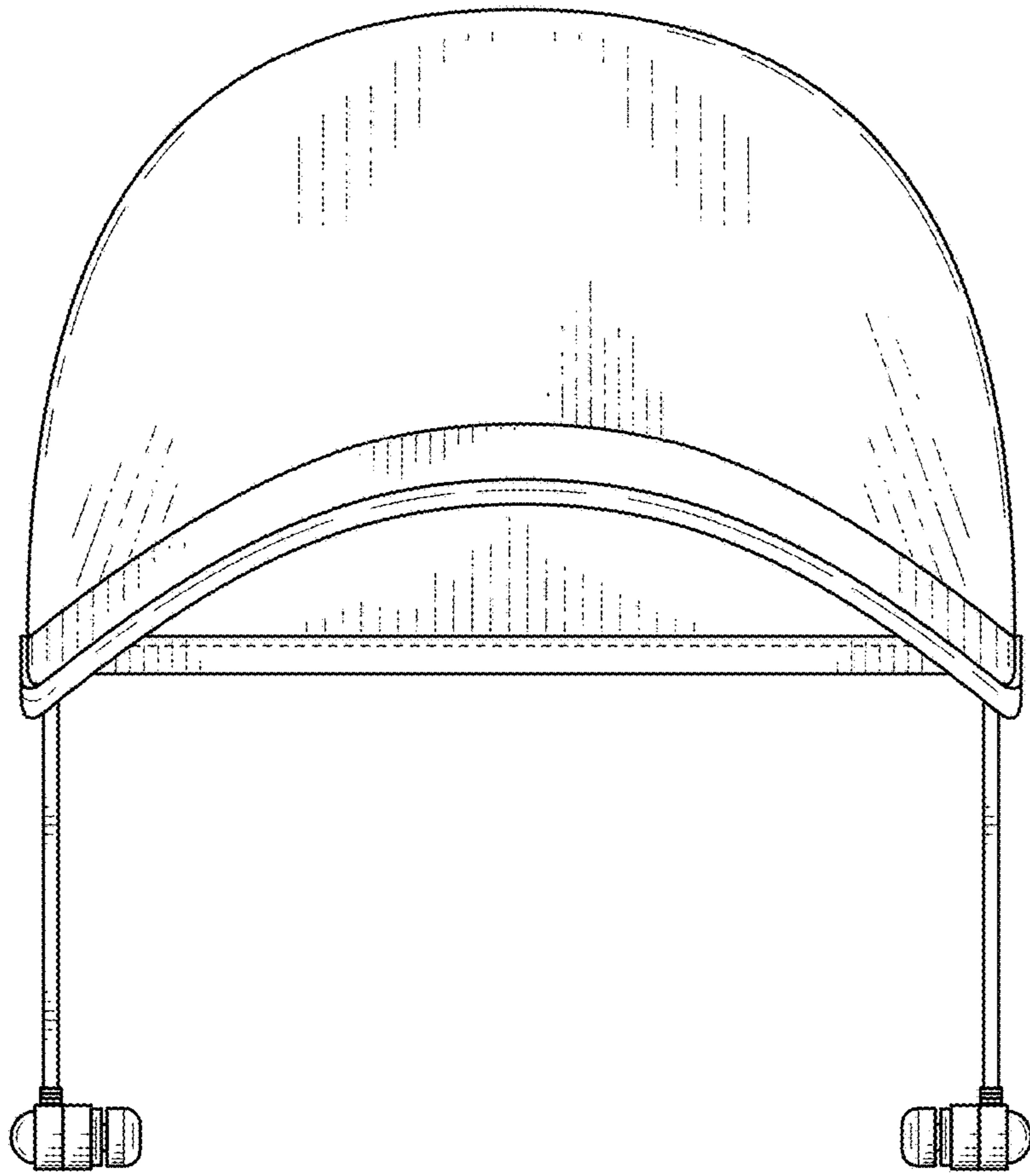

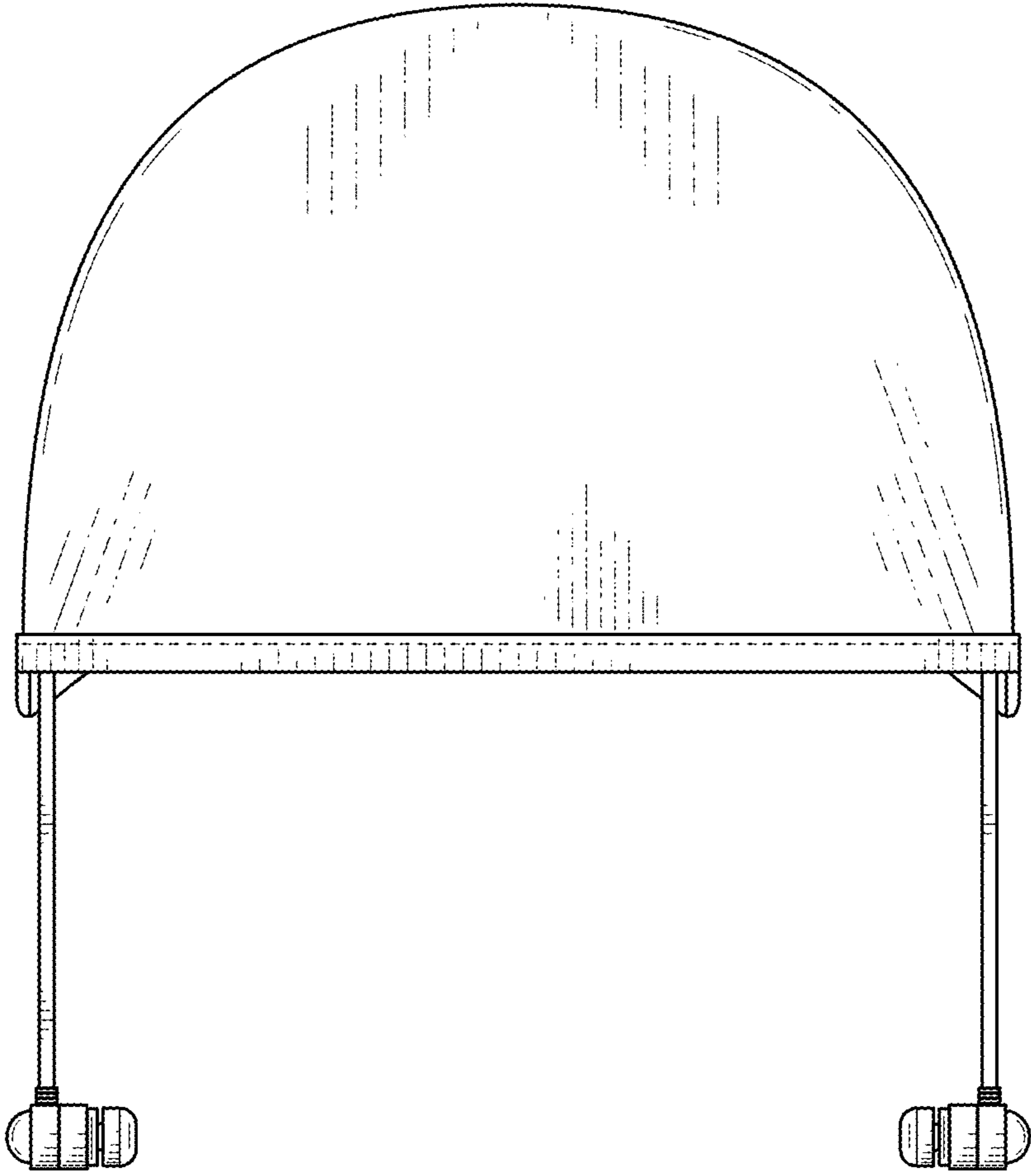

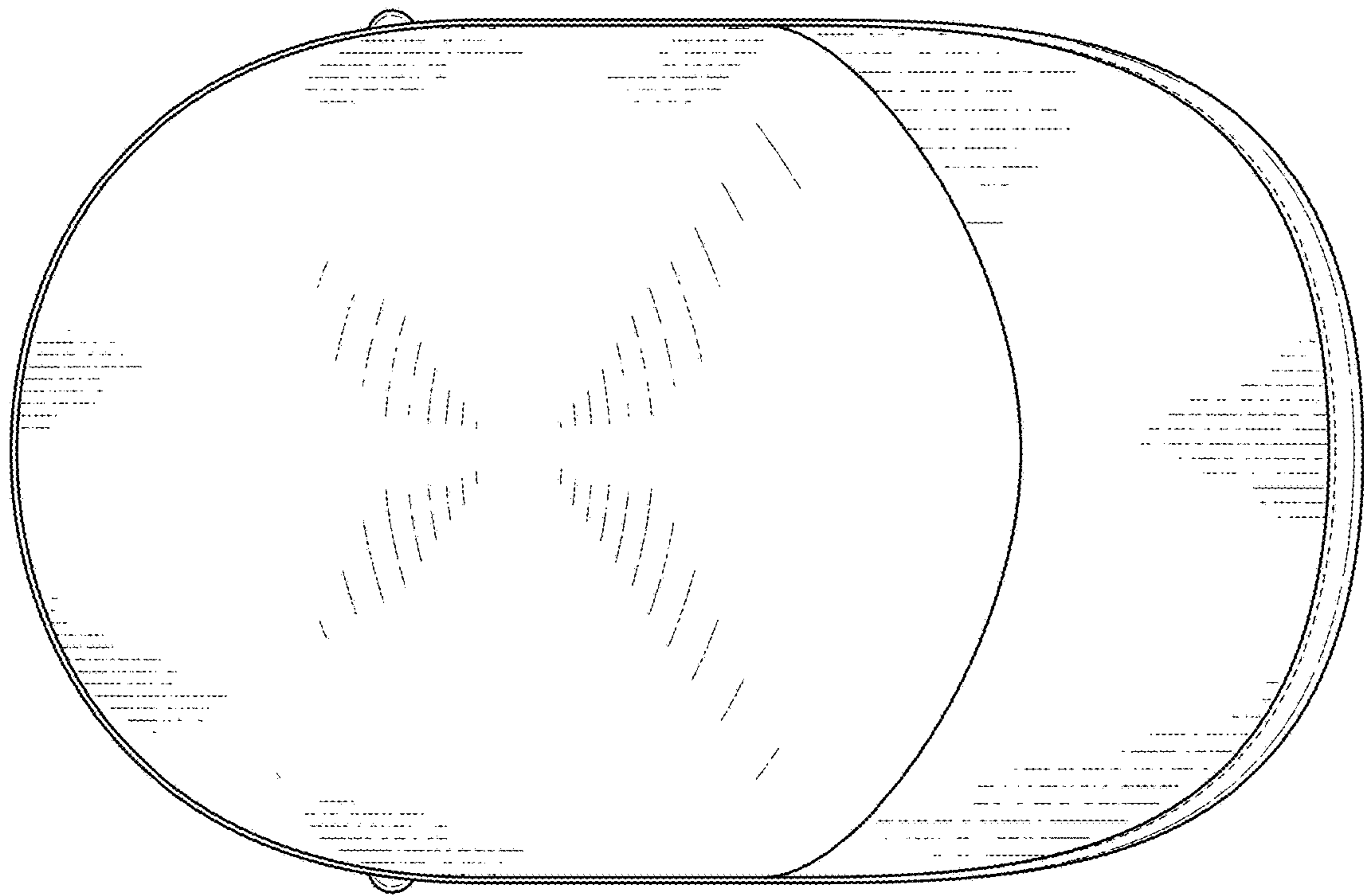

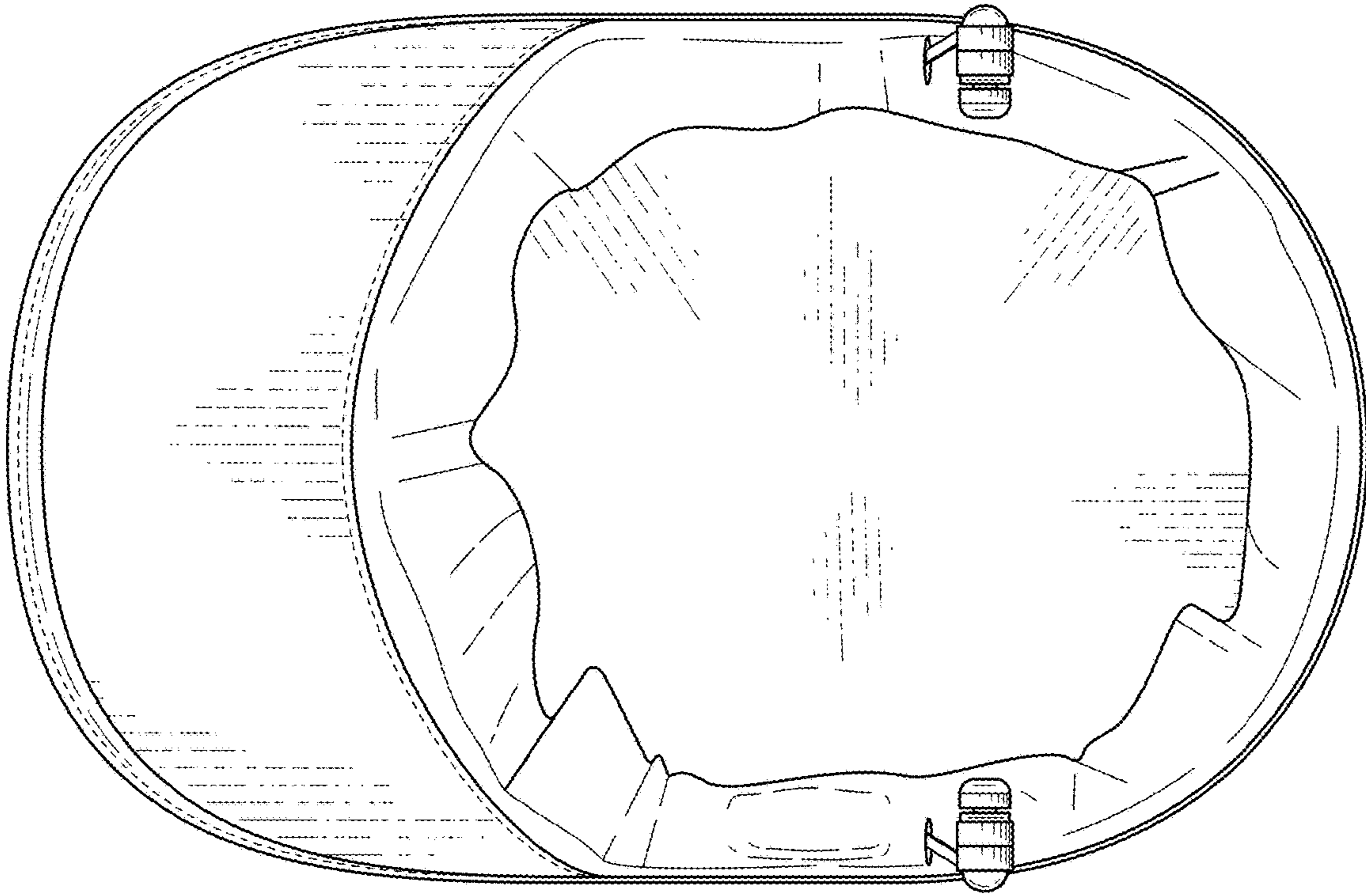

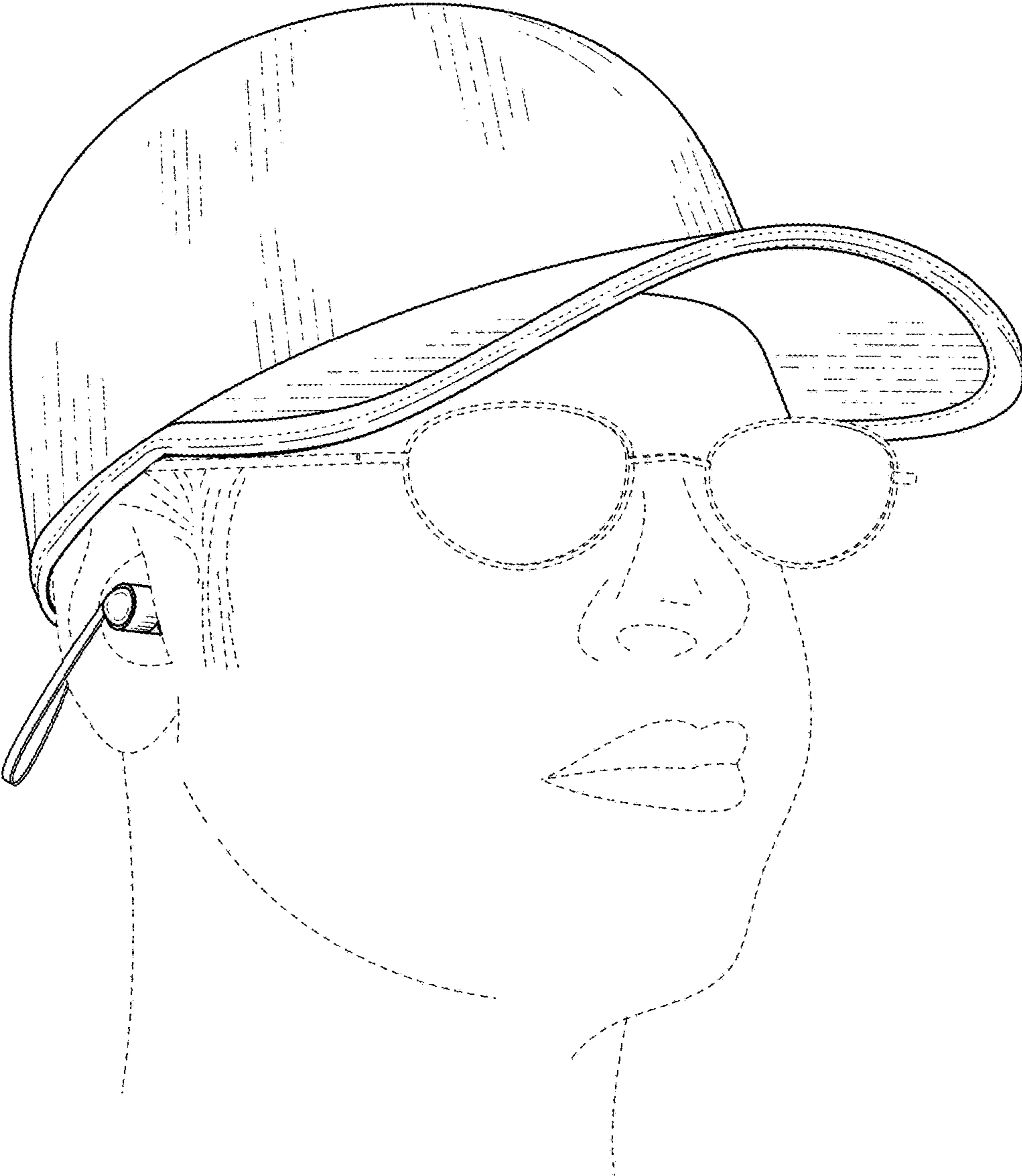

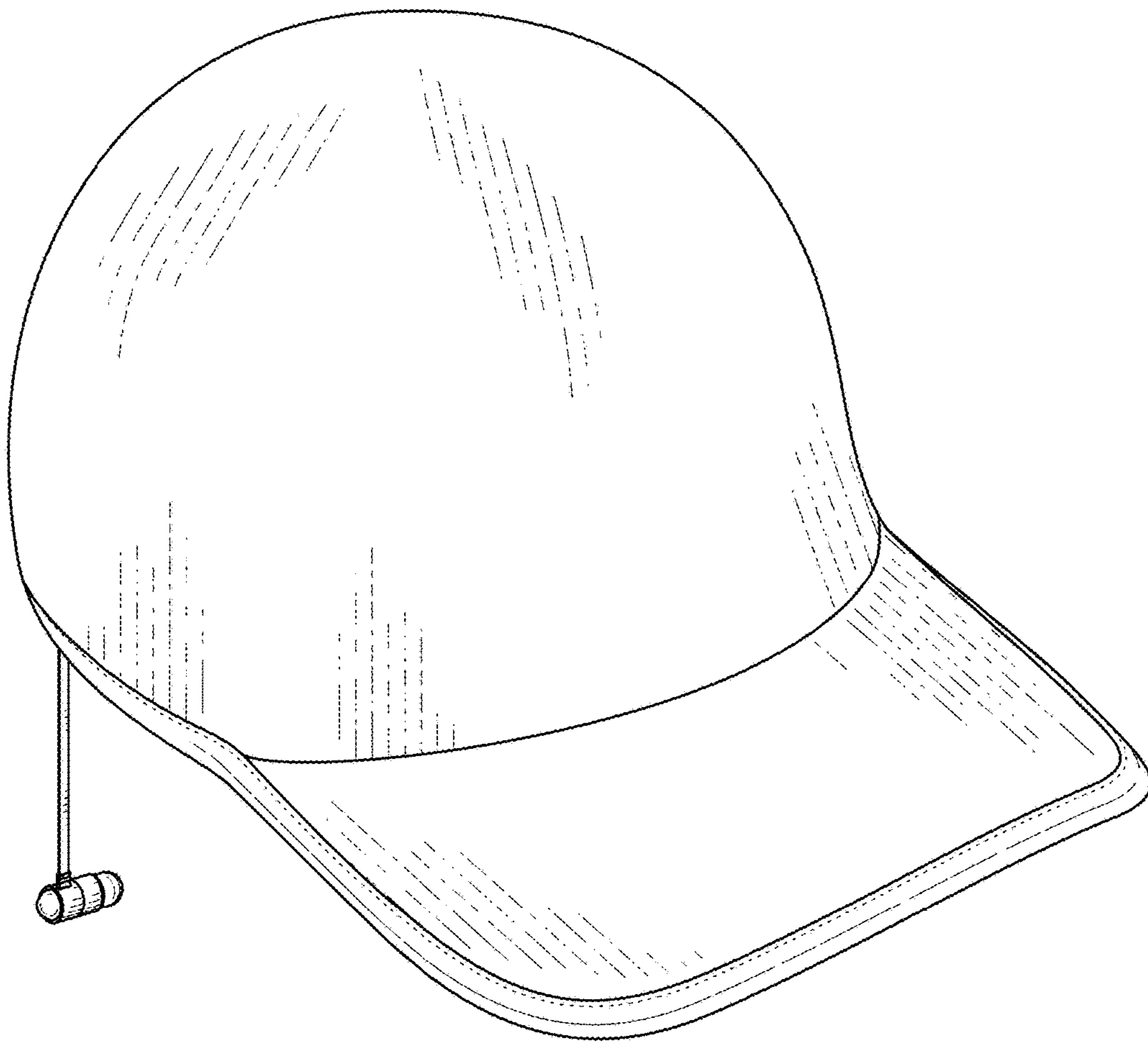

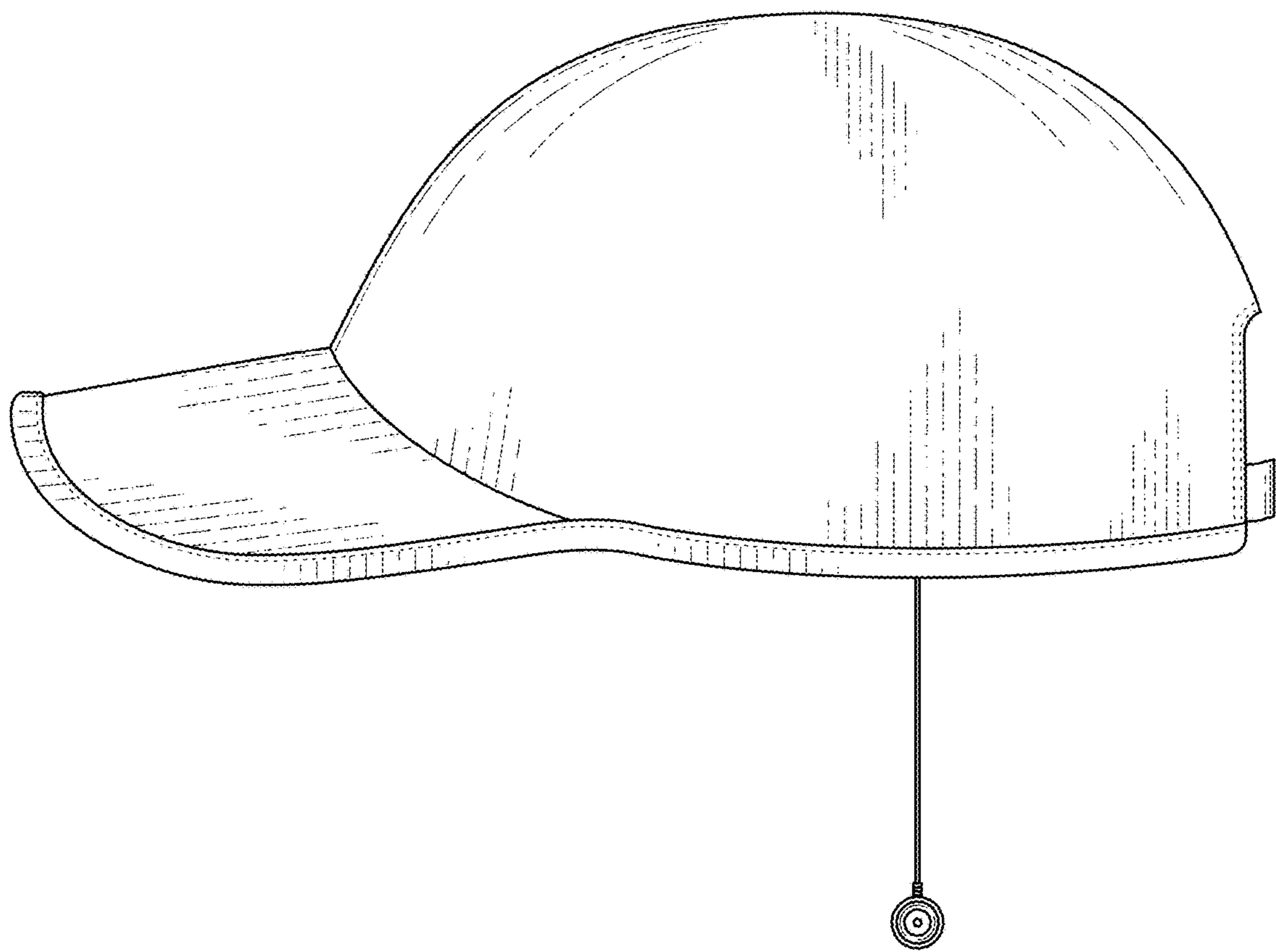

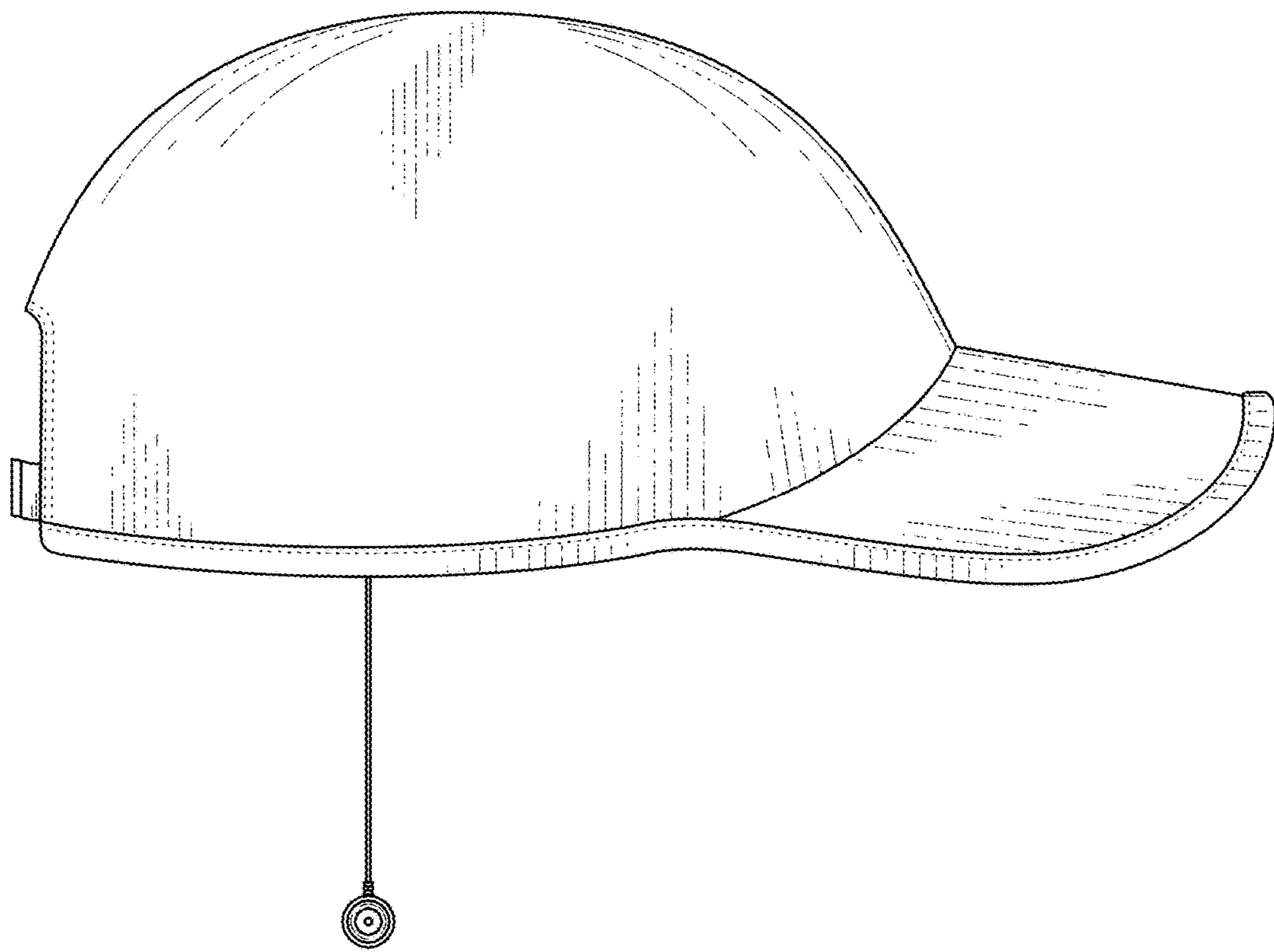

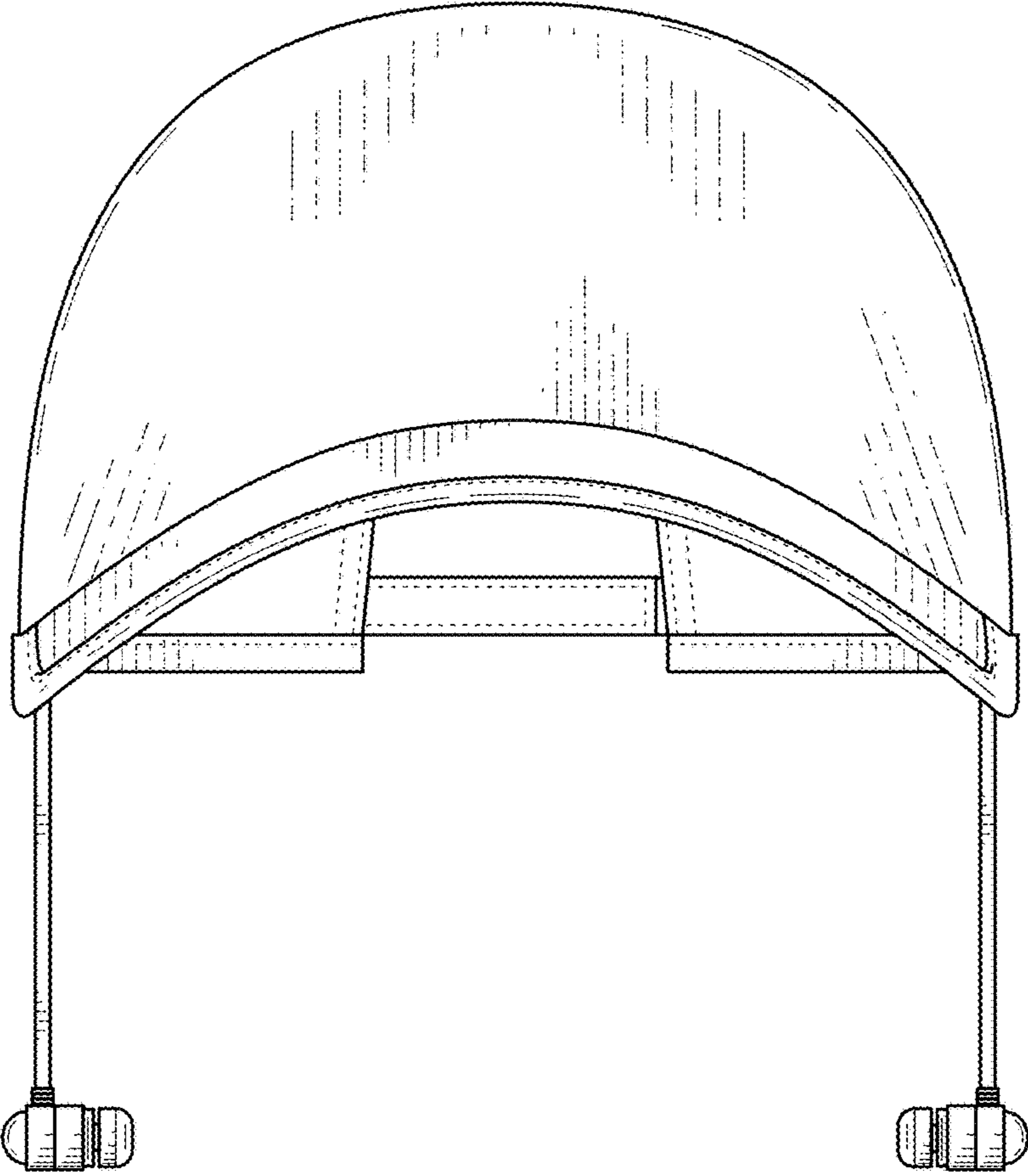

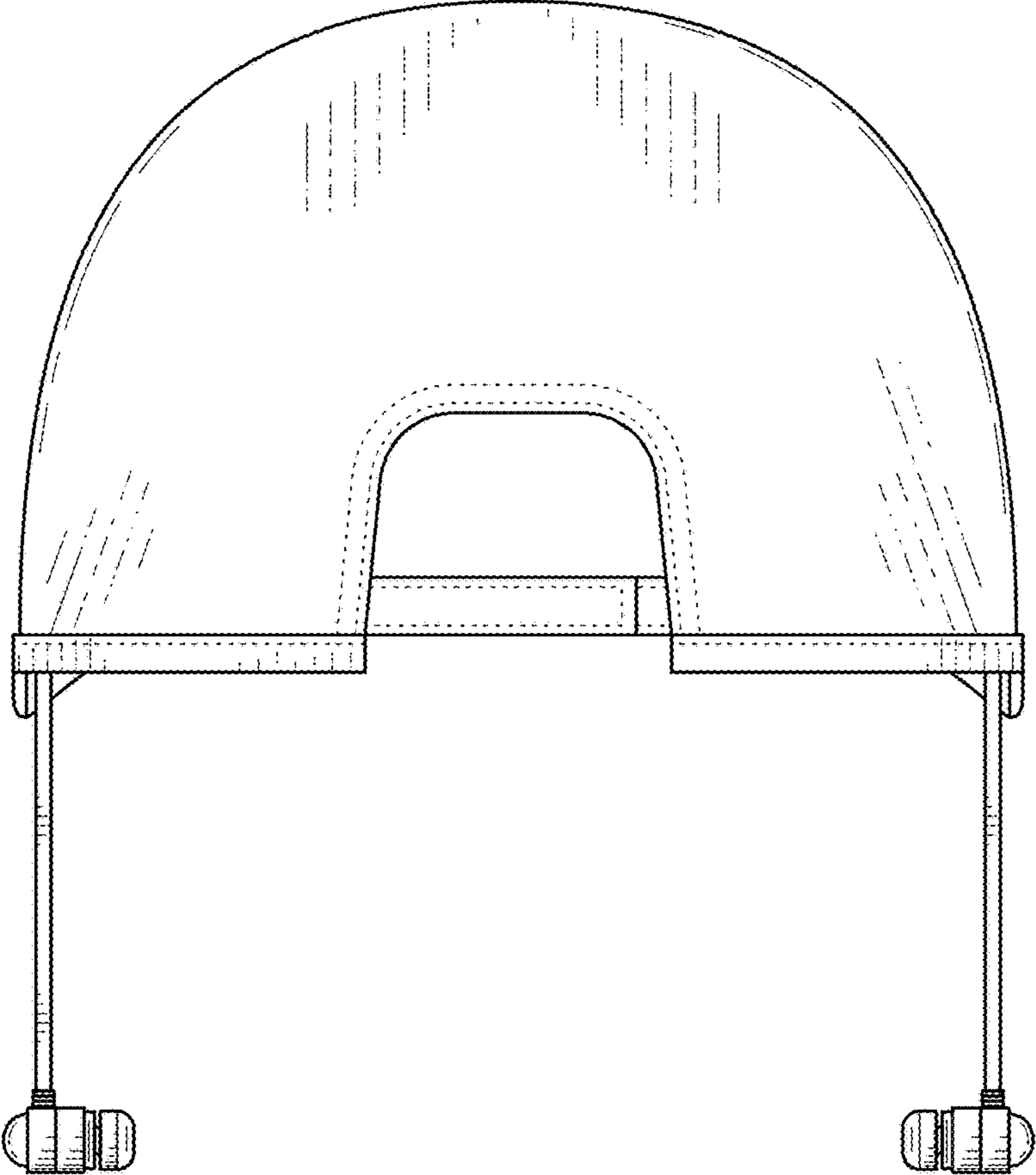

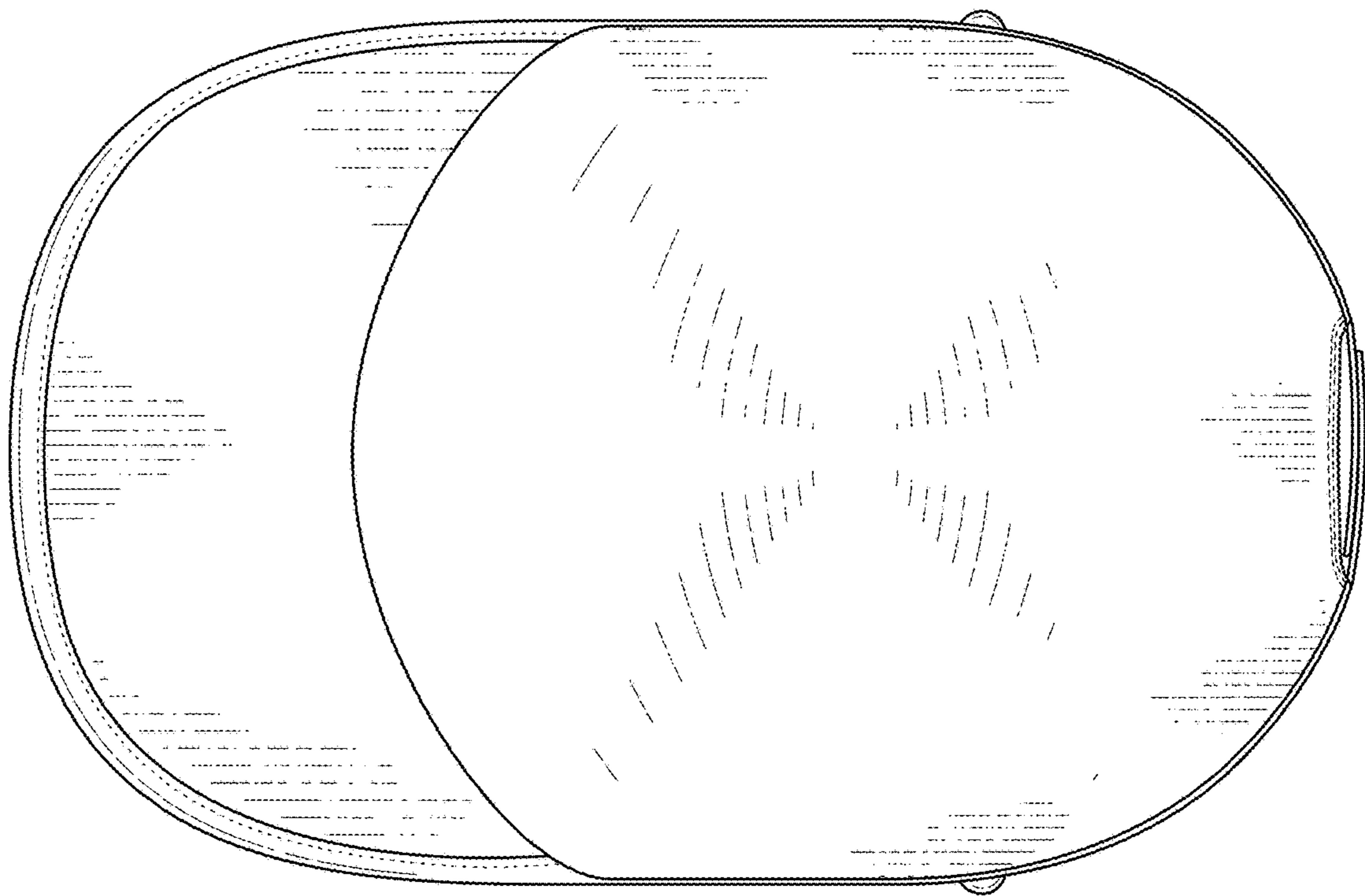

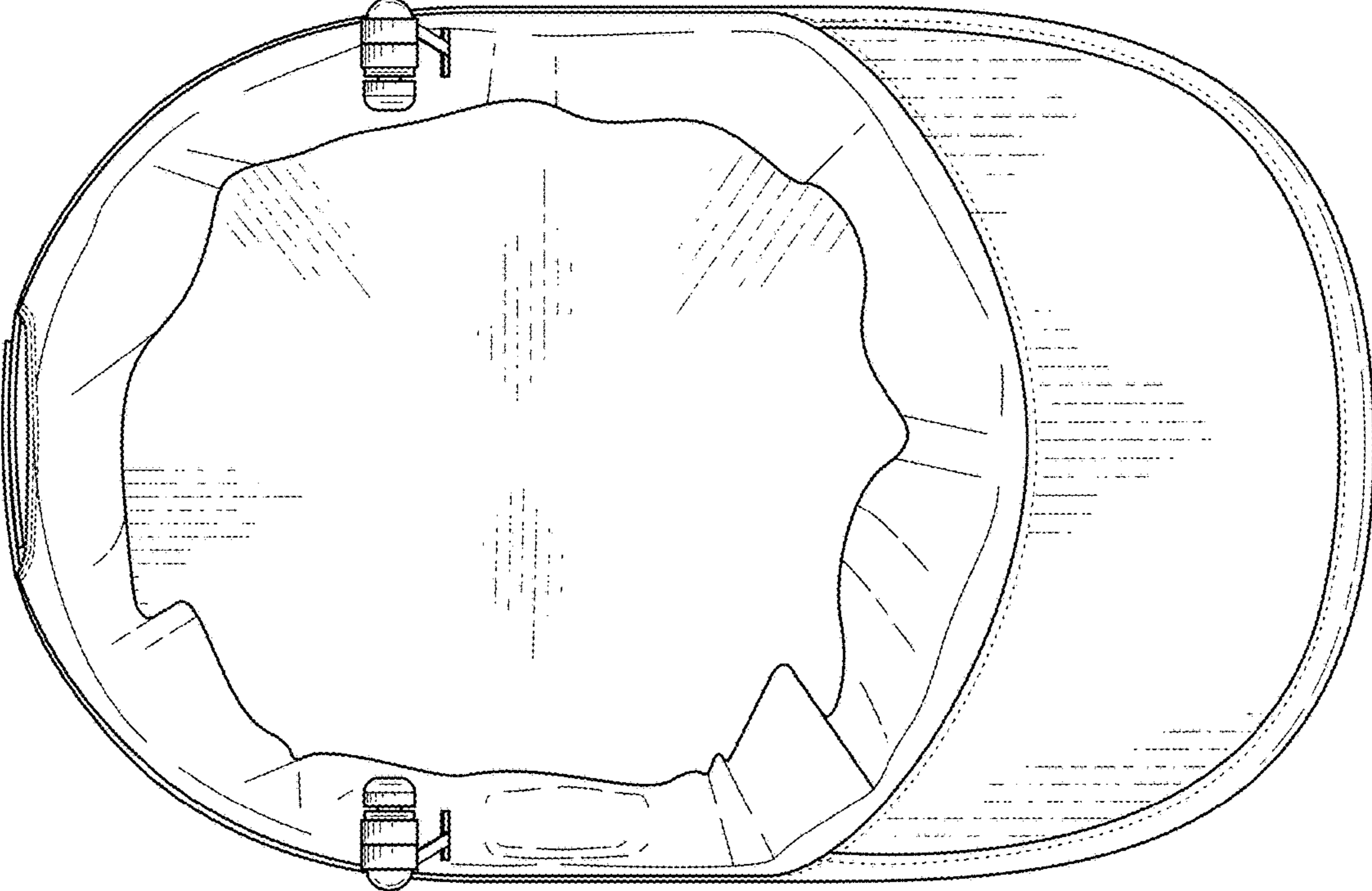
