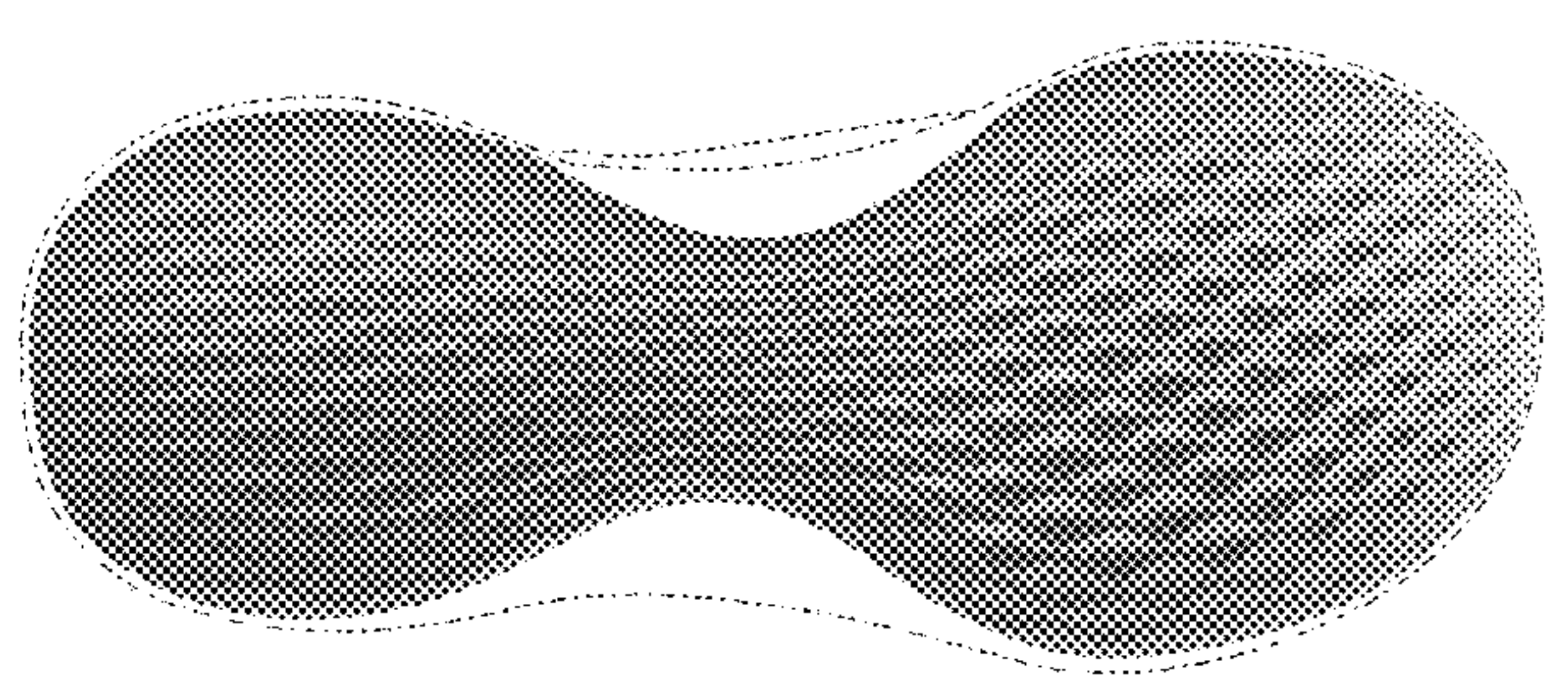
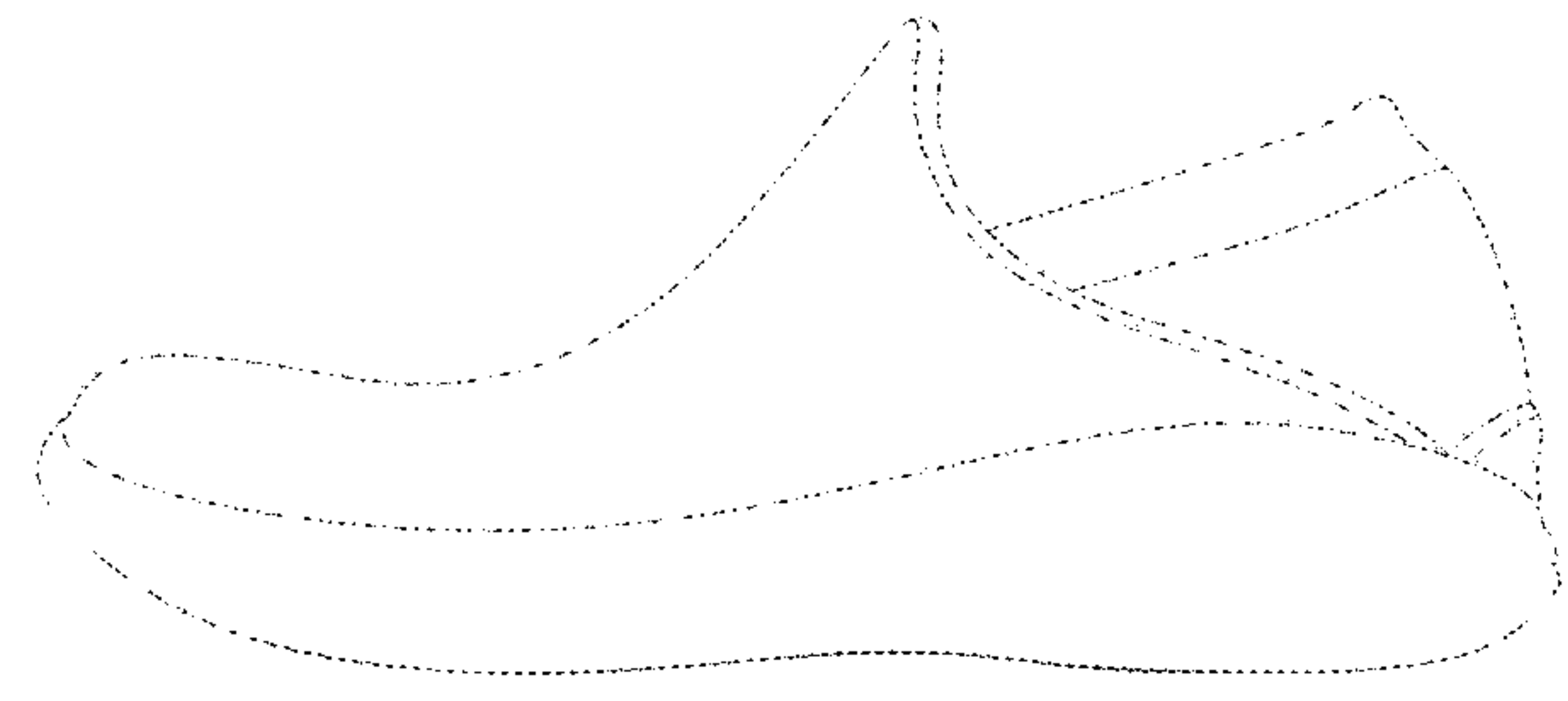

FIG. 1 is a perspective view of a shoe outsole bottom in accordance with my new design.

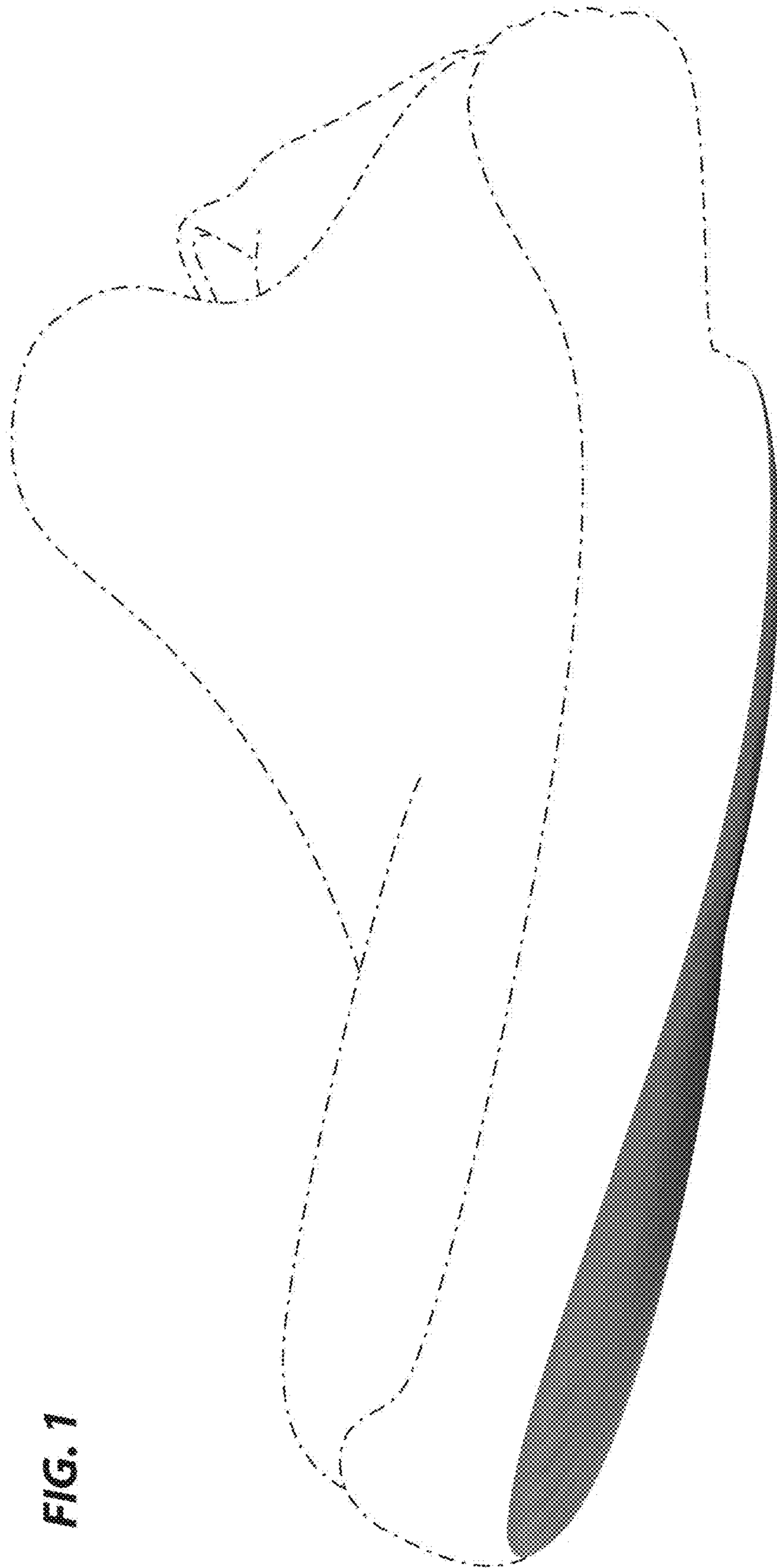
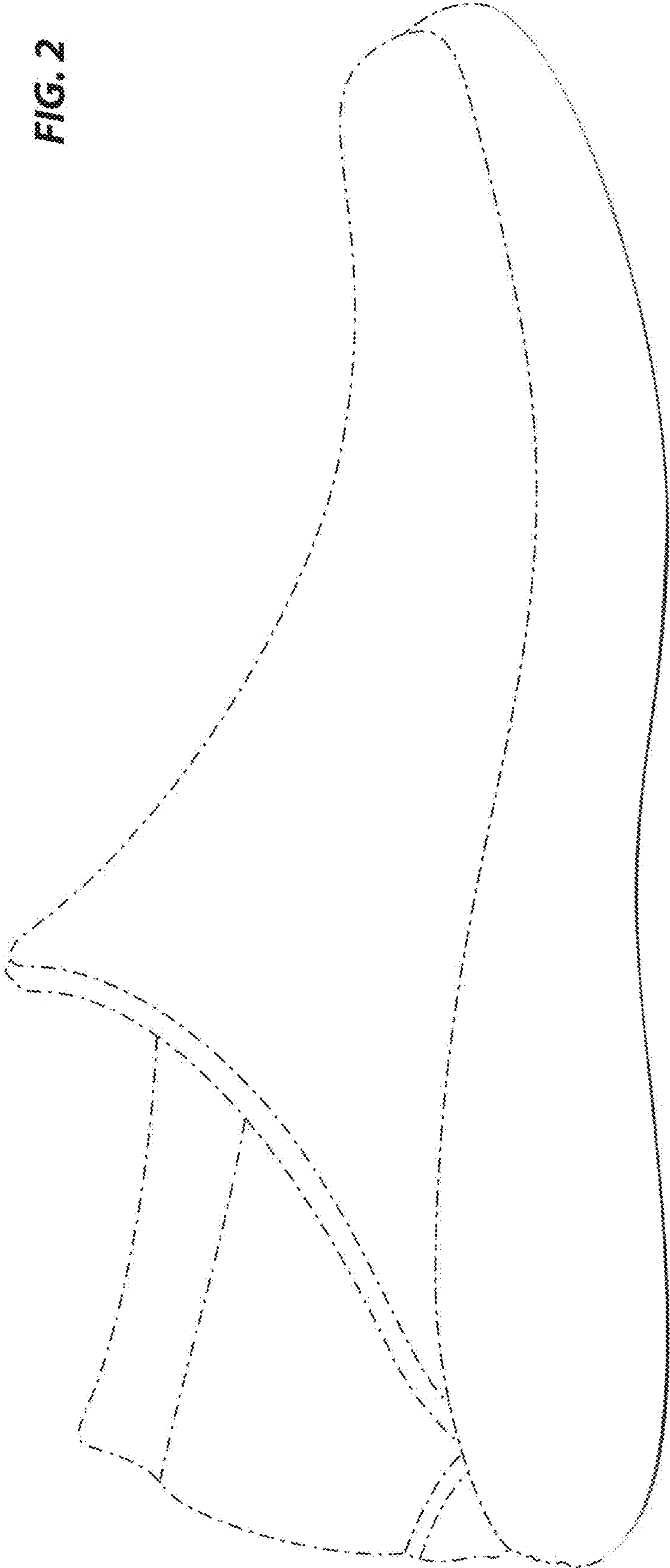

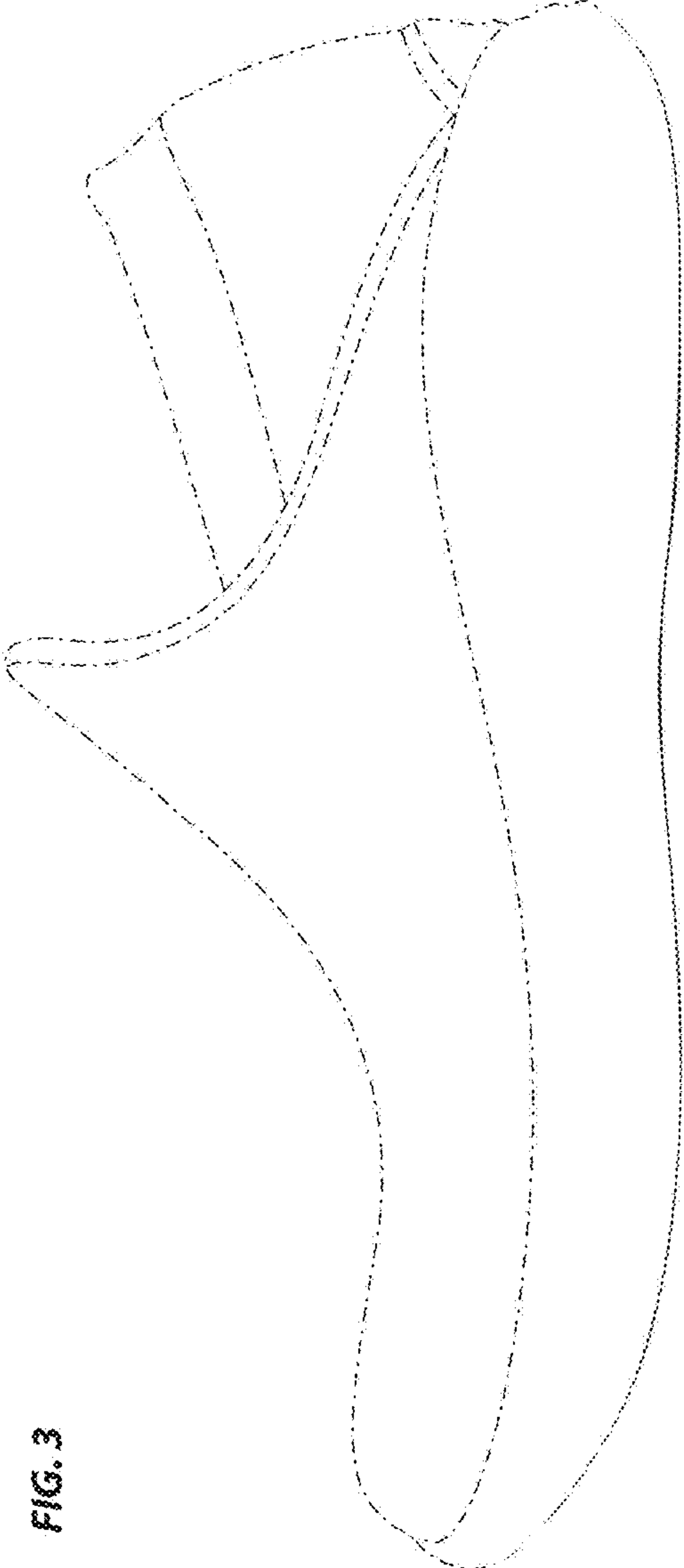

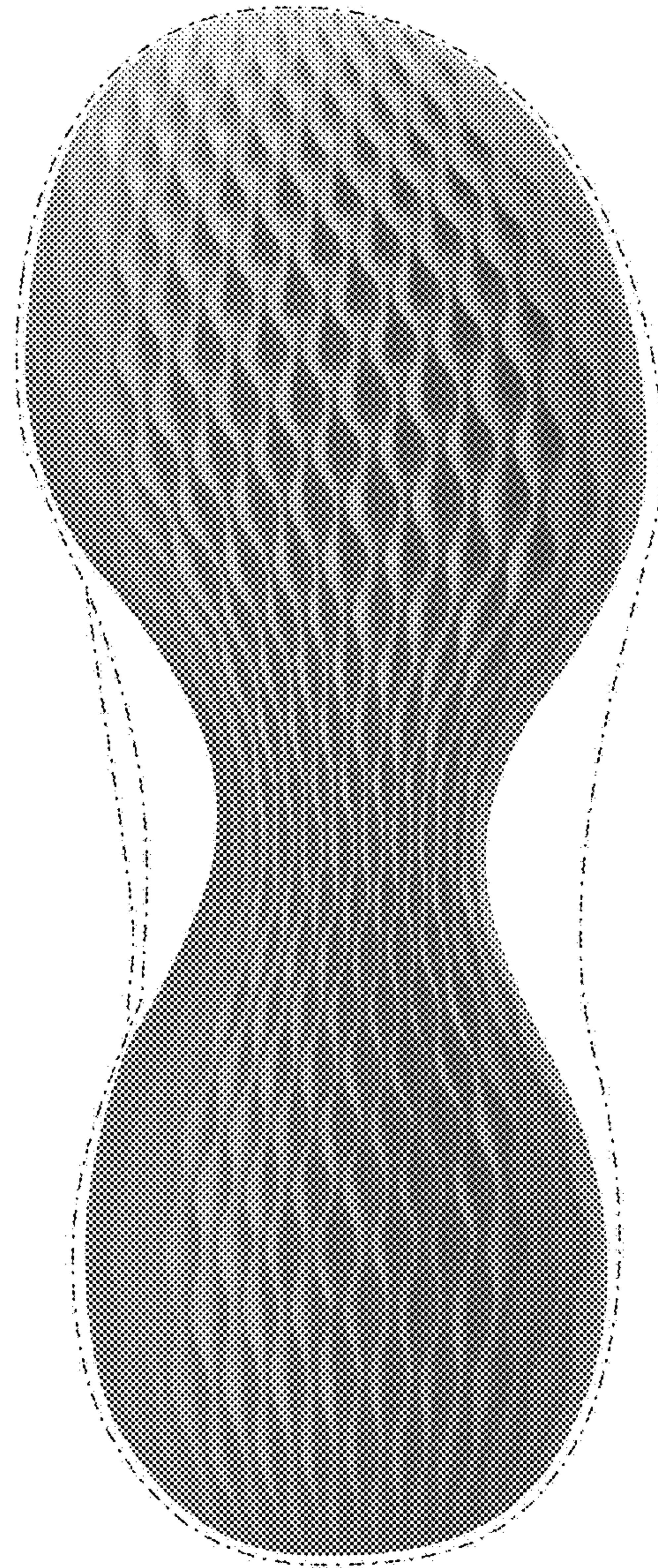

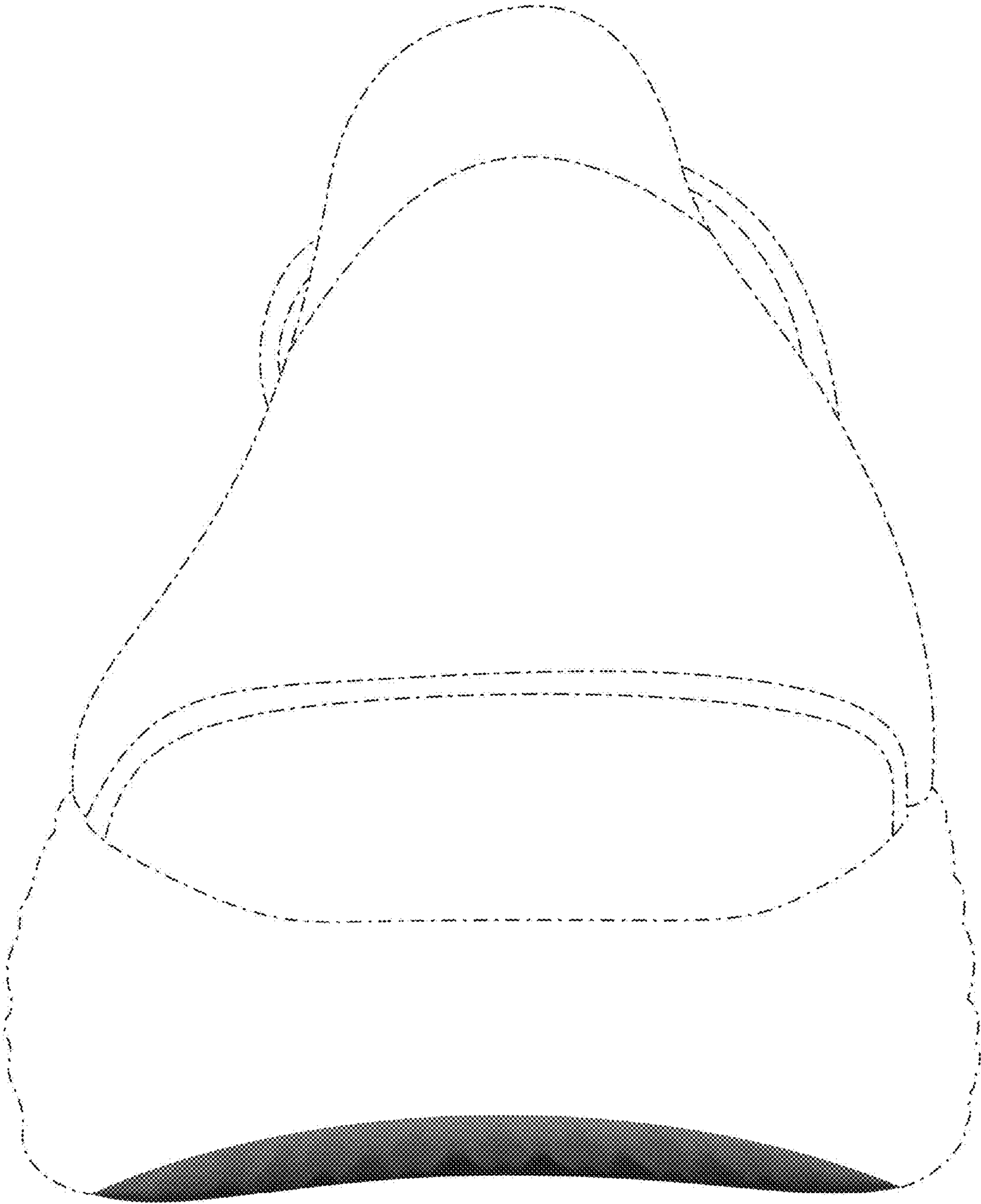

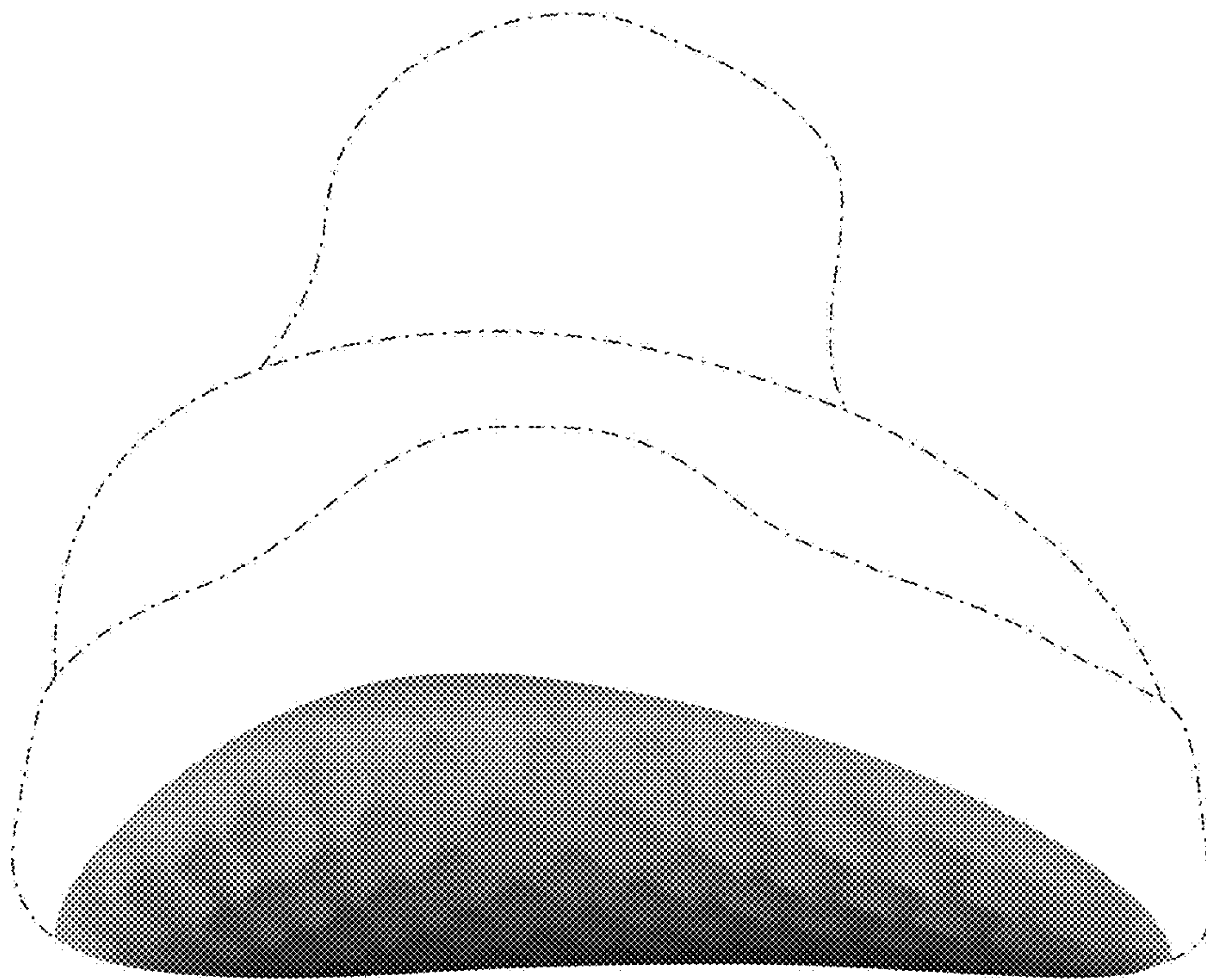
