**DESCRIPTION**

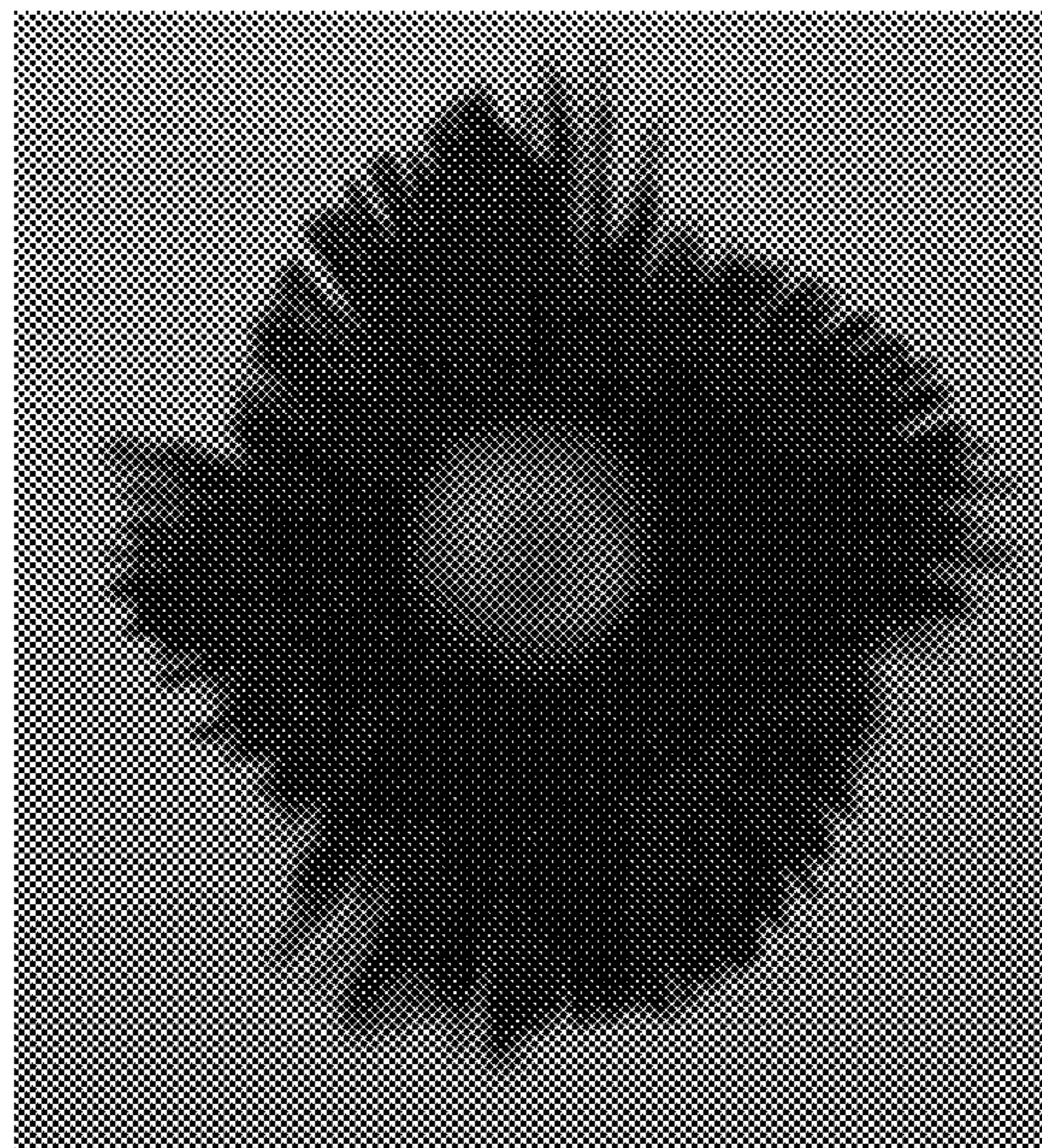
FIG. 1 is a front view of the first embodiment of the mascara brush, showing my new design;

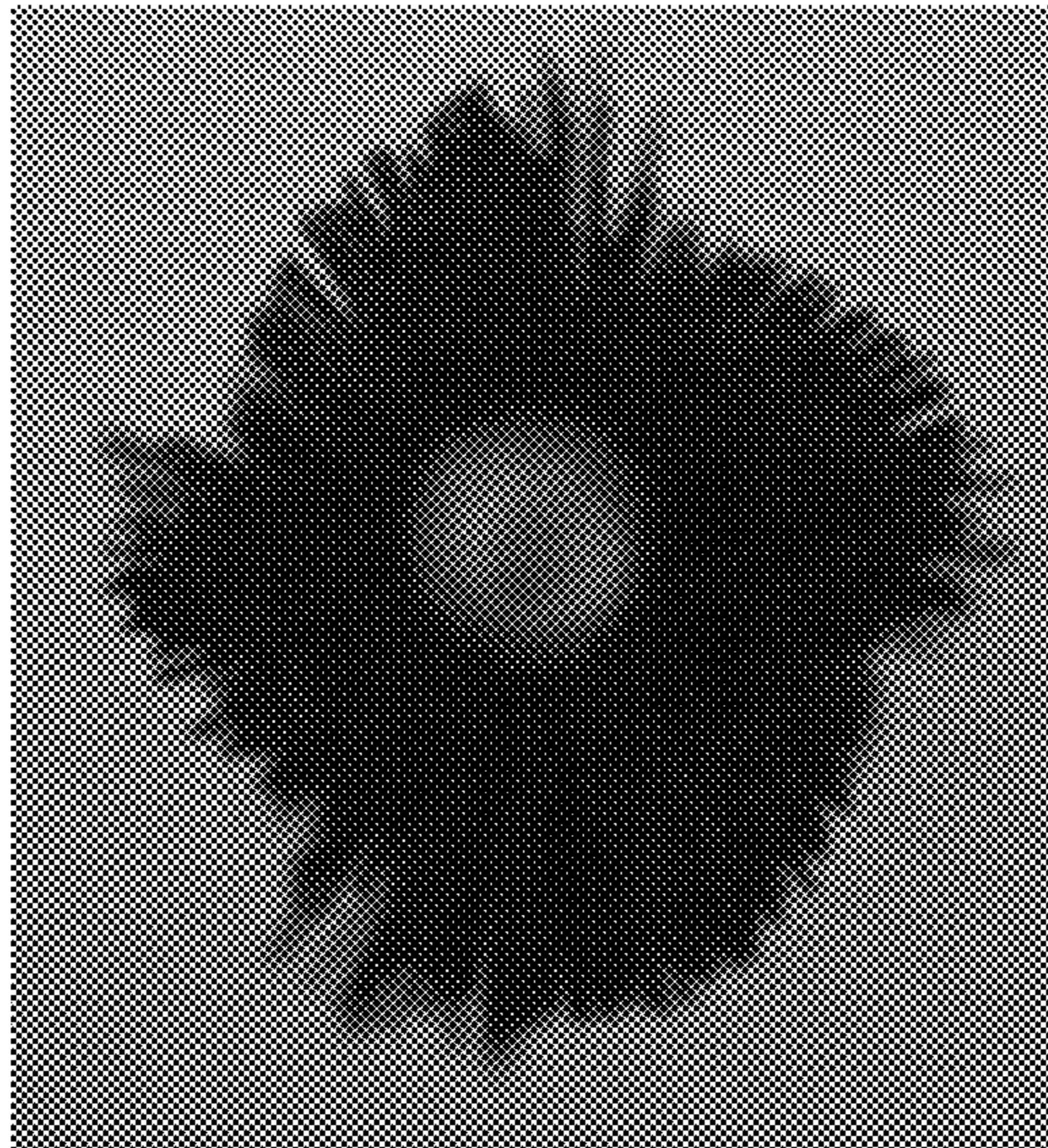

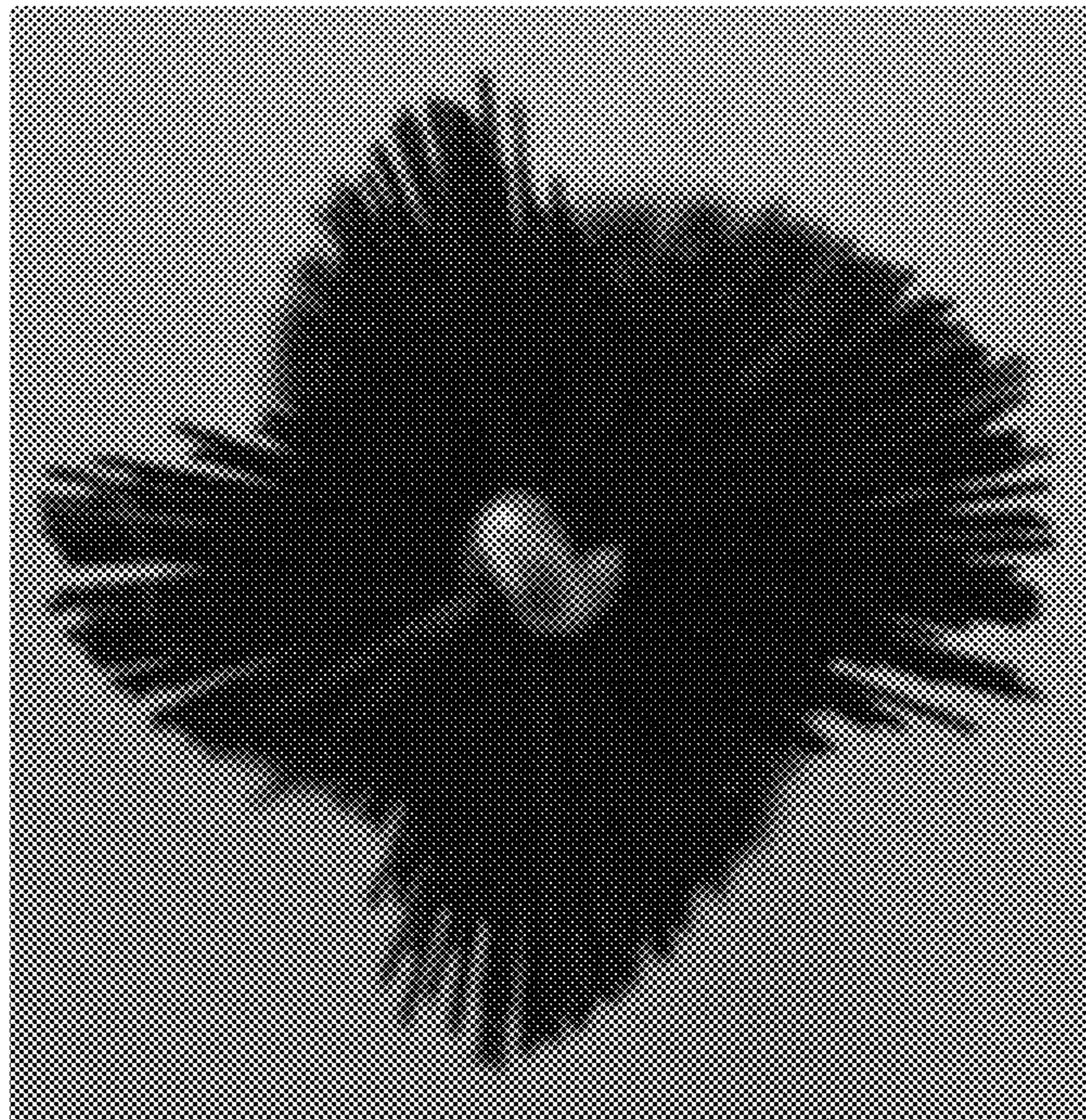

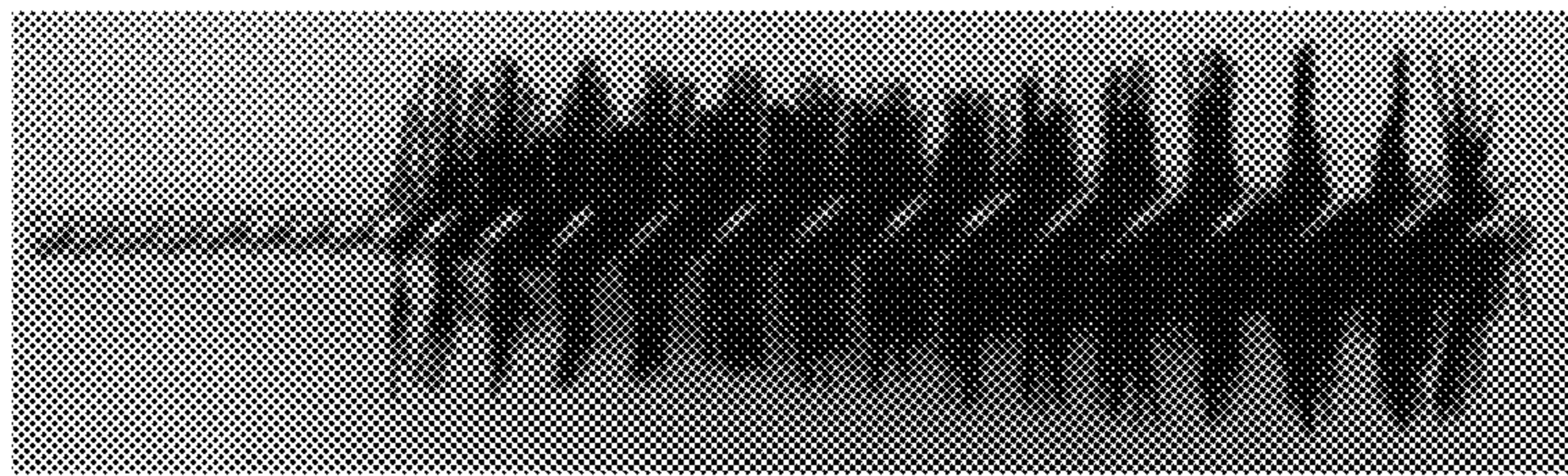

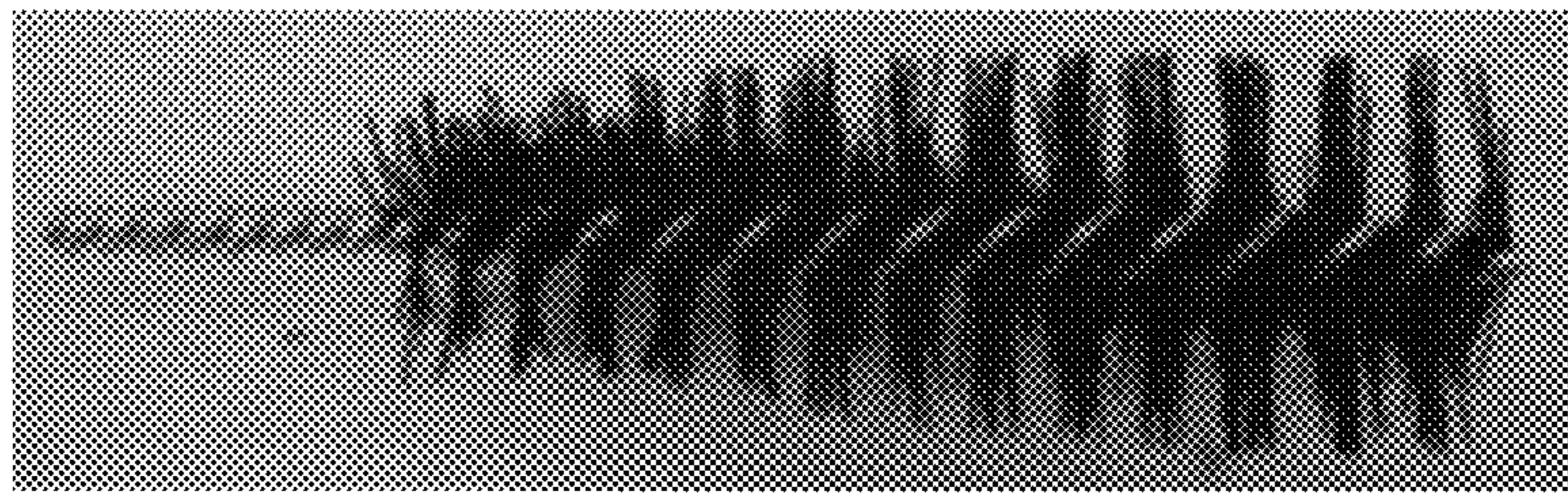

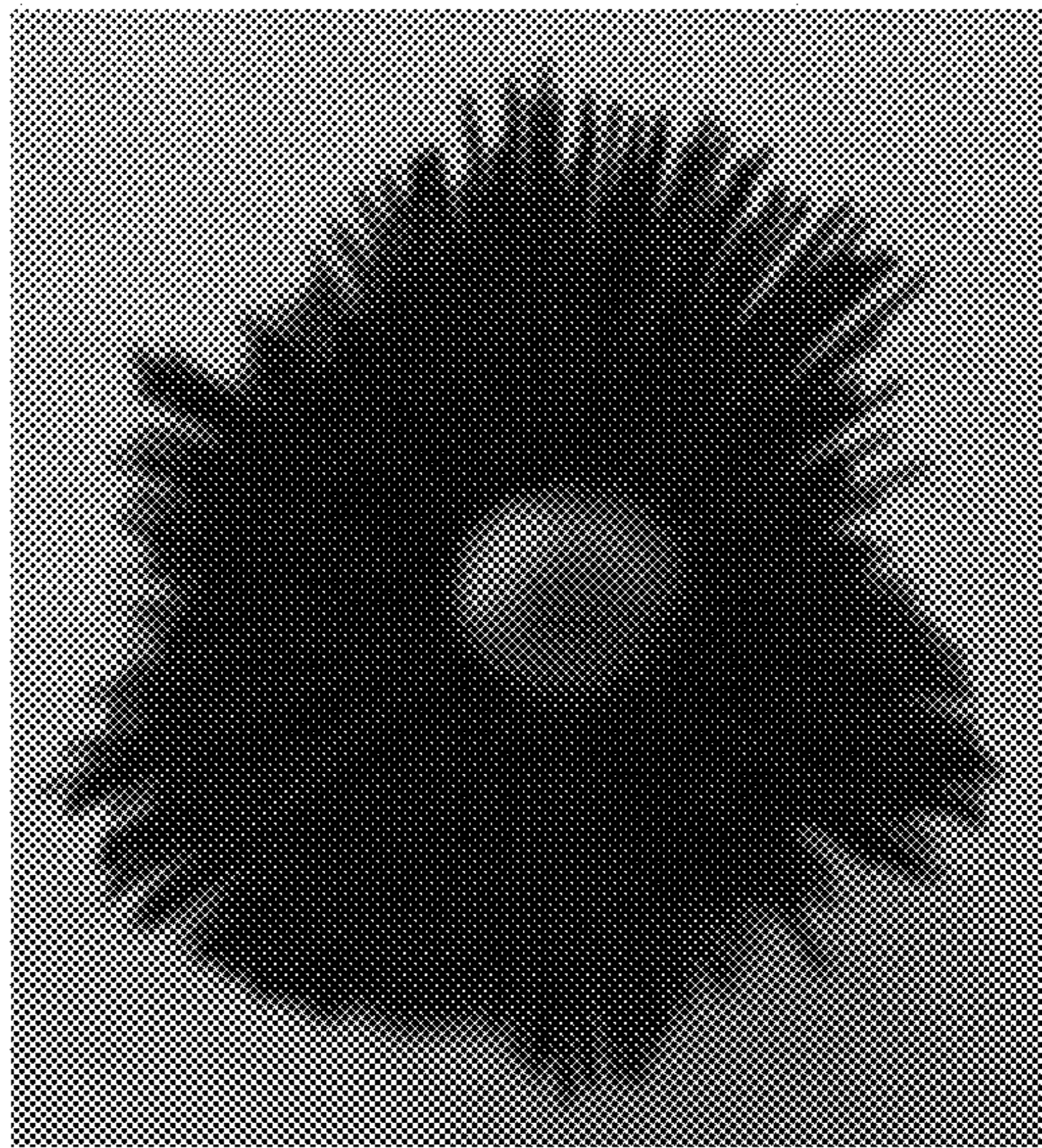

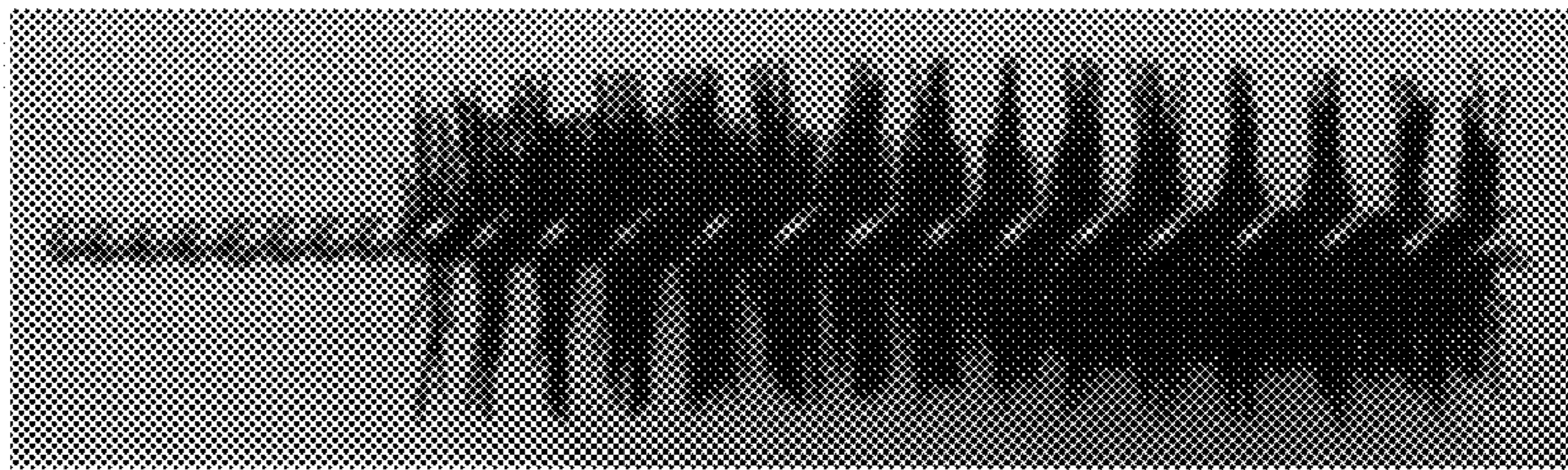

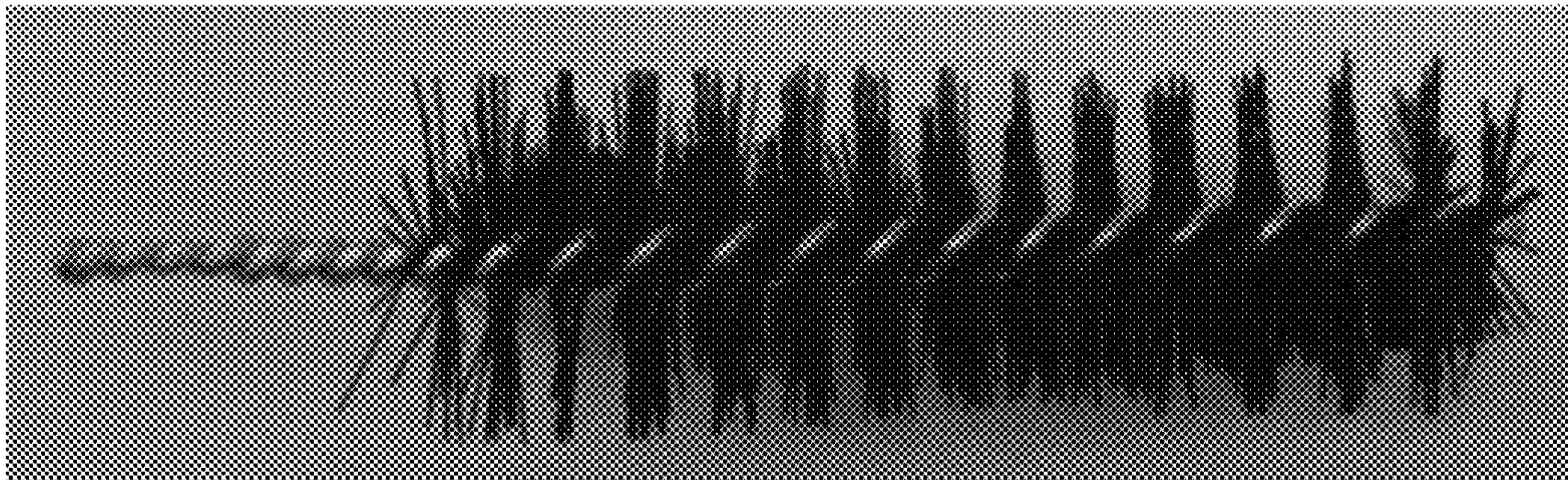

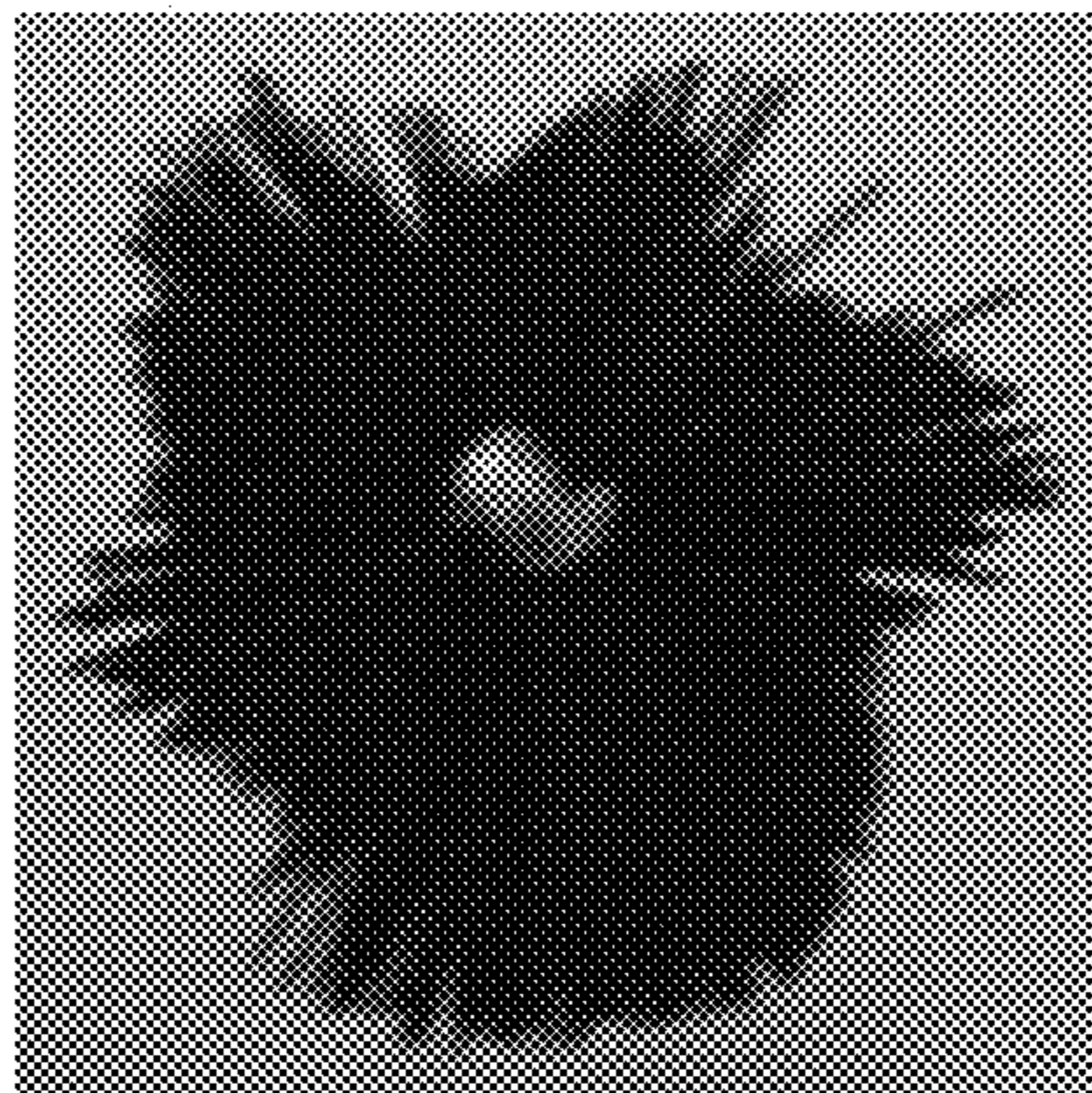
