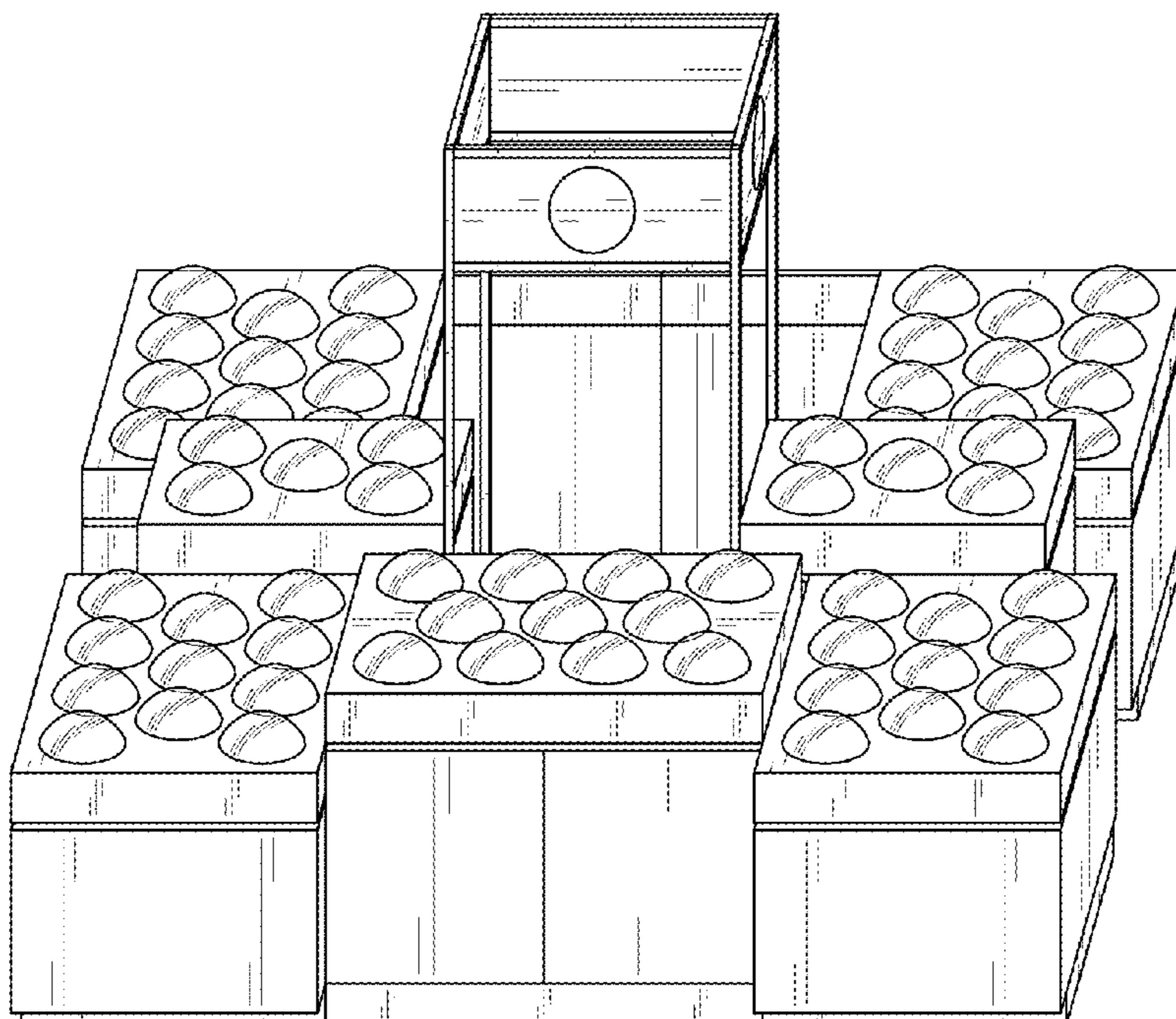
(57) **CLAIM**

The ornamental design for a display apparatus, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right perspective view of a display apparatus of our design; FIG. 2 is a front elevation view thereof; and FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right elevation view thereof; and, FIG. 6 is a top plan view thereof, the bottom of our design being similar to the top.

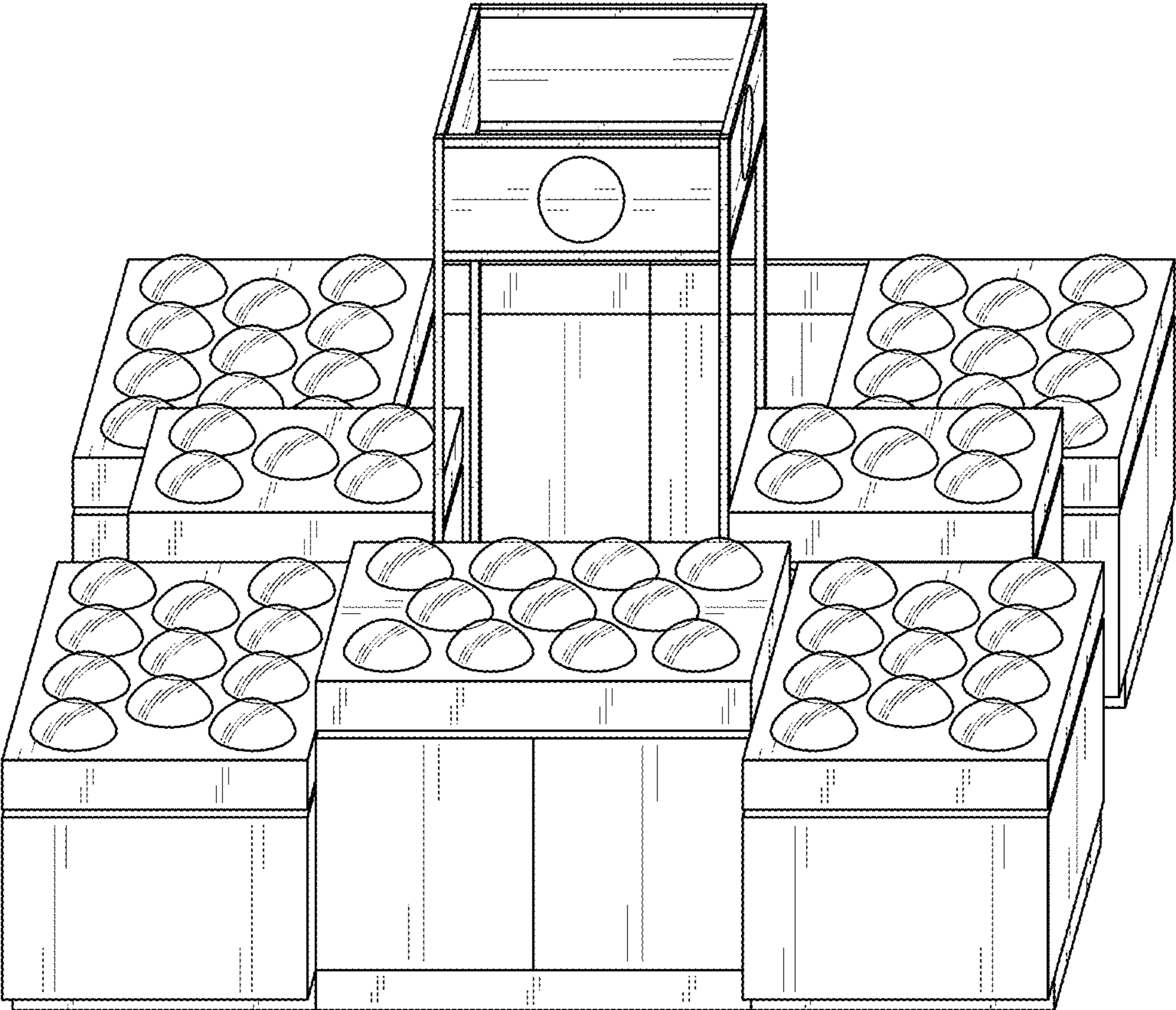

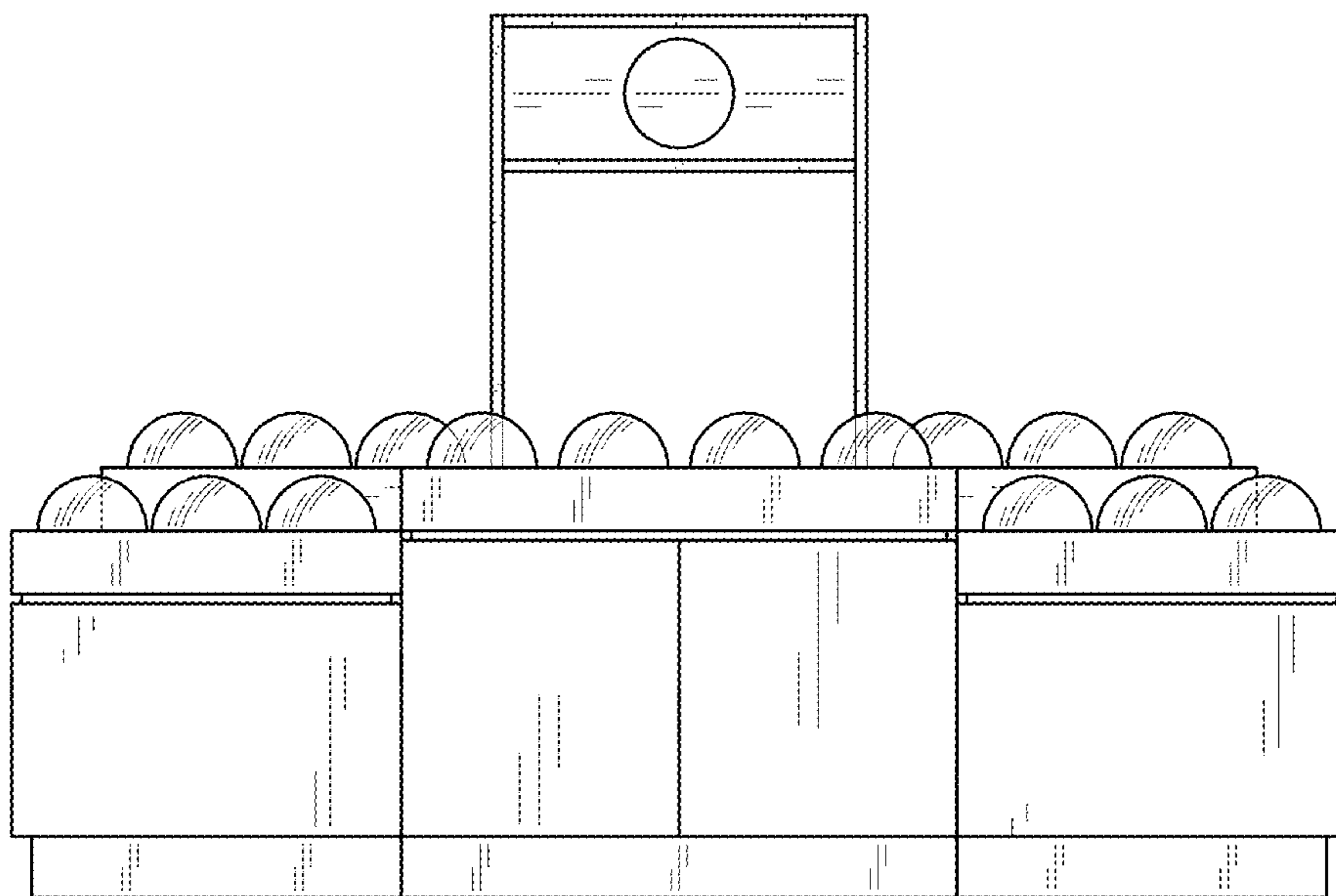

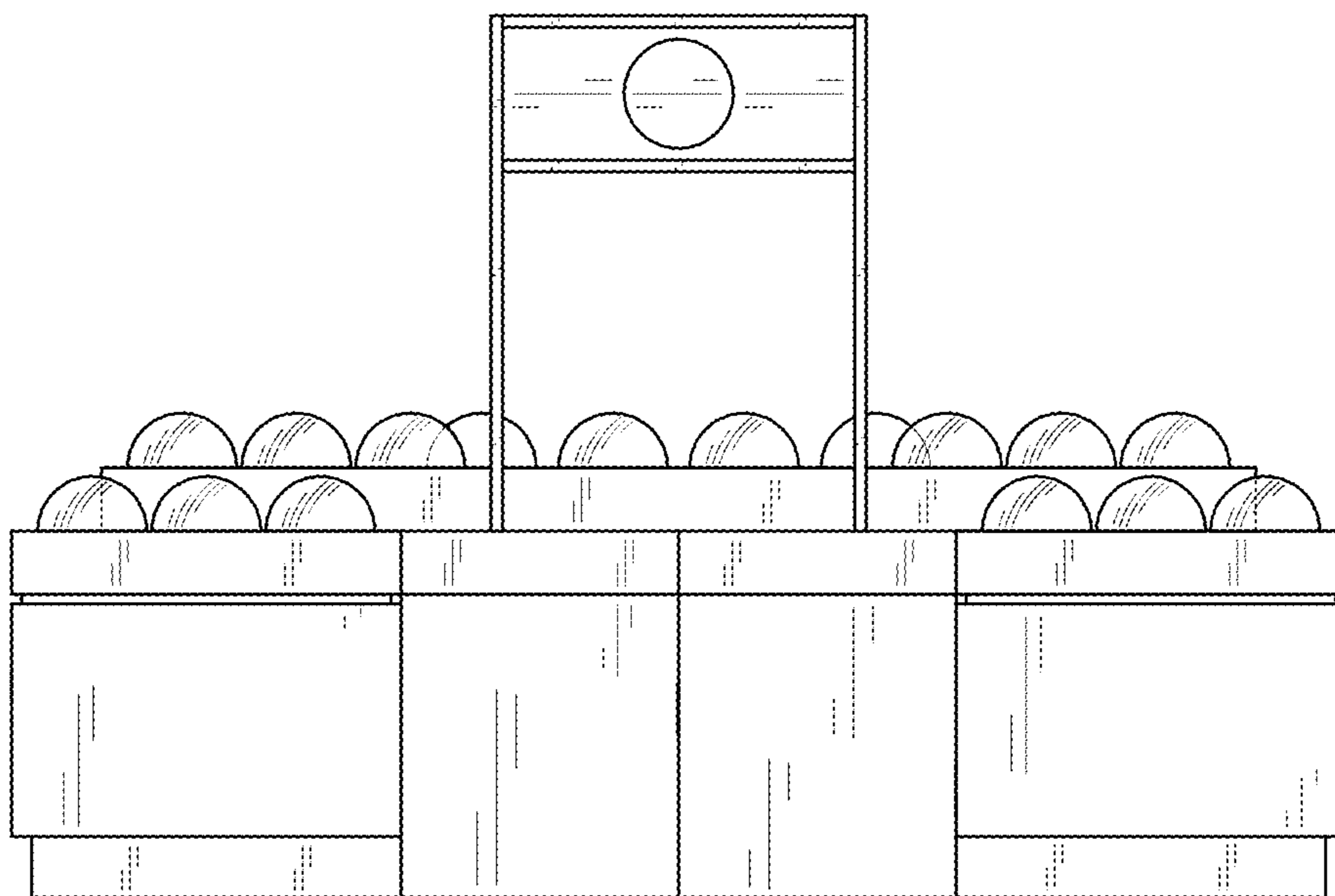

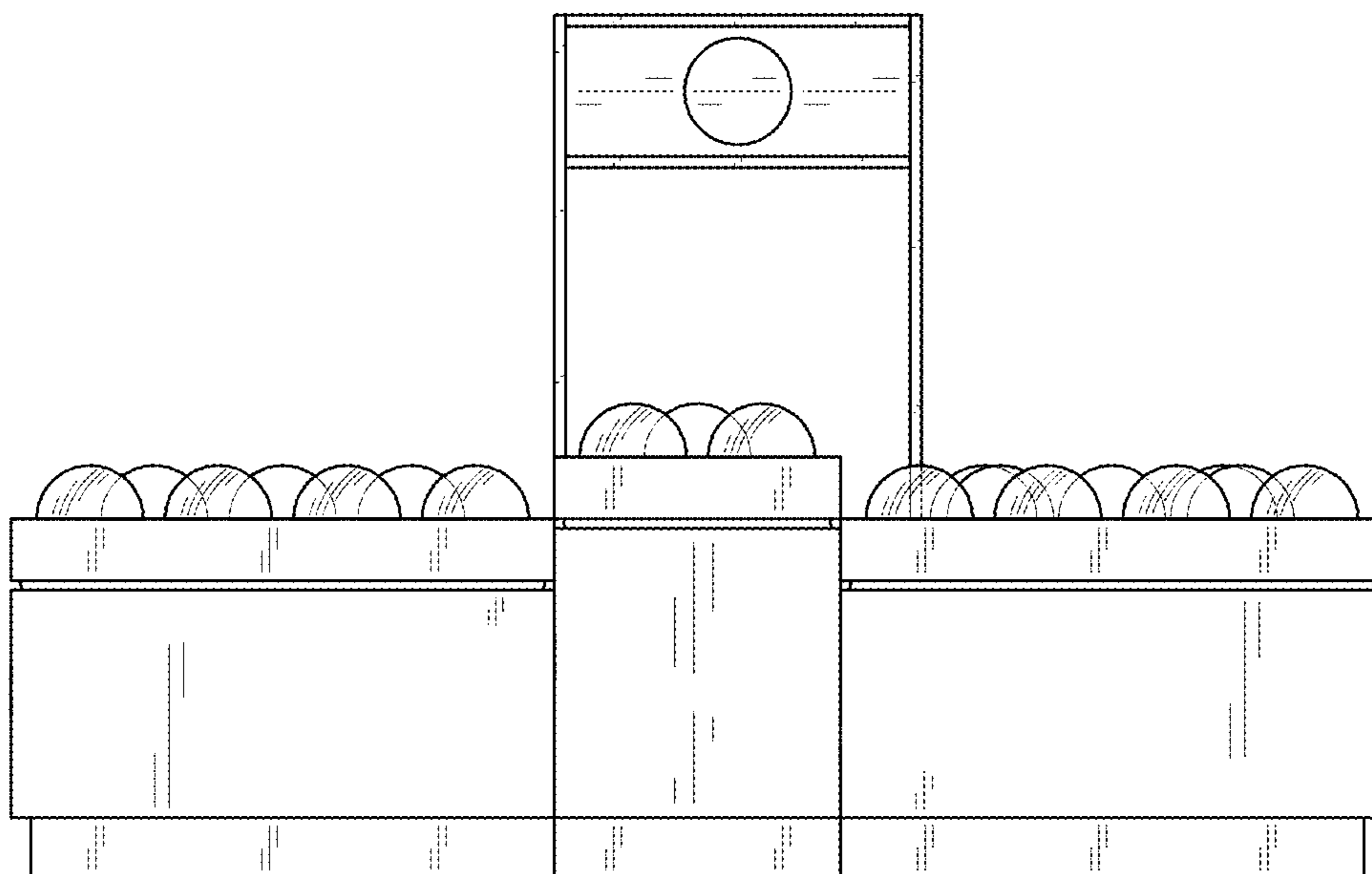

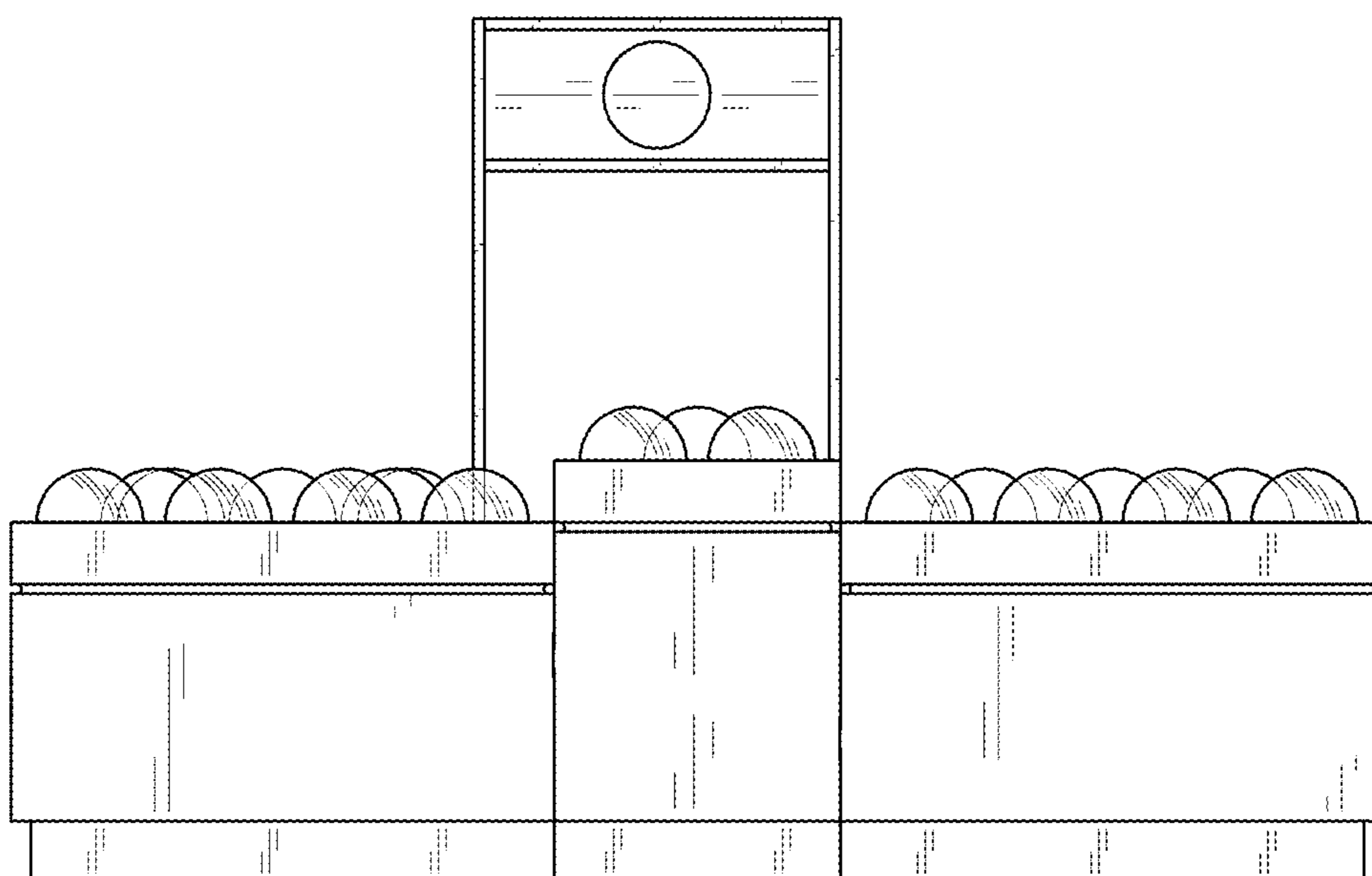

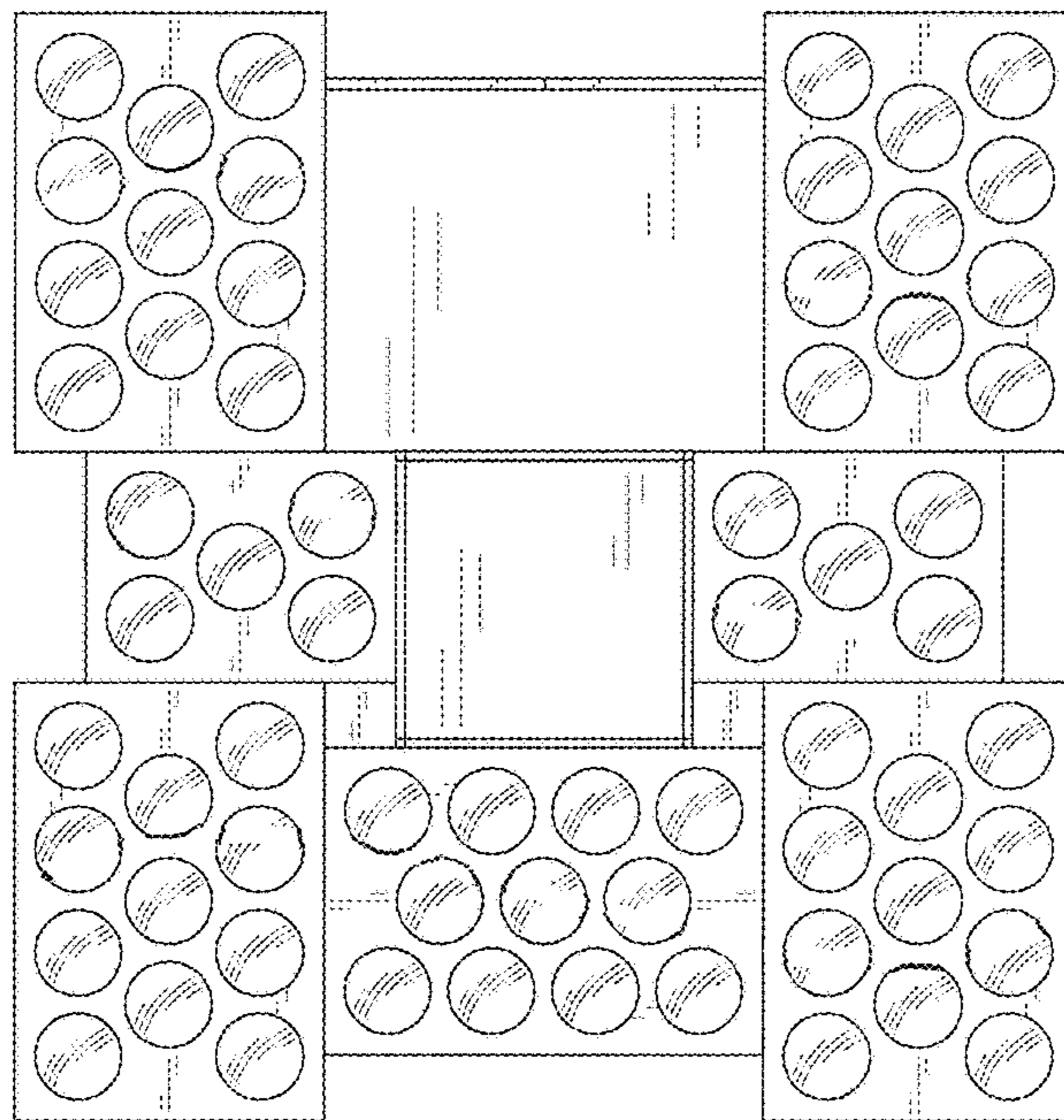
