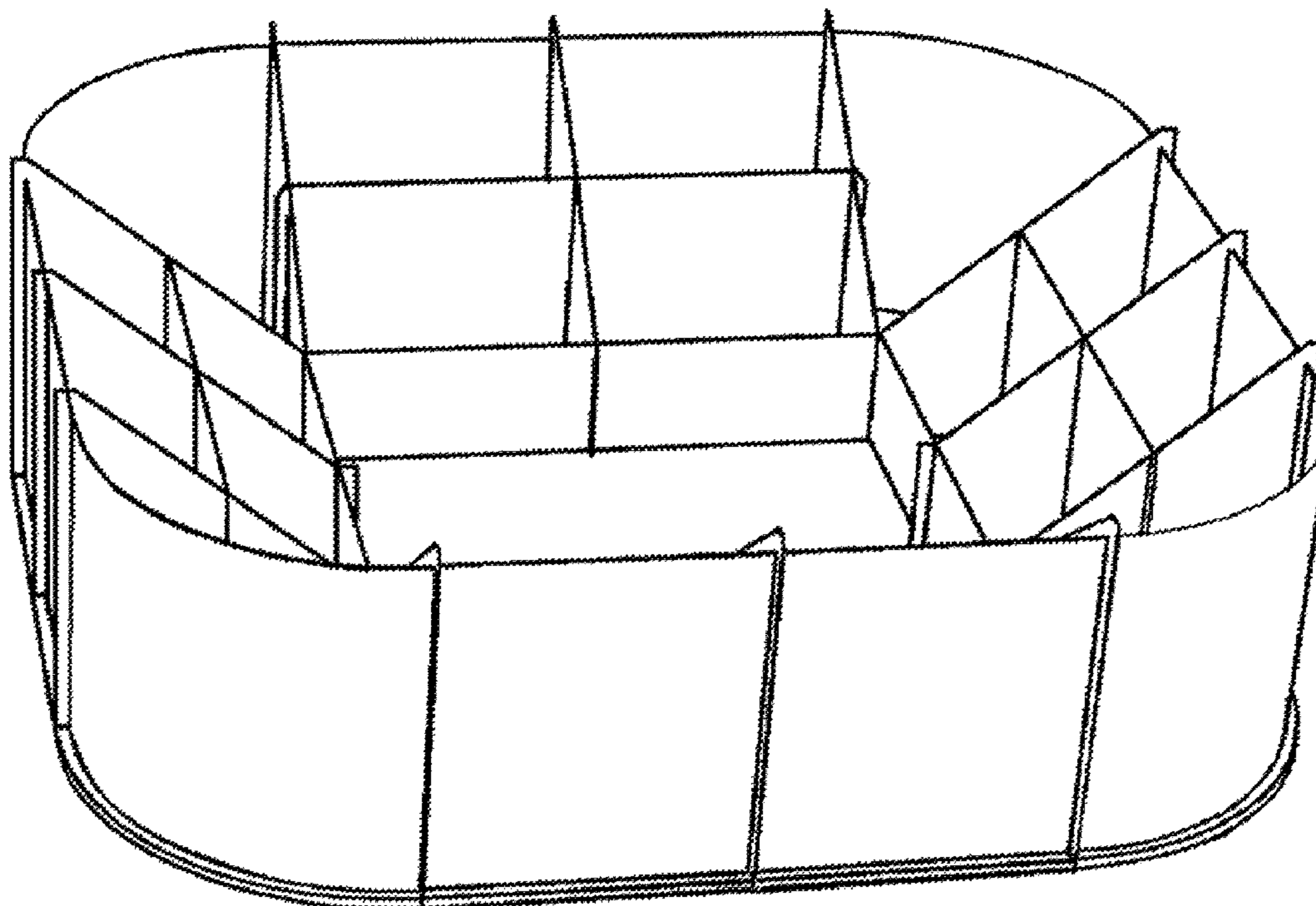
(57) **CLAIM**

The ornamental design for a snack bowl, as shown and described.

DESCRIPTION

FIG. 1 is an overhead perspective view of the snack bowl according to the design;
FIG. 2 is a top plan view of the snack bowl of FIG. 1;
FIG. 3 is a bottom view of the snack bowl opposite the view of FIG. 2;
FIG. 4 is a front view of the snack bowl of FIG. 1;
FIG. 5 is a rear view of the snack bowl opposite the view of FIG. 4;
FIG. 6 is a first second side of the snack bowl of FIG. 1; and,
FIG. 7 is a second side view of the snack bowl opposite the view of FIG. 6.

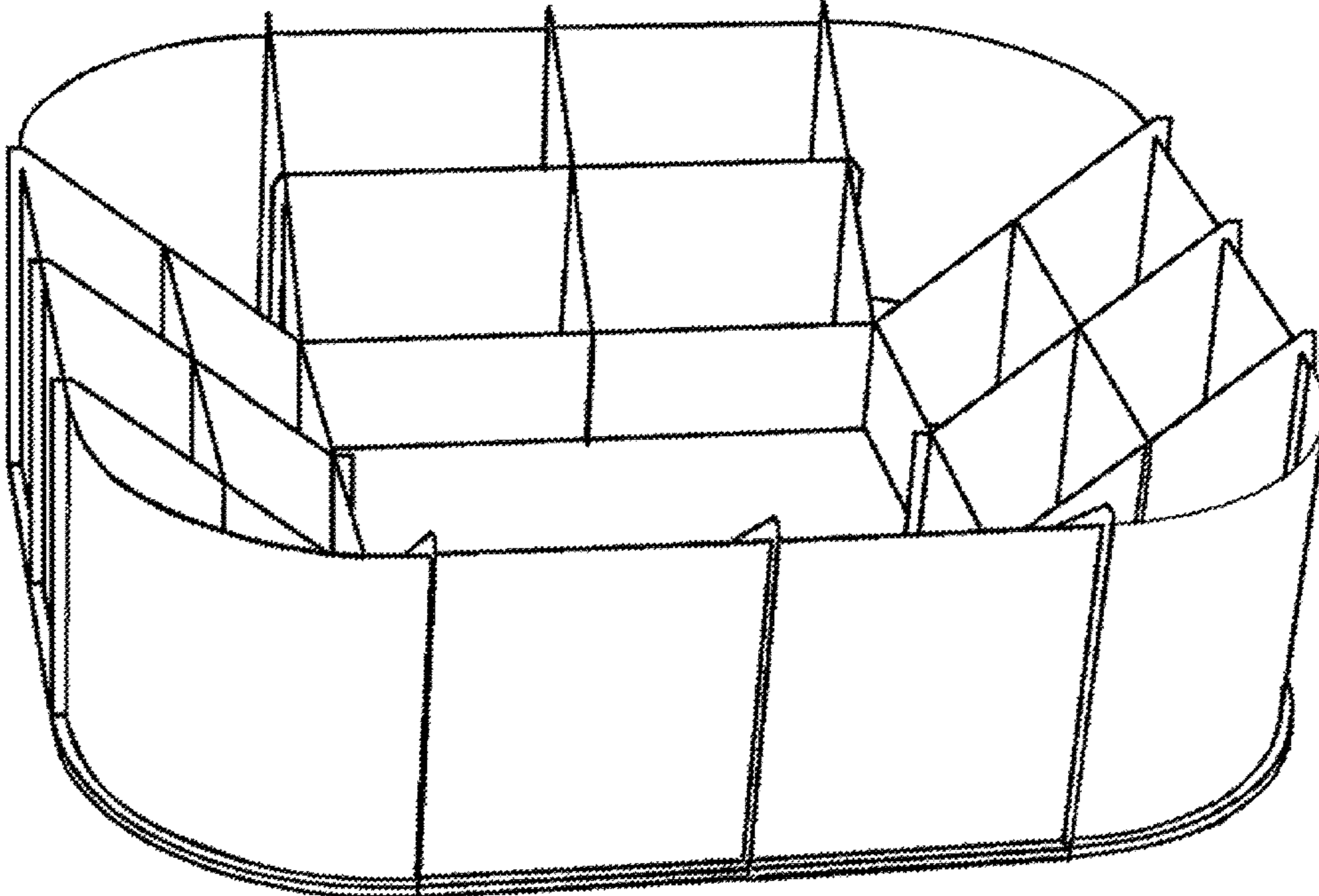

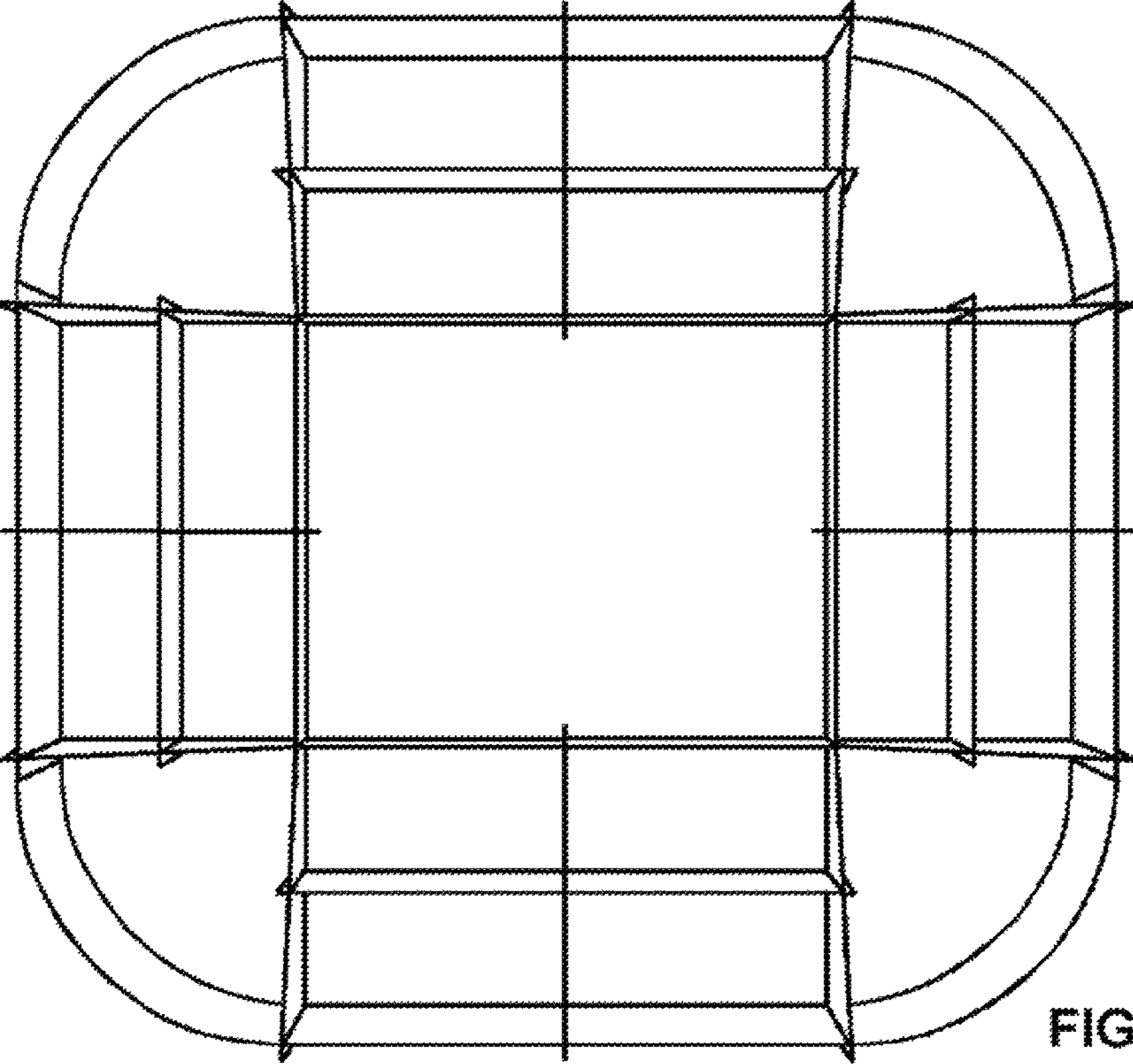

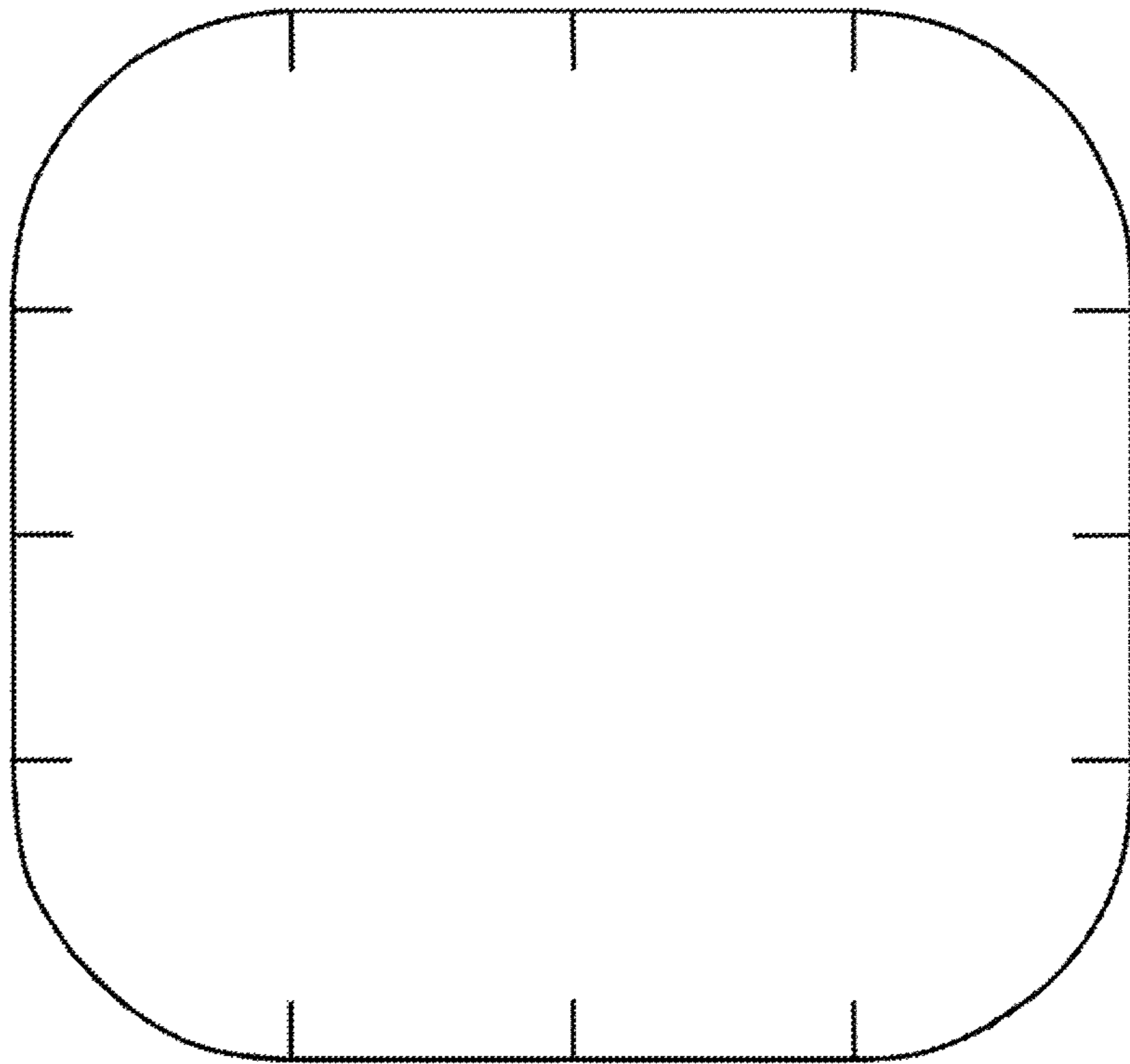

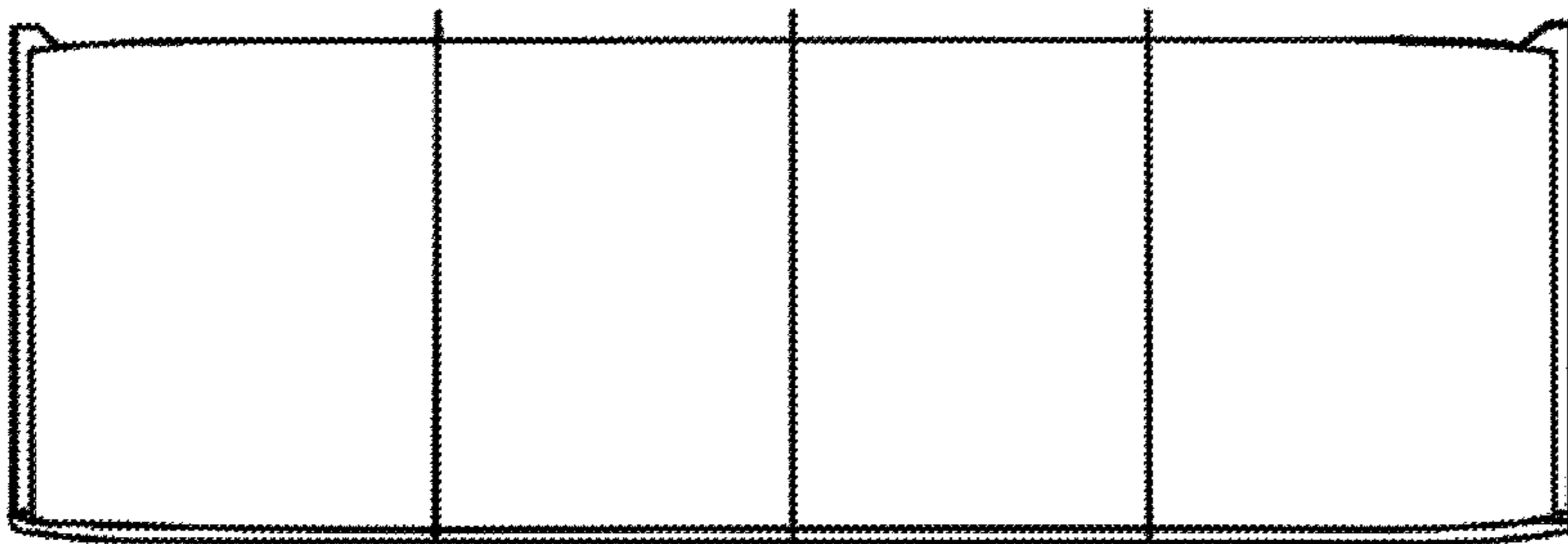

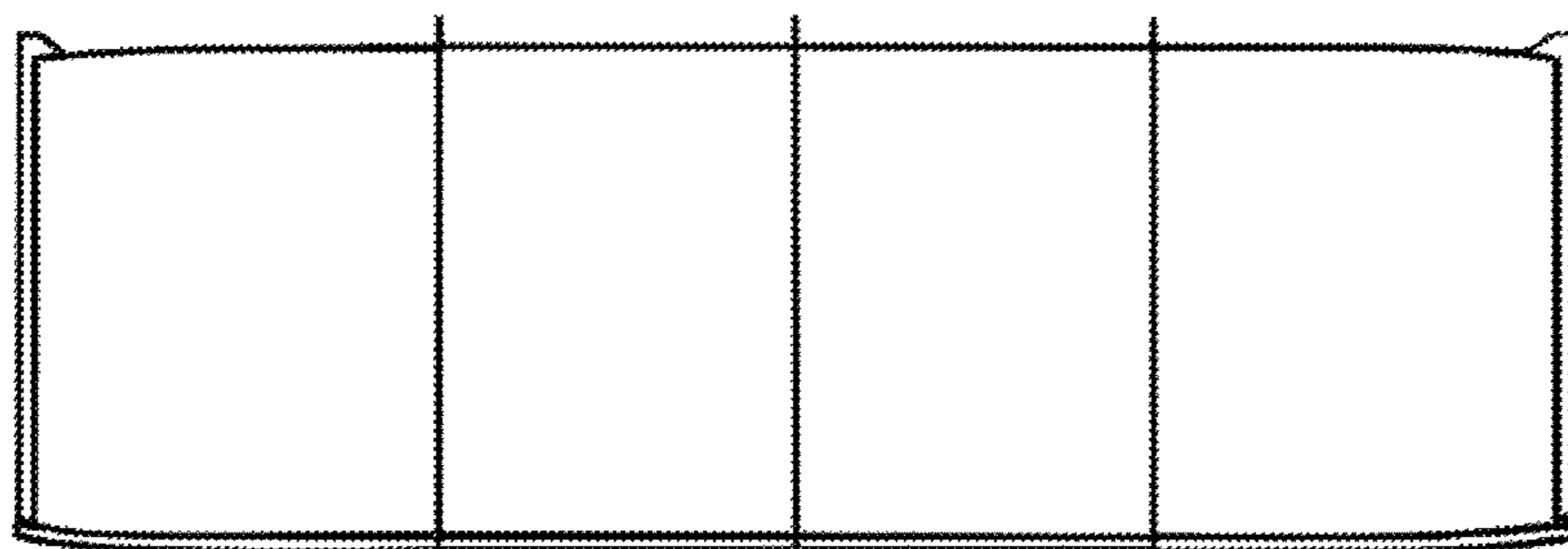

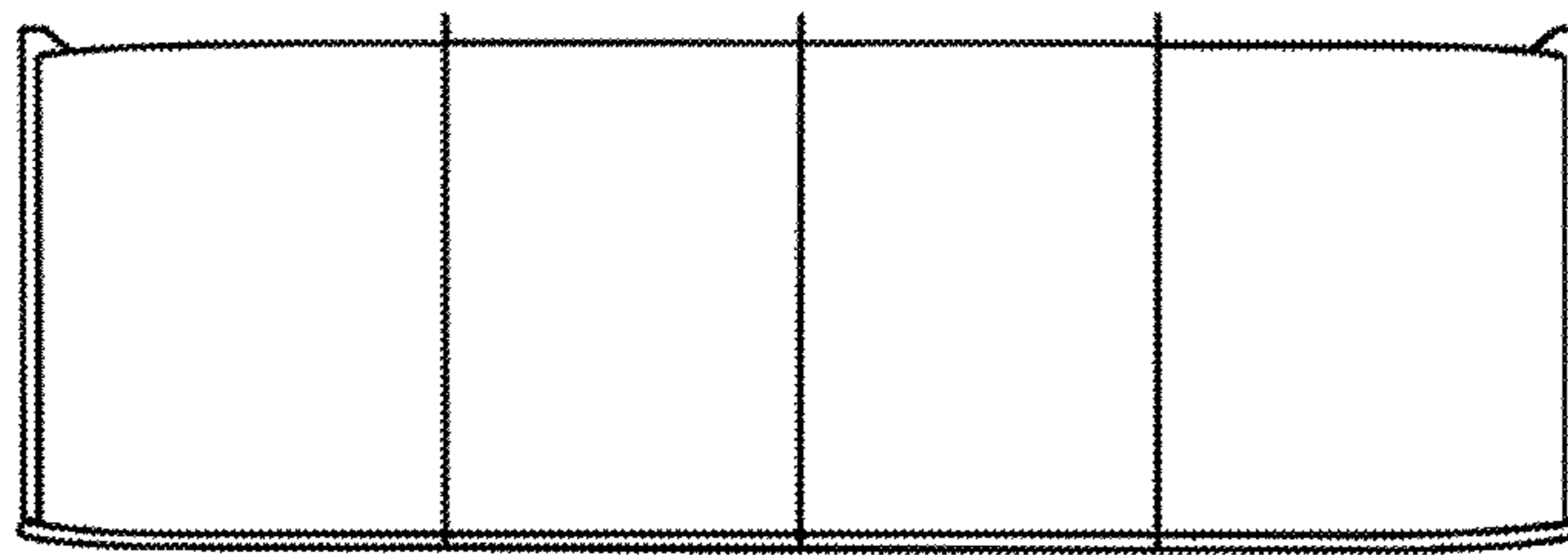

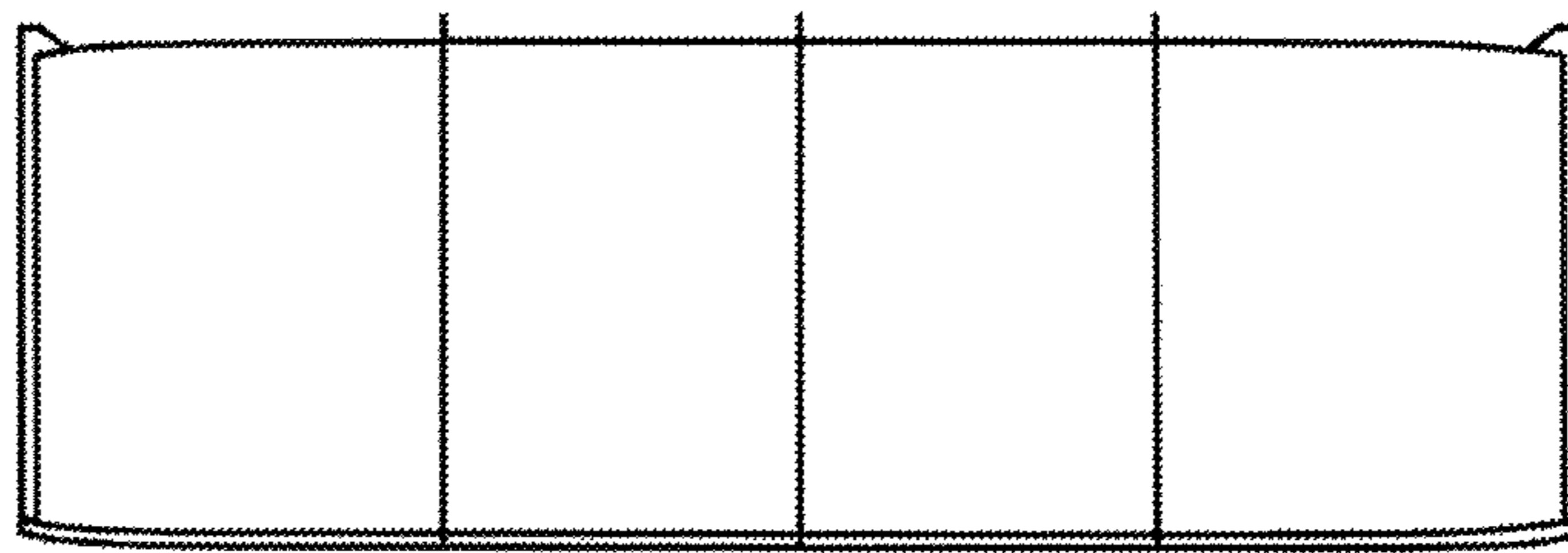
