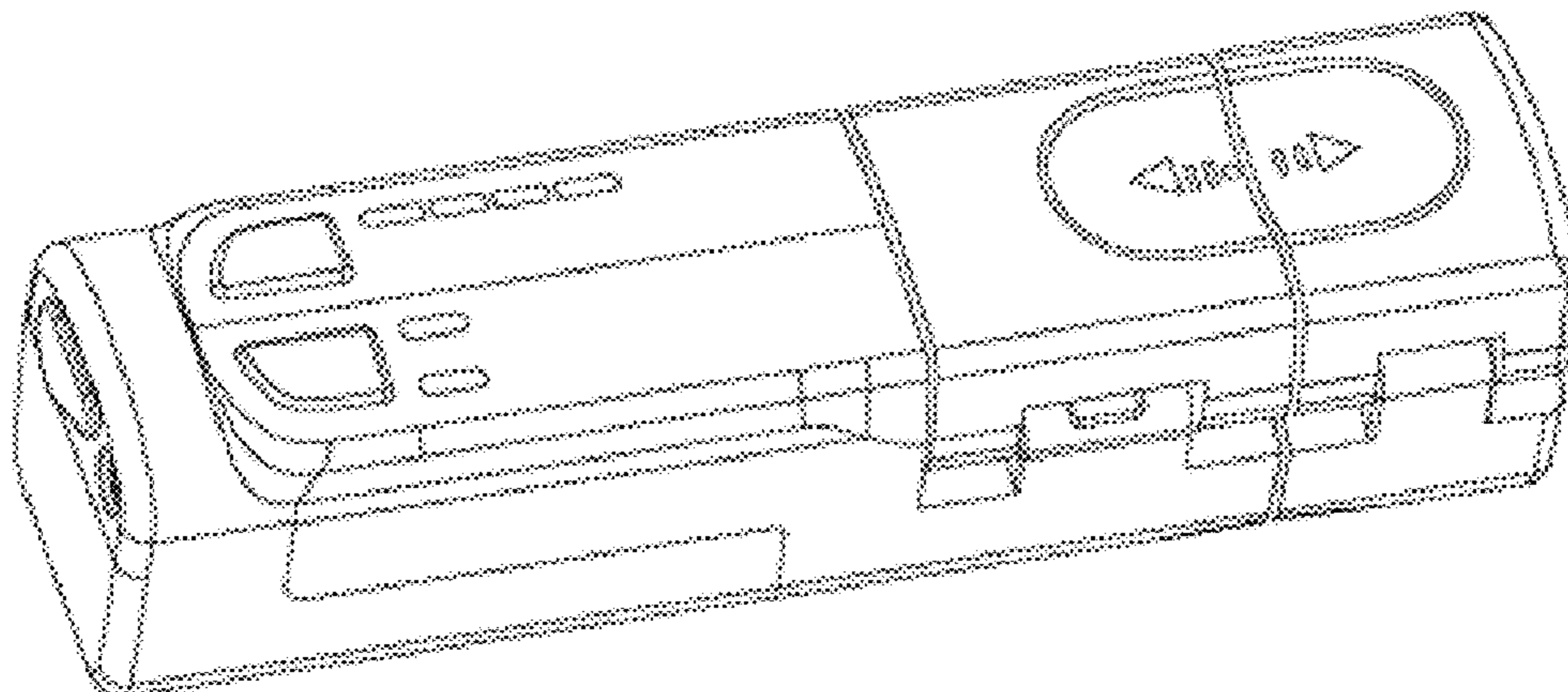
(57) **CLAIM**

The ornamental design for a ribbon fiber optic thermal stripper, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a ribbon fiber optic thermal stripper of the present design;  
 FIG. 2 is a rear view of the ribbon fiber optic thermal stripper thereof;  
 FIG. 3 is a left view of the ribbon fiber optic thermal stripper thereof;  
 FIG. 4 is a right view of the ribbon fiber optic thermal stripper thereof;

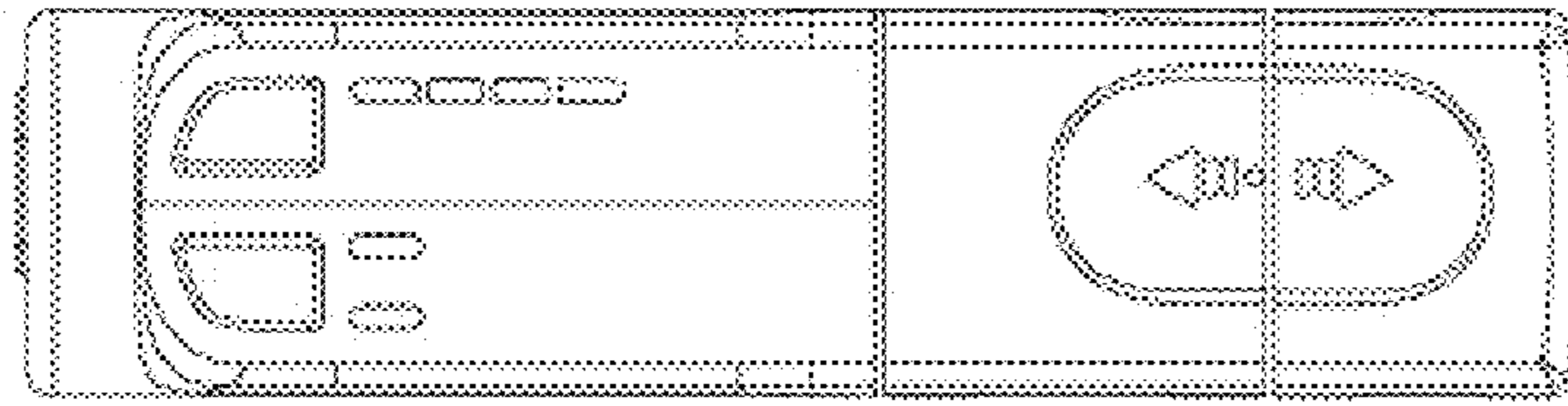

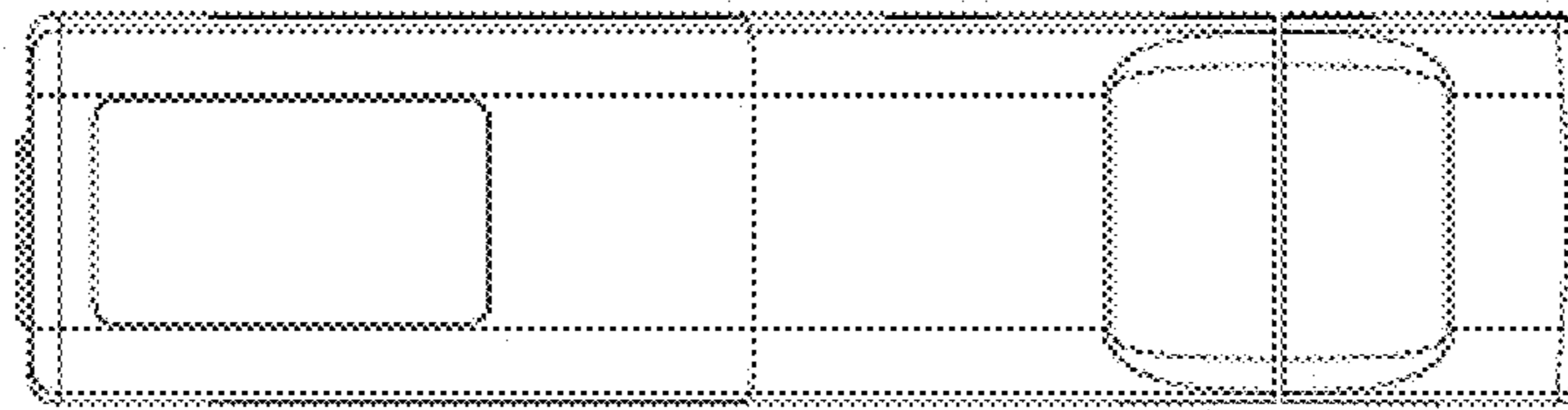

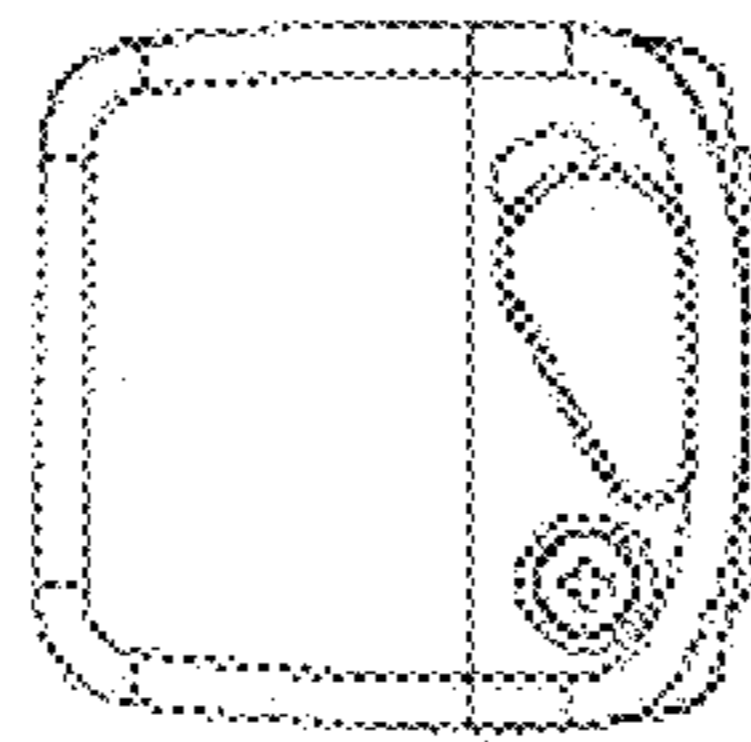

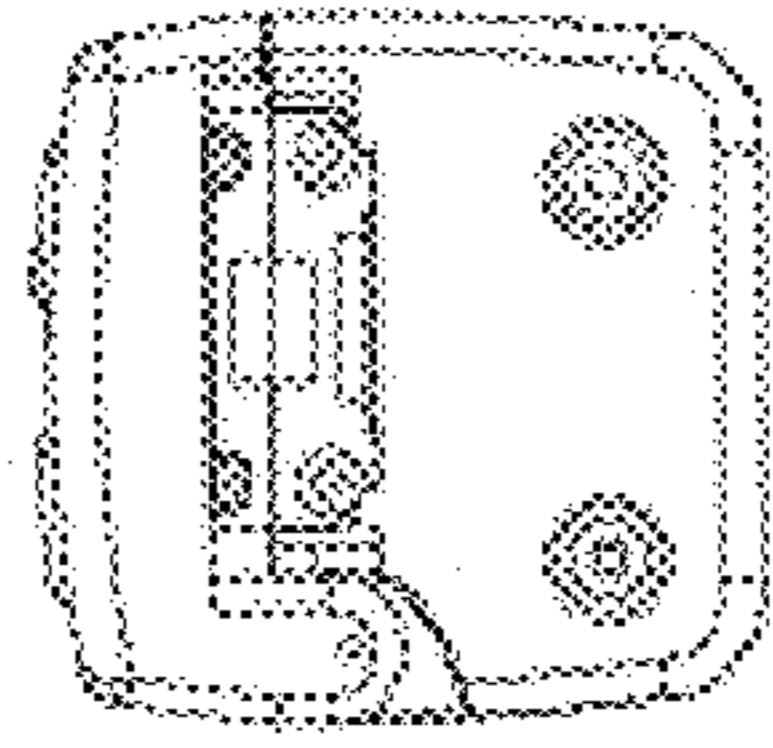

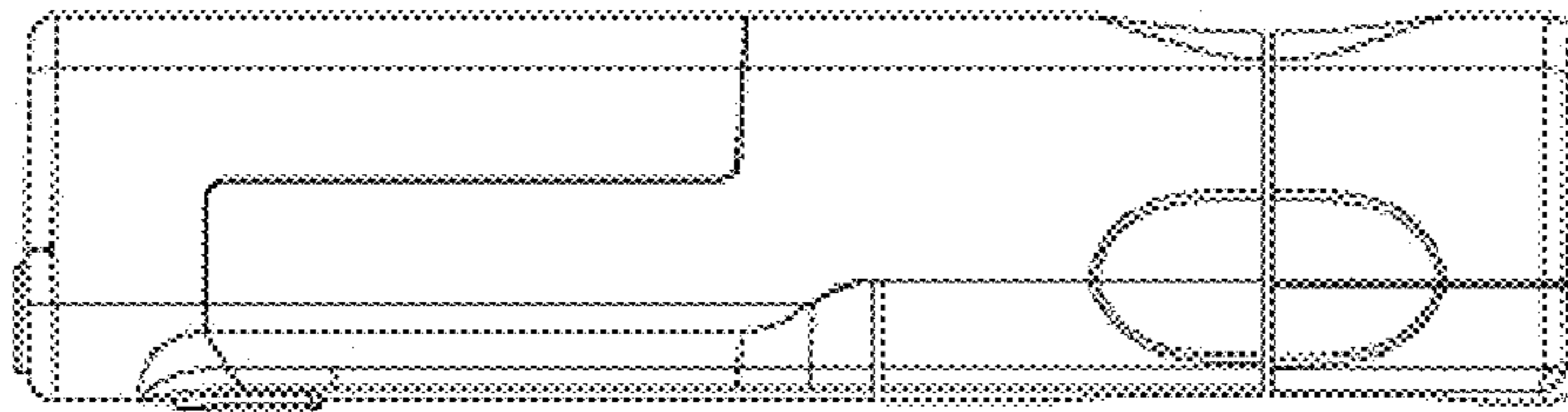

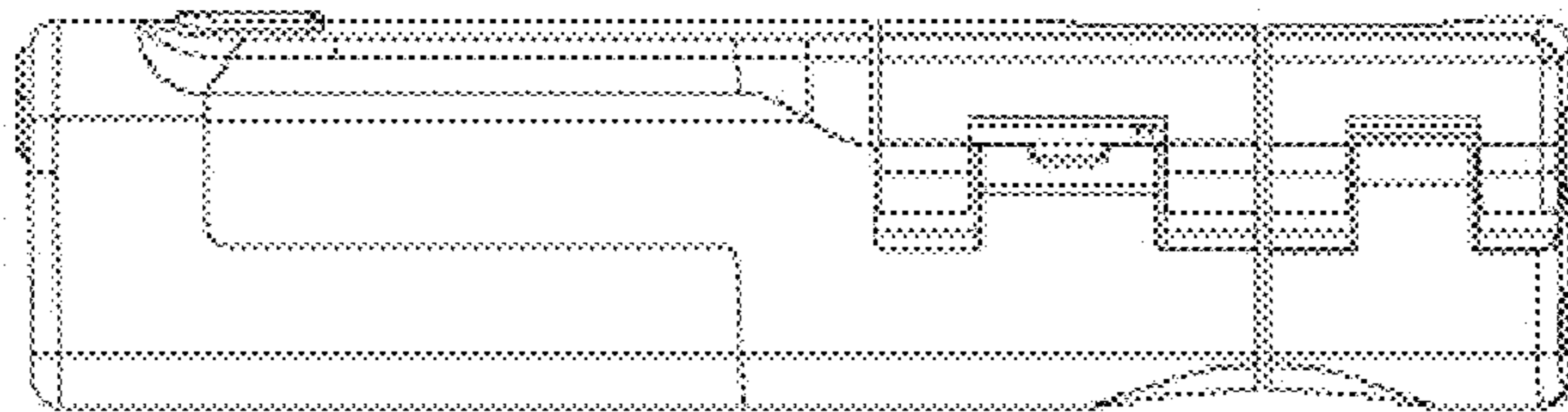

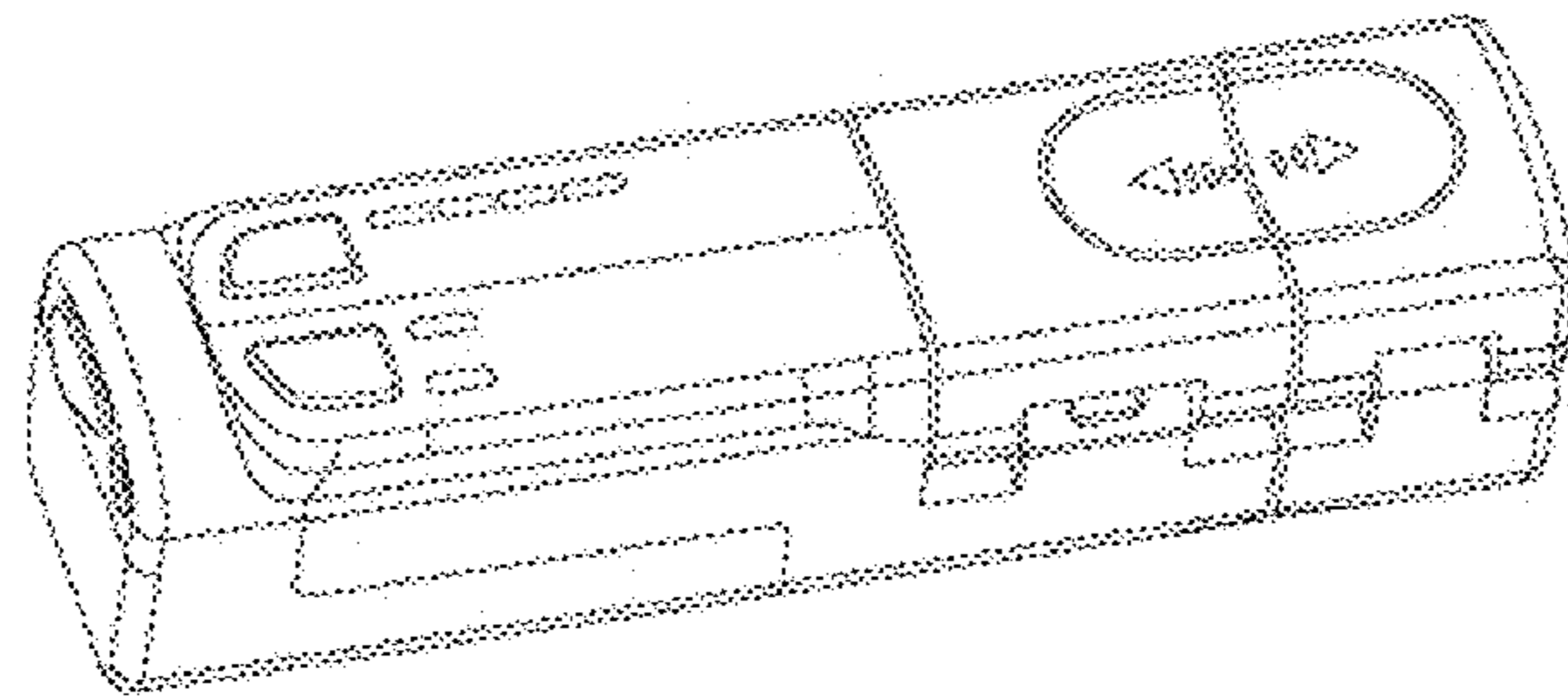
