DESCRIPTION

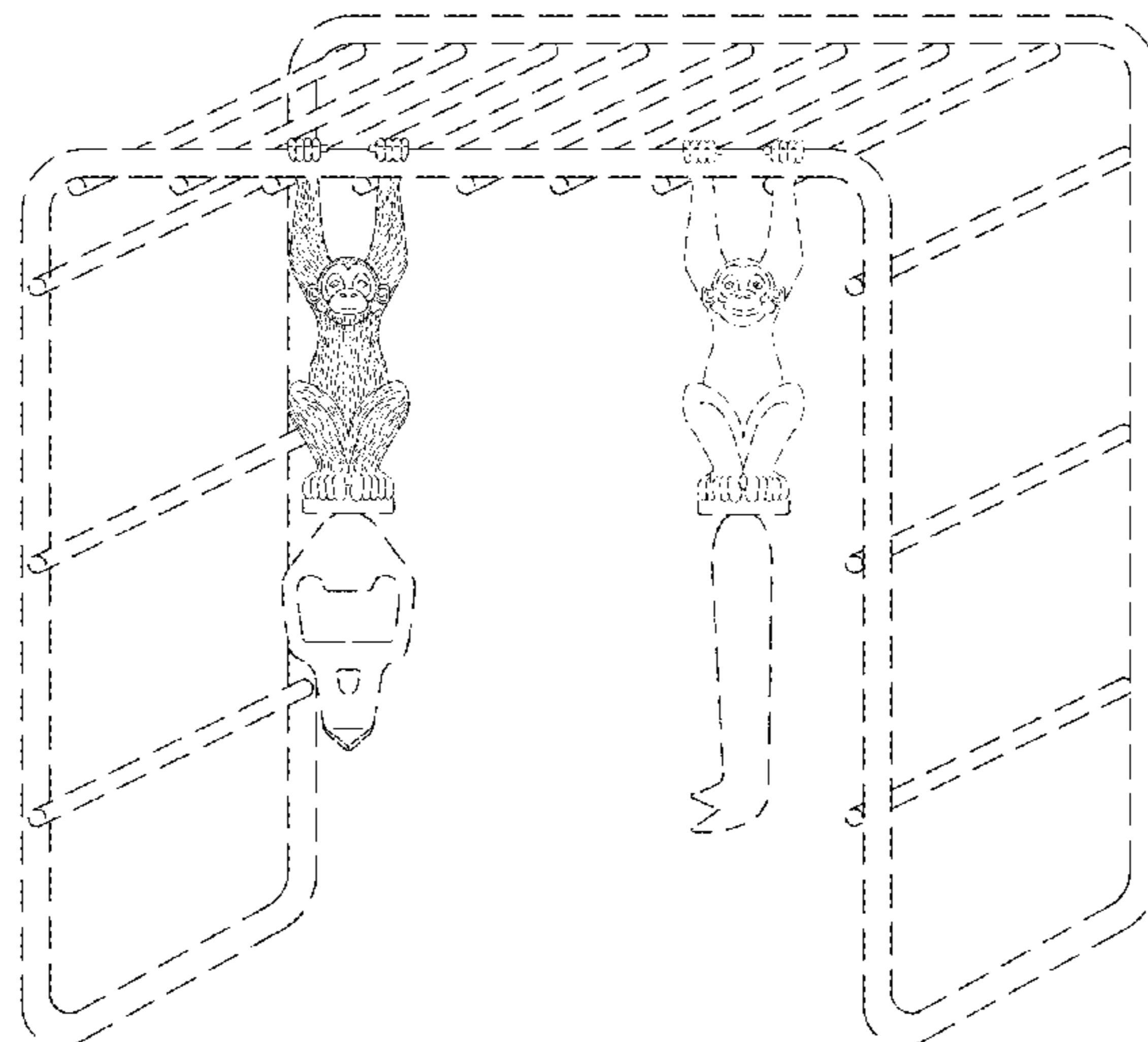
FIG. 1 shows a perspective view of a handle for barware in

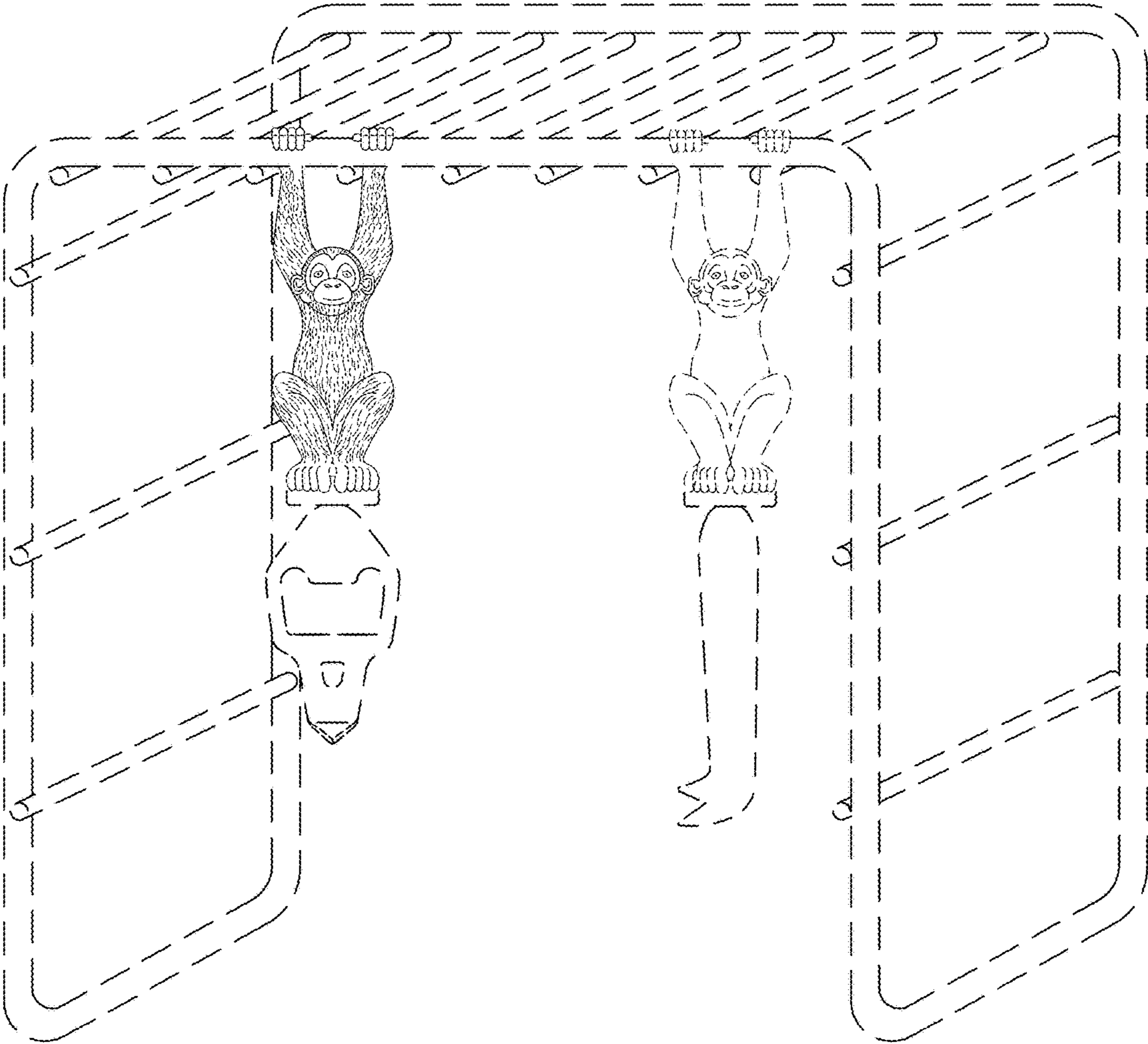

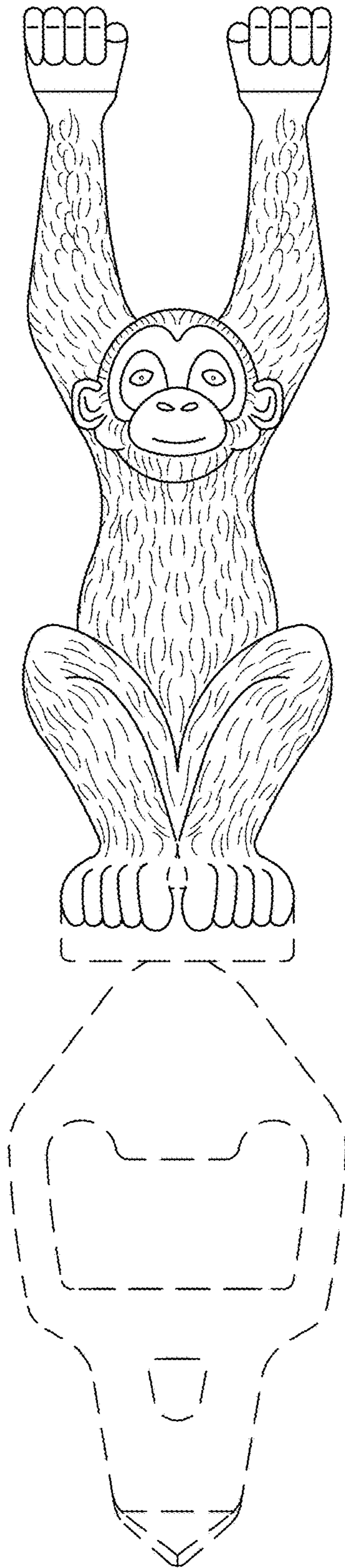

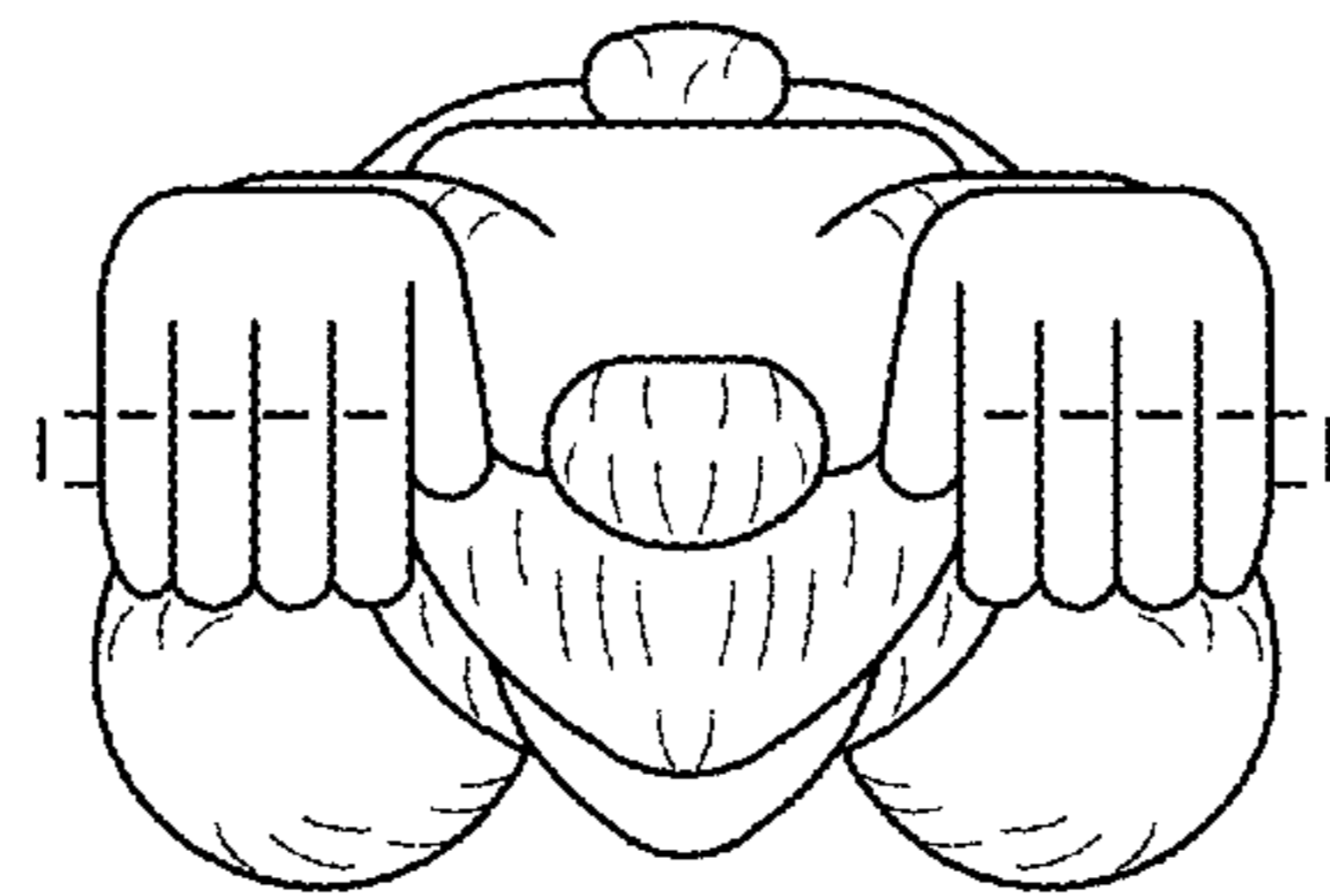

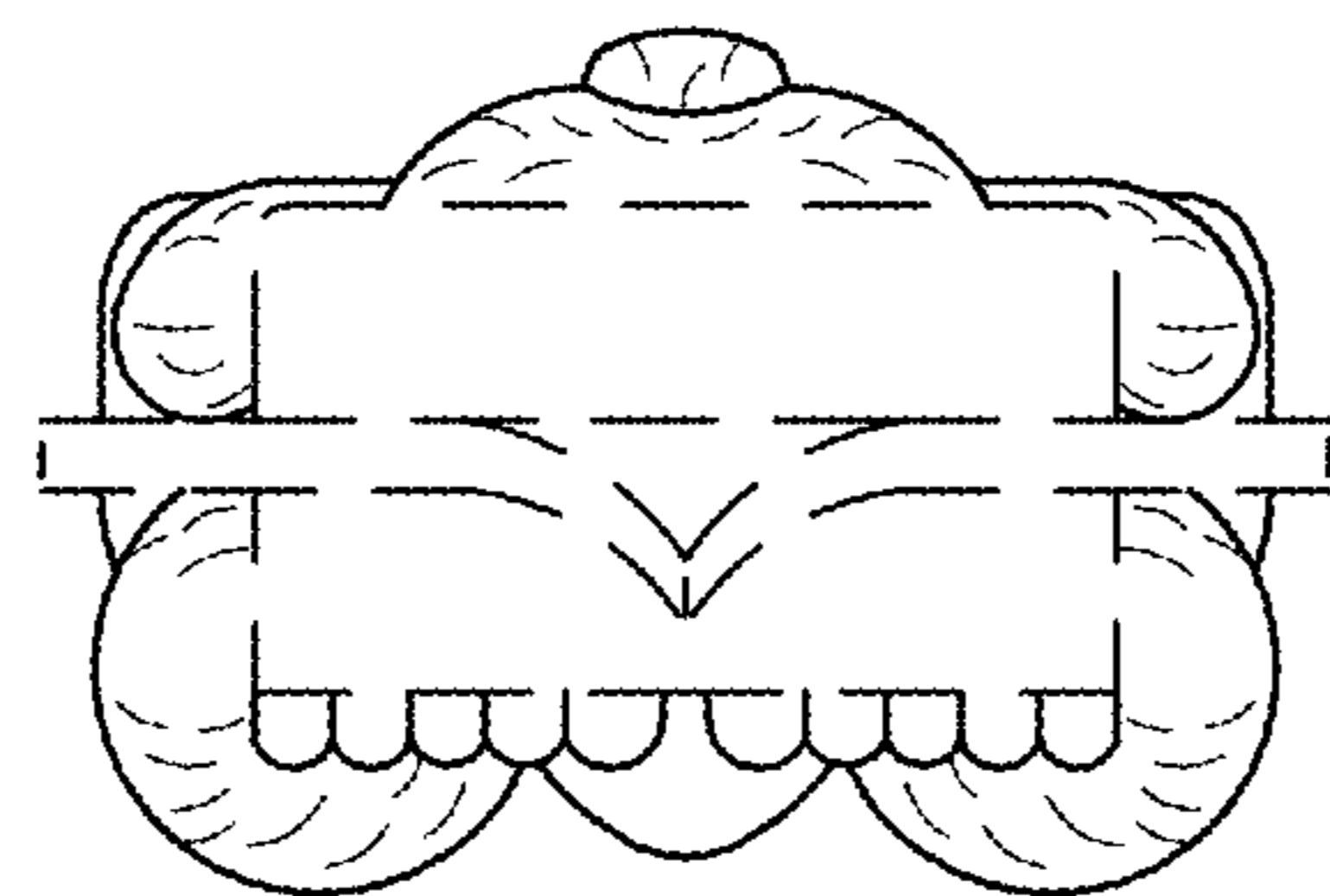

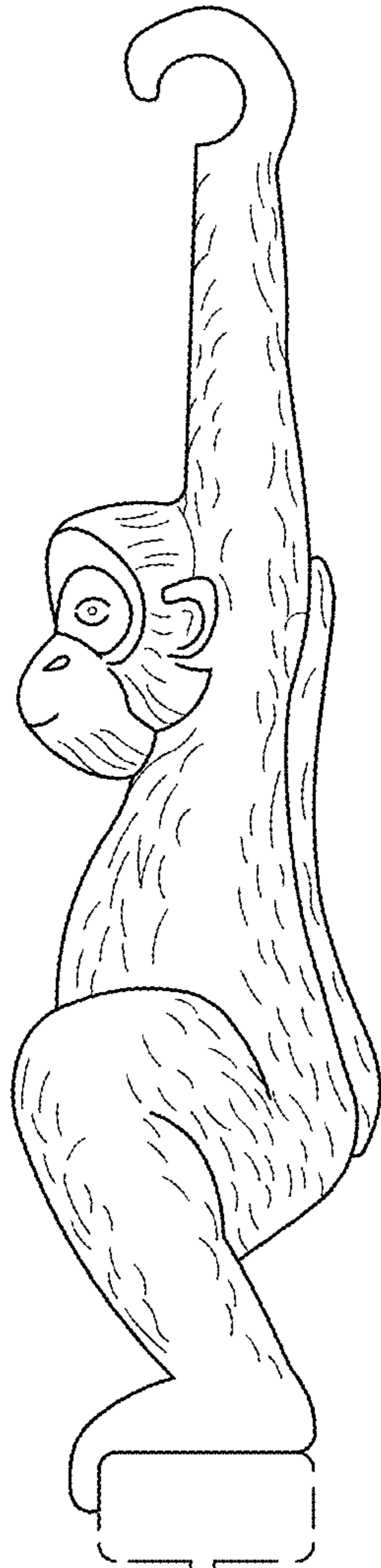

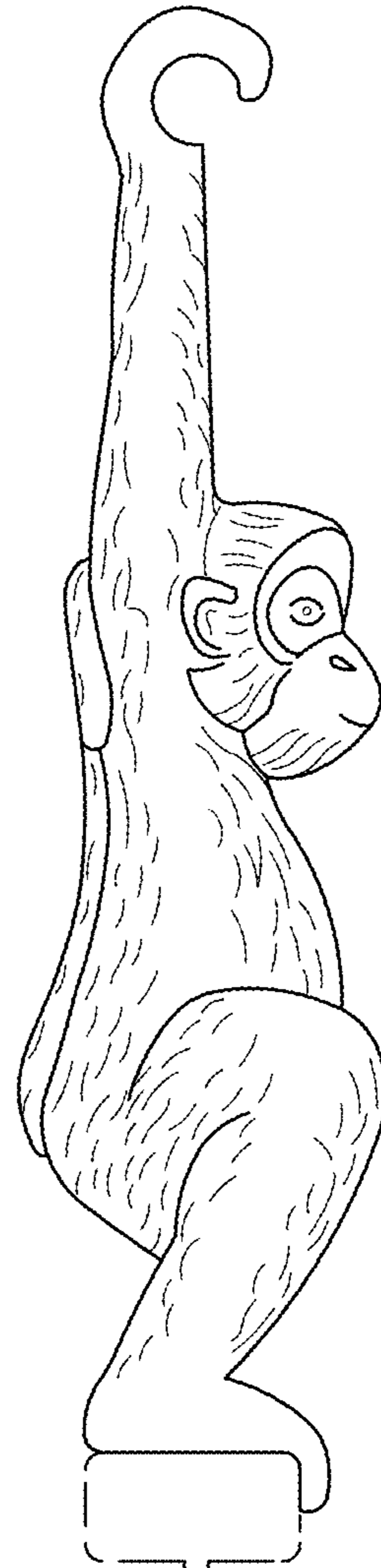

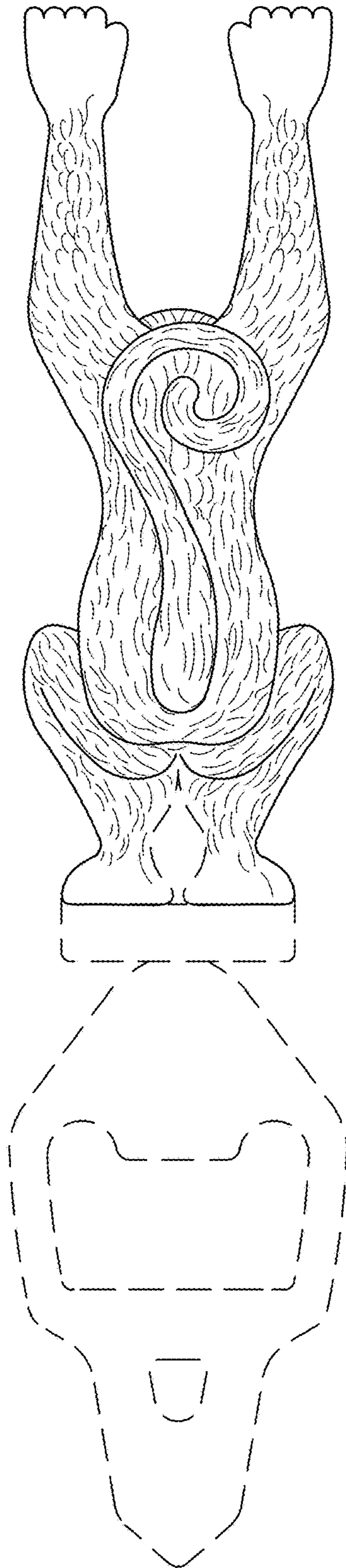
