(57) **CLAIM**

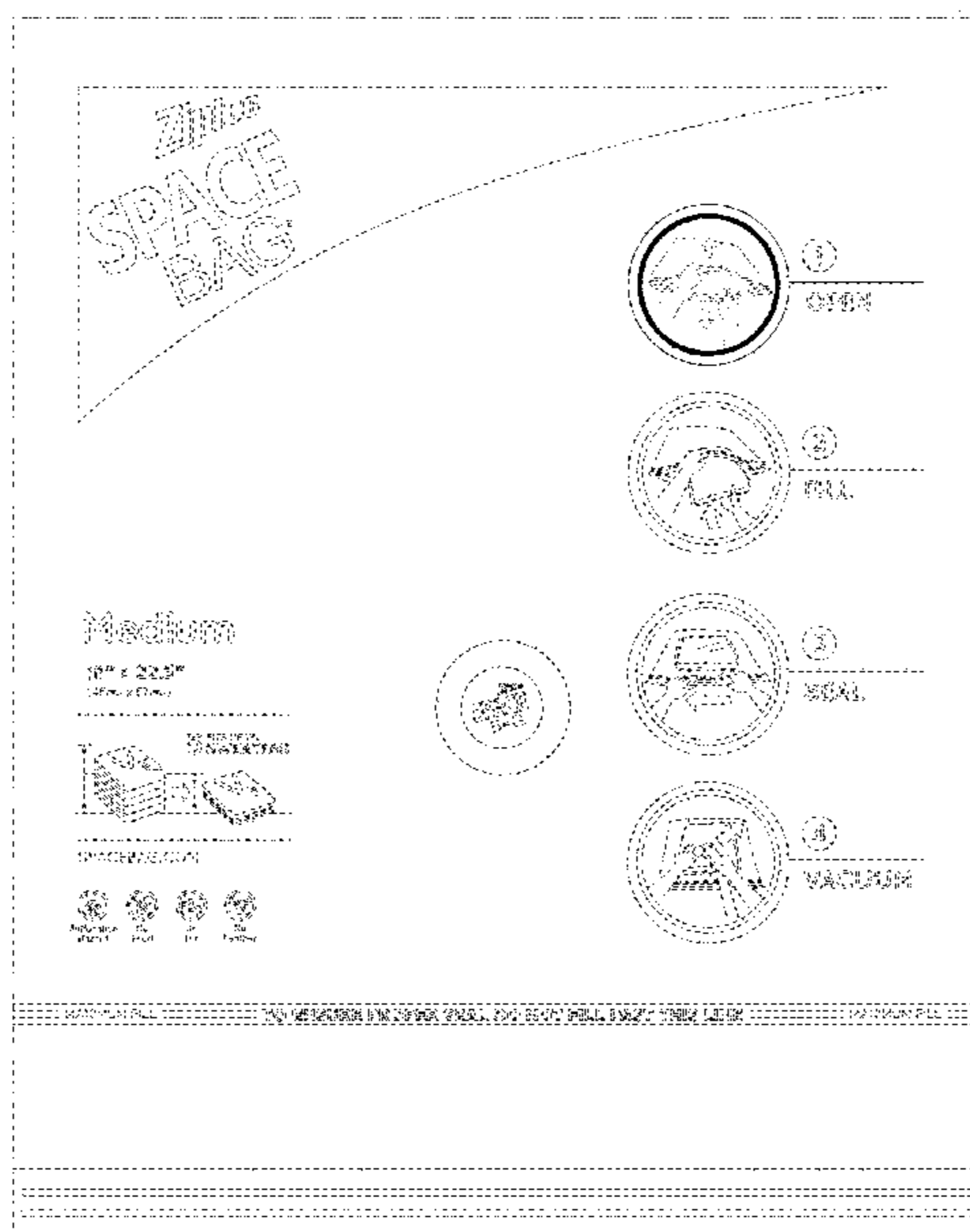
The ornamental design for a consumer product package with indicia, as shown and described.

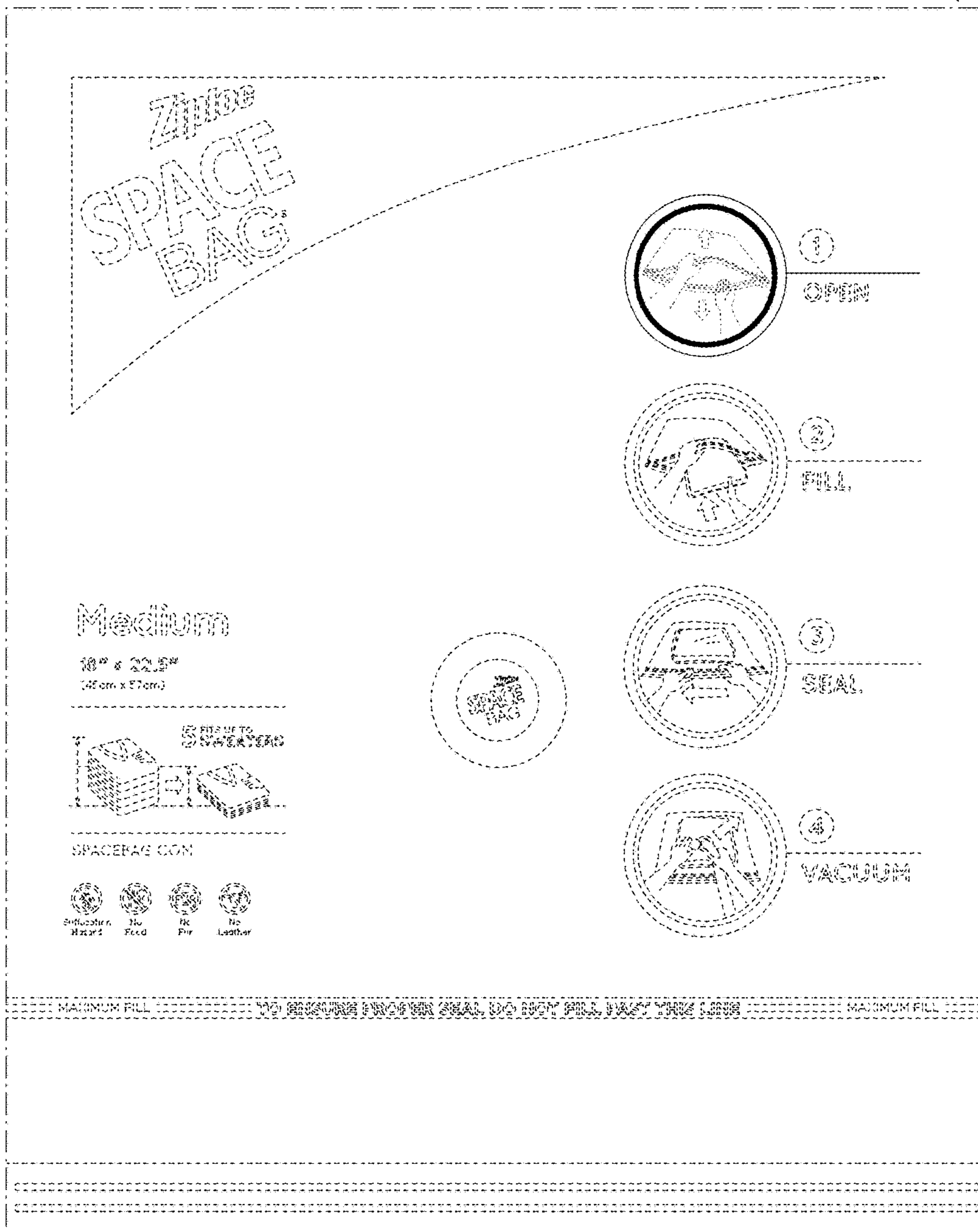

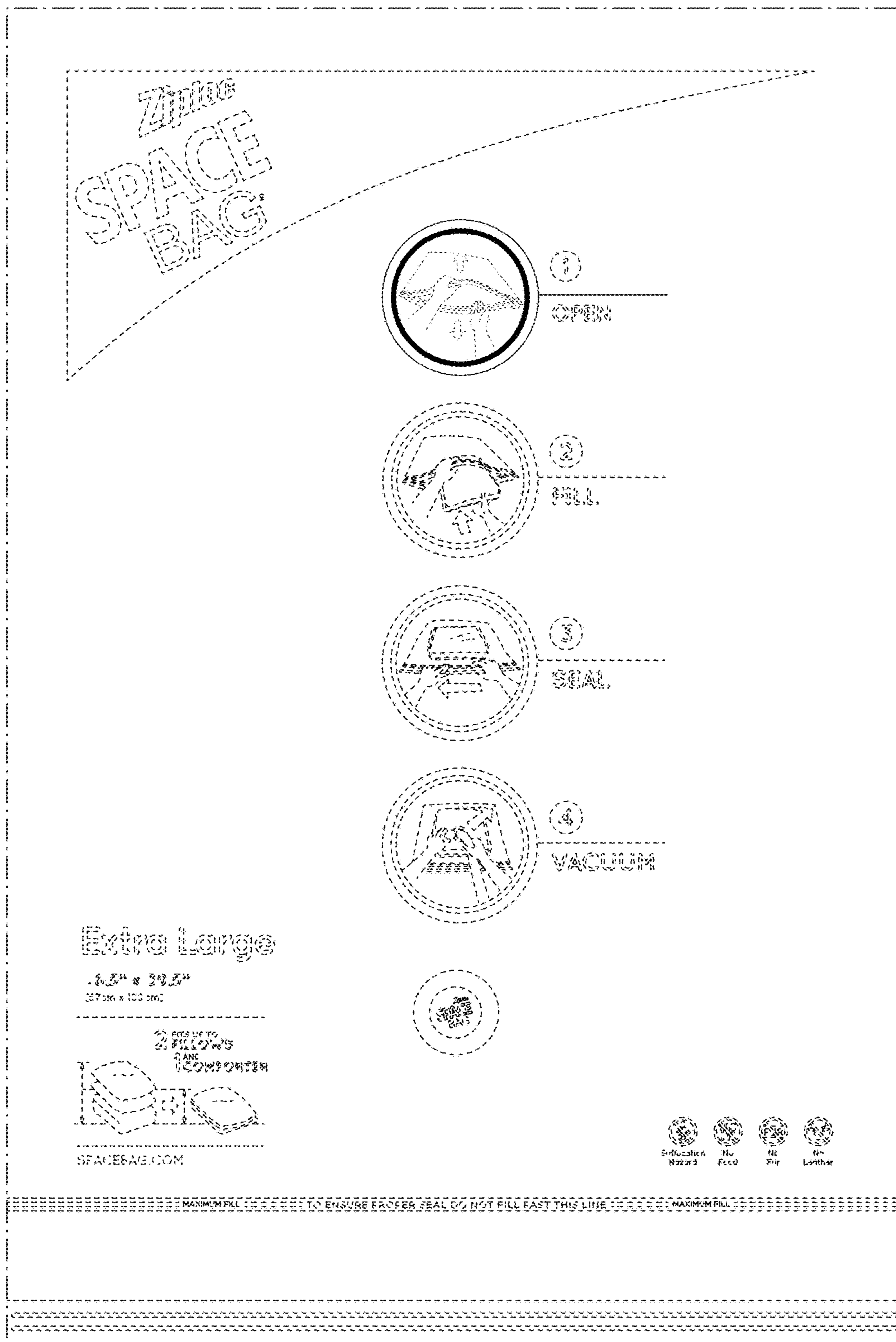
