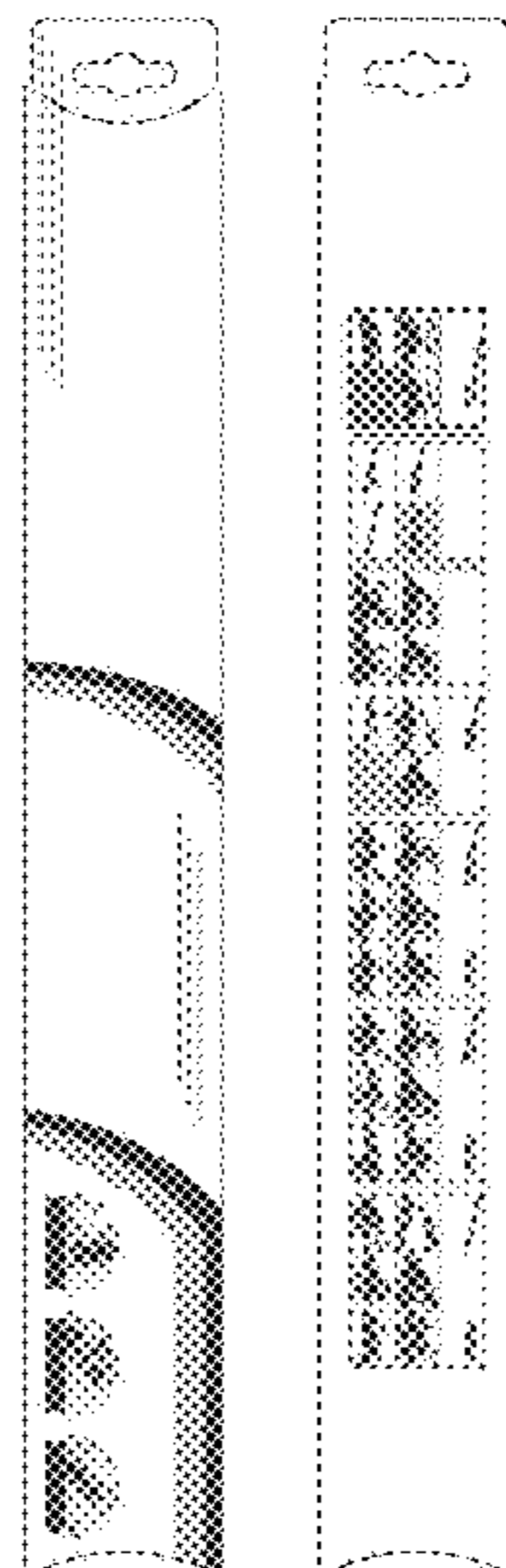
FIG. 1 is a front elevational view of a package showing a first embodiment of my new design.

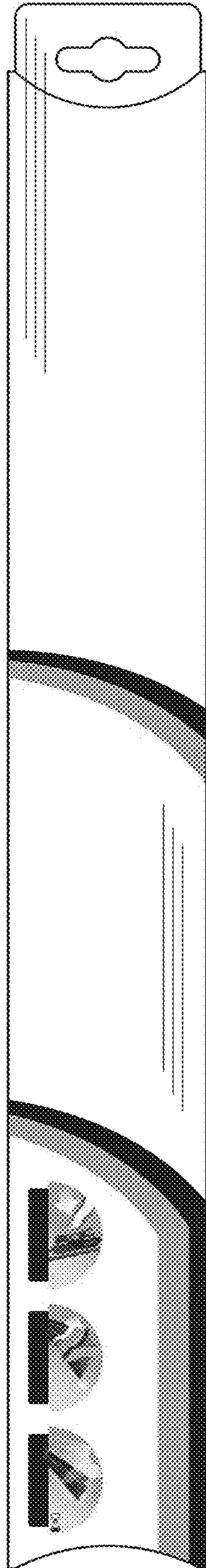

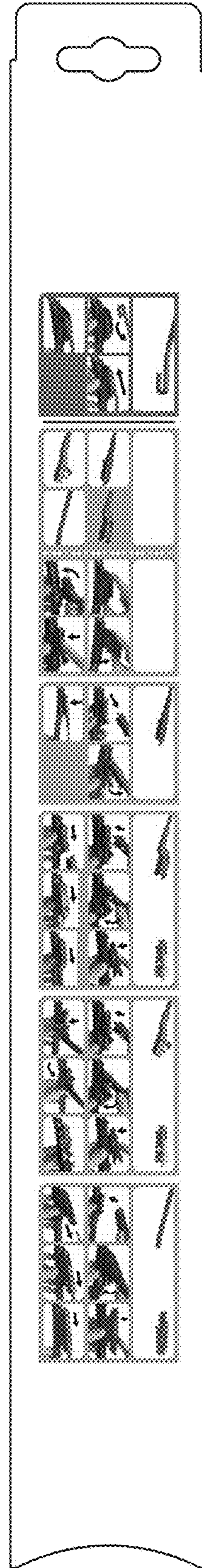
