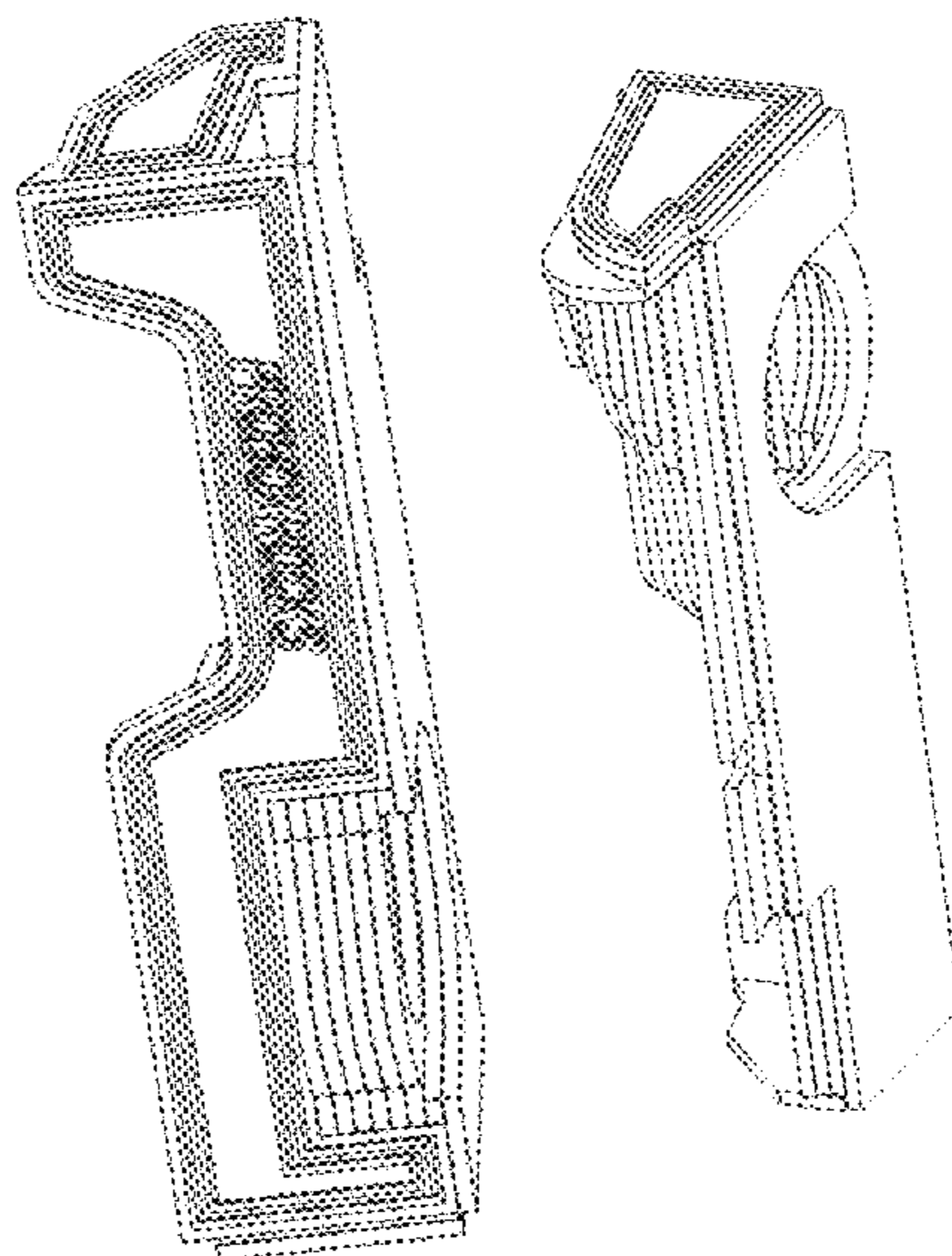
(57) **CLAIM**

The ornamental design for a speaker enclosure, as shown and described.

**DESCRIPTION**

FIG. 1 is a view of the left end of the speaker enclosure. FIG. 2 is a view of the bottom of the speaker enclosure. FIG. 3 is a view of the front of the speaker enclosure. FIG. 4 is a view of the right end of the speaker enclosure. FIG. 5 is a view of the top of the speaker enclosure. FIG. 6 is a view of the back of the speaker enclosure. FIG. 7 is a left end-front-top view of the speaker enclosure. FIG. 8 is a right end-front-top view of the speaker enclosure. FIG. 9 is a left end-back-top view of the speaker enclosure; and, FIG. 10 is a right end-back-top view of the speaker enclosure.

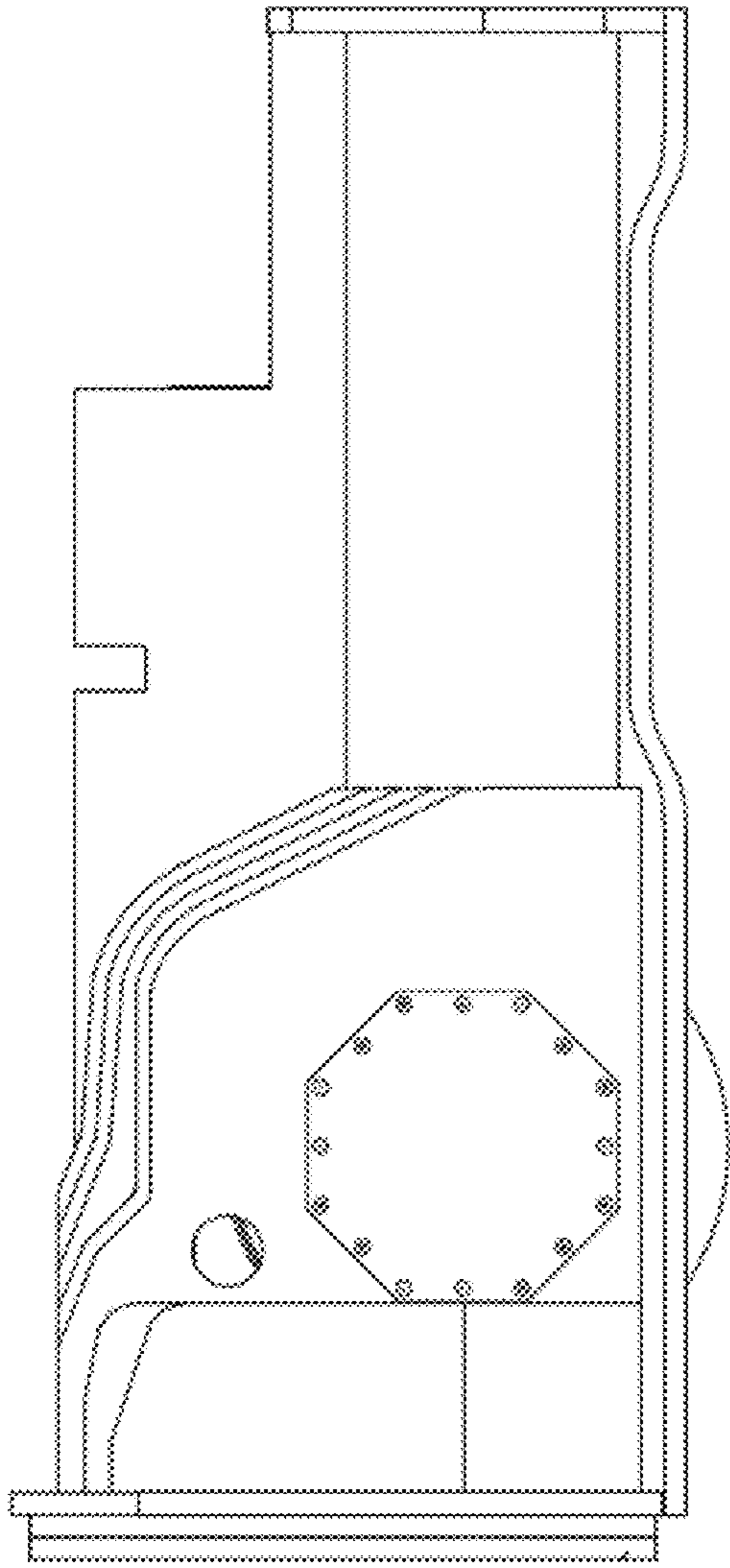

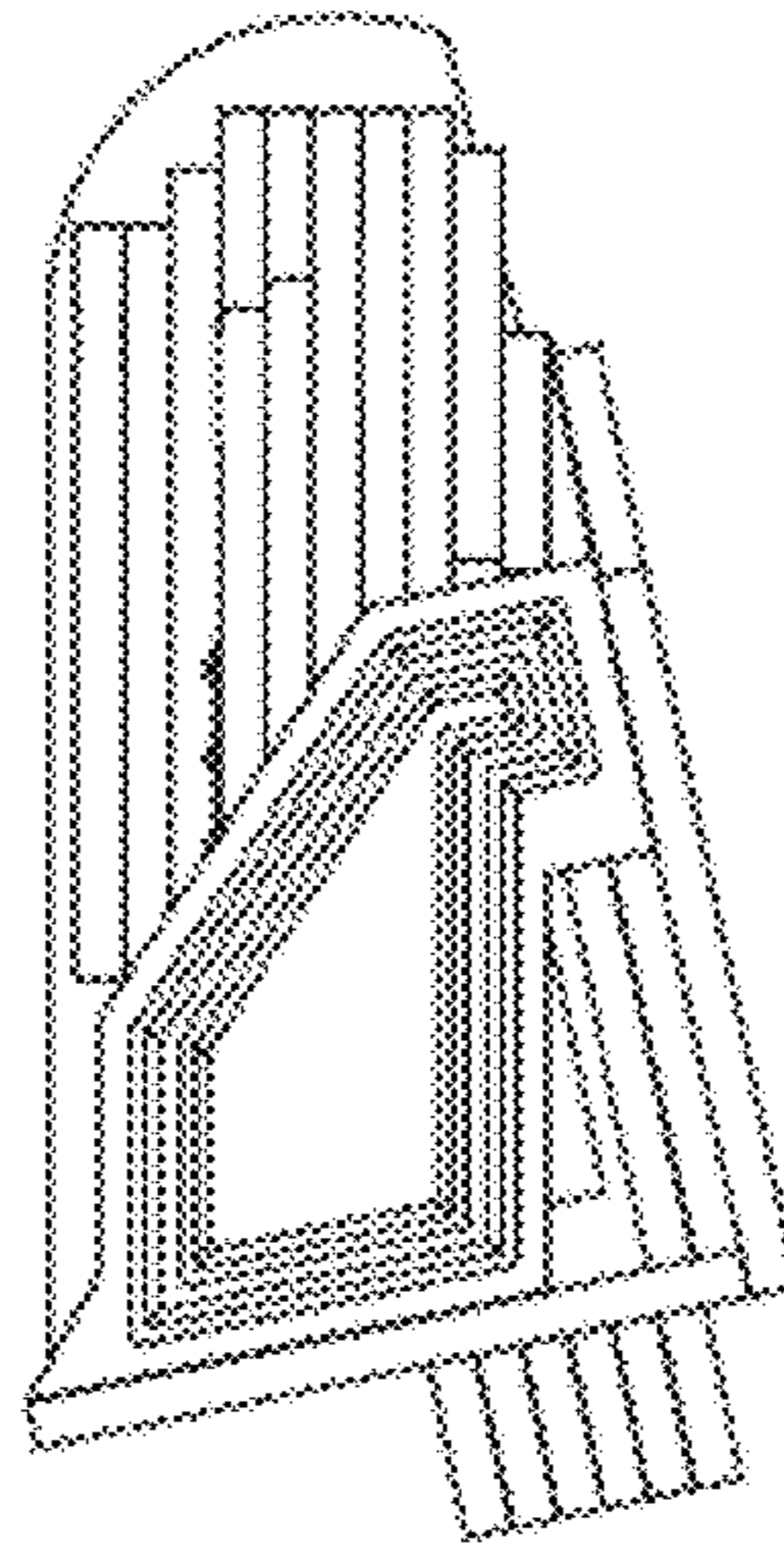

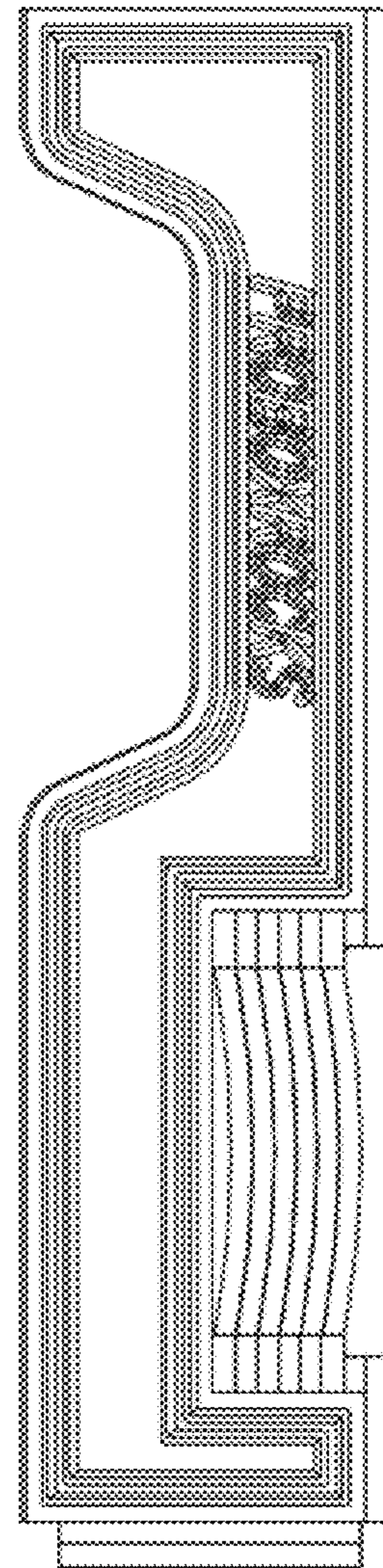

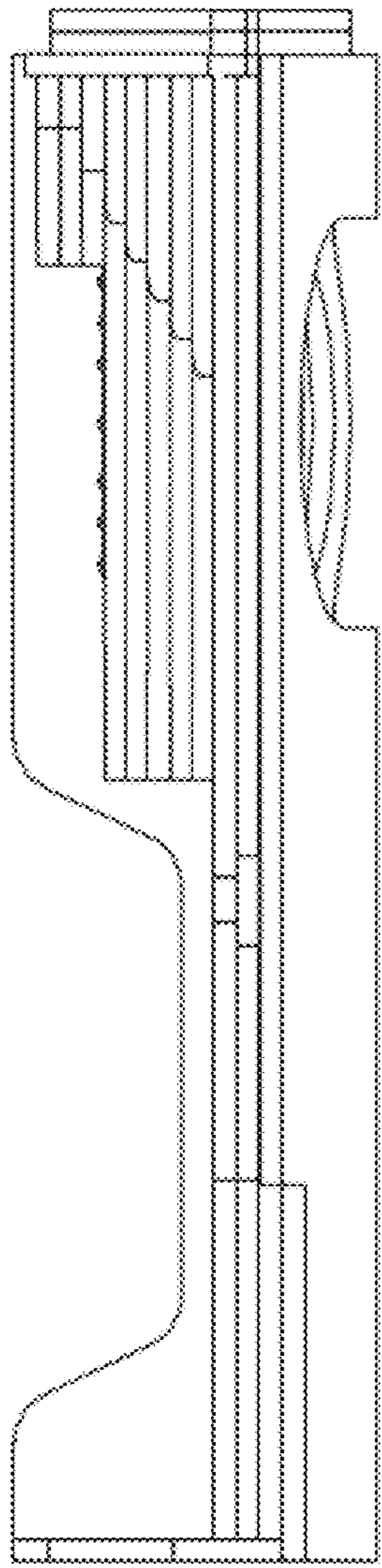

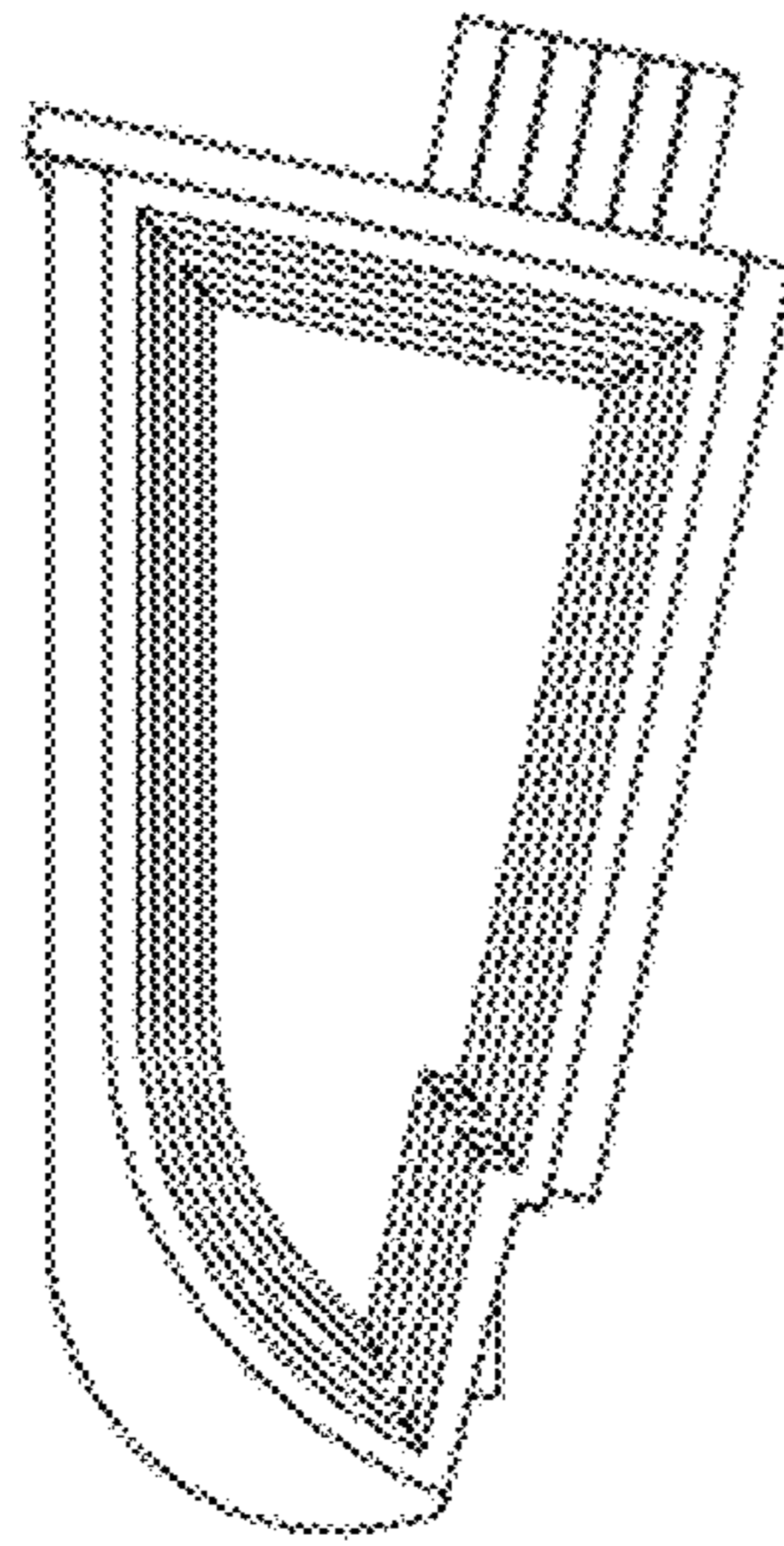

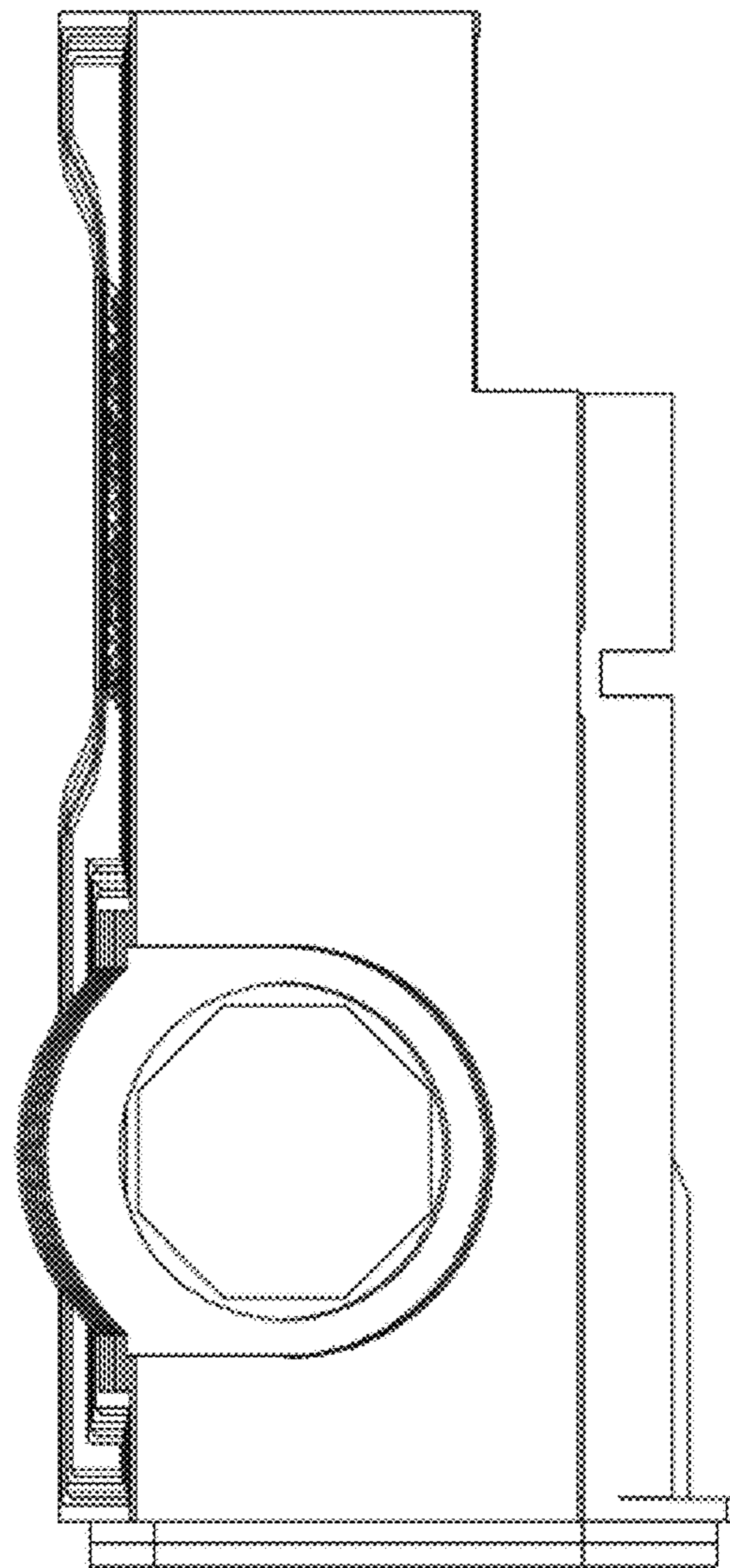

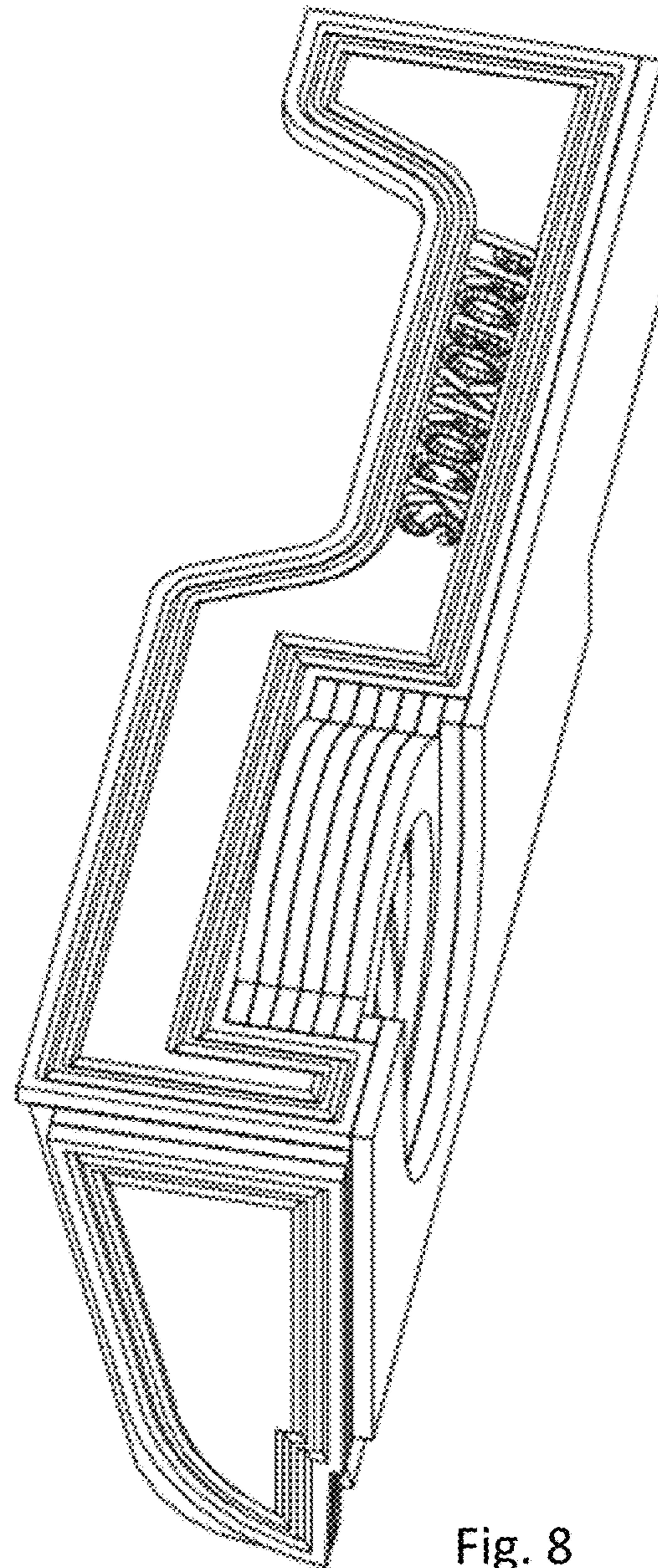
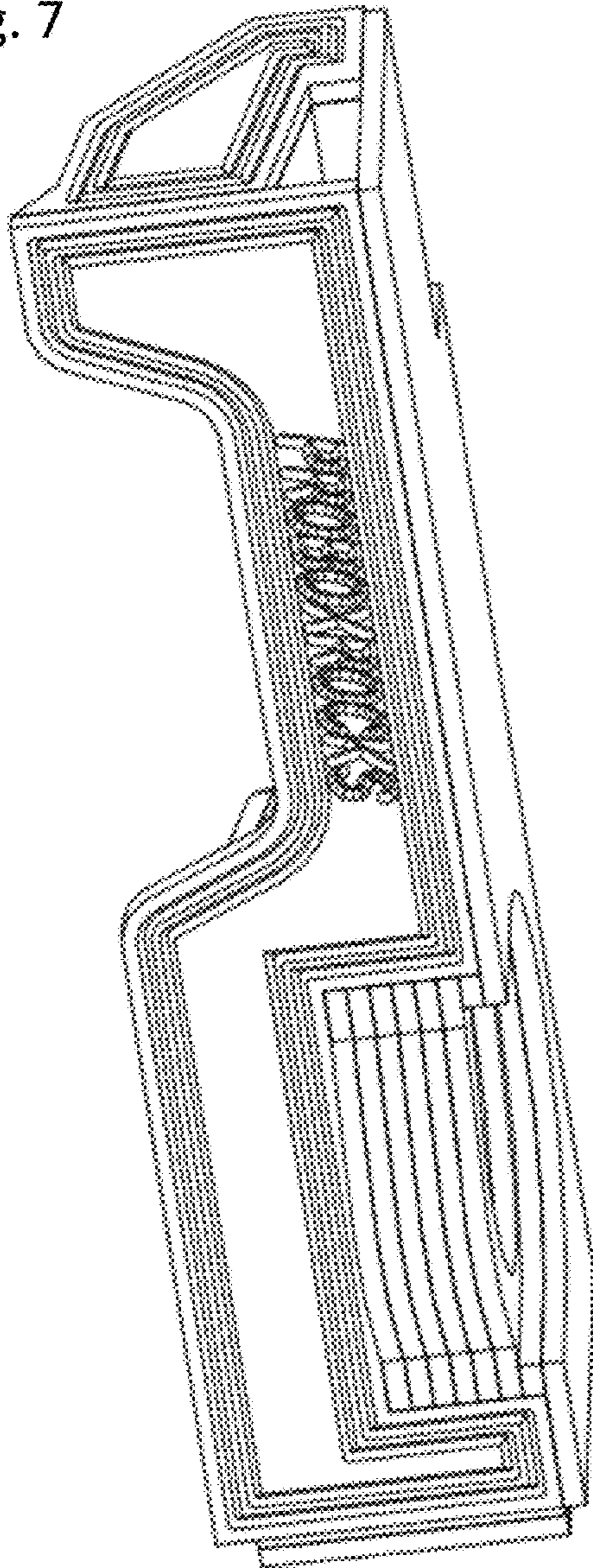

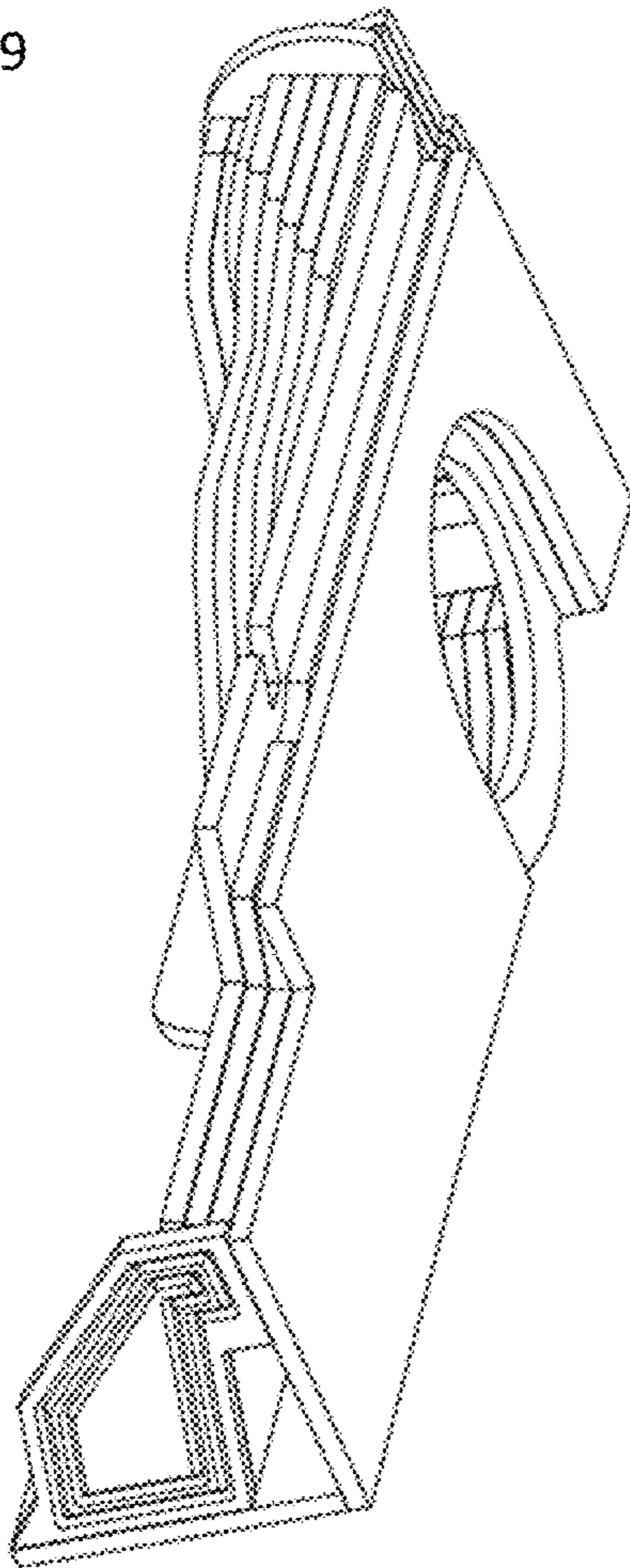
