The ornamental design for an apparatus for recording,
transmission or processing information, as shown and
described.

DESCRIPTION

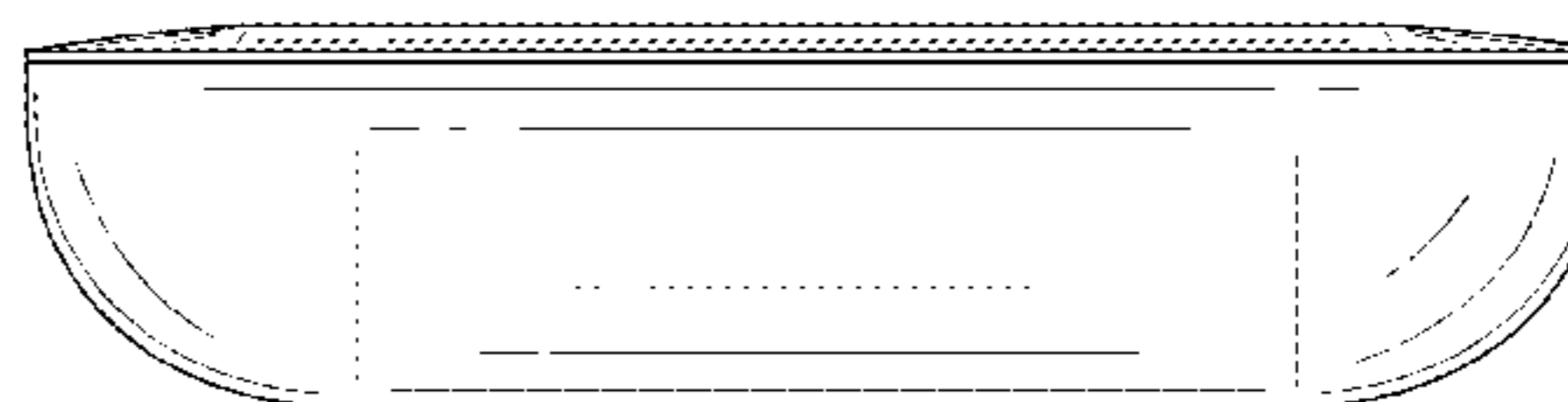
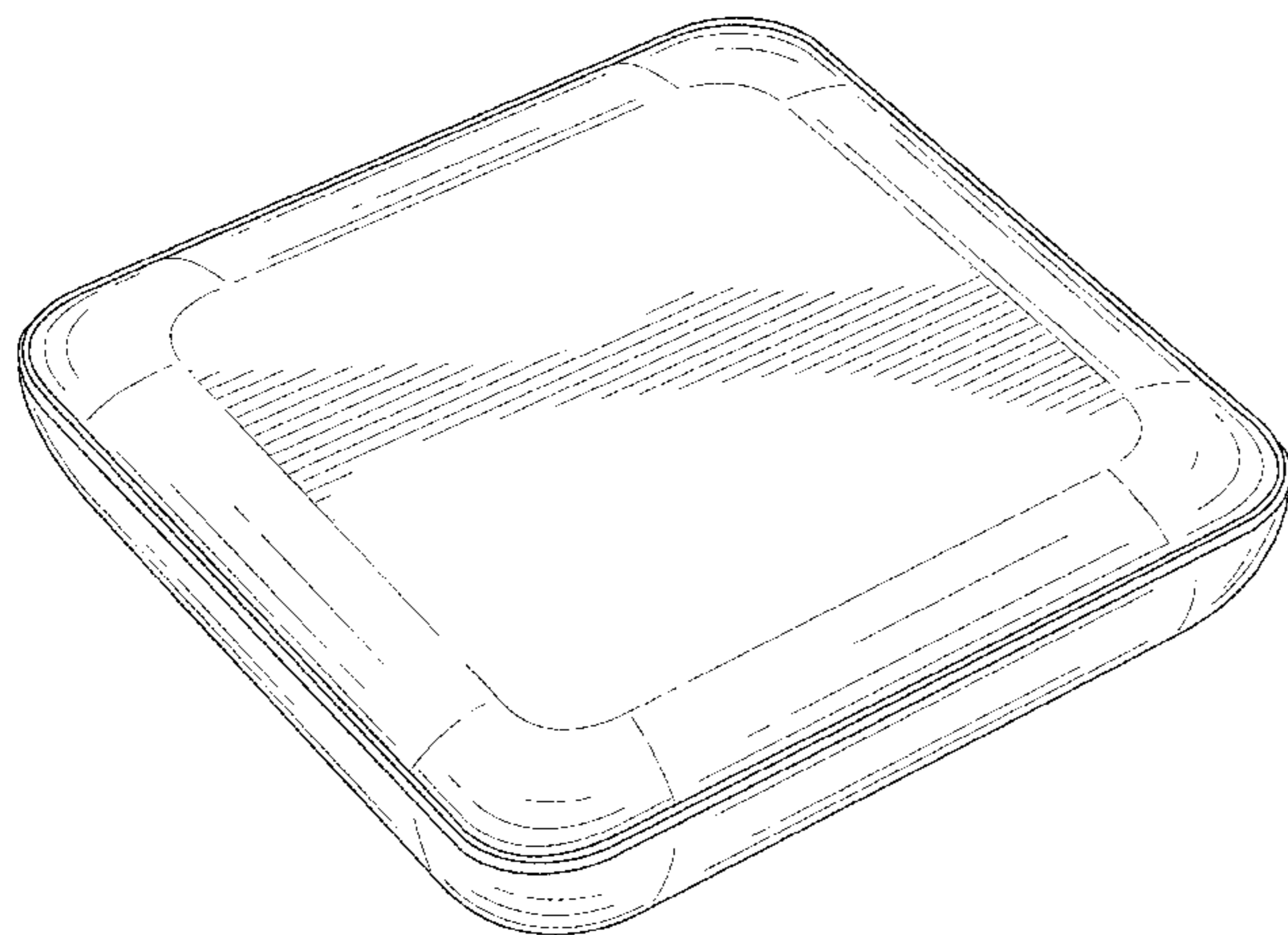


FIG. 8 is a bottom plan view showing the design for the apparatus for recording, transmission or processing information of FIG. 1.

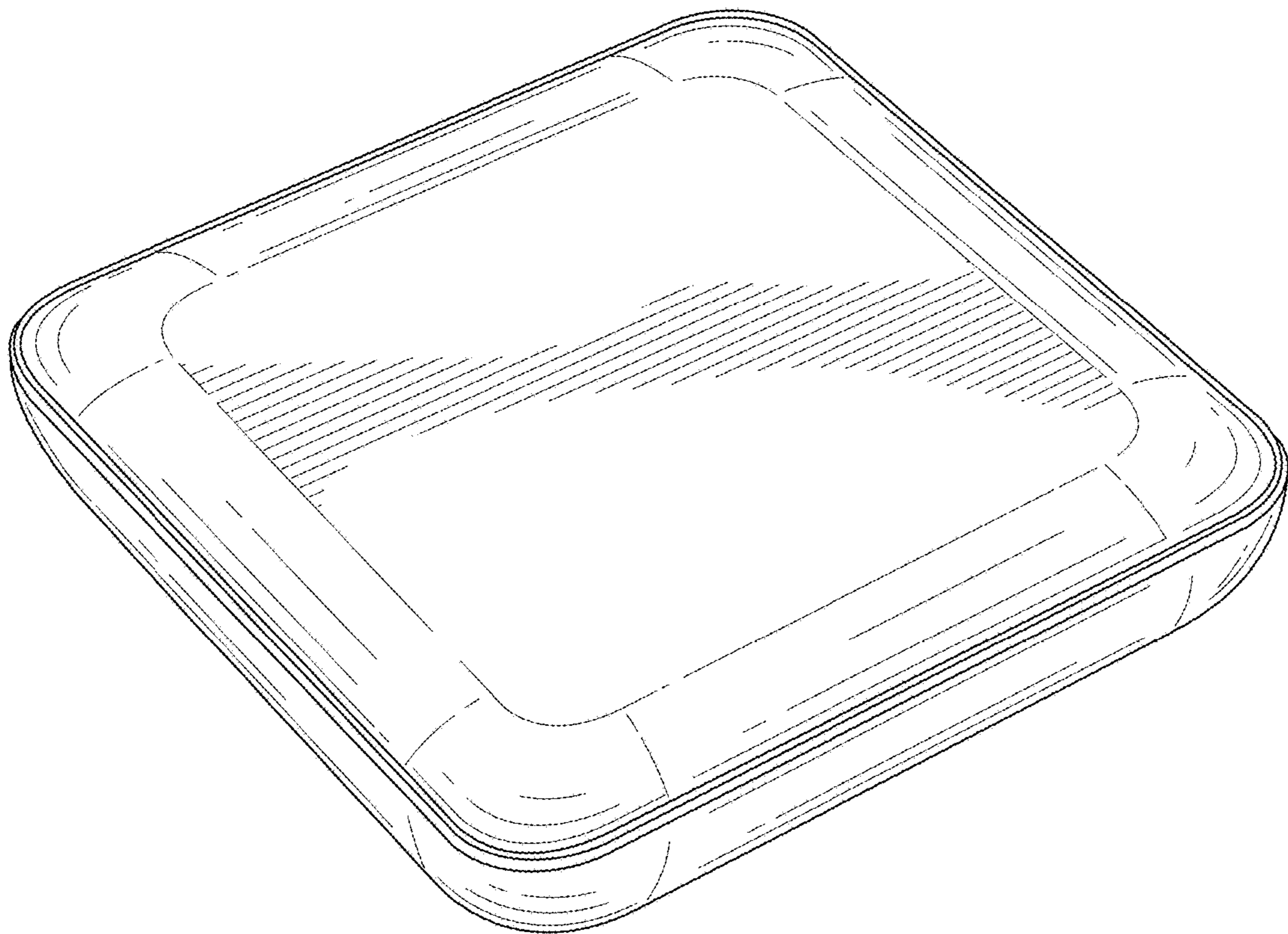

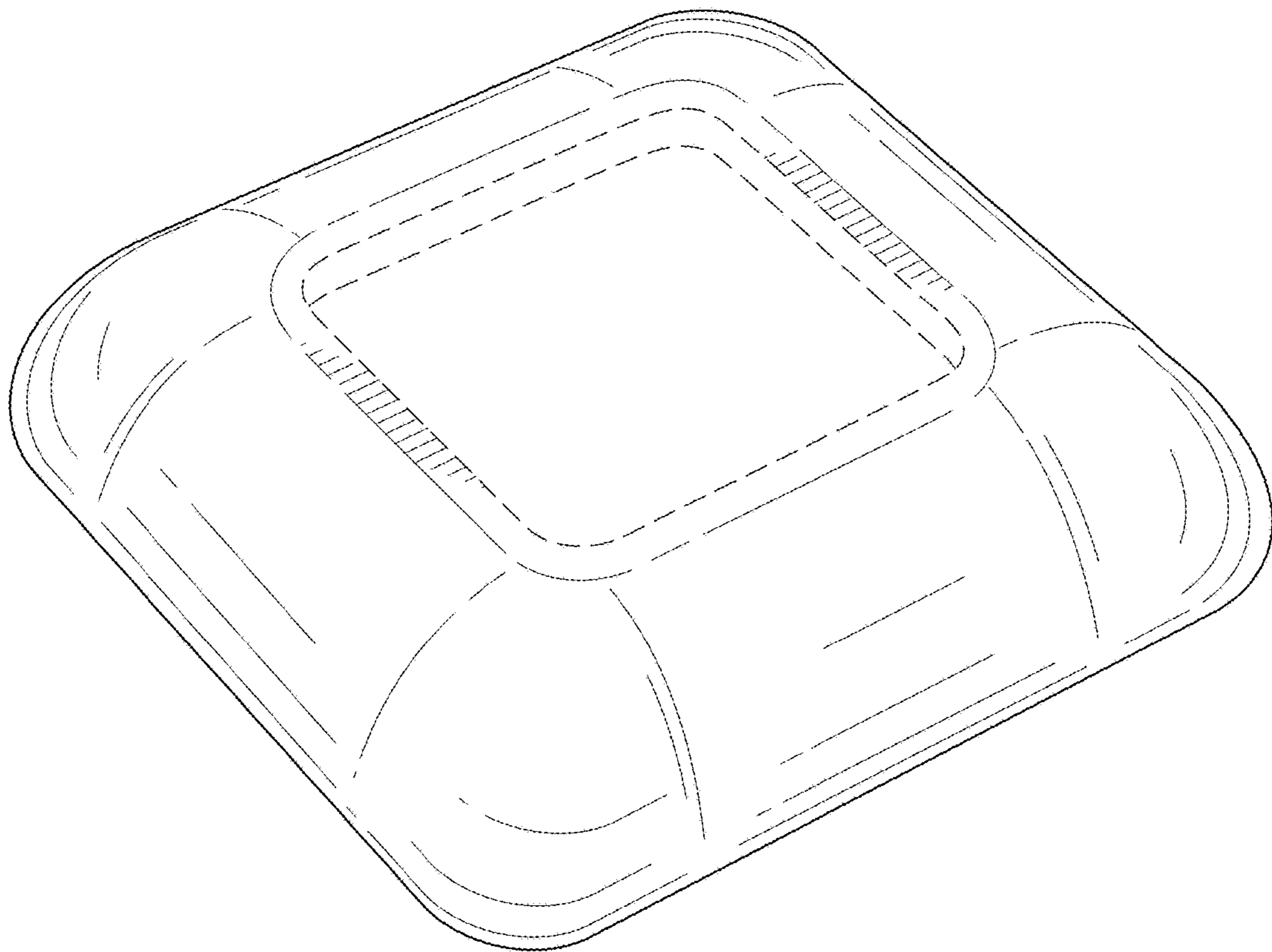

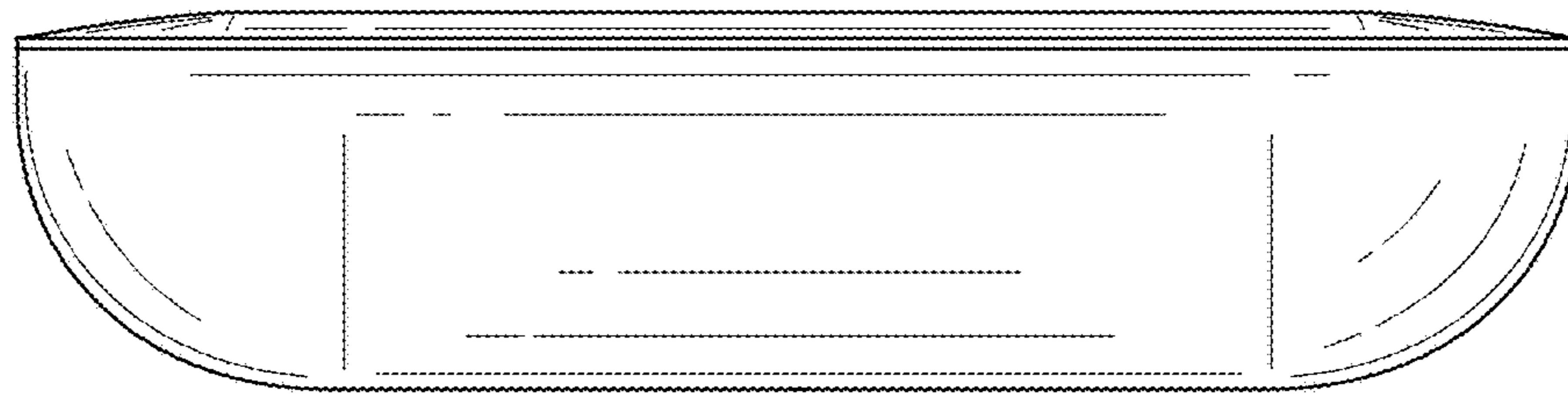

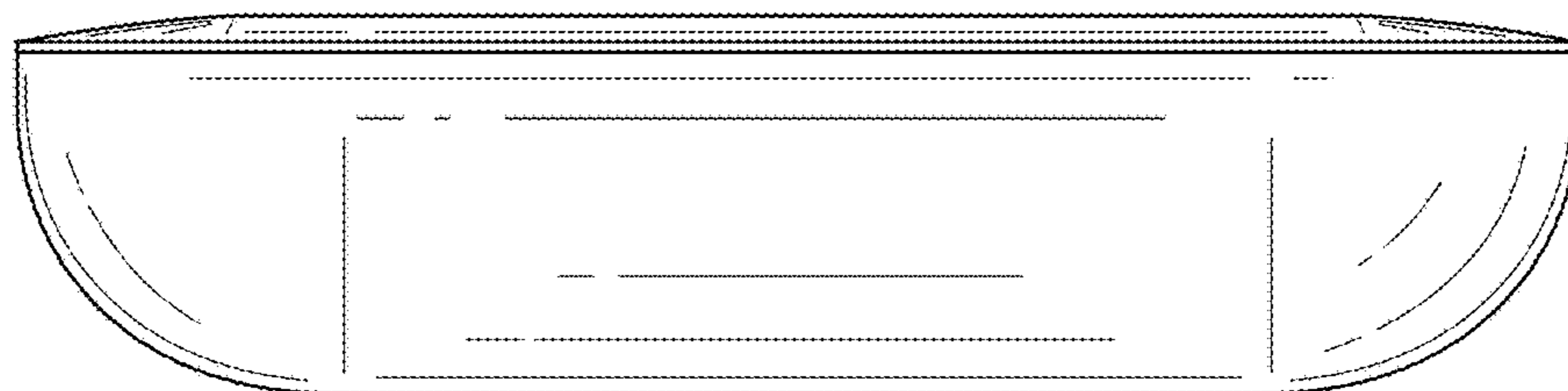

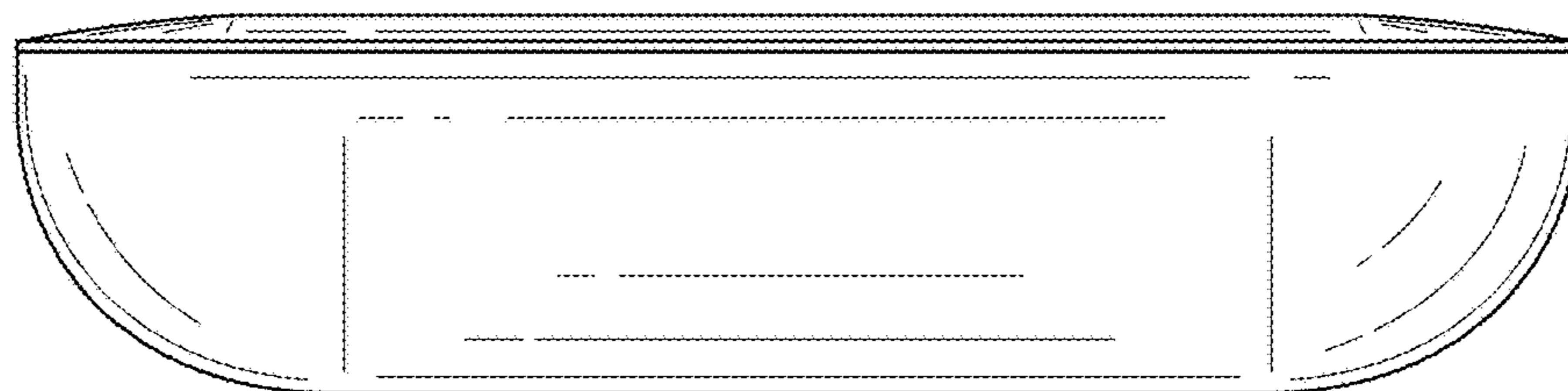

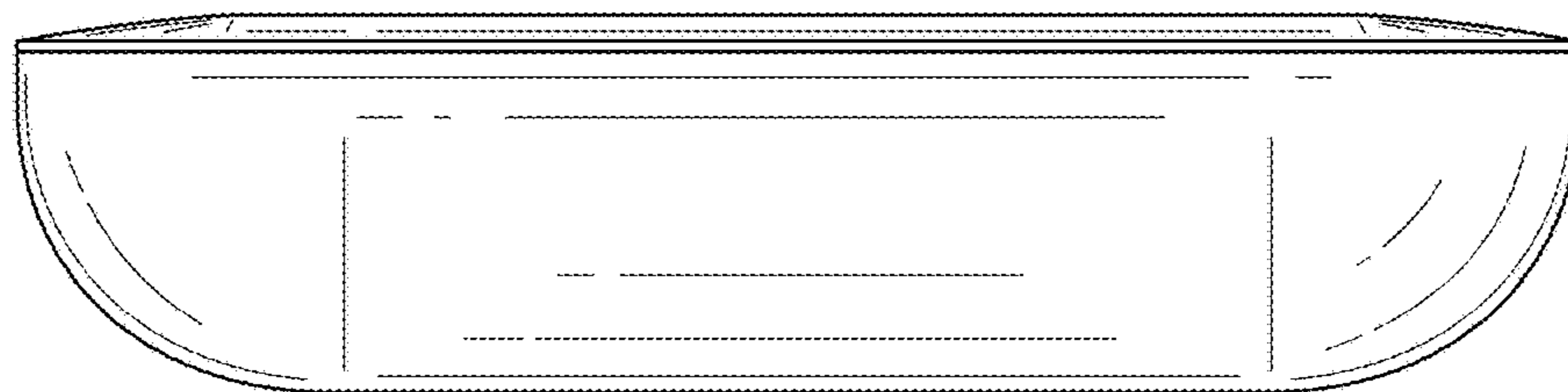

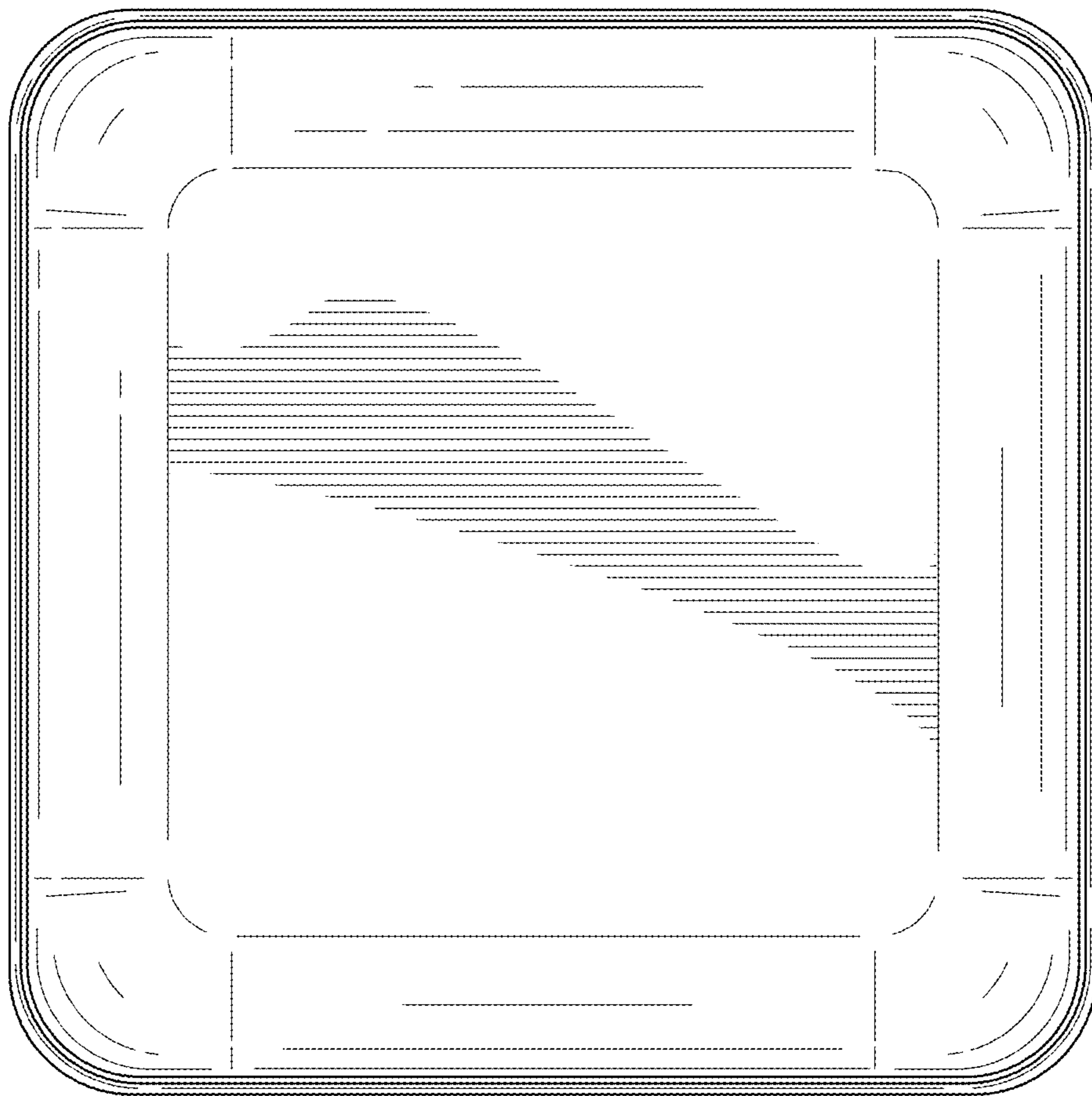

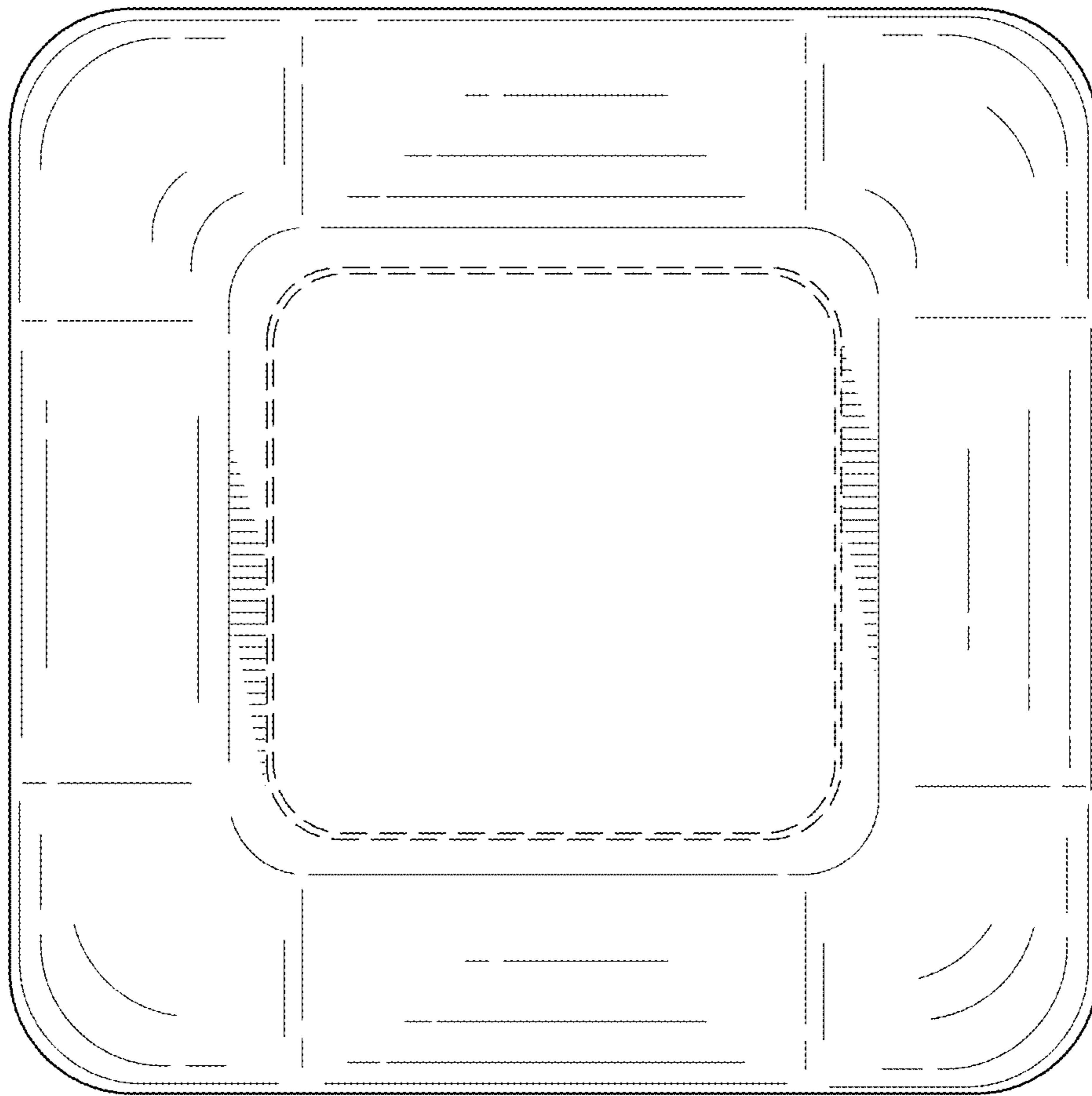
