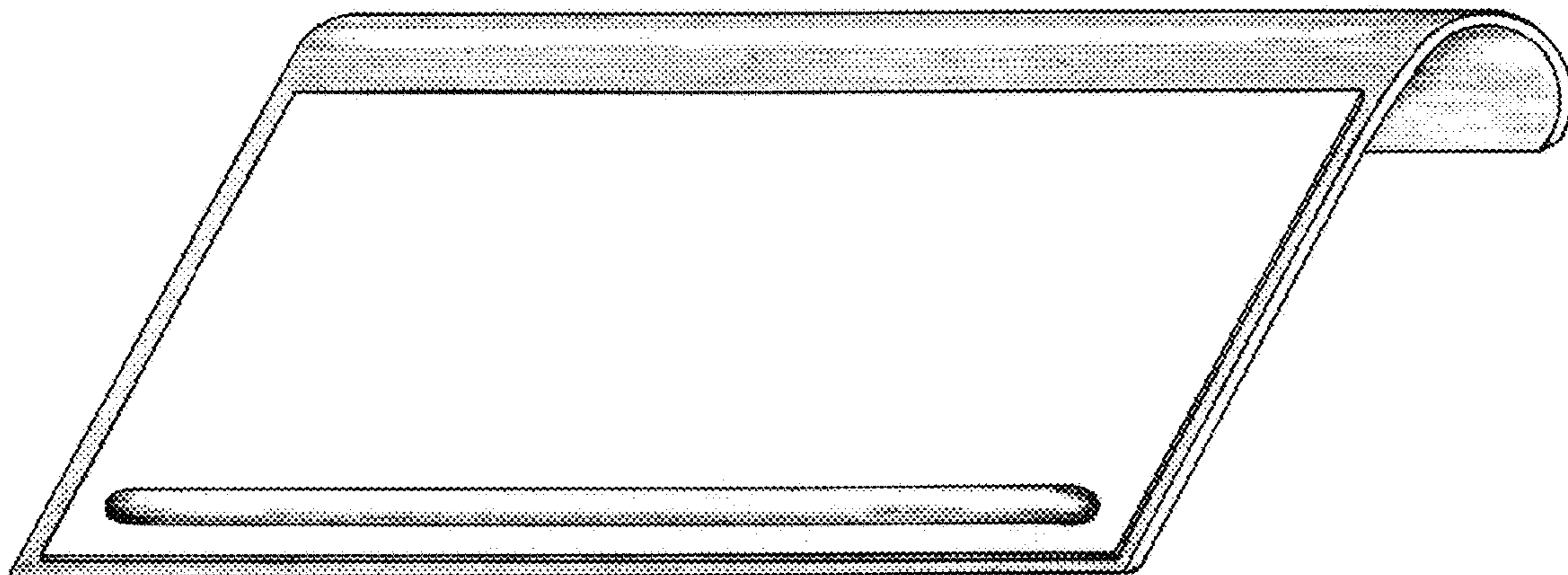
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective elevational view of a tablet stand showing my new shape and design;

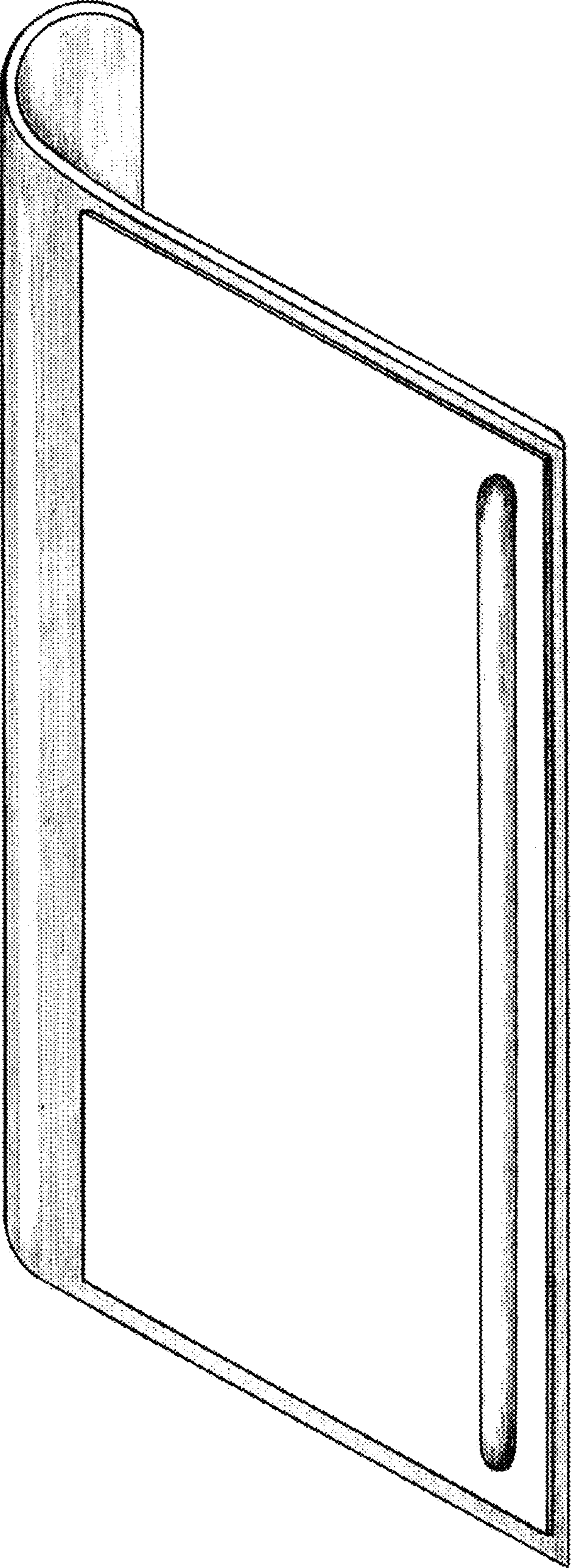

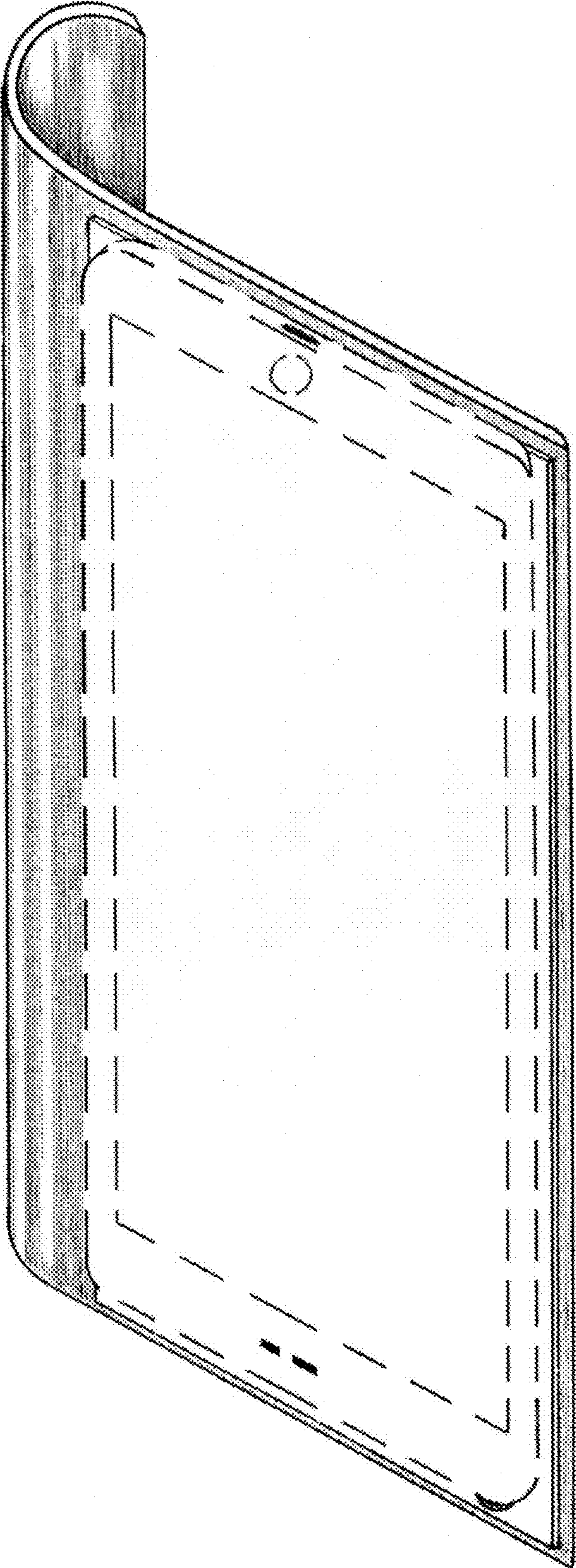
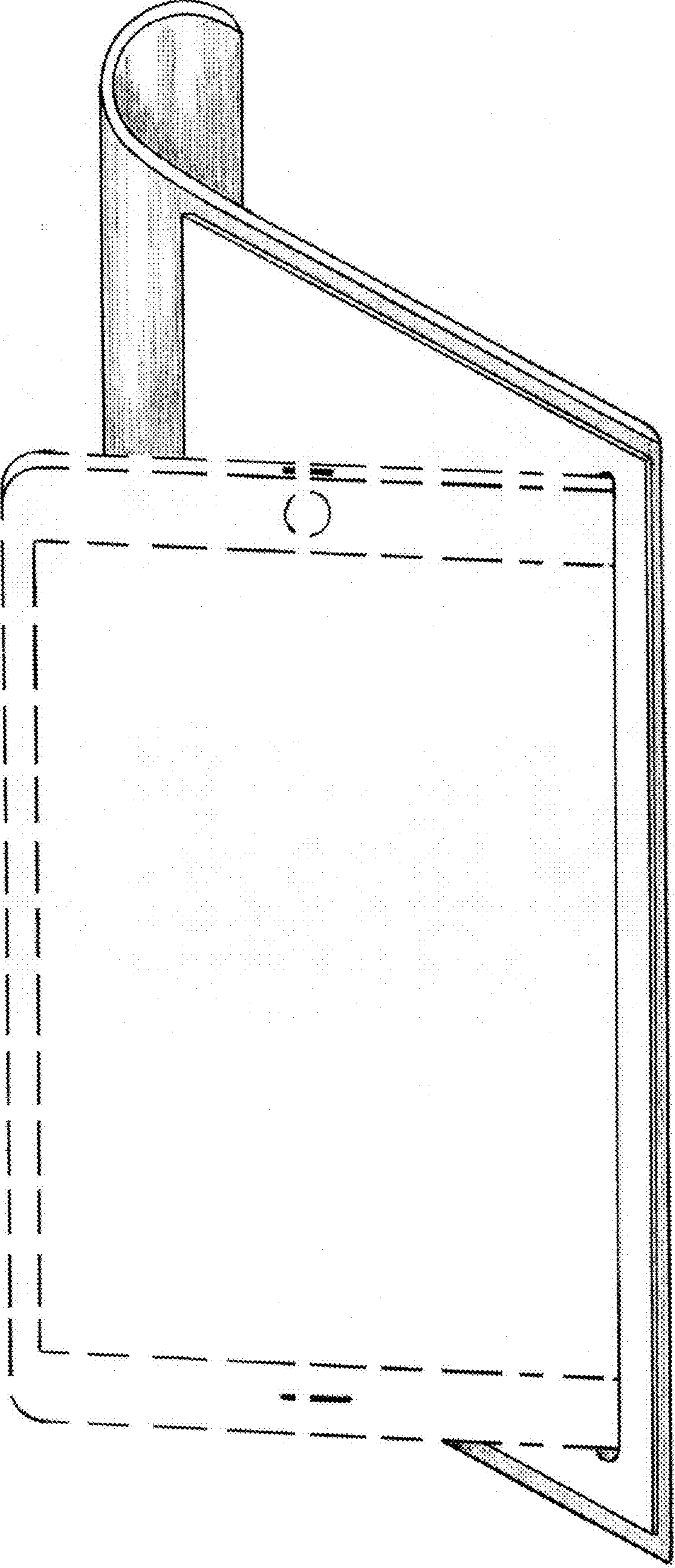

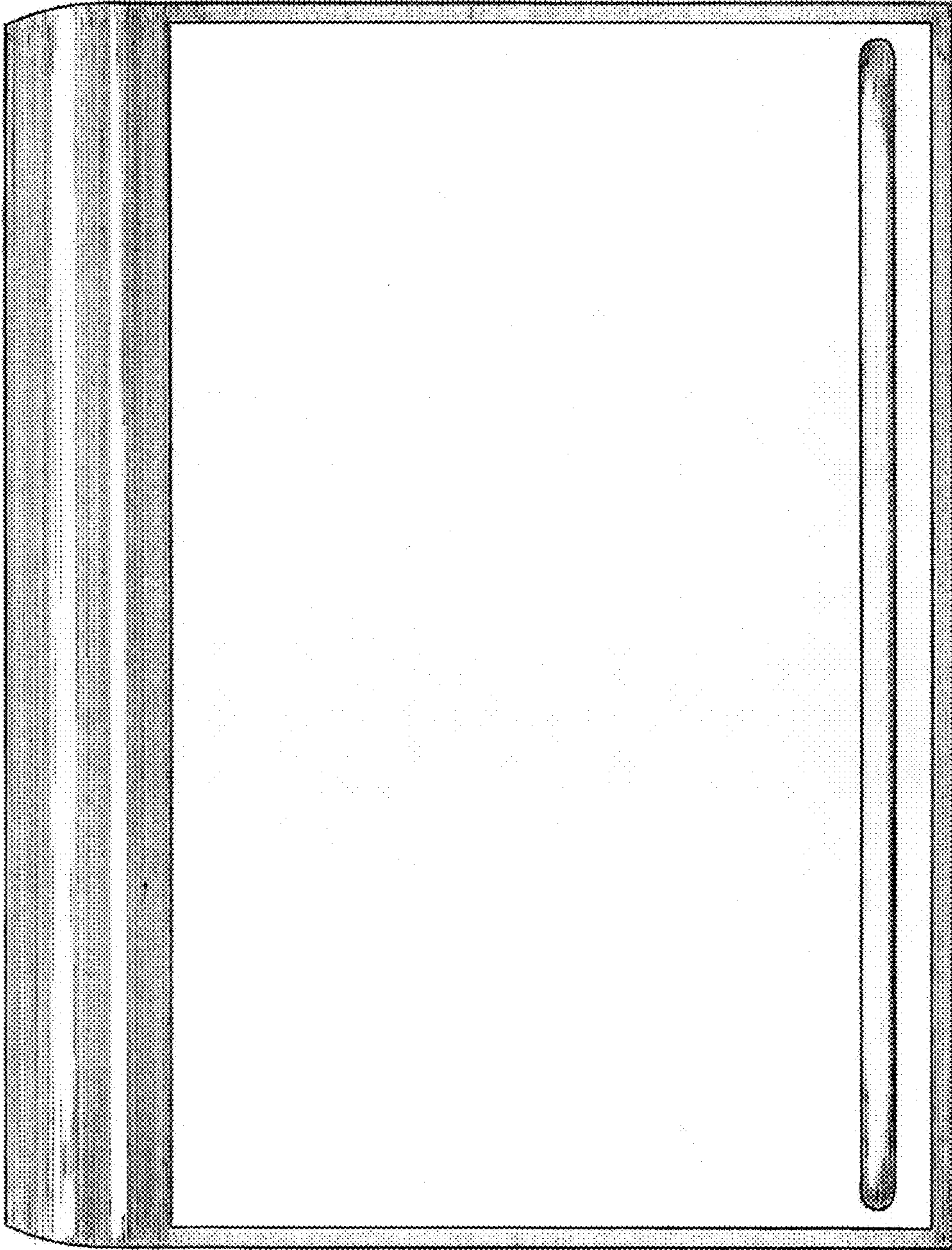

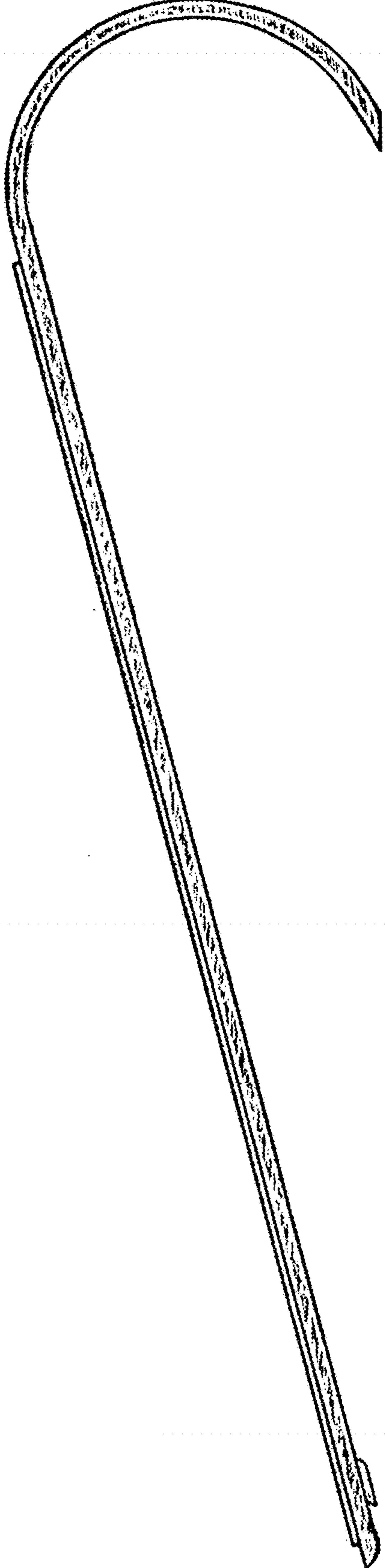

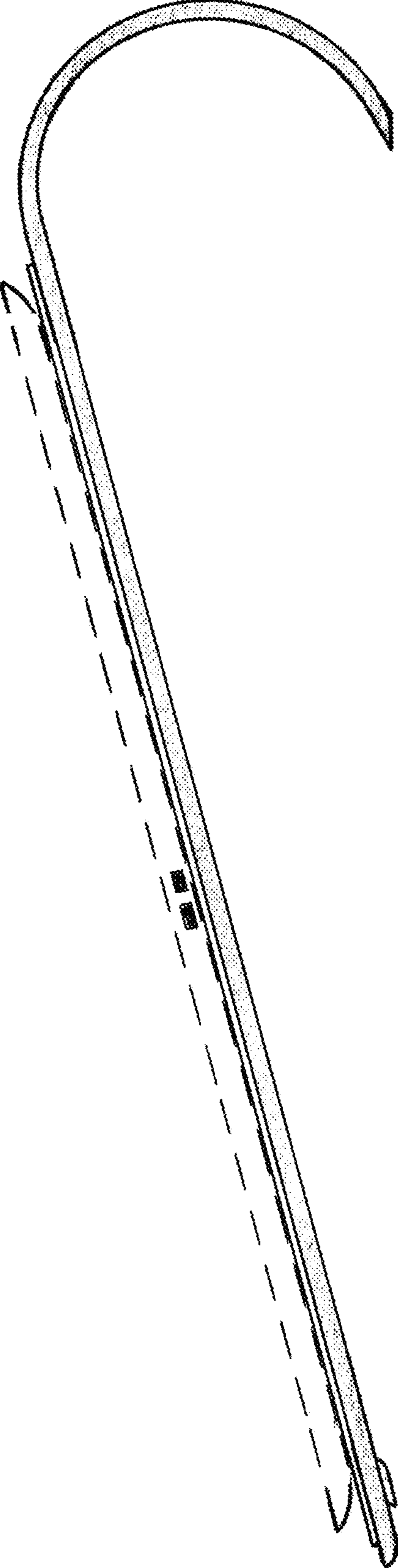

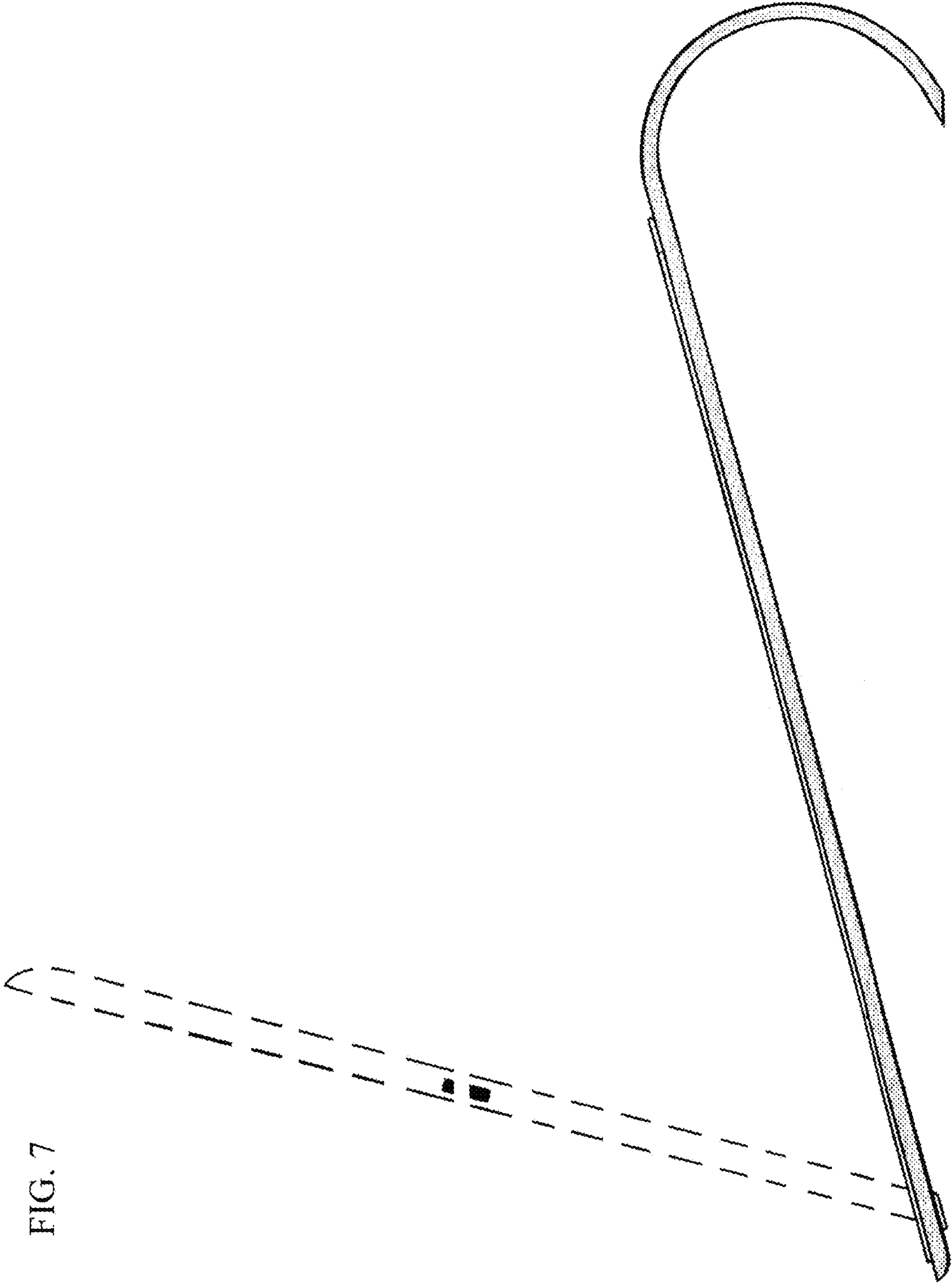

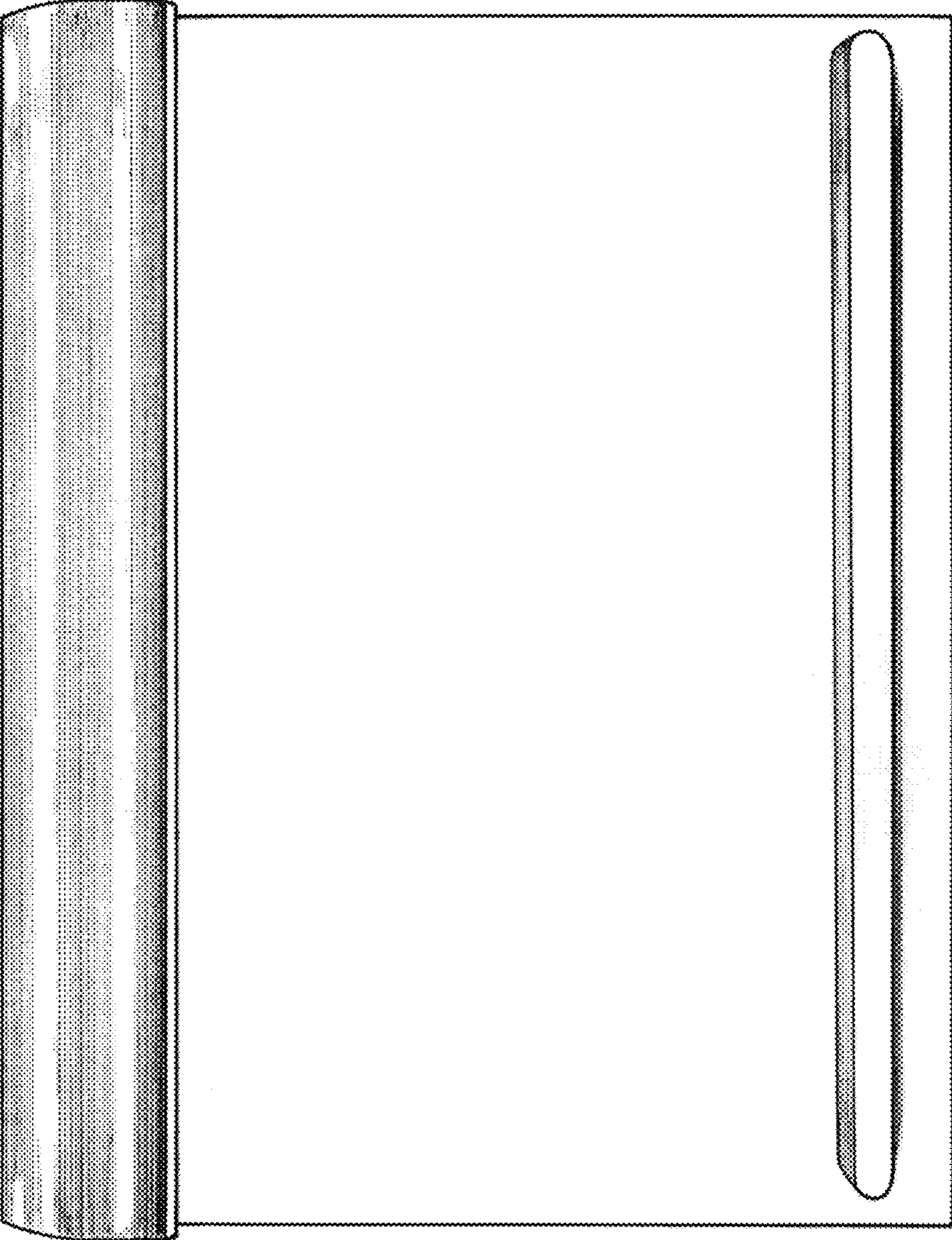
