FIG. 1 is a perspective view of a first embodiment of a keyboard layout for a protective folio showing our new design;

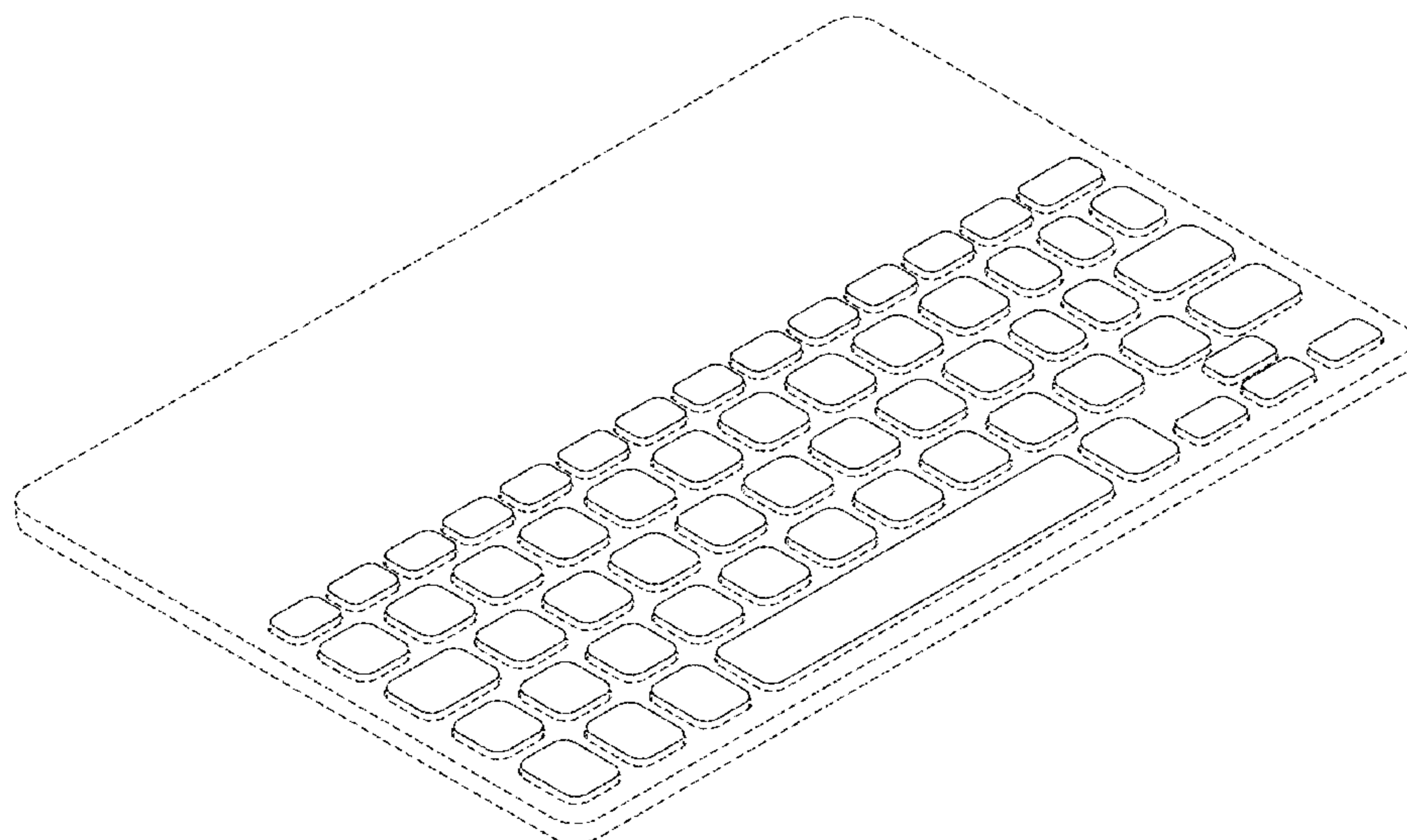
FIG. 2 is a top plan view thereof;

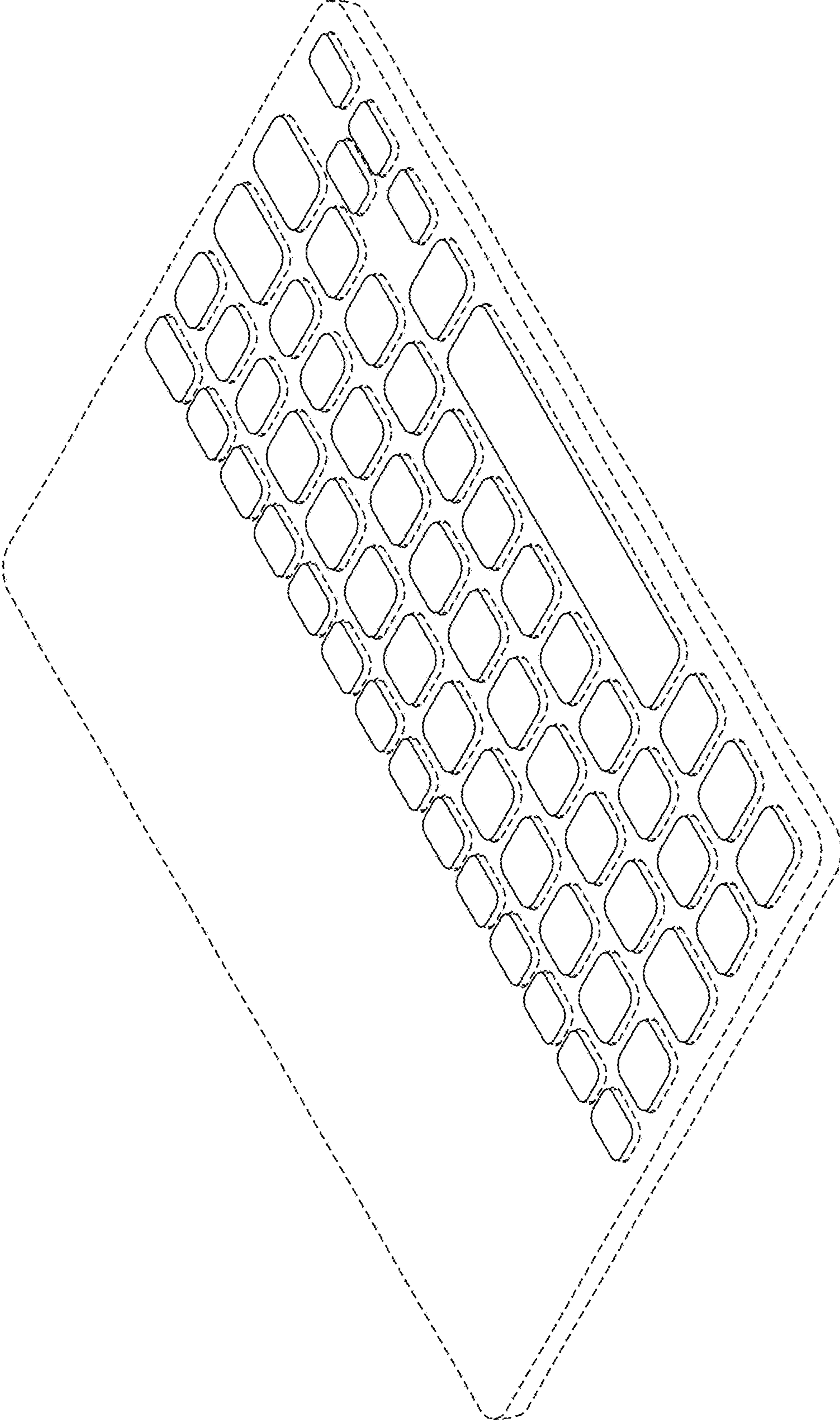

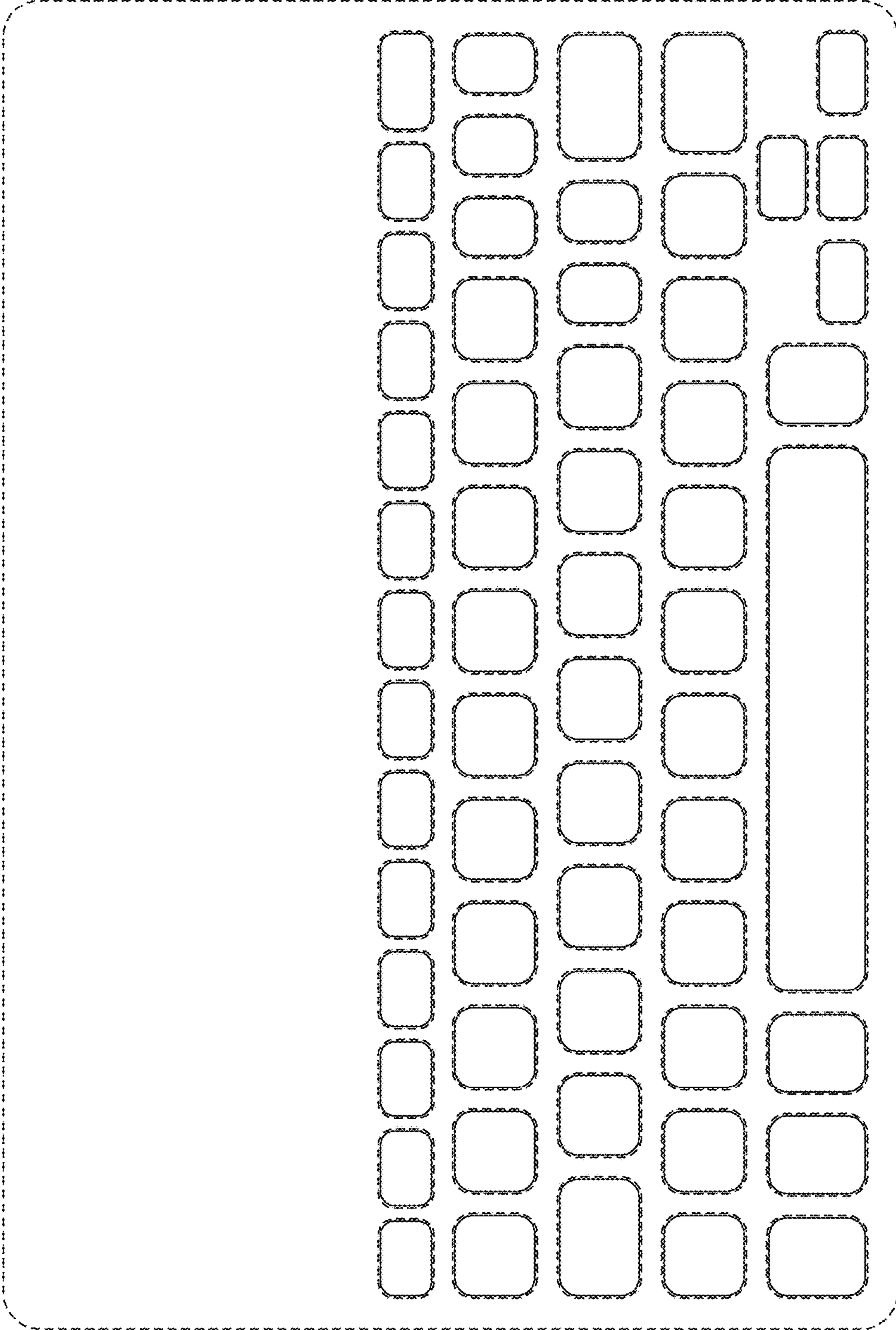

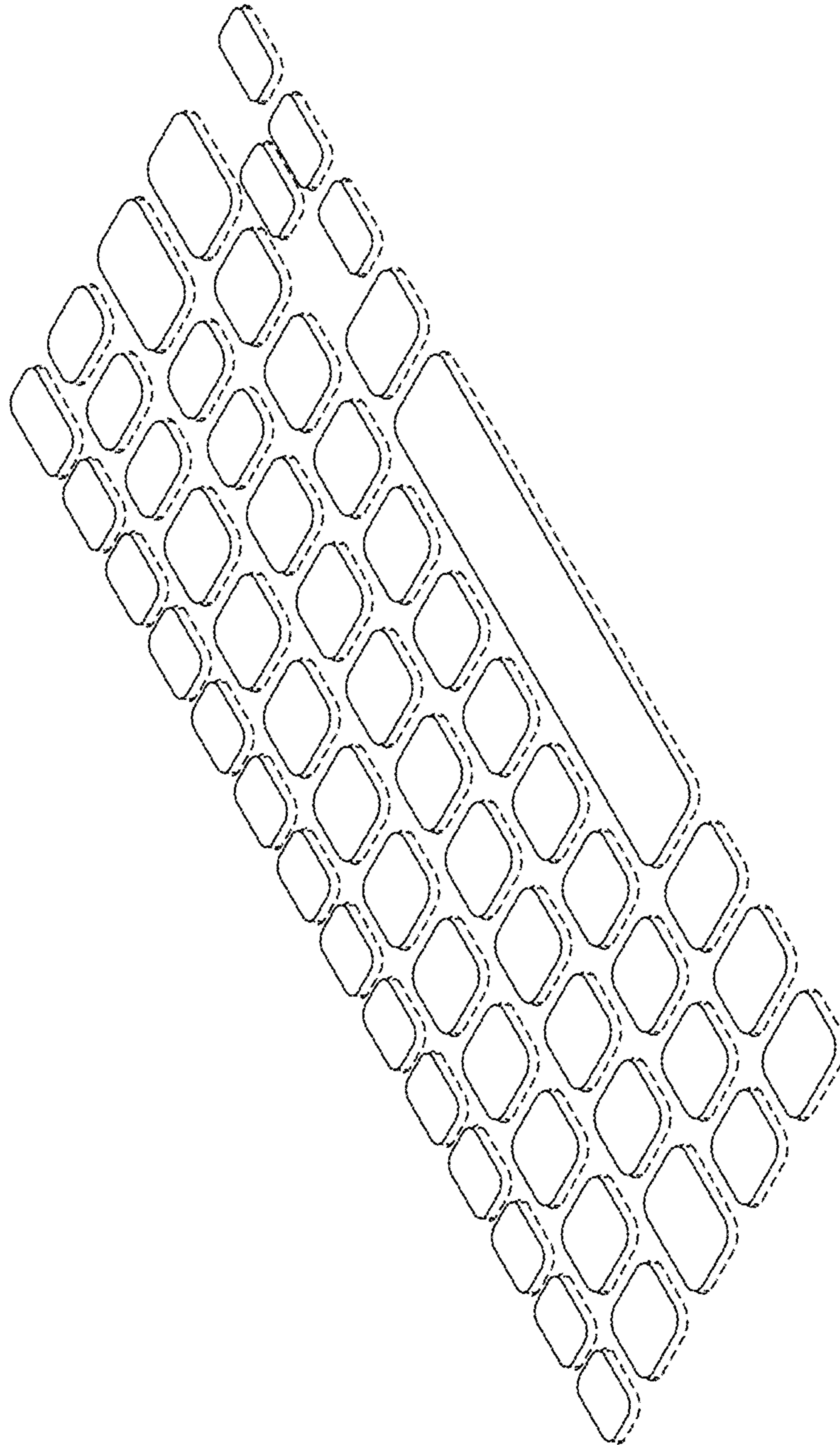

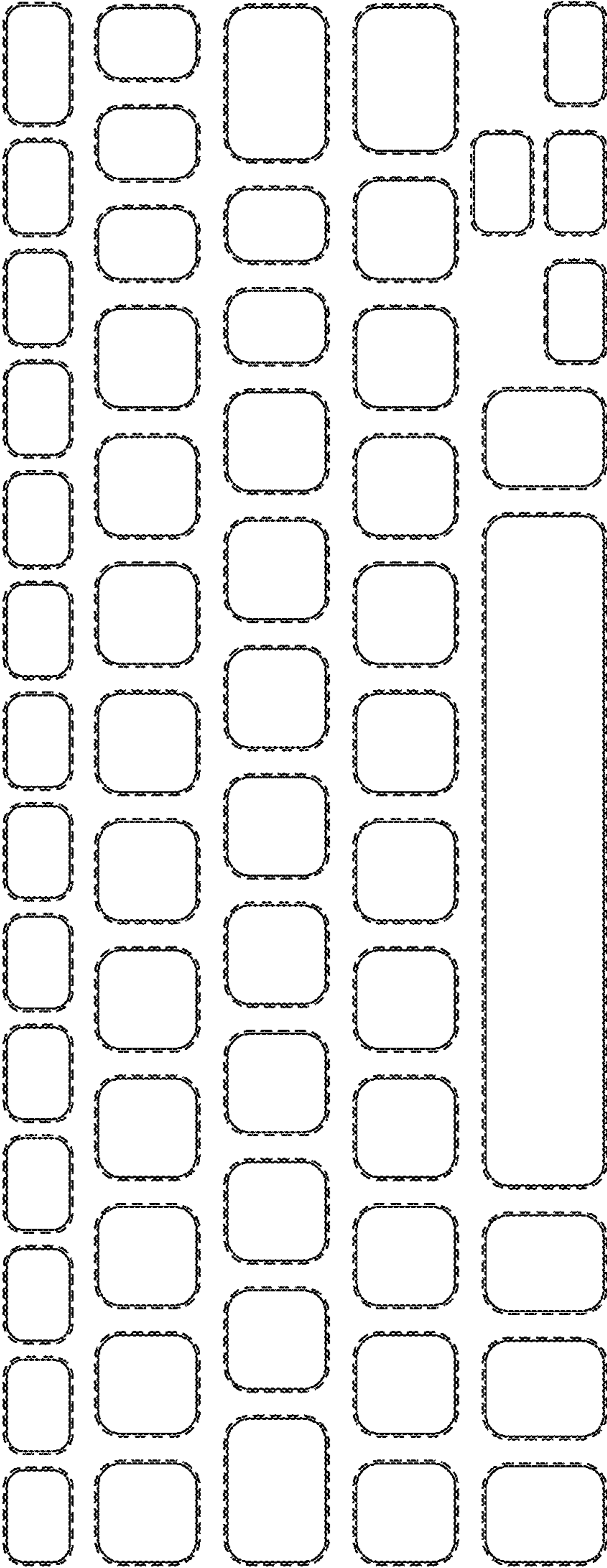
