DESCRIPTION

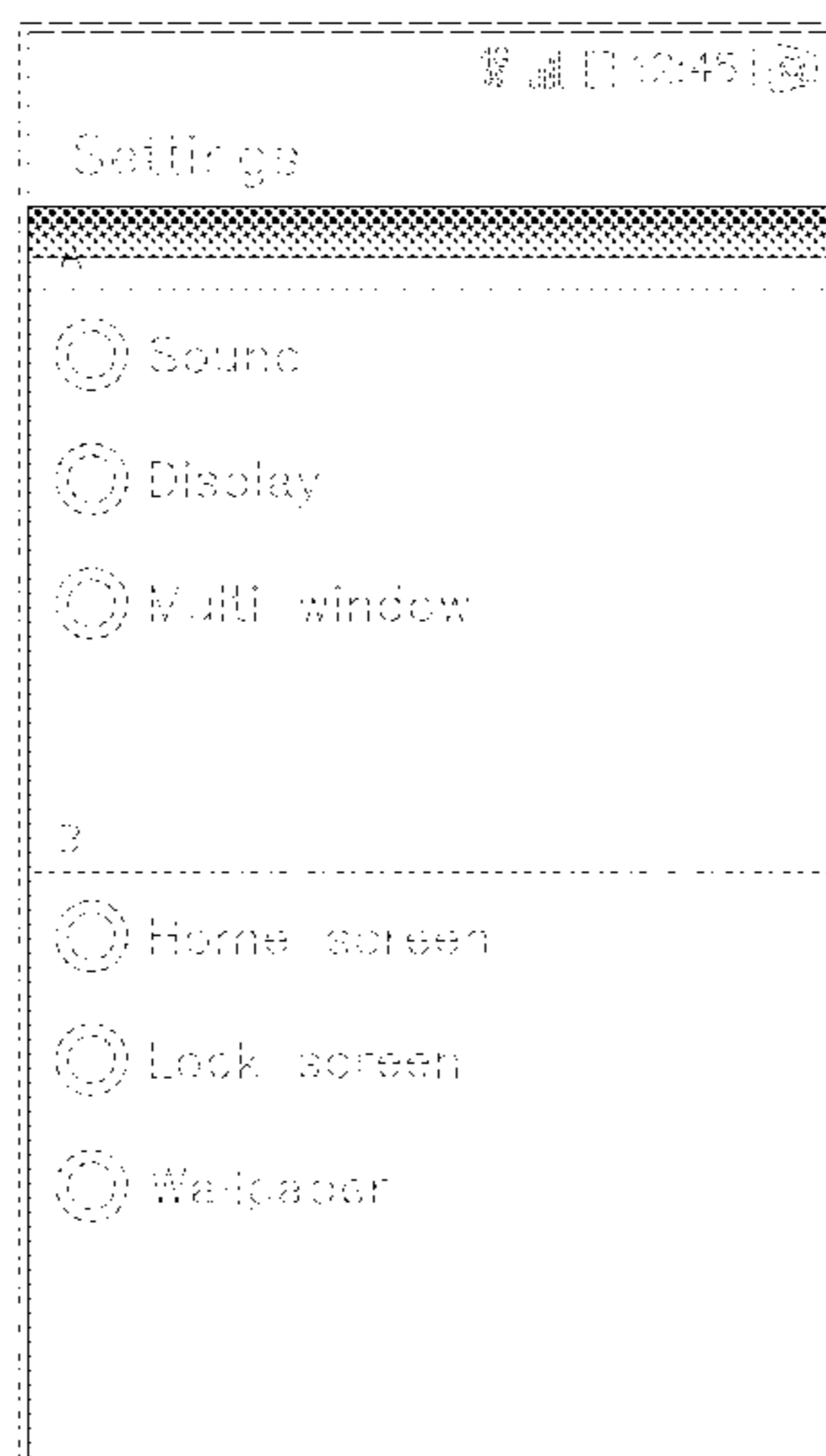
FIG. 1 is the first image in a sequence of a display screen or portion thereof with transitional graphical user interface showing my new design;

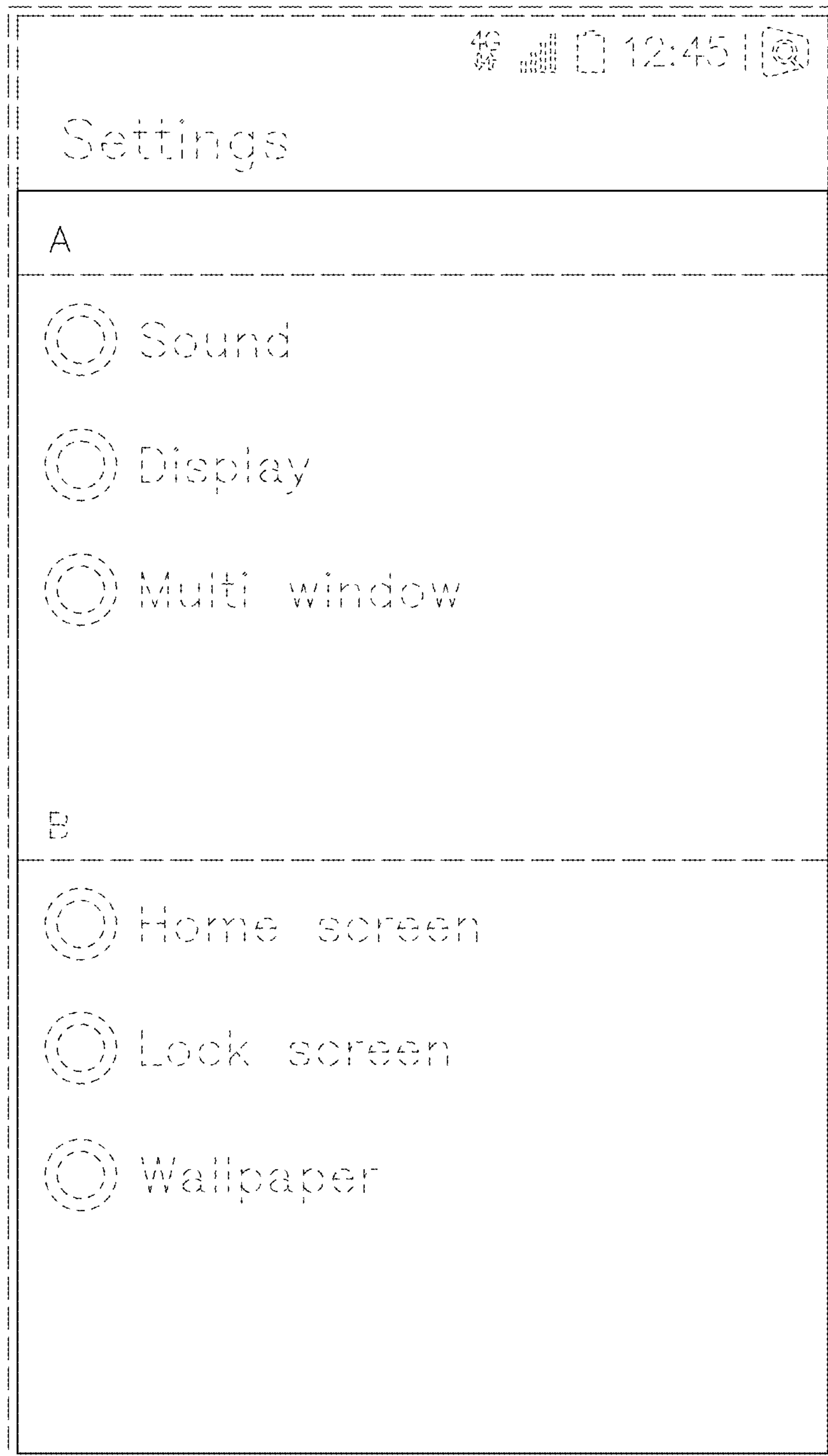

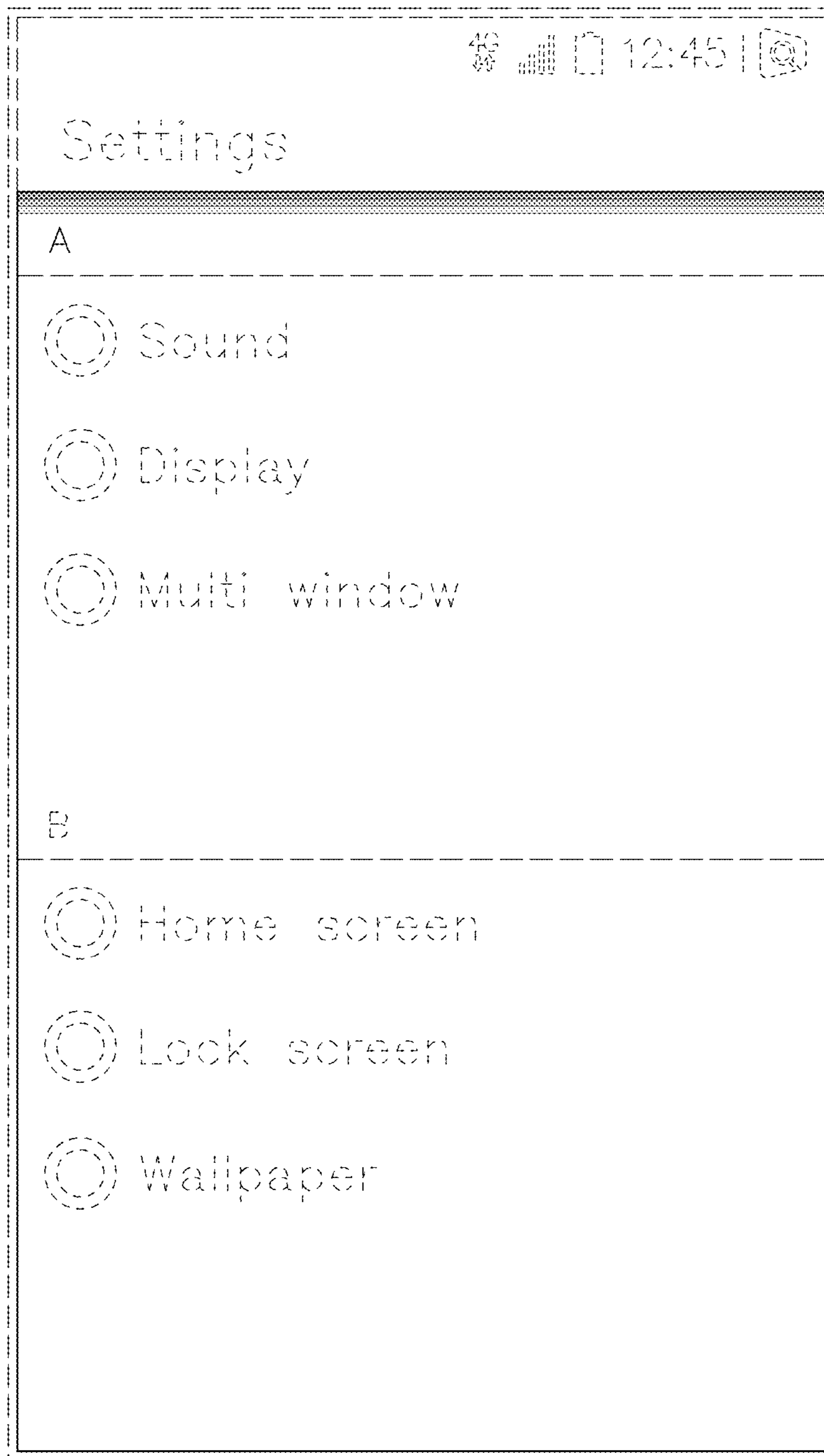

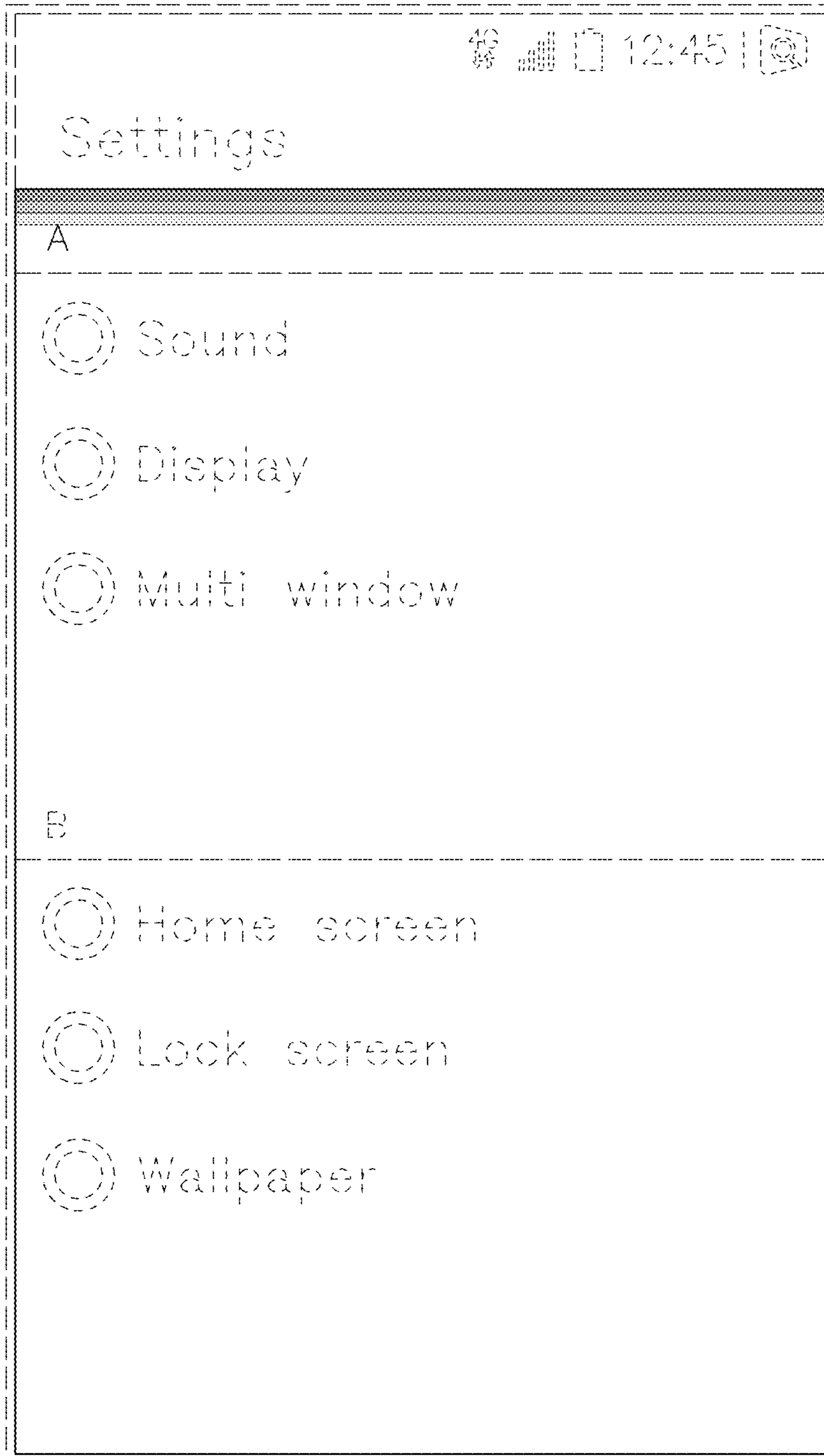
