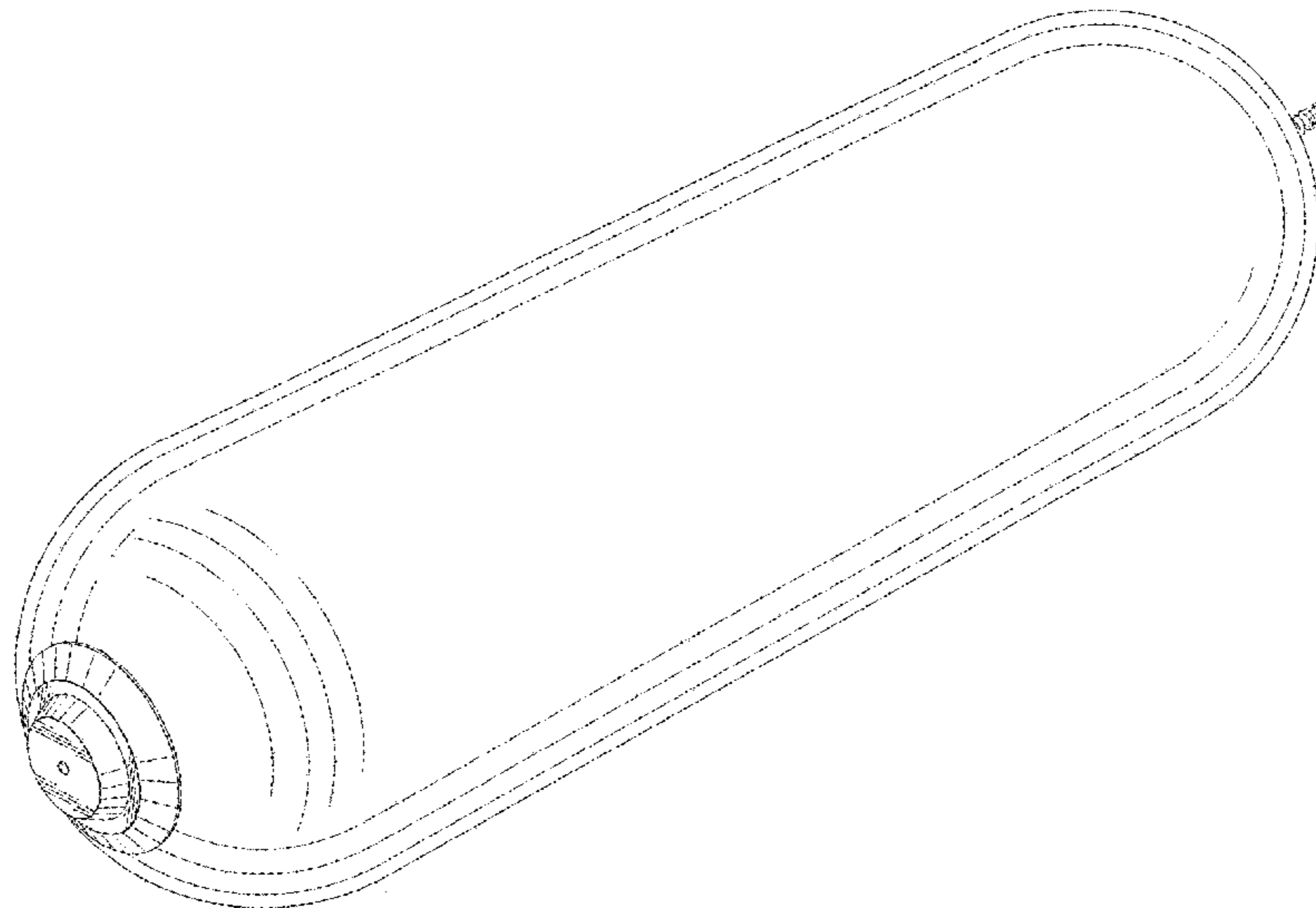
(57) **CLAIM**

The ornamental design for a pulsation dampener bladder, as shown and described.

**DESCRIPTION**

FIG. 1 is a Perspective View of a pulsation dampener bladder illustrating my design;  
 FIG. 2 is a Reverse Perspective view of FIG. 1;  
 FIG. 3 is a Top View of FIG. 1 and the Bottom View is a mirror image thereof;  
 FIG. 4 is a Right Side View of FIG. 1 and the Left Side View is a mirror image thereof;  
 FIG. 5 is a Front View of FIG. 1; and,  
 FIG. 6 is a Rear View of FIG. 1.  
 The broken line showing of the pulsation dampener bladder inflation stem is for the purpose of illustrating environmental structure and forms no part of the claimed design.

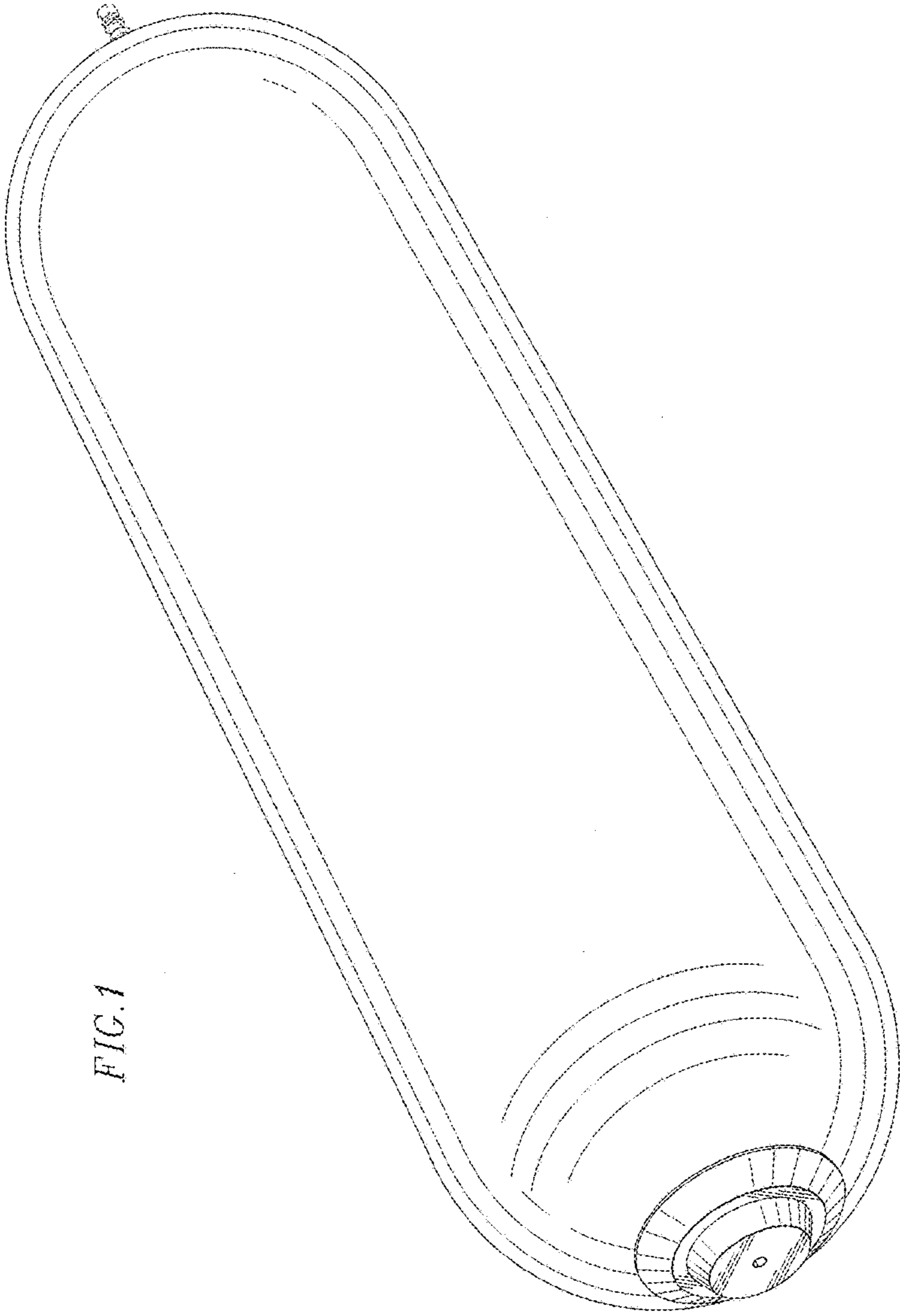

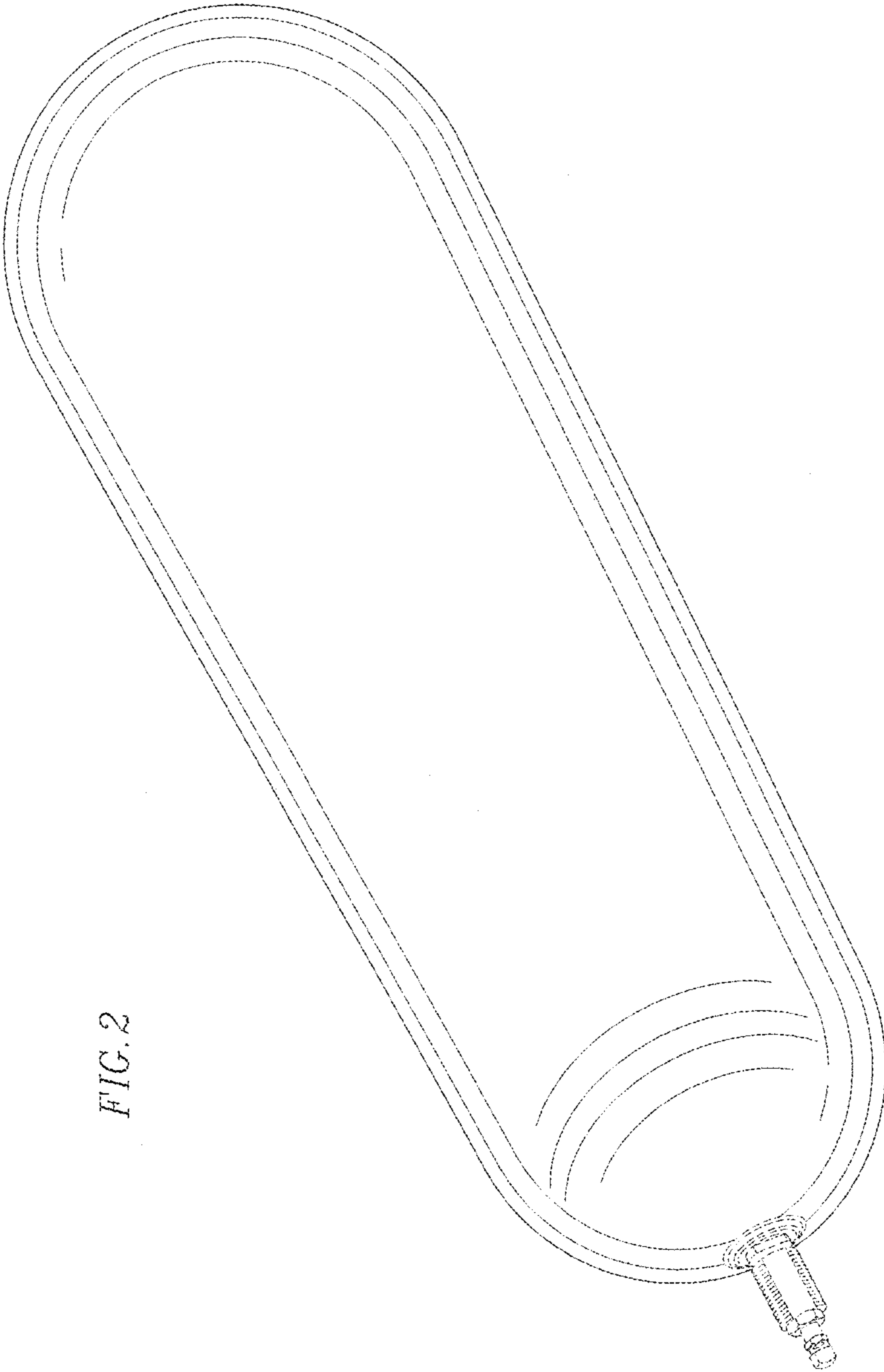

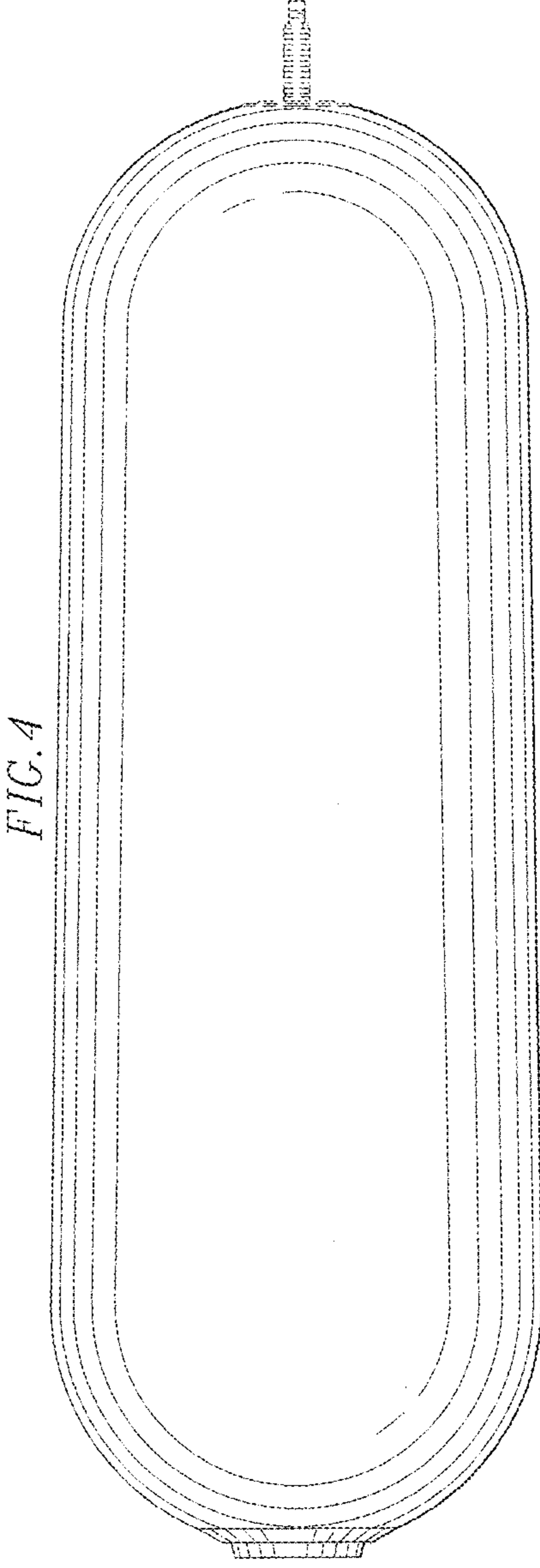
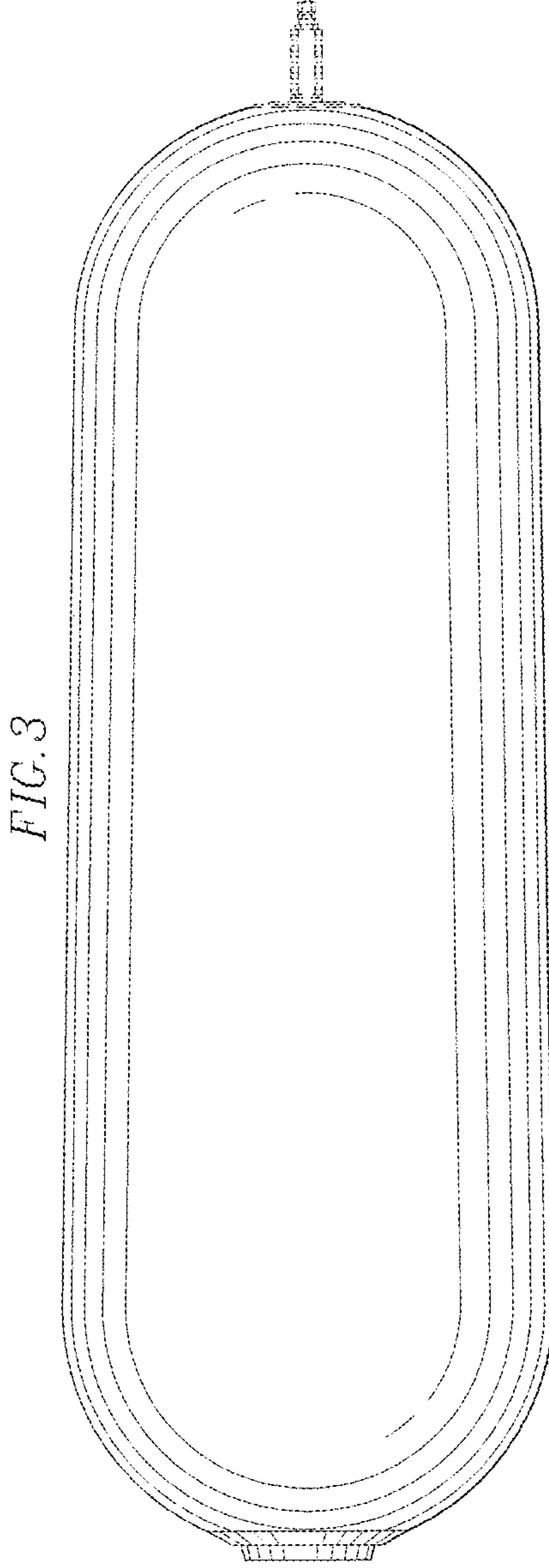

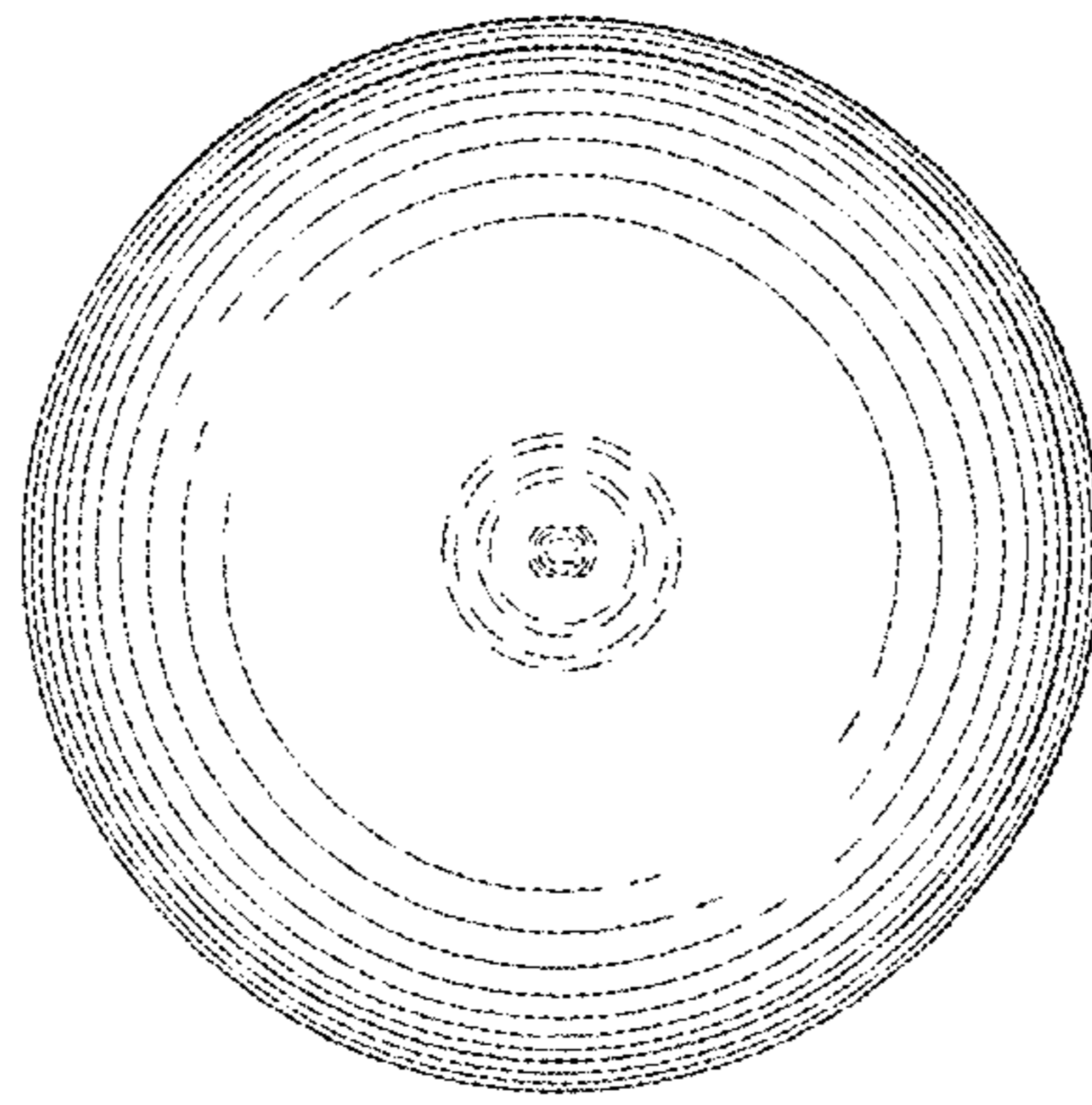
