(57) **CLAIM**

The ornamental design for an interactive stuffed animal puppy toy, as shown and described.

DESCRIPTION

FIG. 1 is a front angled view of an interactive stuffed animal puppy toy;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The broken line showing of the rectangular portion on the rear of the toy is for the purpose of illustrating an internal pocket containing electronics required for charging the toy and forms no part of the claimed design.

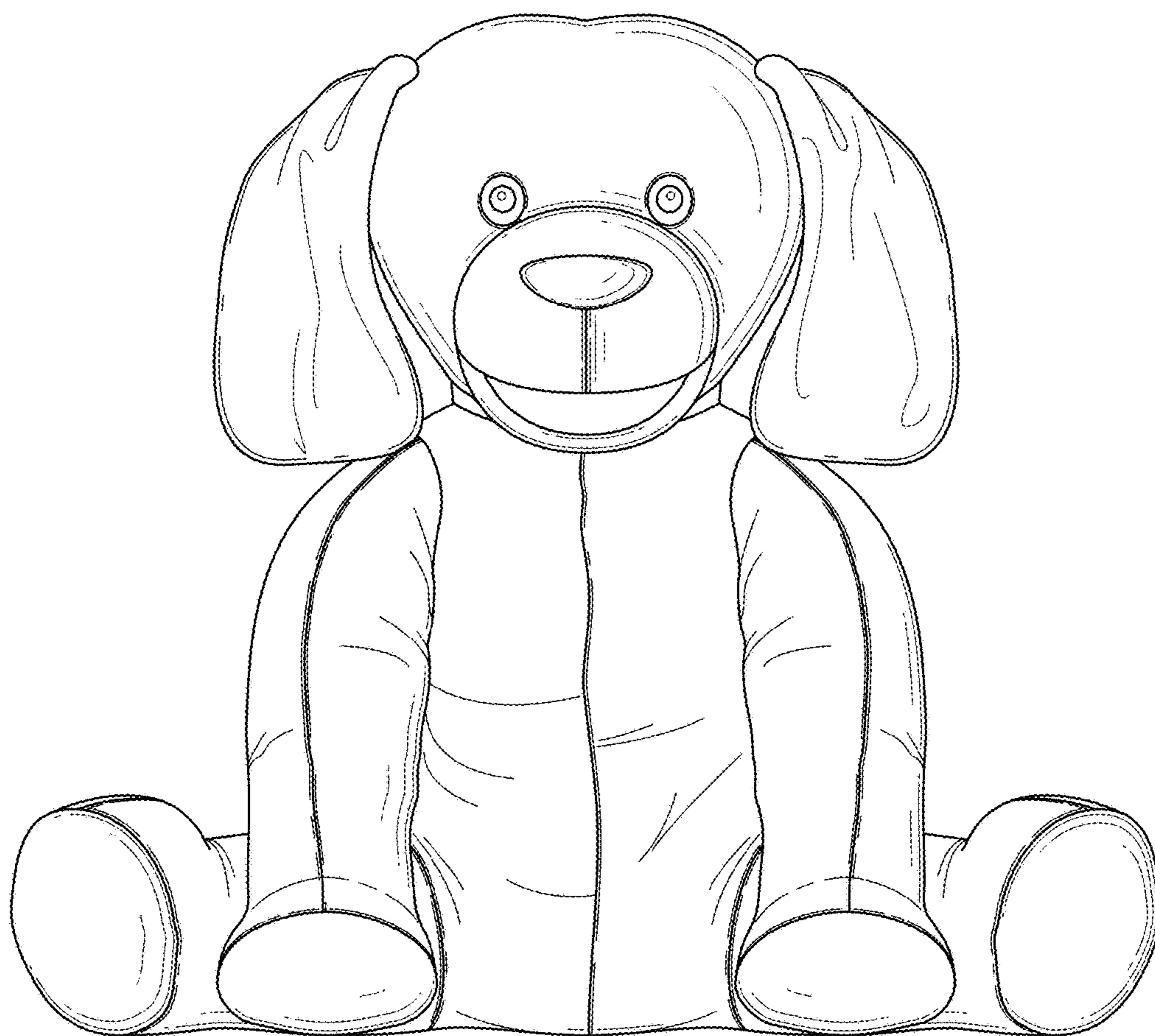

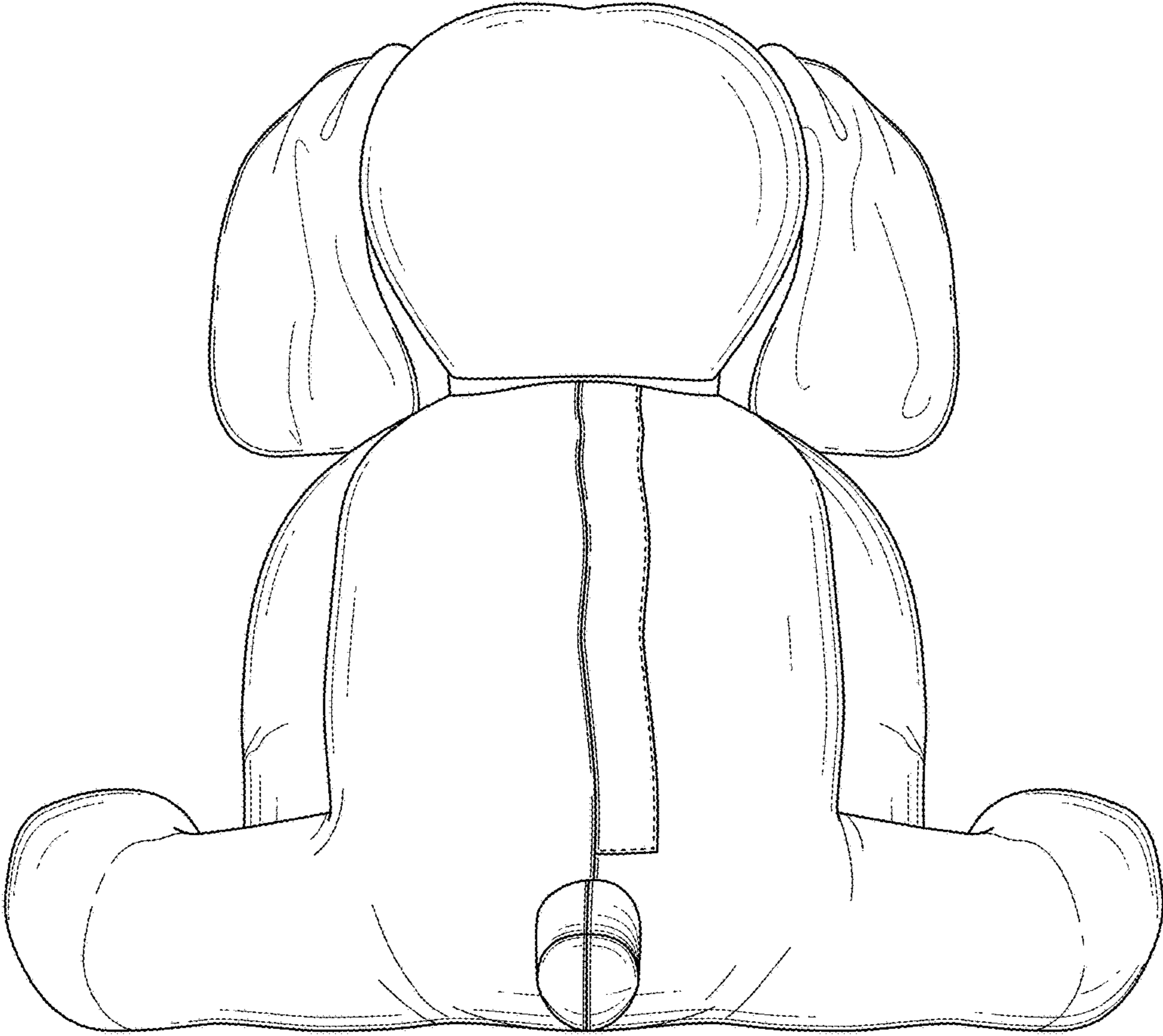

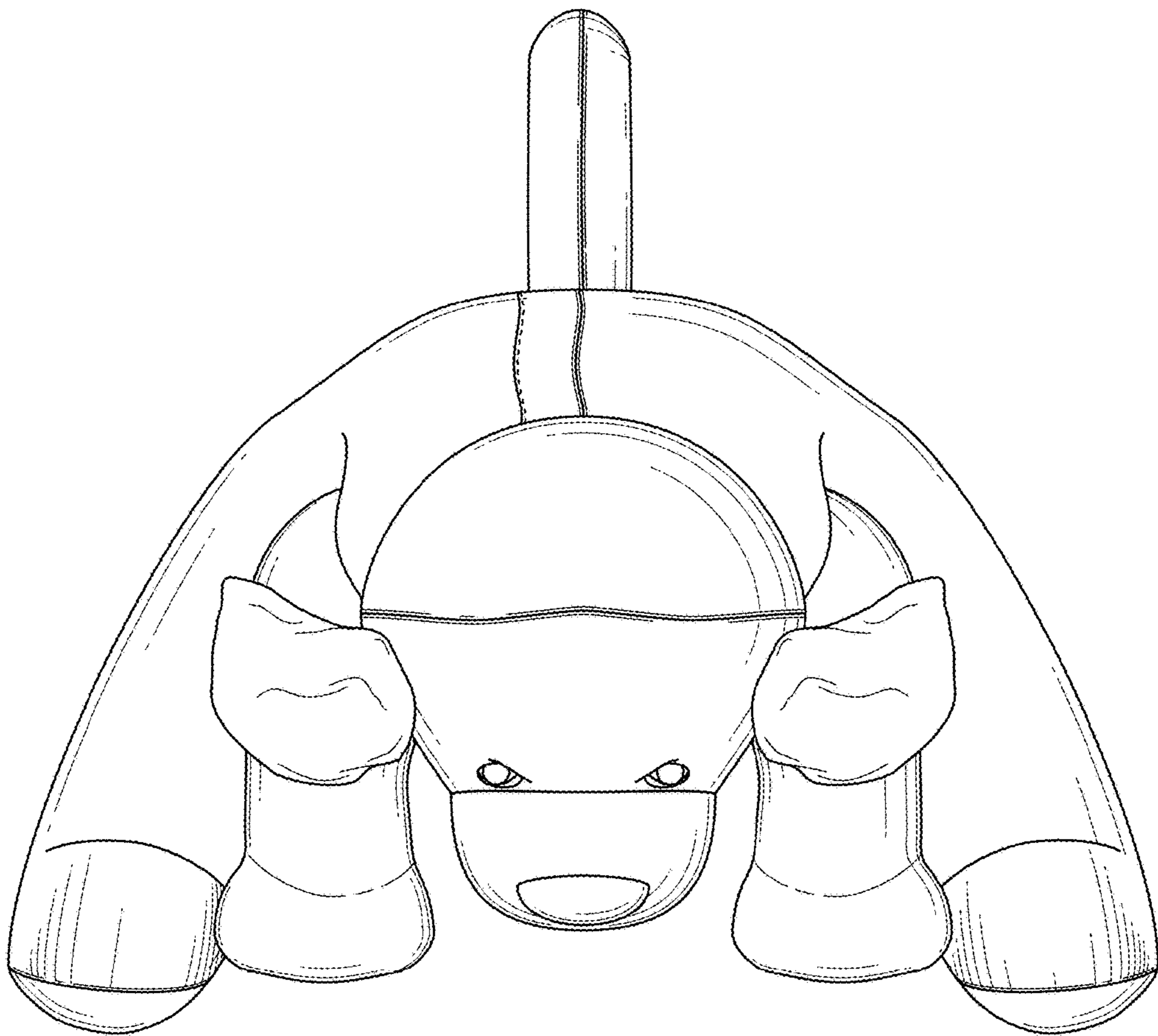

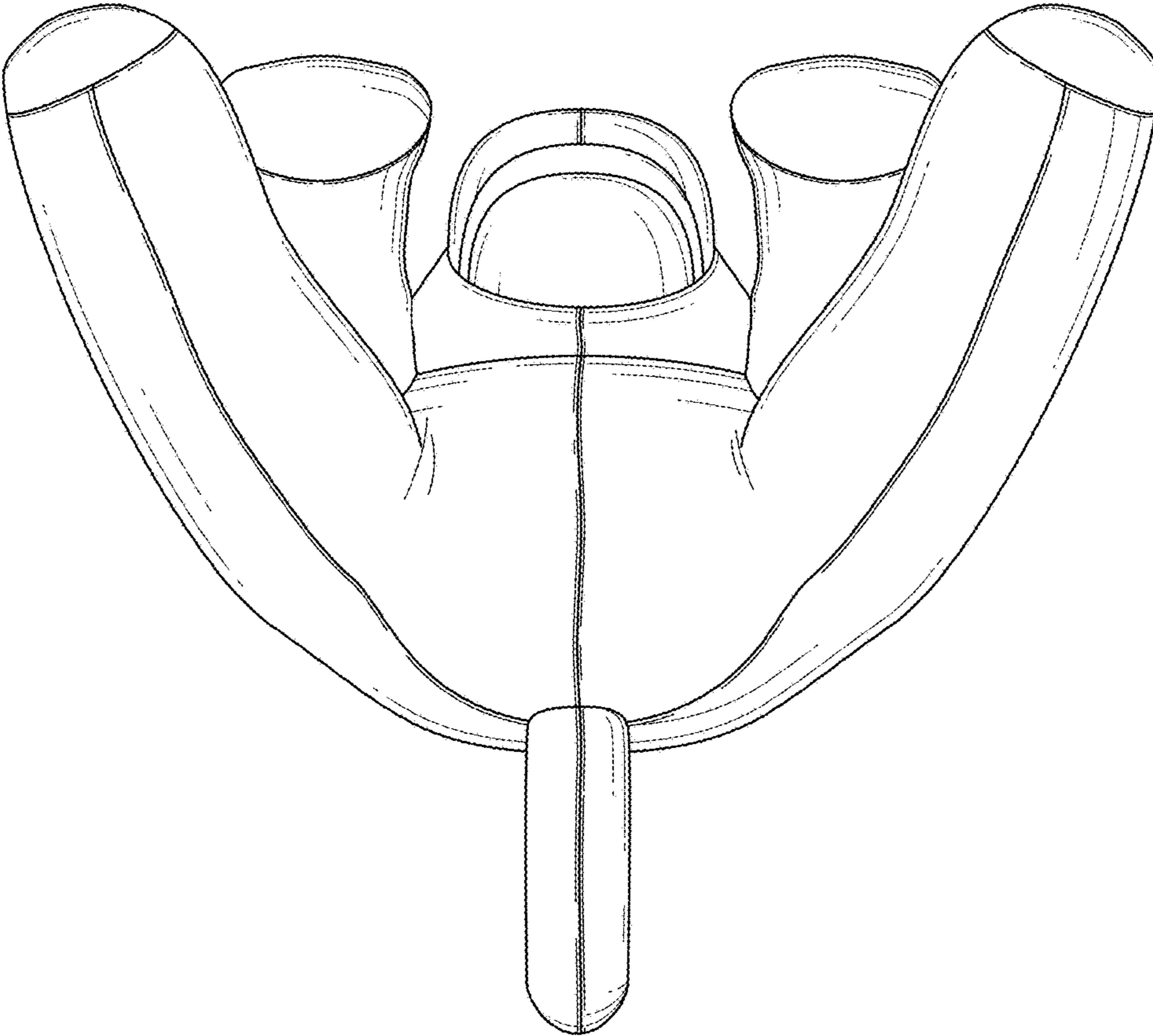
