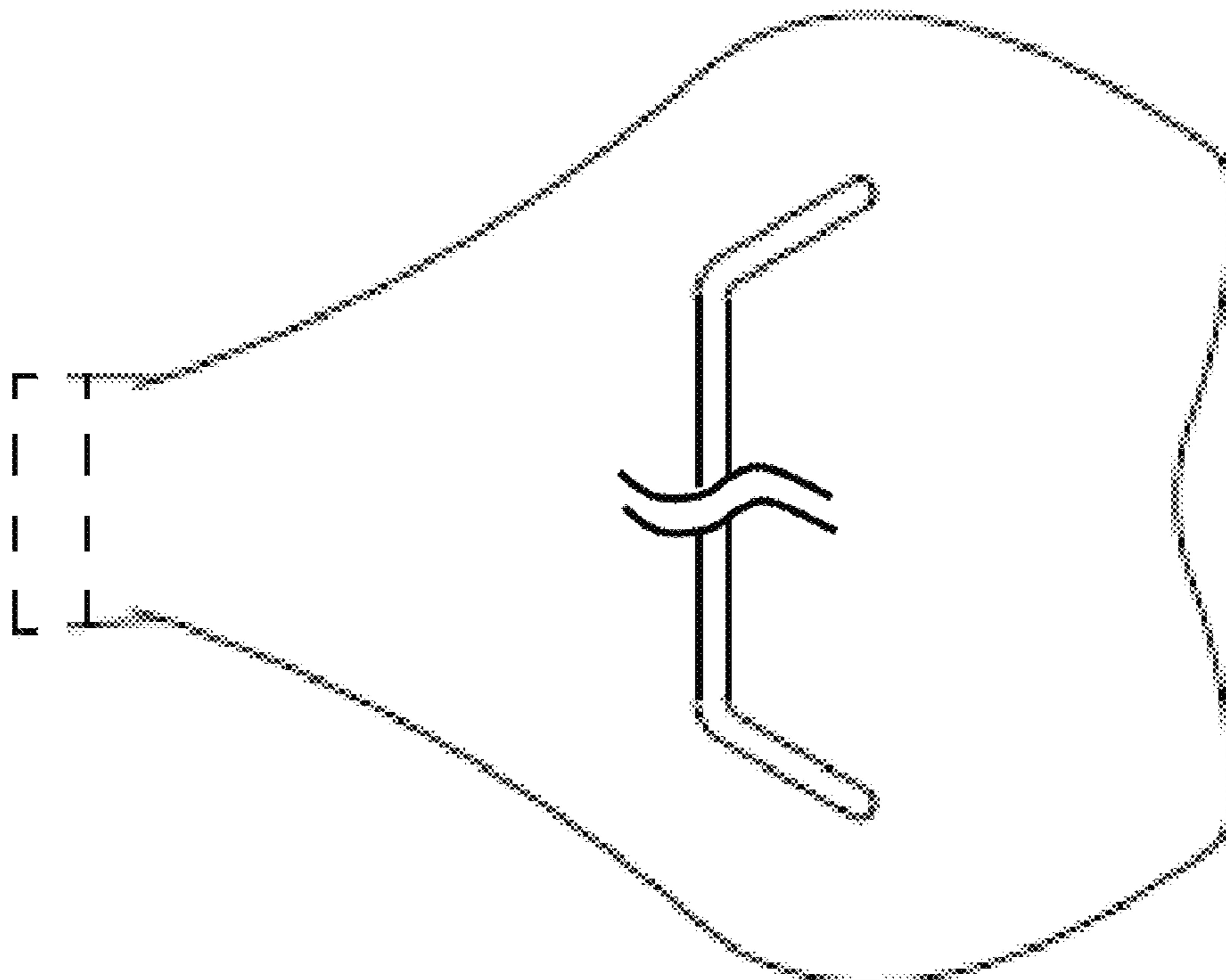
(57) **CLAIM**

The ornamental design for a “fishing lure slotted tail design,” as shown and described.

DESCRIPTION

FIG. 1 is a first side view of an ornamental design for a fishing lure slotted tail design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a second side view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a rear view thereof;
FIG. 7 is a front perspective view thereof; and,

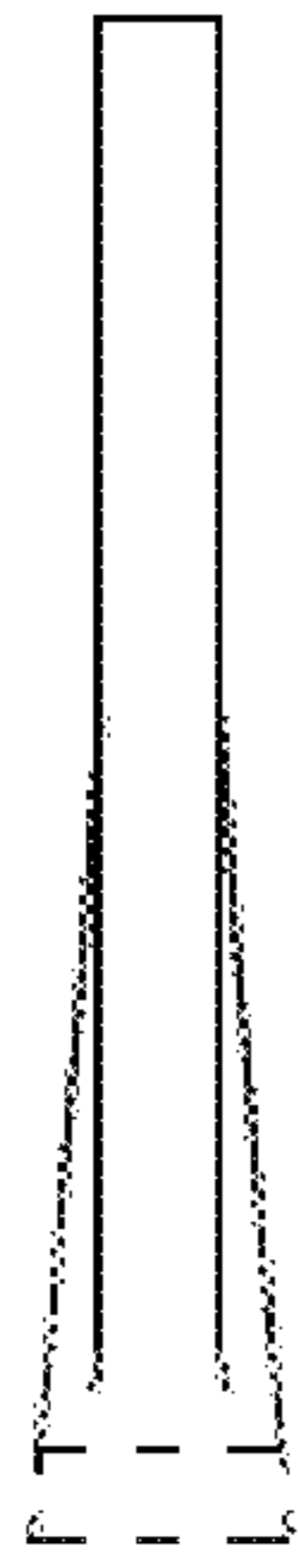

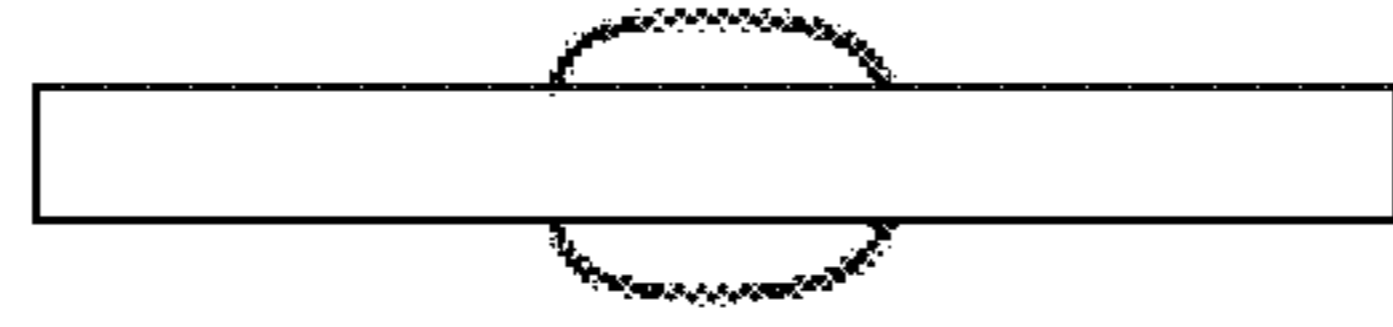

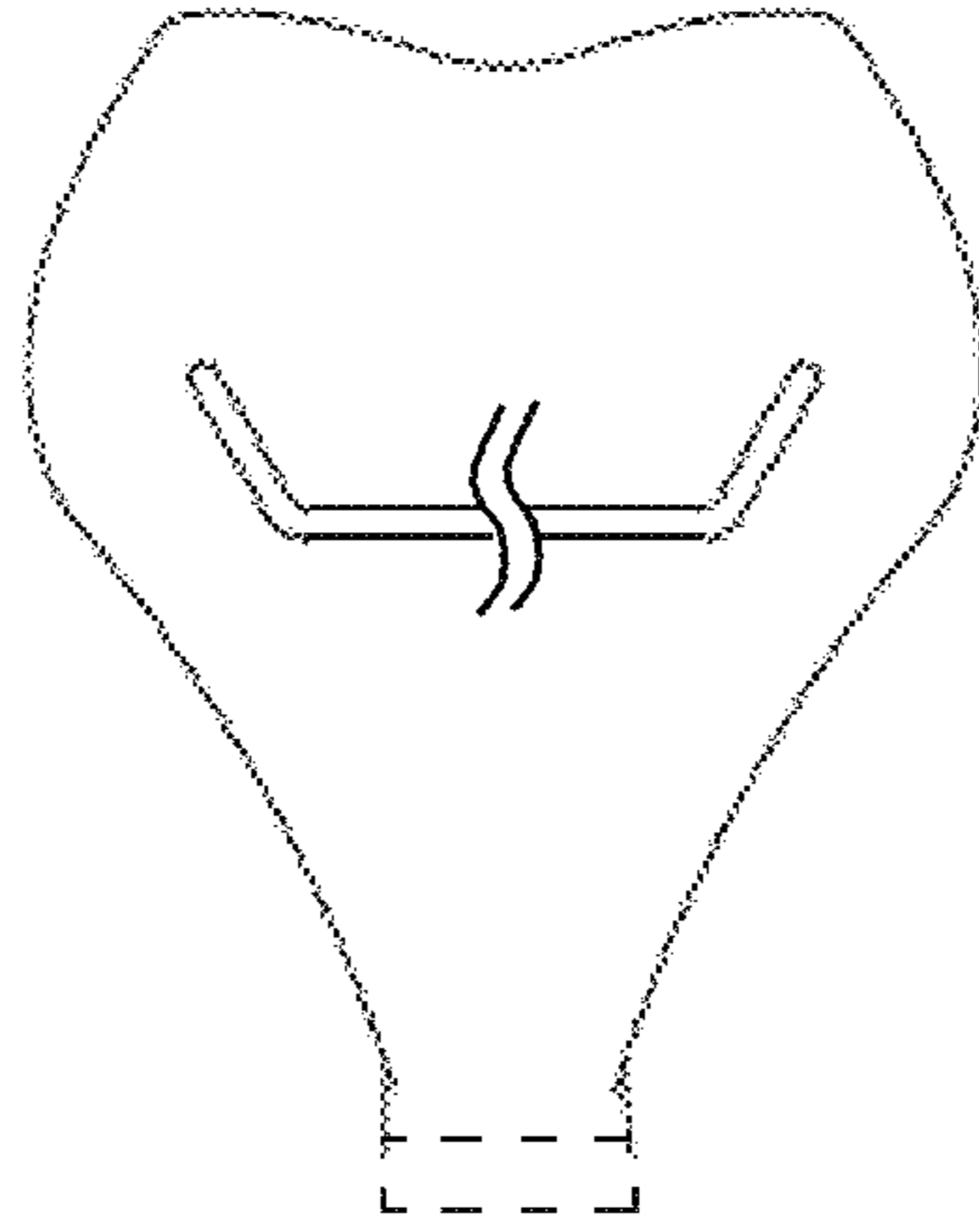

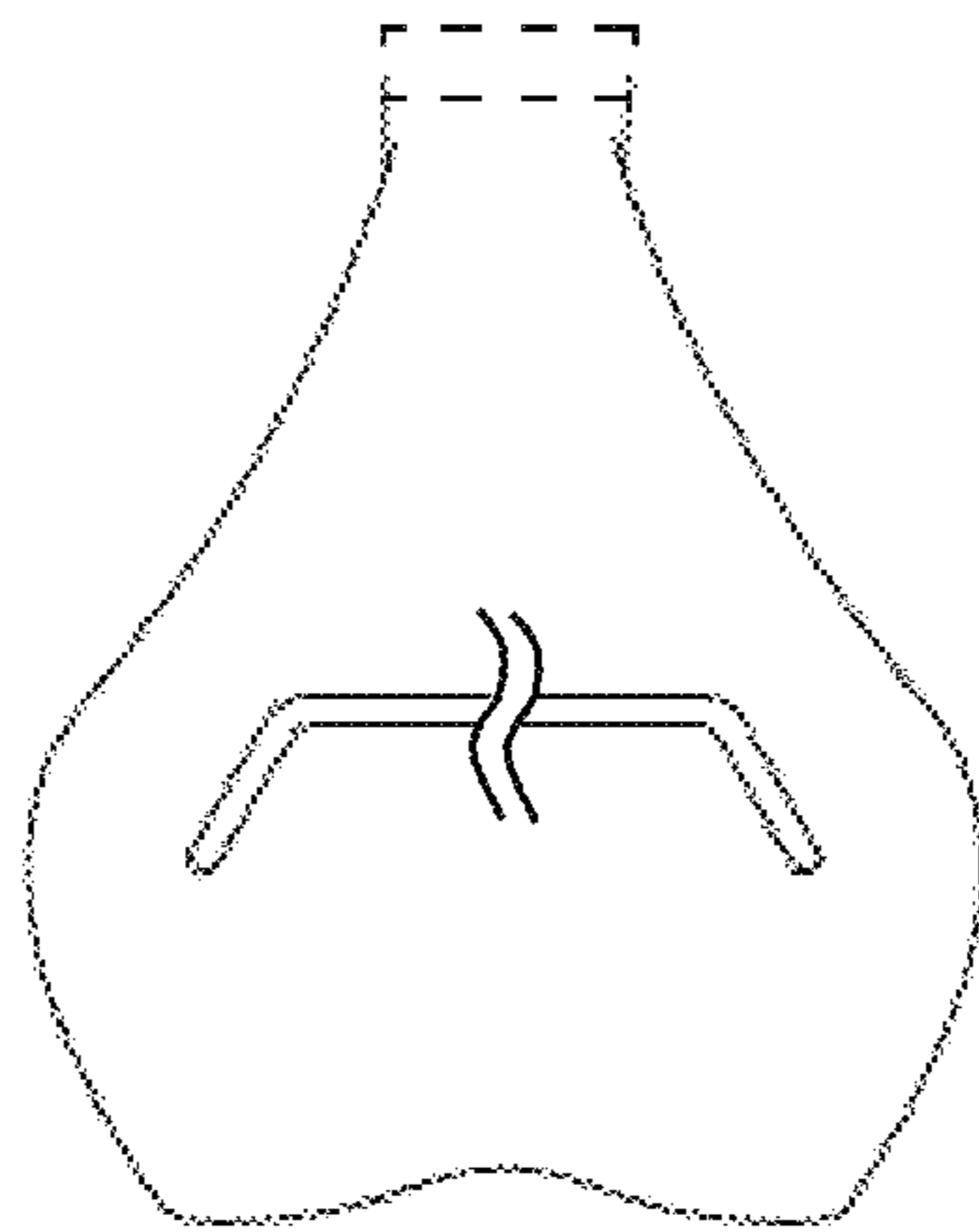

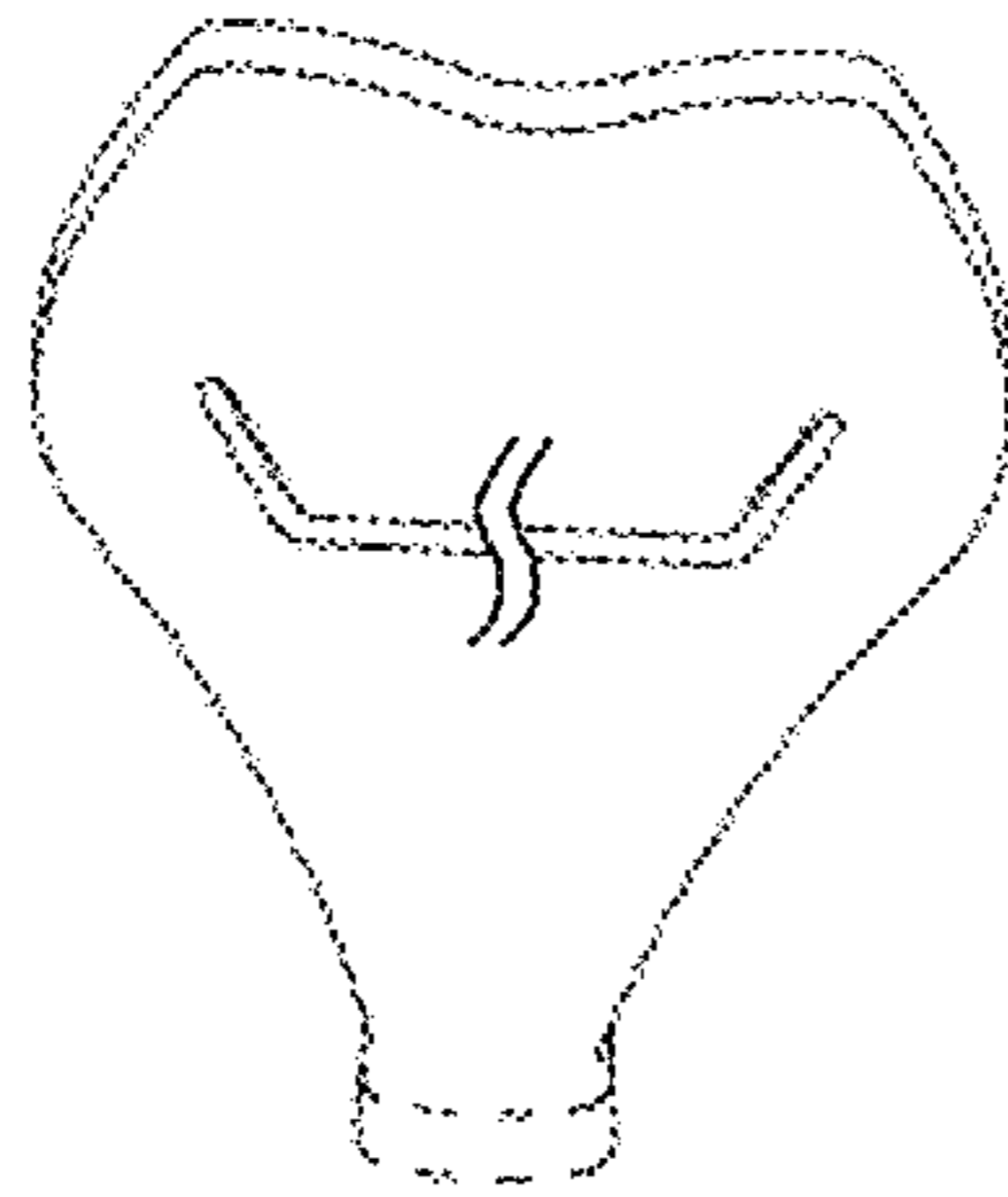

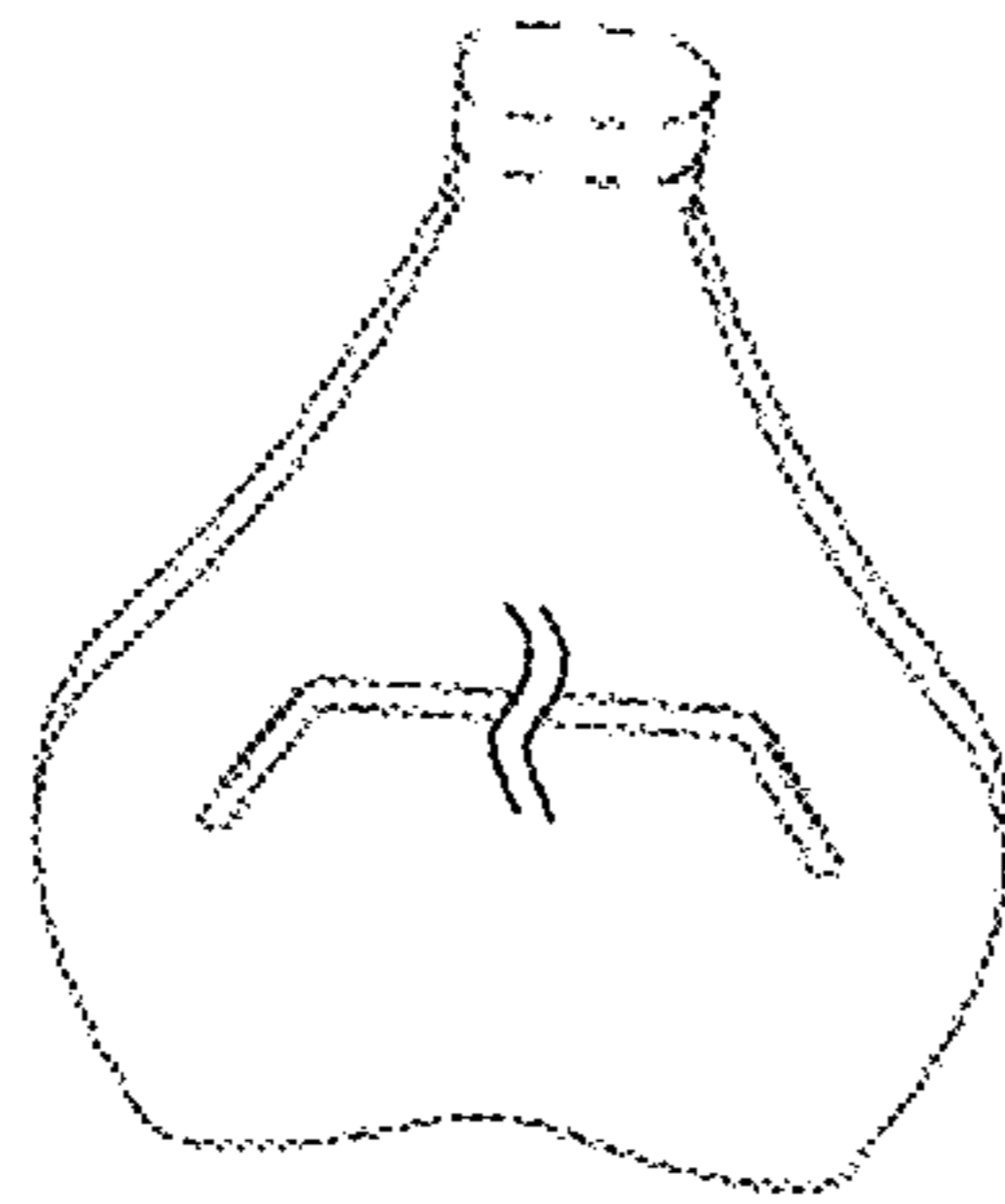
