FIG. 8 is an enlarged cross sectional view taken through line 8-8 of FIG. 2.

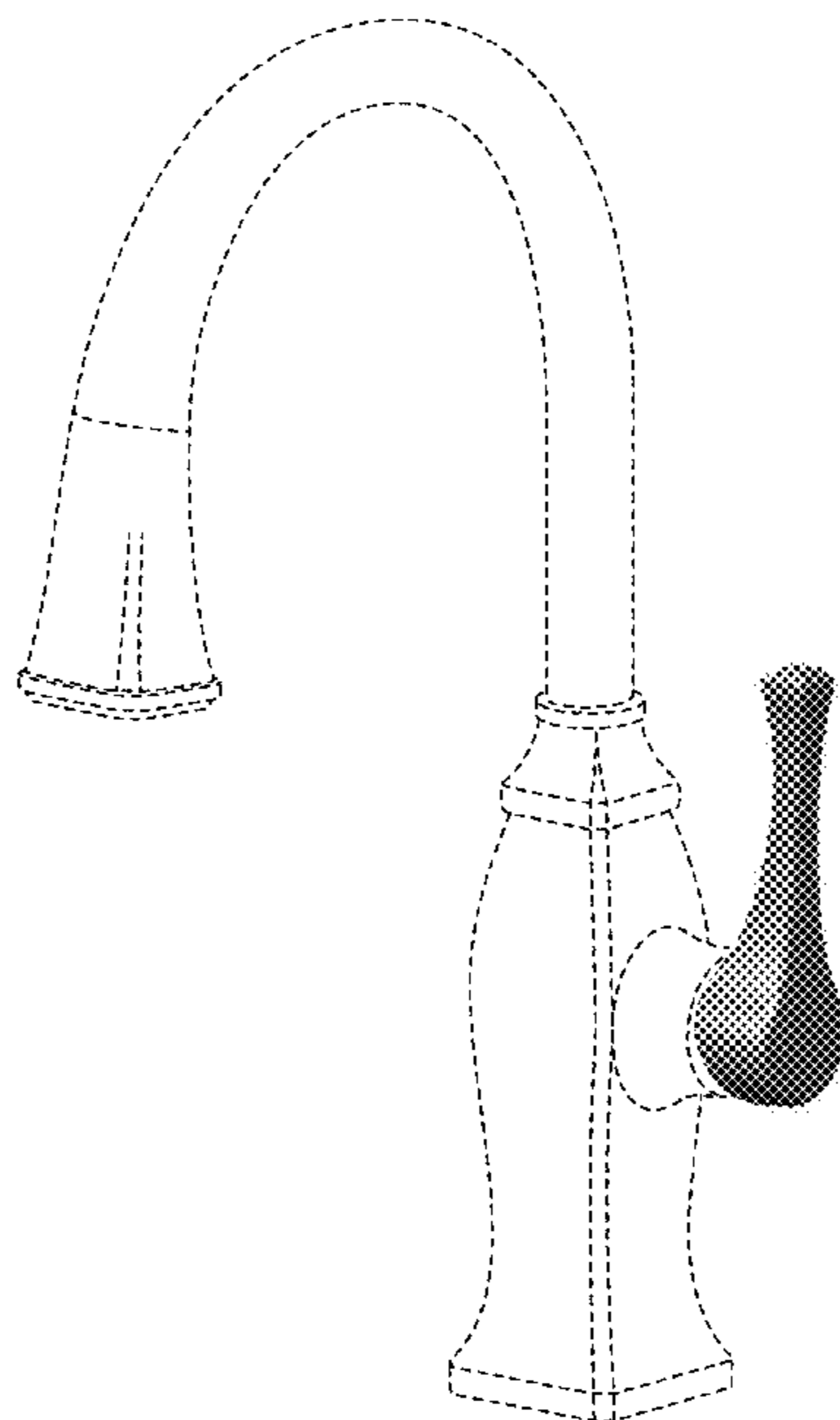

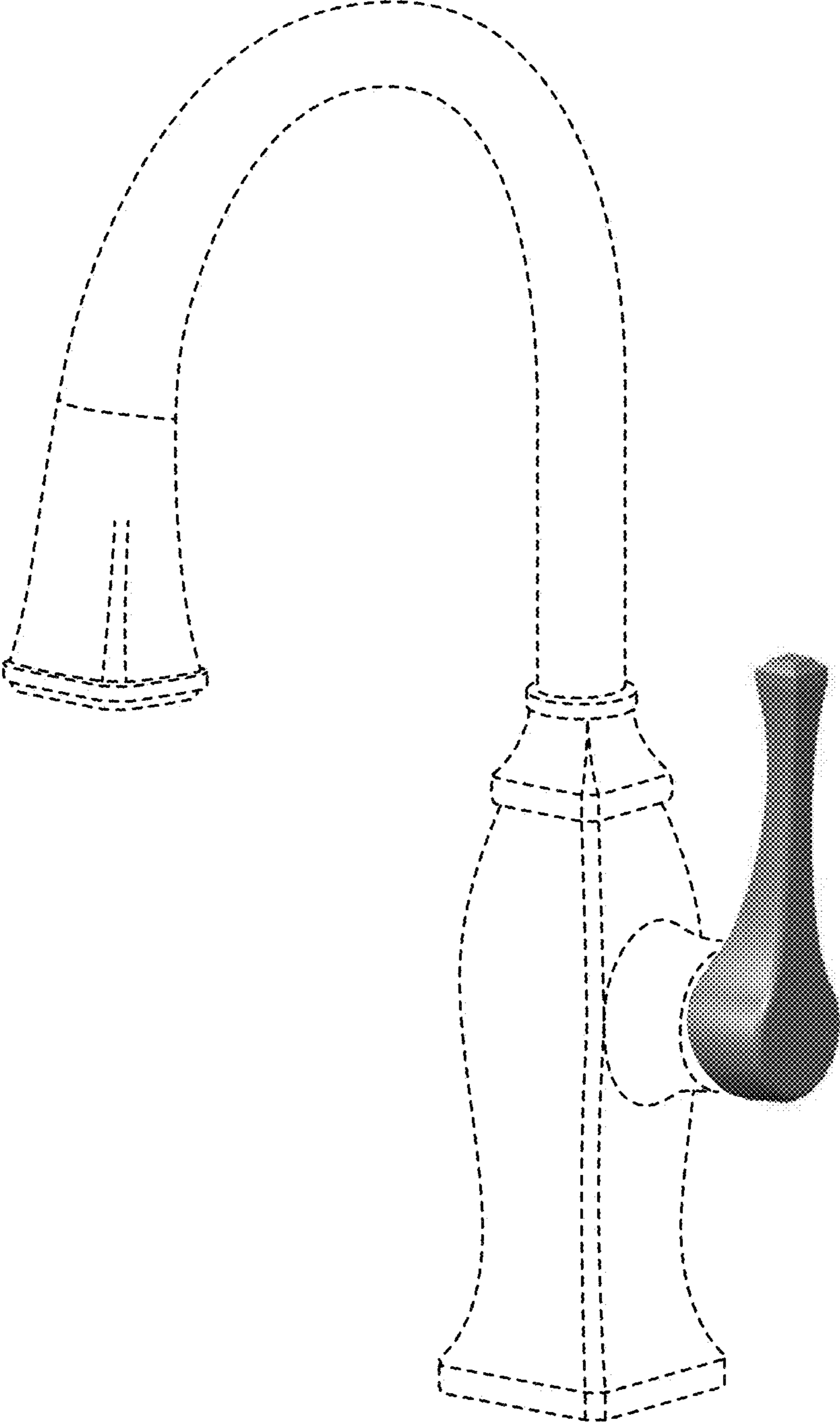

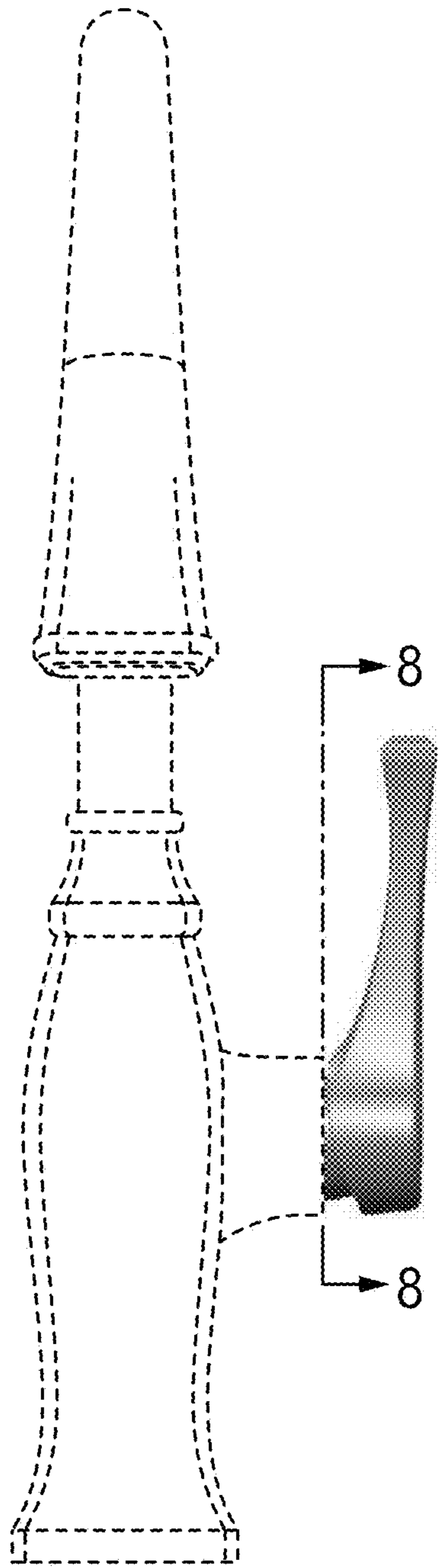

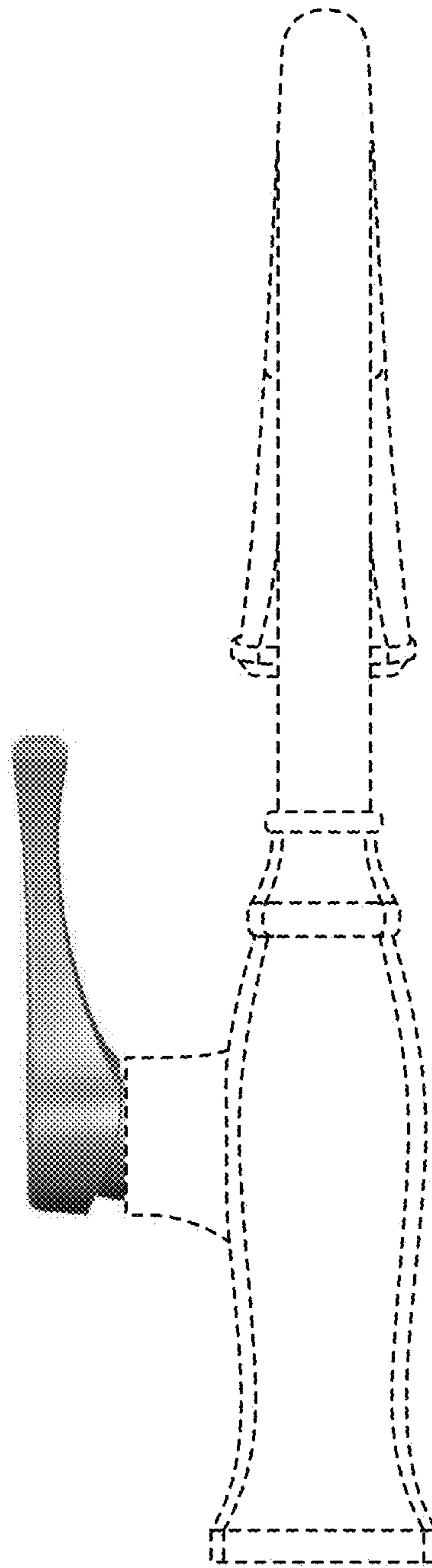

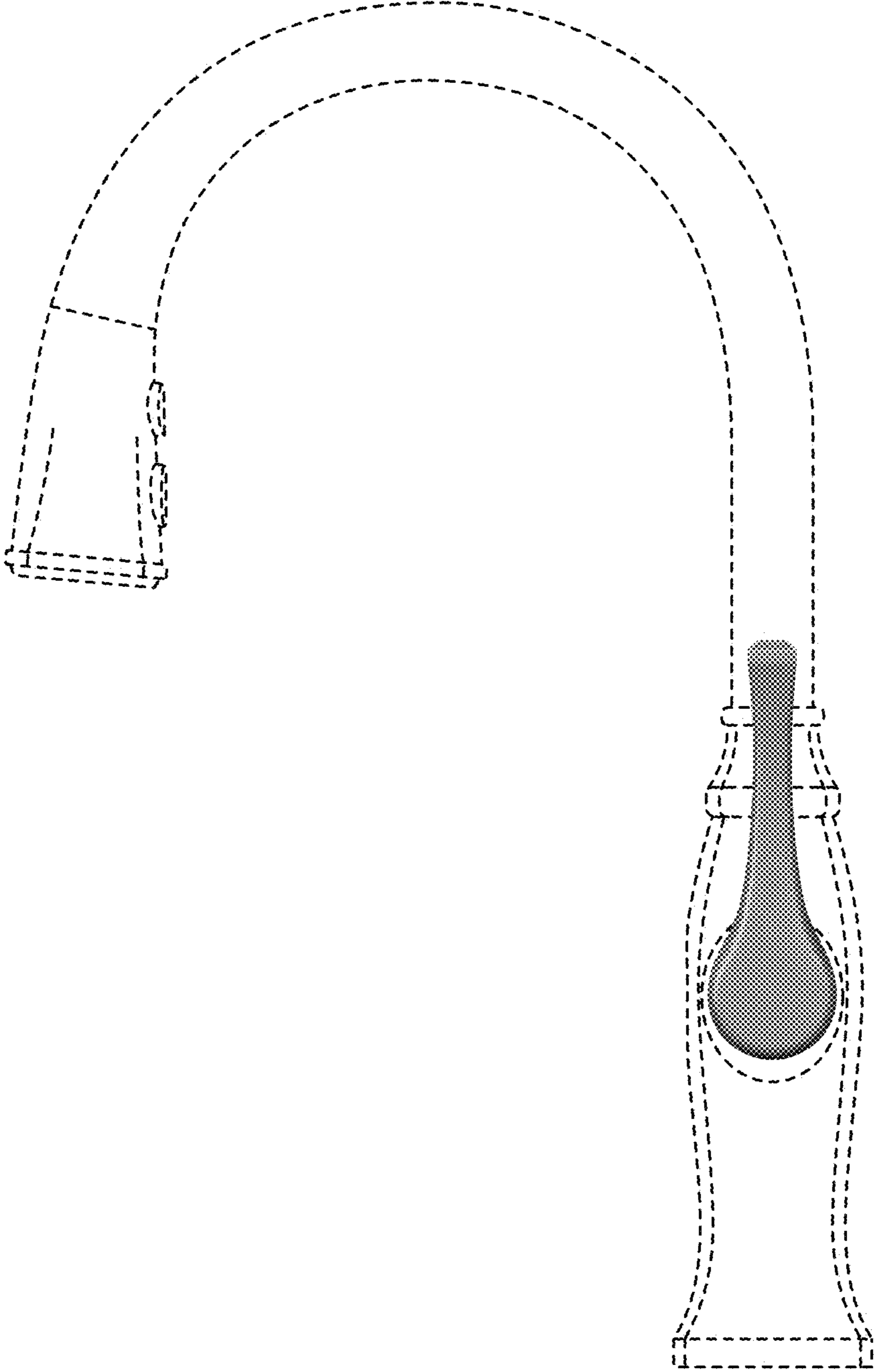

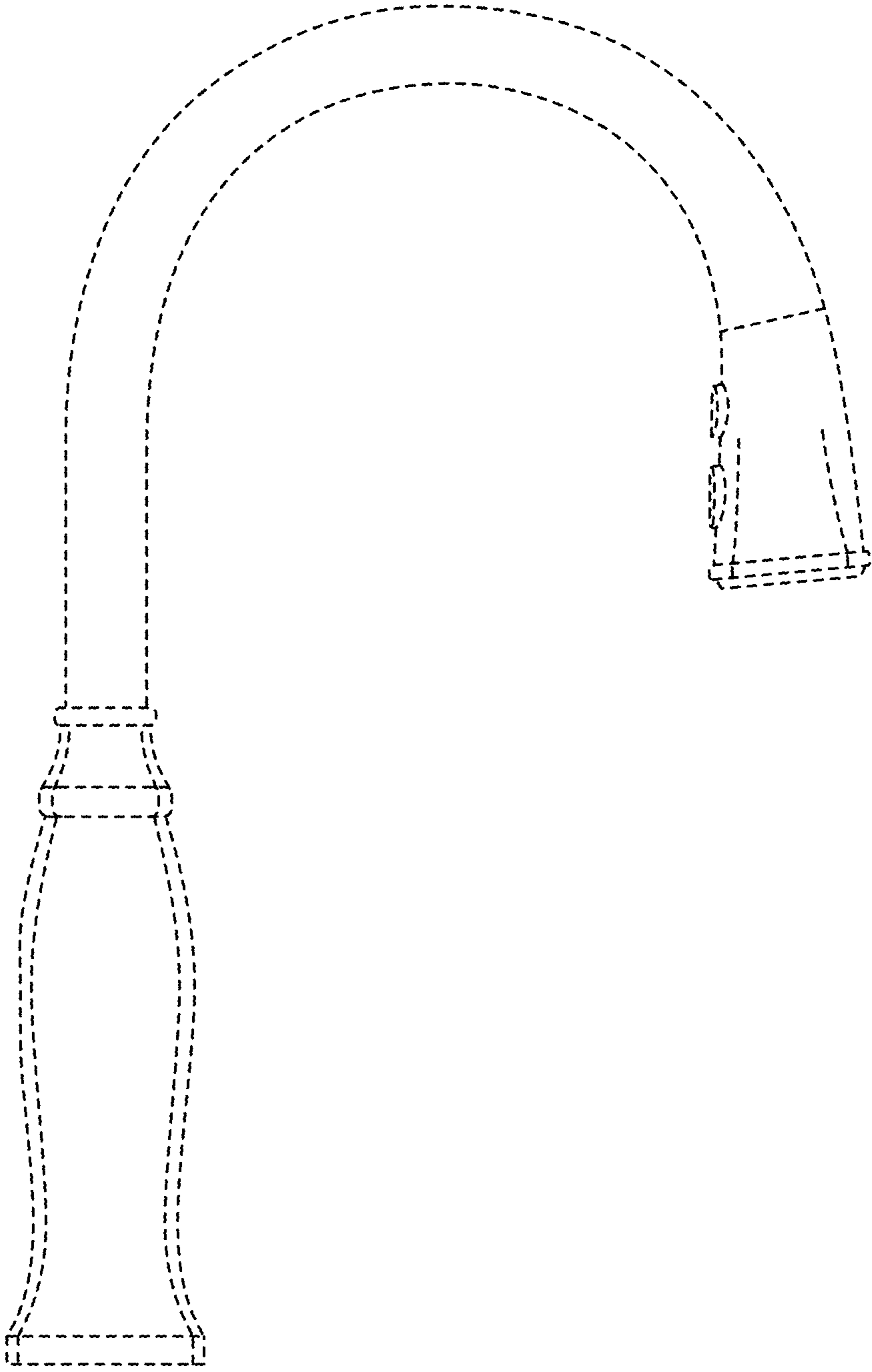

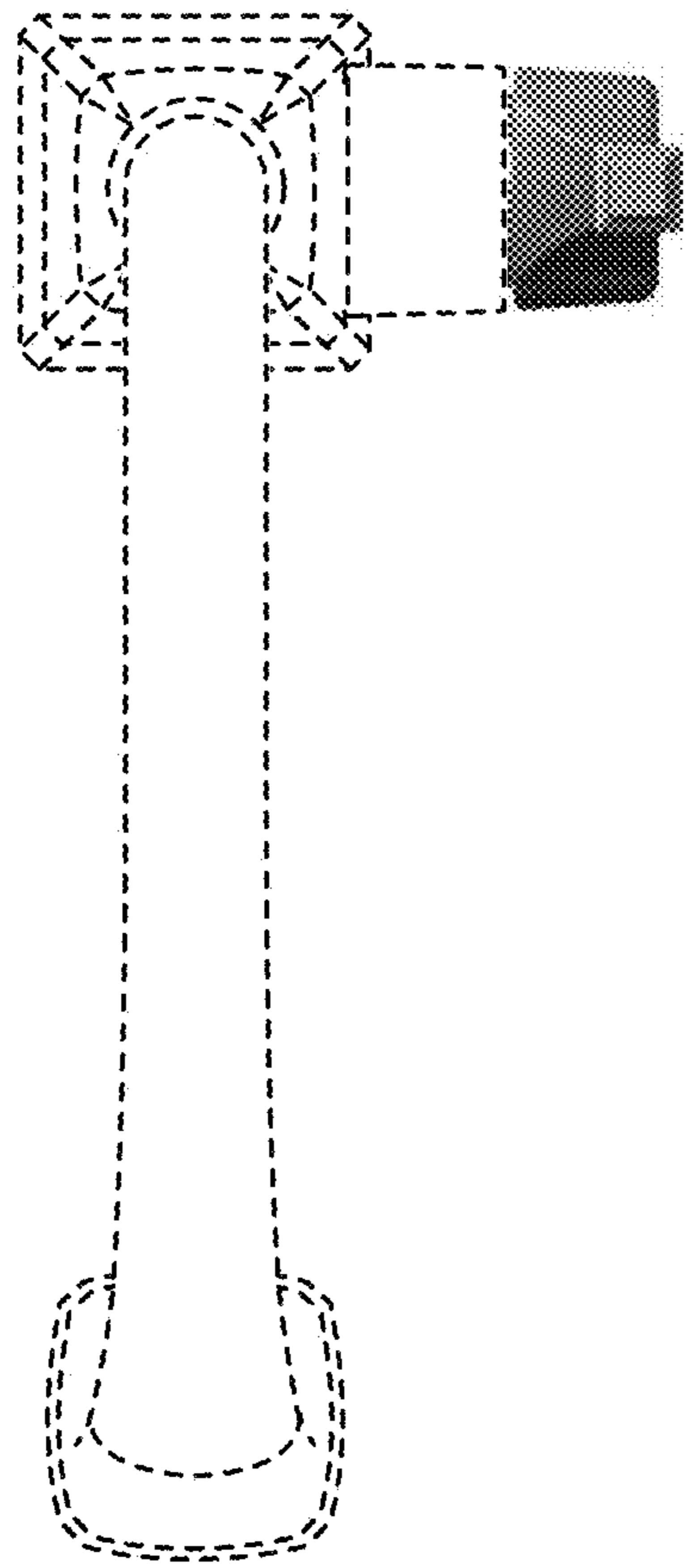

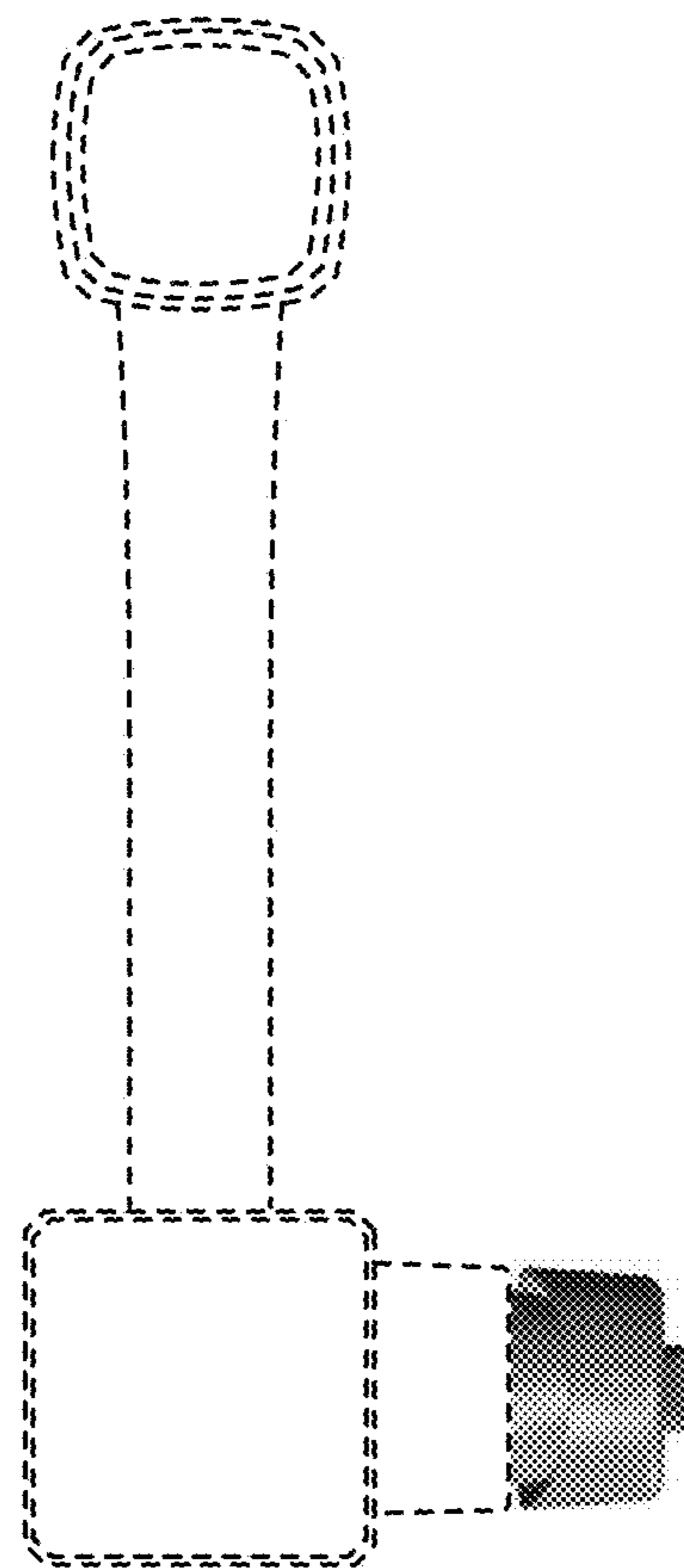

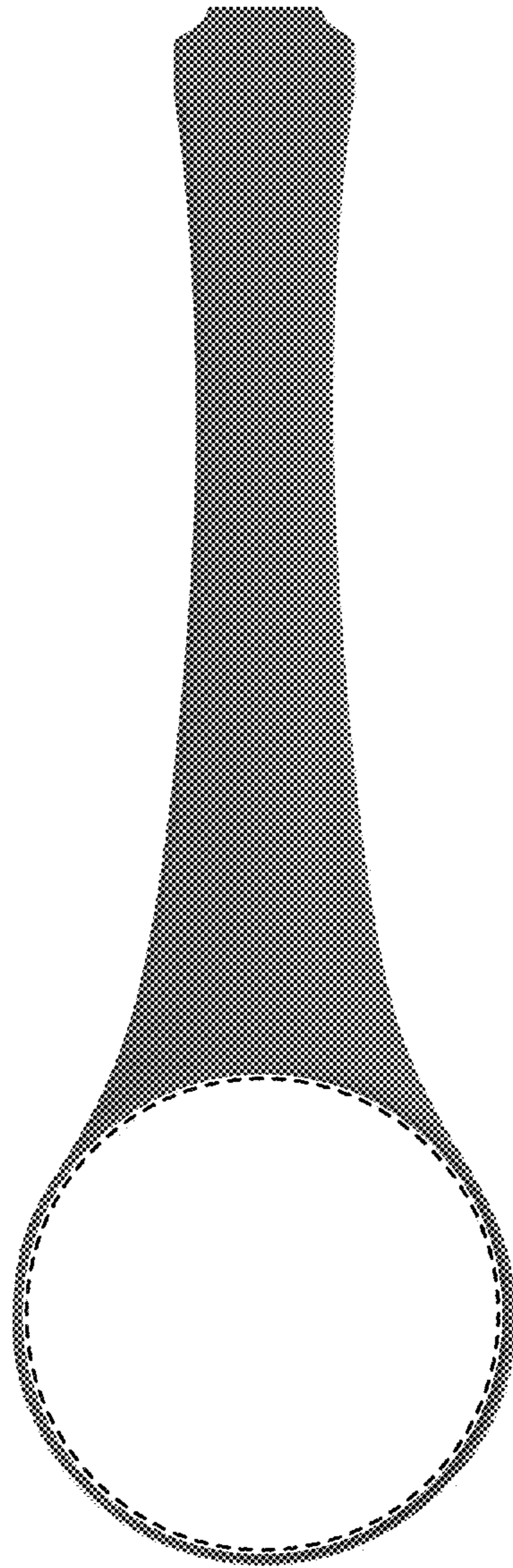
