DESCRIPTION

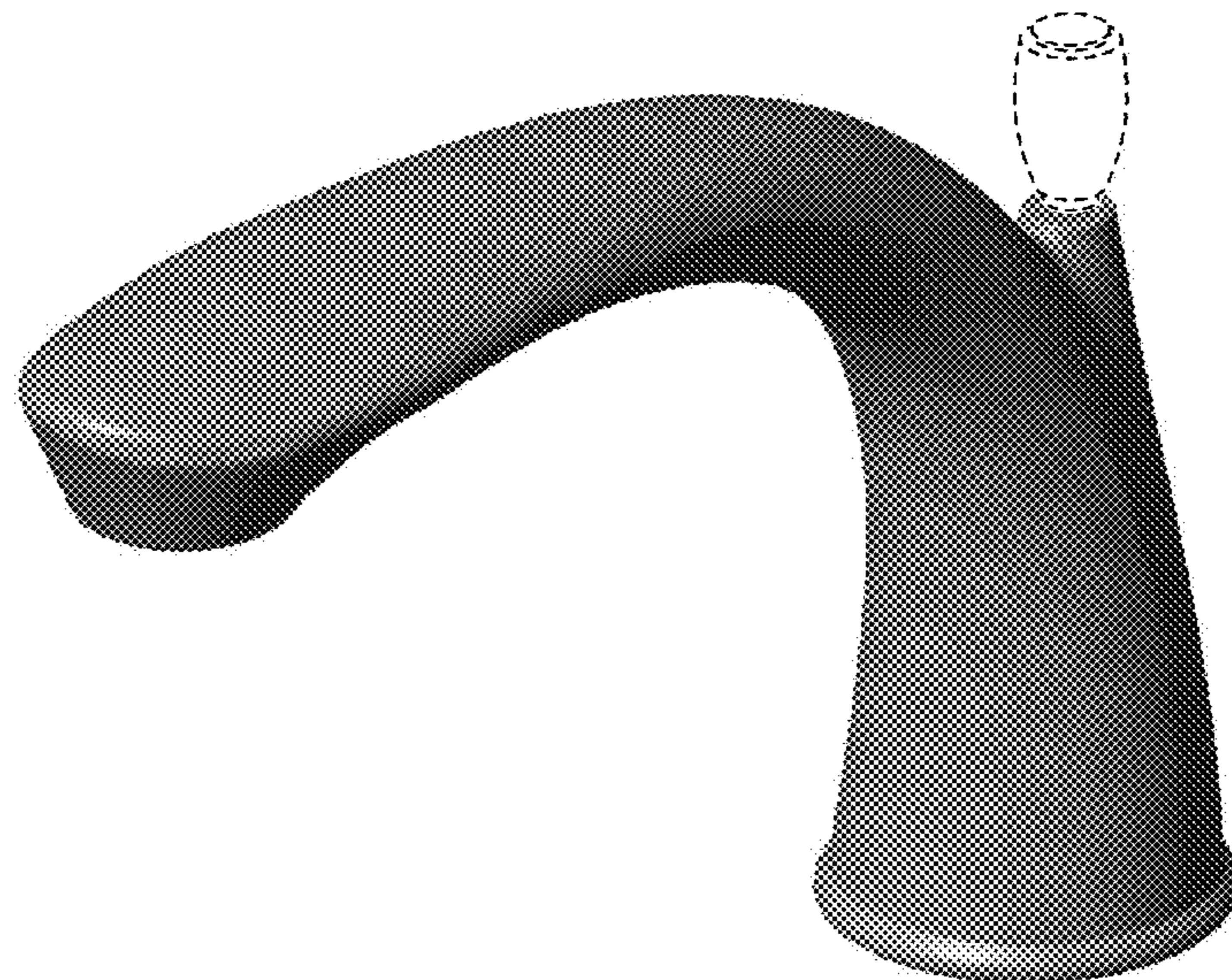
FIG. 1 is a front perspective view of a spout showing my new design;

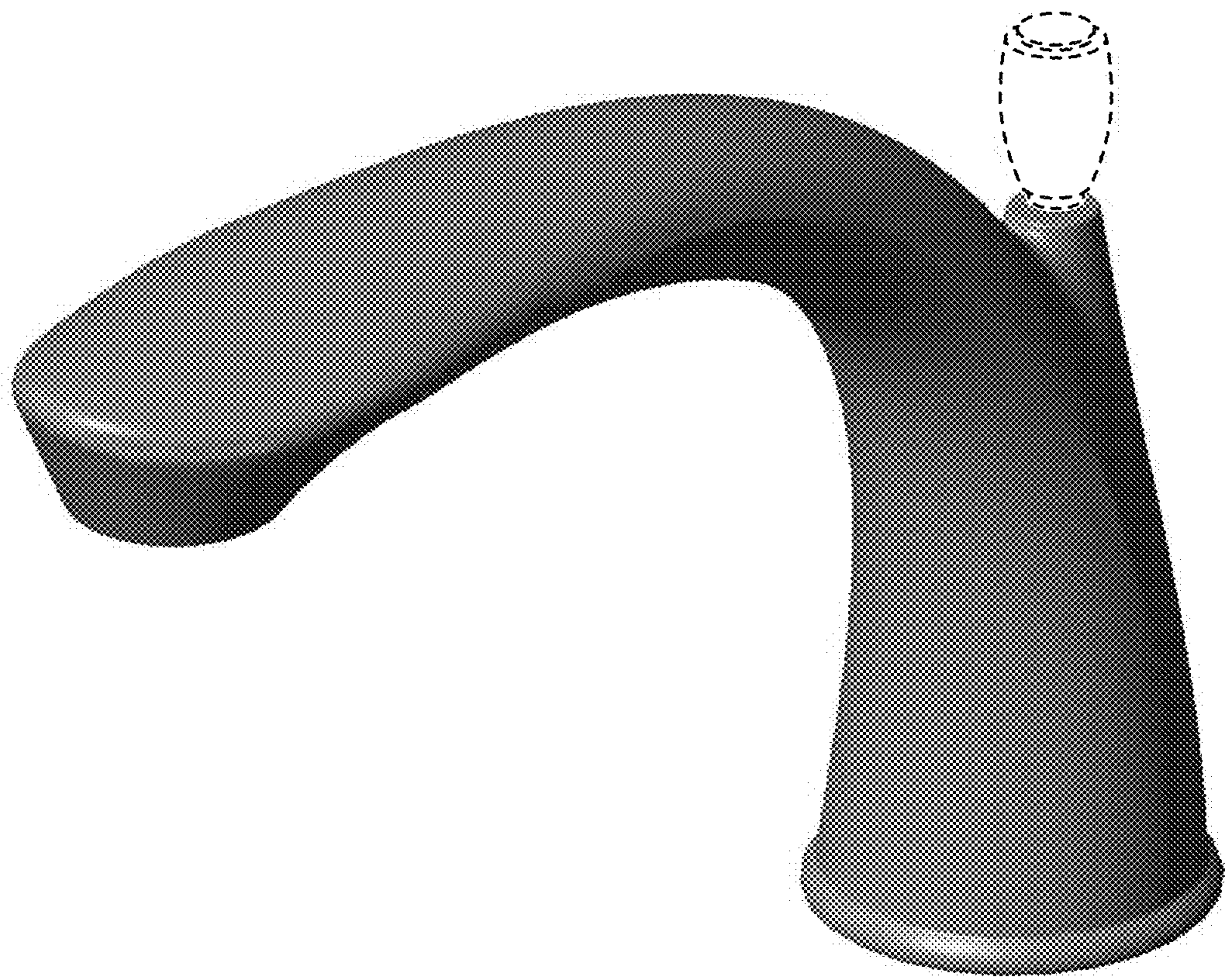

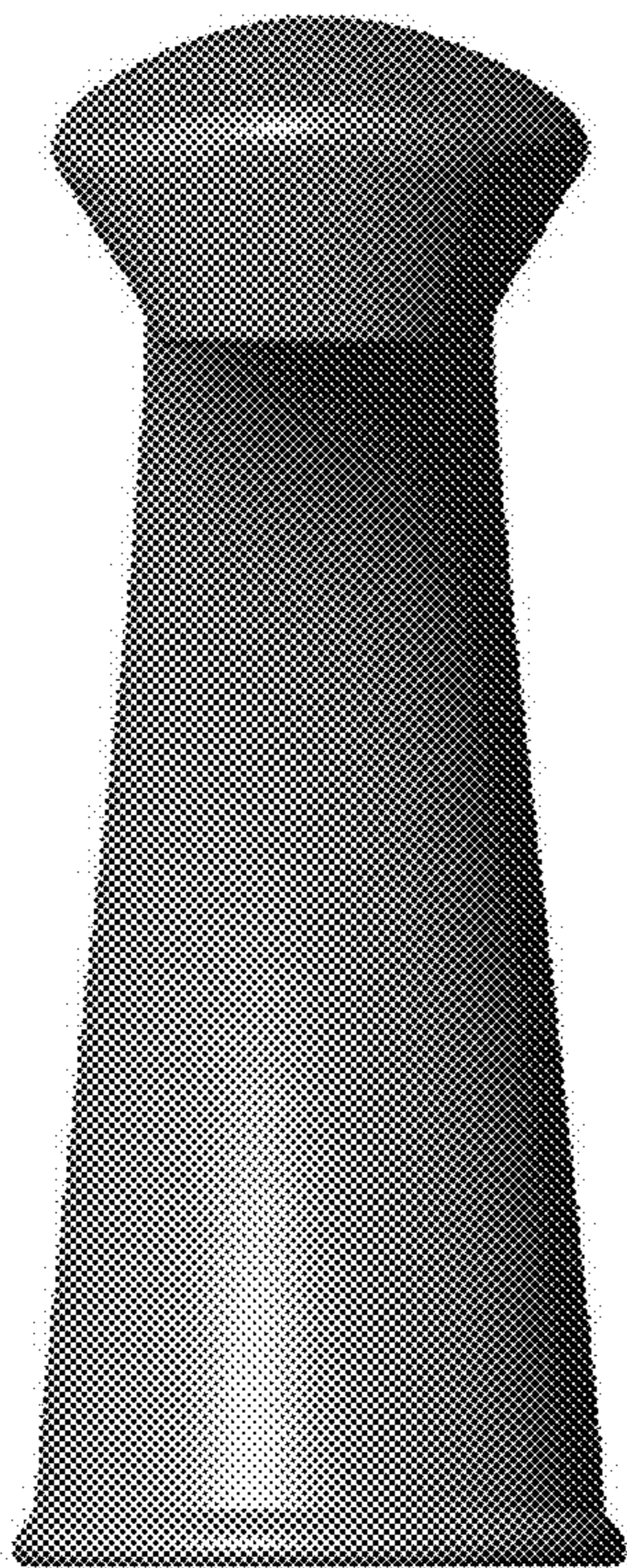

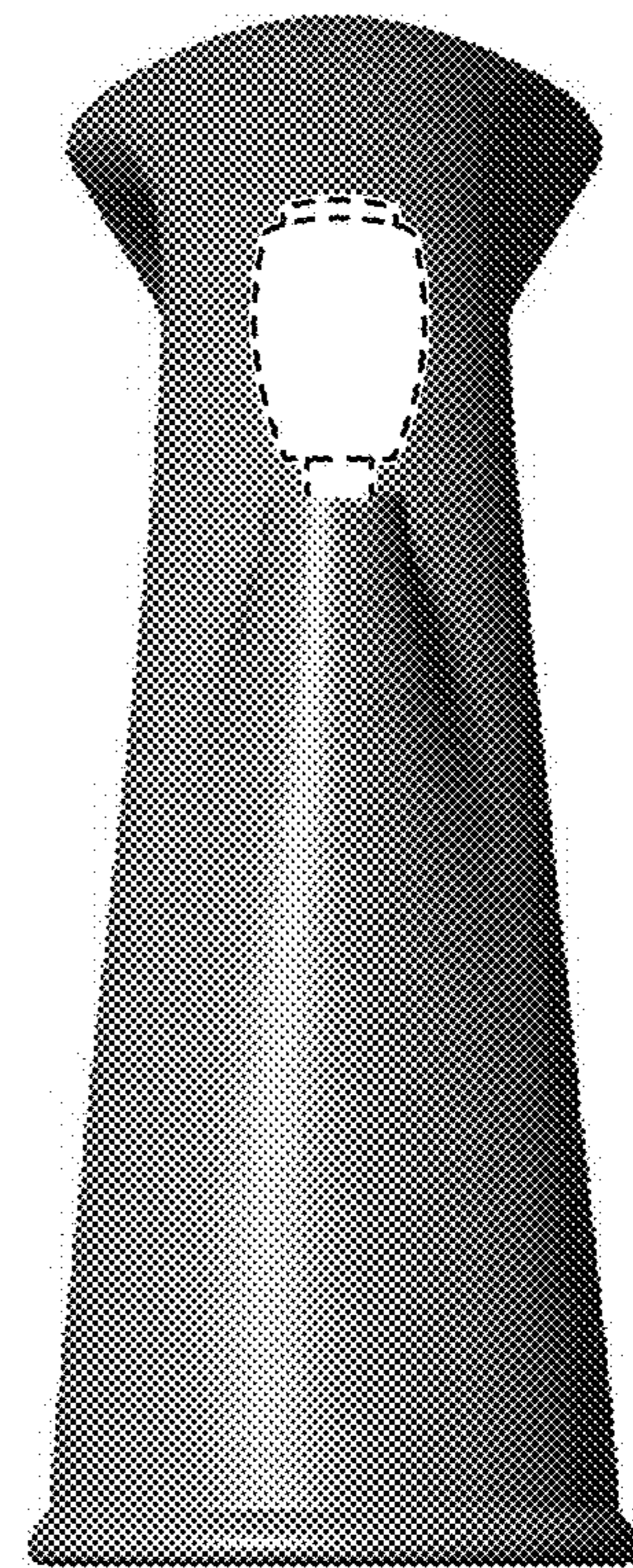

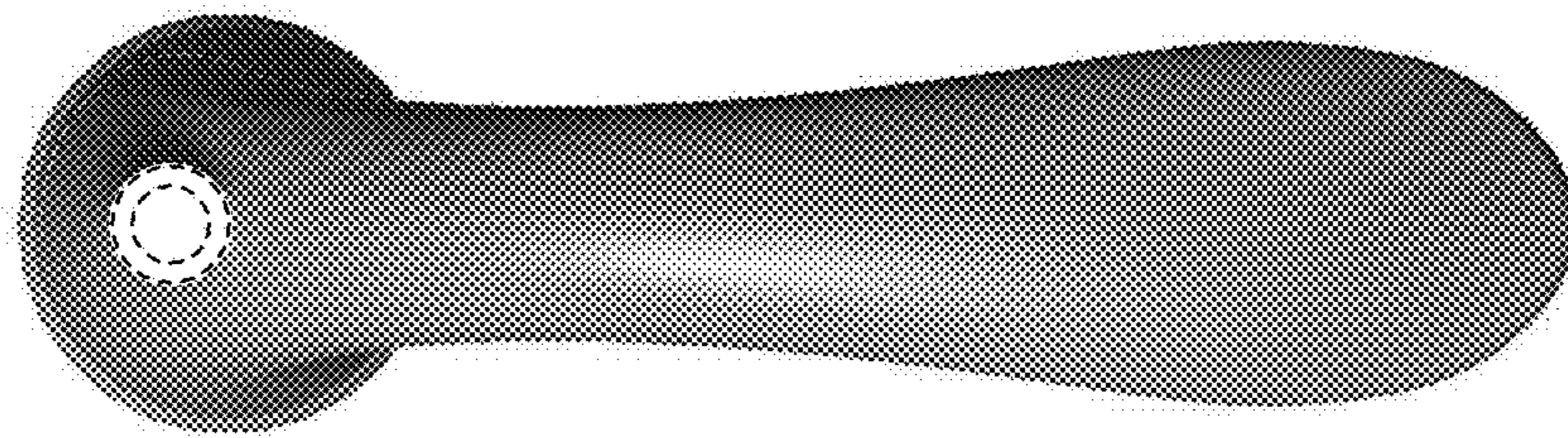

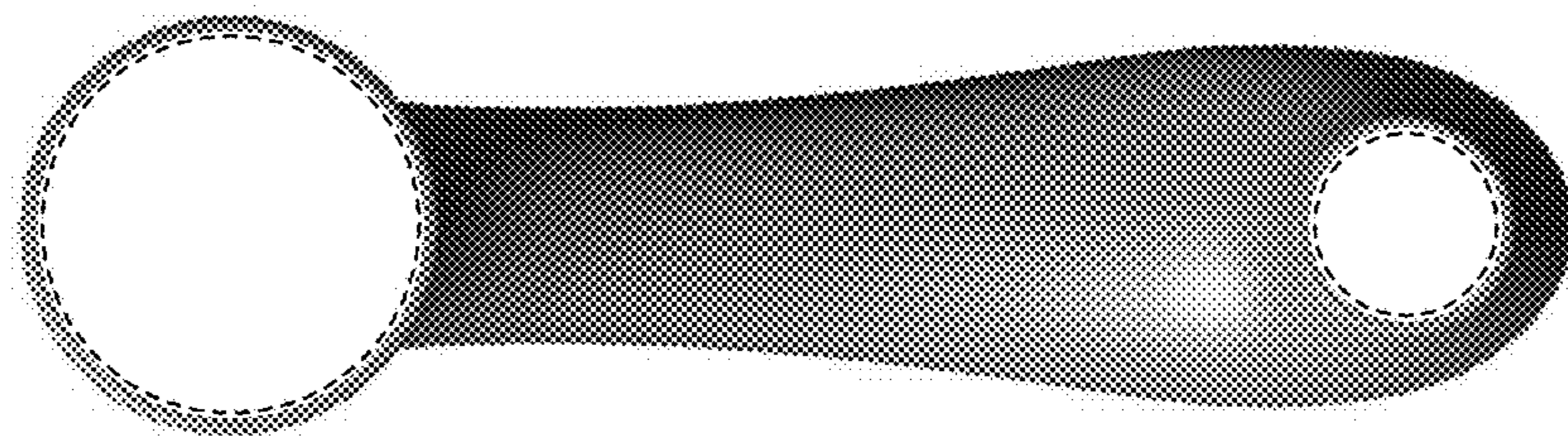
