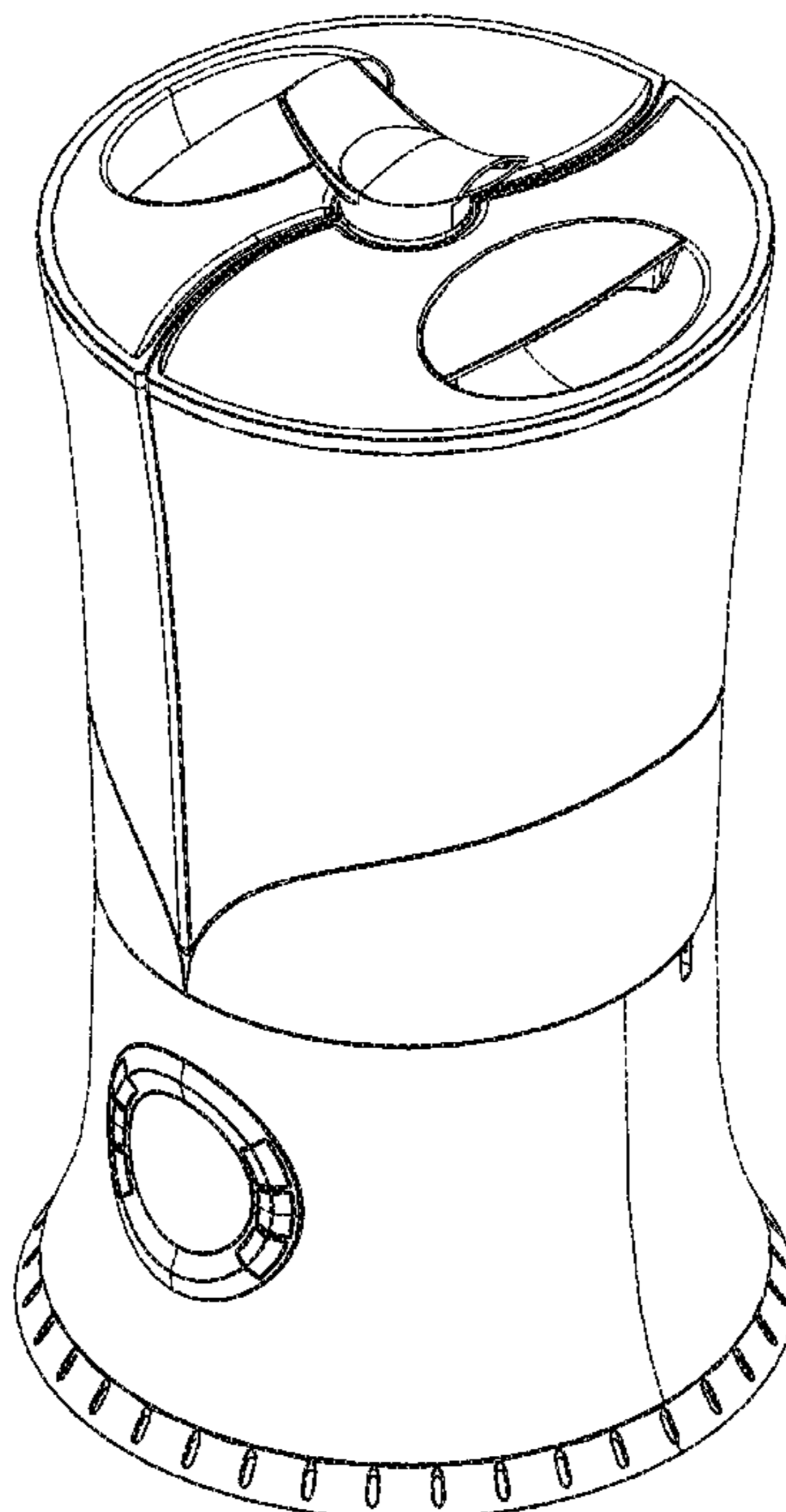
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of a dual tank humidifier
showing my new design;

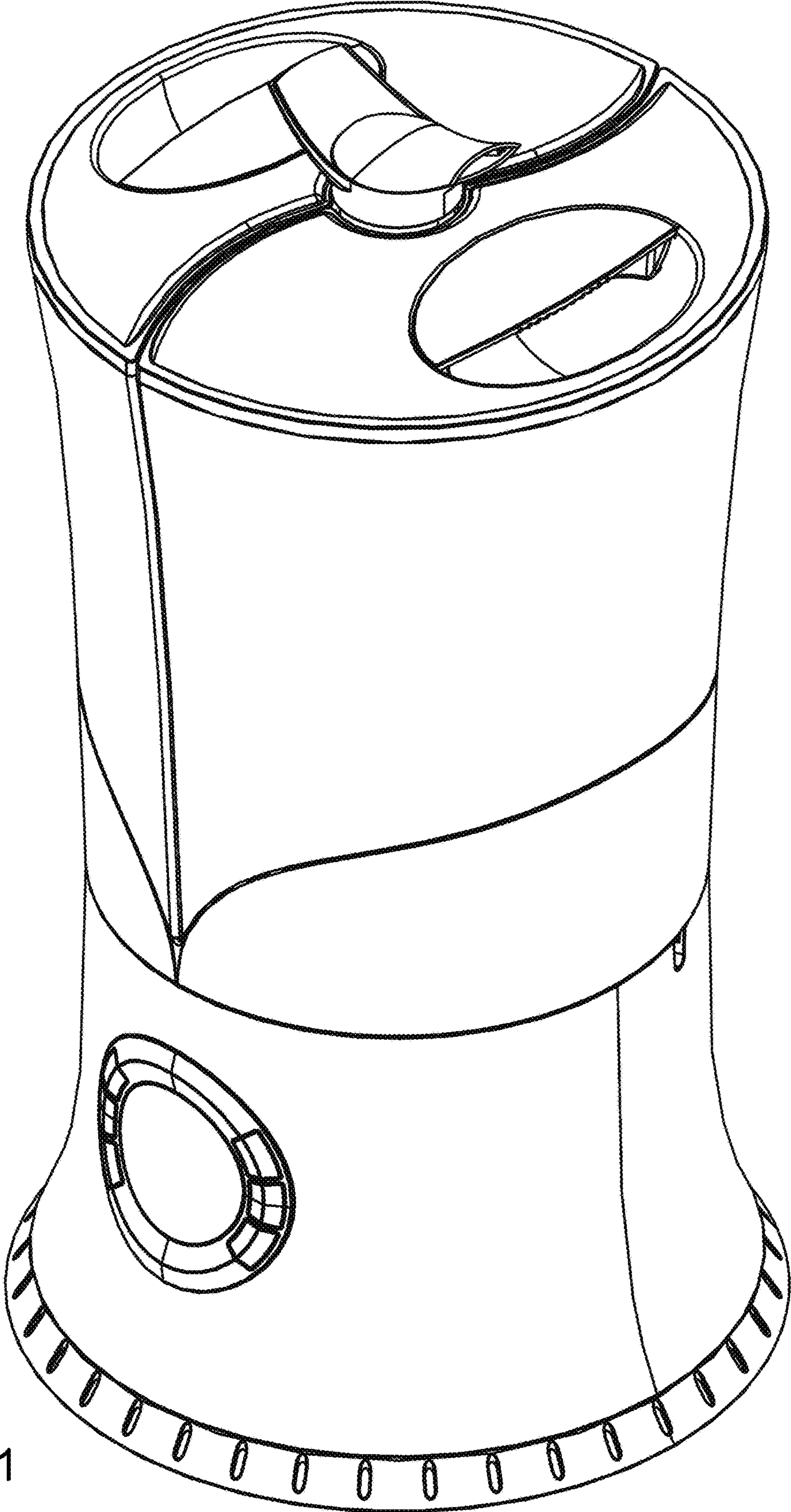

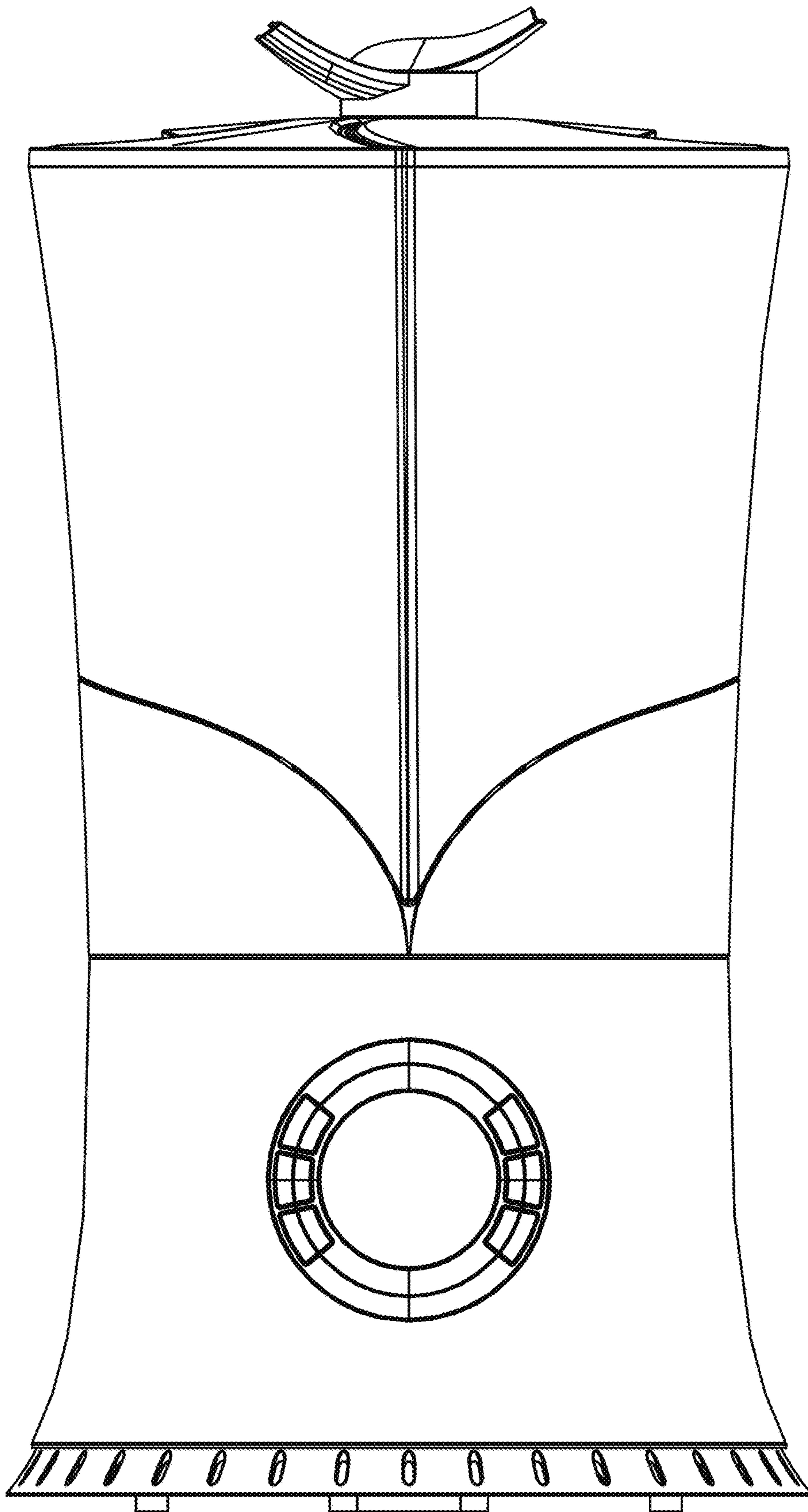

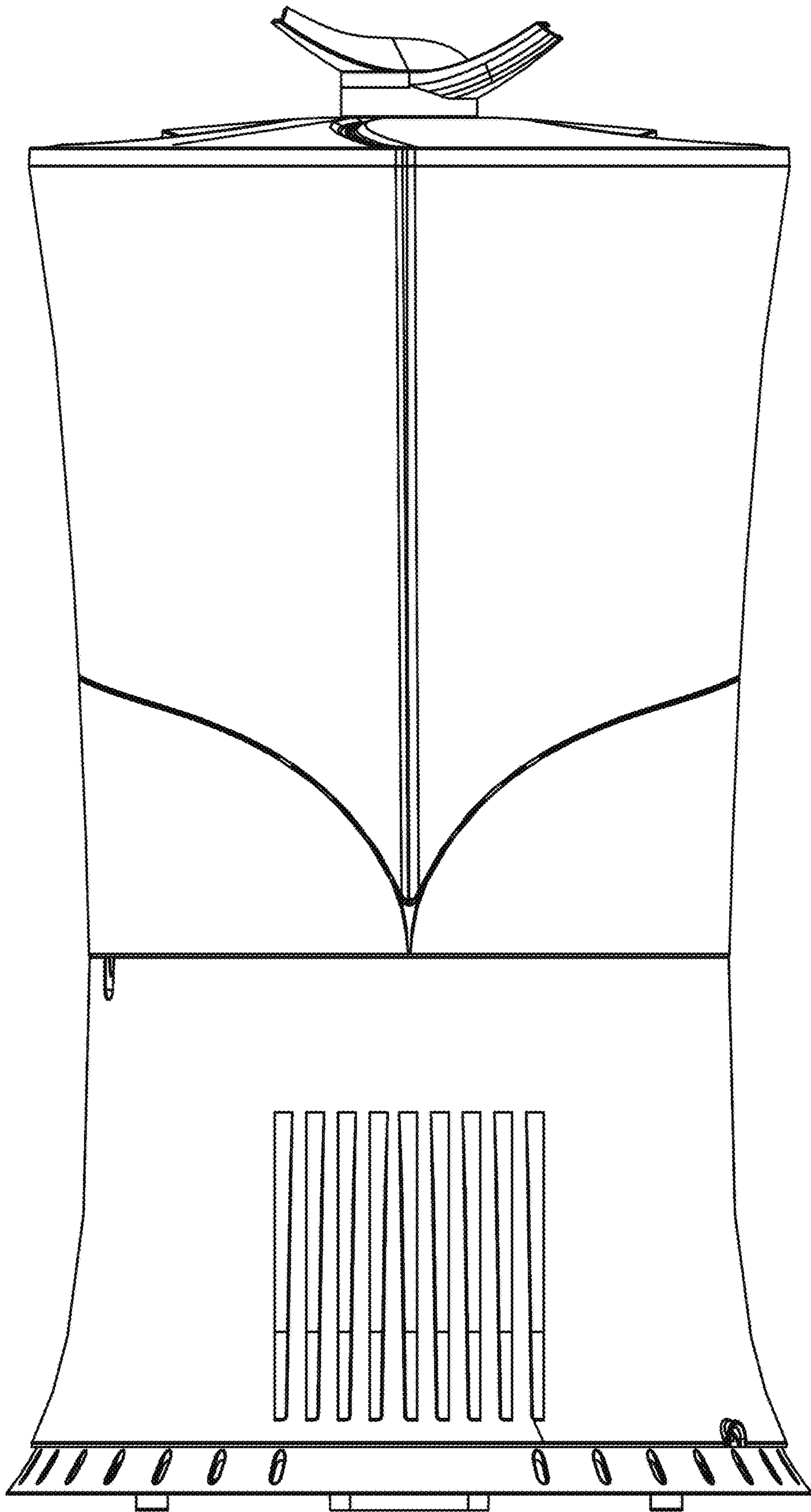

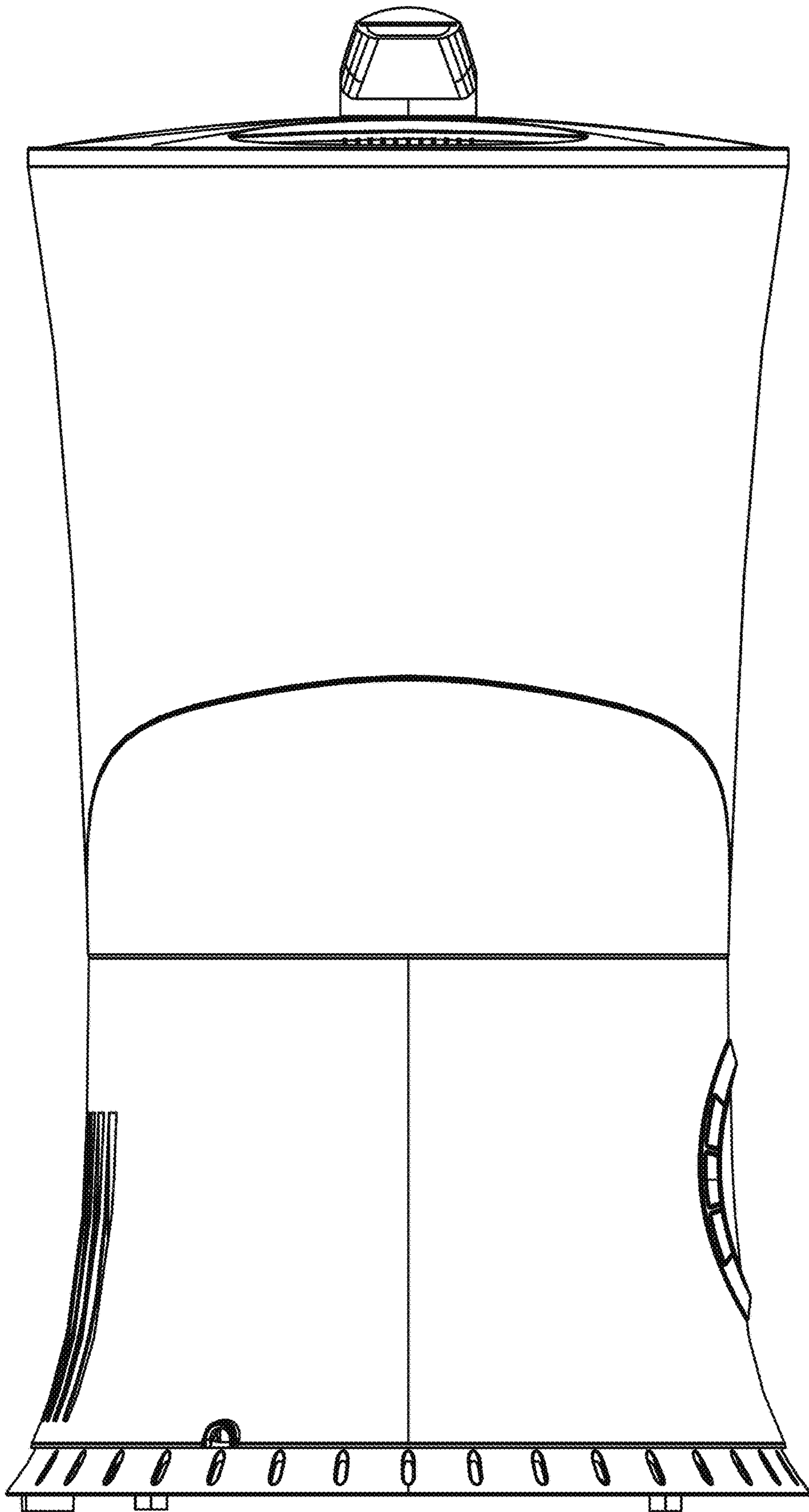

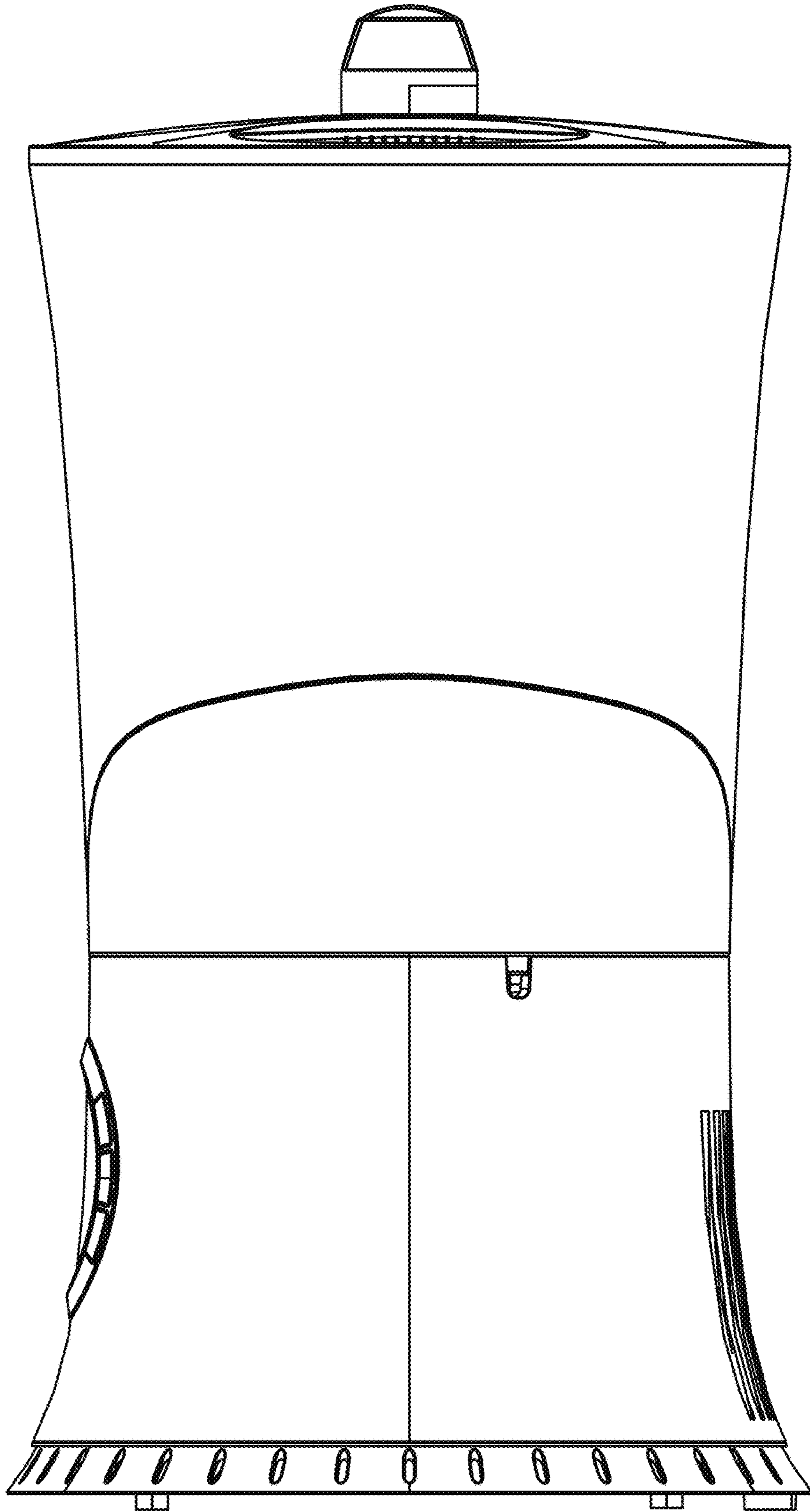

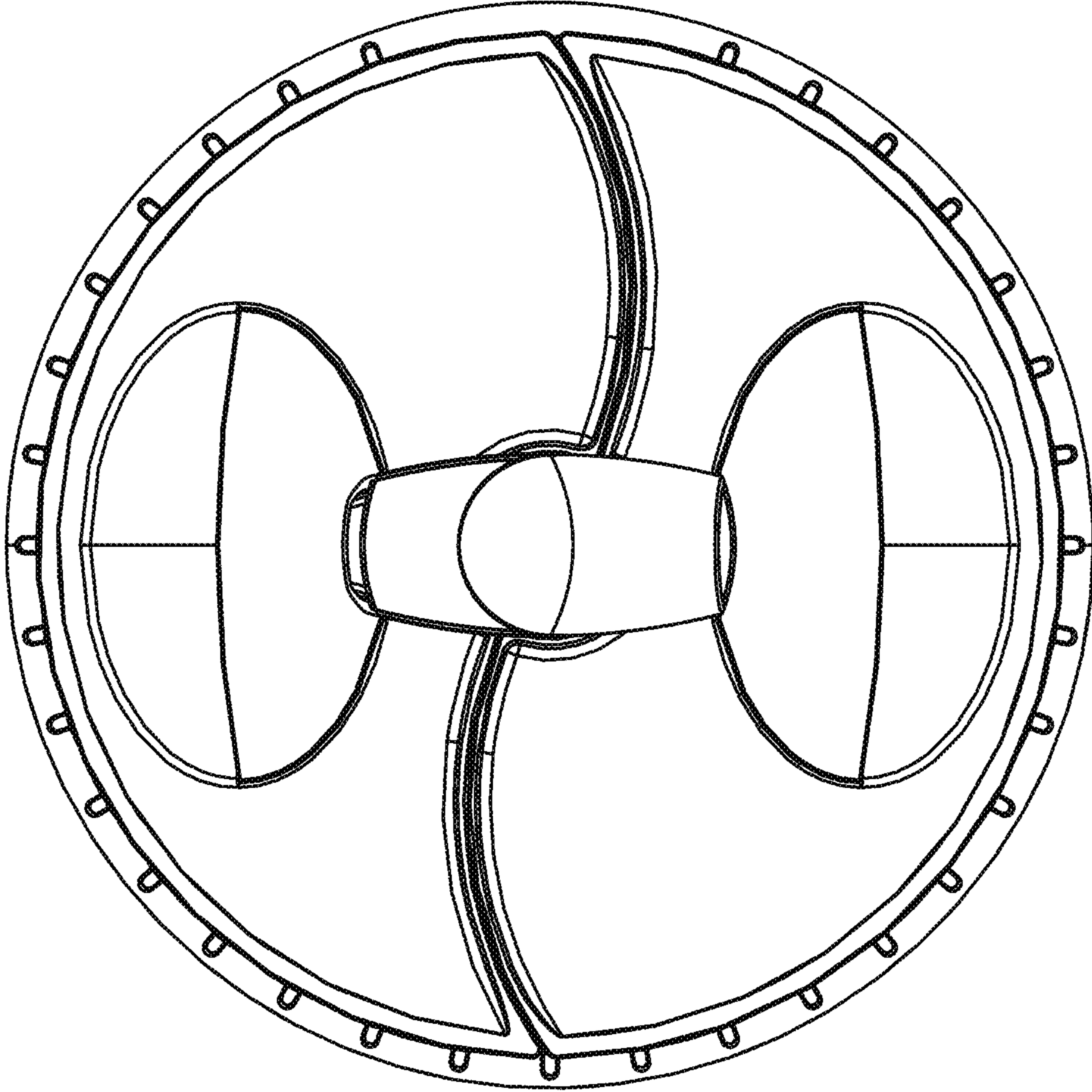

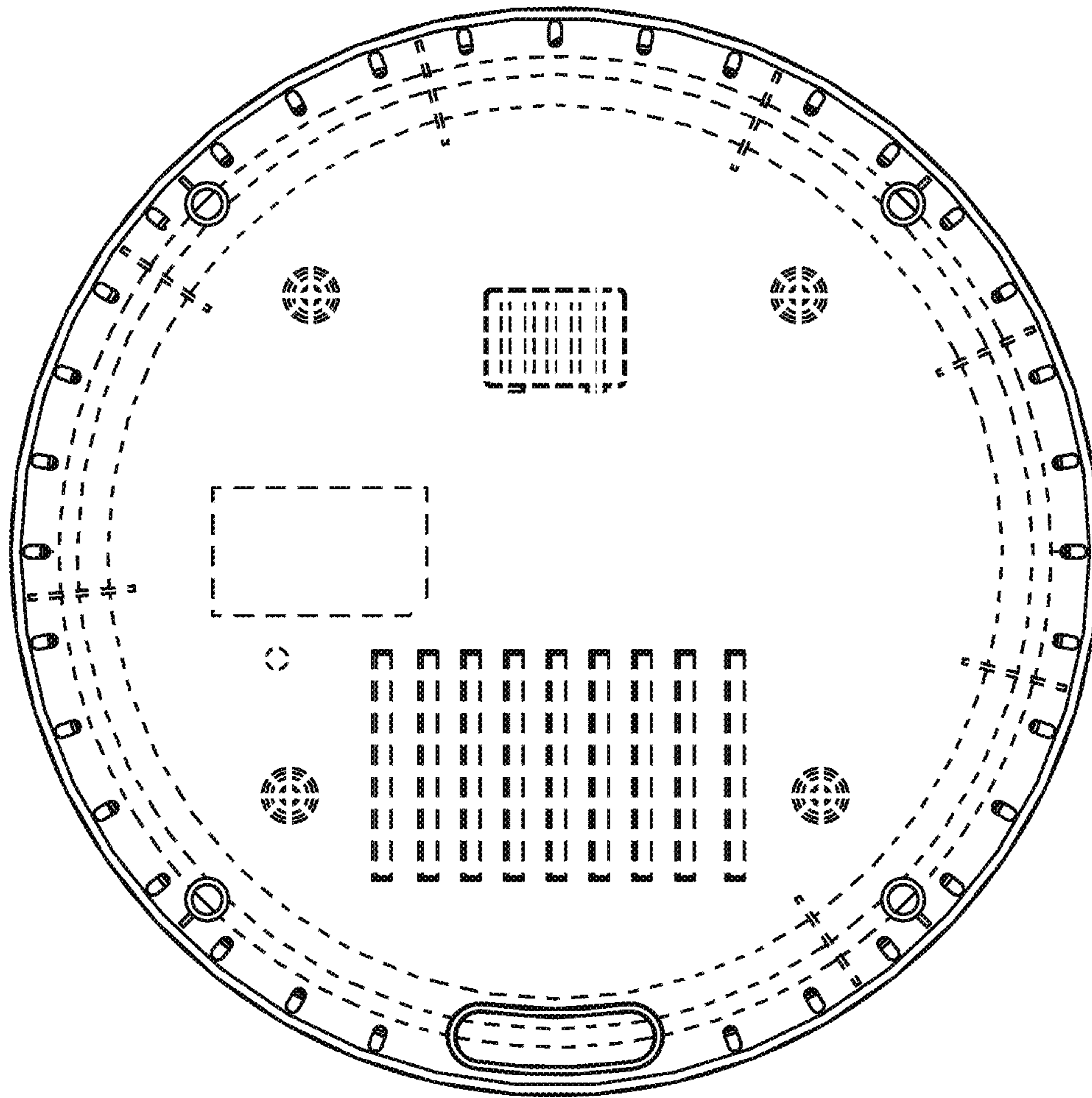
