**DESCRIPTION**

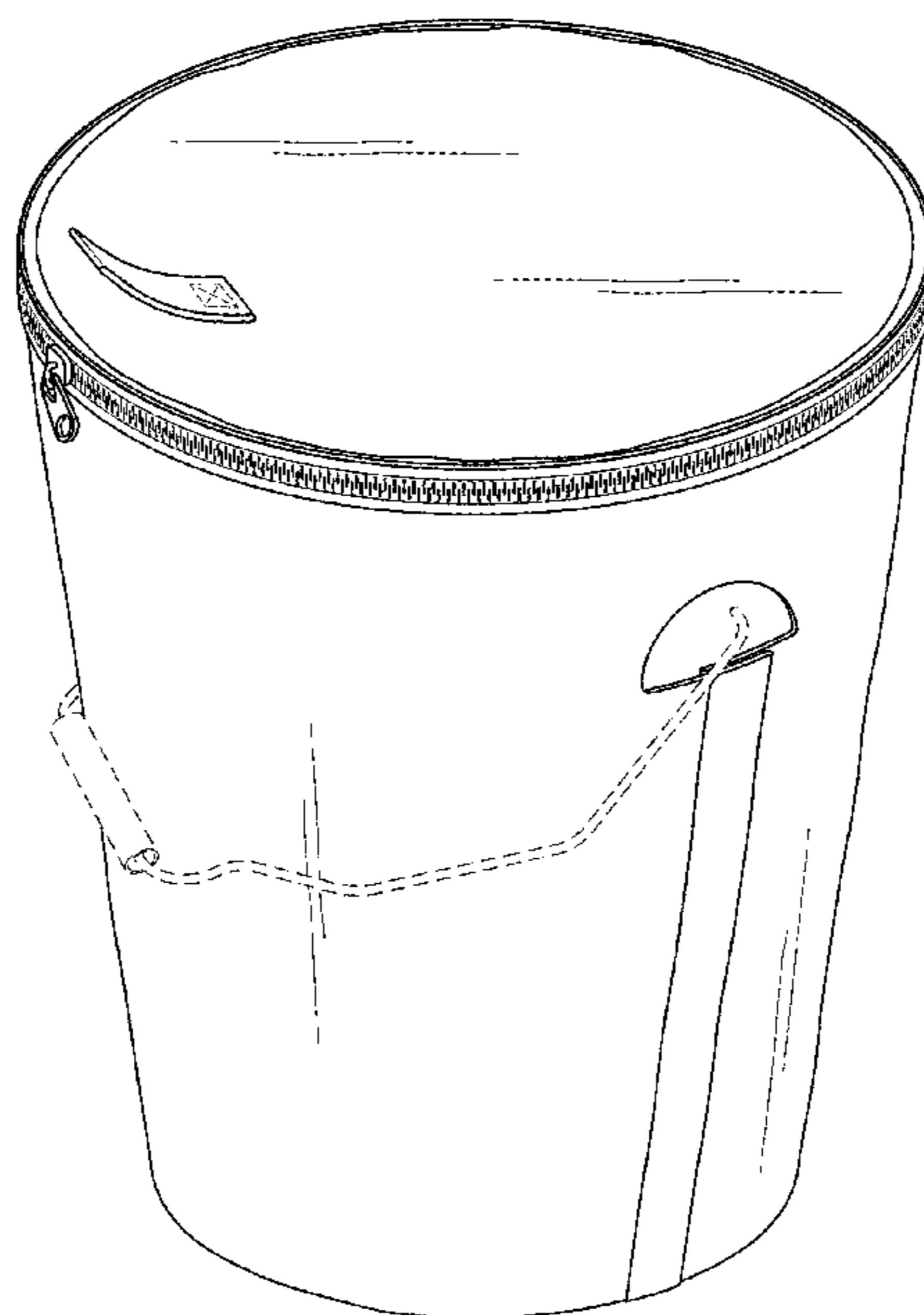
FIG. 1 is a top and side perspective view of an insulated bucket cover, showing our new design;

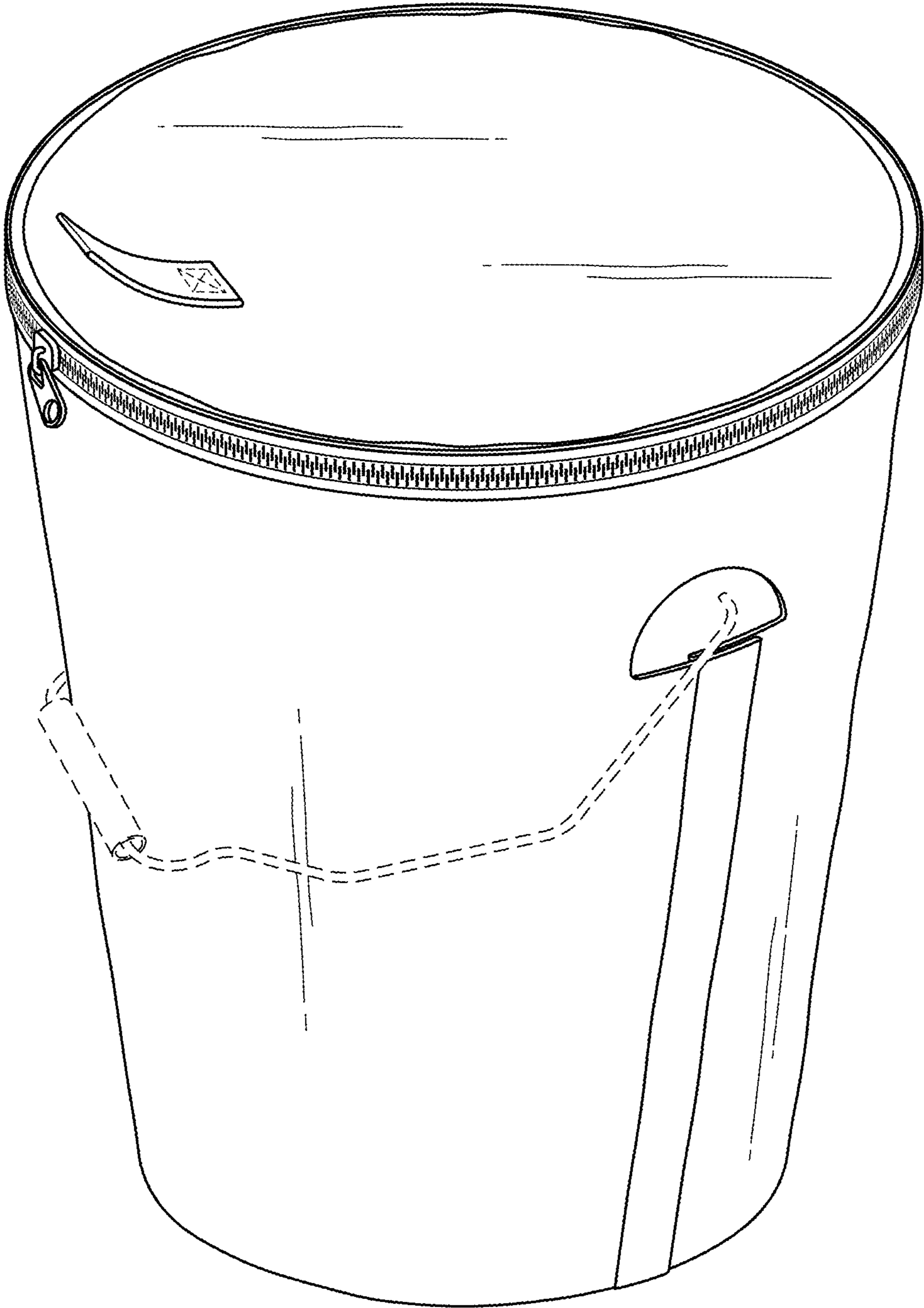

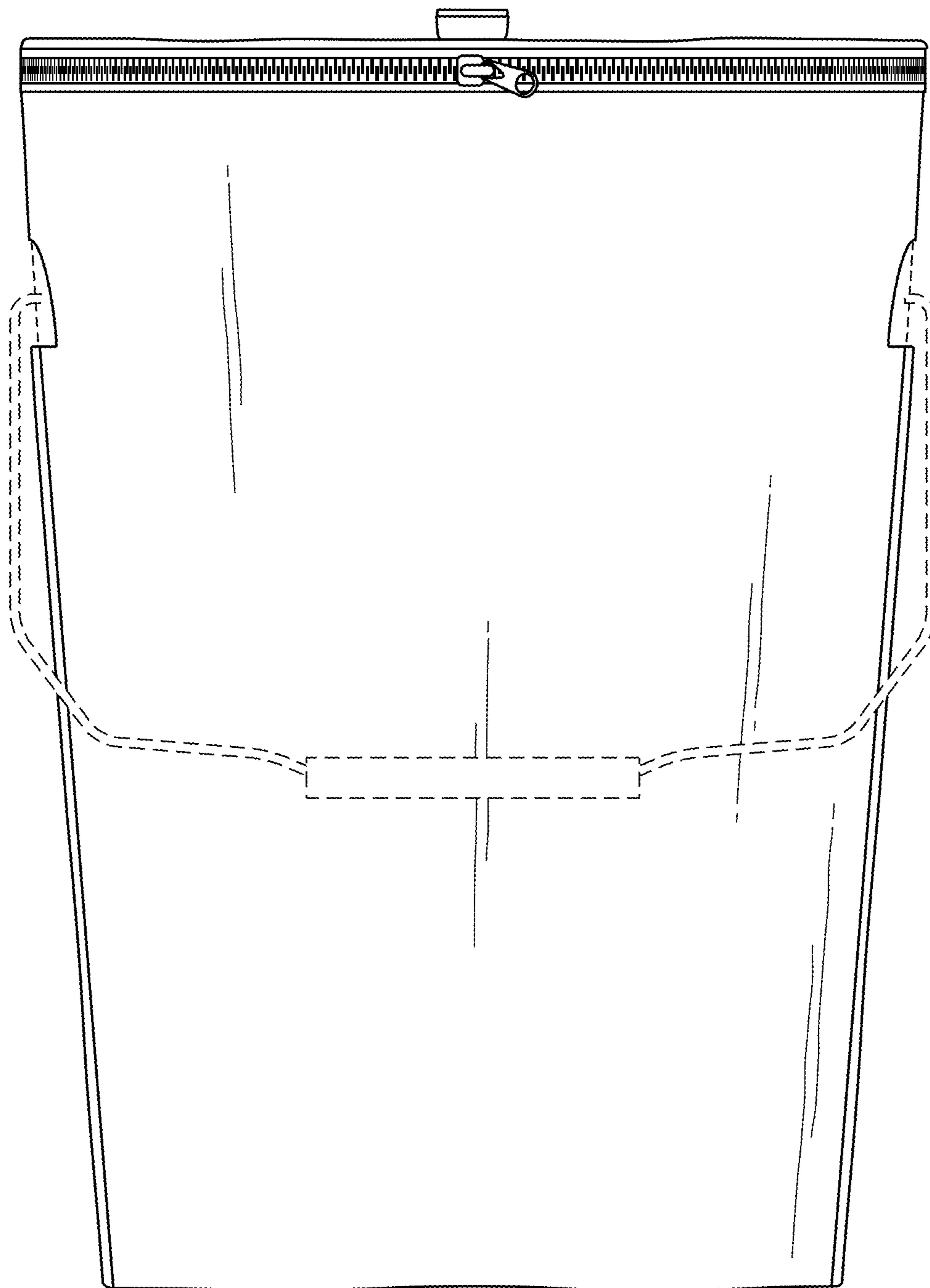

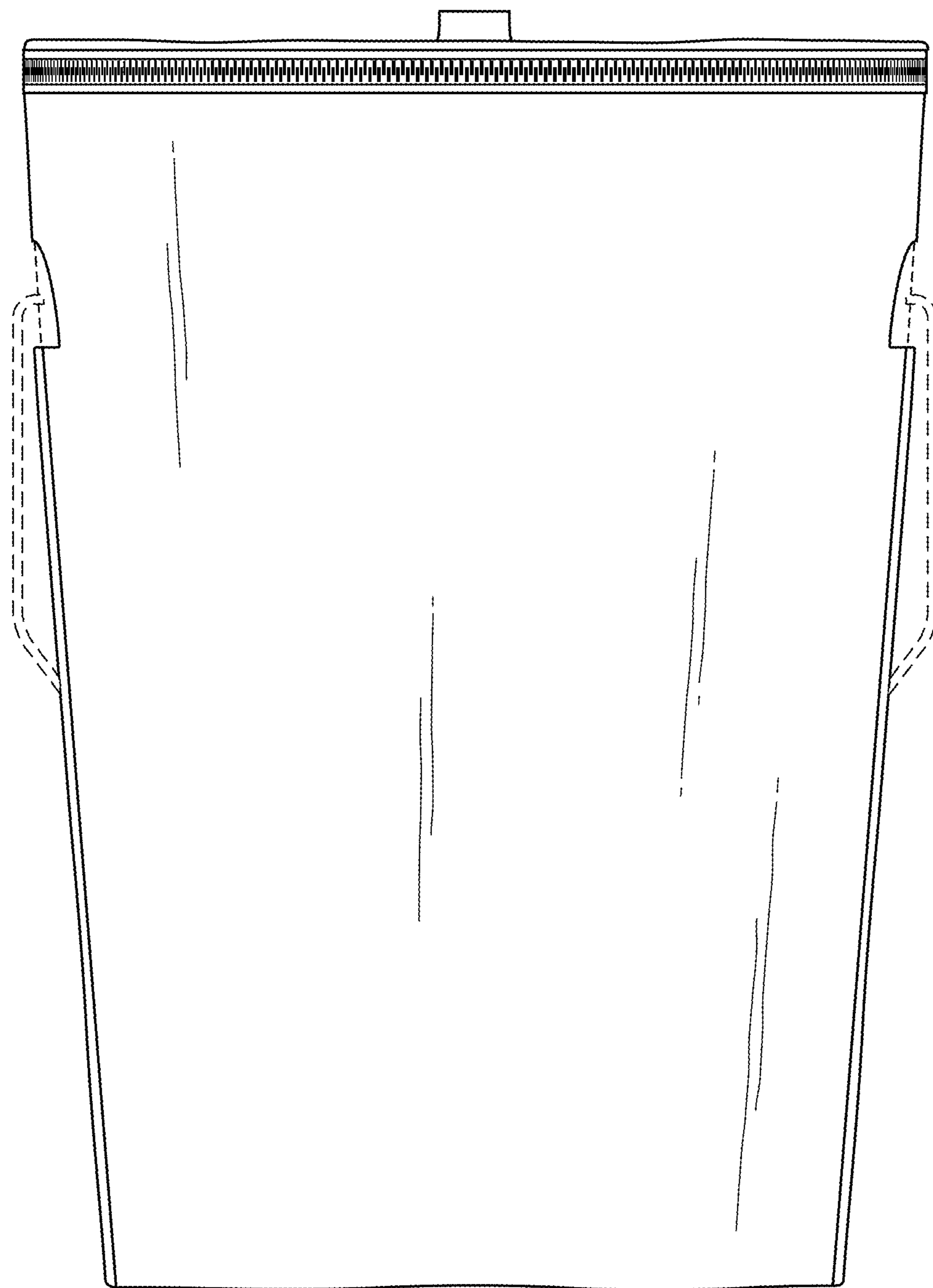

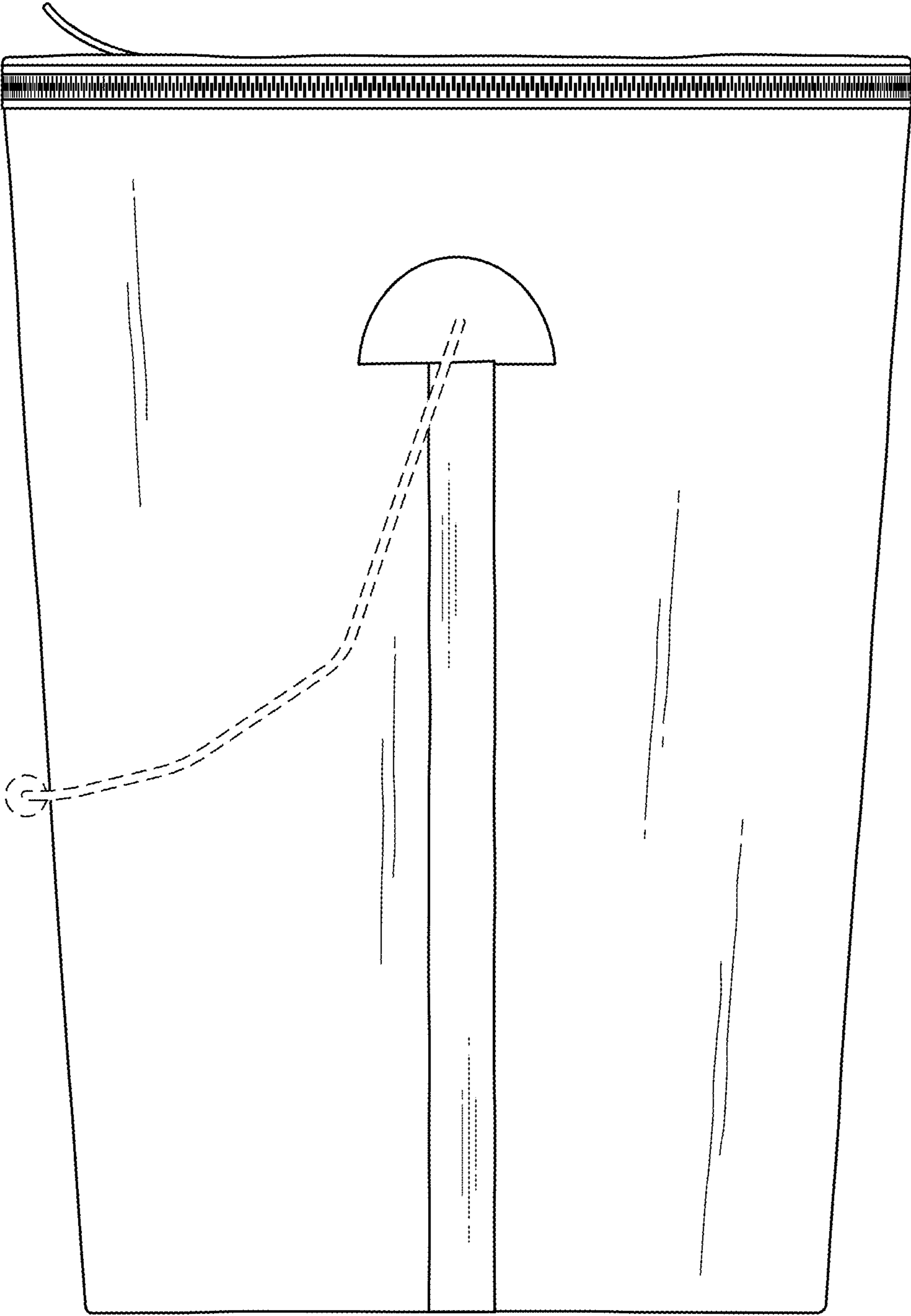

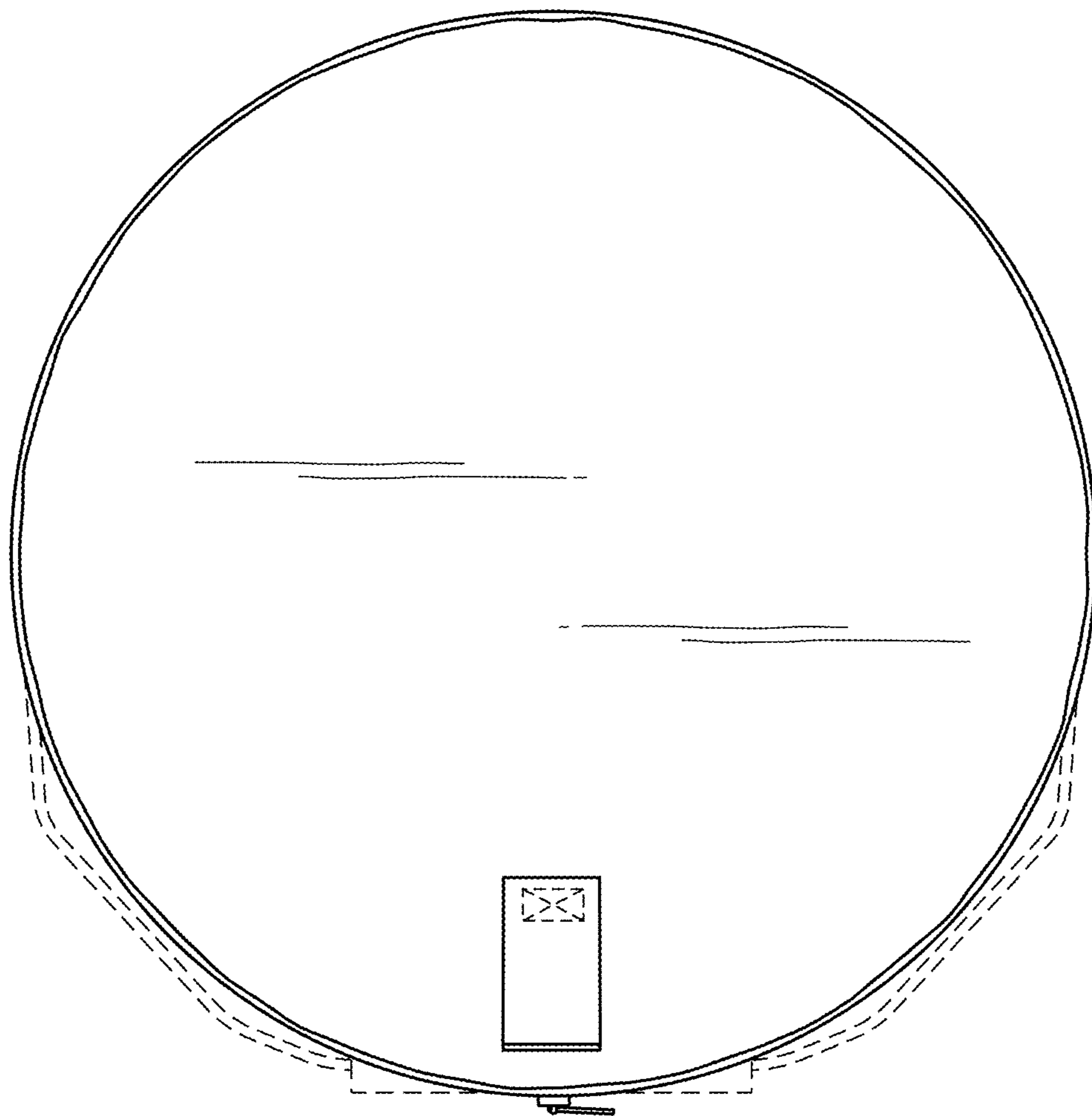

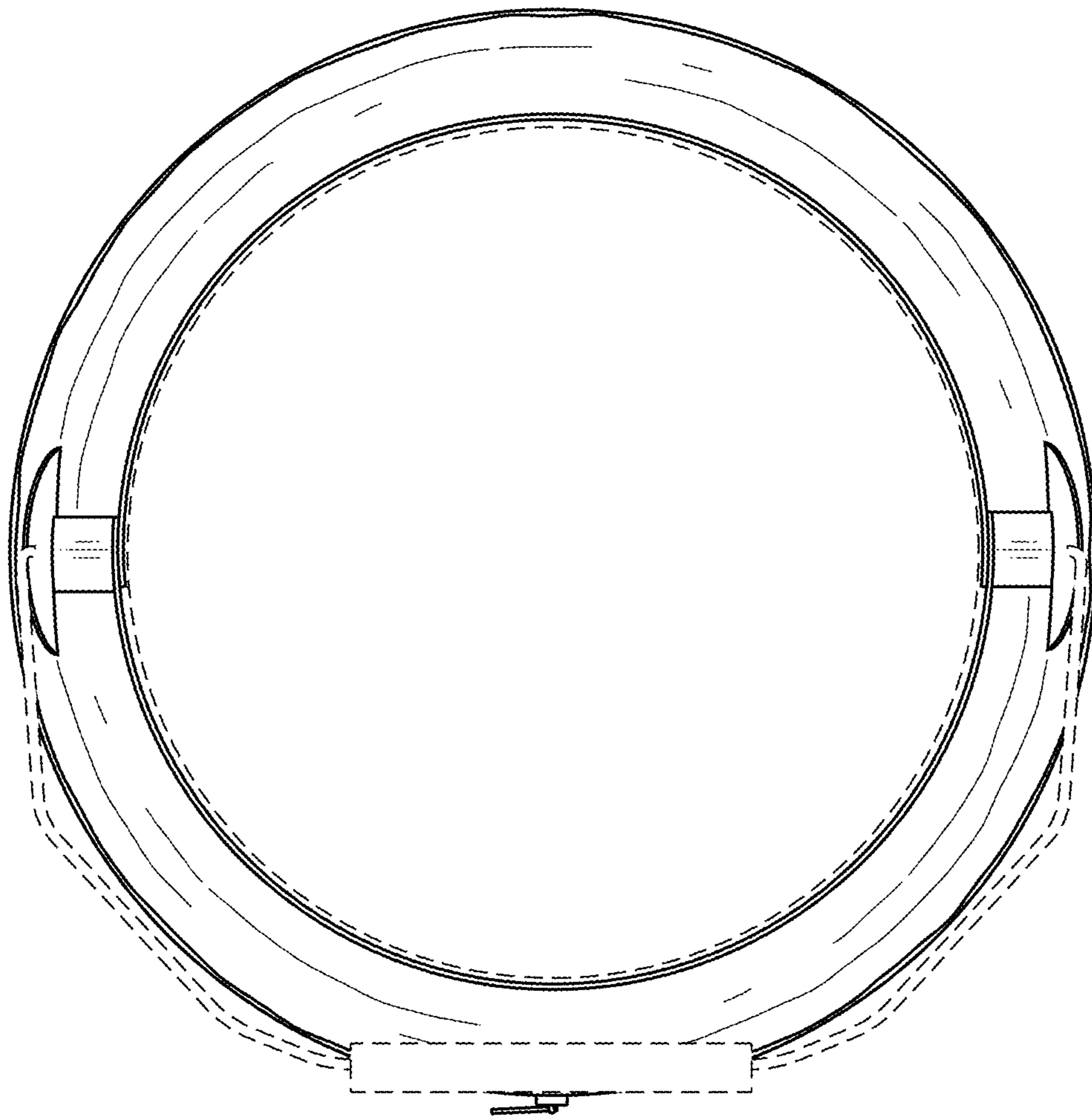
