DESCRIPTION

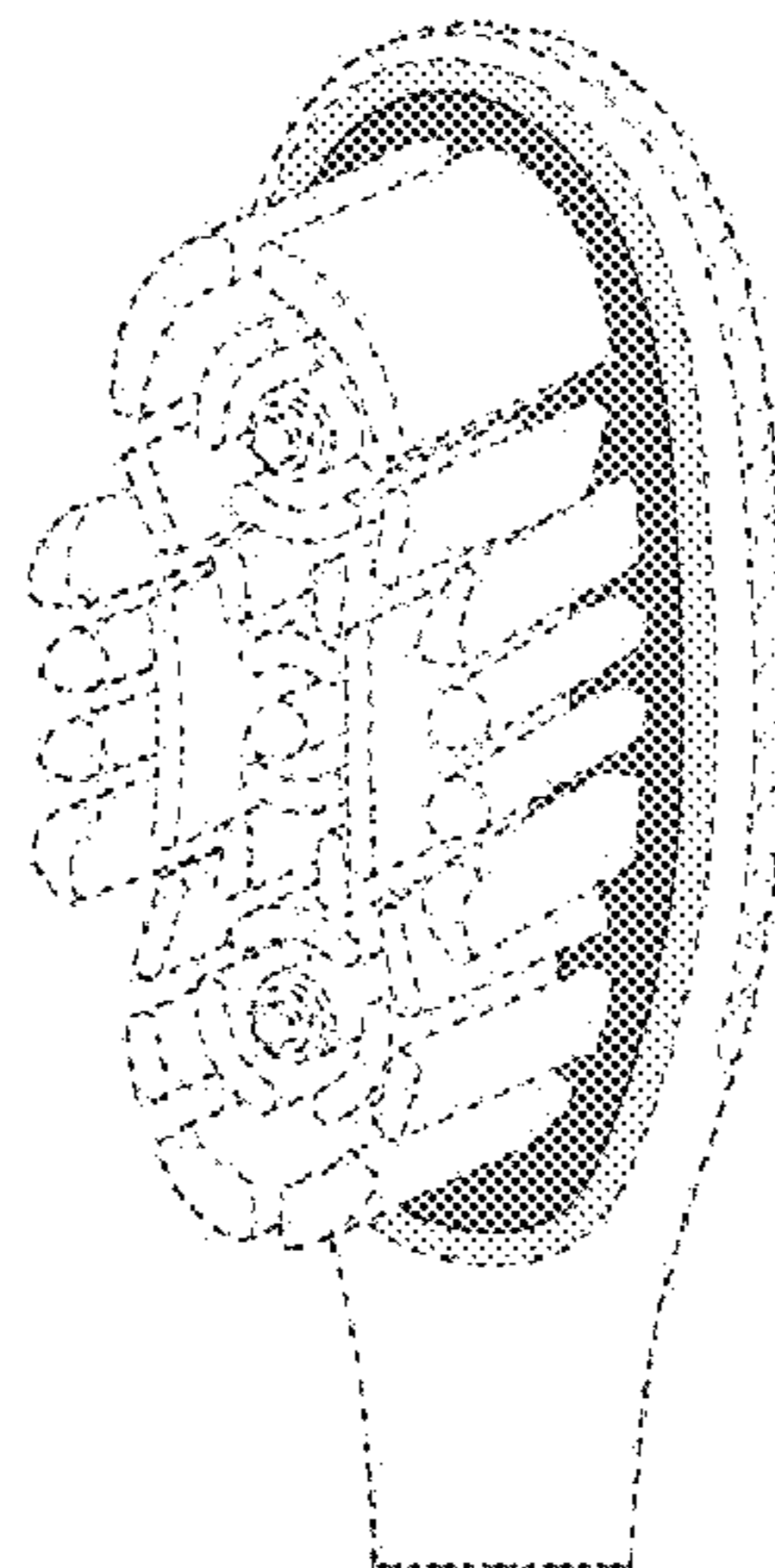
FIG. 1 is a front-right perspective view of a toothbrush head according to our design;

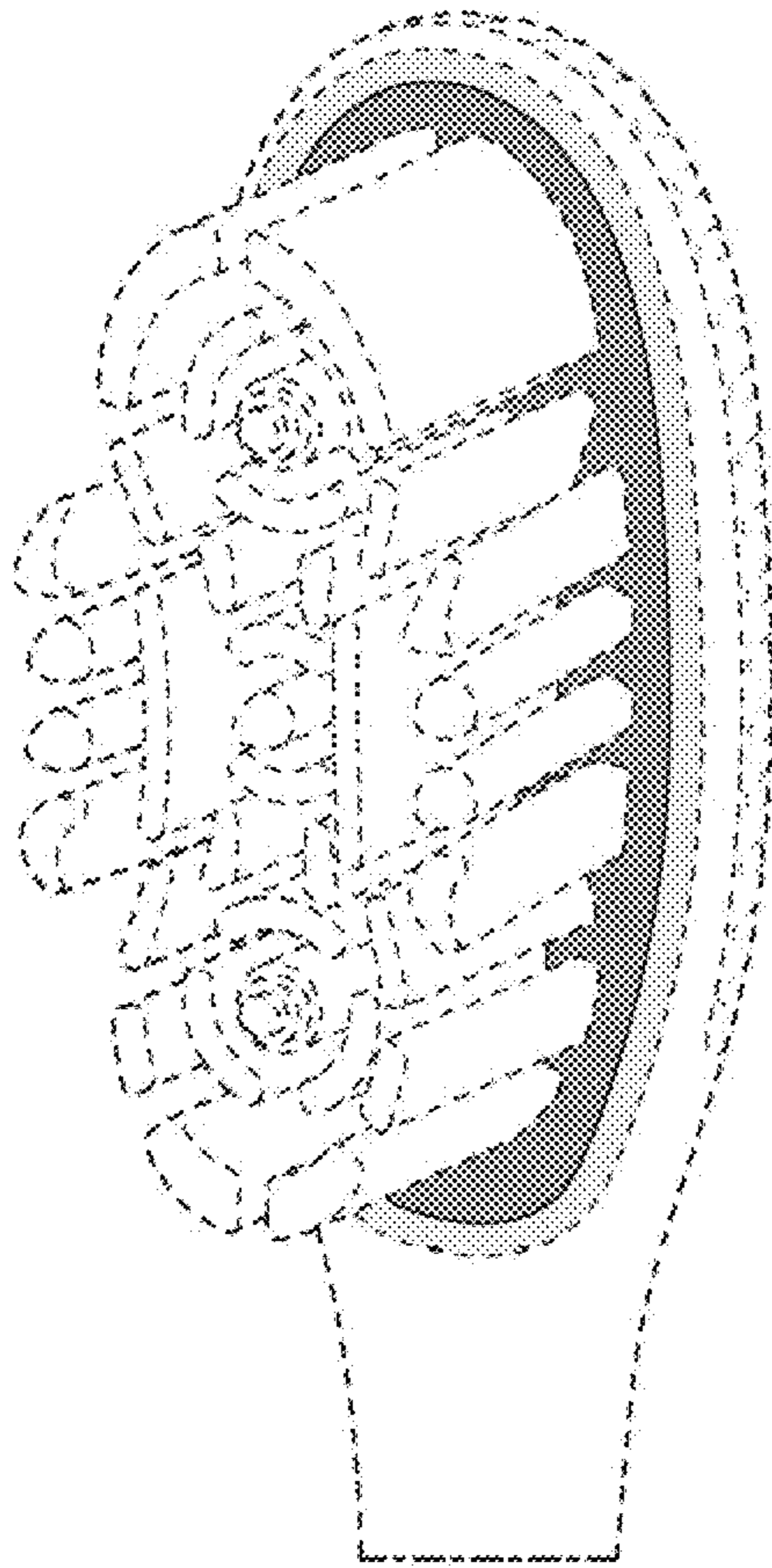

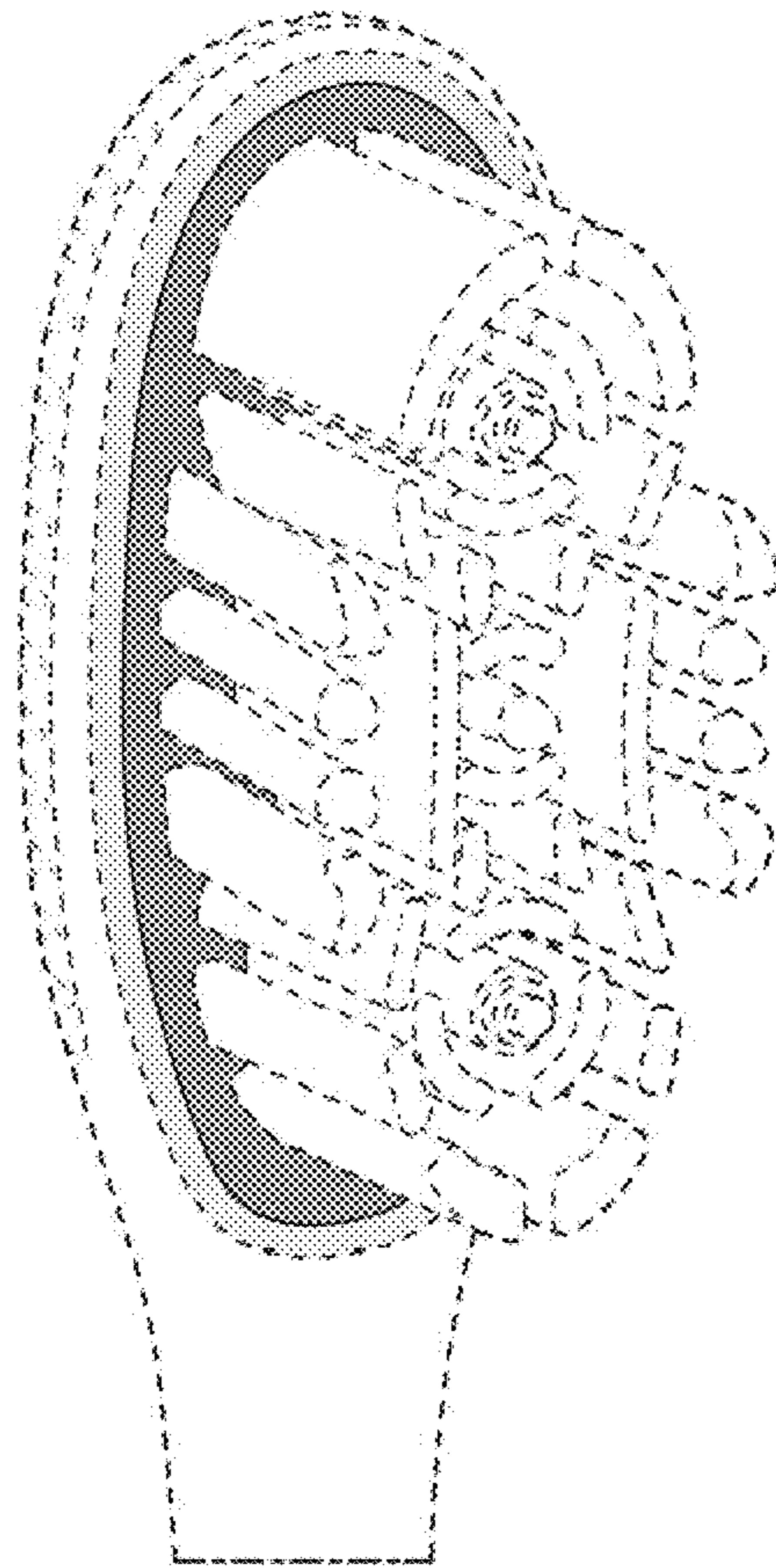

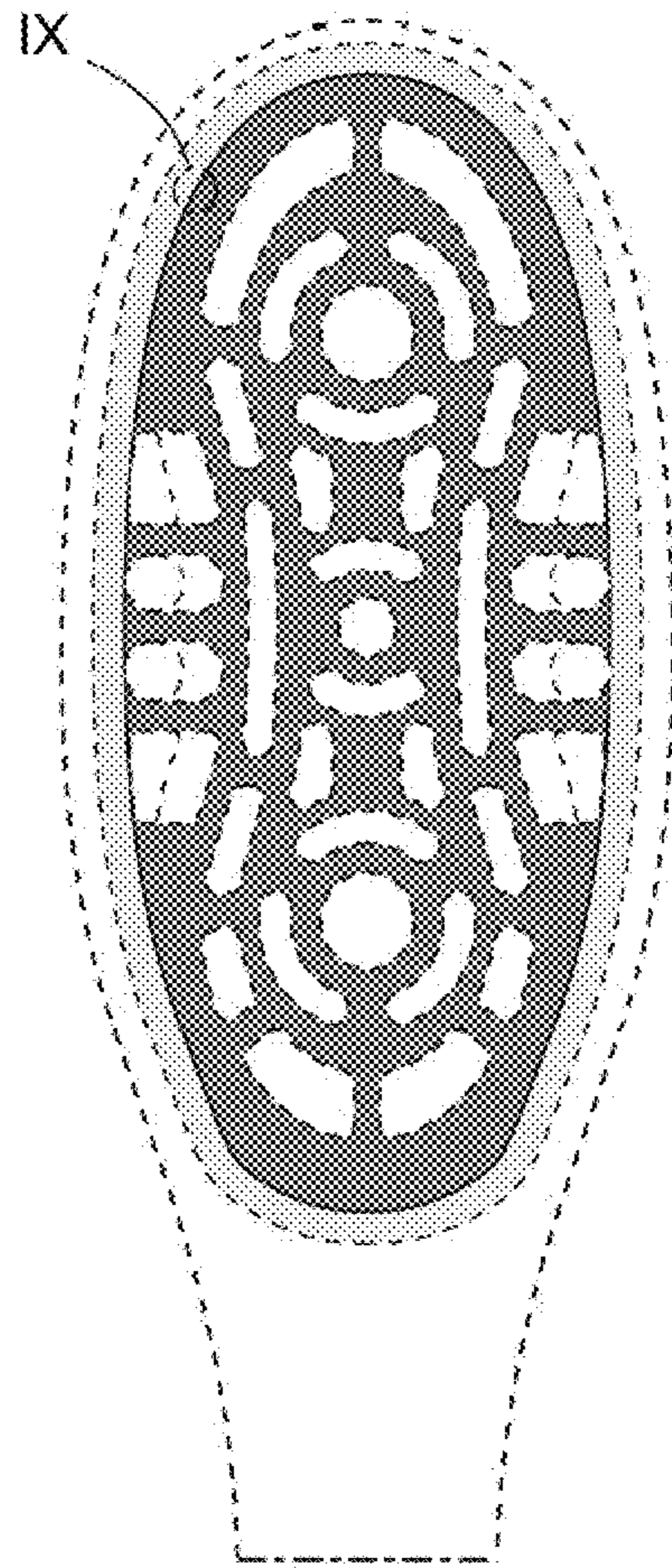

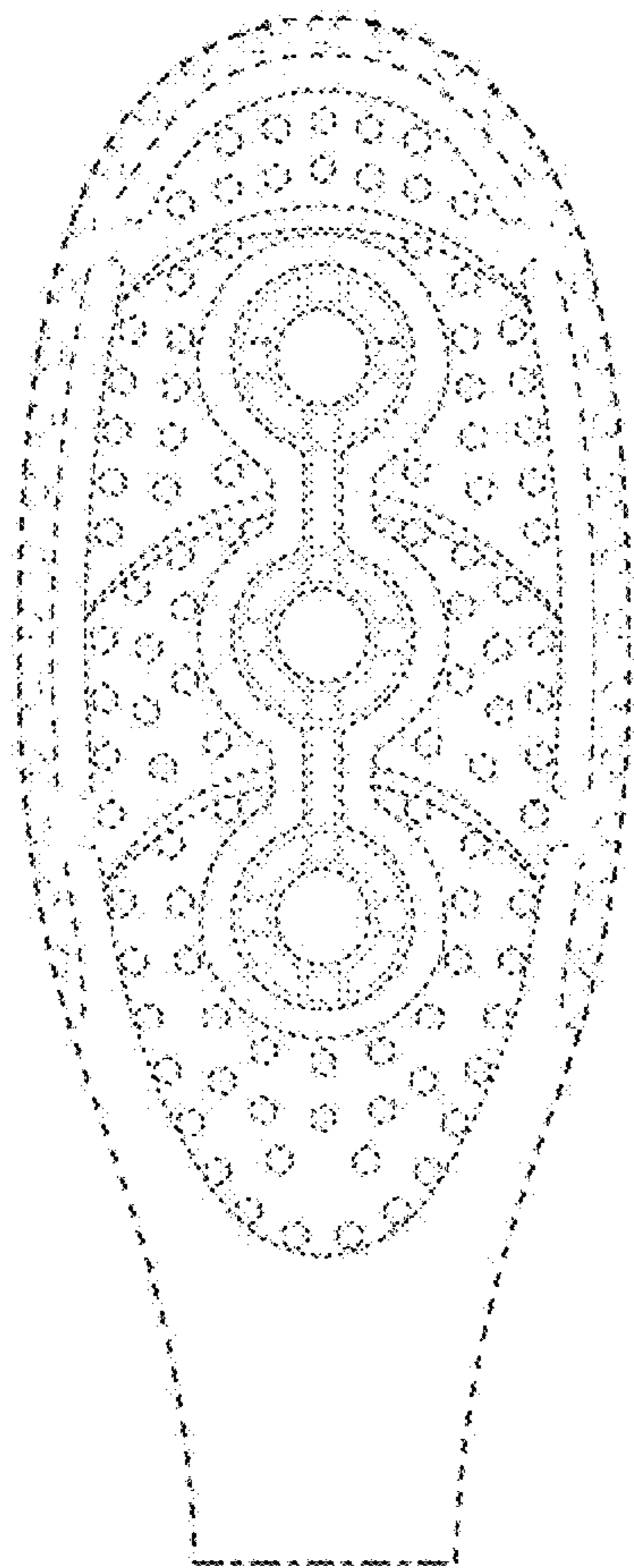

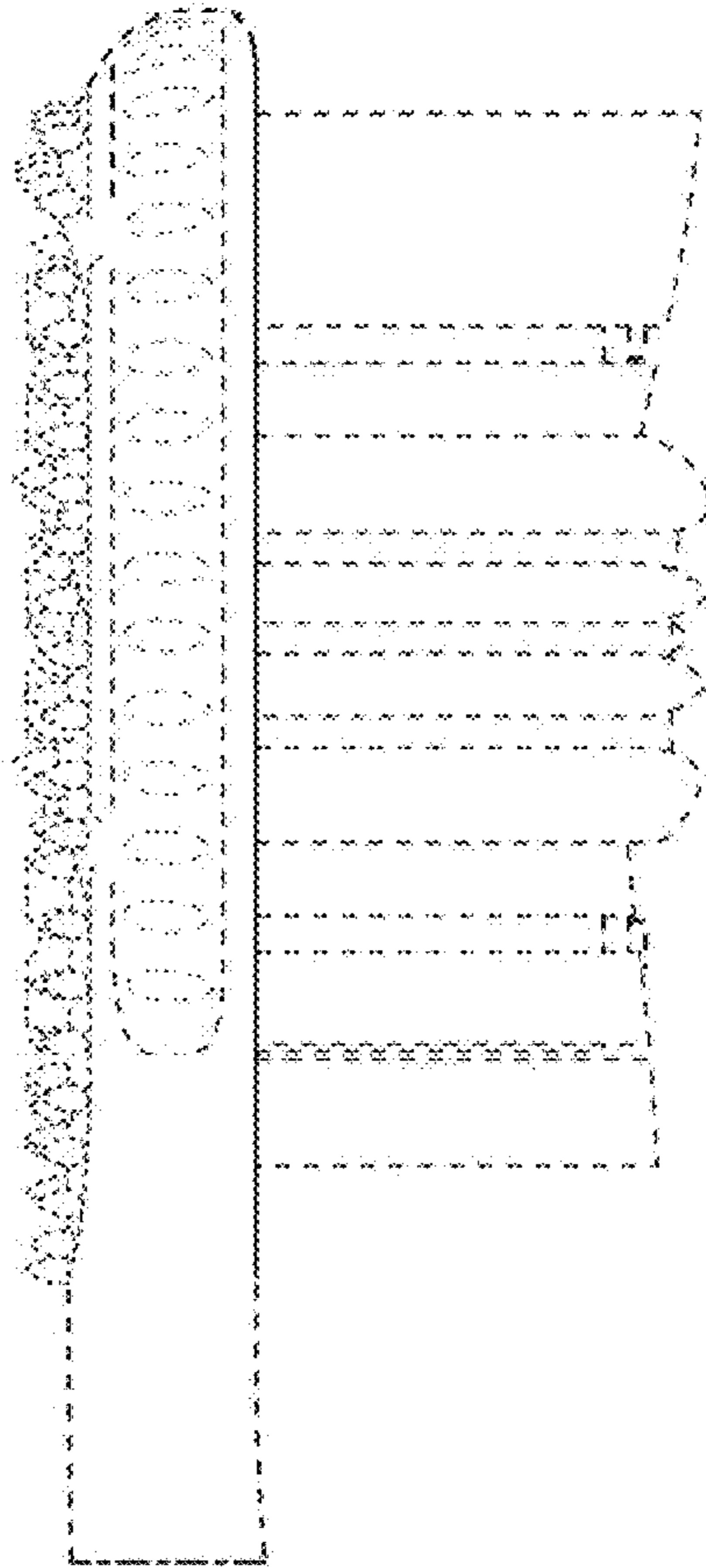

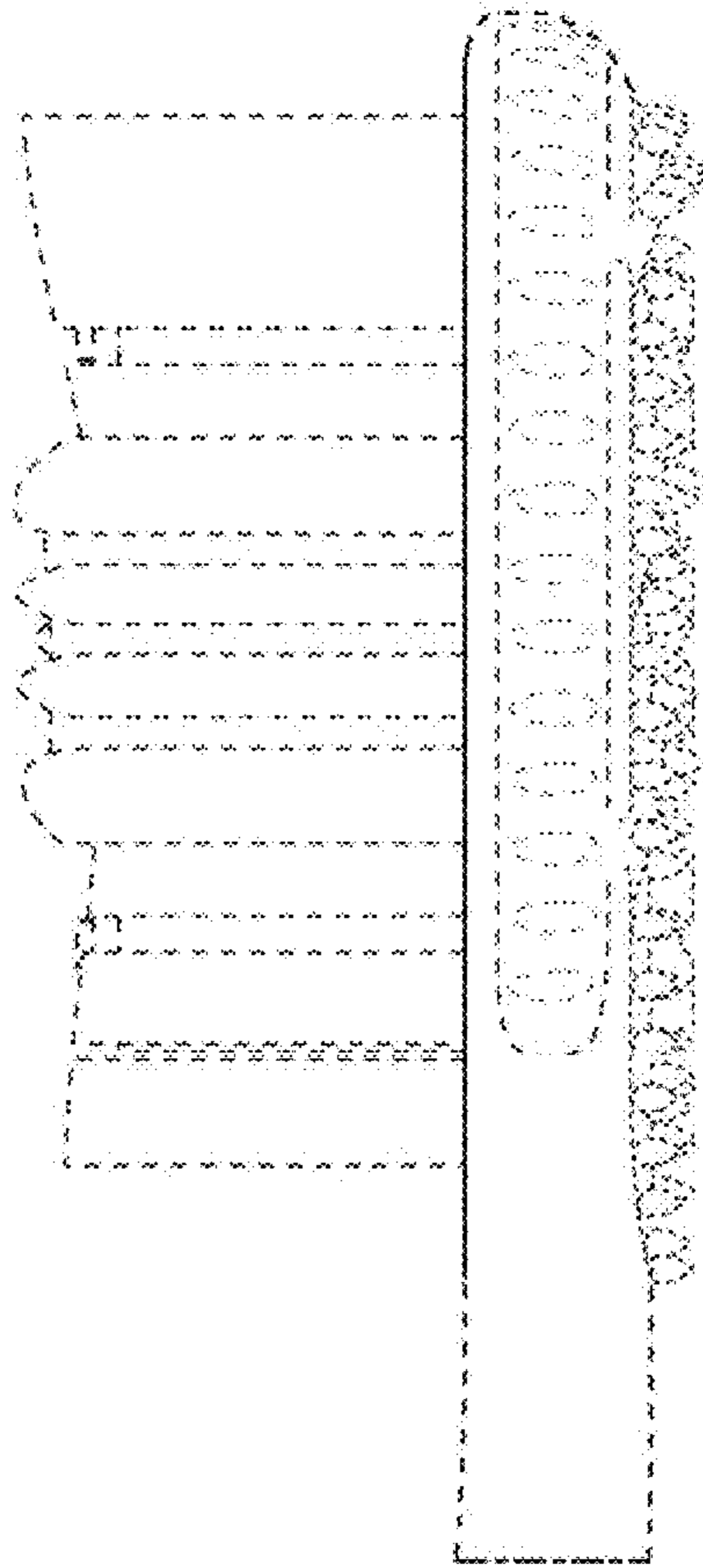

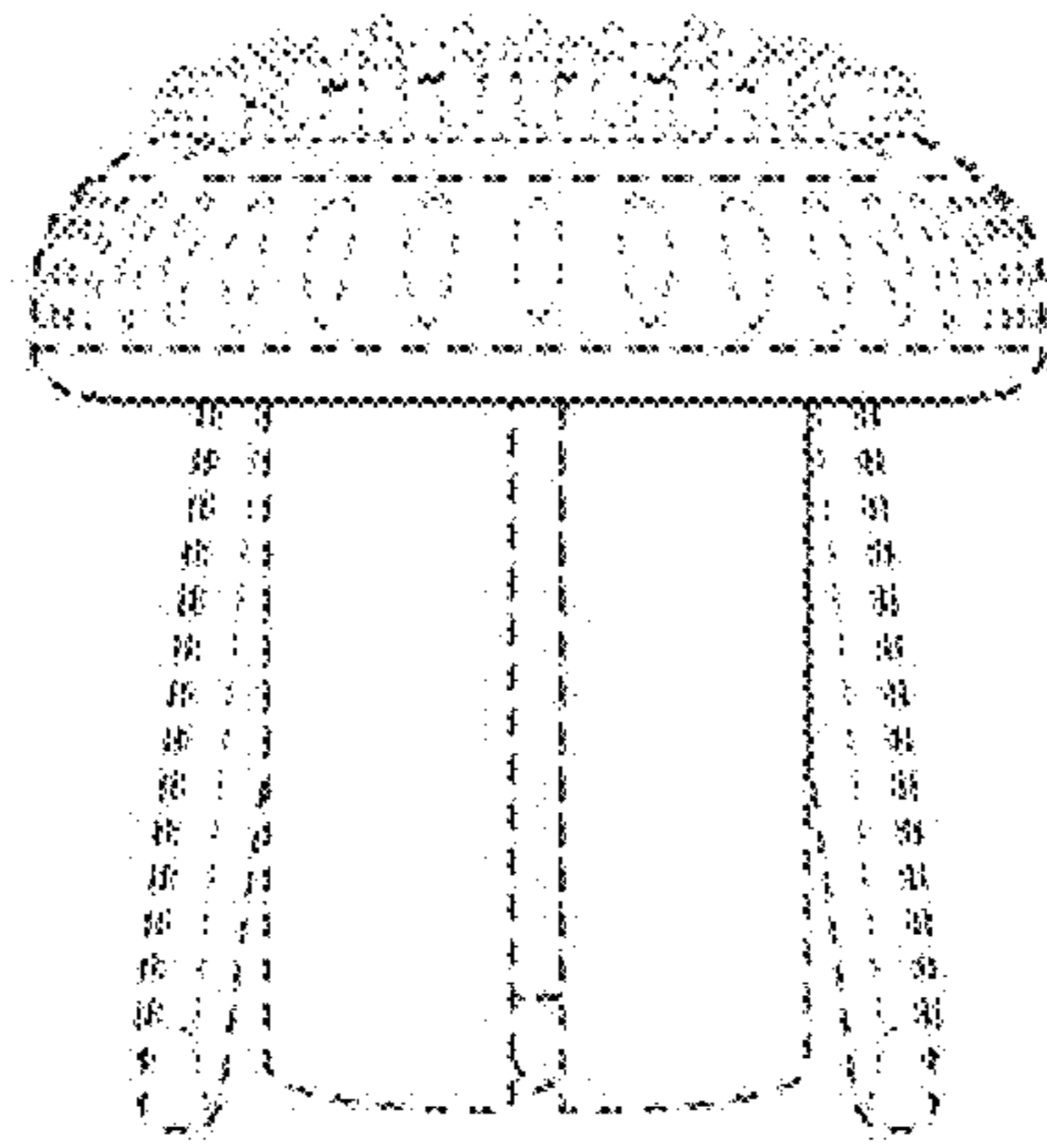

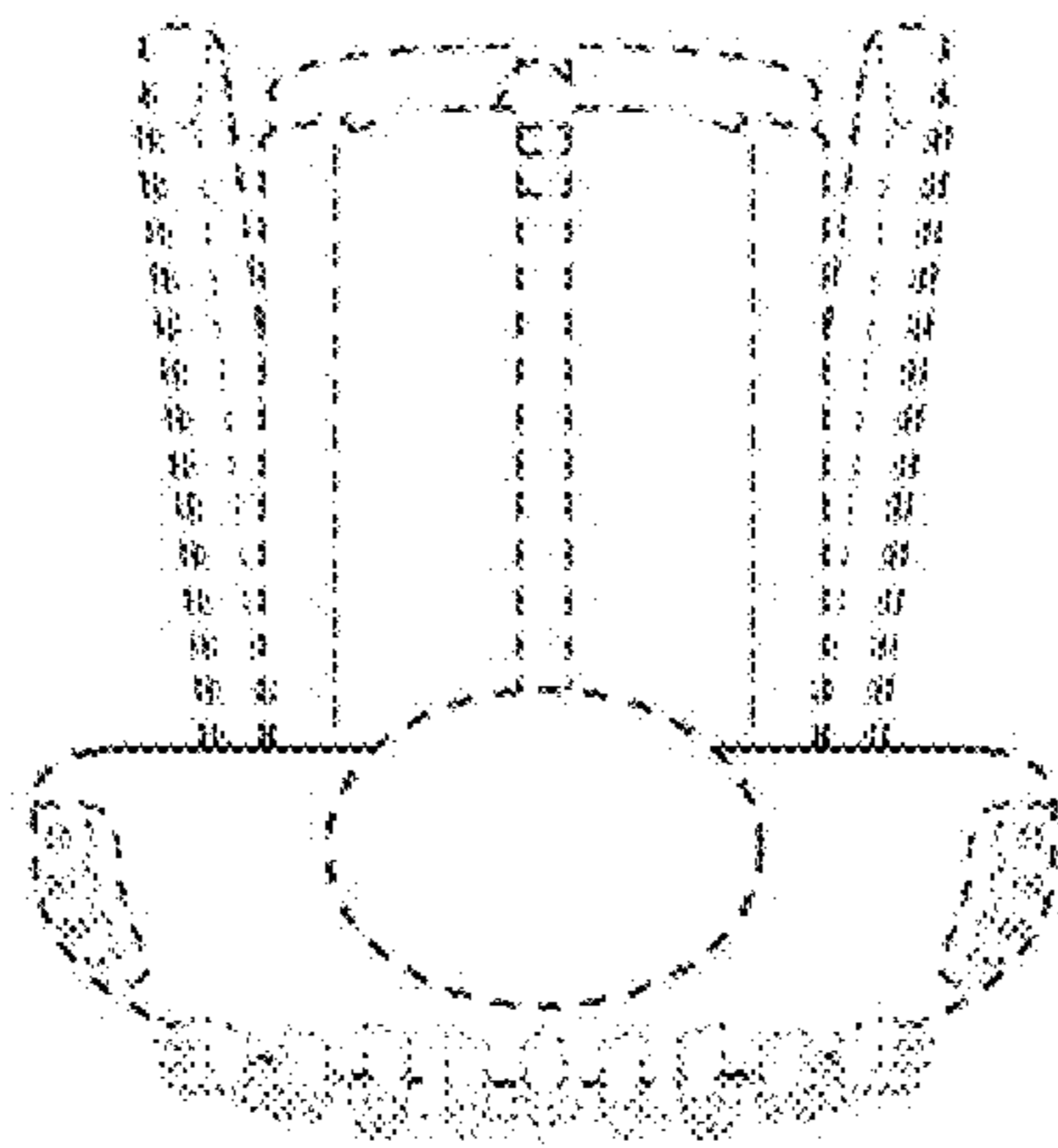

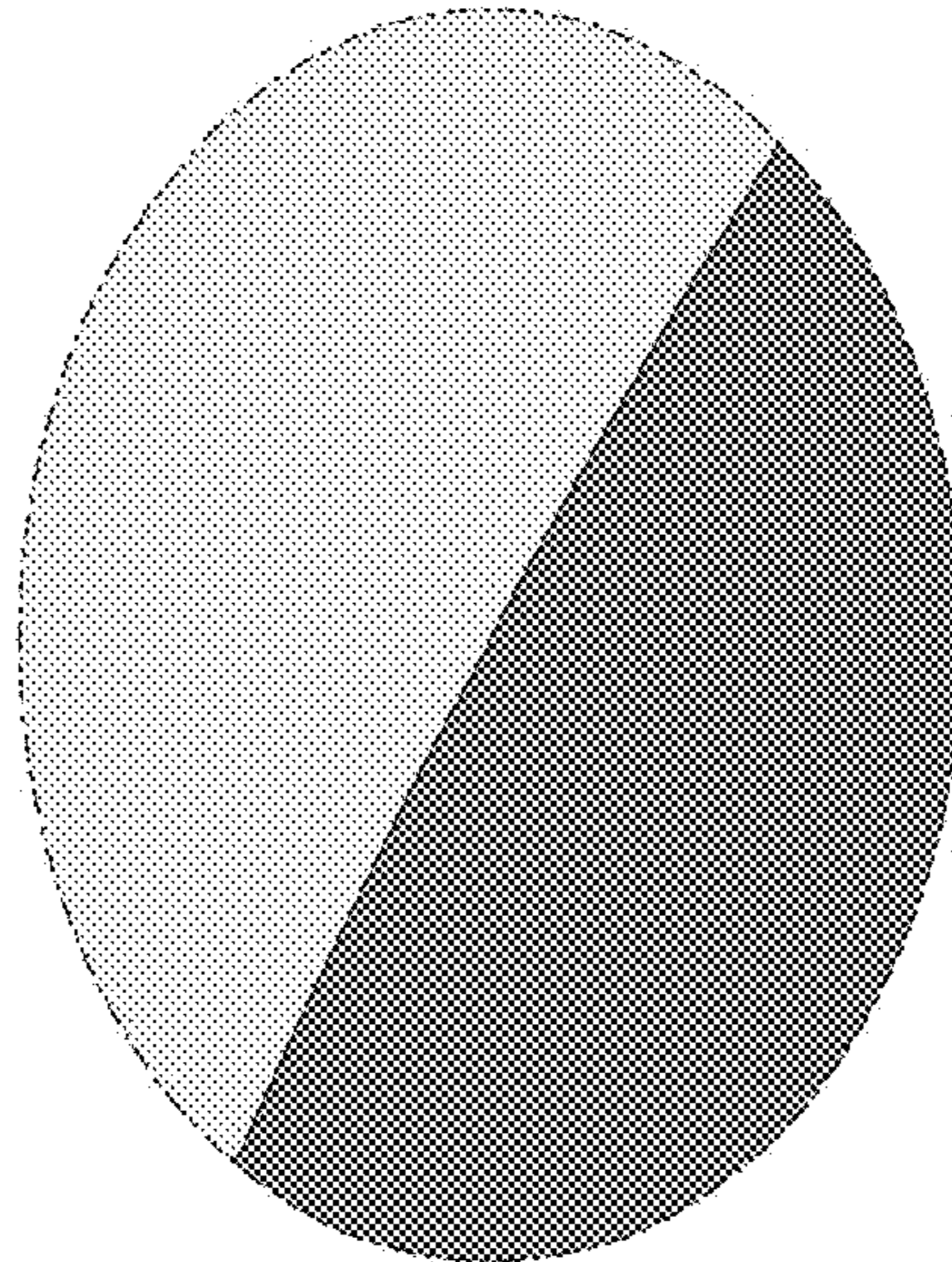
