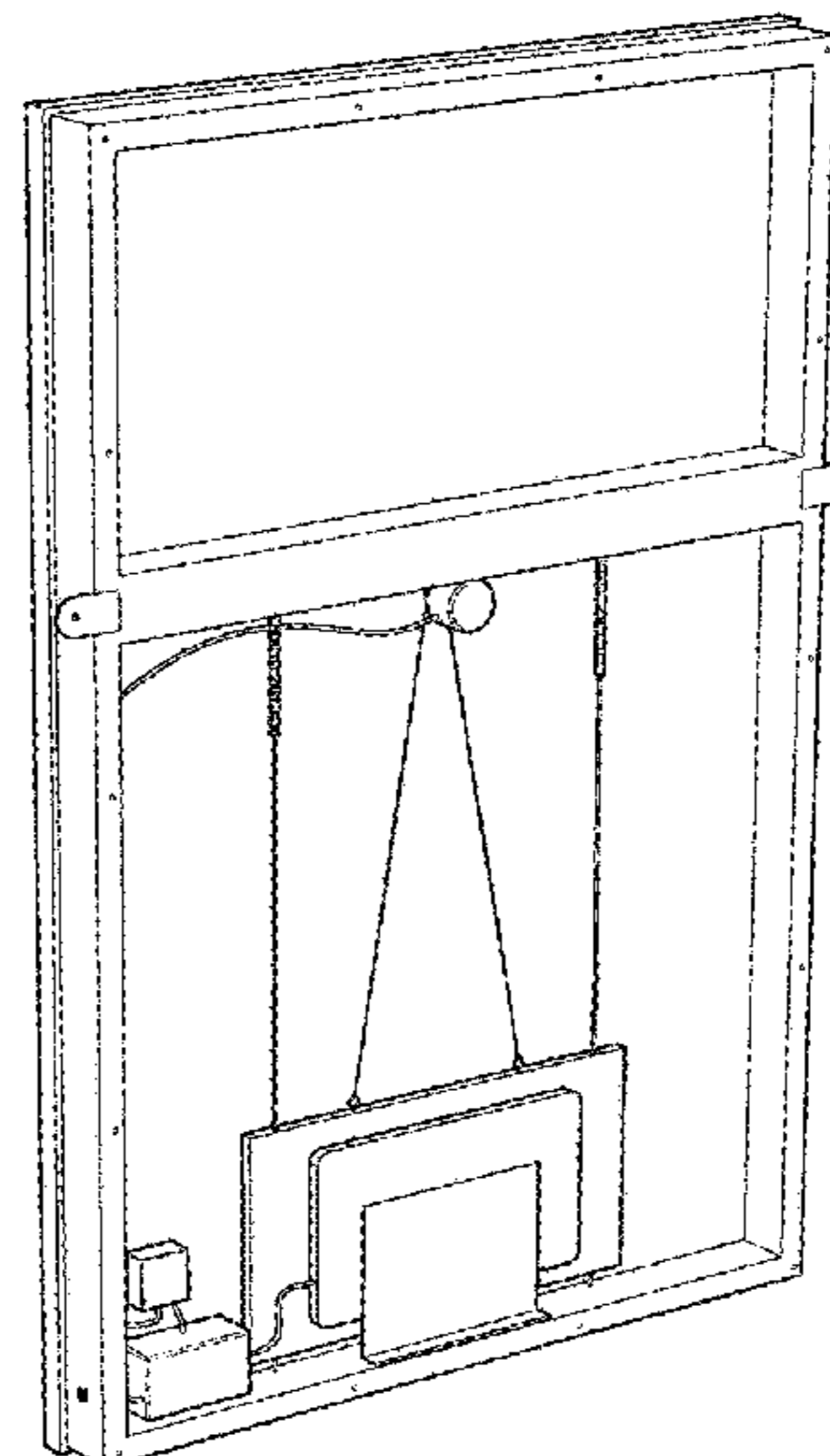
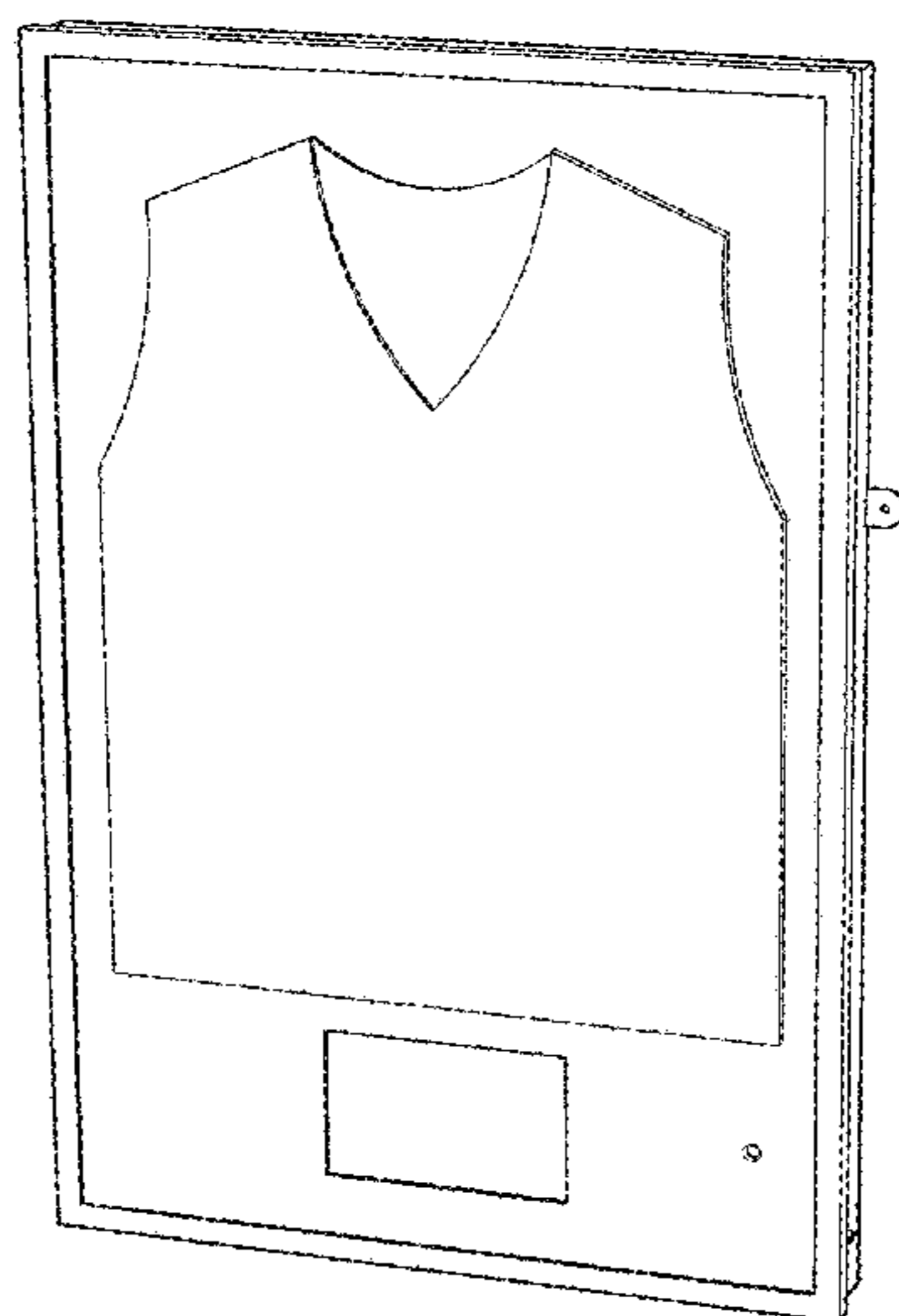
(57) **CLAIM**

The ornamental design for a memorabilia display, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a memorabilia display; FIG. 2 is a rear perspective view thereof; FIG. 3 is a rear perspective view thereof, shown without a back cover; FIG. 4 is a rear perspective view thereof, shown in an alternate position; FIG. 5 is a front elevational view of the design shown in FIG. 1; FIG. 6 is a rear elevational view of the design shown in FIG. 4; FIG. 7 is a right side view of the design shown in FIG. 1; FIG. 8 is a cross-sectional view thereof, taken along line 8-8 of FIG. 5; and, FIG. 9 is a cross-sectional view of the design shown in FIG. 4, taken along line 9-9 of FIG. 6.

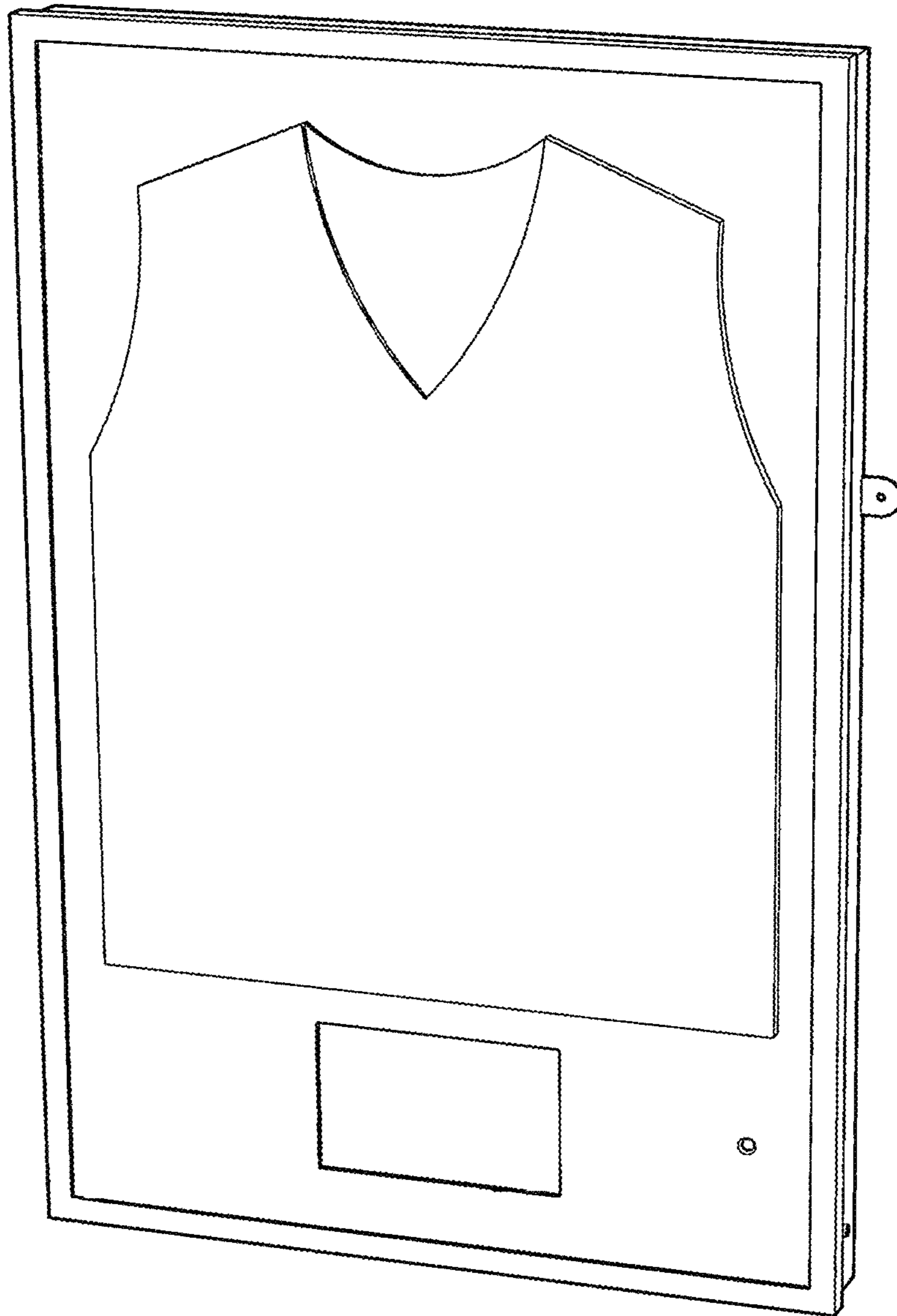

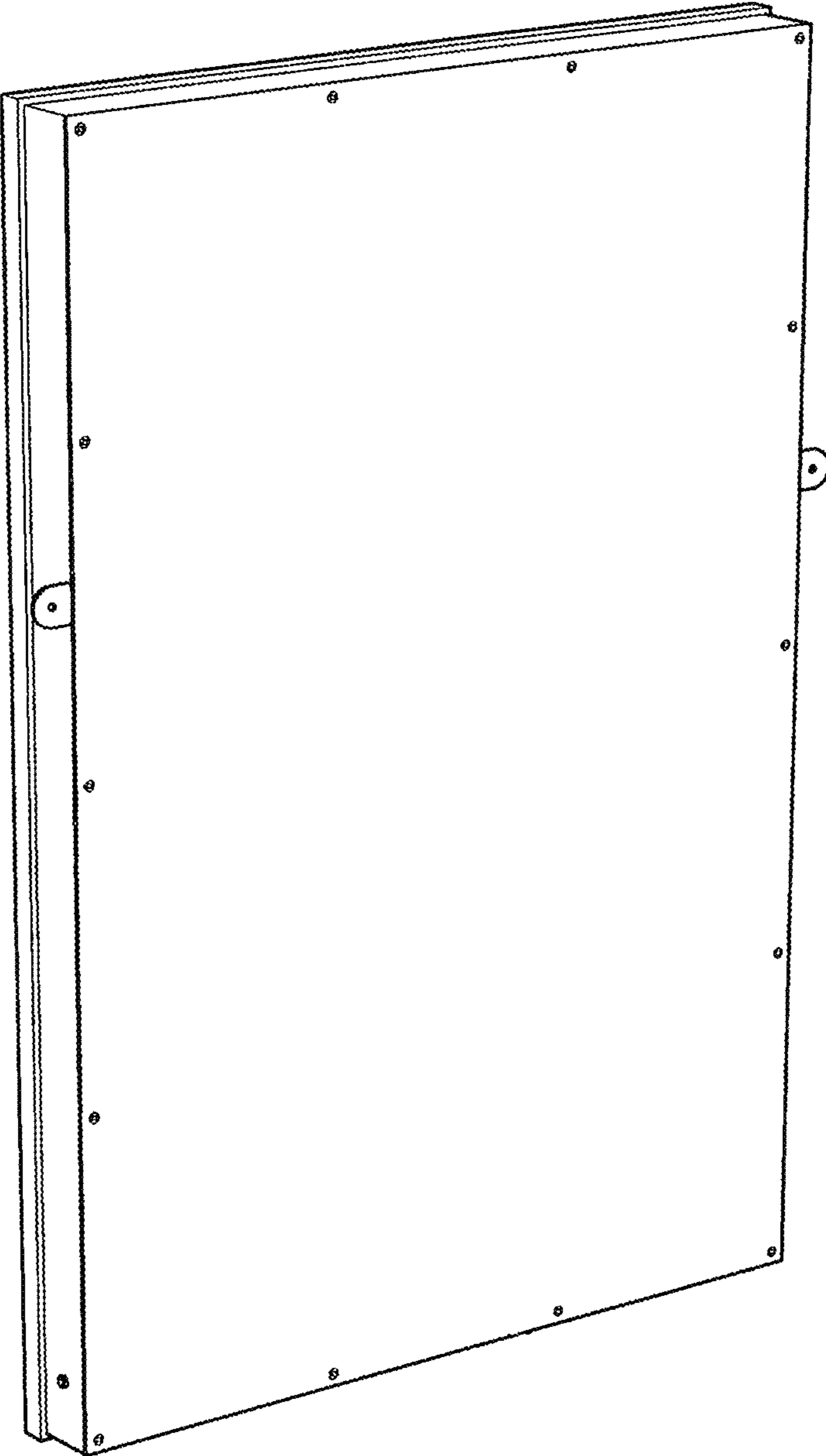

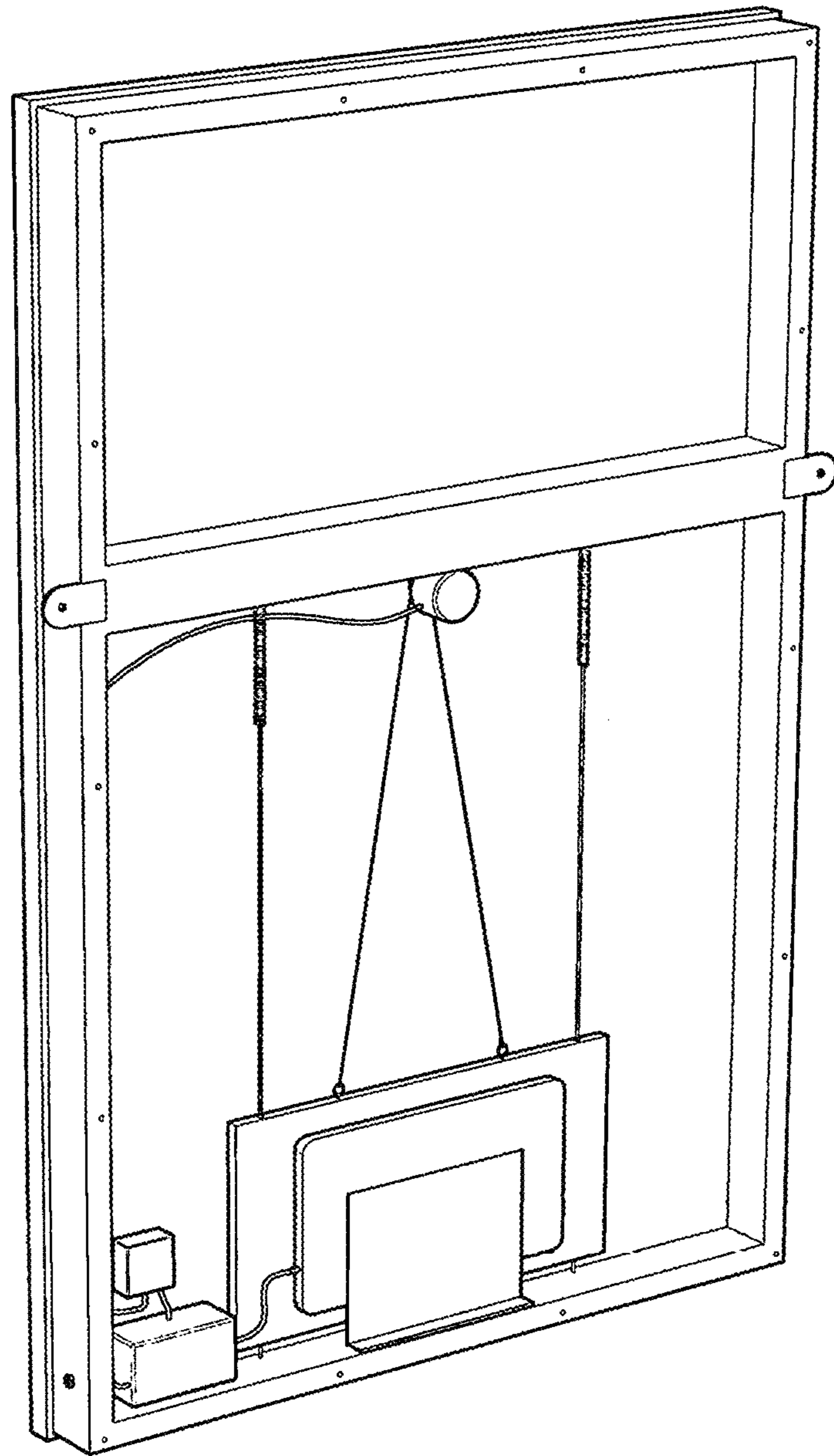

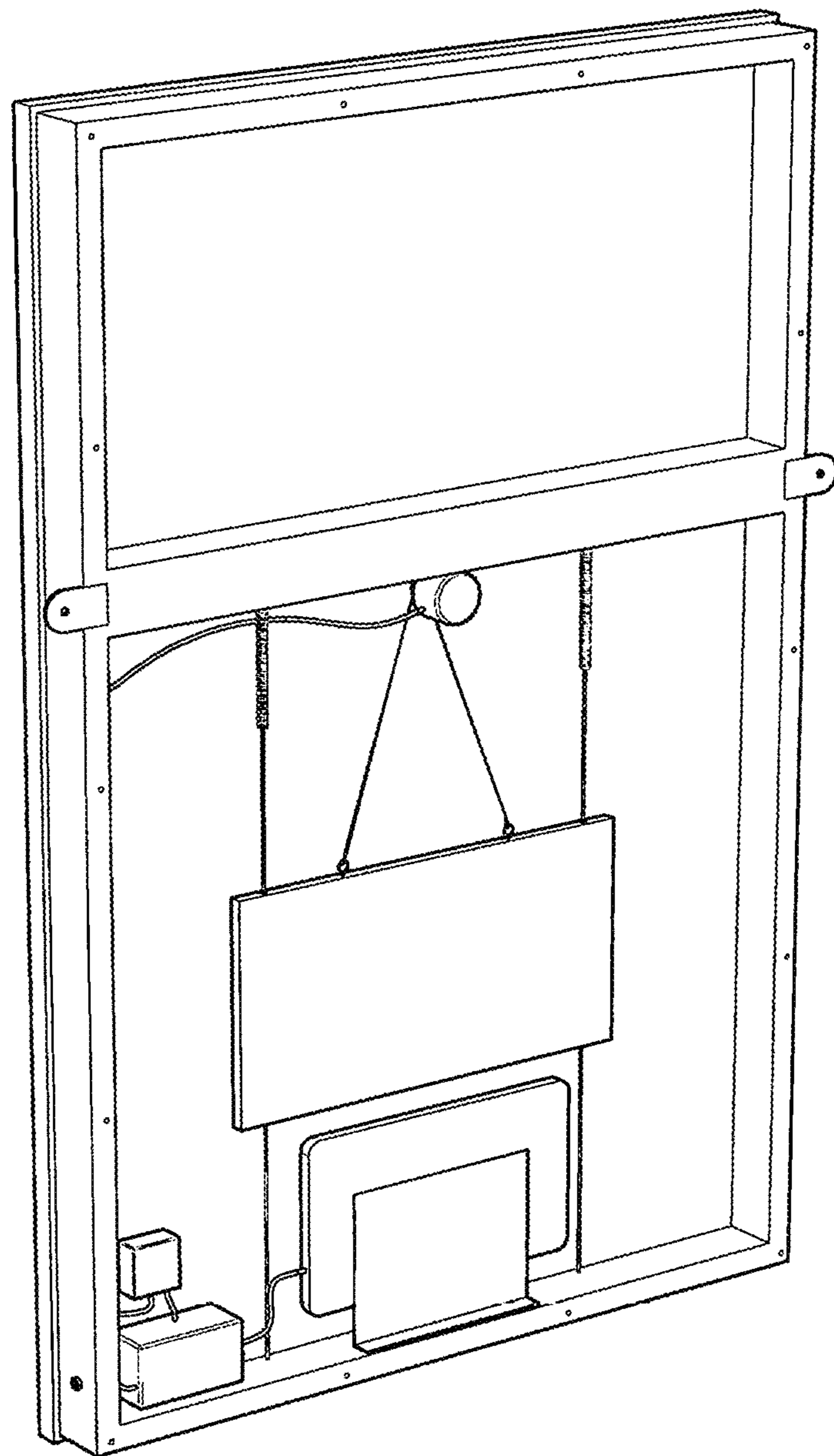

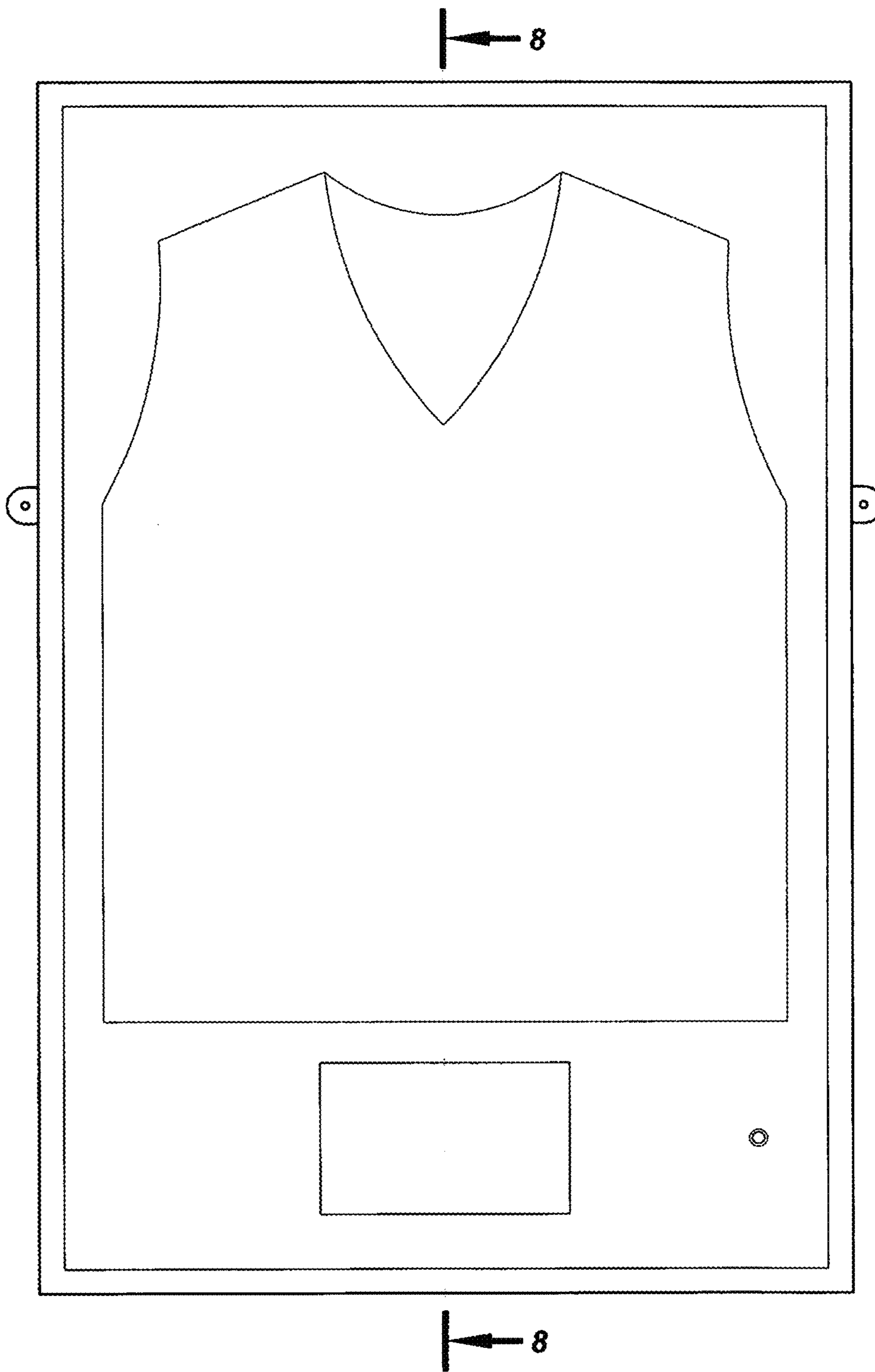

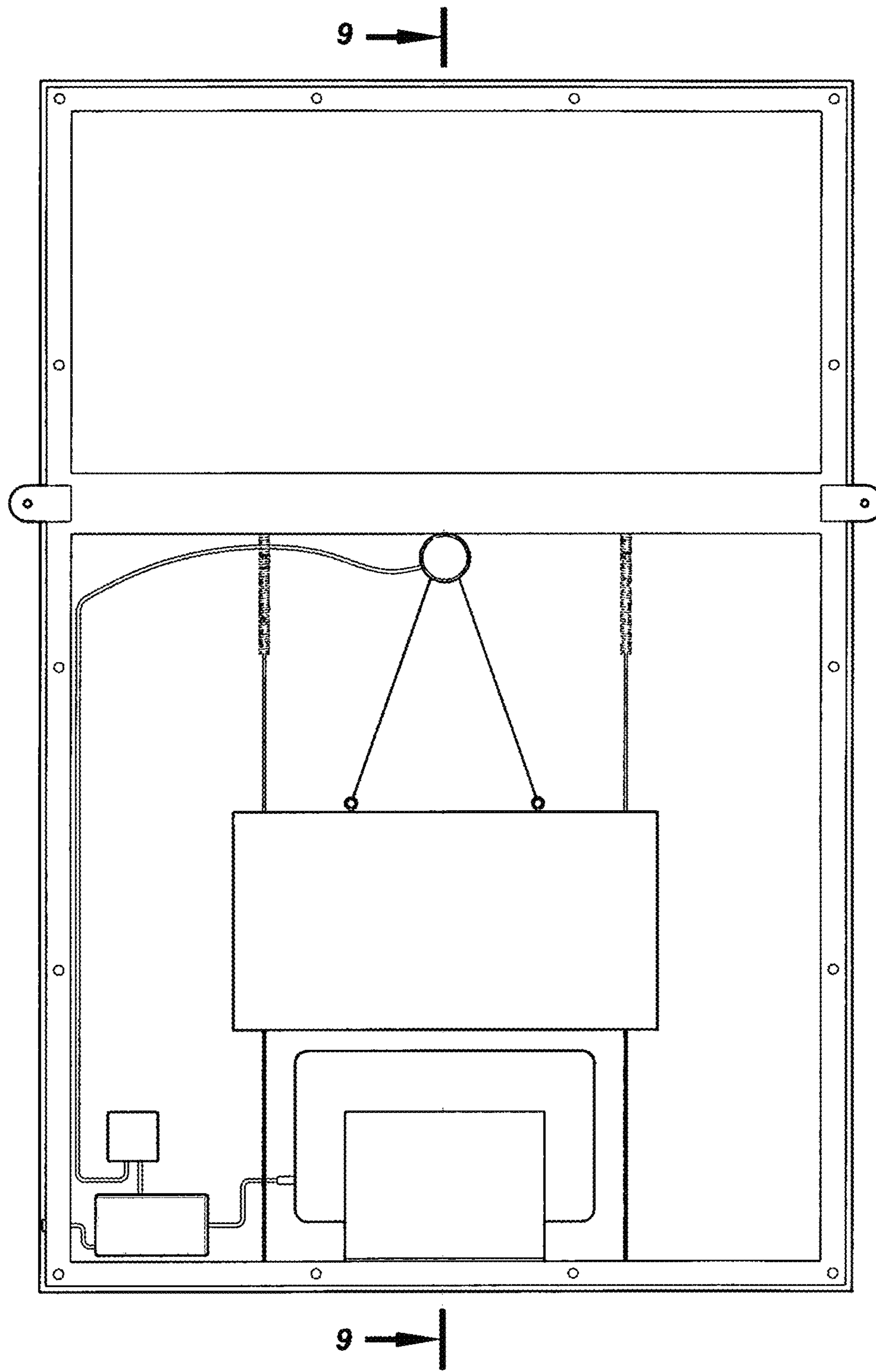

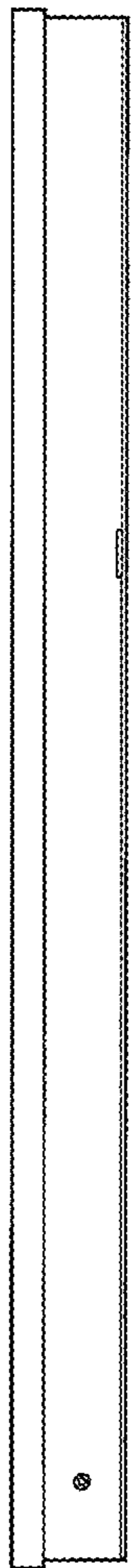

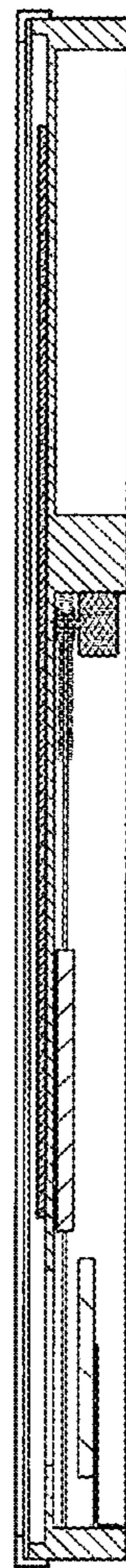
