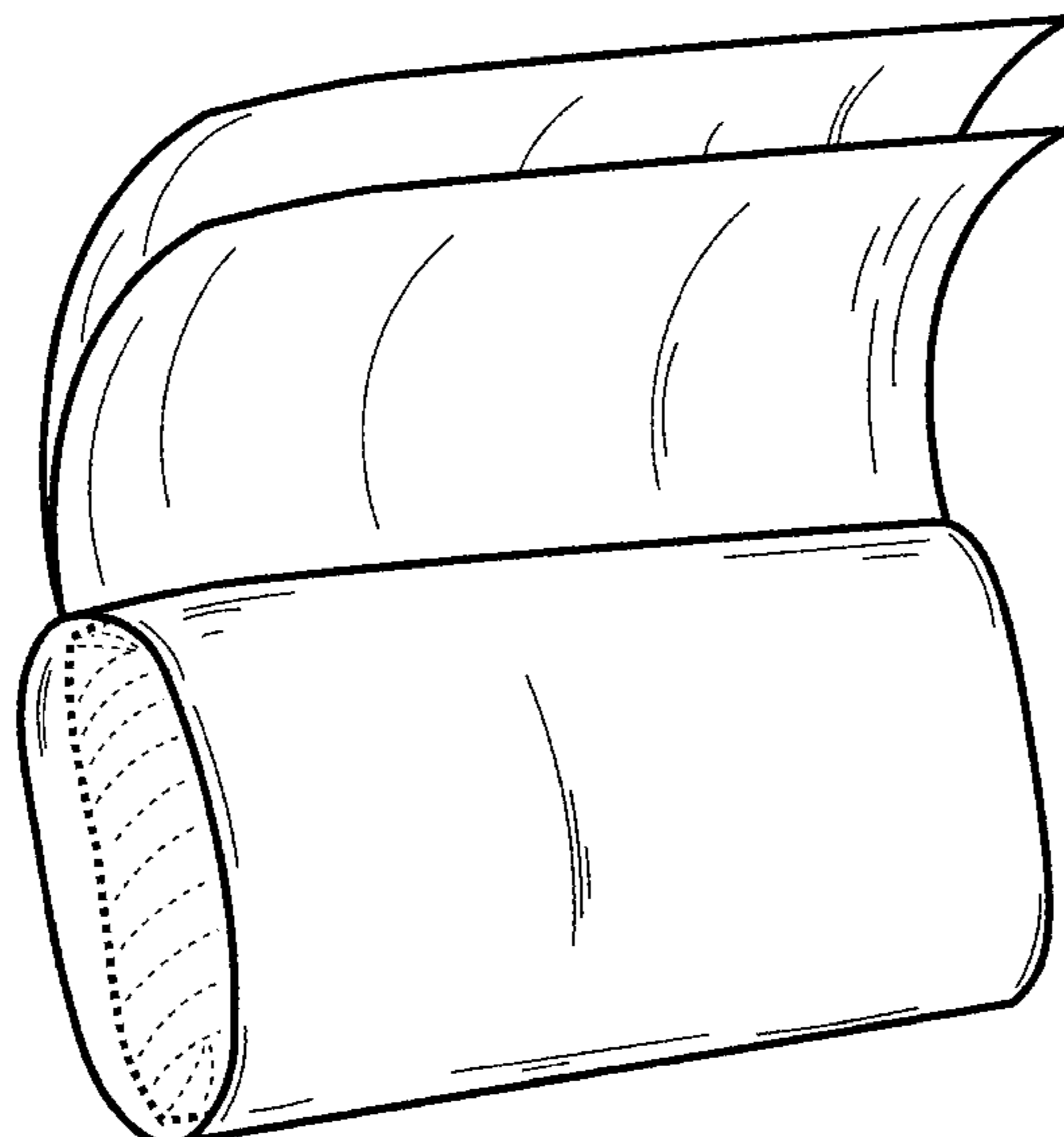
The ornamental design for a pillowcase, as shown and described.

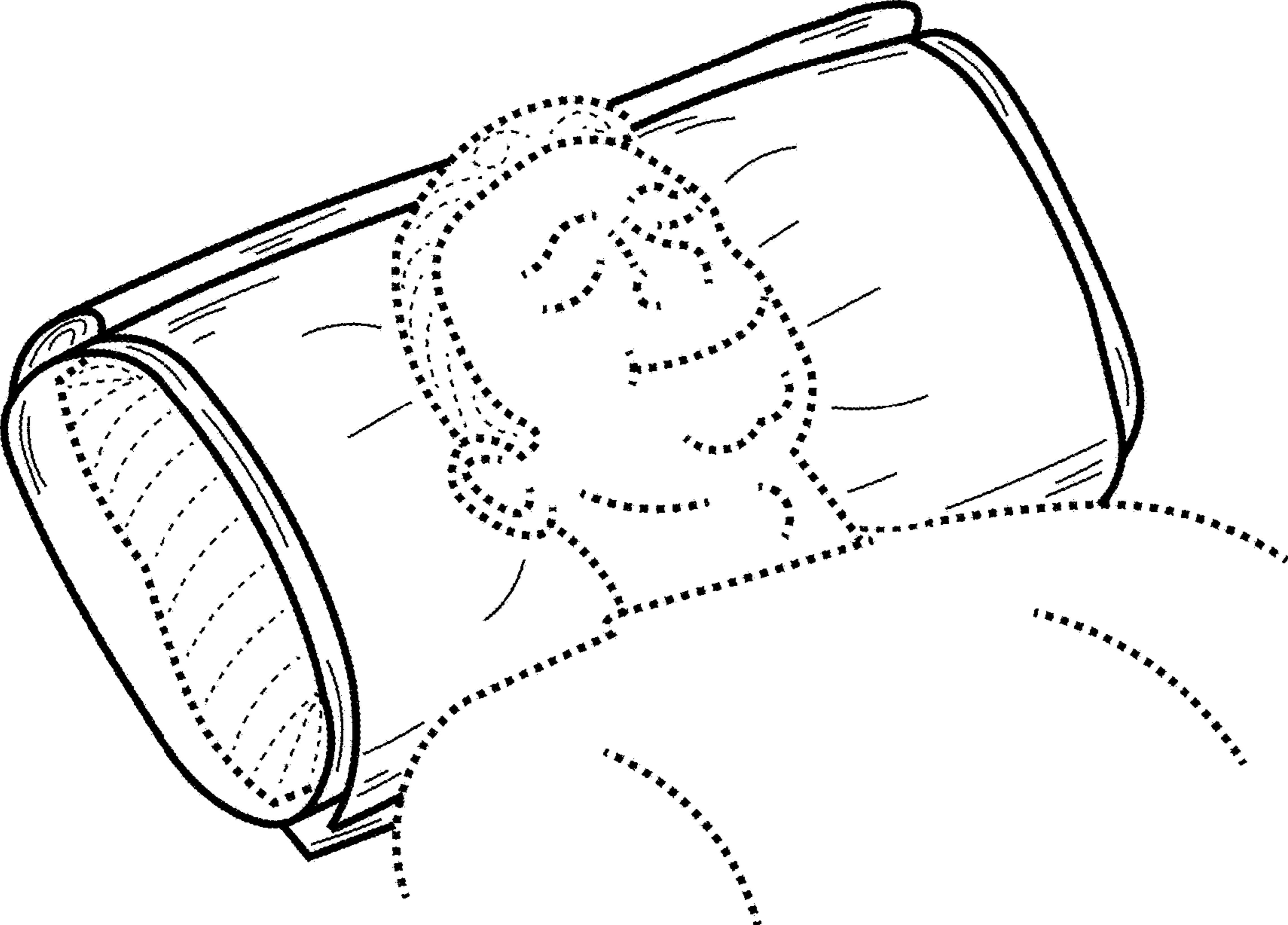

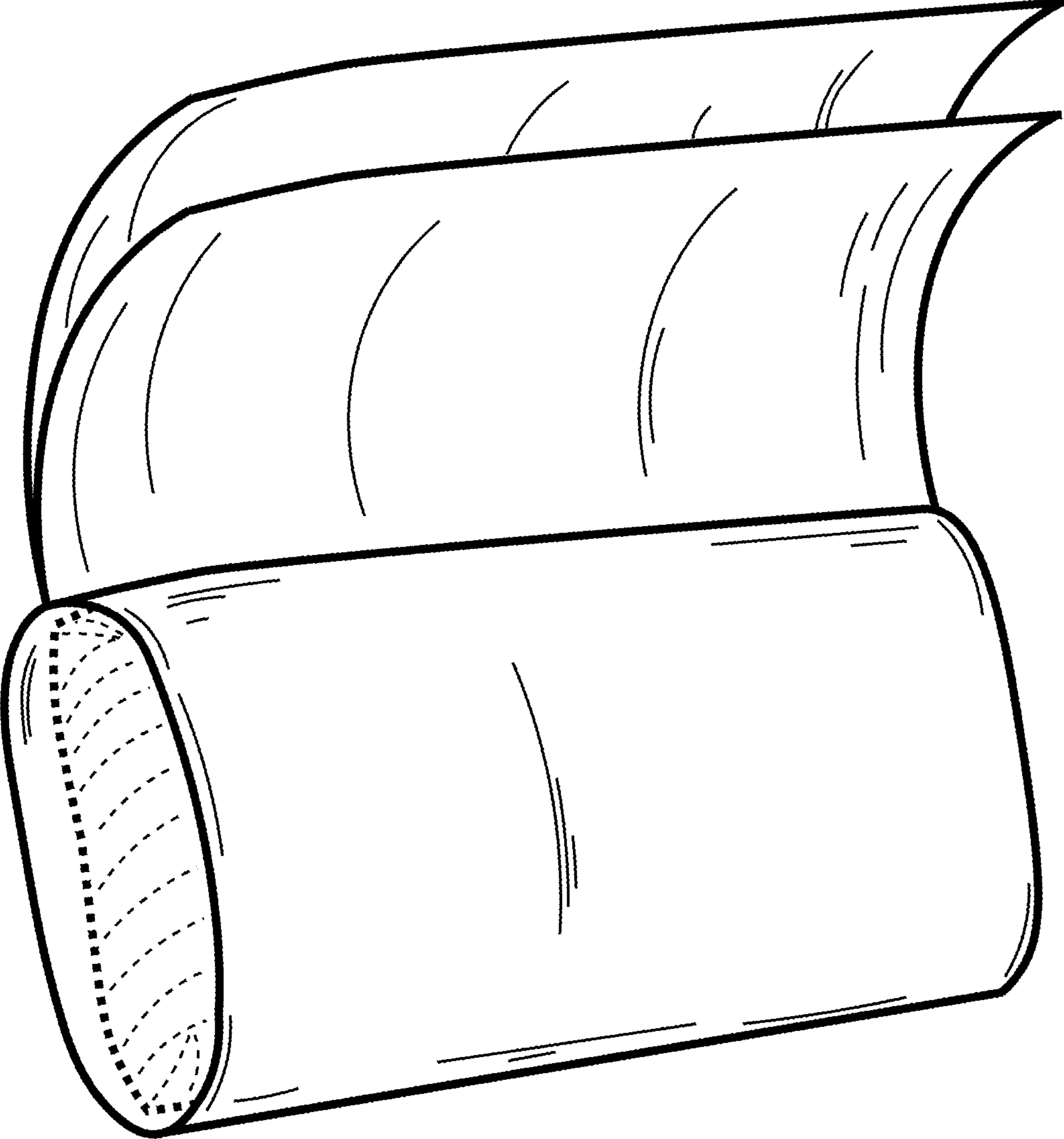
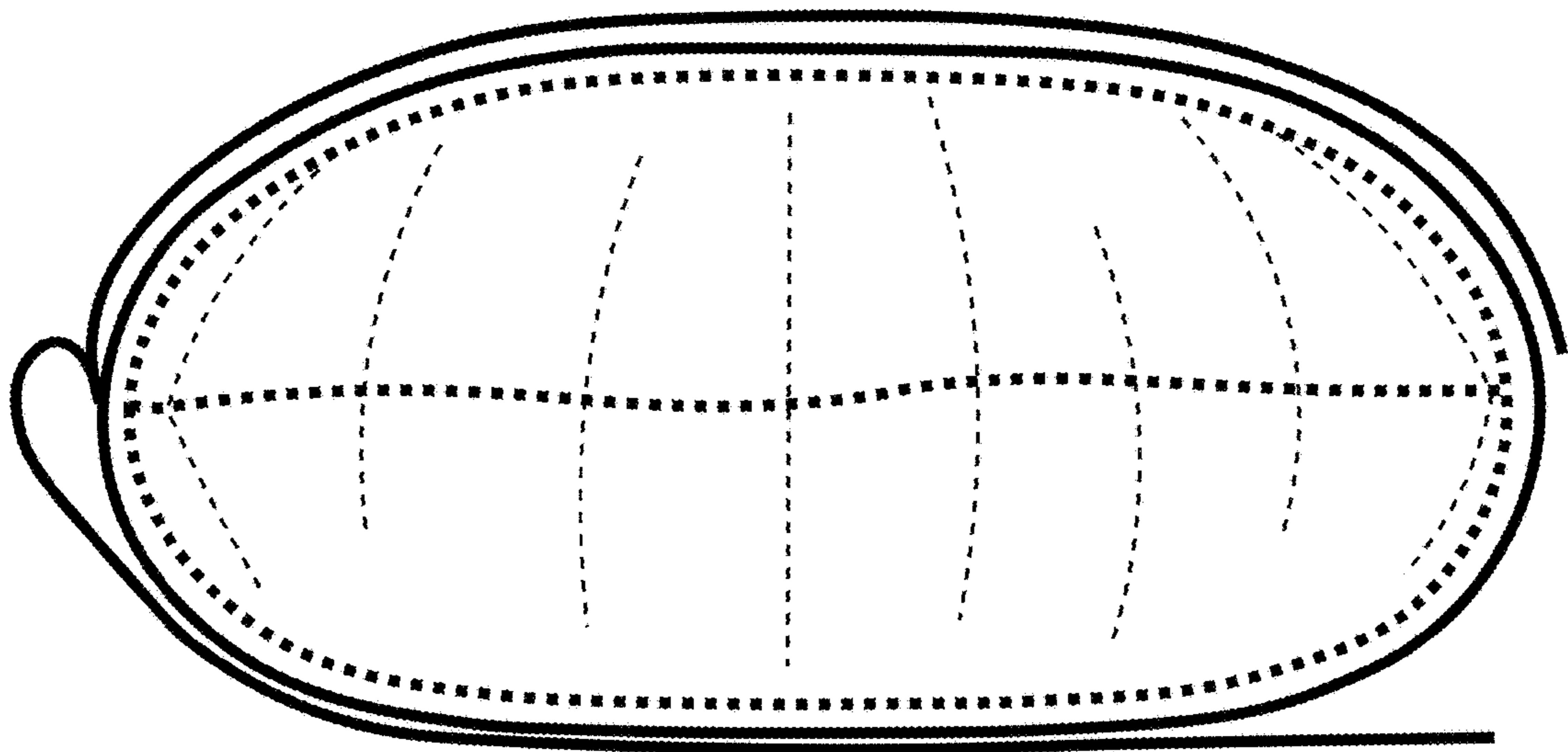
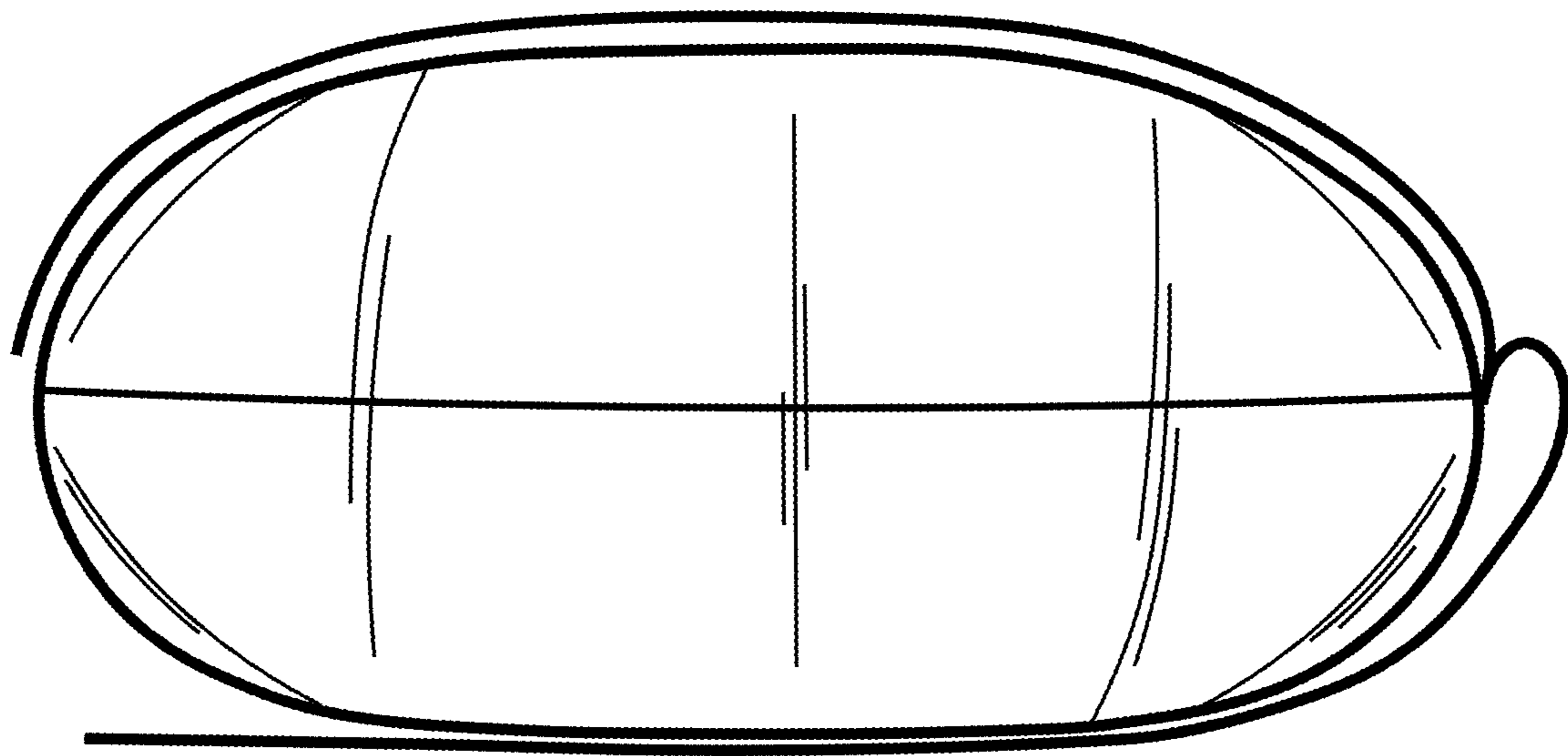

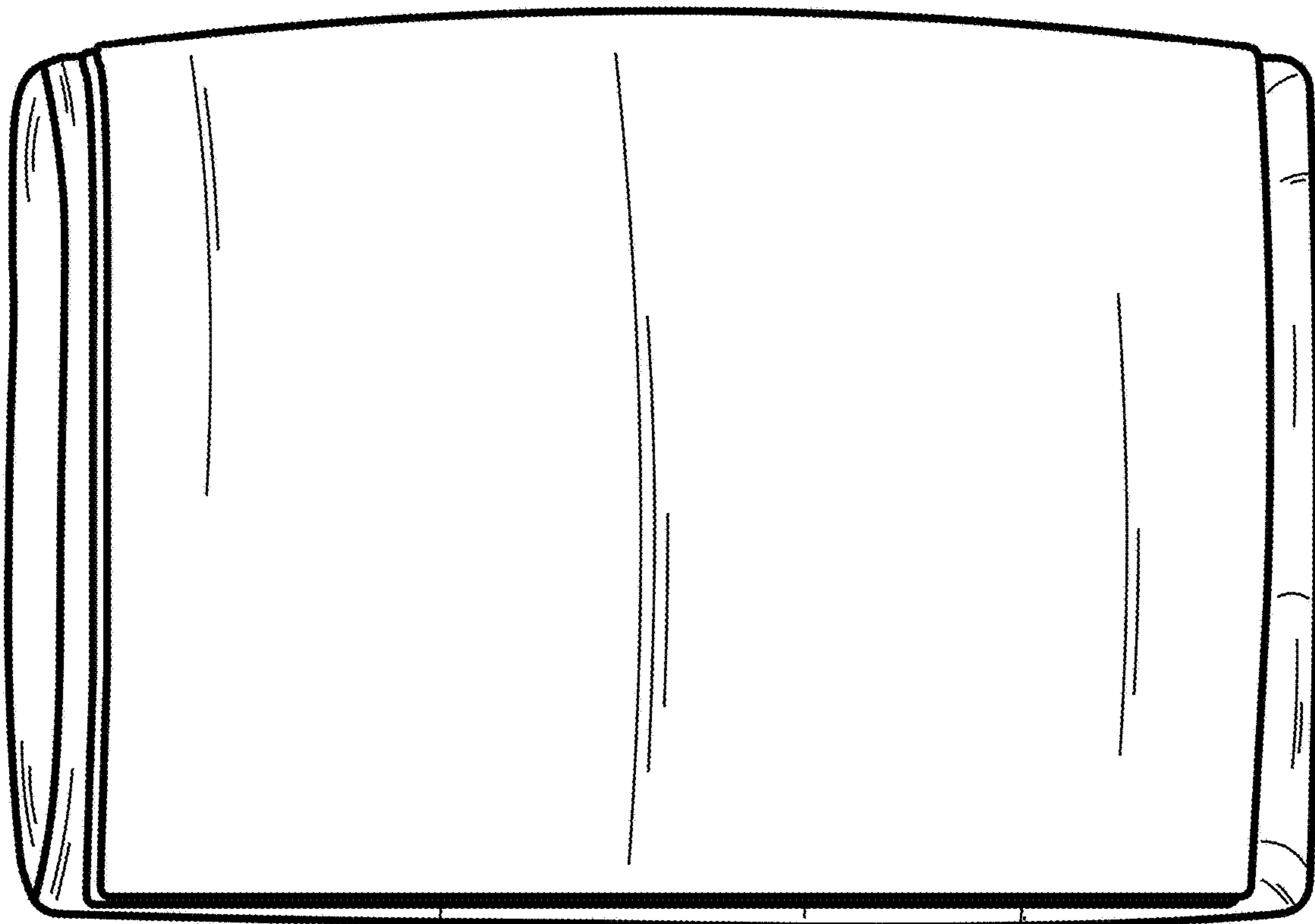
