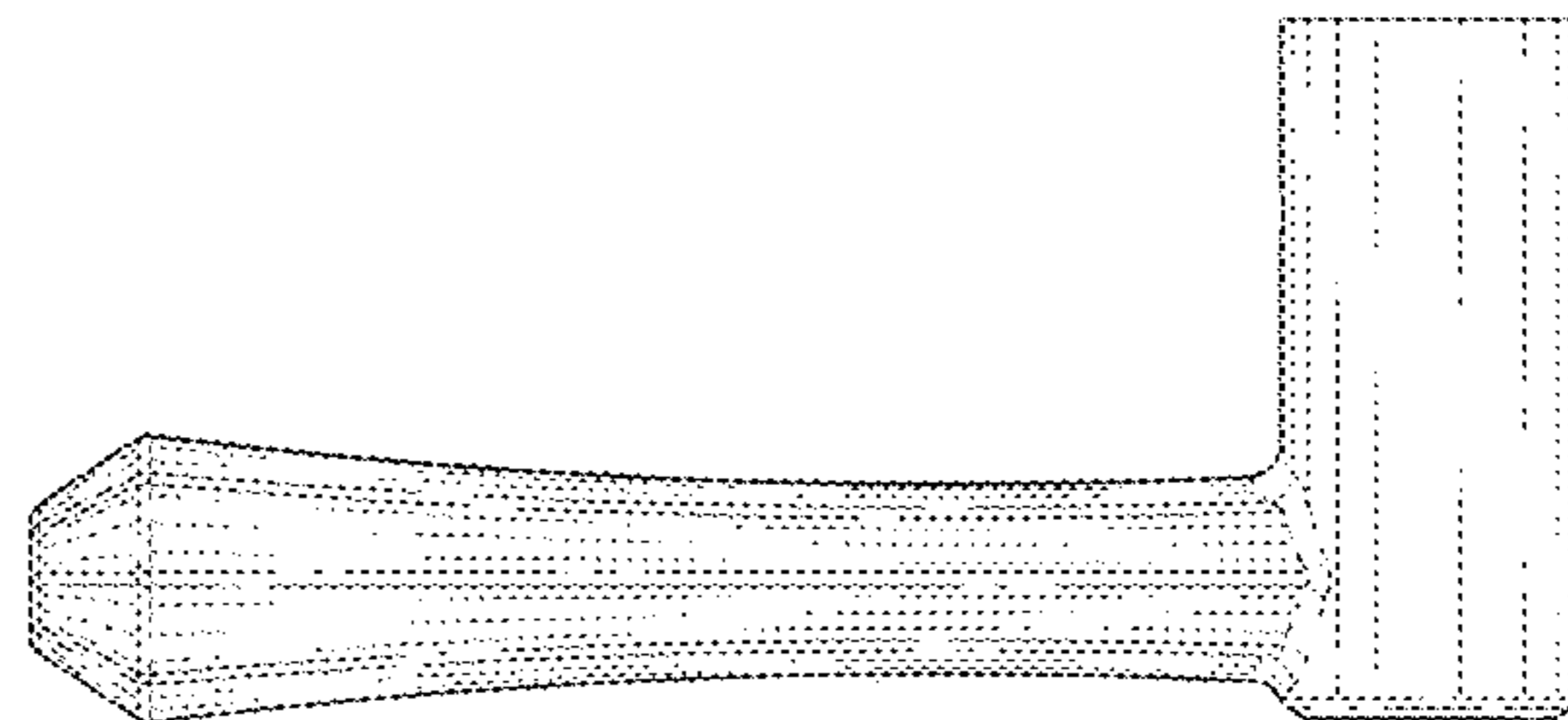
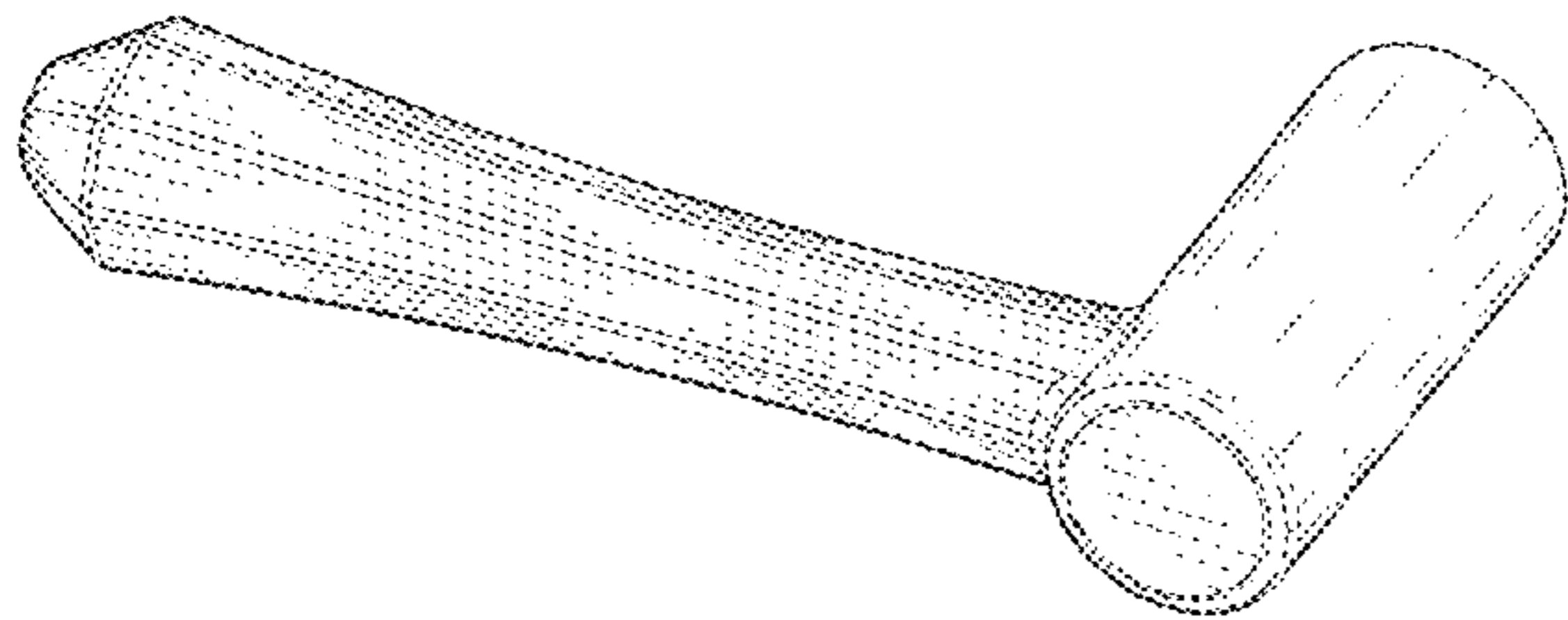
The ornamental design for a glam lever, as shown and

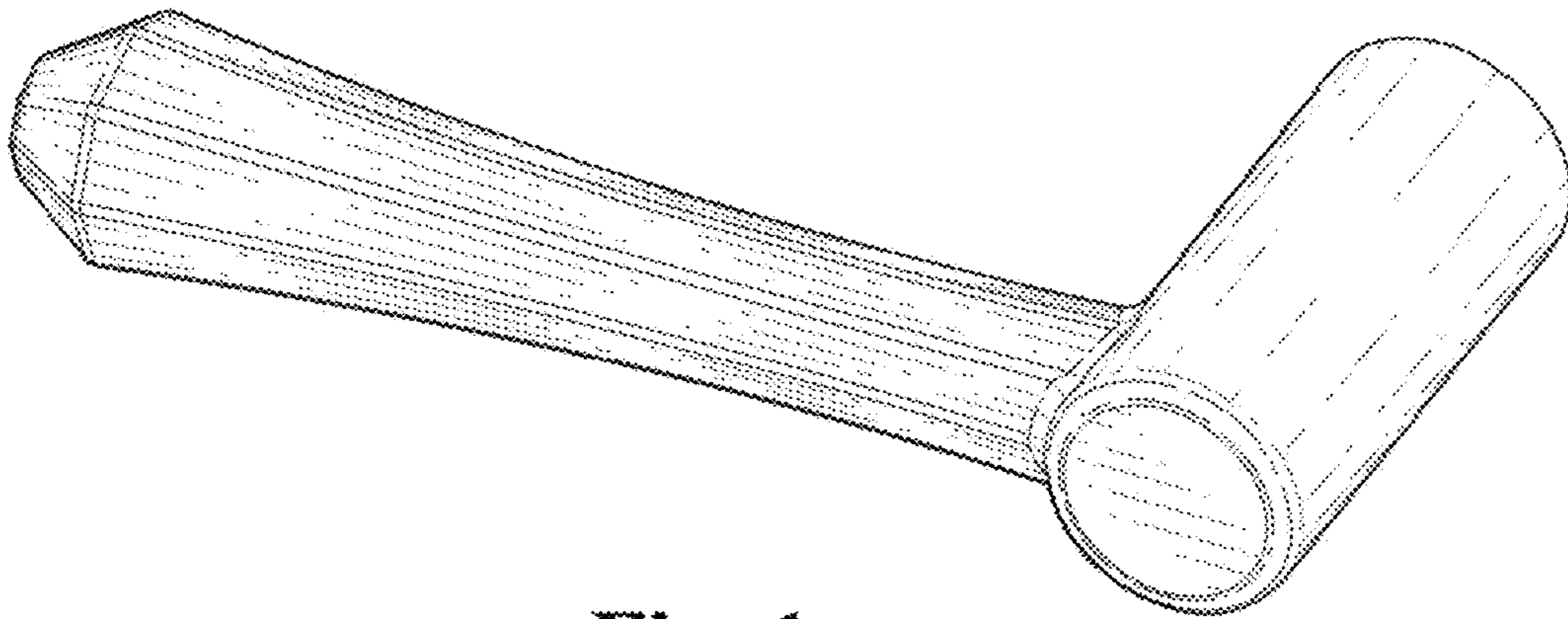

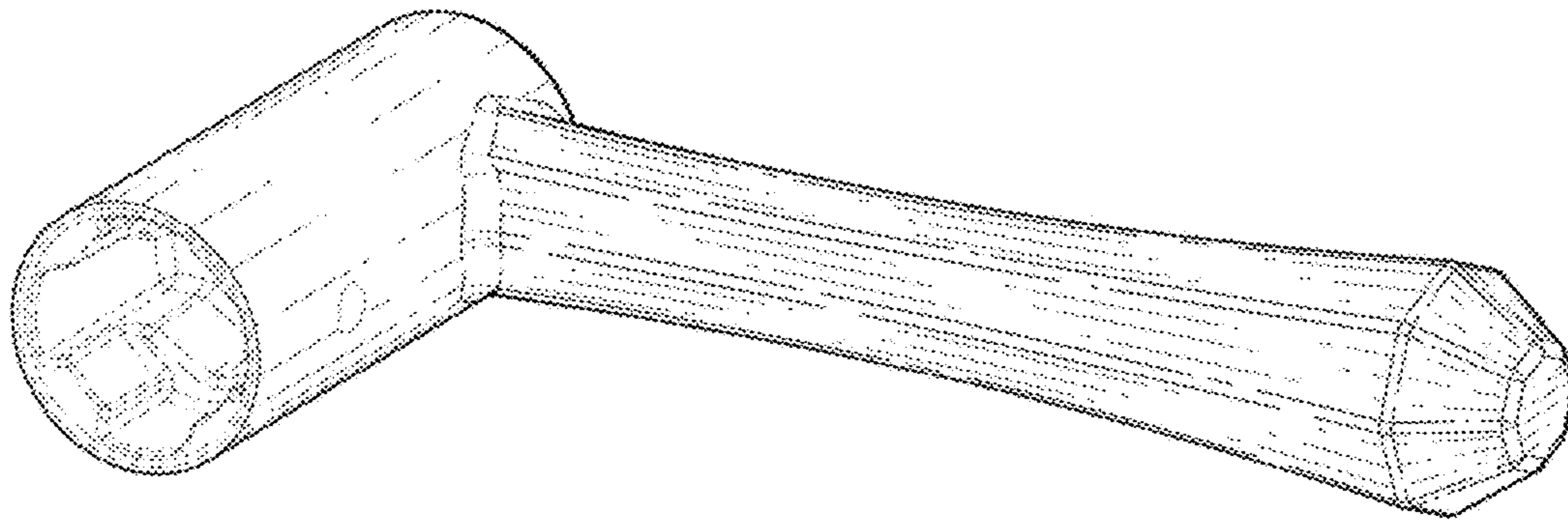

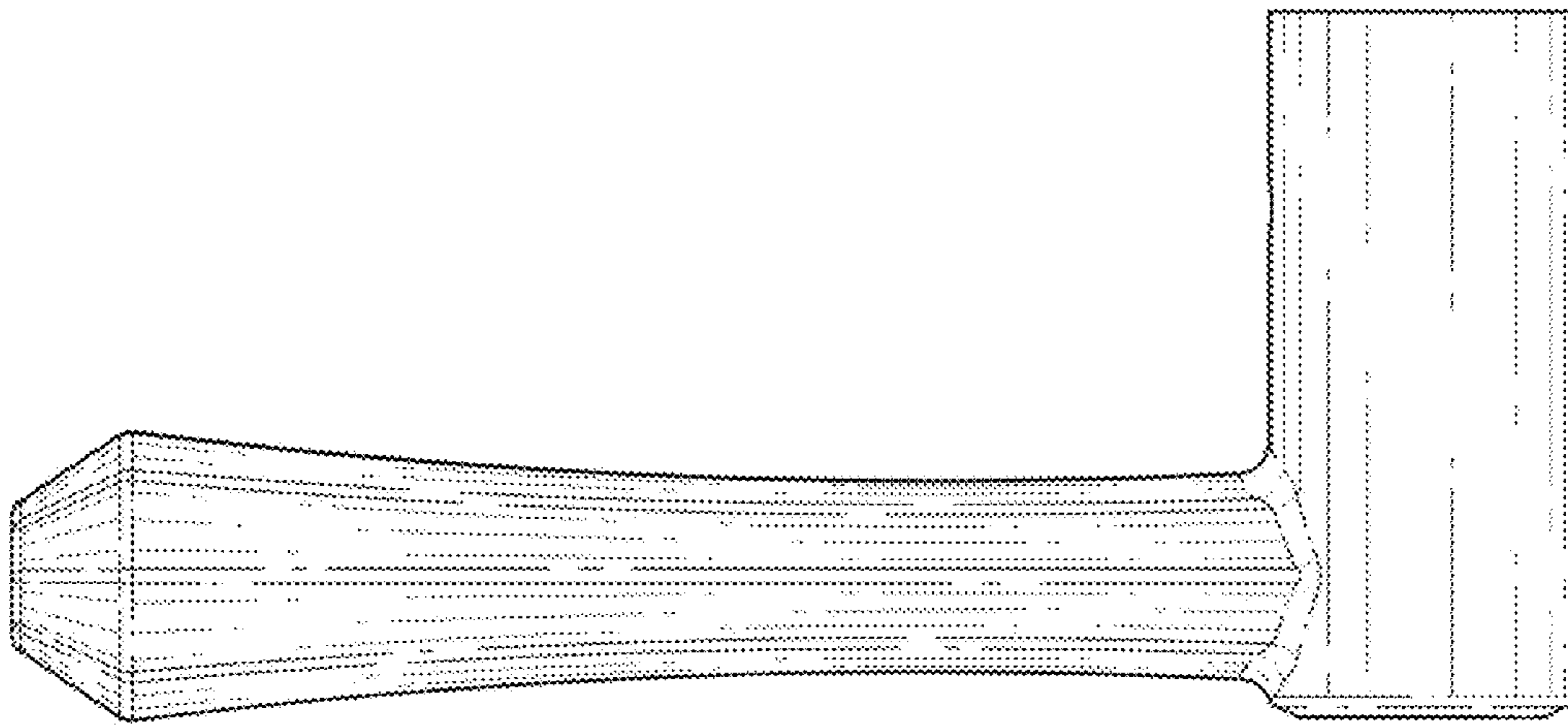

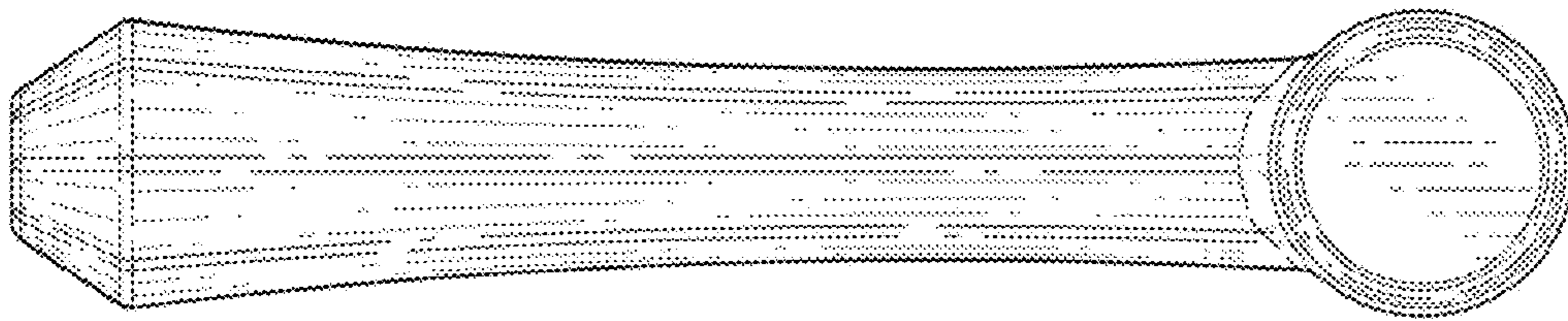

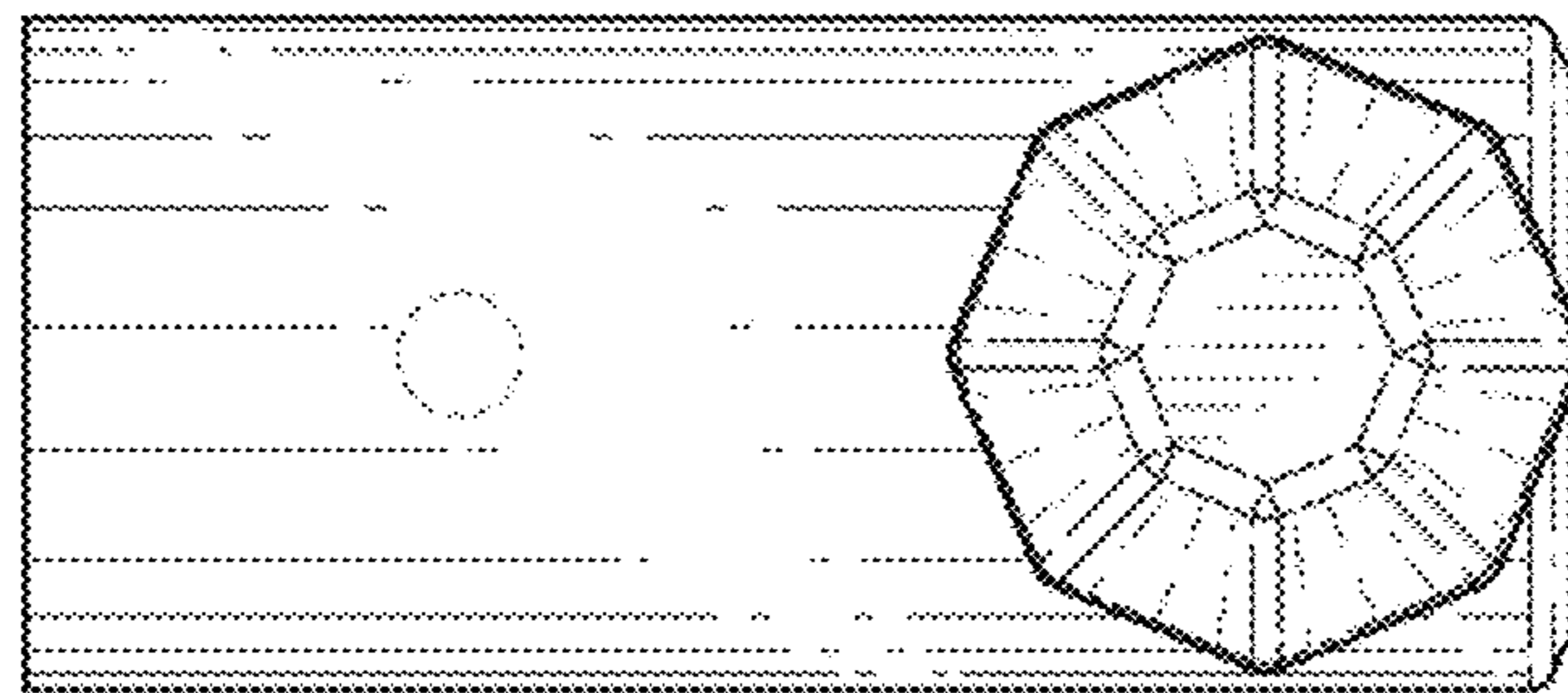

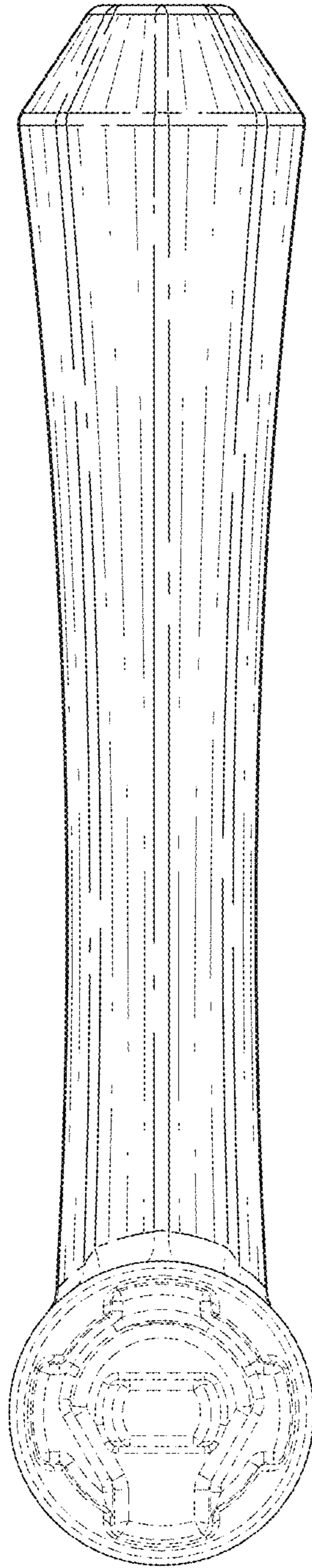
