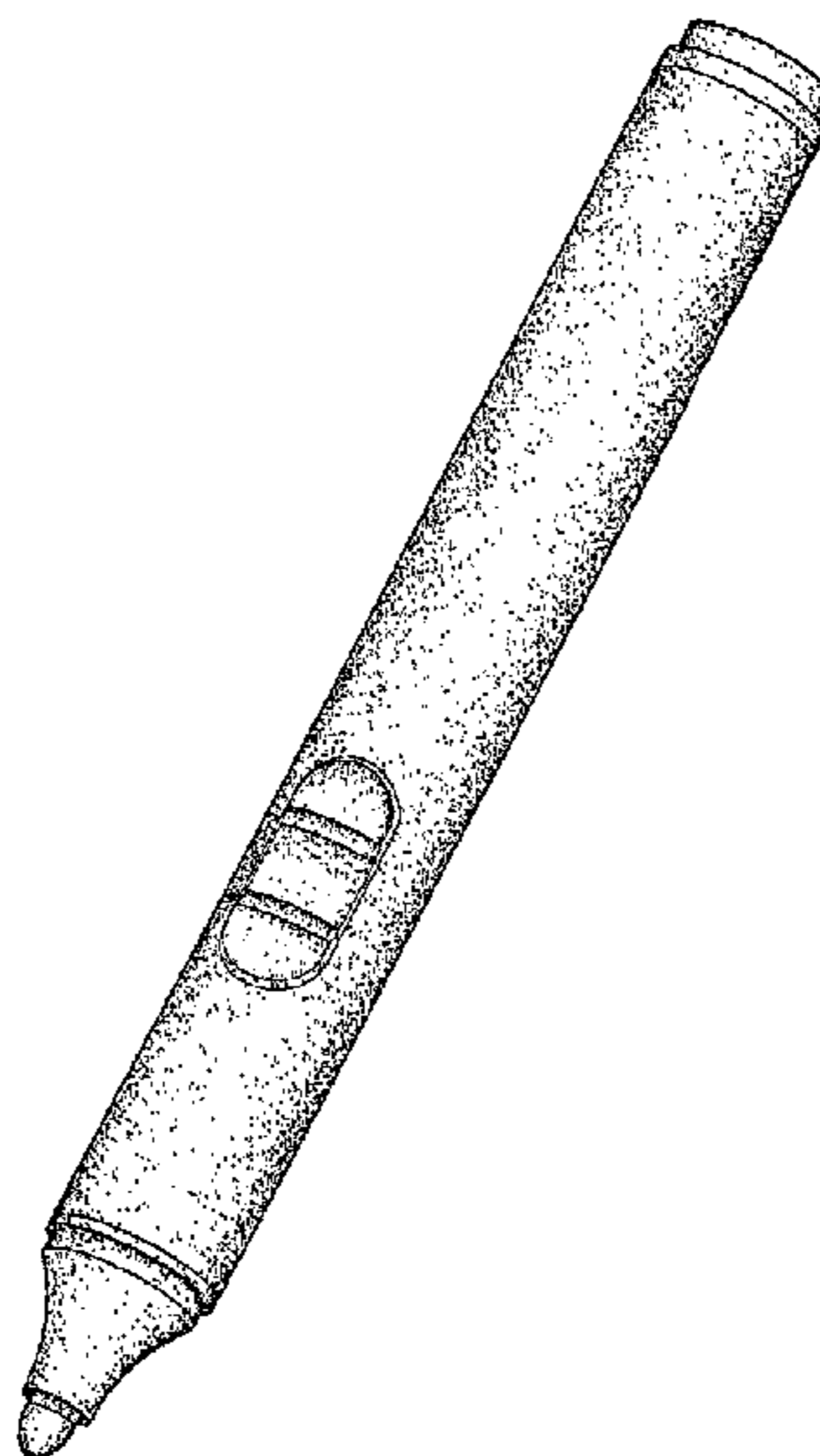

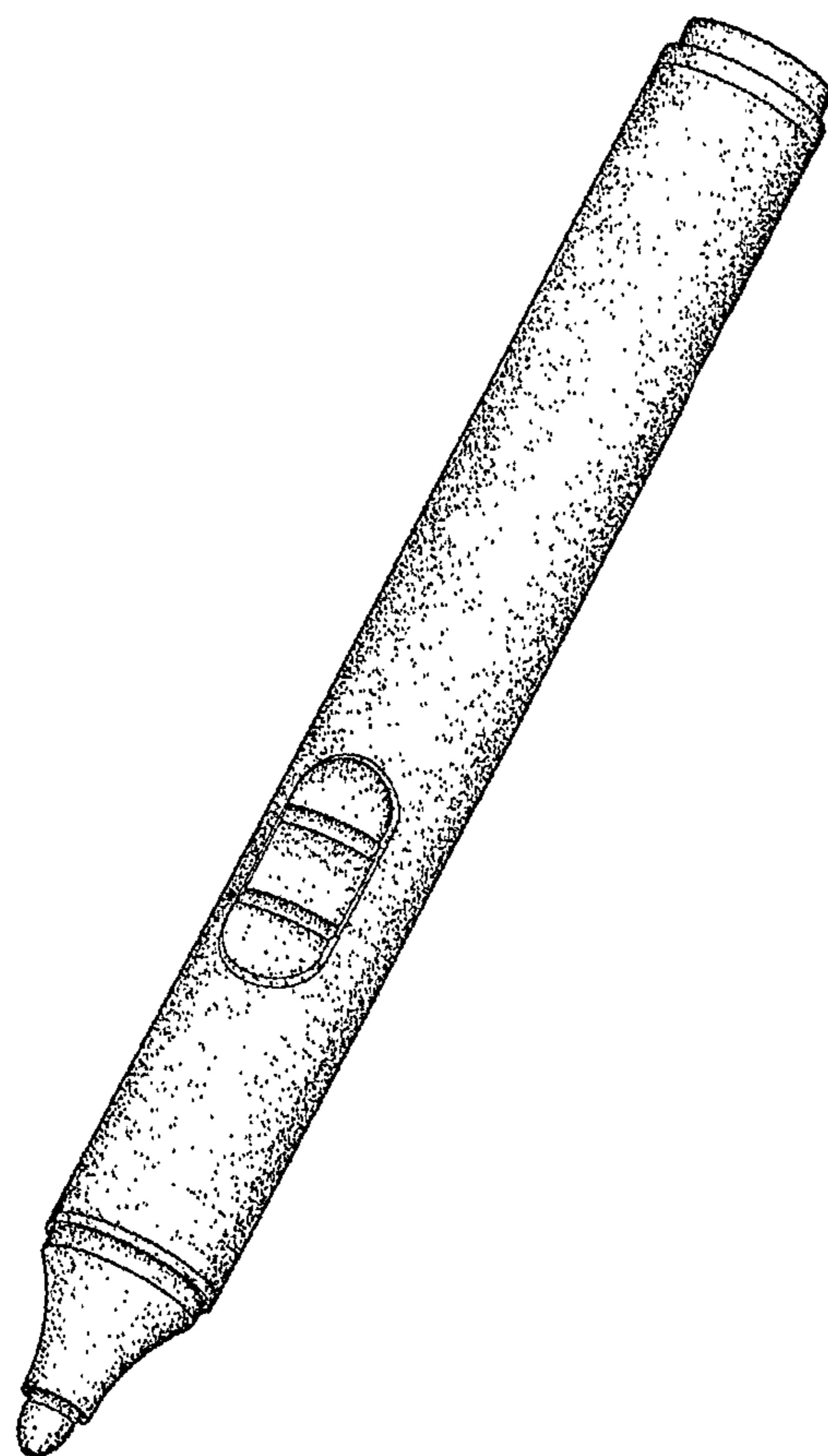
The ornamental design for an stylus, as shown and described.

**DESCRIPTION**

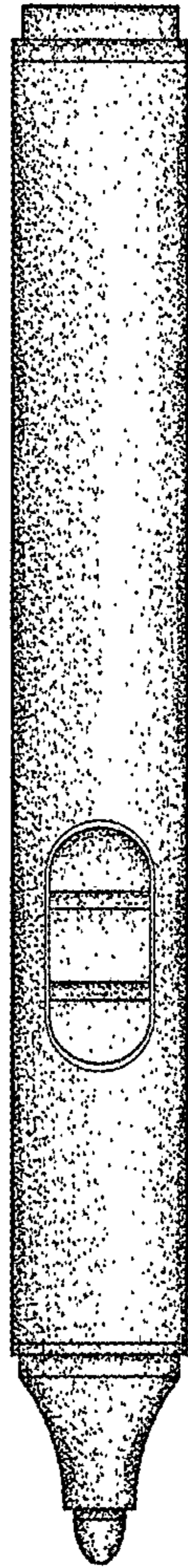
FIG. 1 is a perspective view of an stylus showing my design;

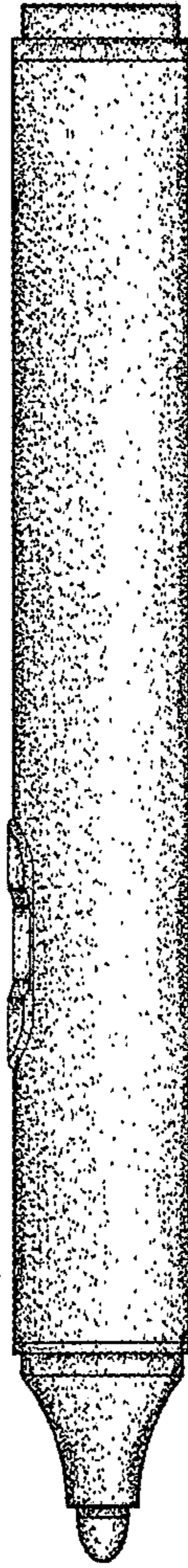

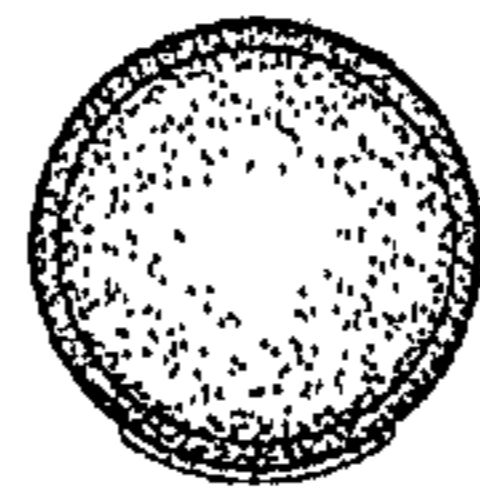

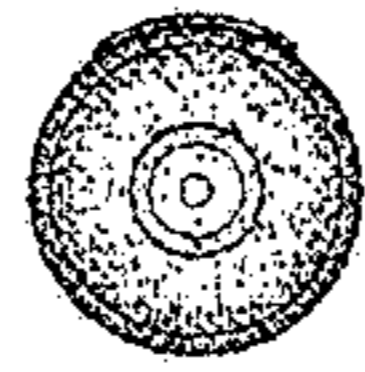
