**DESCRIPTION**

FIG. 1 is a front view of a display screen portion of an incubator with a graphical user interface shown on a monitor showing our new design.

FIG. 2 is a back view of the monitor of FIG. 1.

FIG. 3 is a top view of the monitor of FIG. 1.

FIG. 4 is a bottom view of the monitor of FIG. 1.

FIG. 5 is a right side view of the monitor of FIG. 1; and,

FIG. 6 is a left side view of the monitor of FIG. 1.

The solid lines in FIG. 1 illustrate a display screen portion of an incubator with a graphical user interface showing an alarm indicator button combined with one or more alarm indicator types according to the present invention.

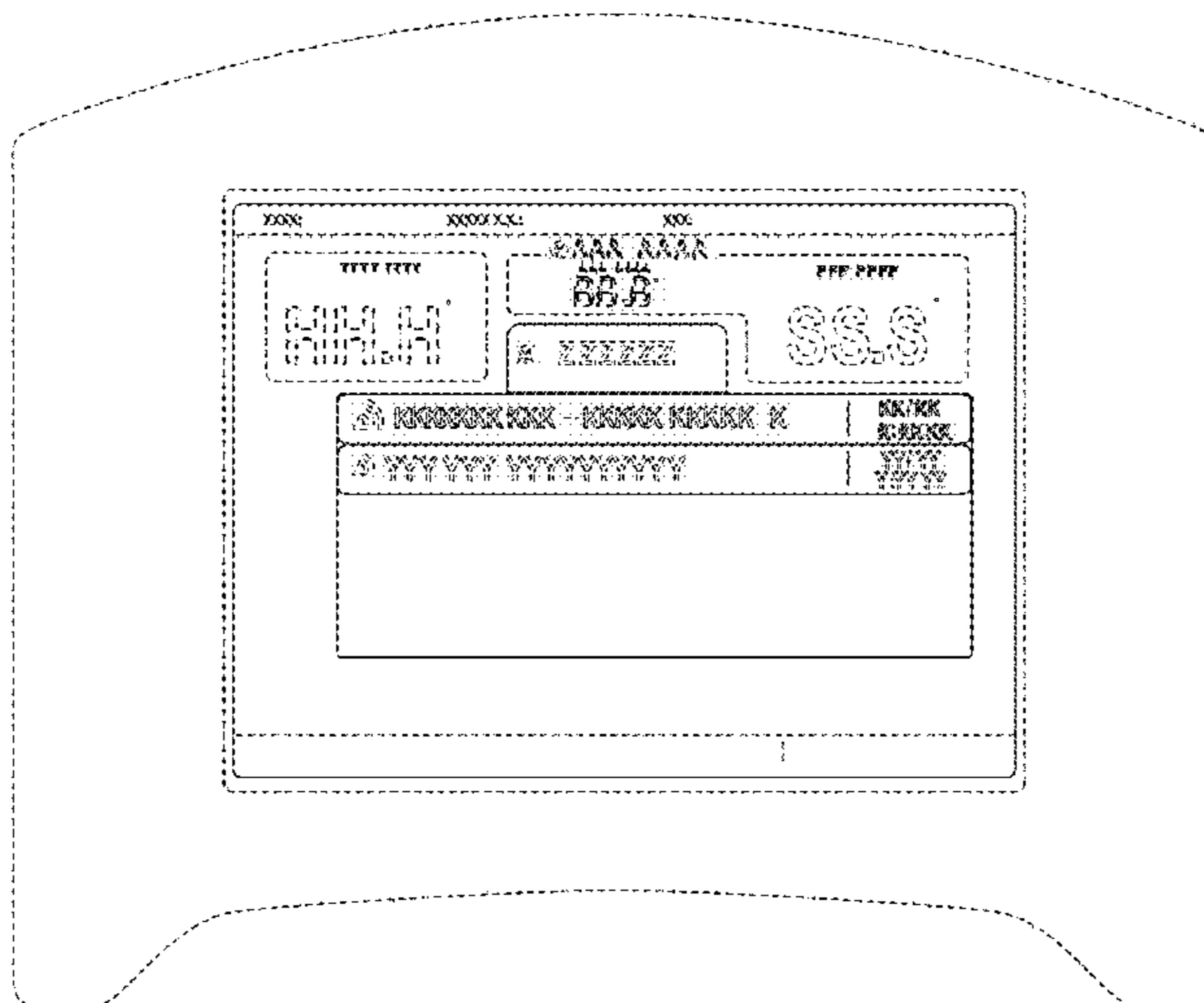

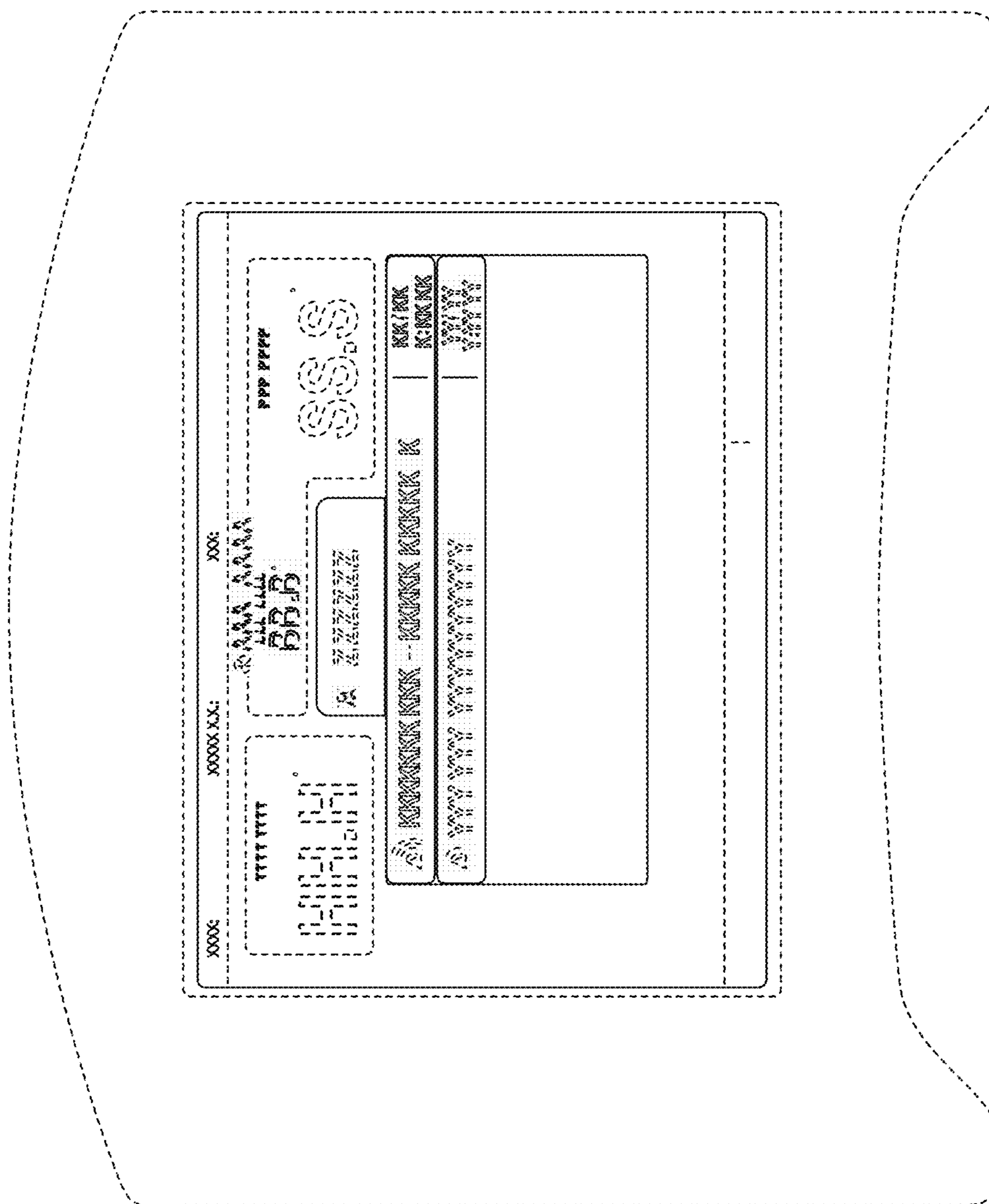

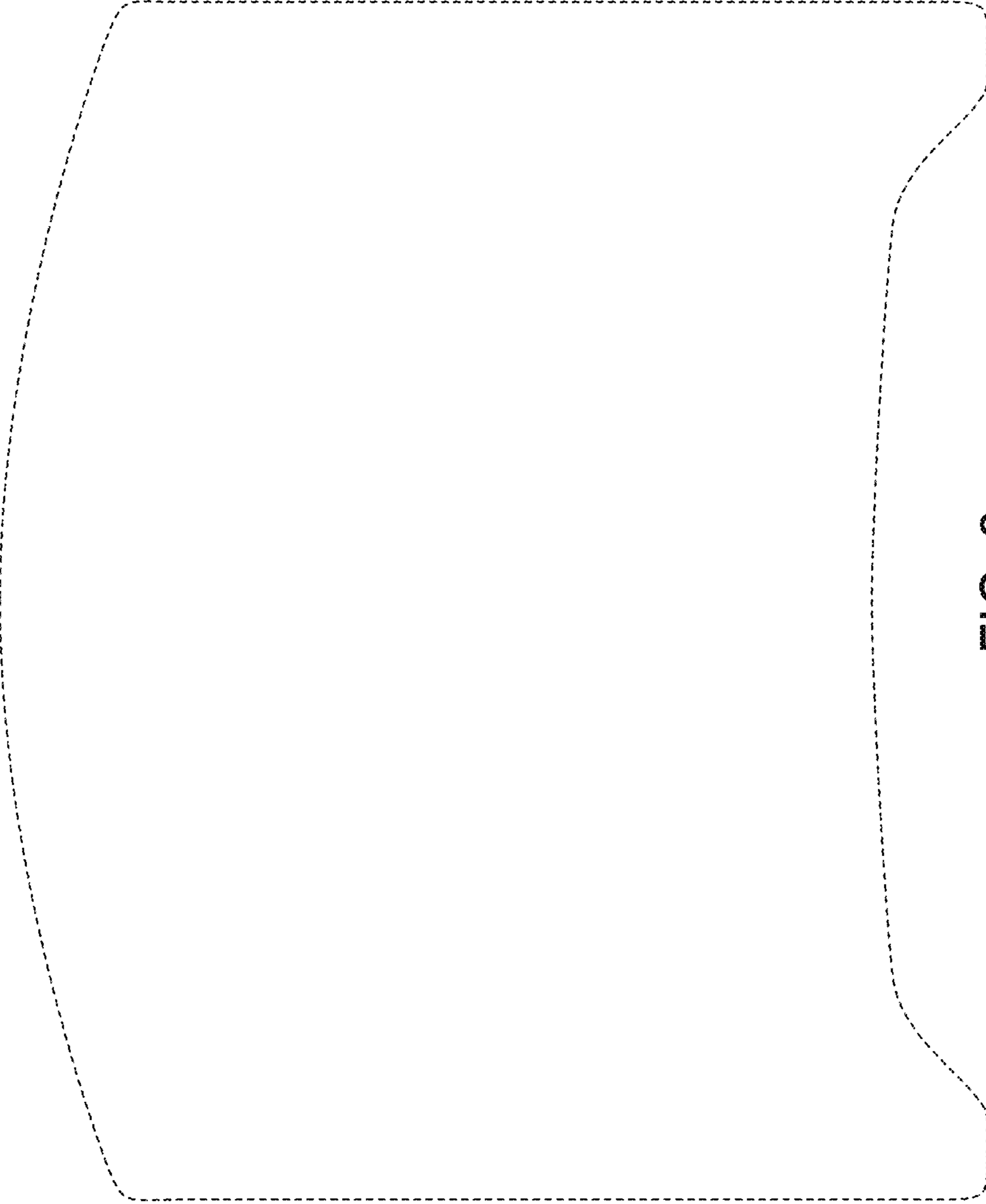

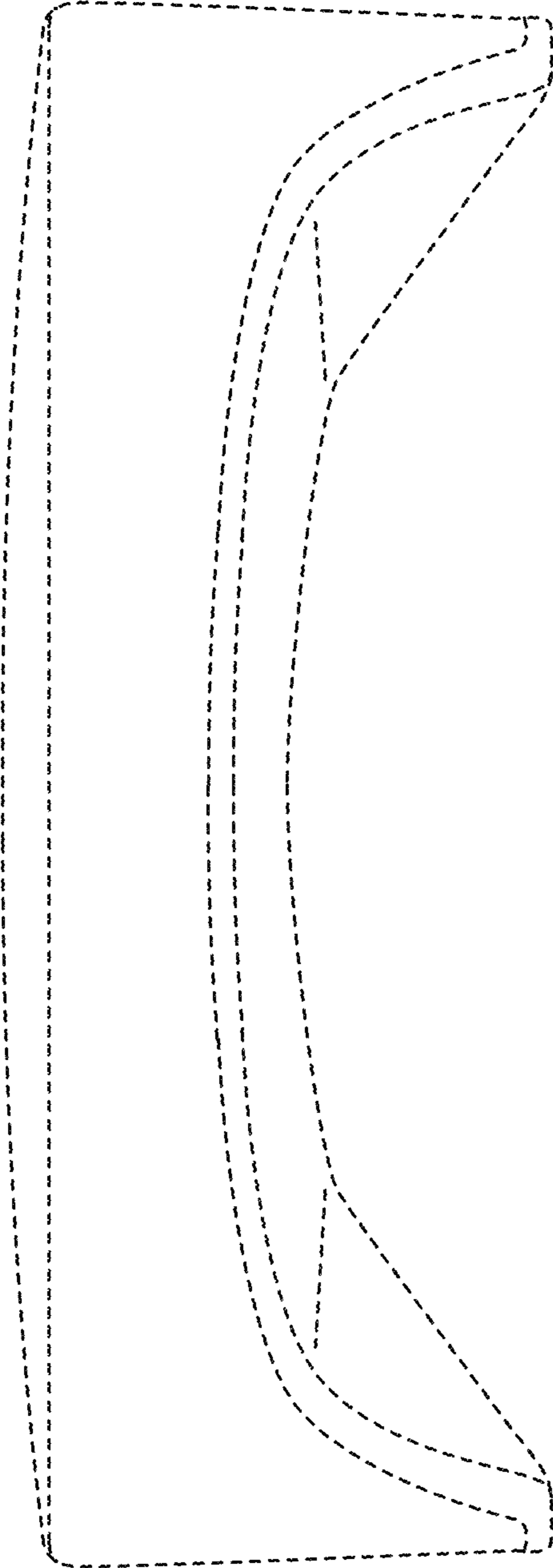

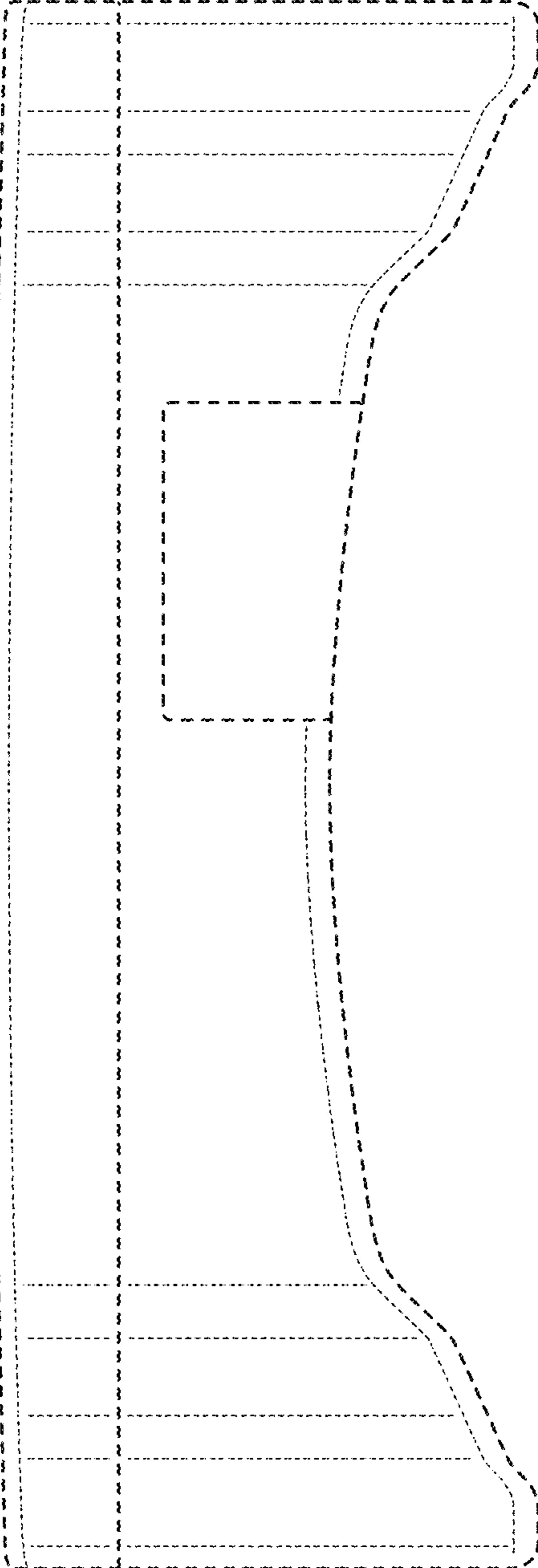

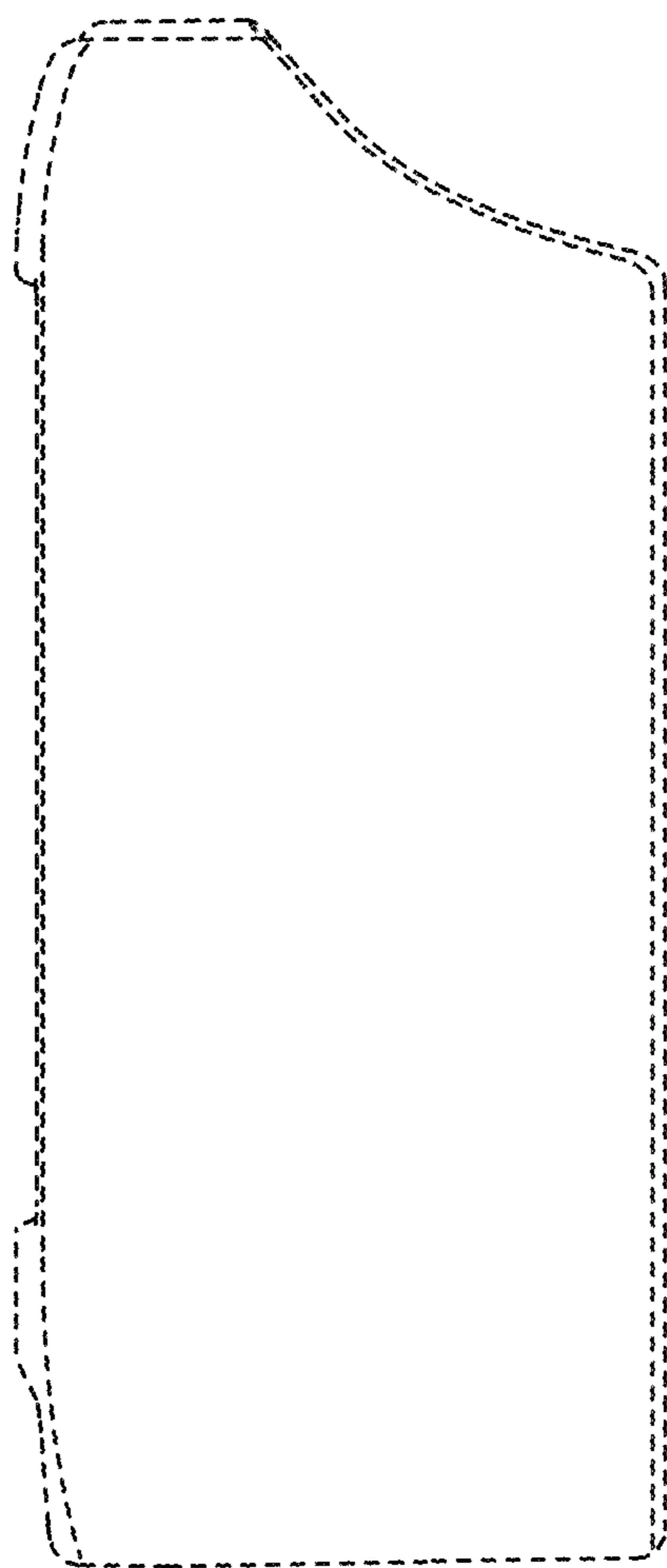

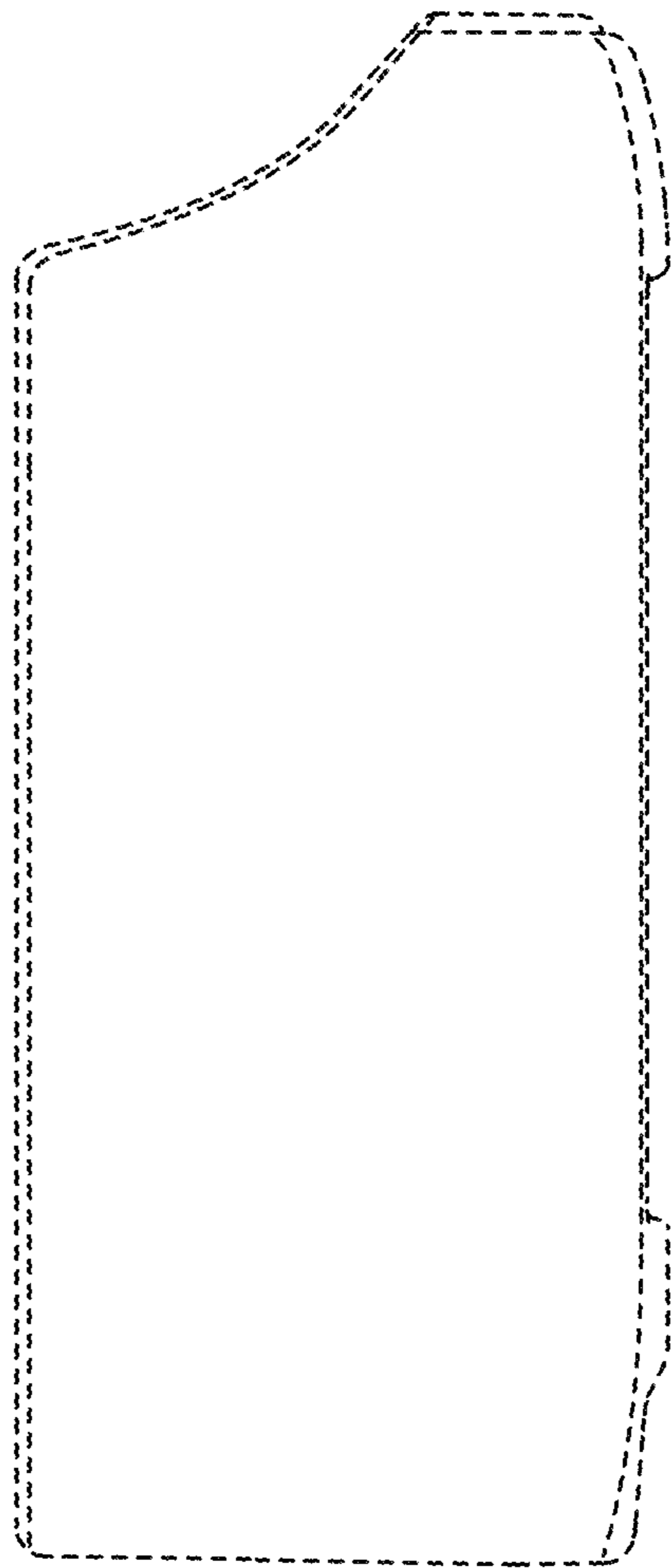
