(57) **CLAIM**

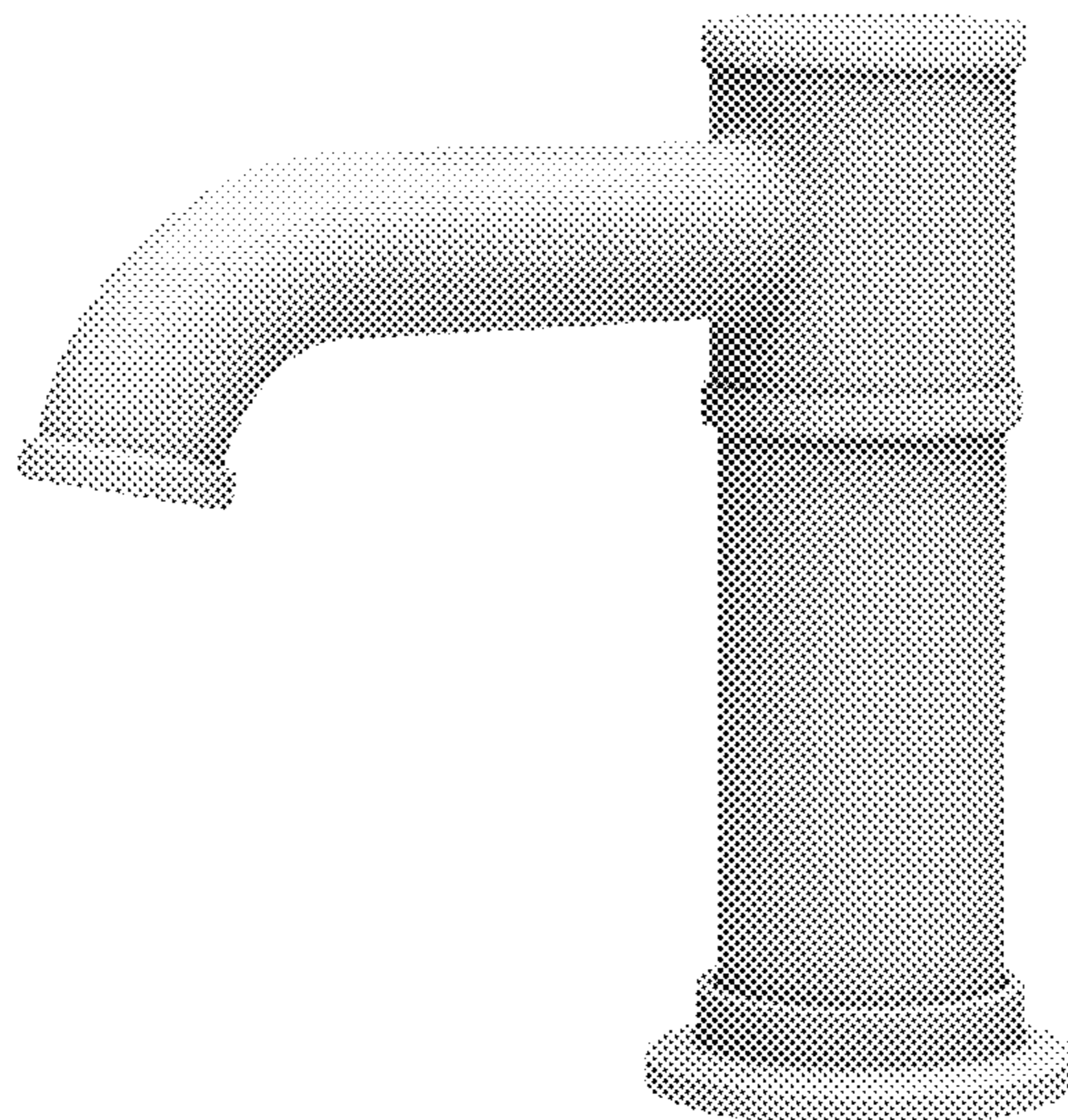
The ornamental design for a faucet, as shown and described.

The broken line showing of the spout opening of the faucet in FIG. 4 is for environmental purposes only and forms no part of the claimed design.

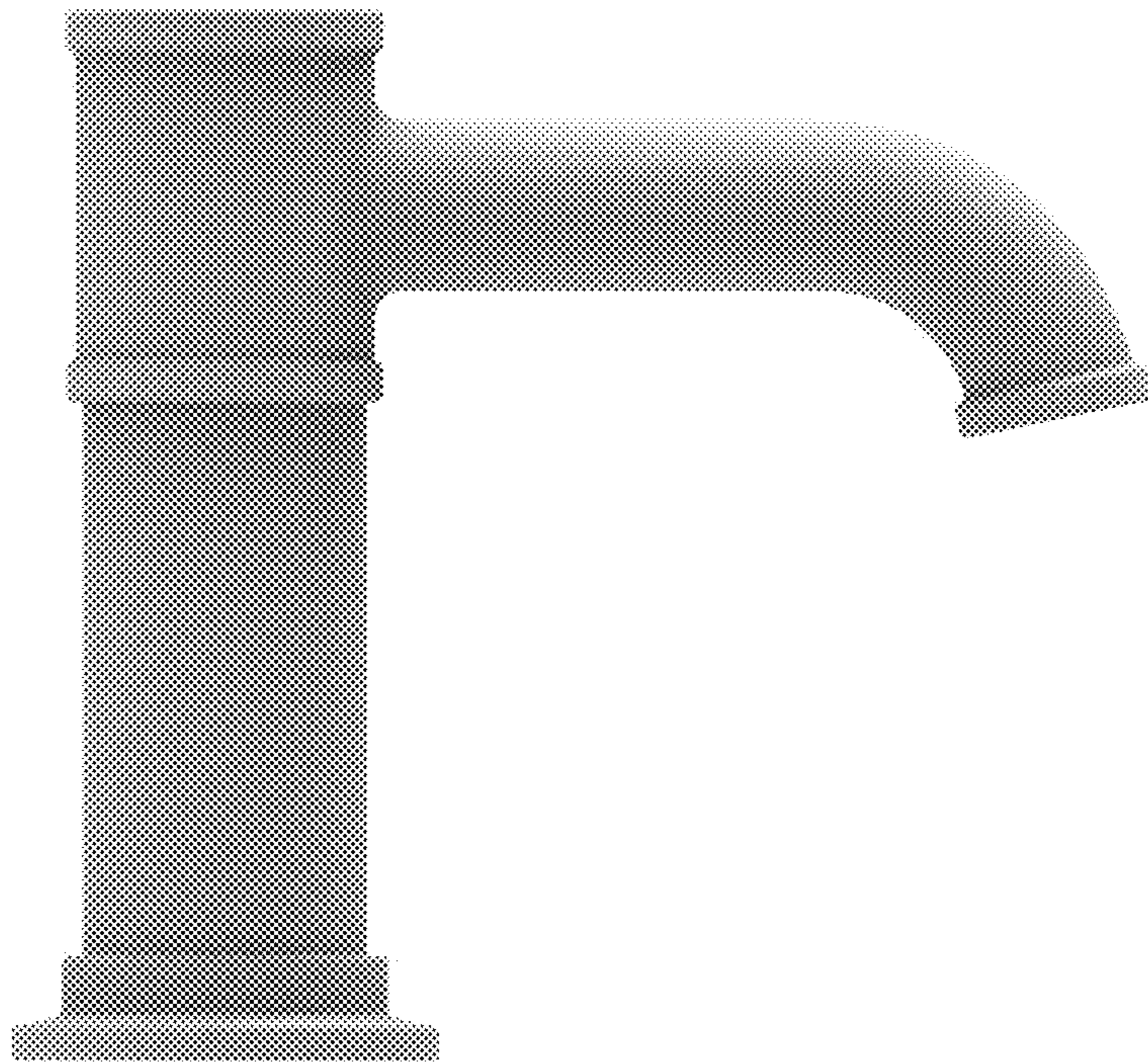

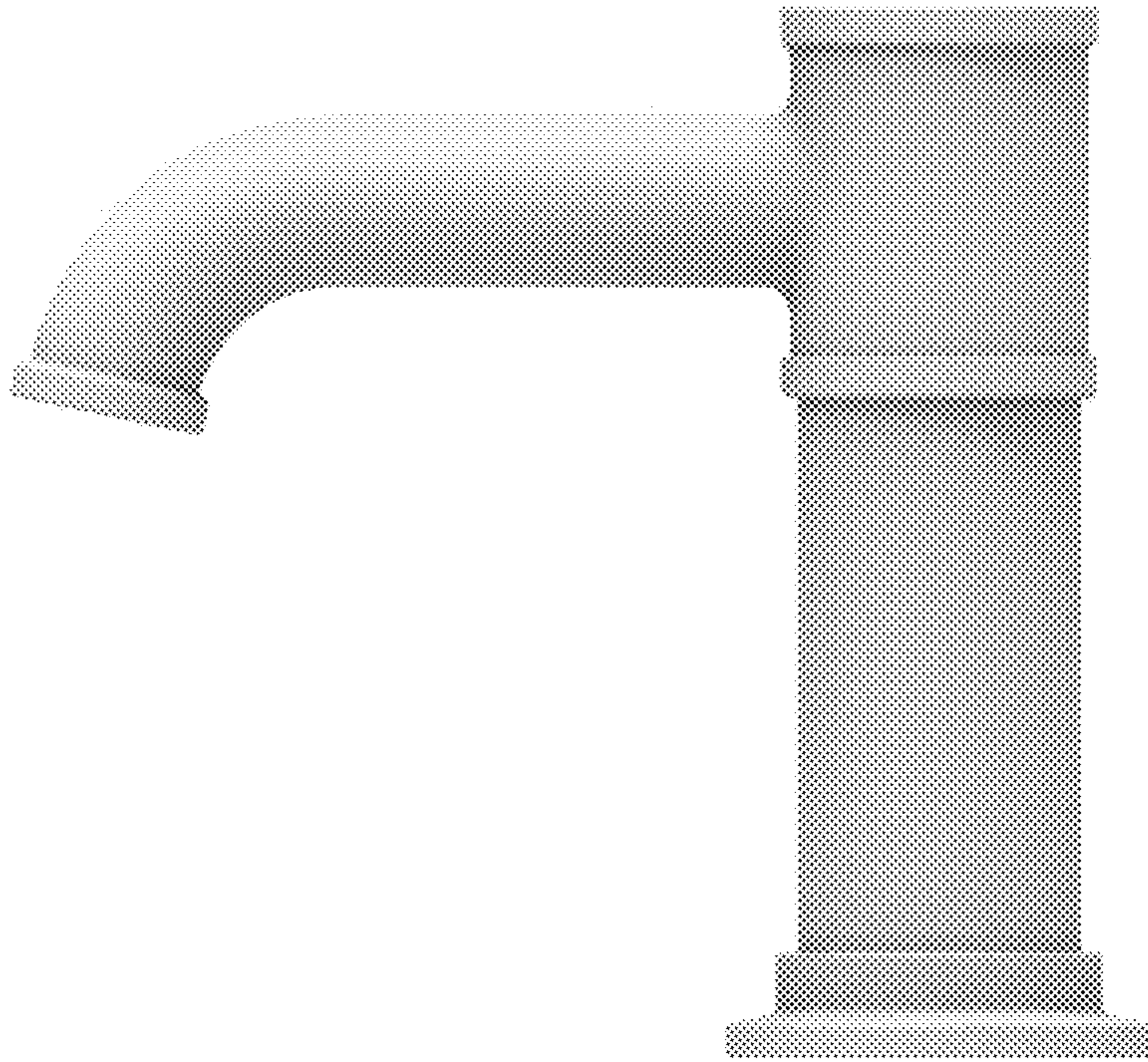

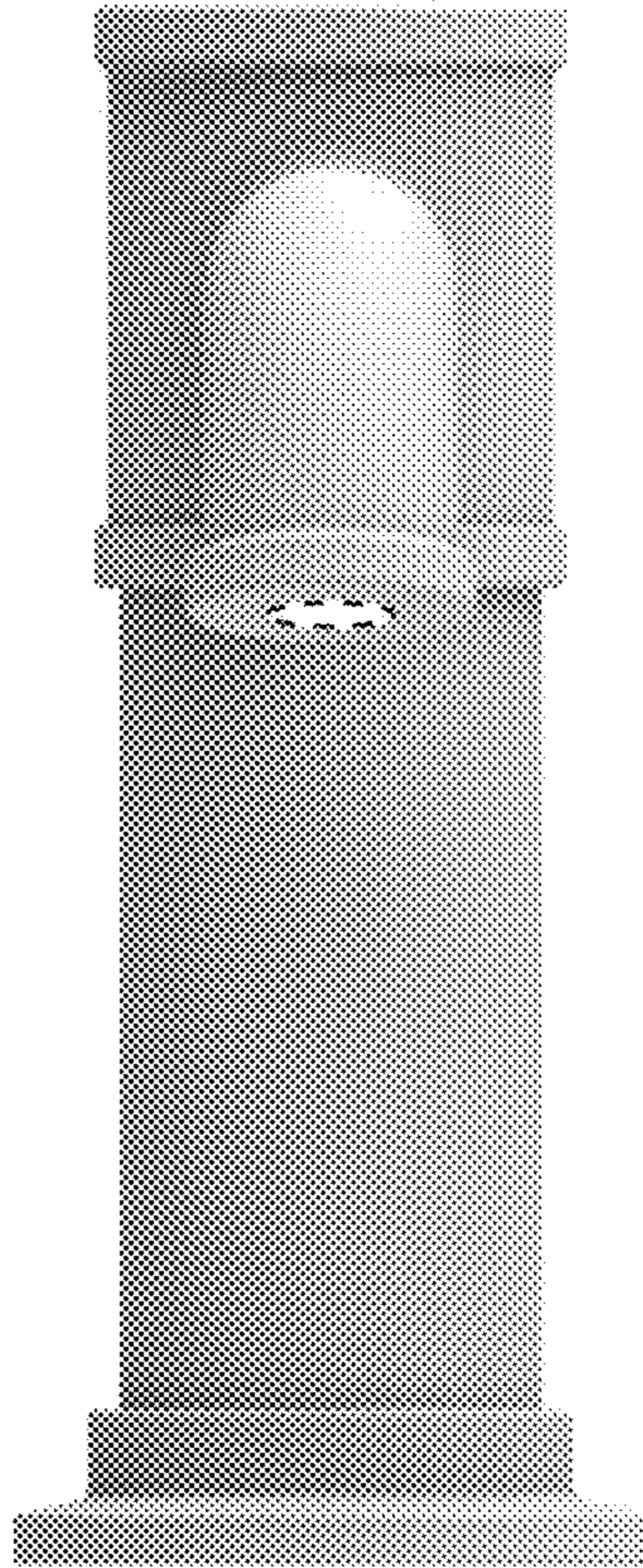

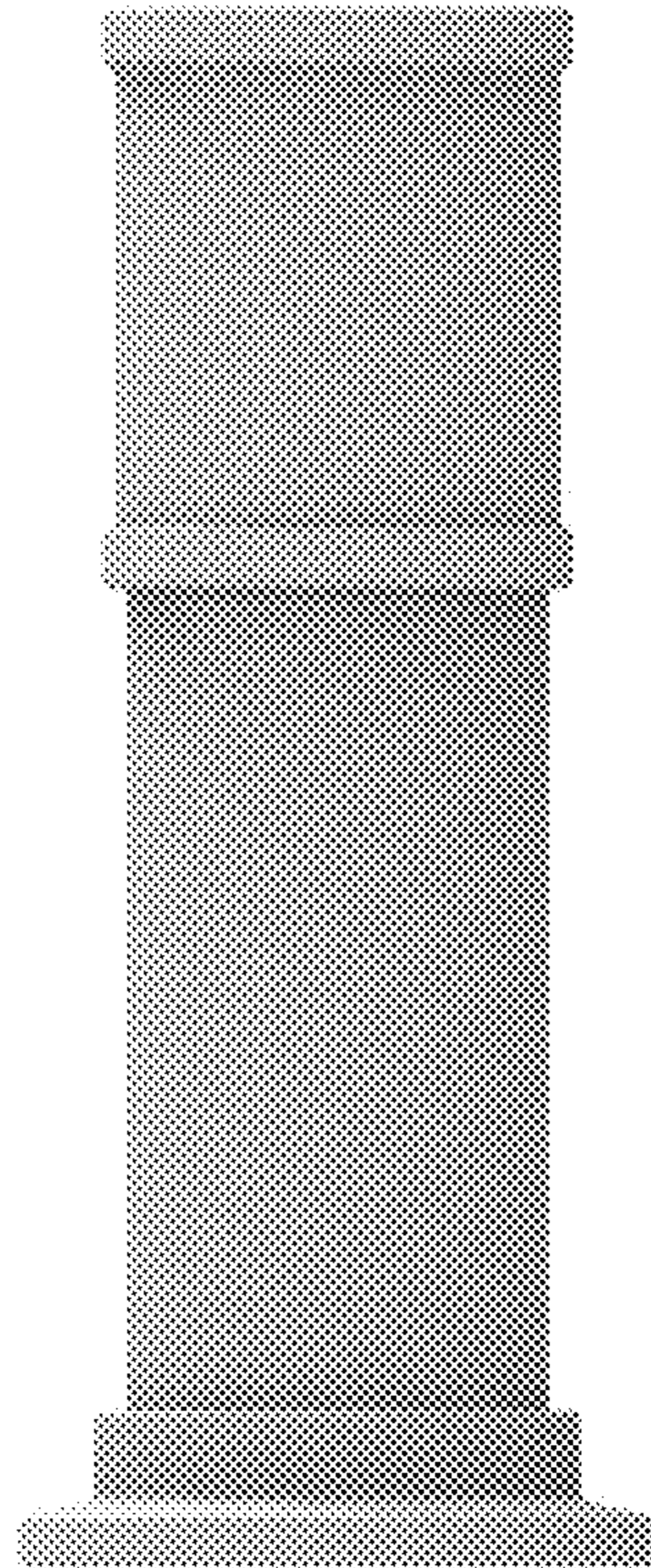




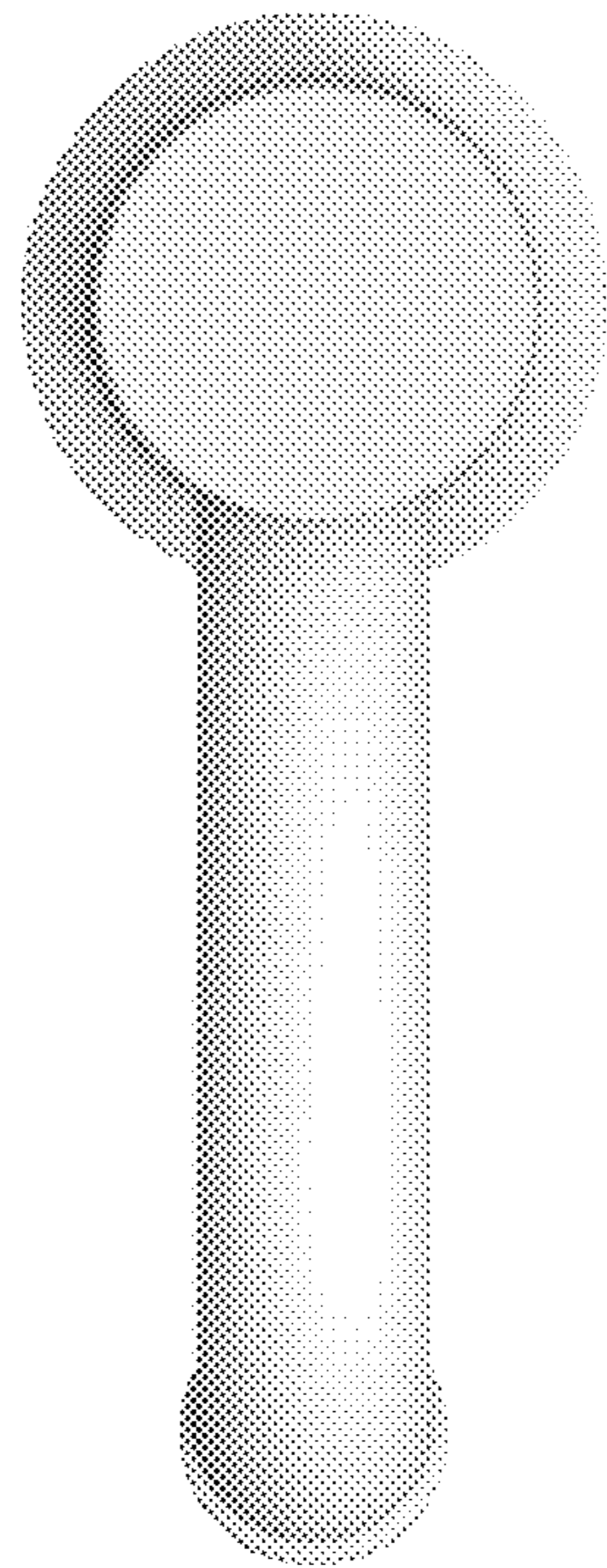
