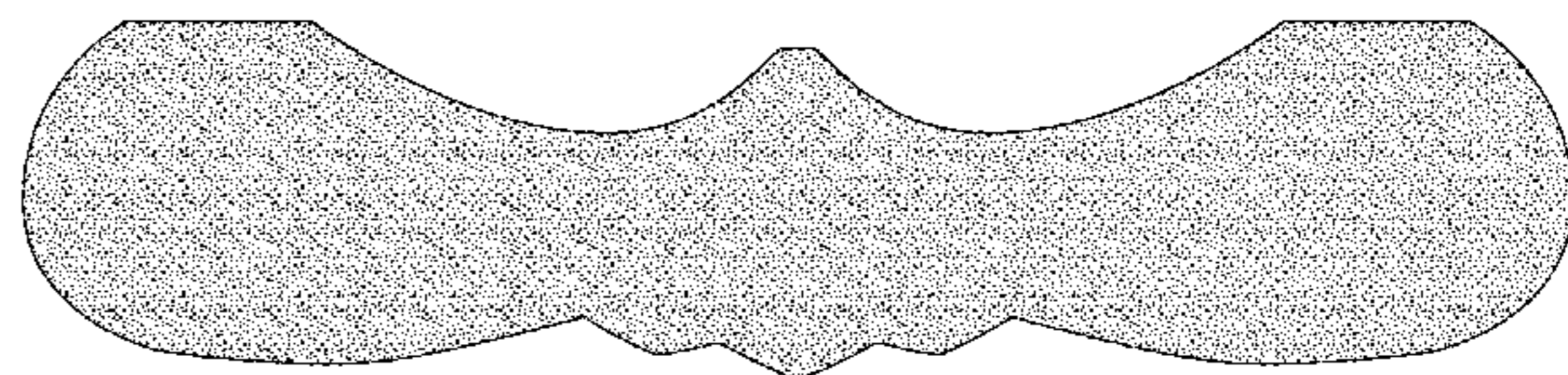
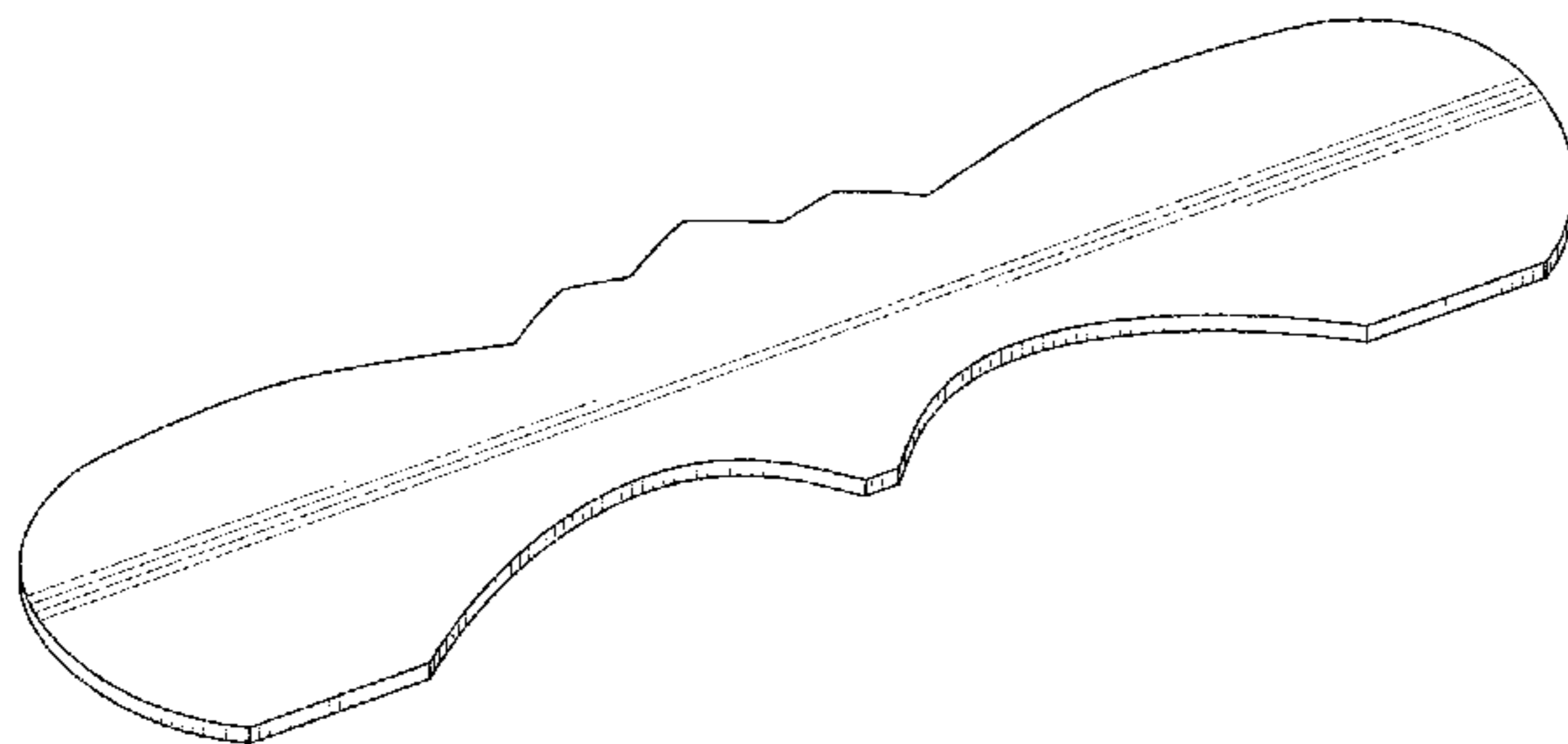
(57) **CLAIM**

The ornamental design for an adhesive skin insulator, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an adhesive skin insulator according to the present invention.
 FIG. 2 is a top plan view of the adhesive skin insulator illustrated in FIG. 1.
 FIG. 3 is a bottom plan view of the adhesive skin insulator illustrated in FIG. 1.

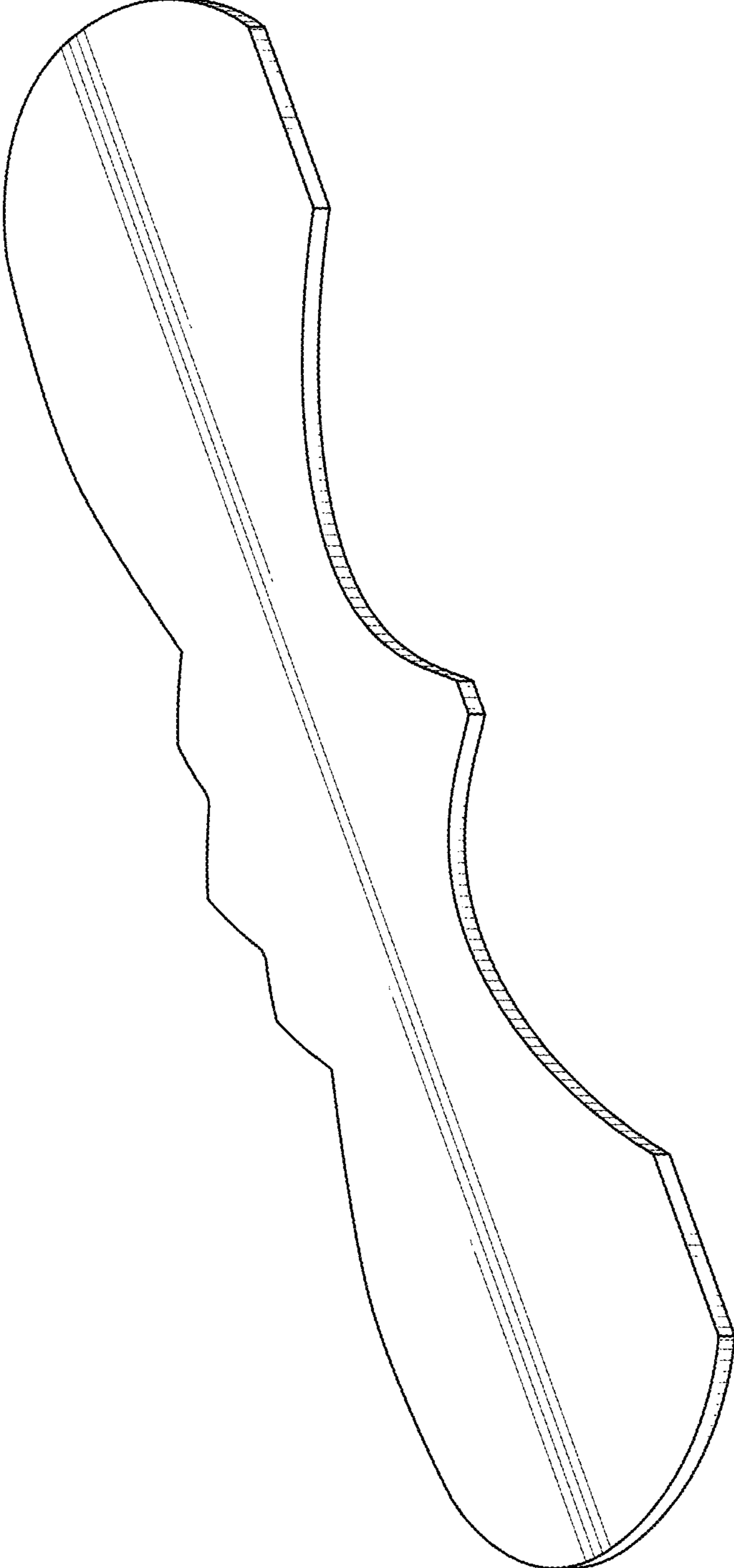

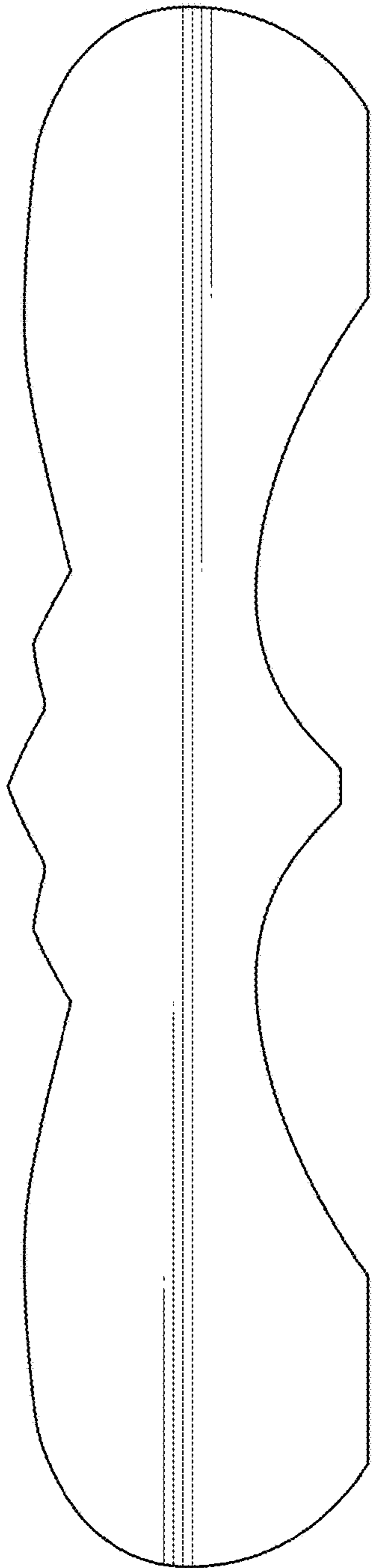

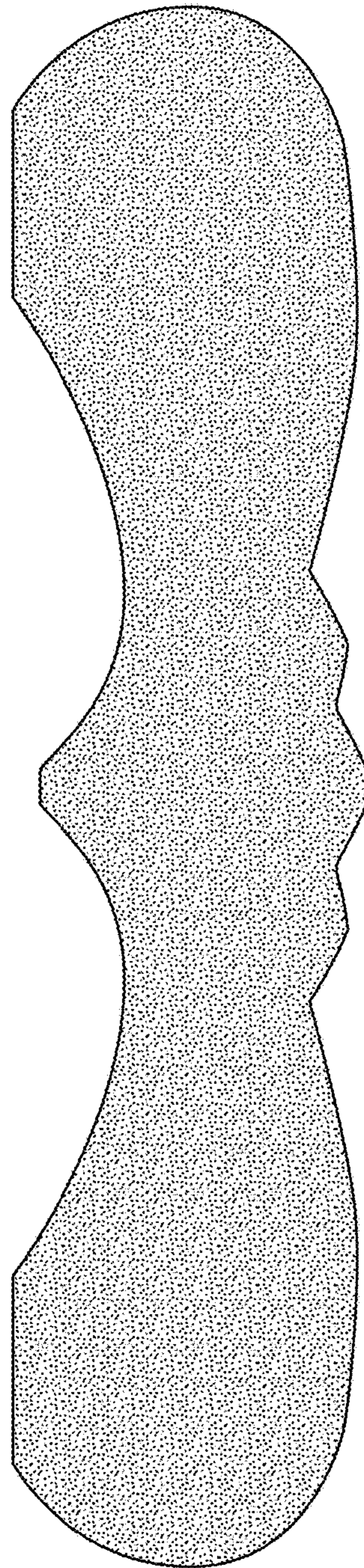

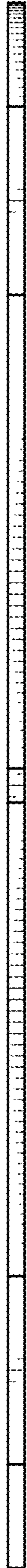

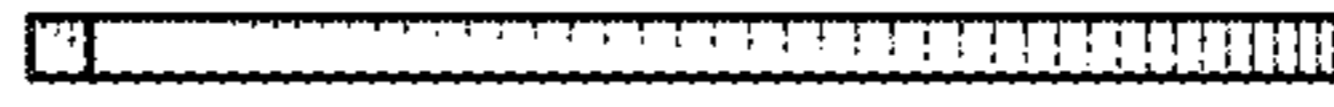
