DESCRIPTION

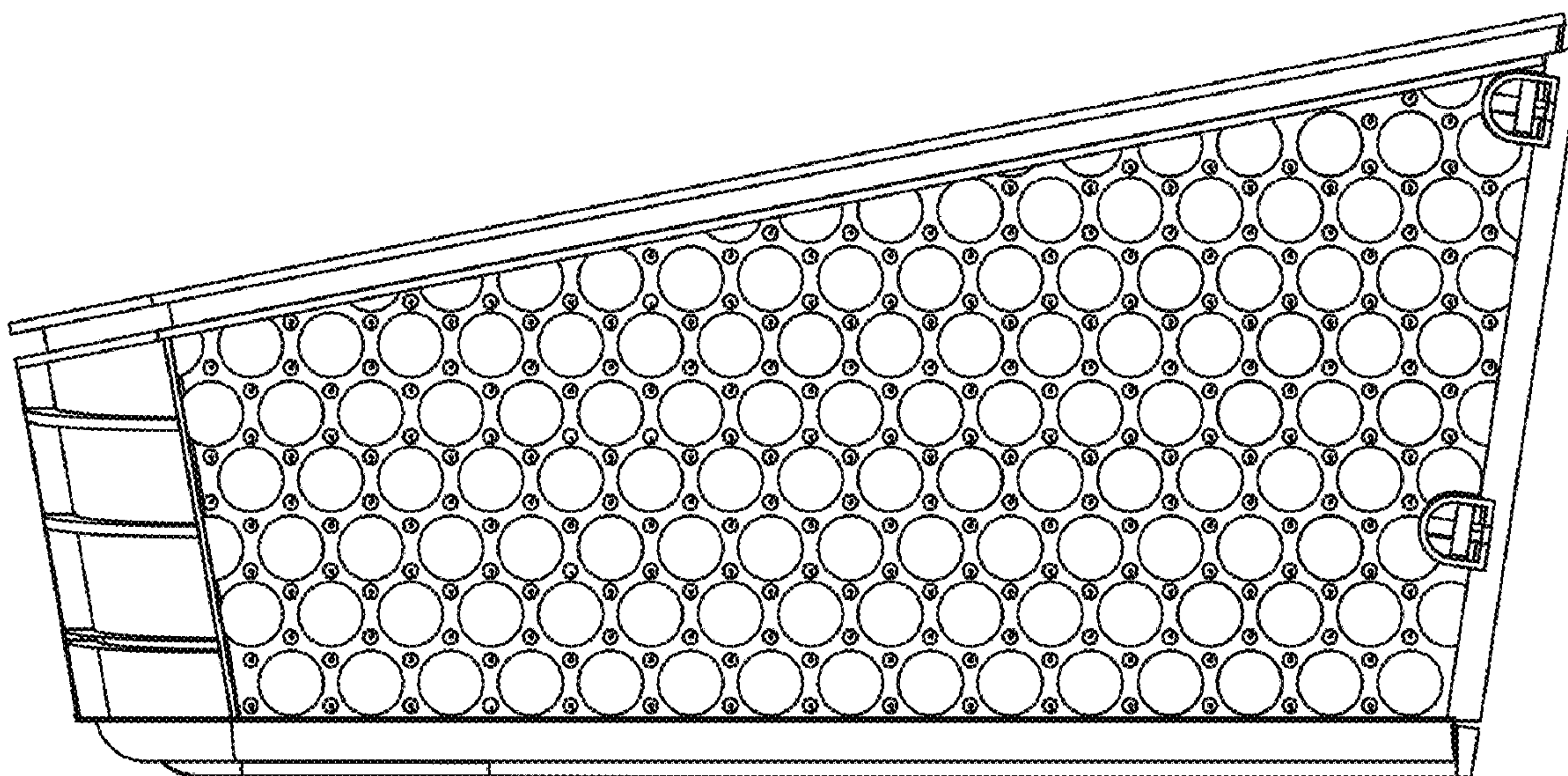
FIG. 1 is a right side view of a shopping cart basket showing my new design;

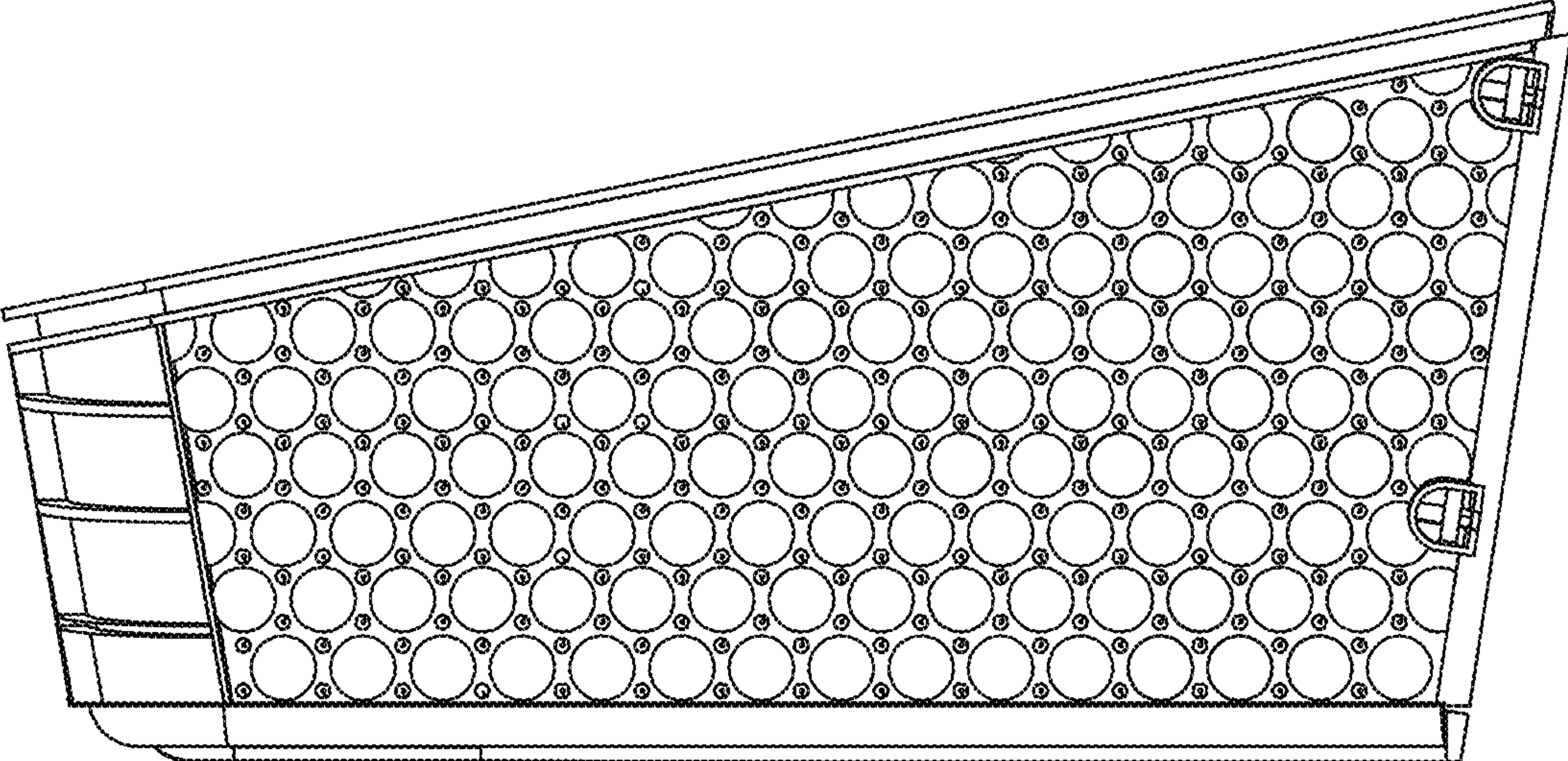

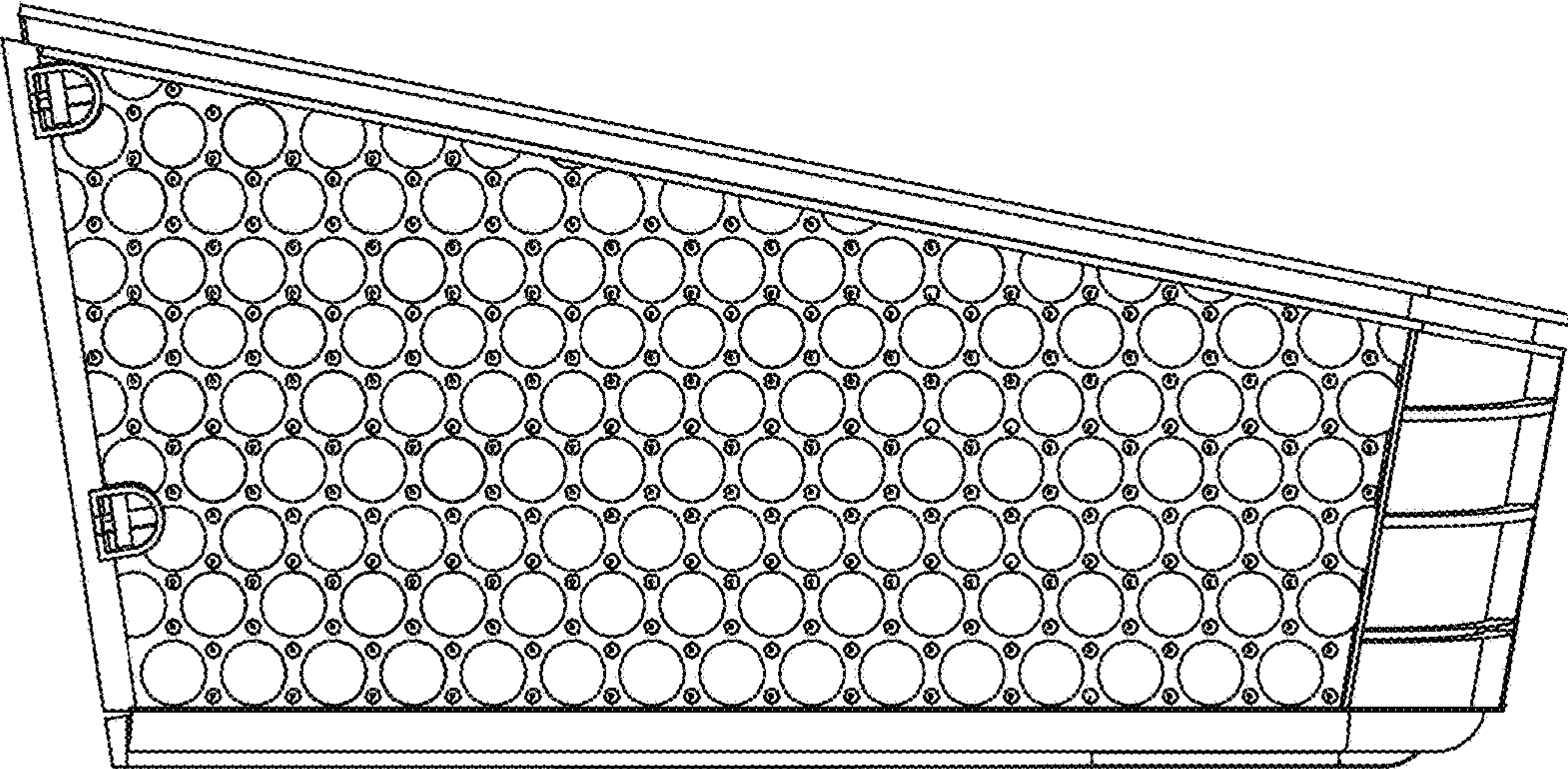

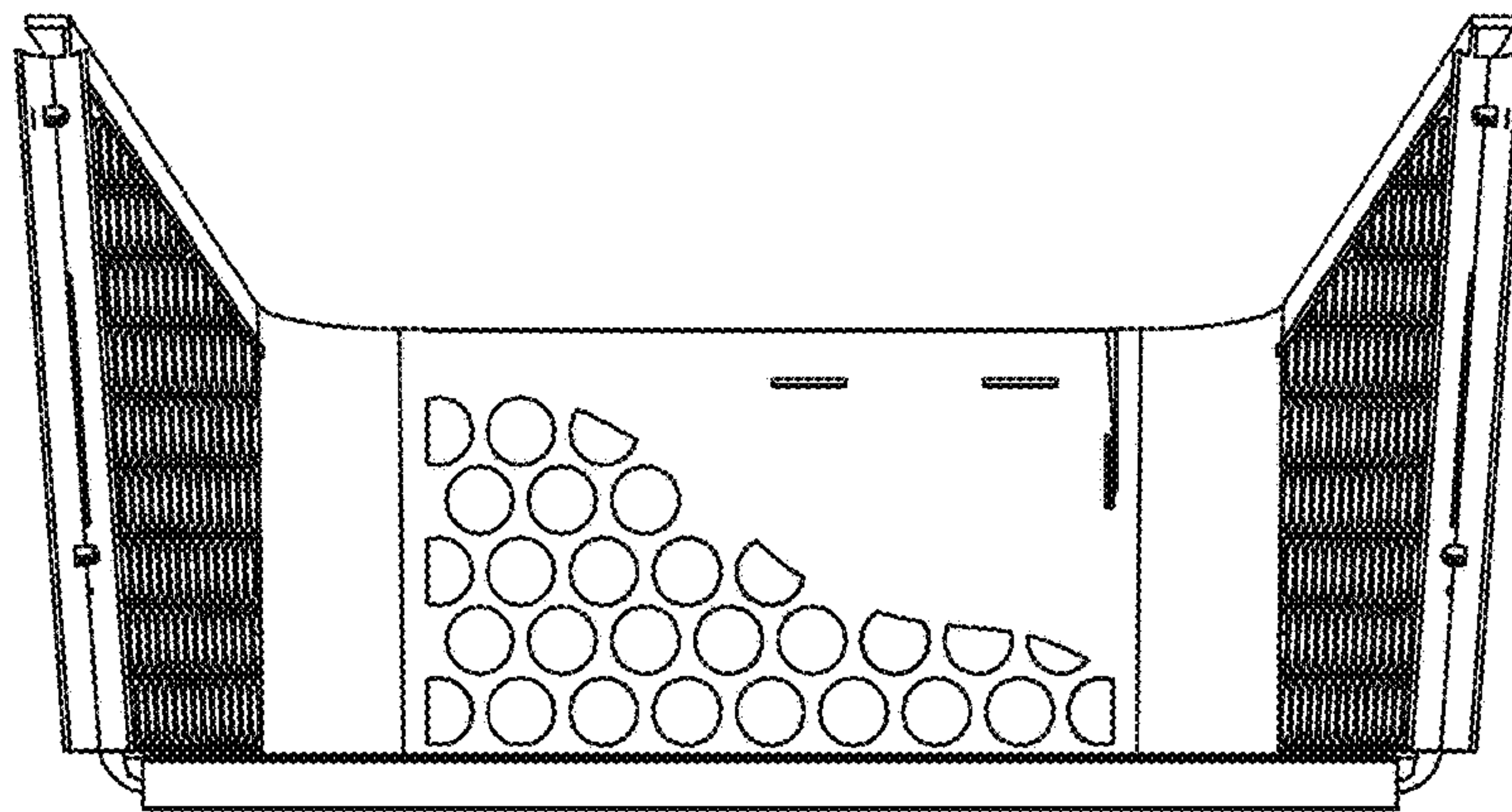

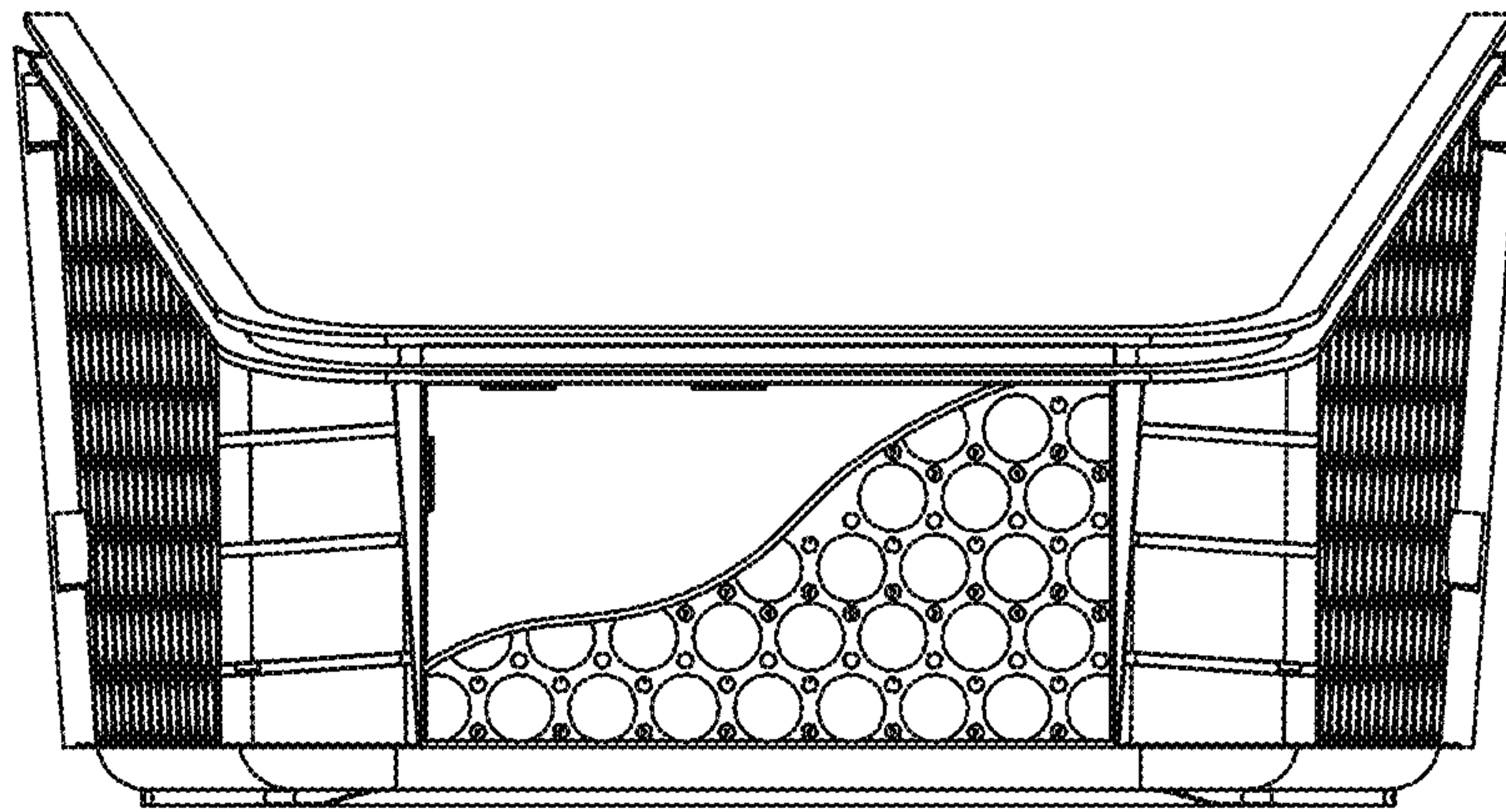

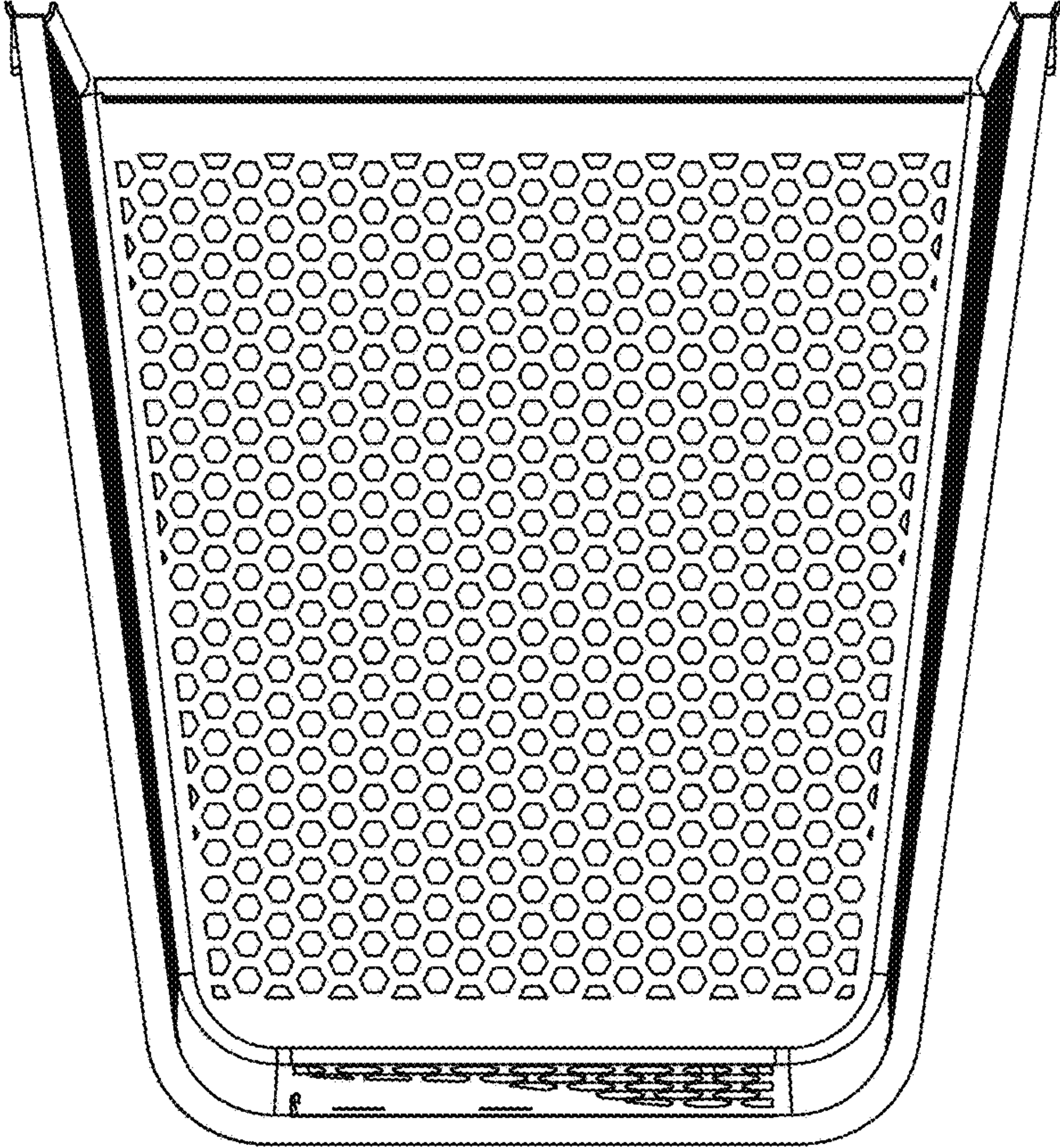

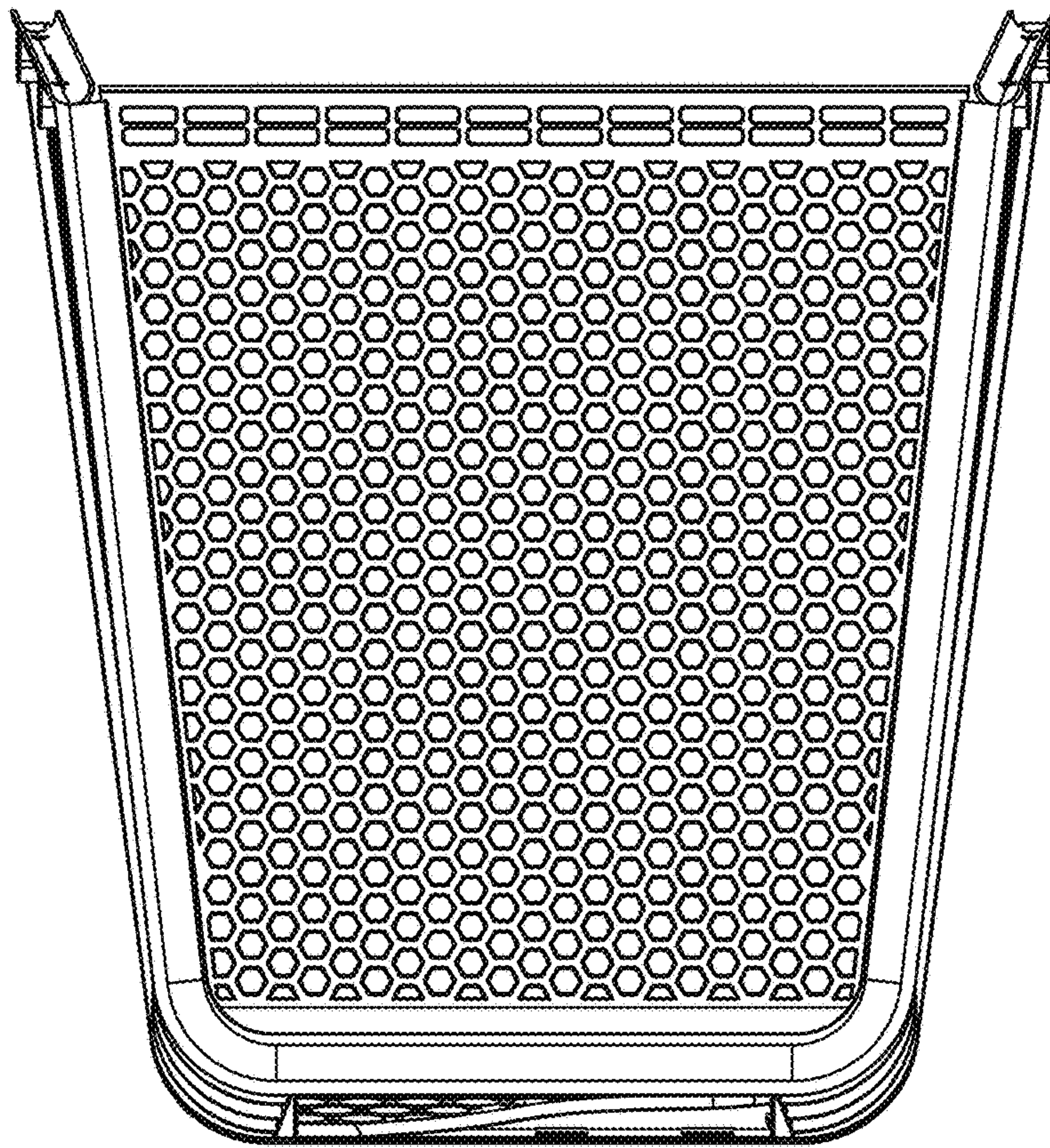

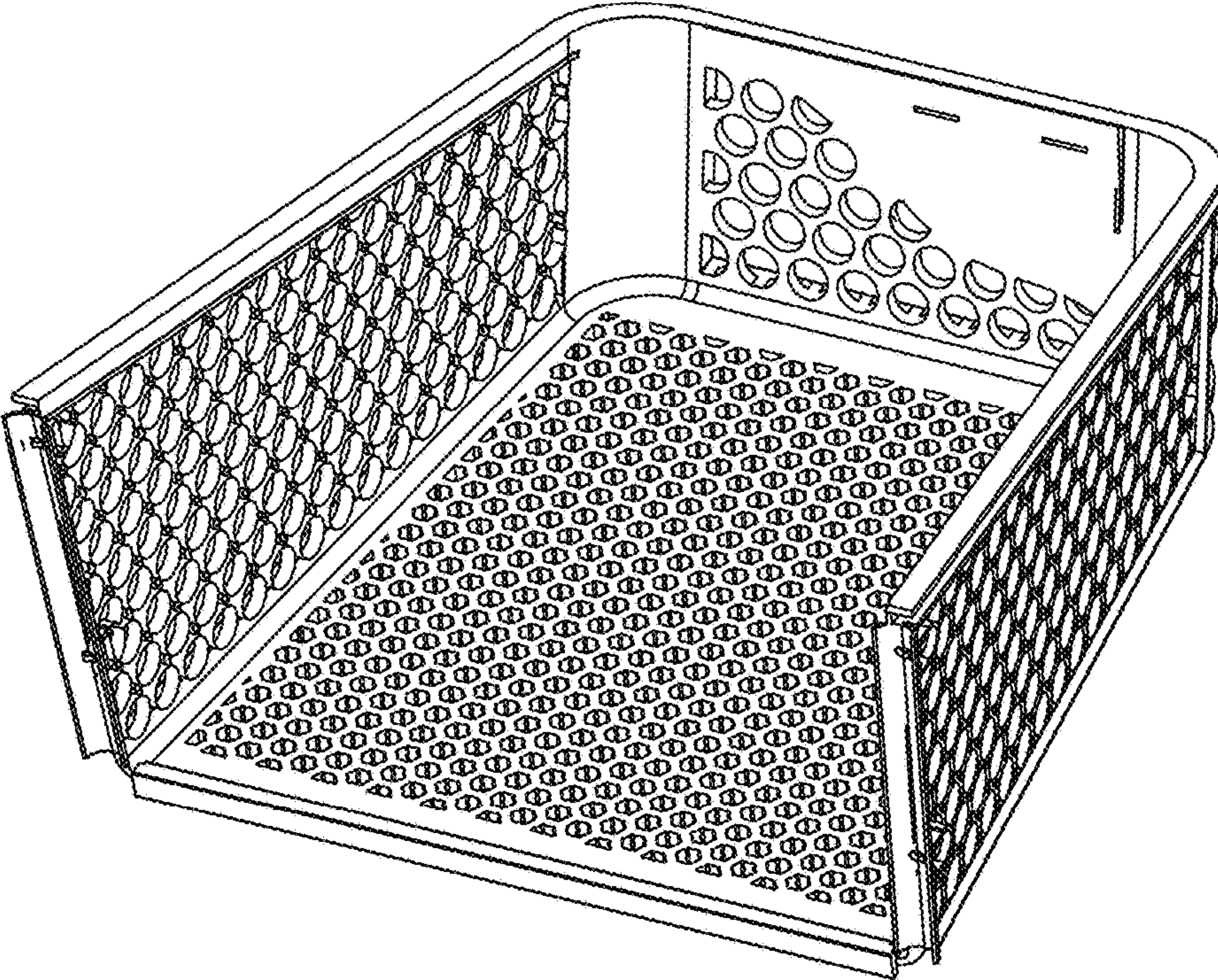

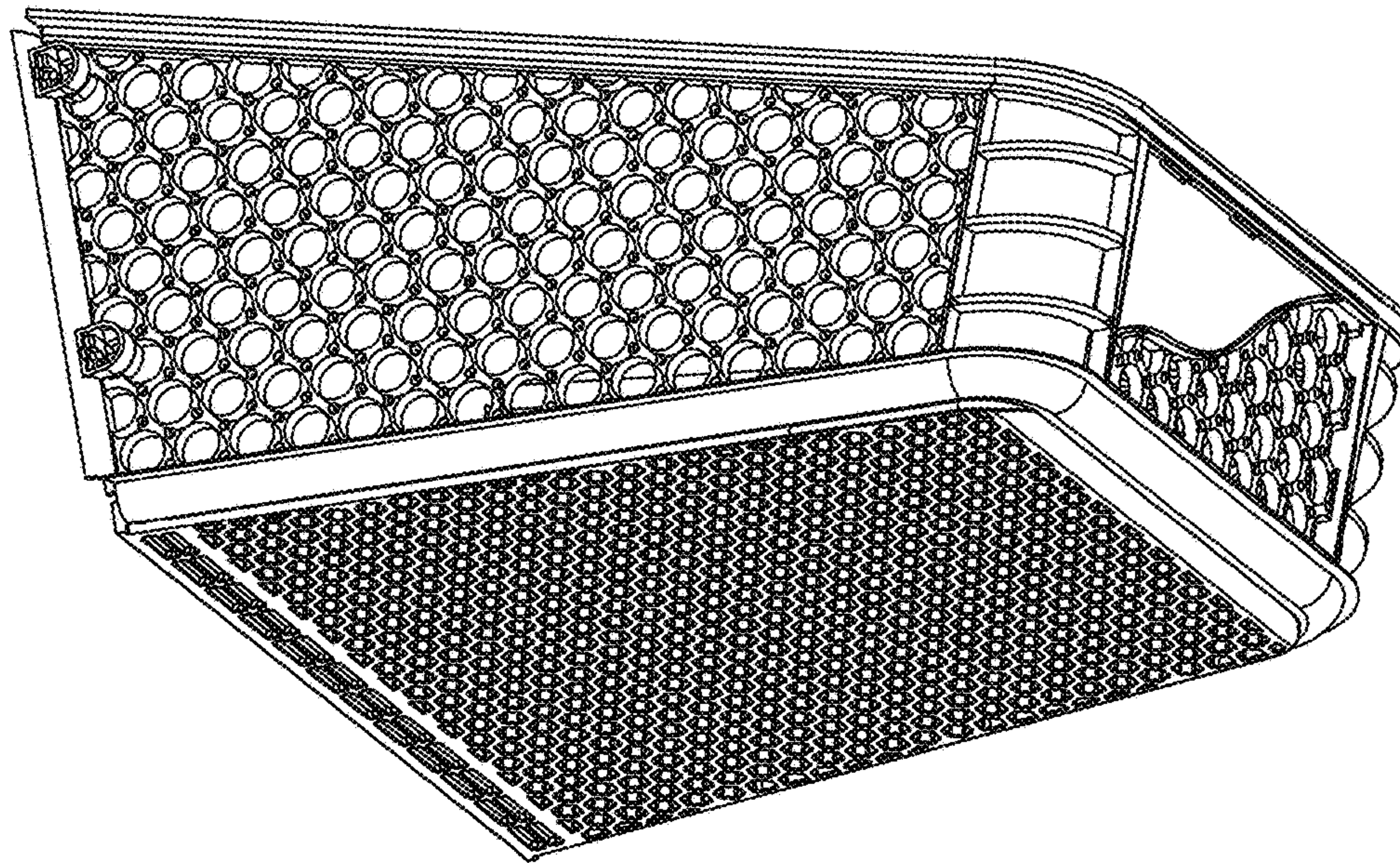
