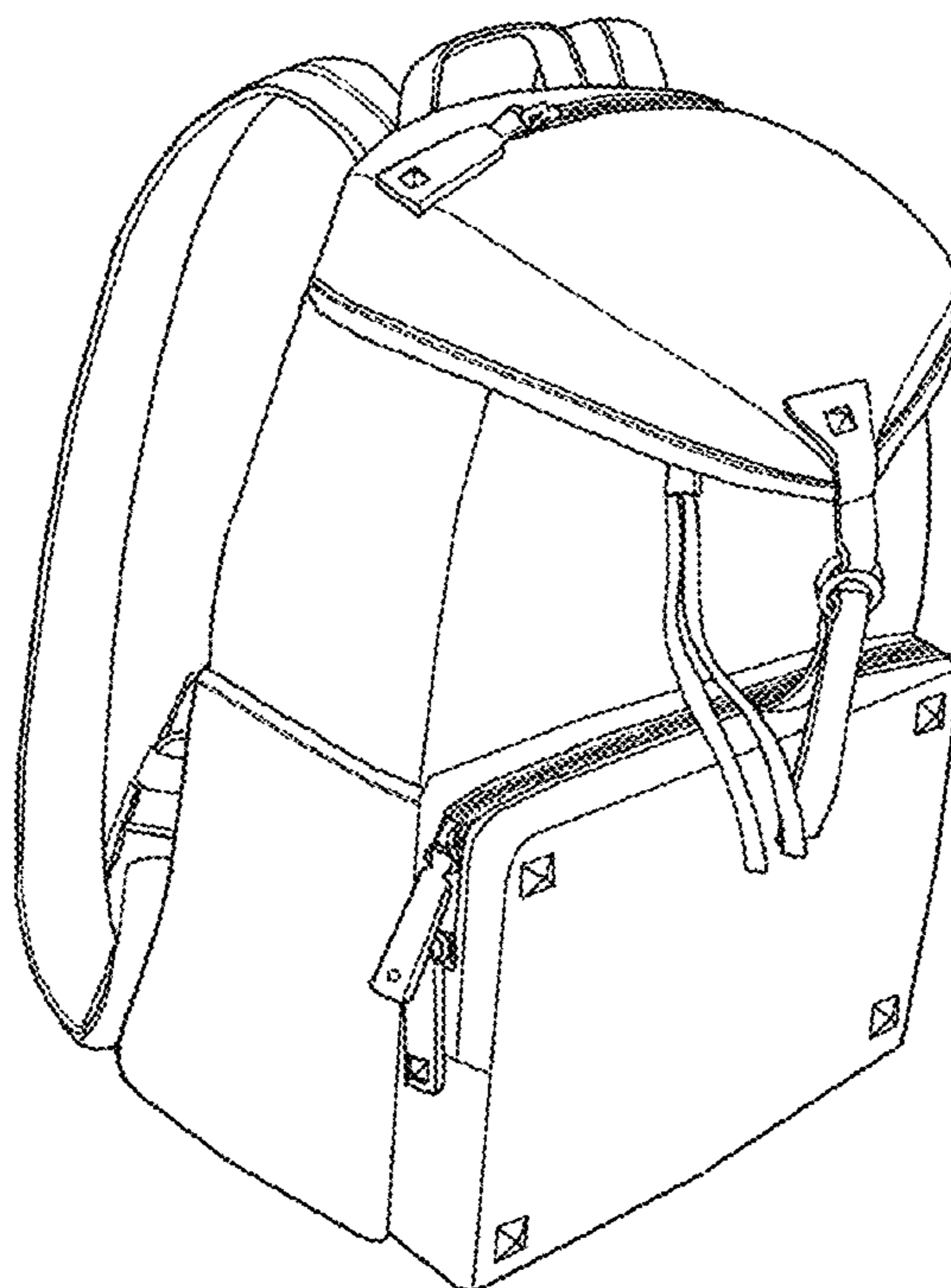
1.1 is a perspective view of a bag showing my new design;

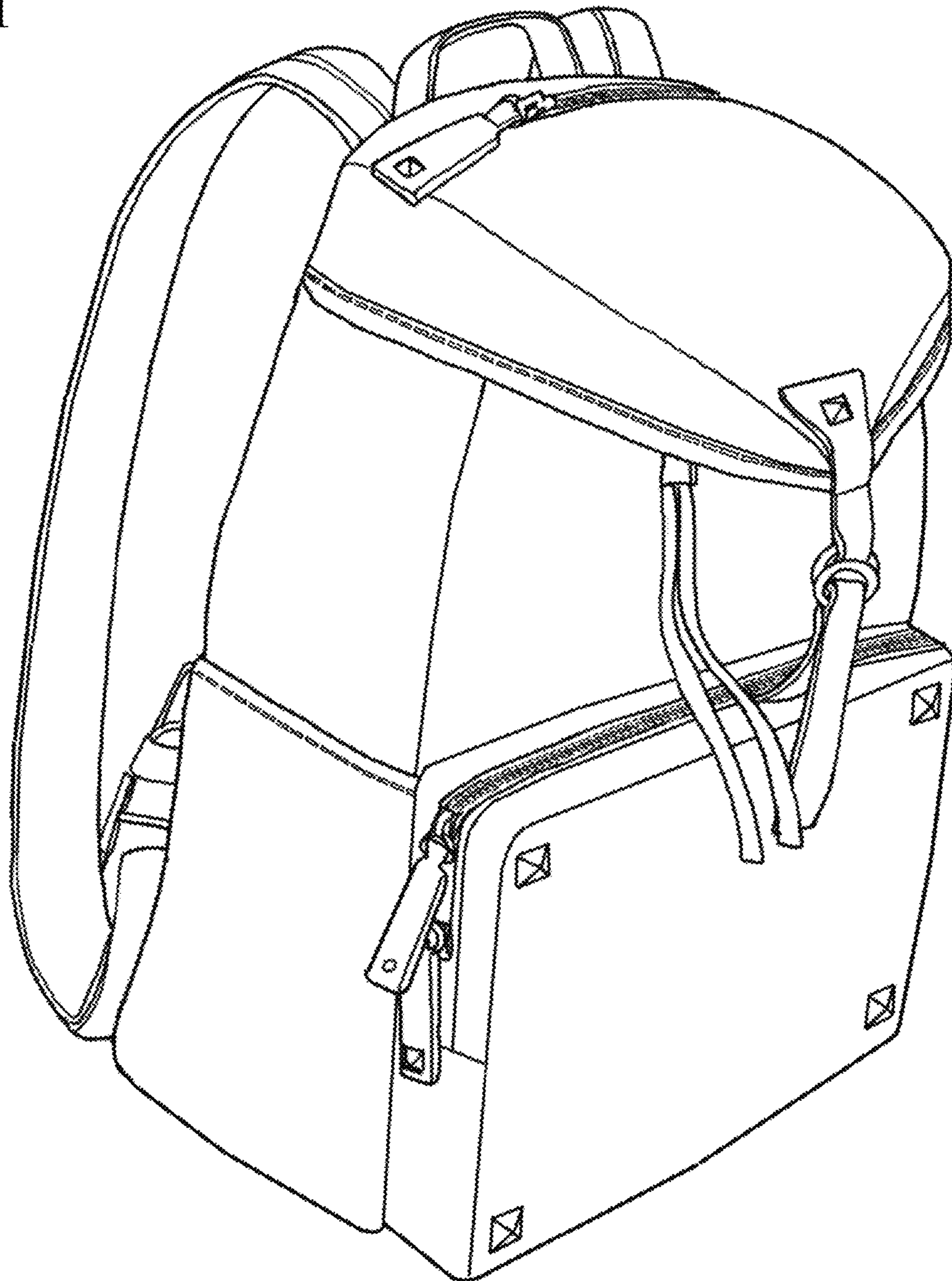

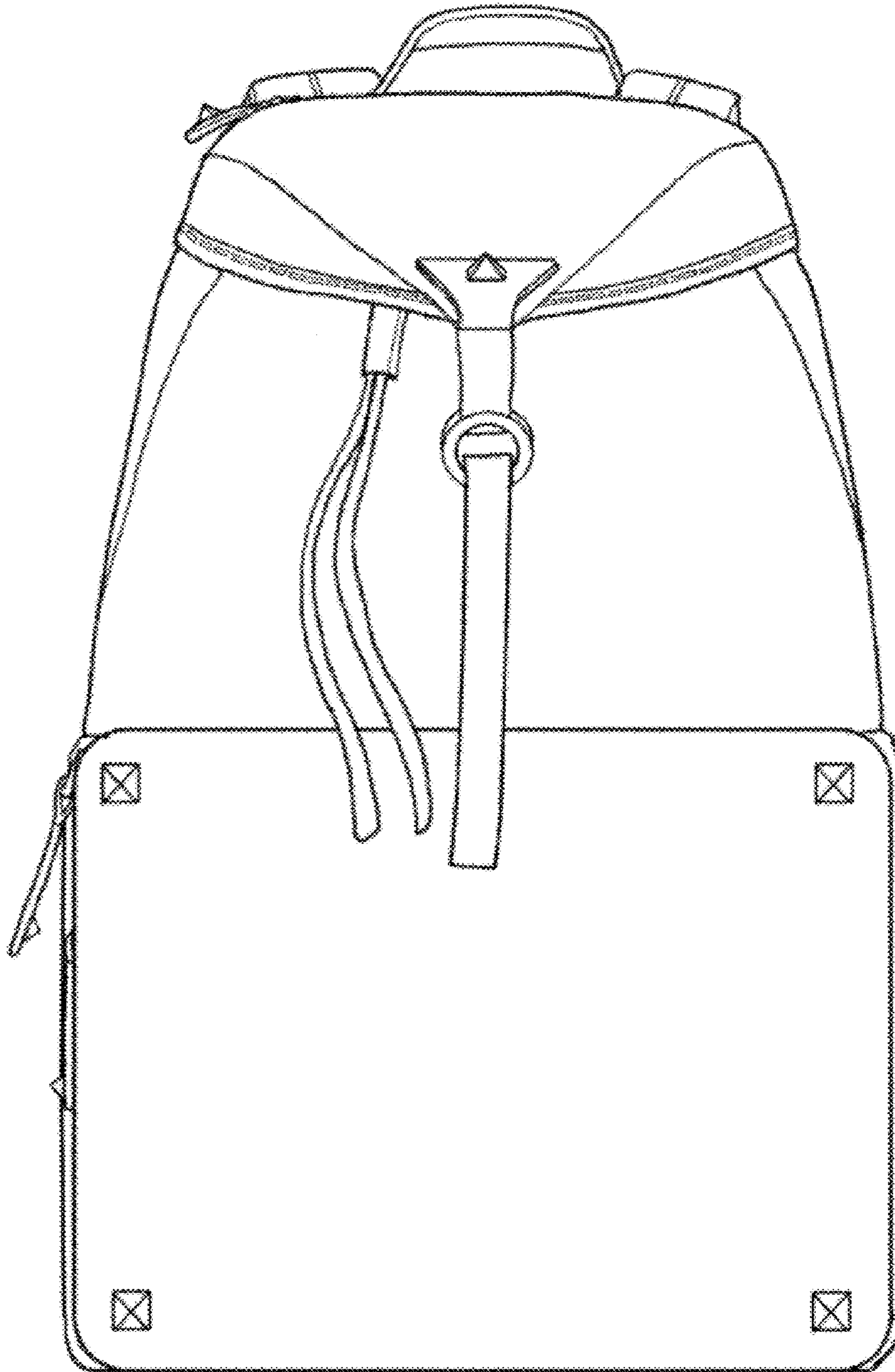

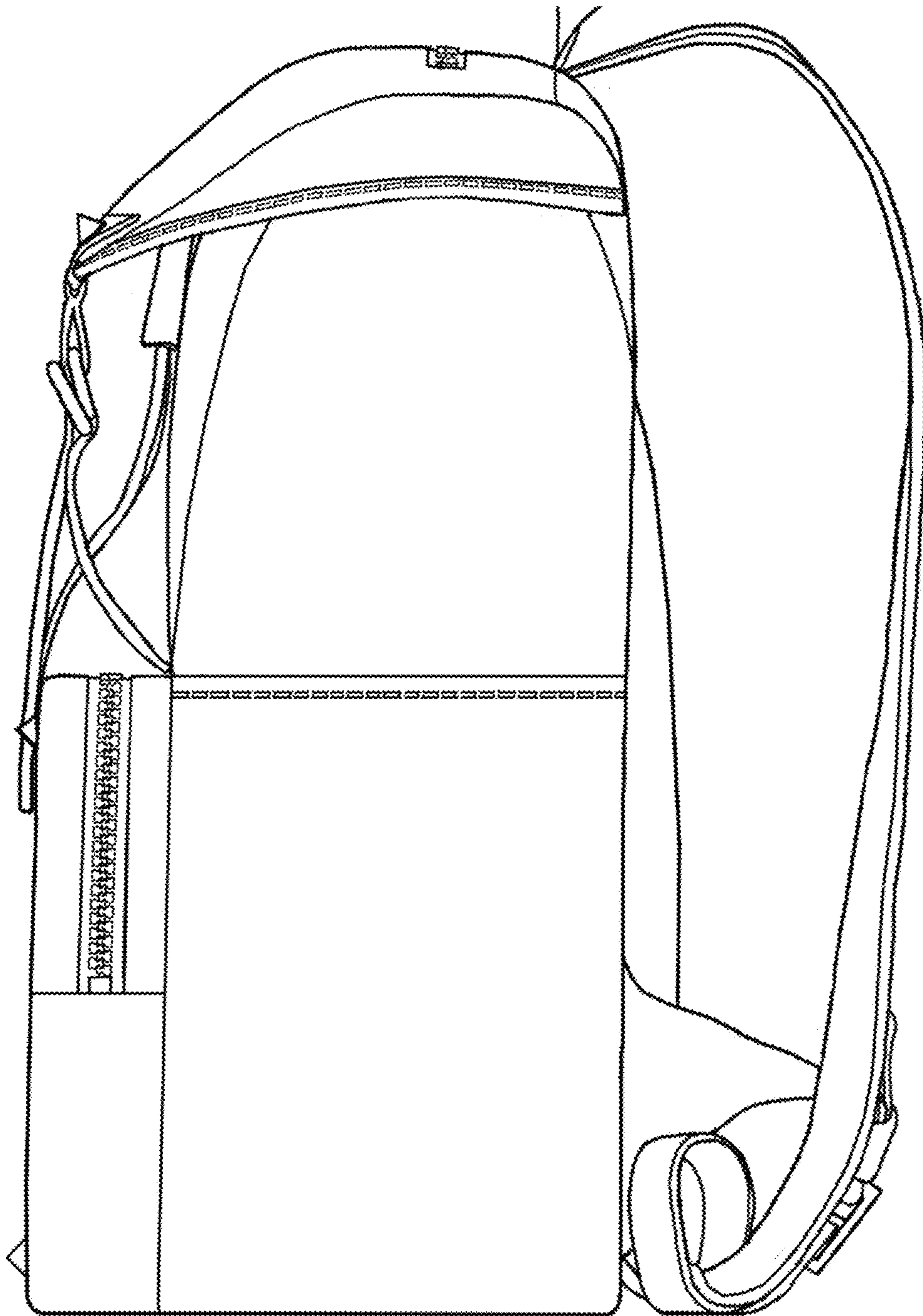

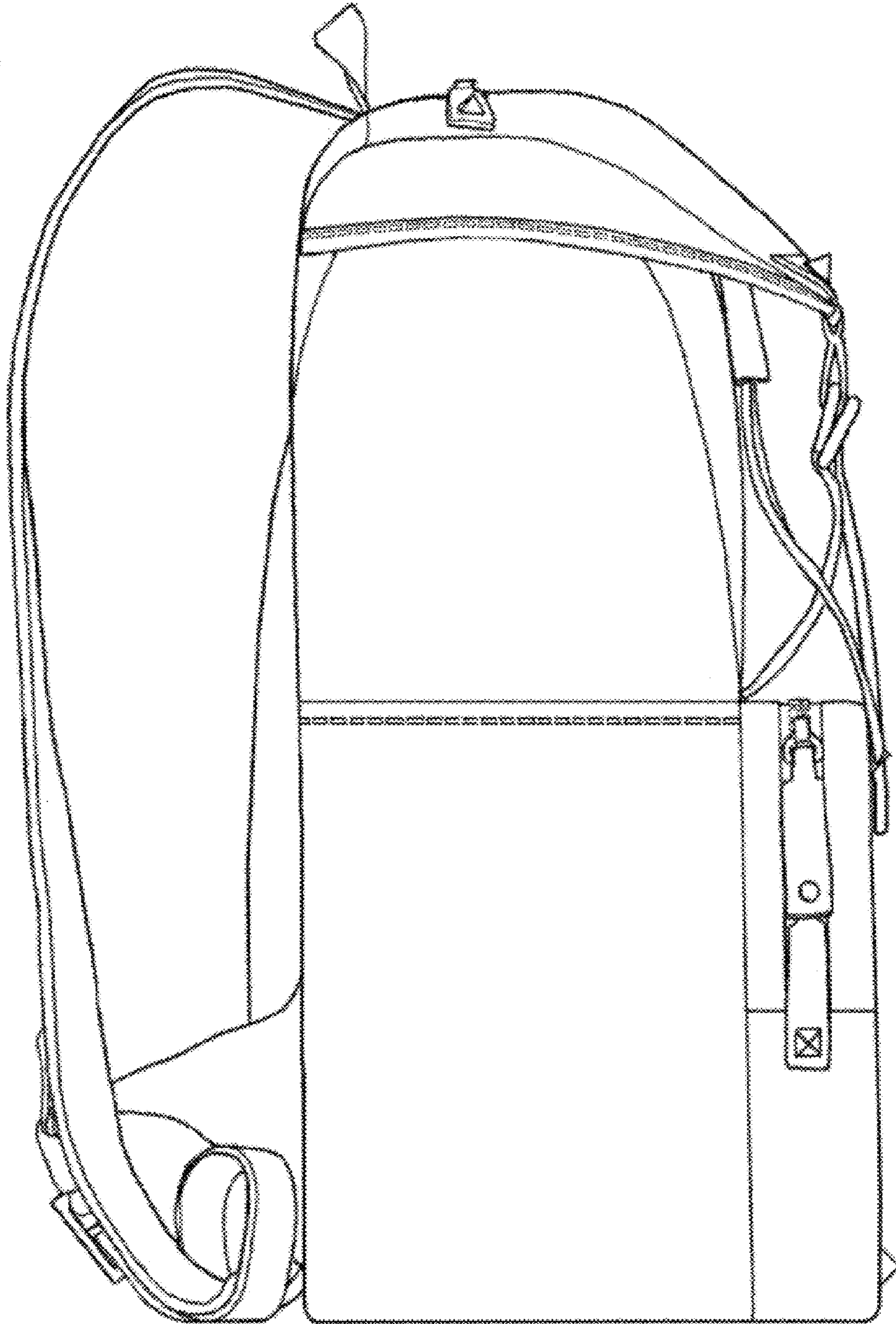

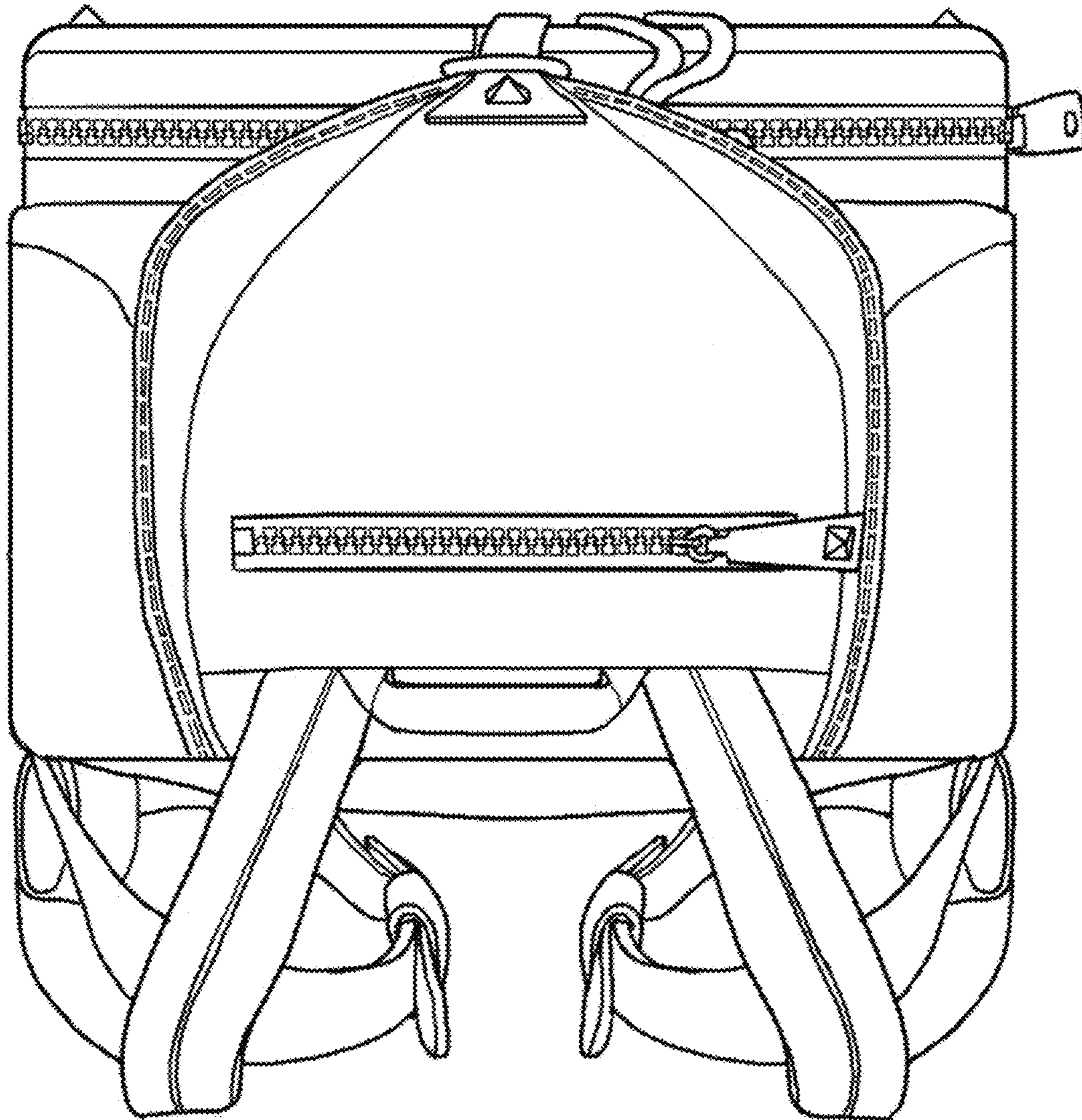
