The ornamental design for a nonwoven fabric, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a nonwoven fabric, embodying the new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a rear plan view thereof; and,
FIG. 4 is a cross-sectional view taken along line 4-4 of FIG. 2.
The broken lines shown in the drawings depict portions of the nonwoven fabric that form no part of the claimed design.

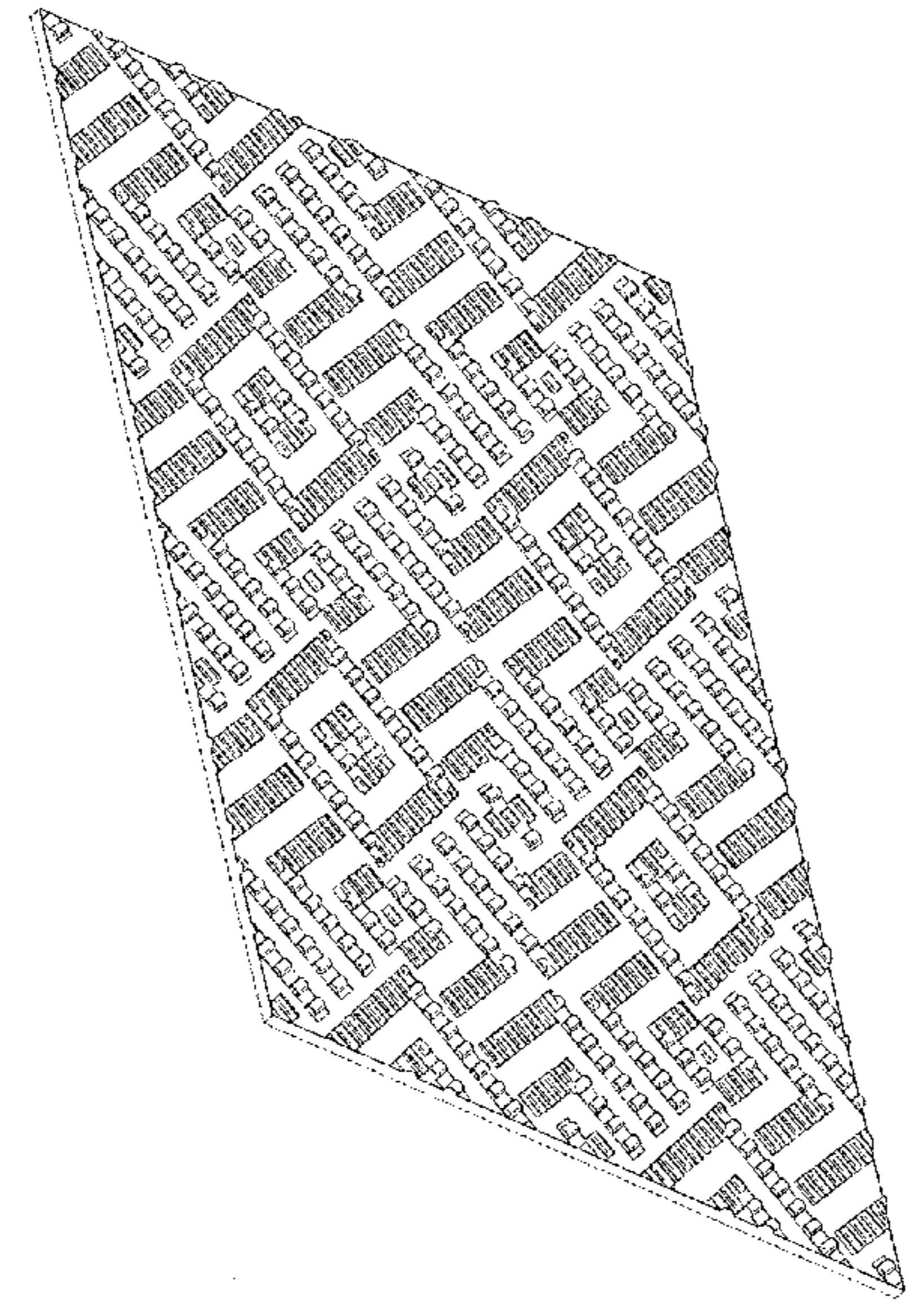

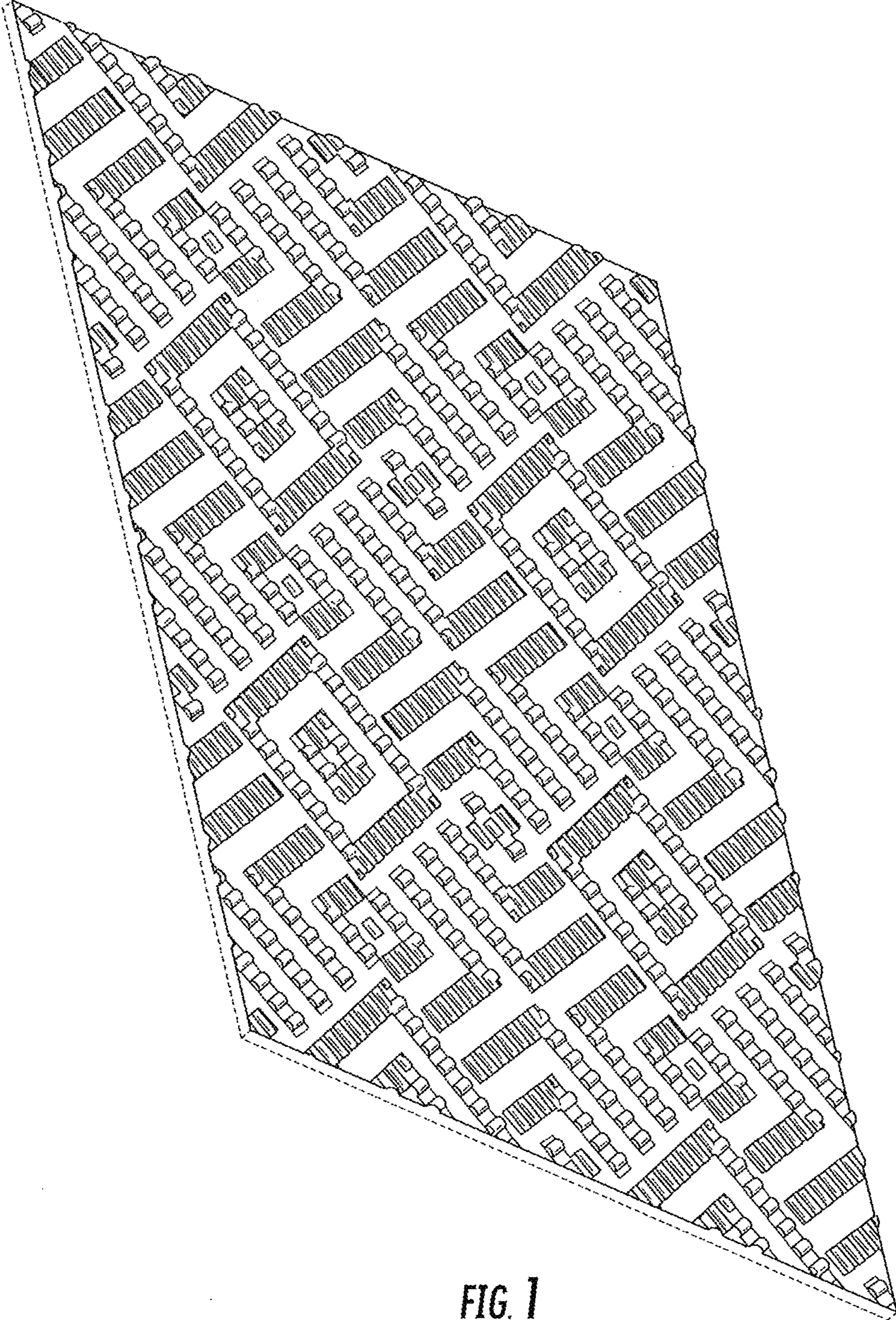

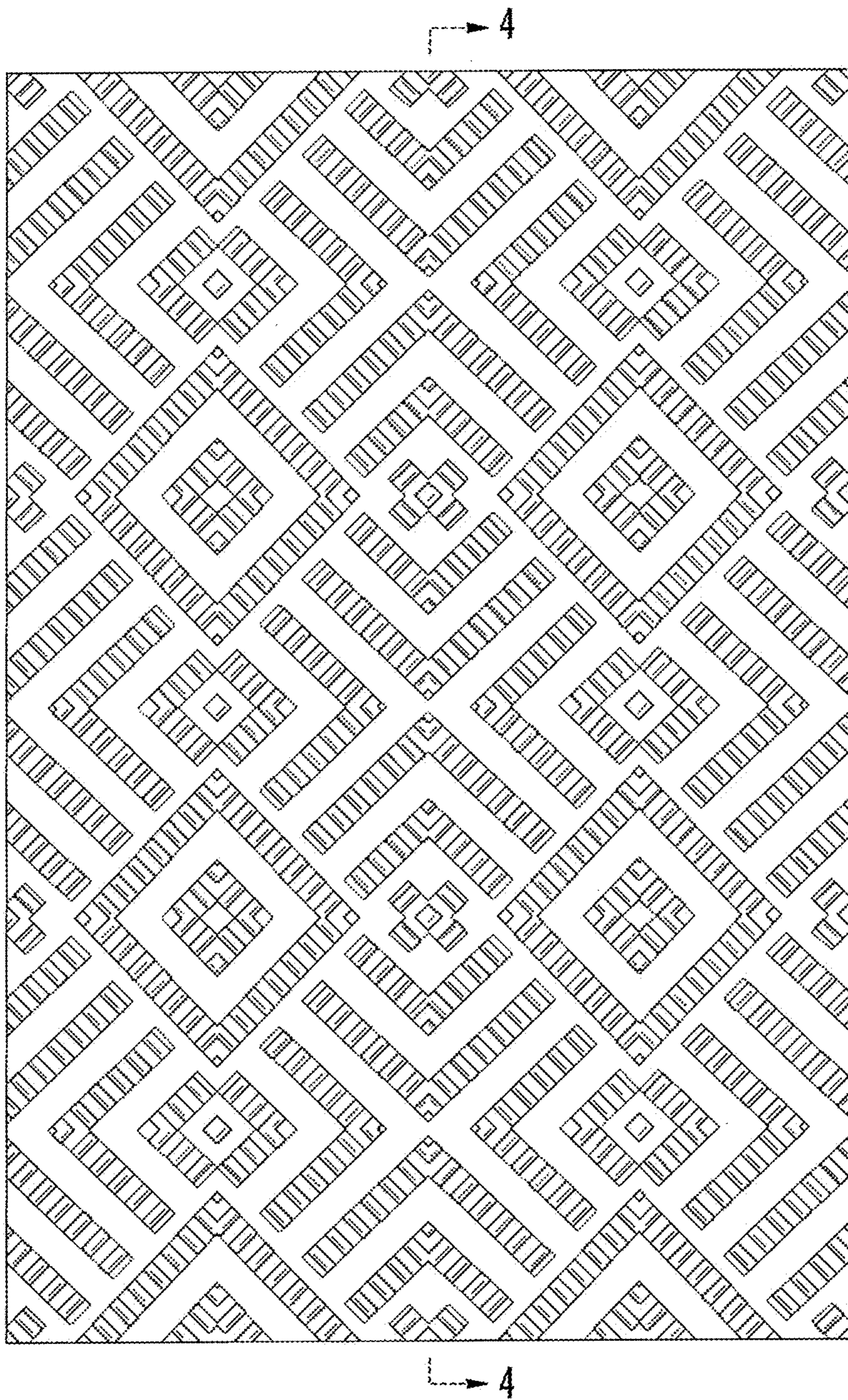

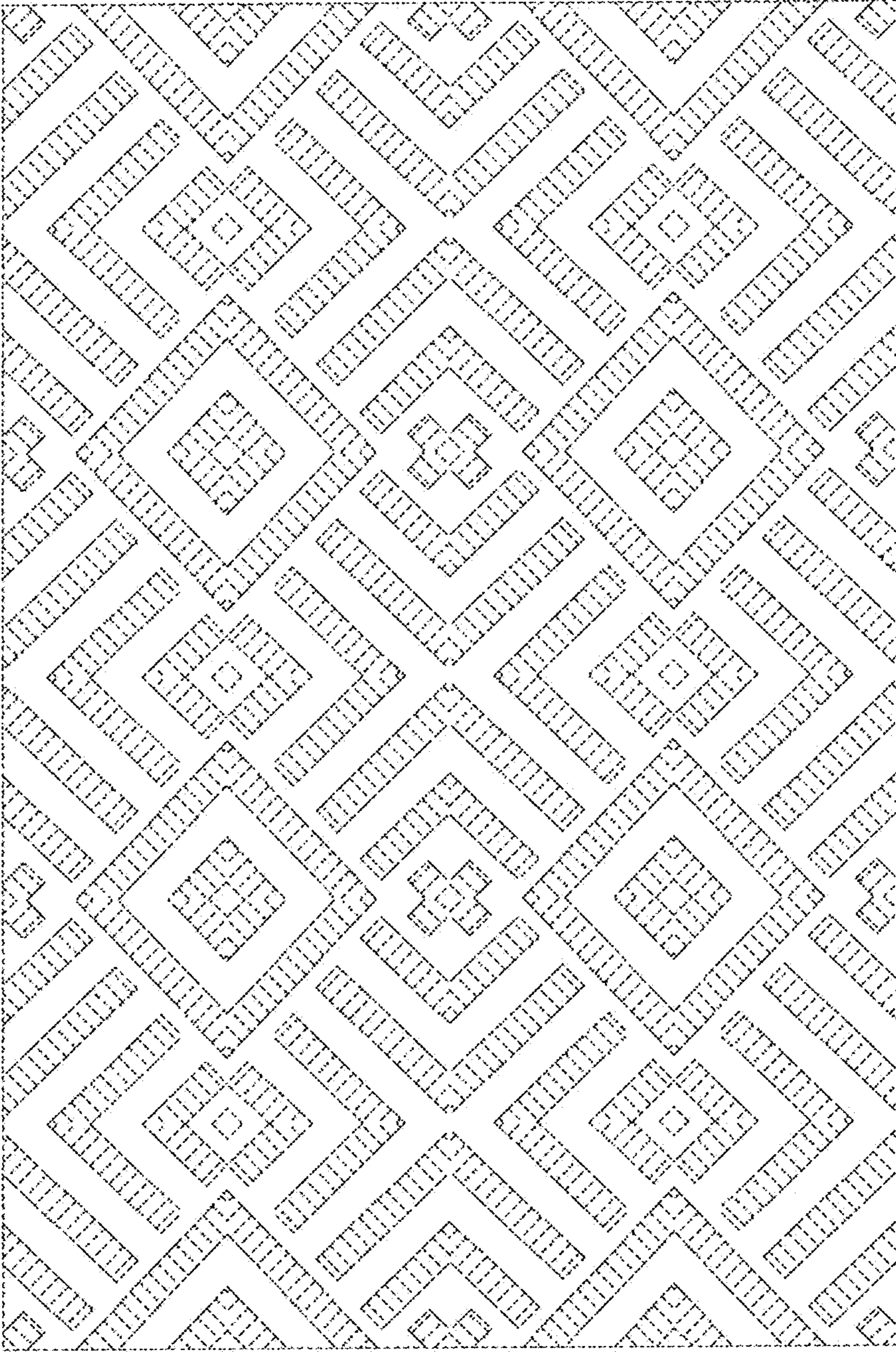

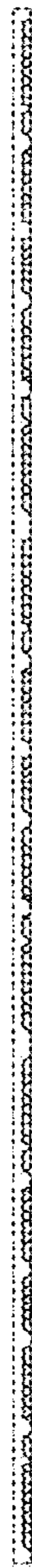
