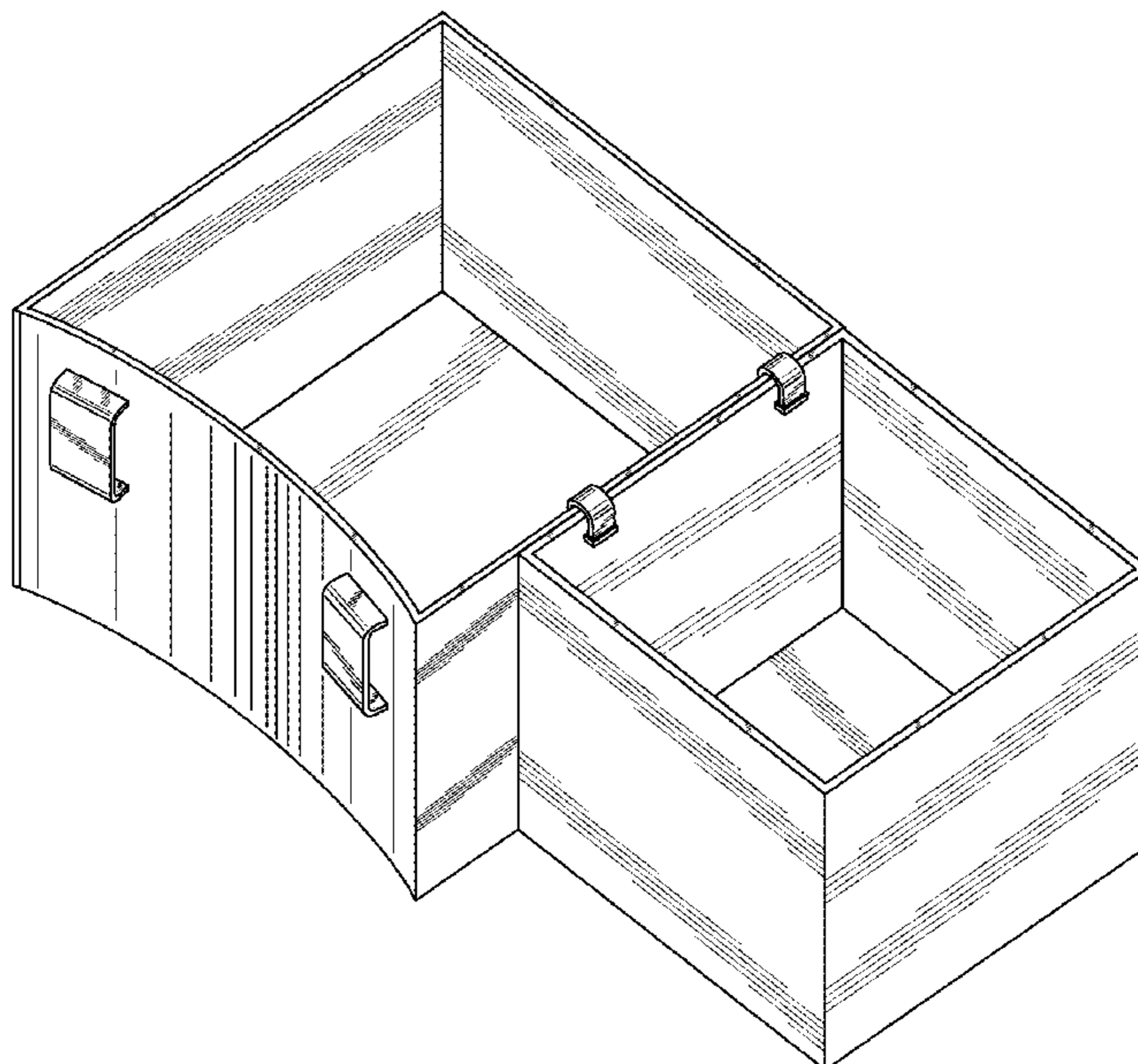
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective front view of the drywall tape box assembly, showing my new design;

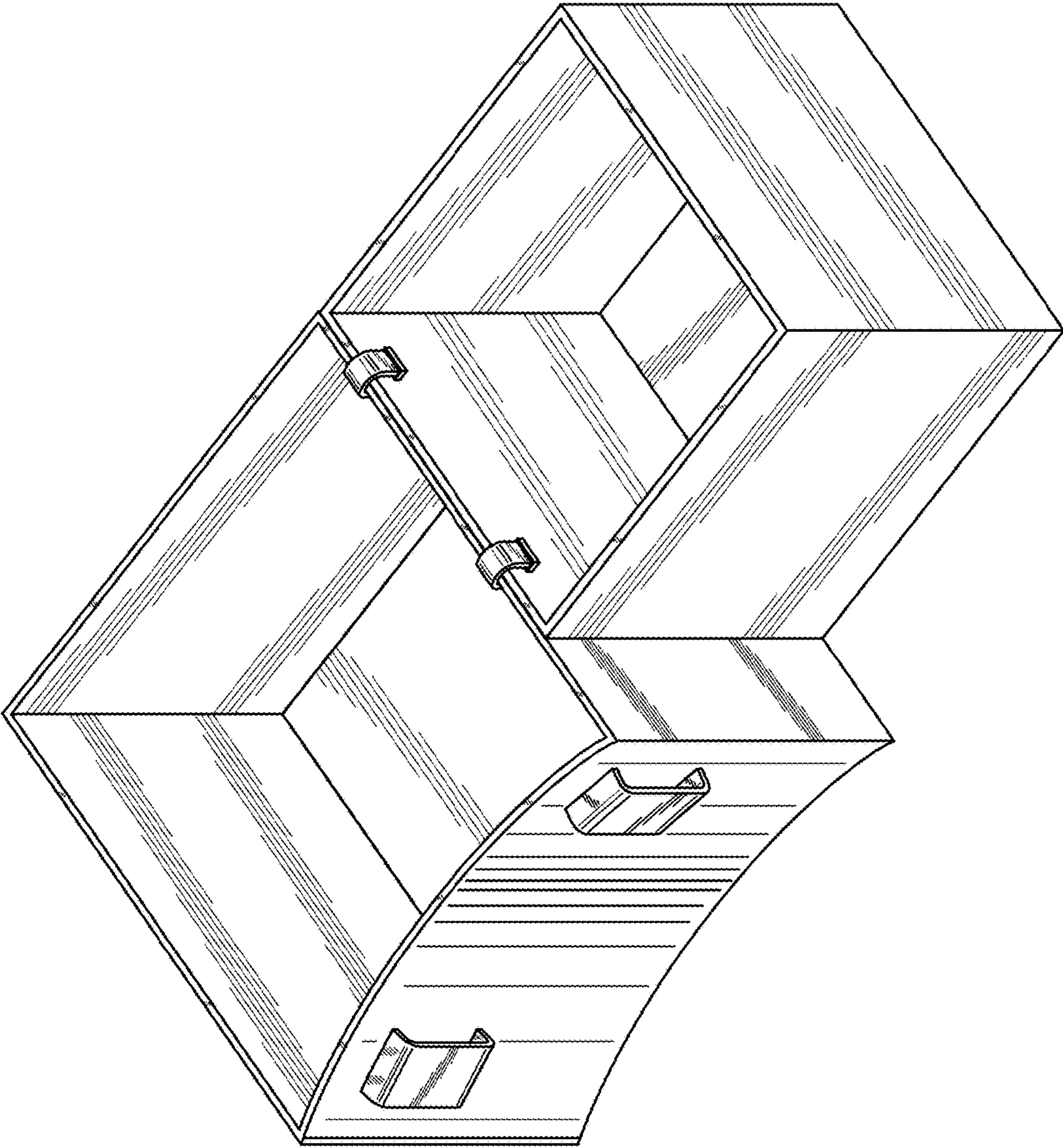

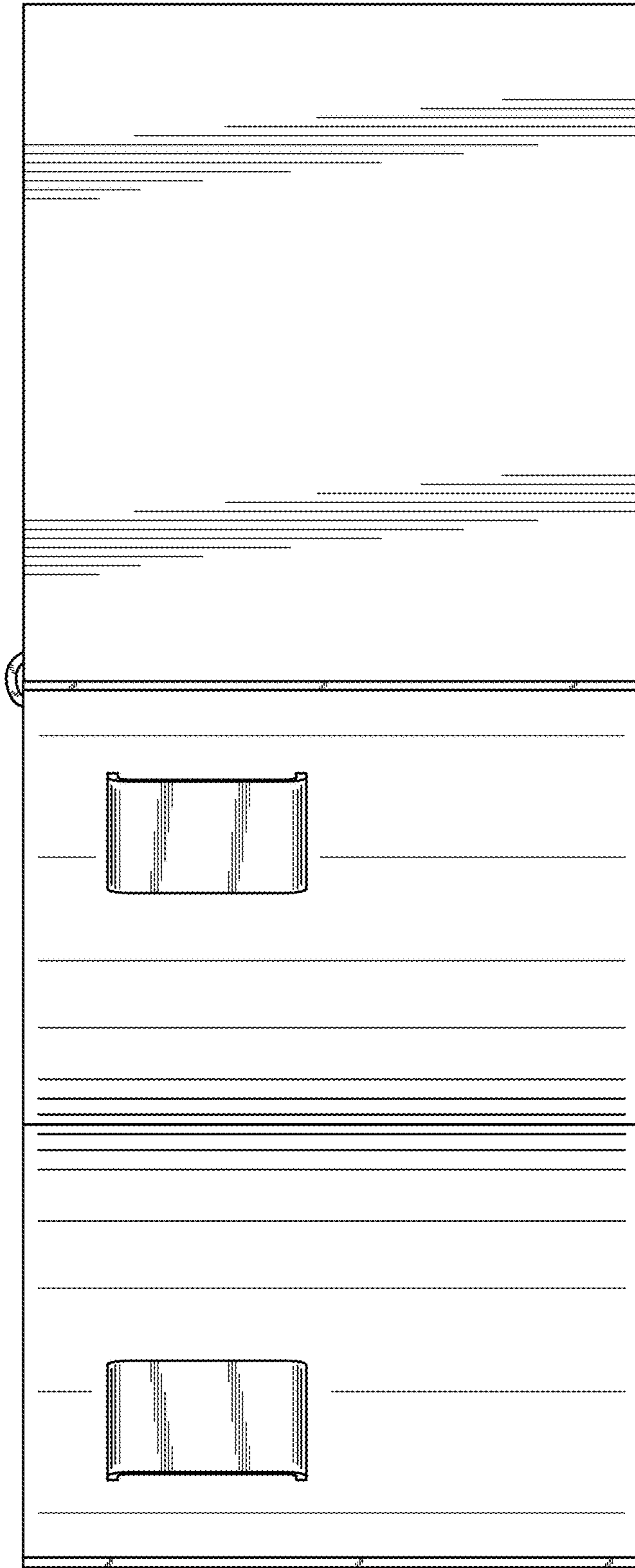

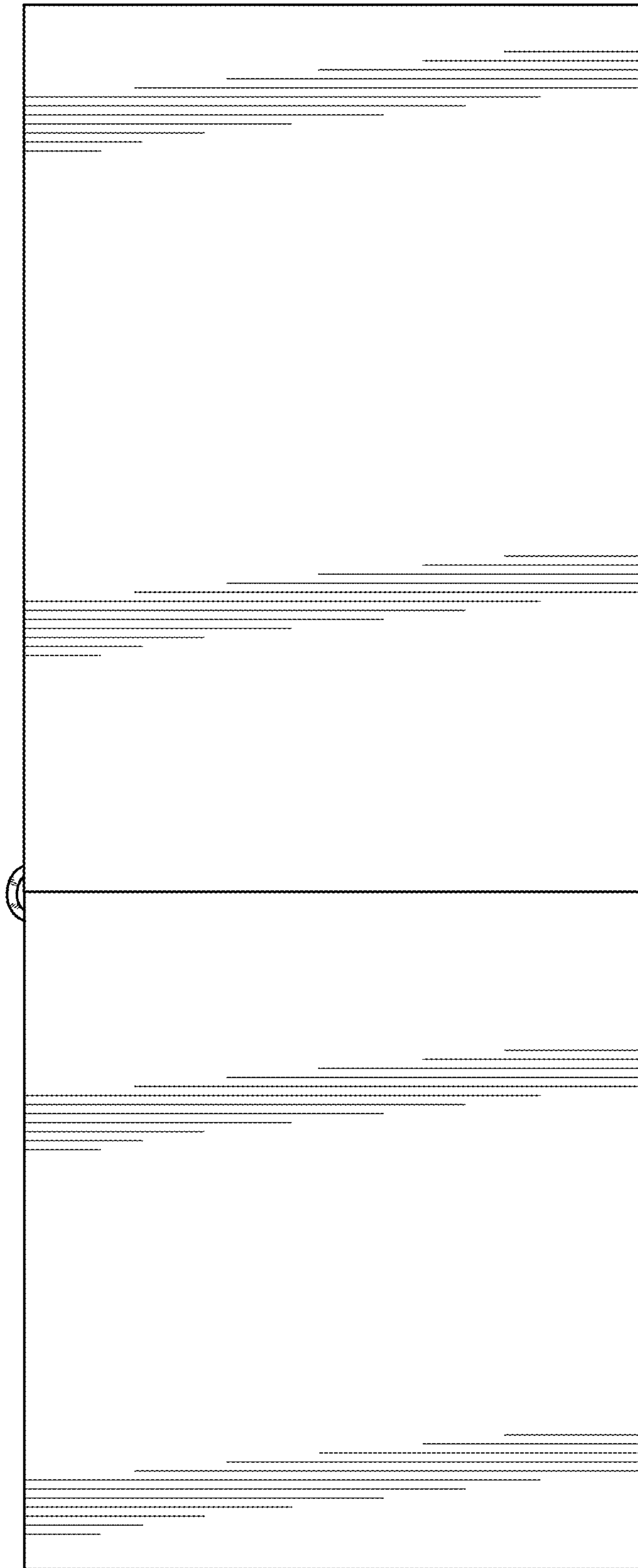

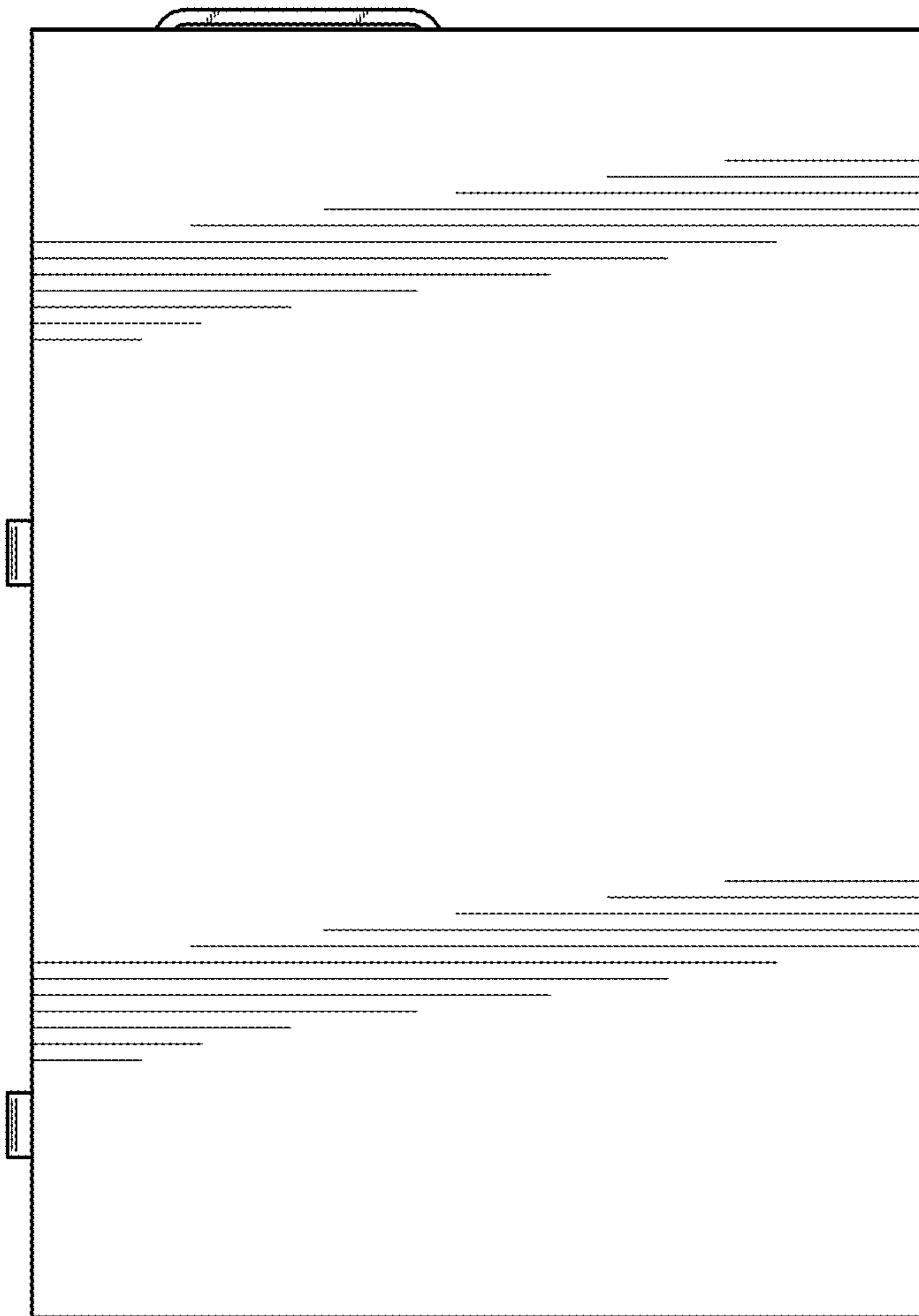

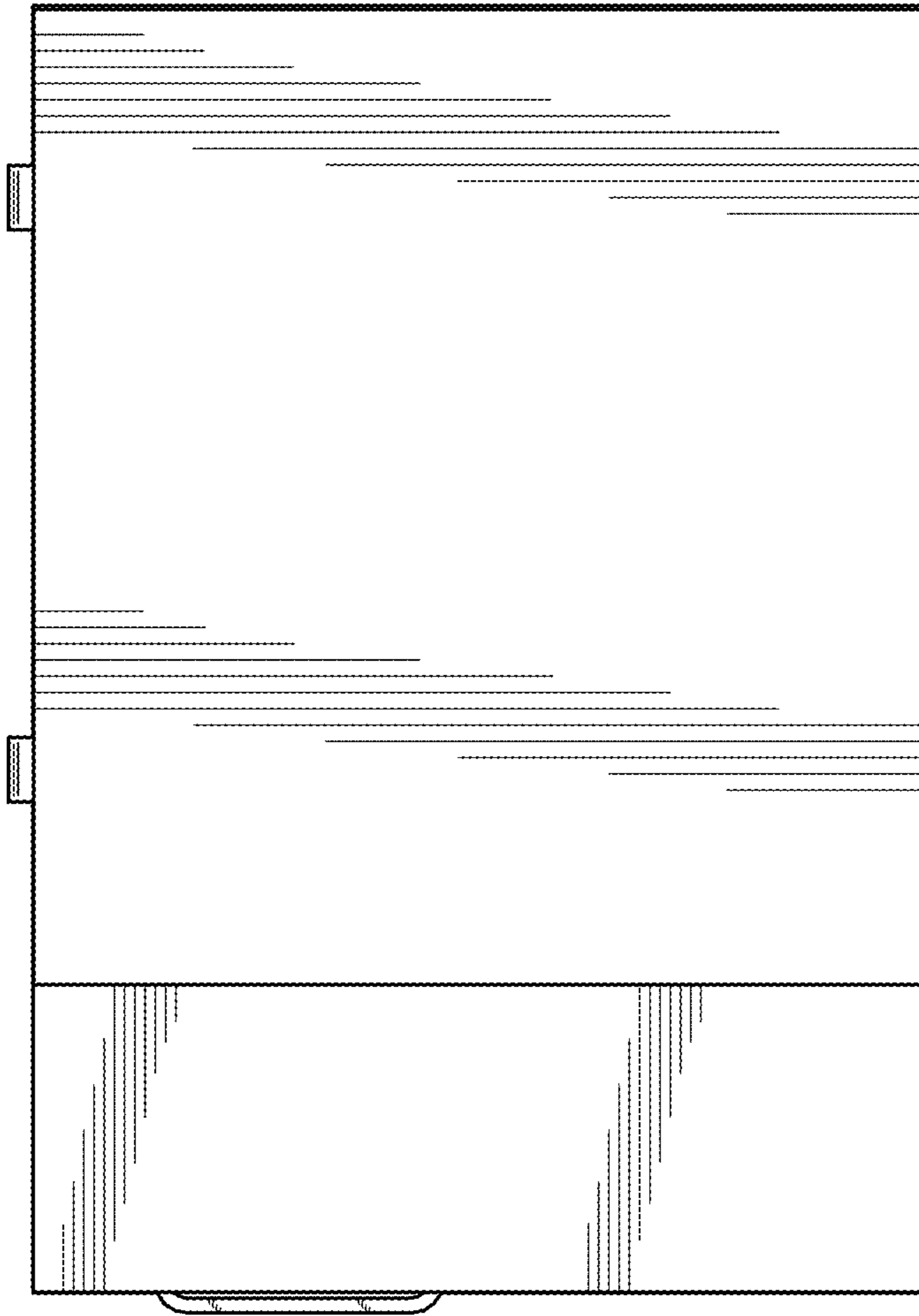

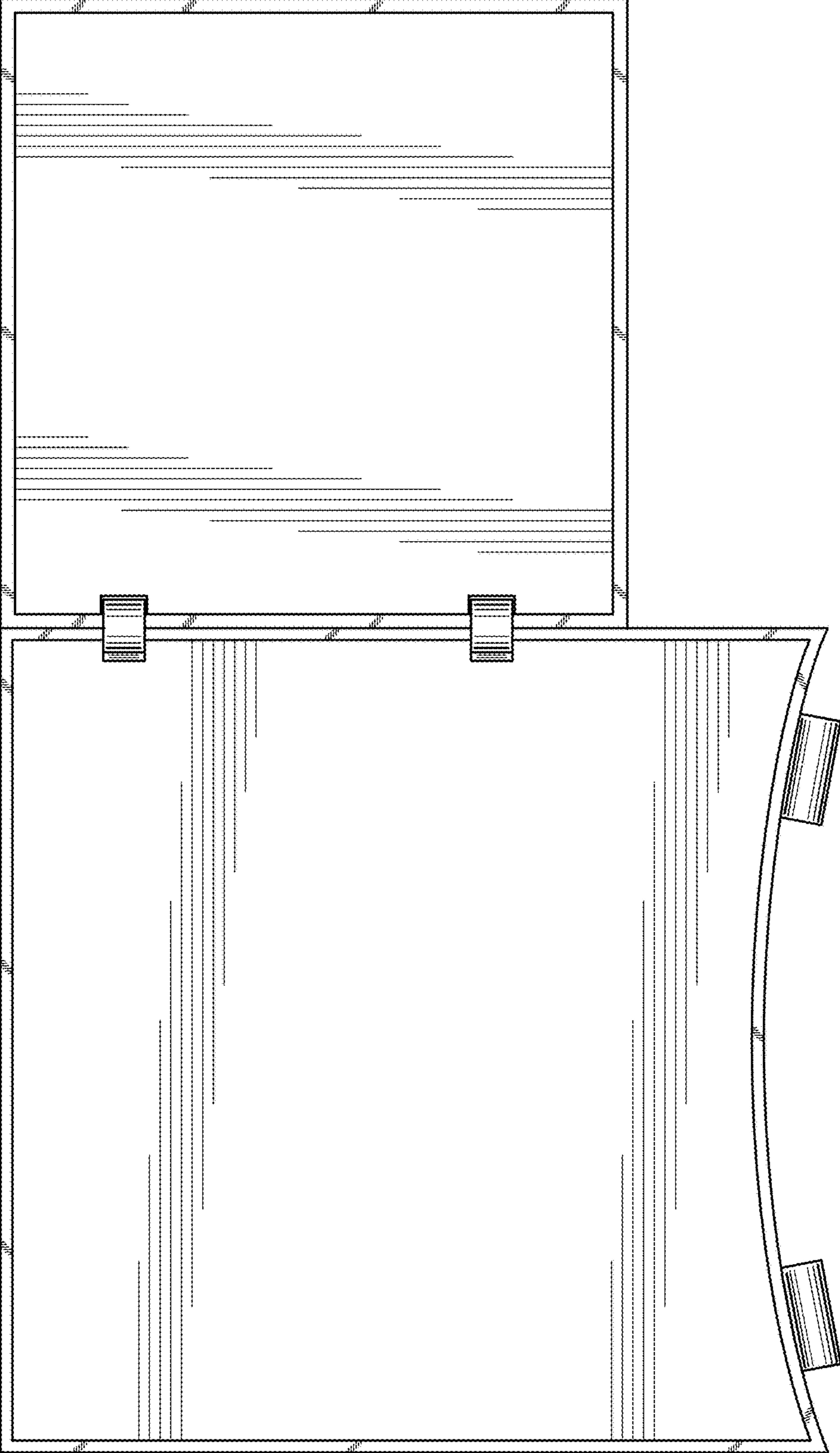

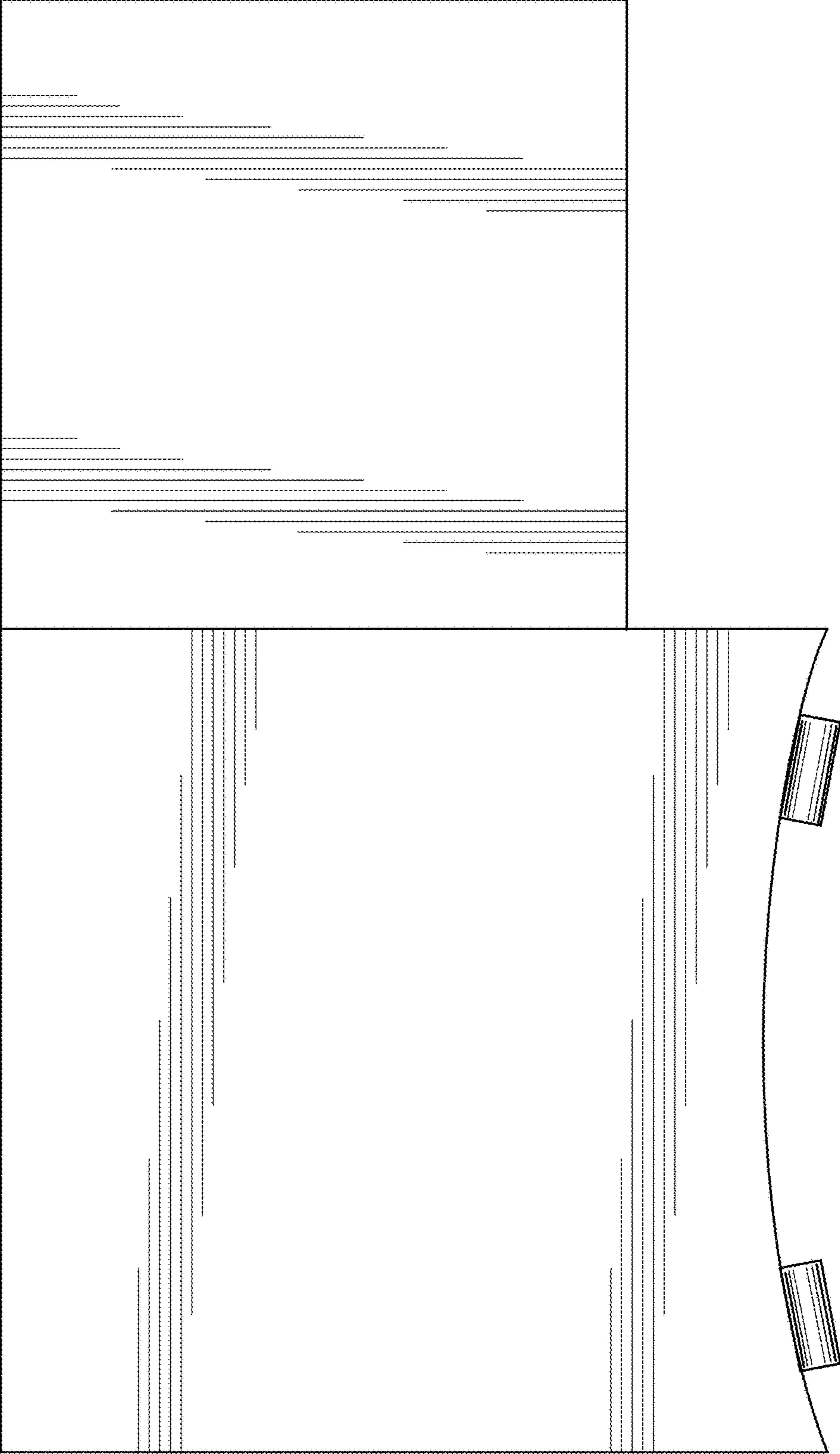
