DESCRIPTION

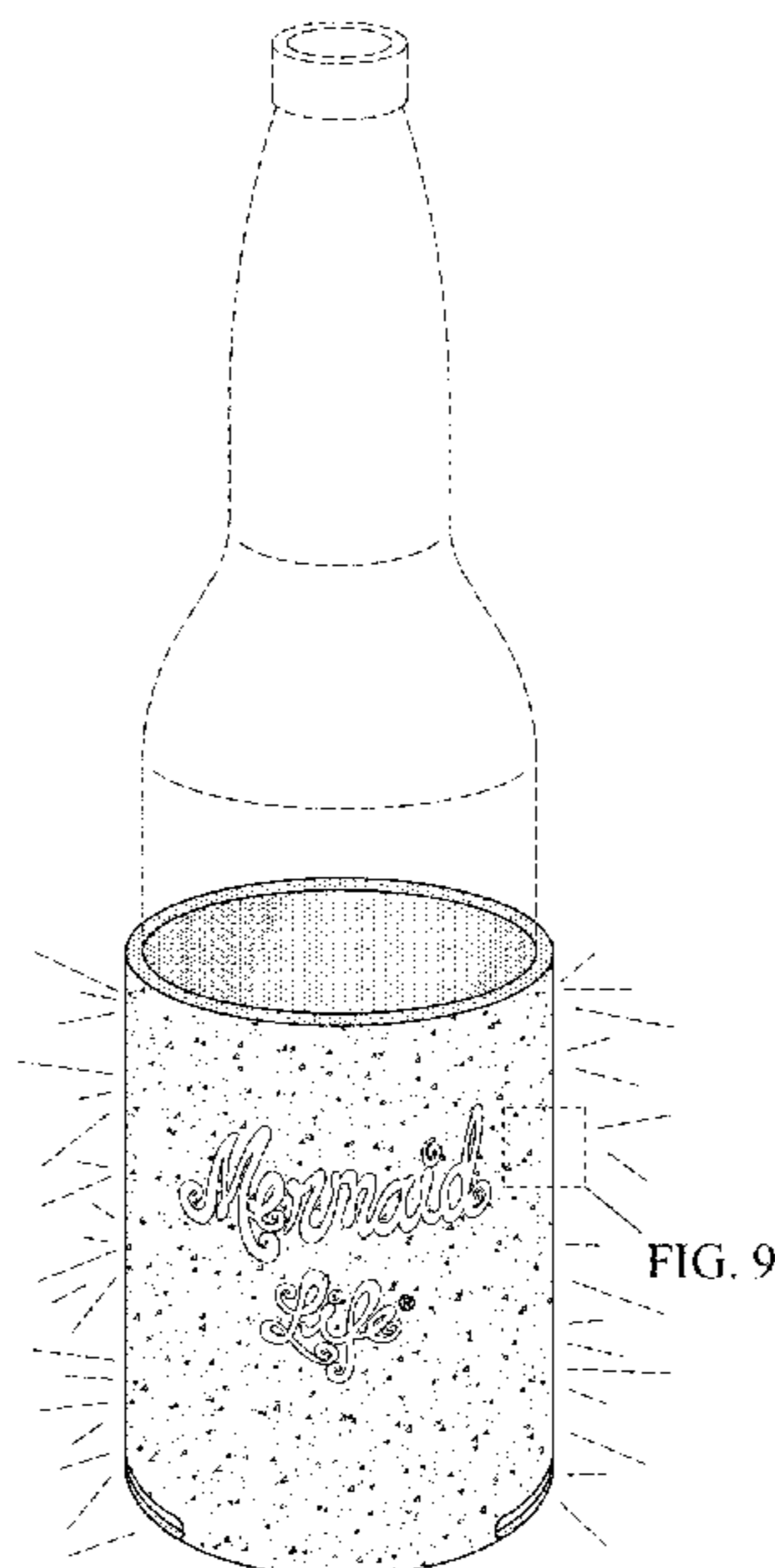
FIG. 1 is a front perspective view of an insulated beverage holder showing my new design, also showing a beverage bottle contained therein;

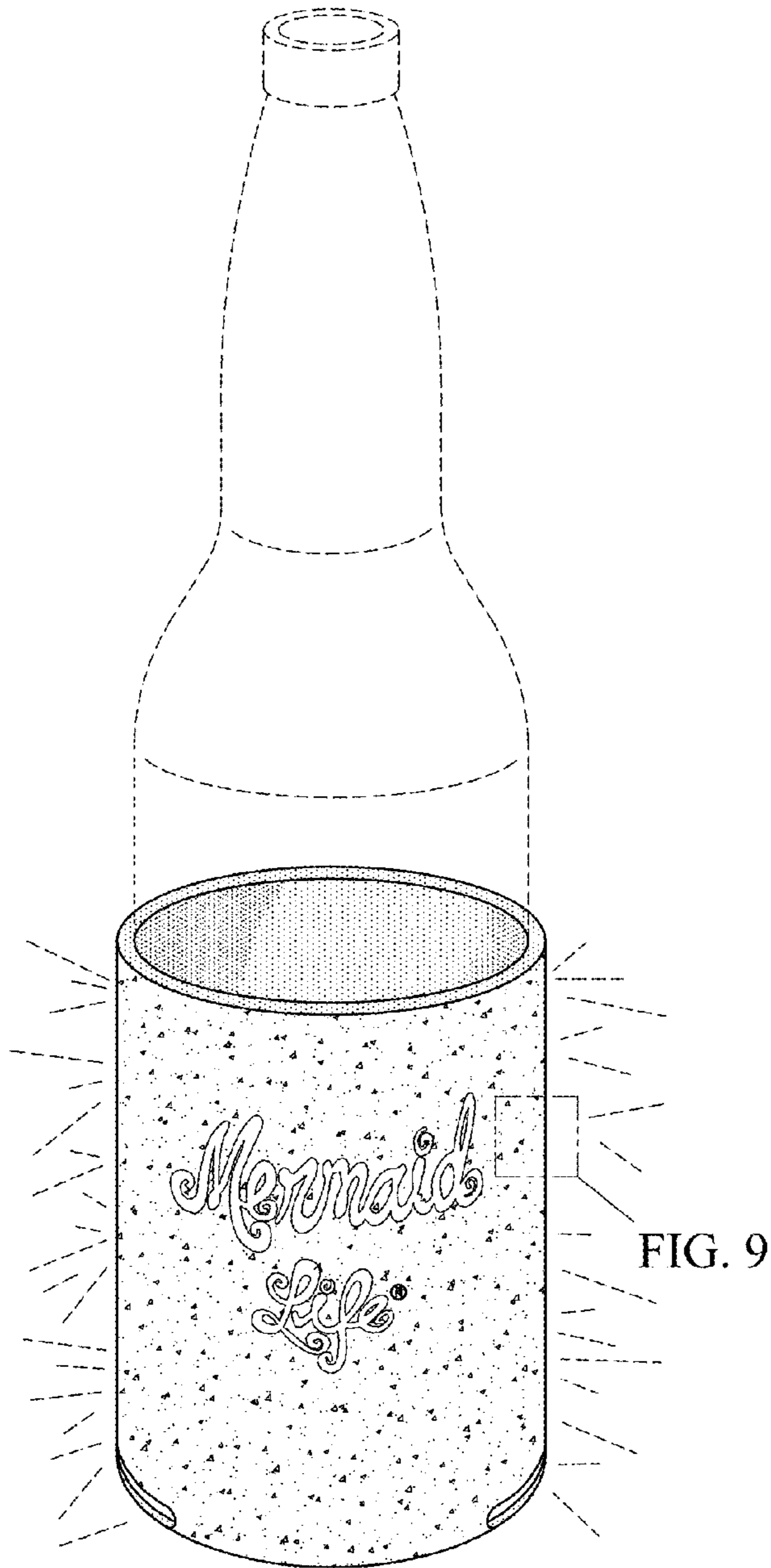

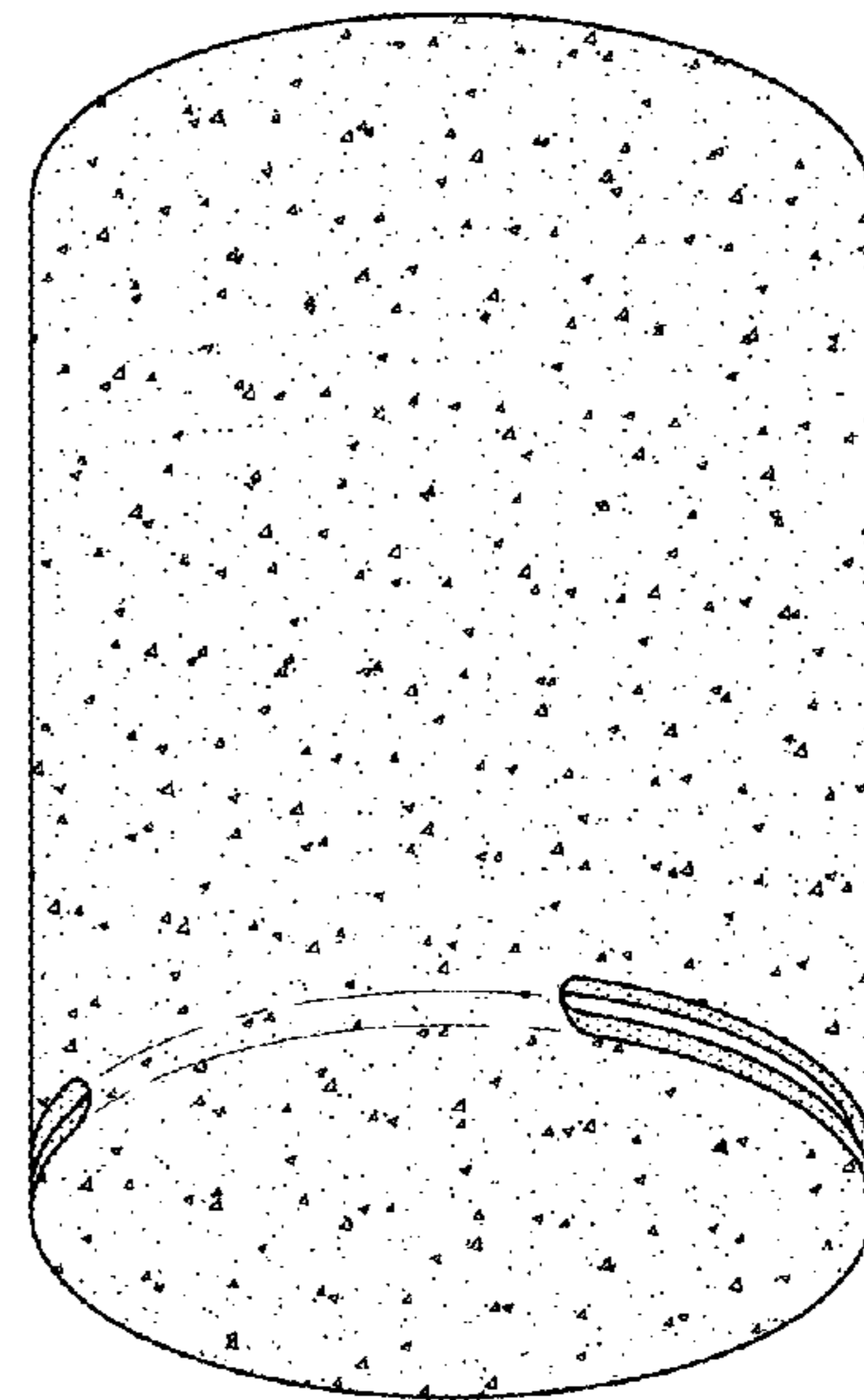

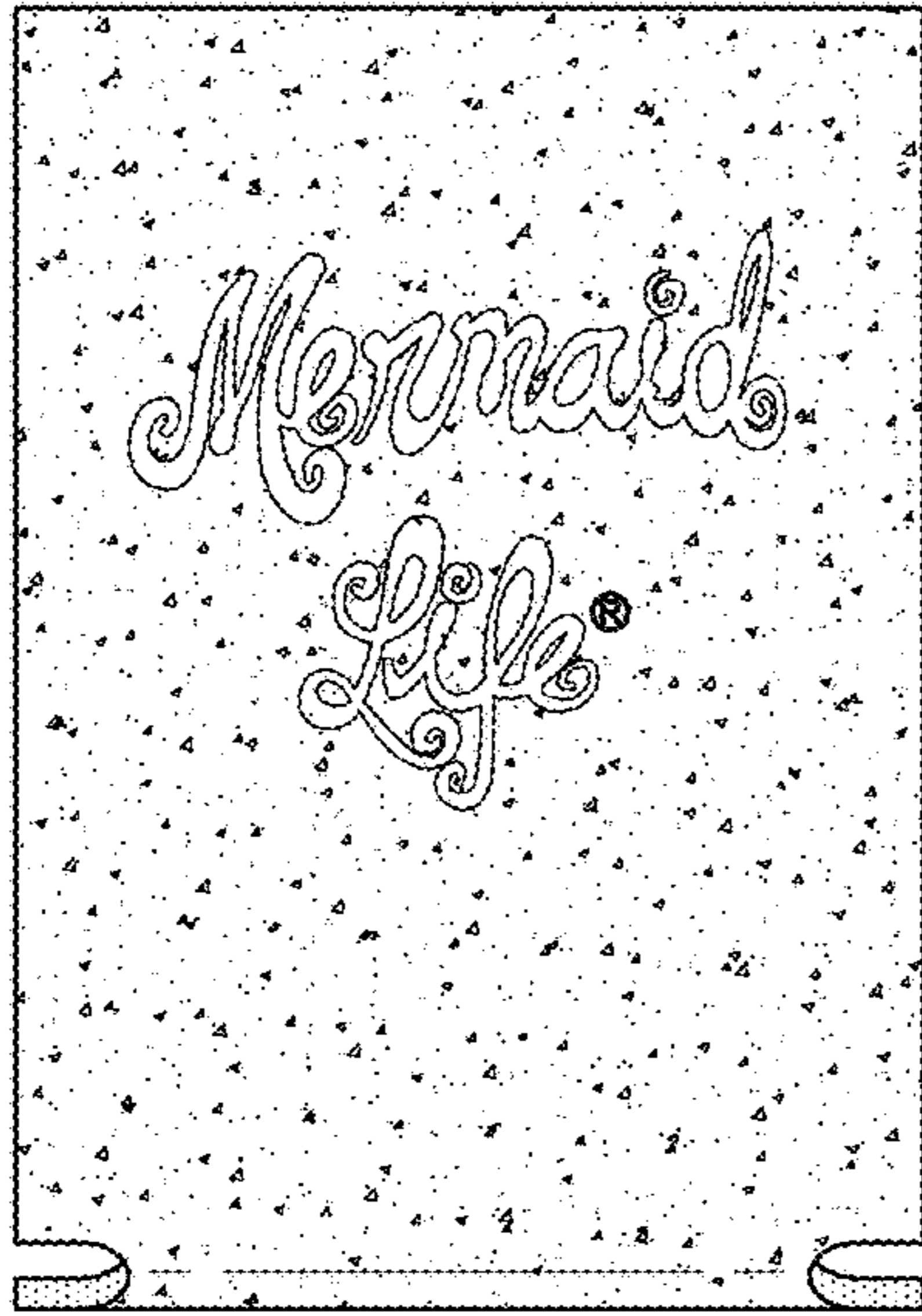

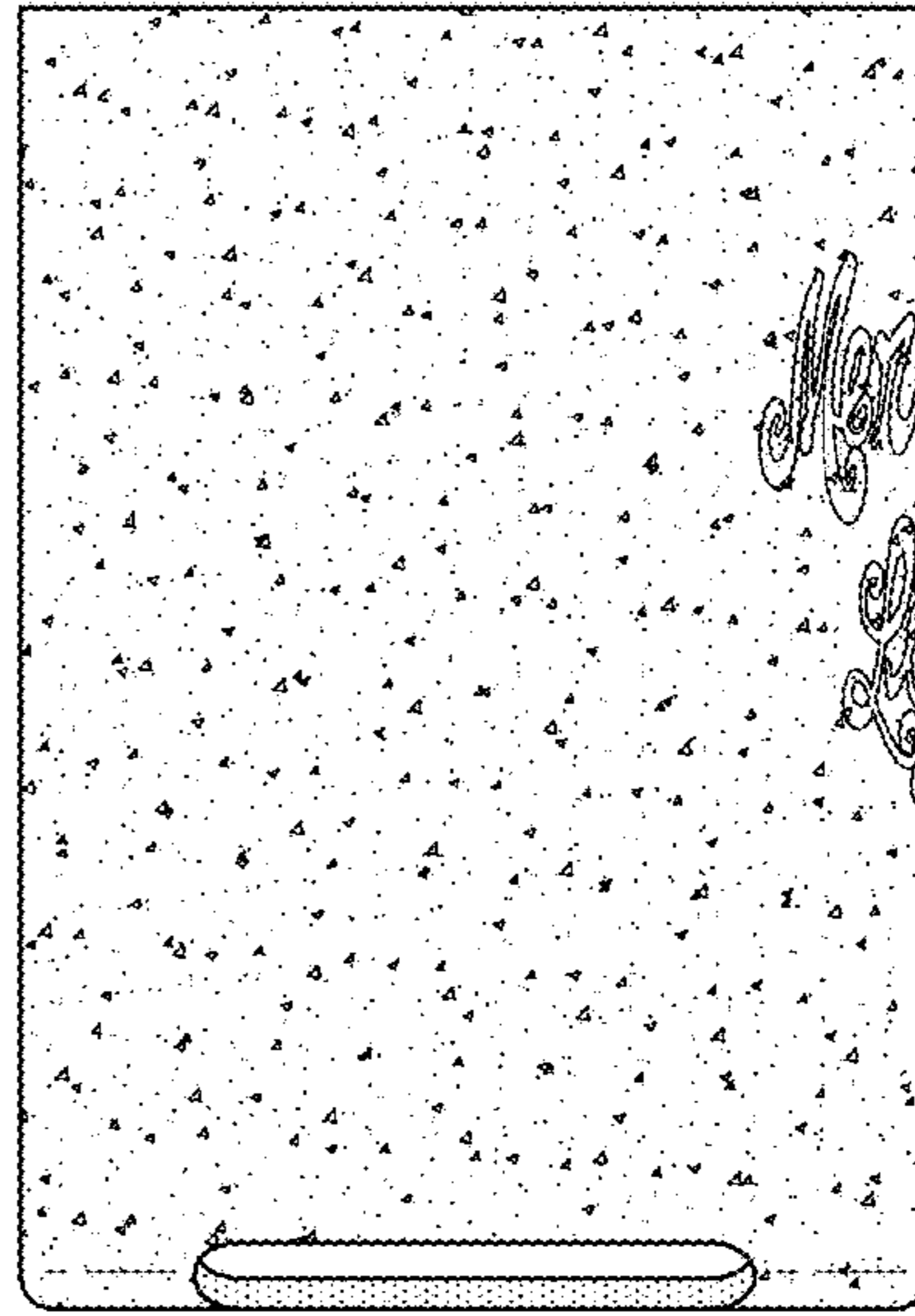

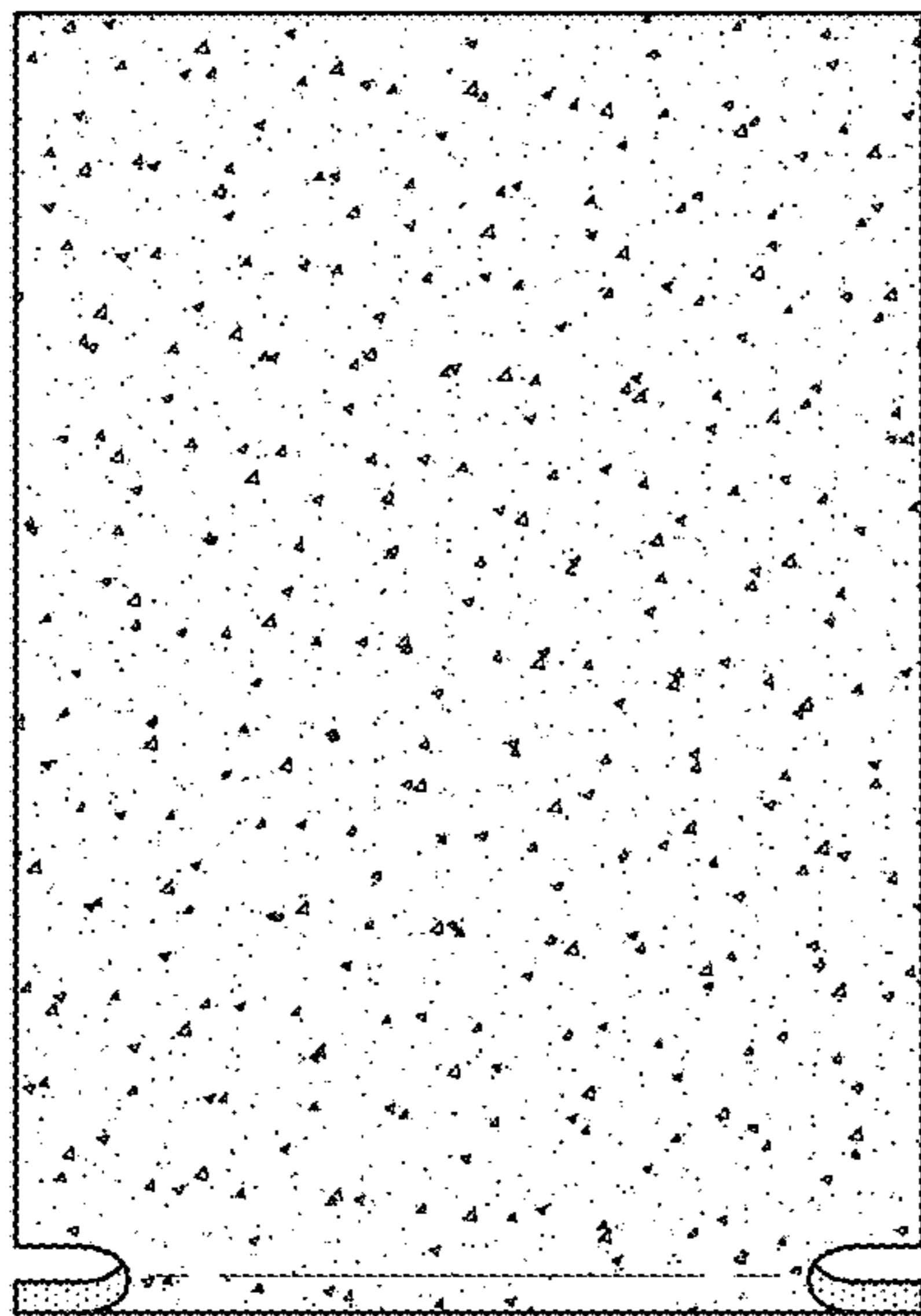

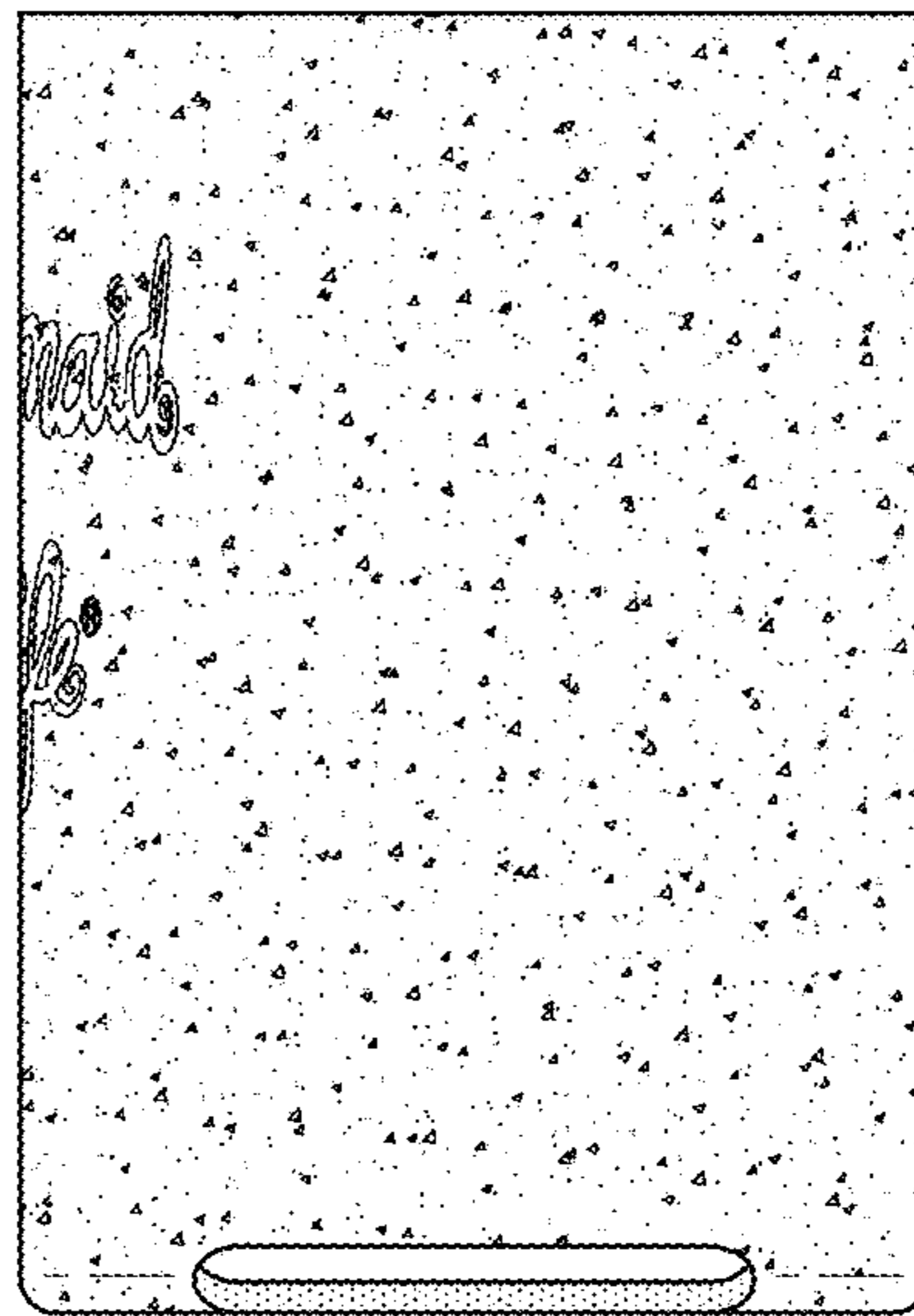

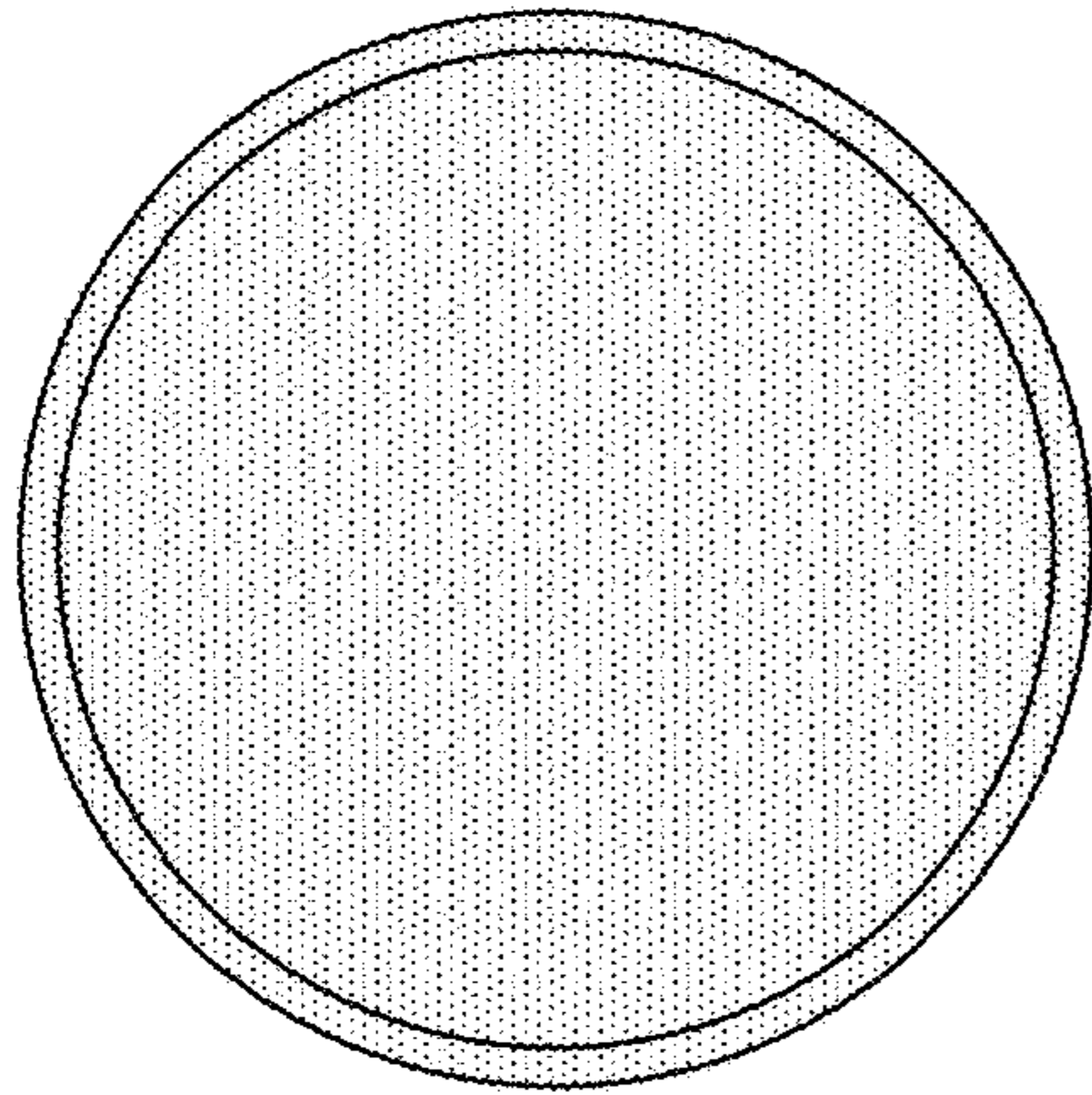

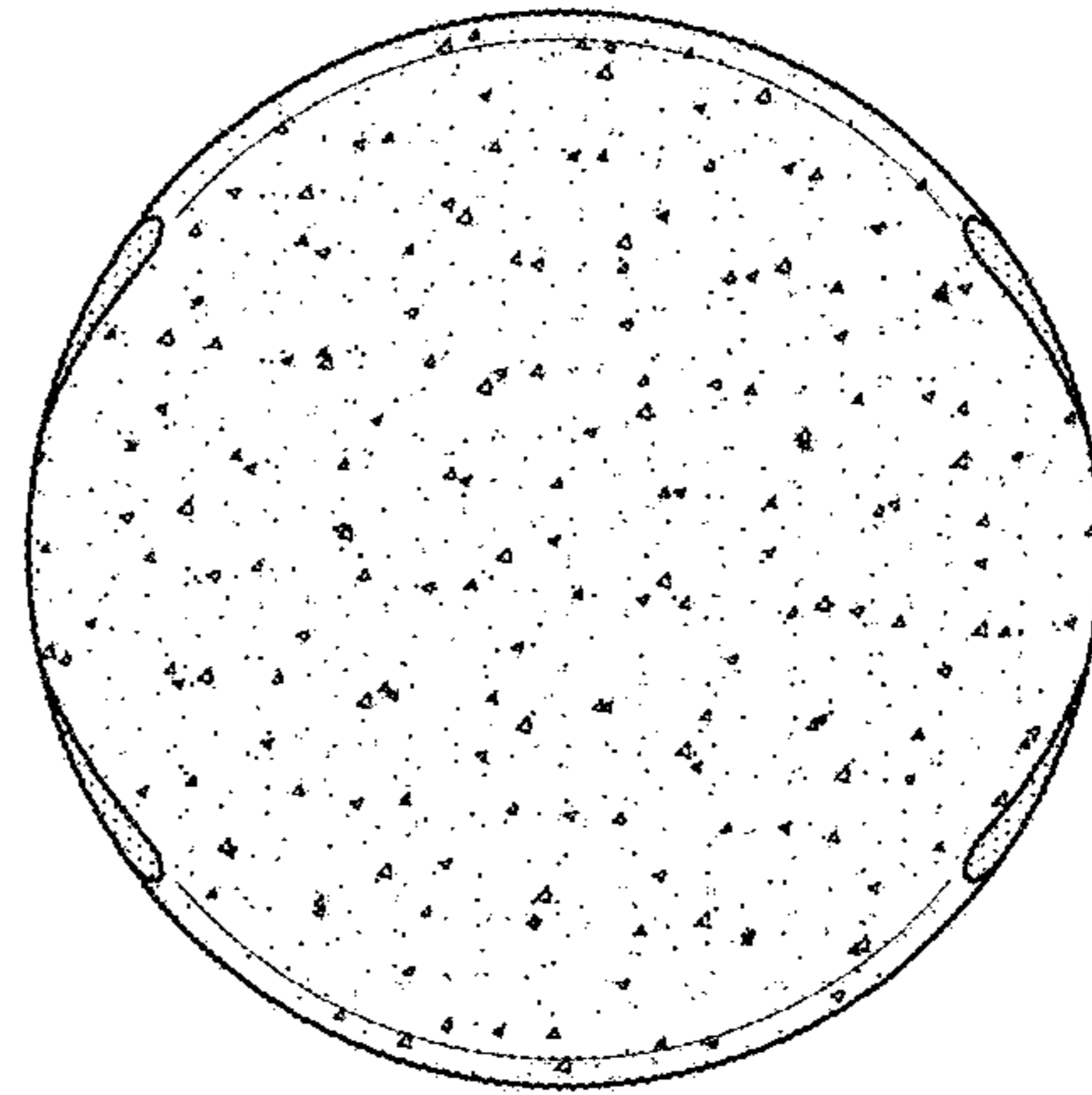

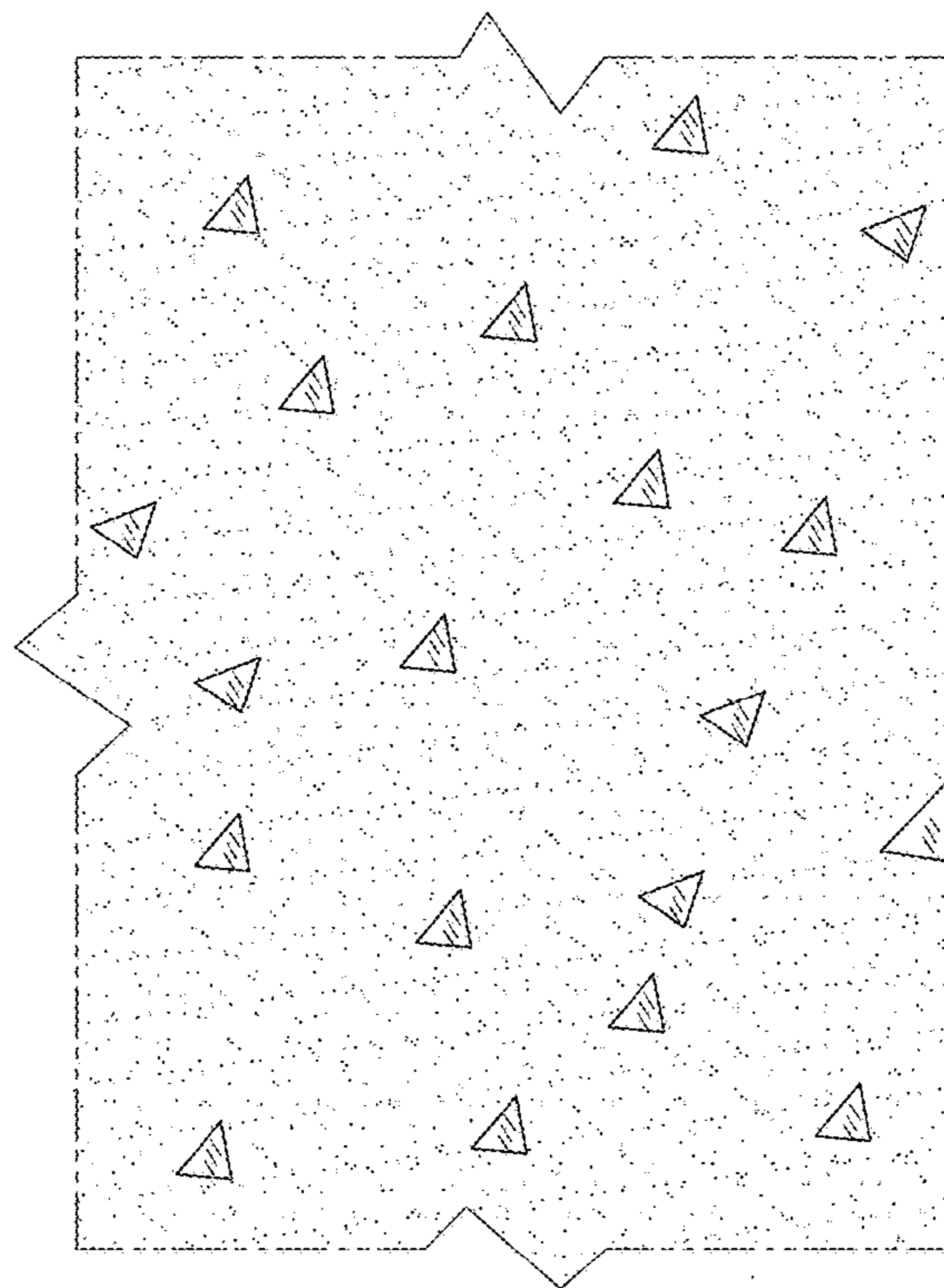
