**DESCRIPTION**

FIG. 1 is a front perspective view of a motor vehicle, toy and/or replica;

FIG. 3 is a right side elevation view thereof, the left side being substantially a mirror image;

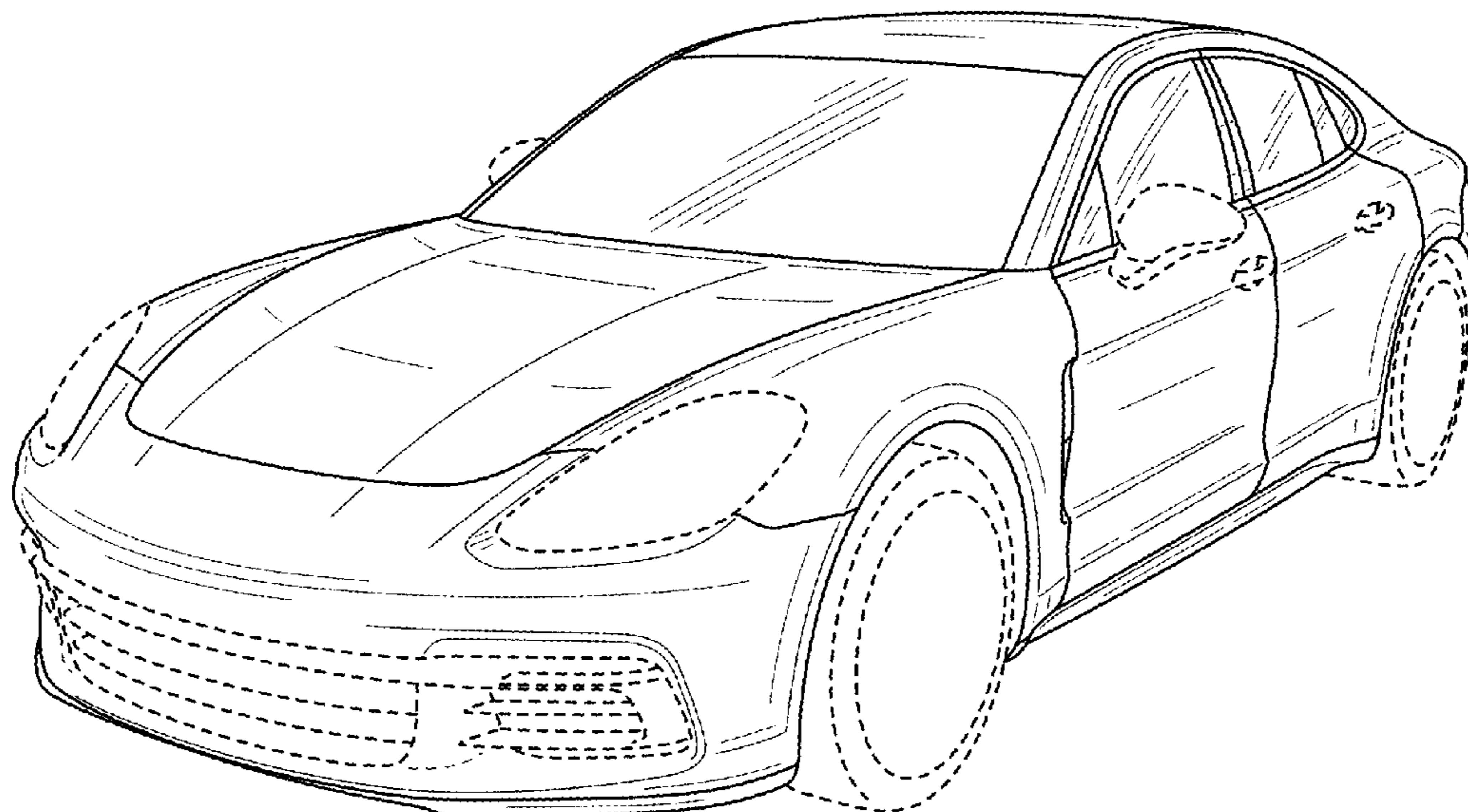
FIG. 4 is a front elevation view thereof;

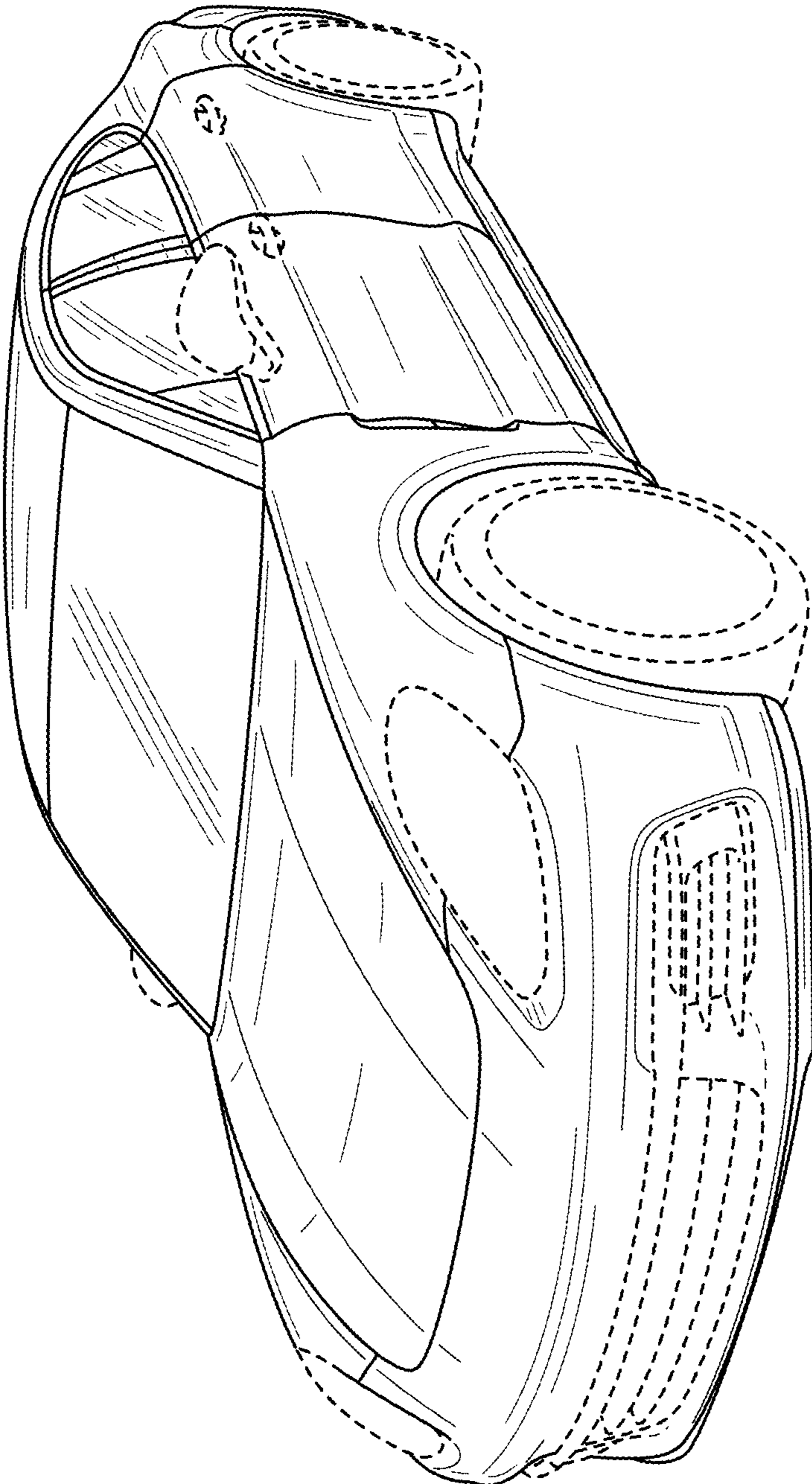

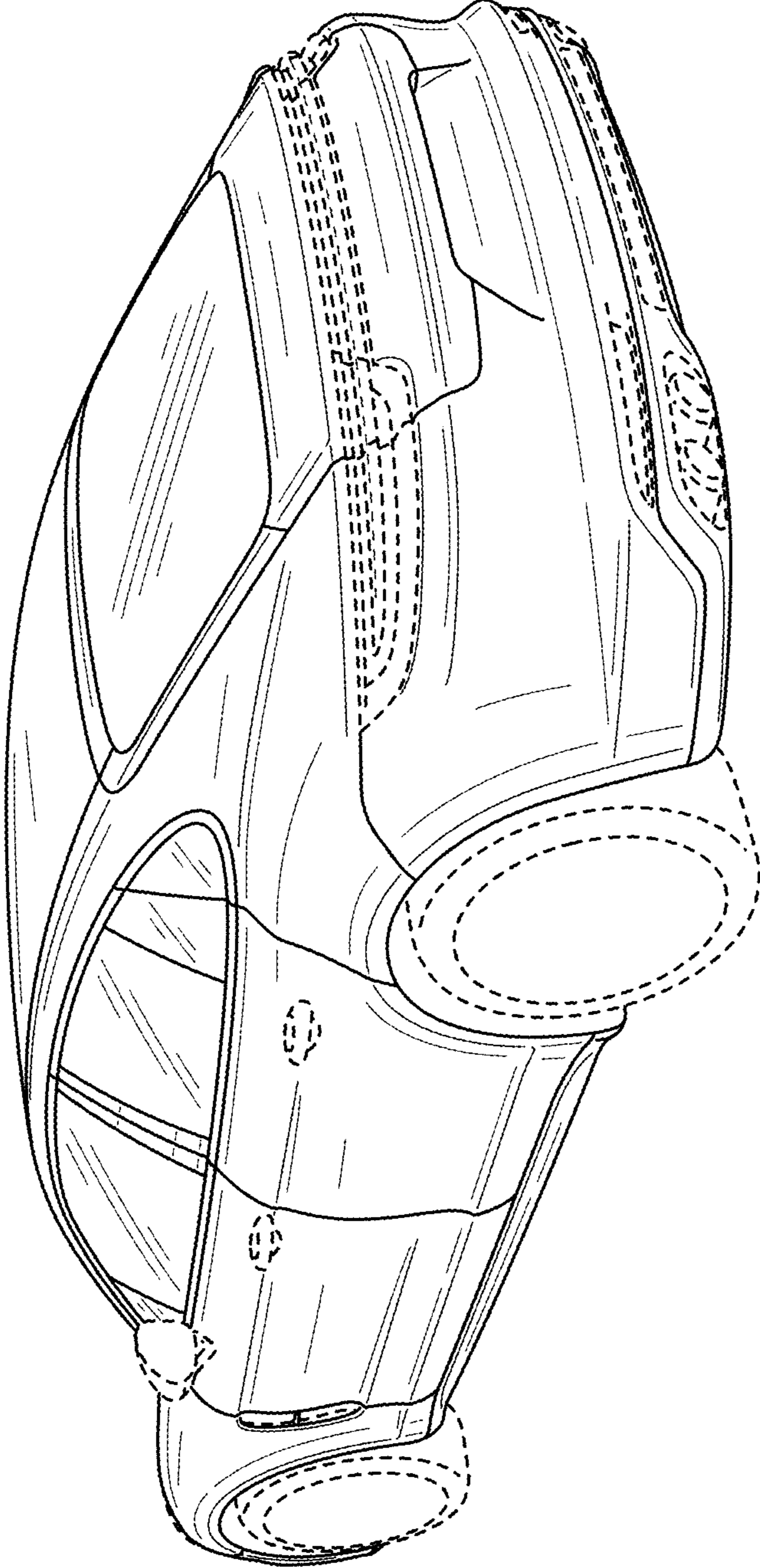

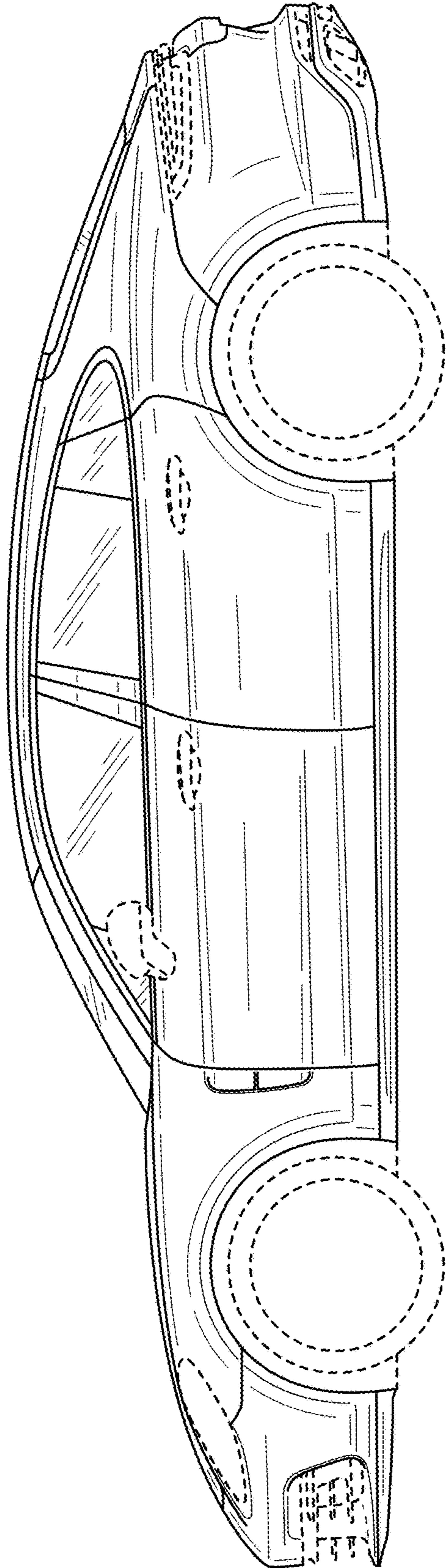

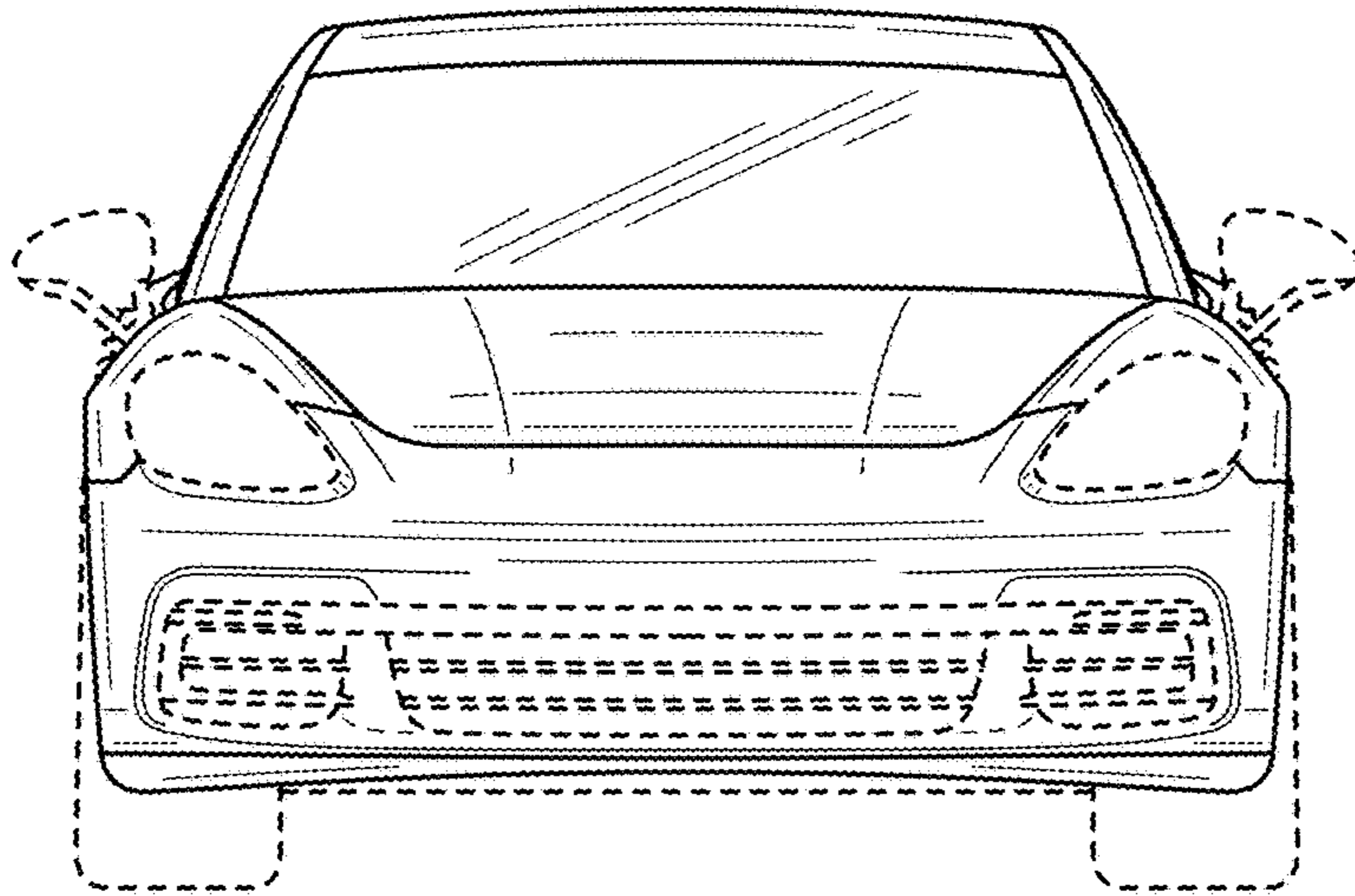

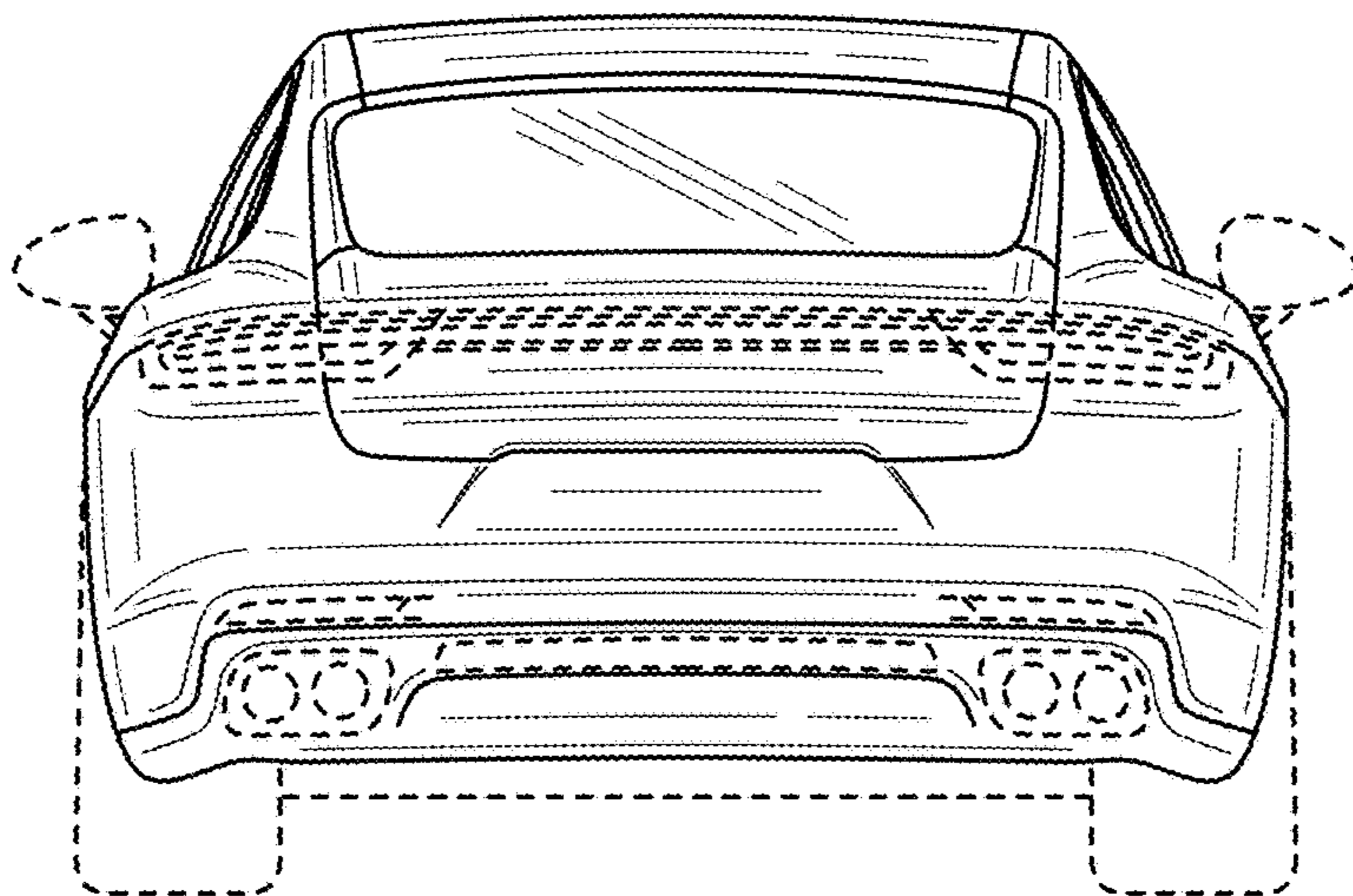

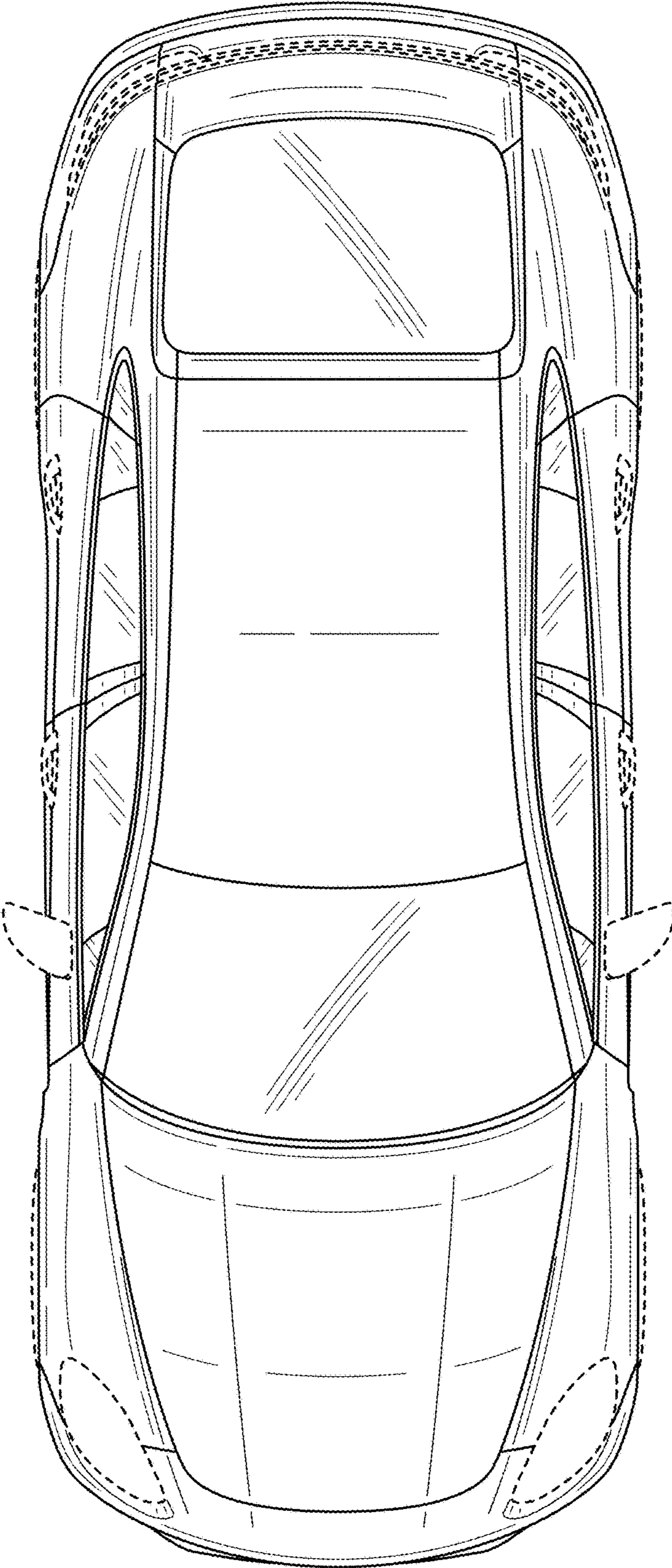
