FIG. 1 is a front perspective view of a tire, showing our new design, it being understood that the tread pattern is repeated throughout the circumference of the tire, the back perspective view being a mirror image of that shown;

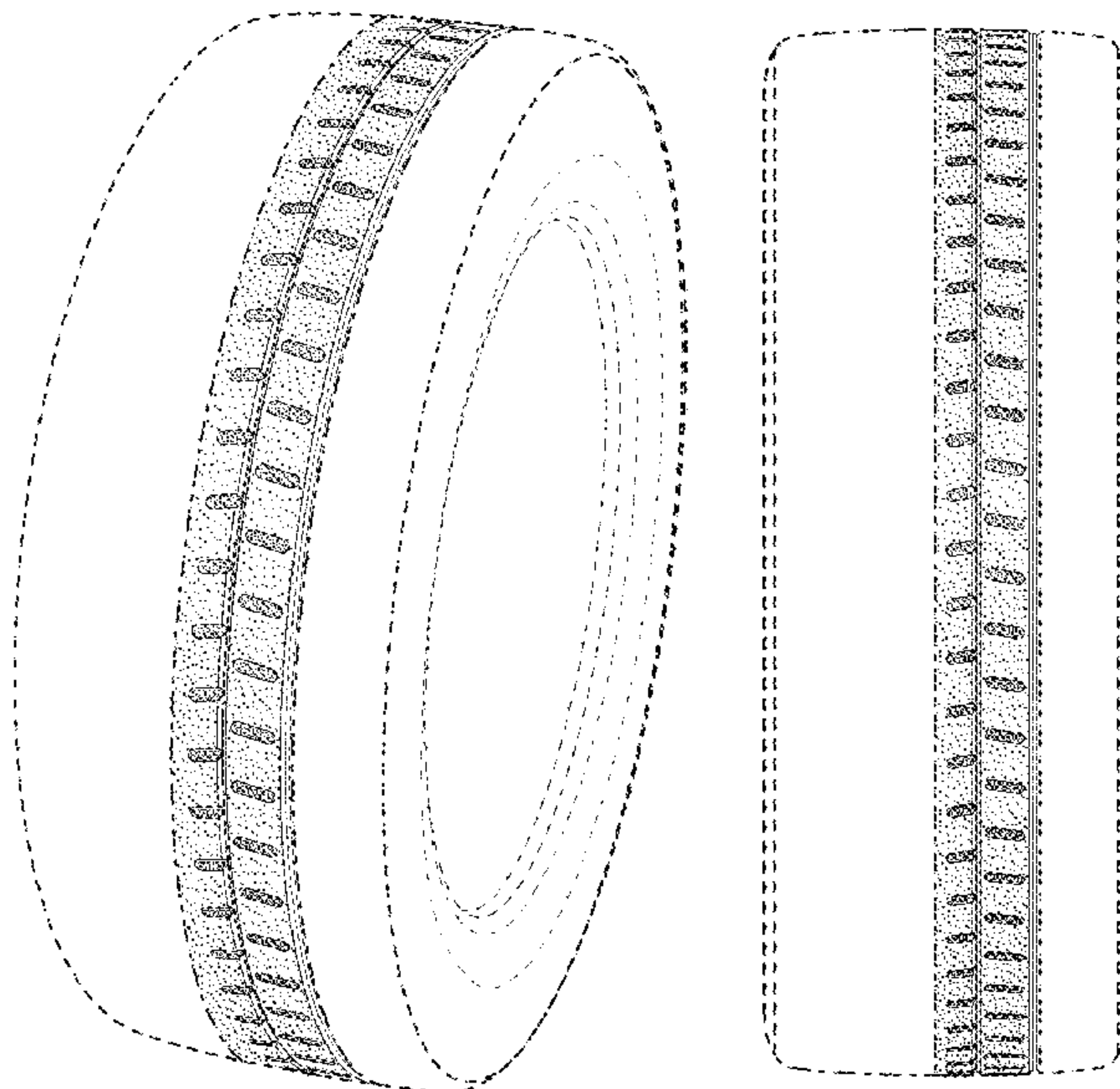
FIG. 2 is a right side view thereof;

FIG. 4 is a left side view thereof.

The portions depicted in broken lines of uneven length define the unclaimed boundary of the claimed design. The broken lines of even length shown in the drawings illustrate portions of the tire that form no part of the claimed design.

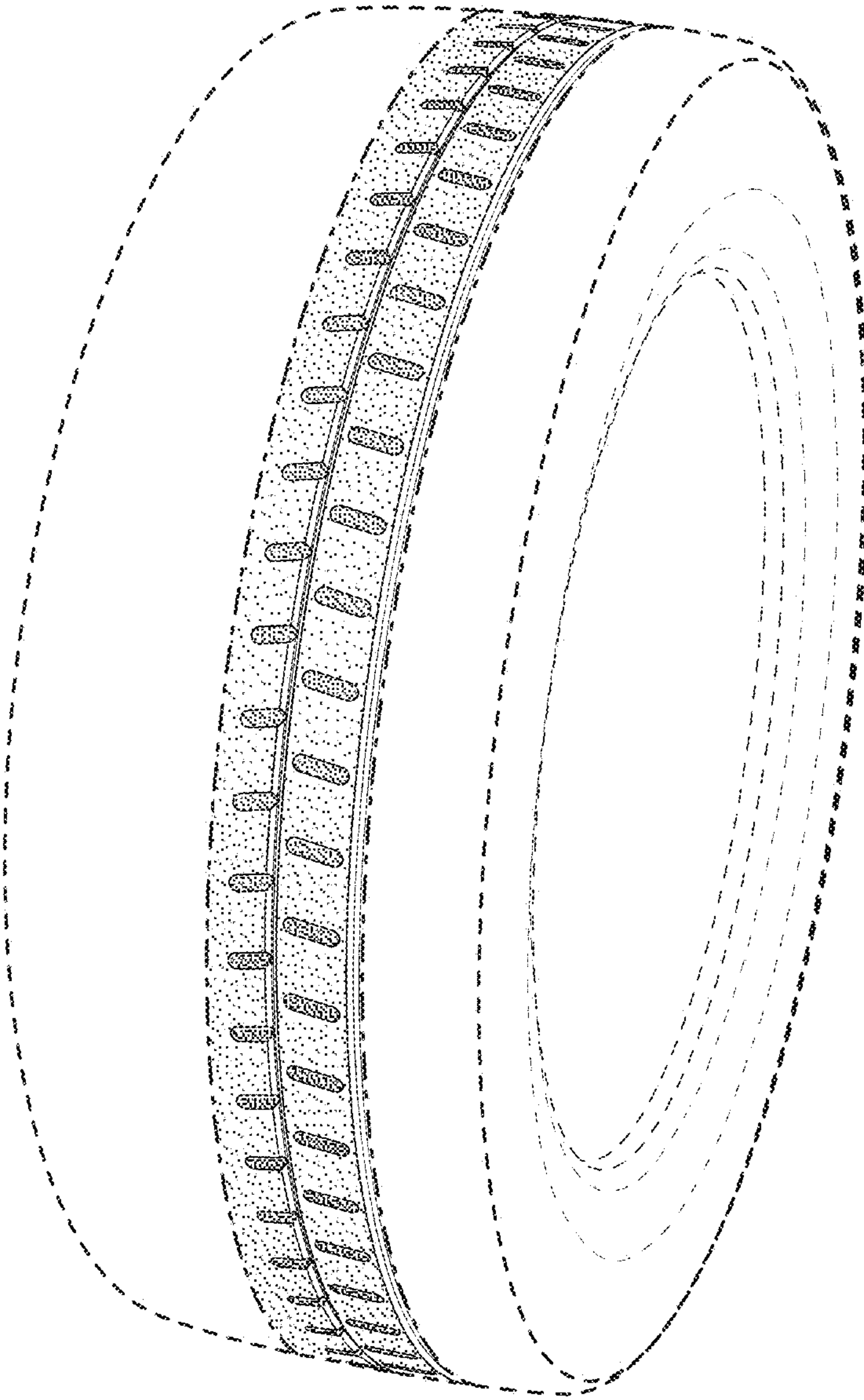

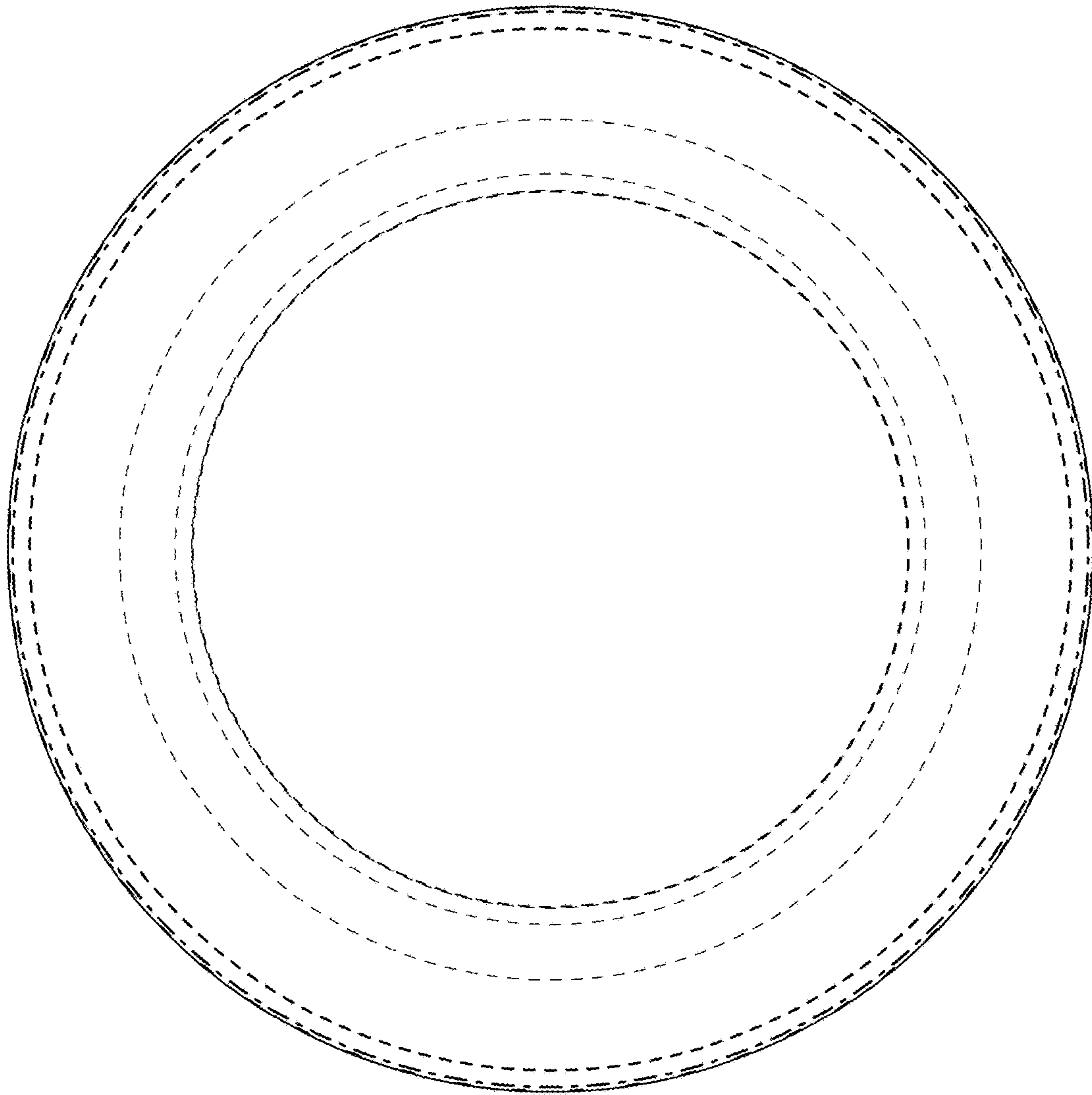

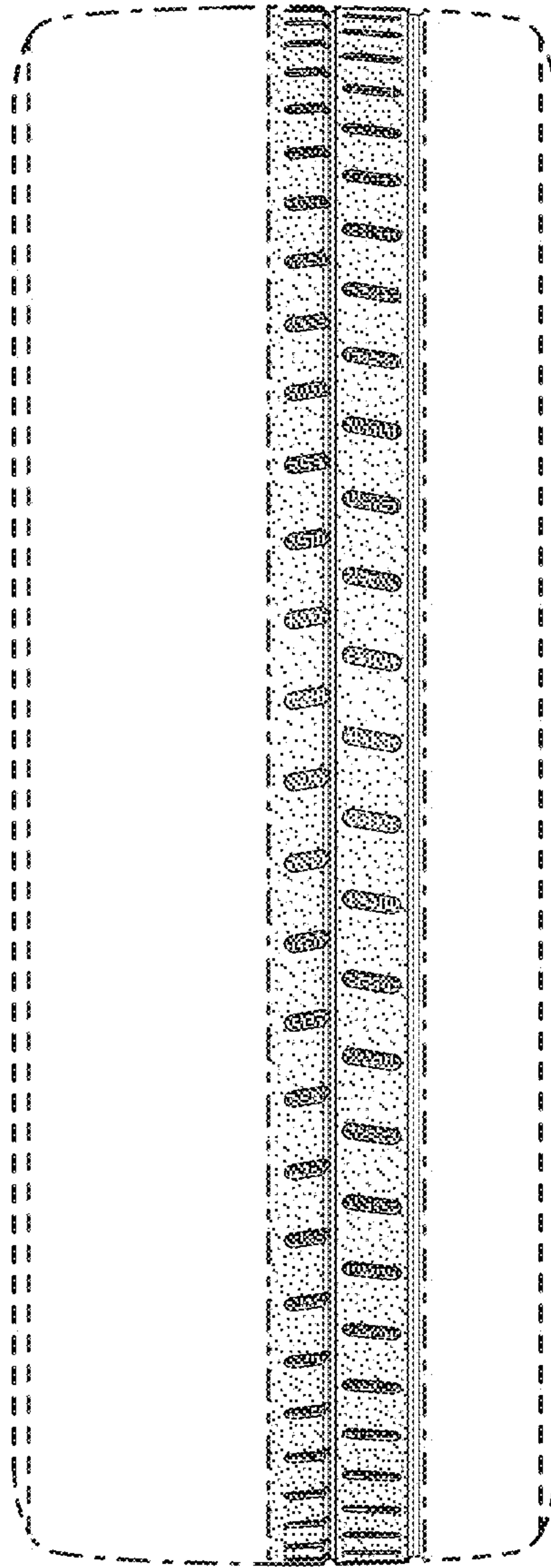

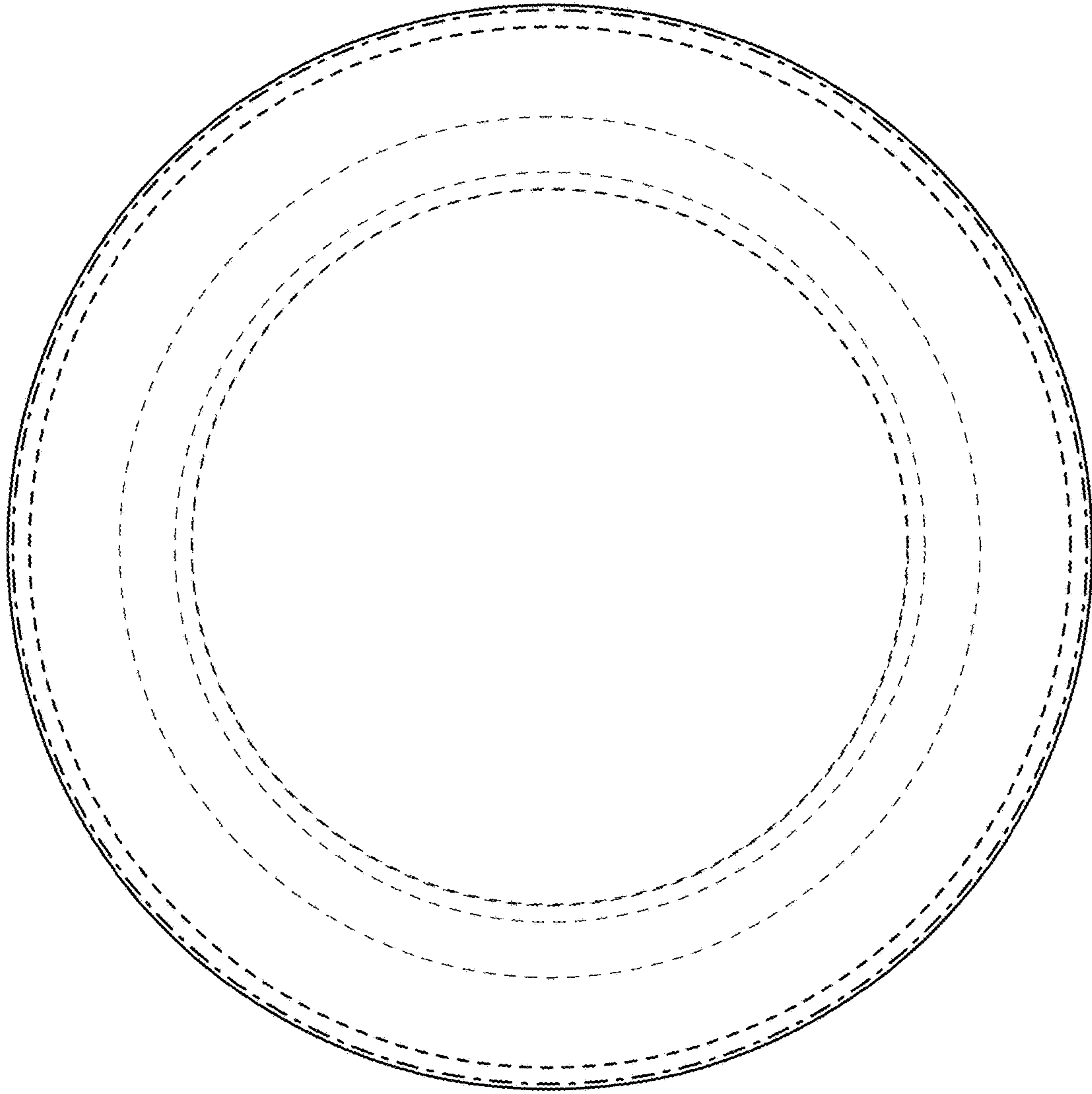
