(57) **CLAIM**

The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tire showing the claimed design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

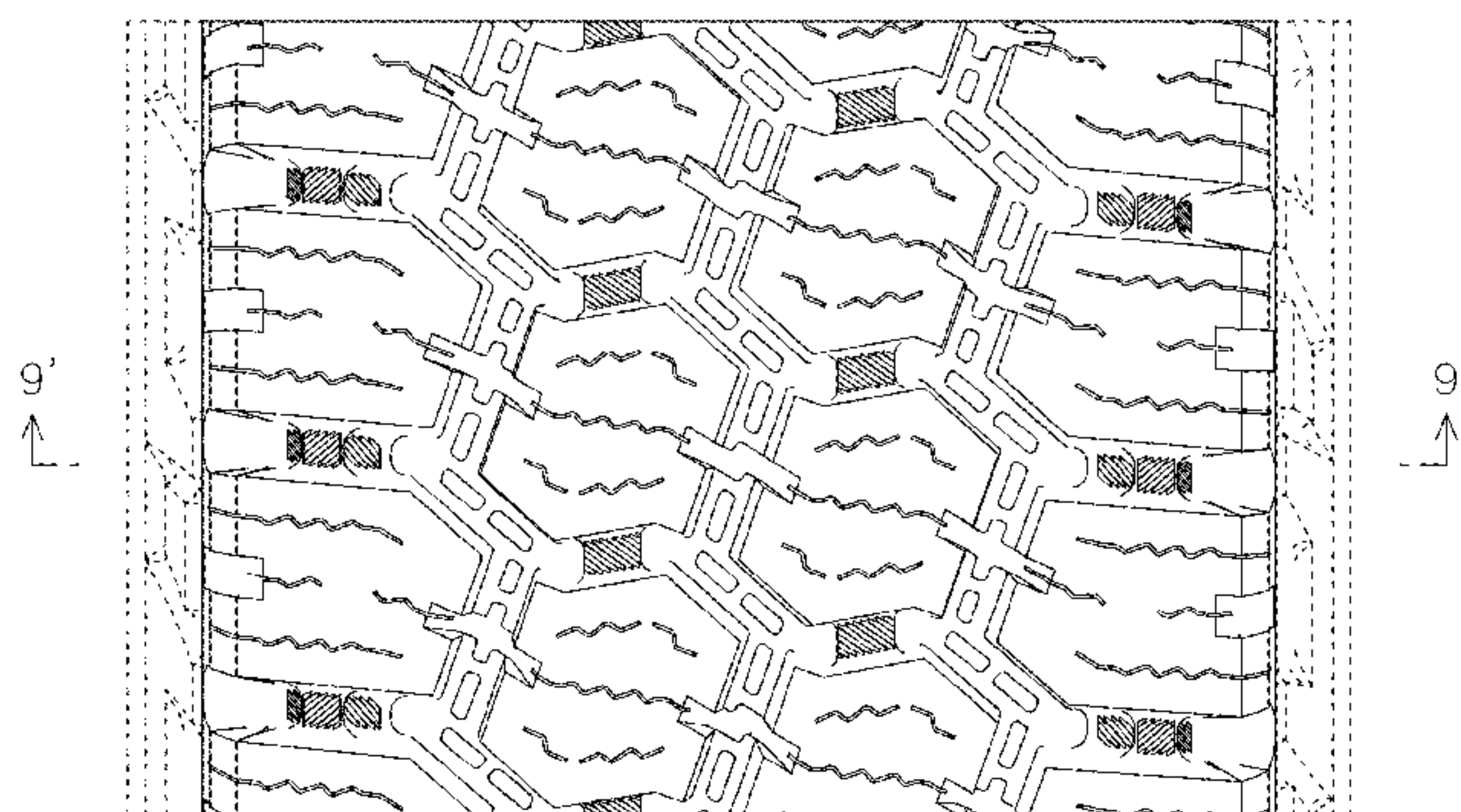
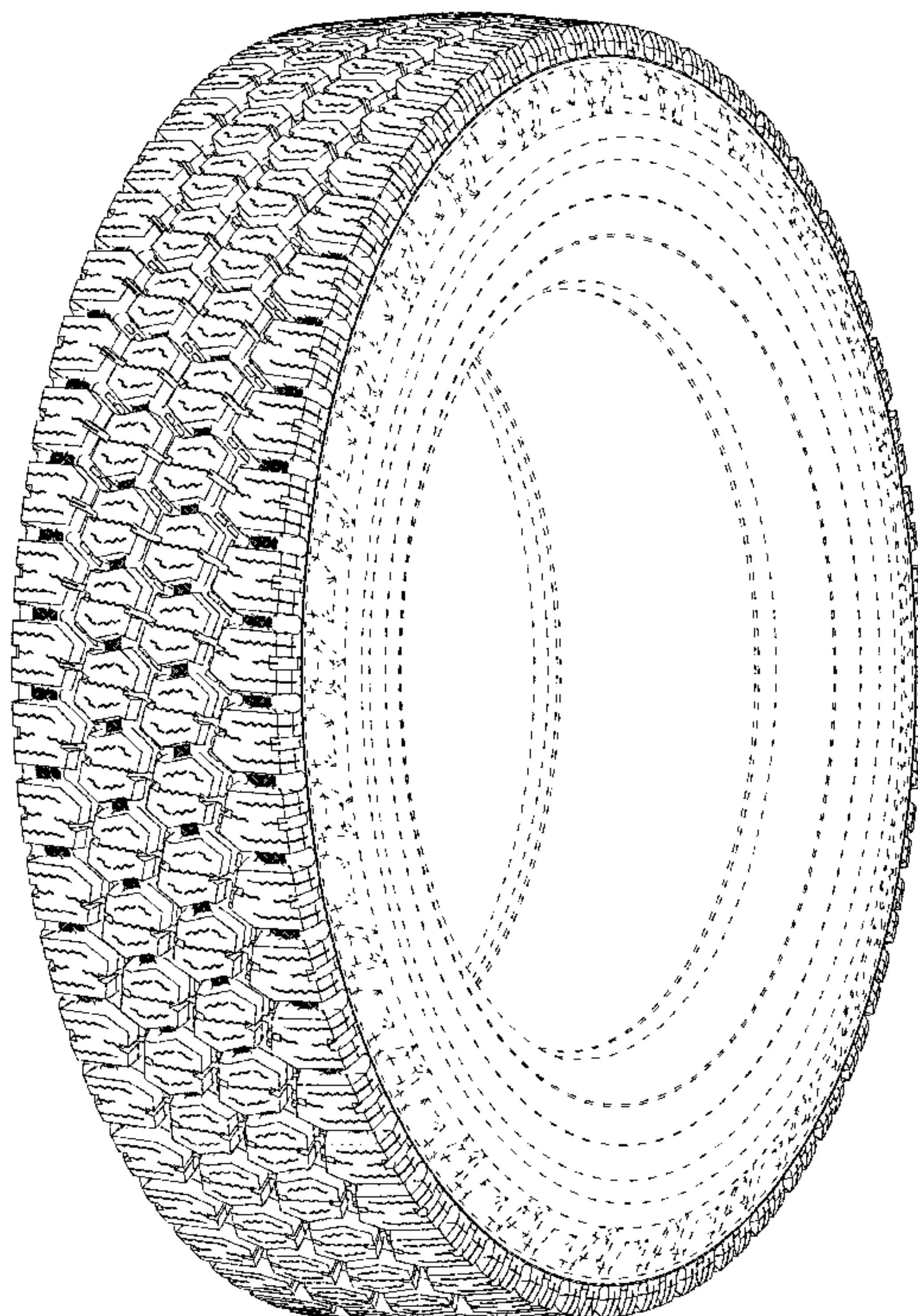
FIG. 6 is a right side view thereof;

FIG. 7 is a left side view thereof;

FIG. 8 is an enlarged view of the portion 8-8 in FIG. 2; and,
FIG. 9 is an enlarged cross-sectional view taken along line 9'-9' in FIG. 8 to line 9'-9' in FIG. 6, it being understood that the depth of all sipes and the height of all pebble ejector elements on the tire are as shown in this figure.

In the drawings, the broken lines showing portions of the sidewall, inner bead, and peripheral boundary depict portions of the tire that form no part of the claimed design.

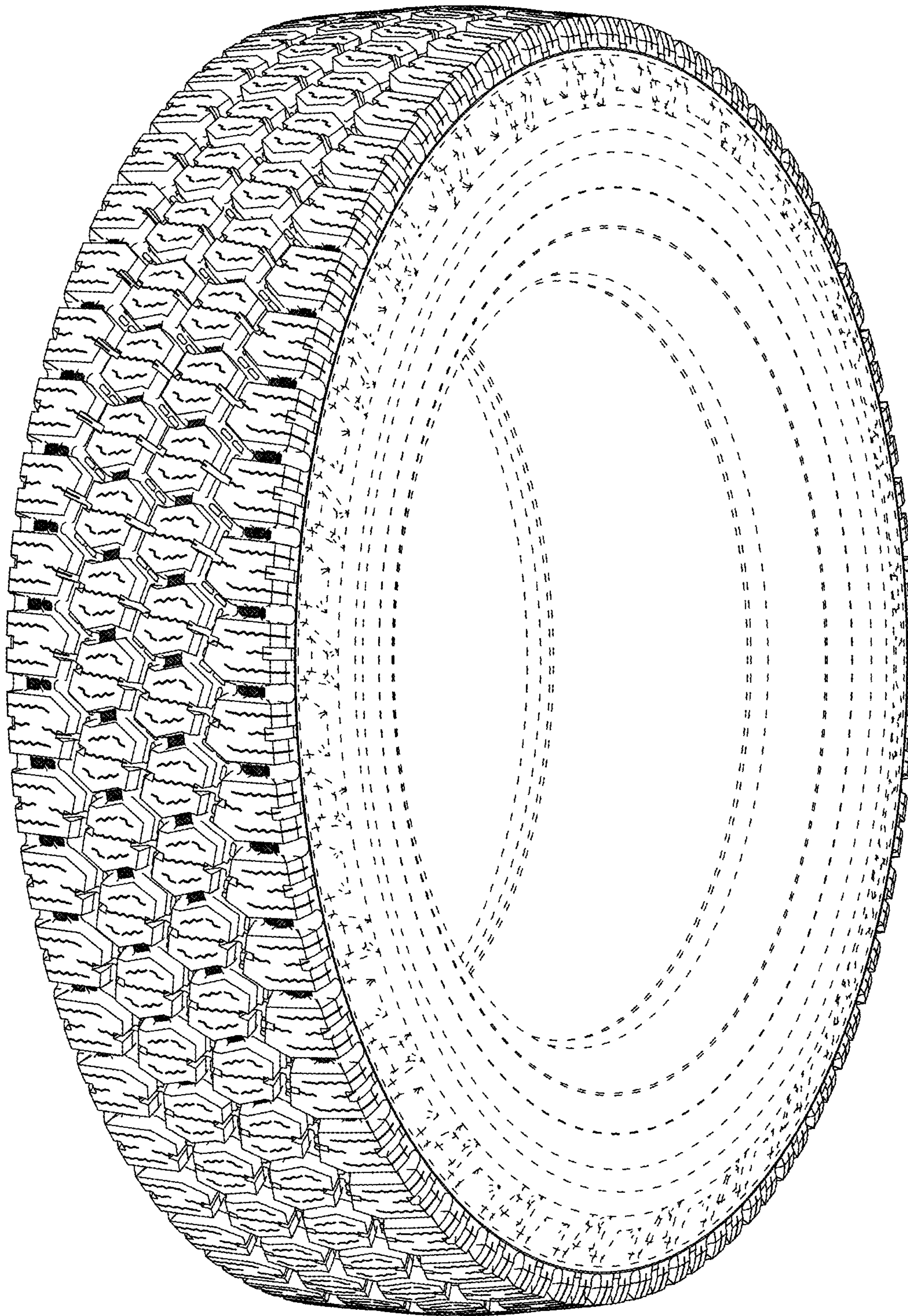

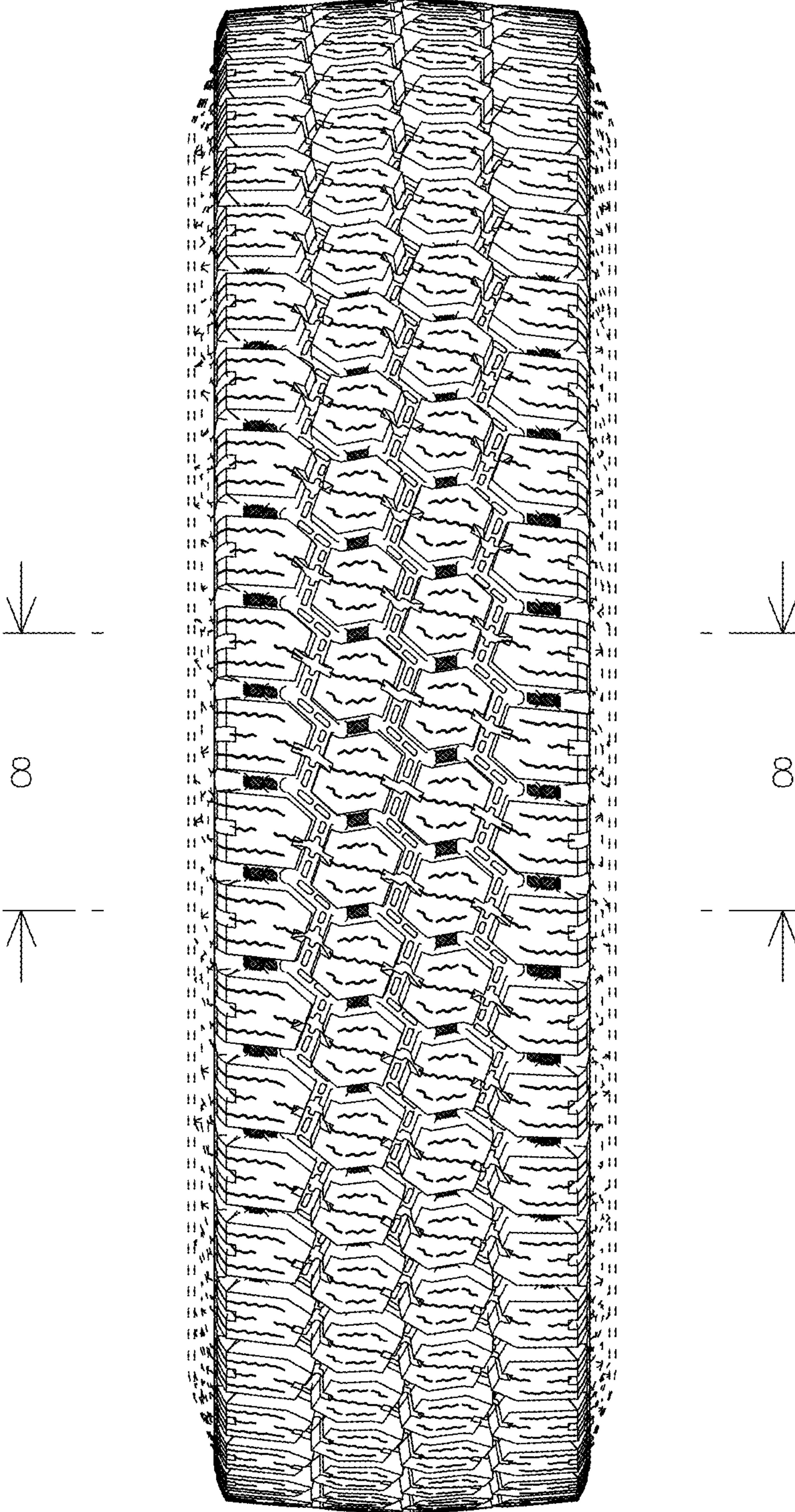

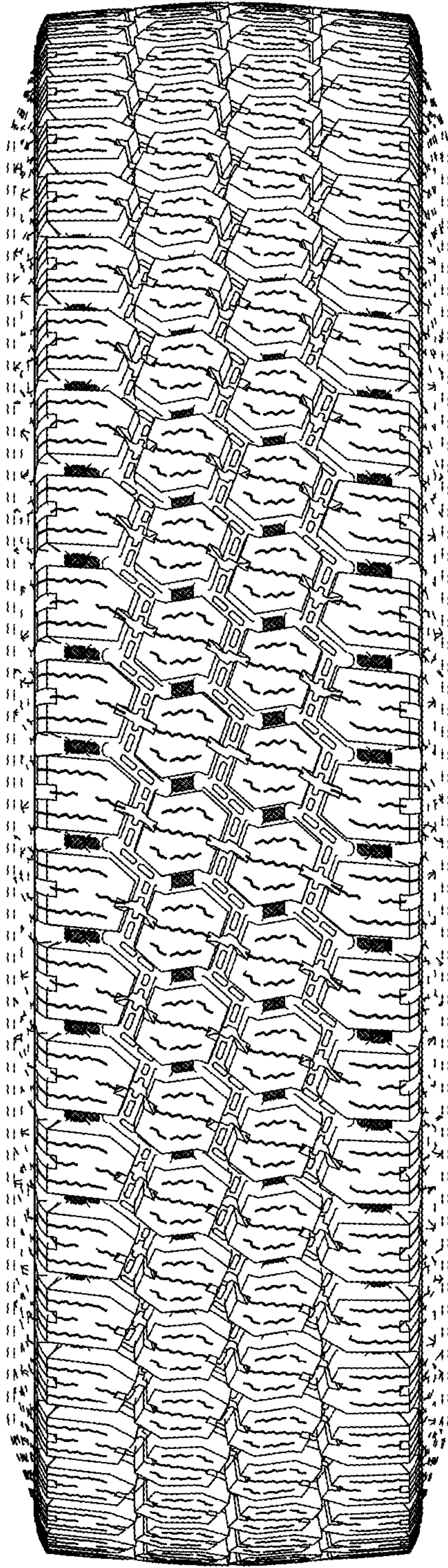

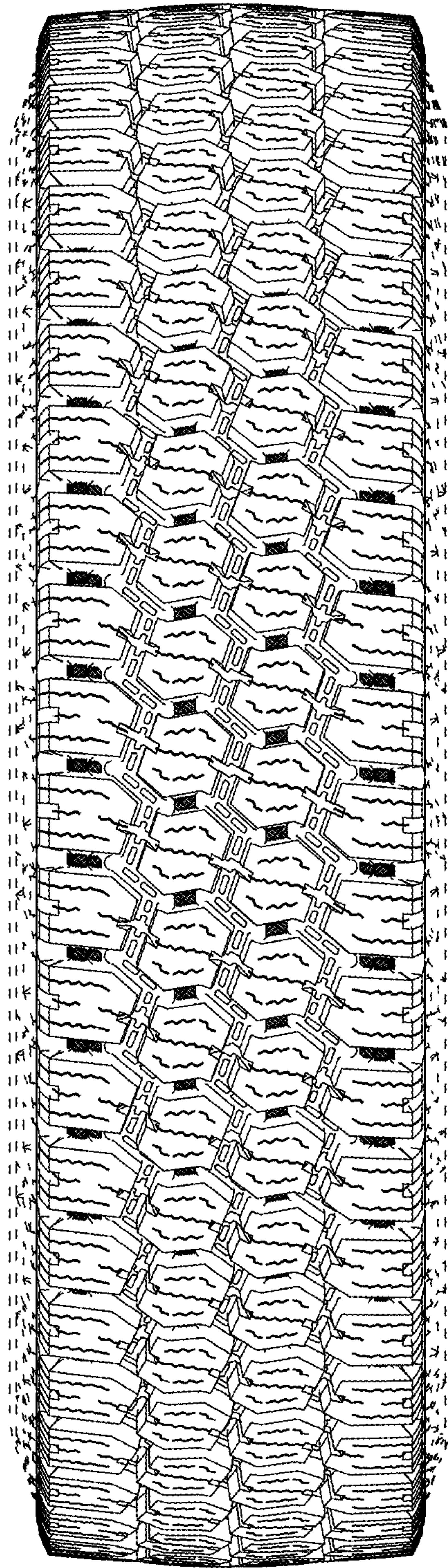

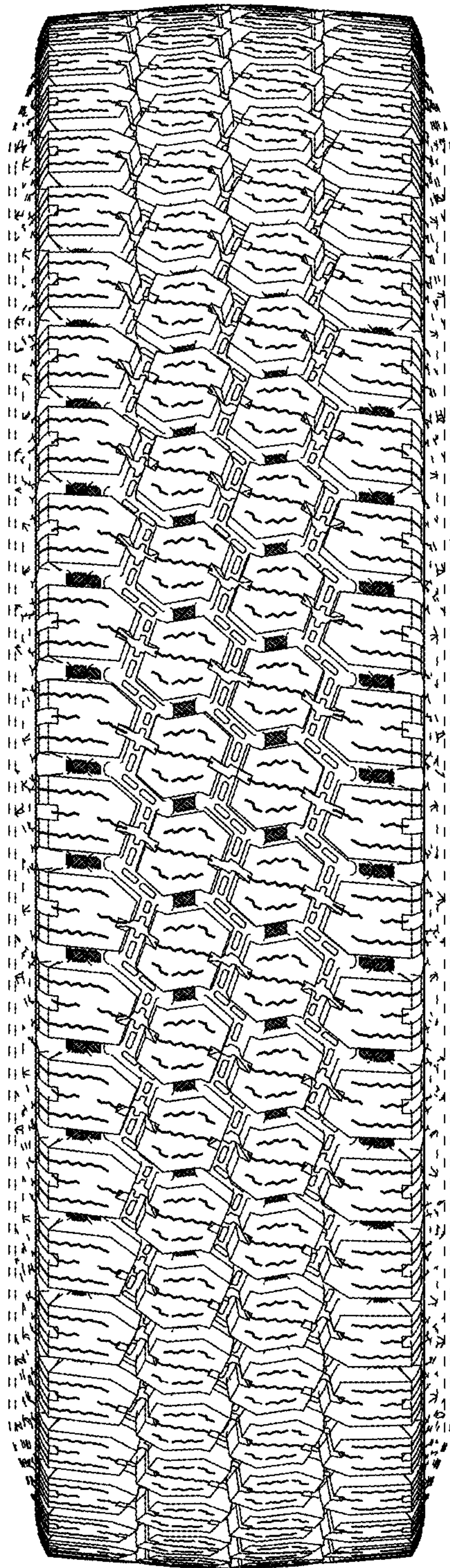

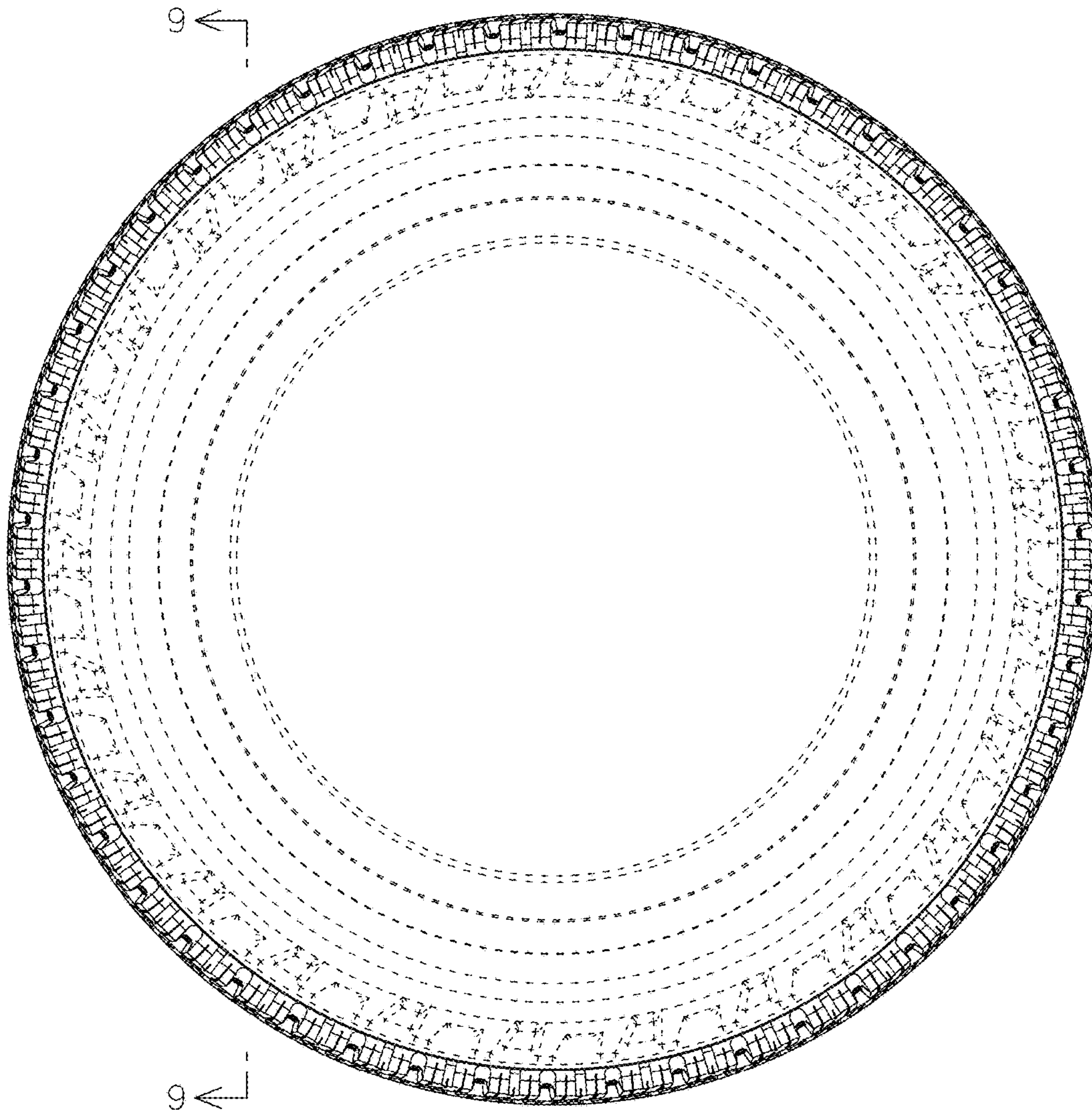

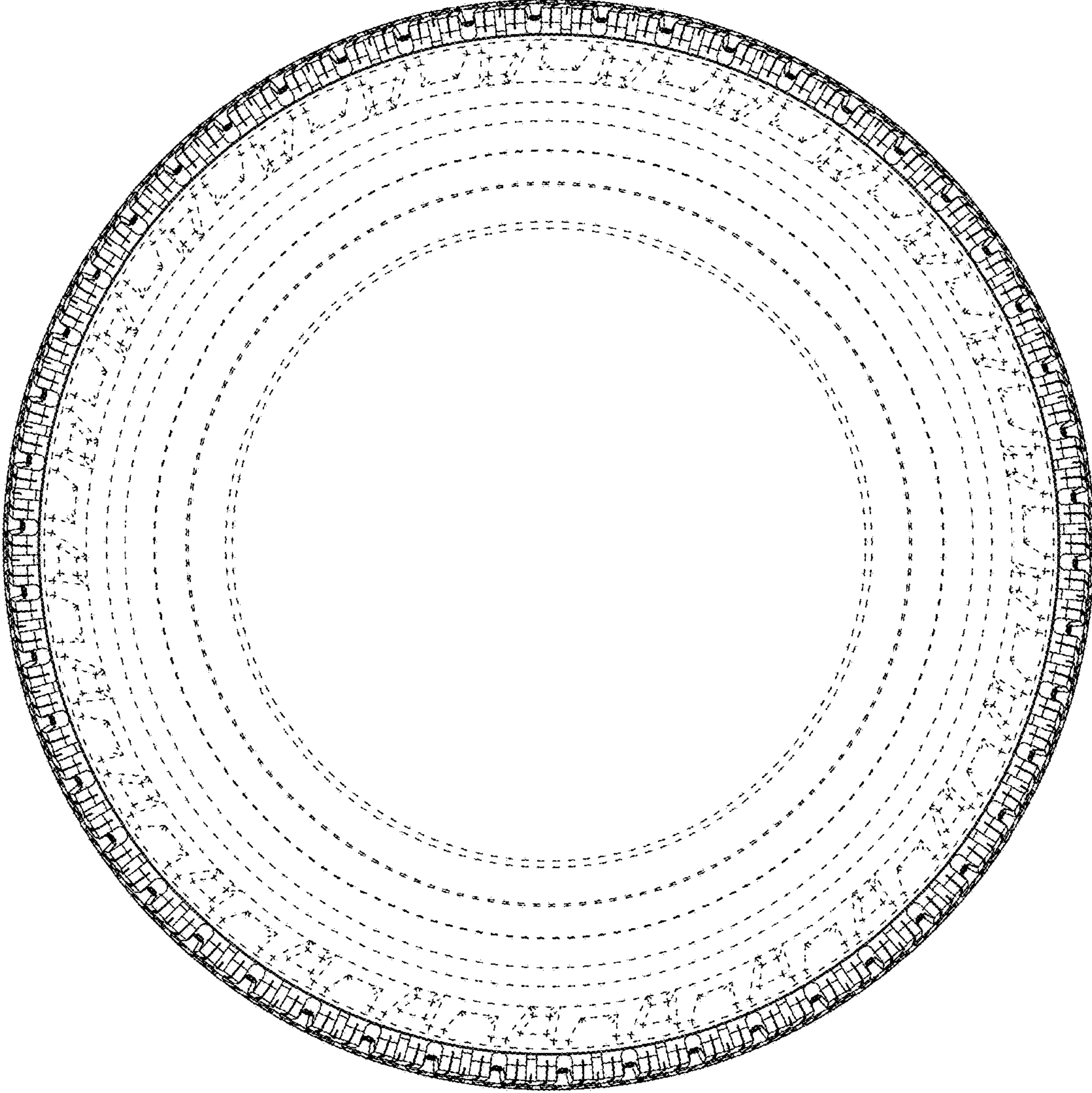

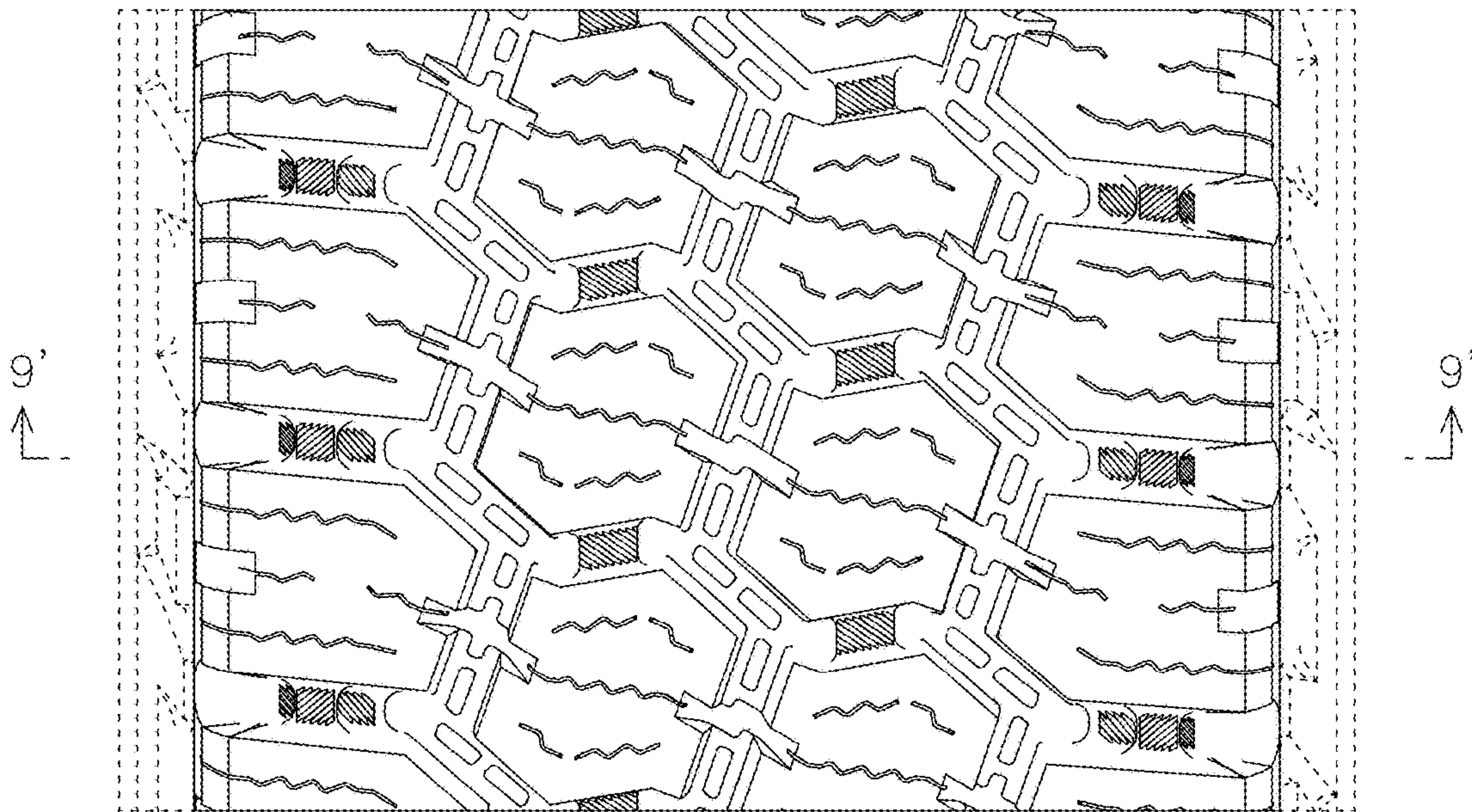

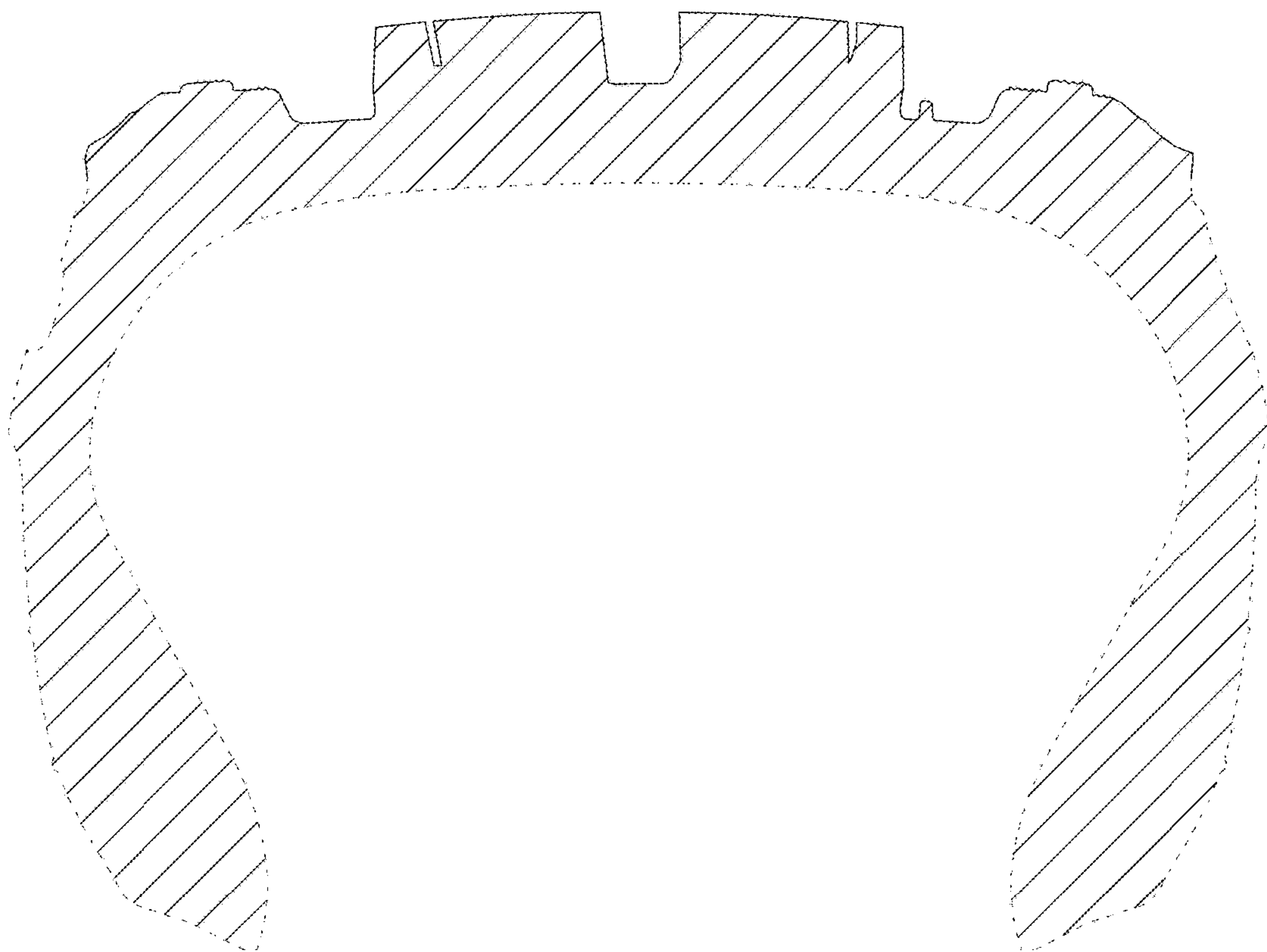
