(57) **CLAIM**

The ornamental design for a smartphone cable with deco-
rative chain, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a
smartphone cable with decorative chain of the new design;
FIG. 2 is an enlarged portion of FIG. 1 thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a right side elevation view thereof;

FIG. 6 is a left side elevation view thereof;

FIG. 7 is a front elevation view thereof;

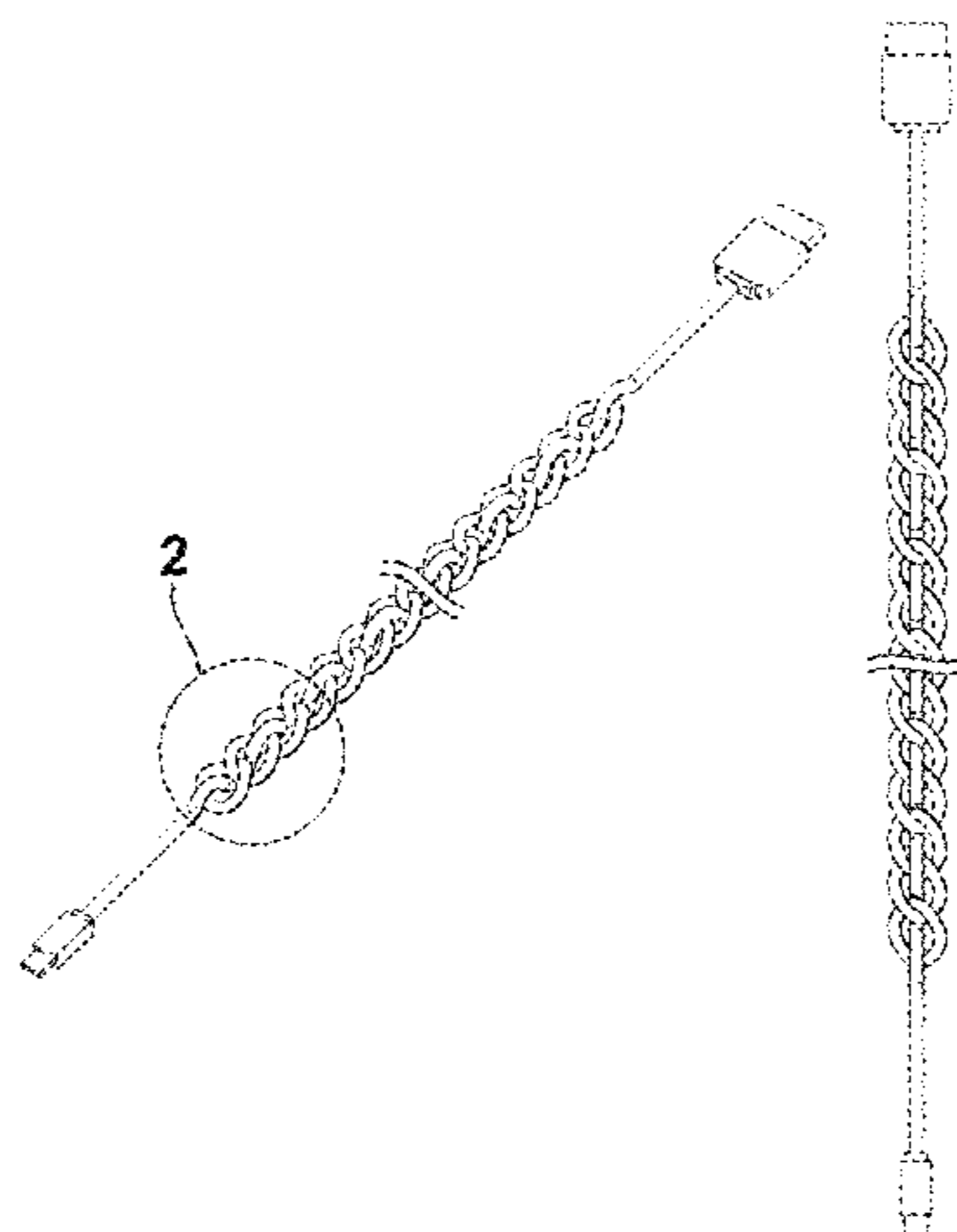
FIG. 8 is a rear elevation view thereof;

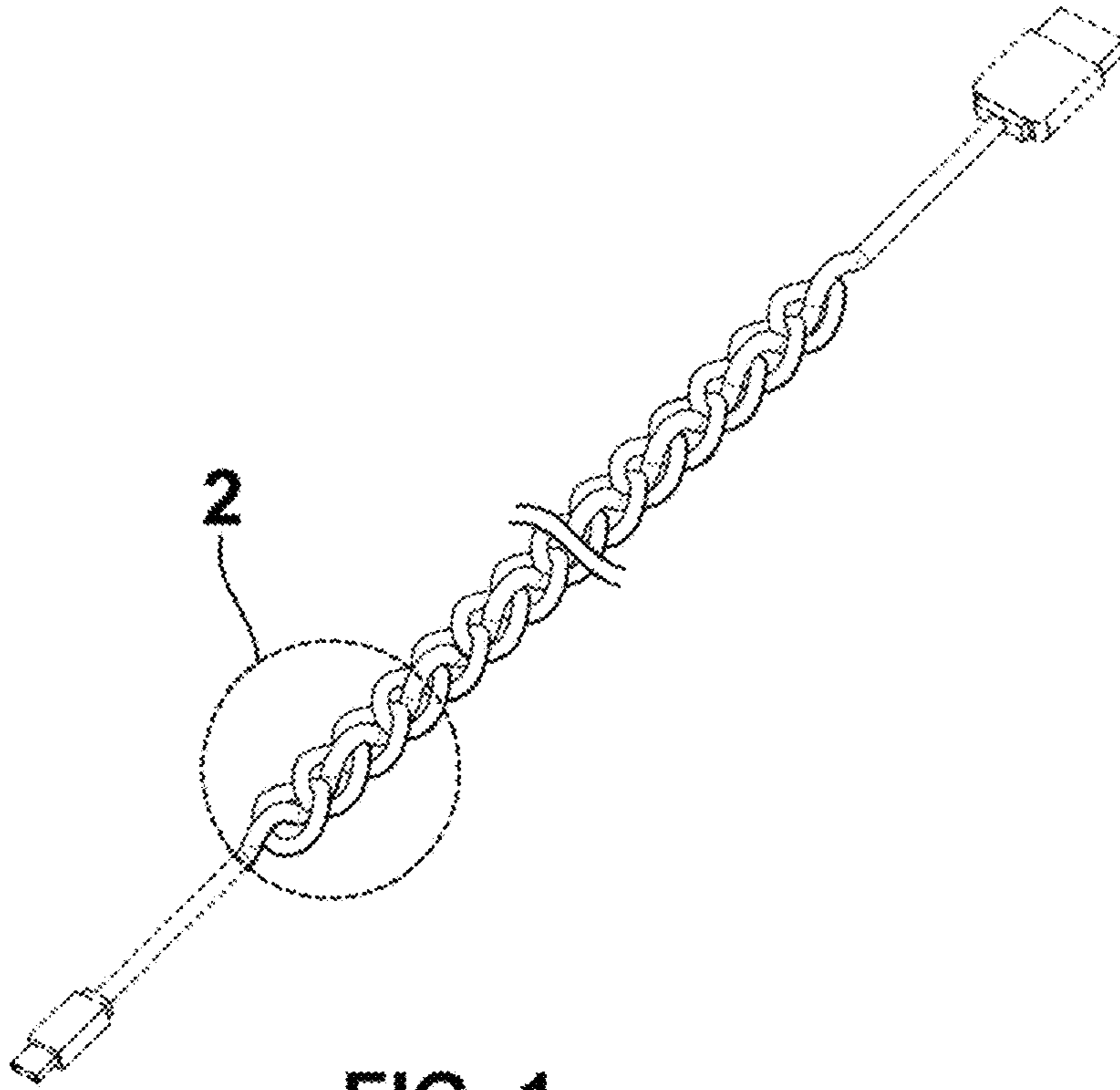

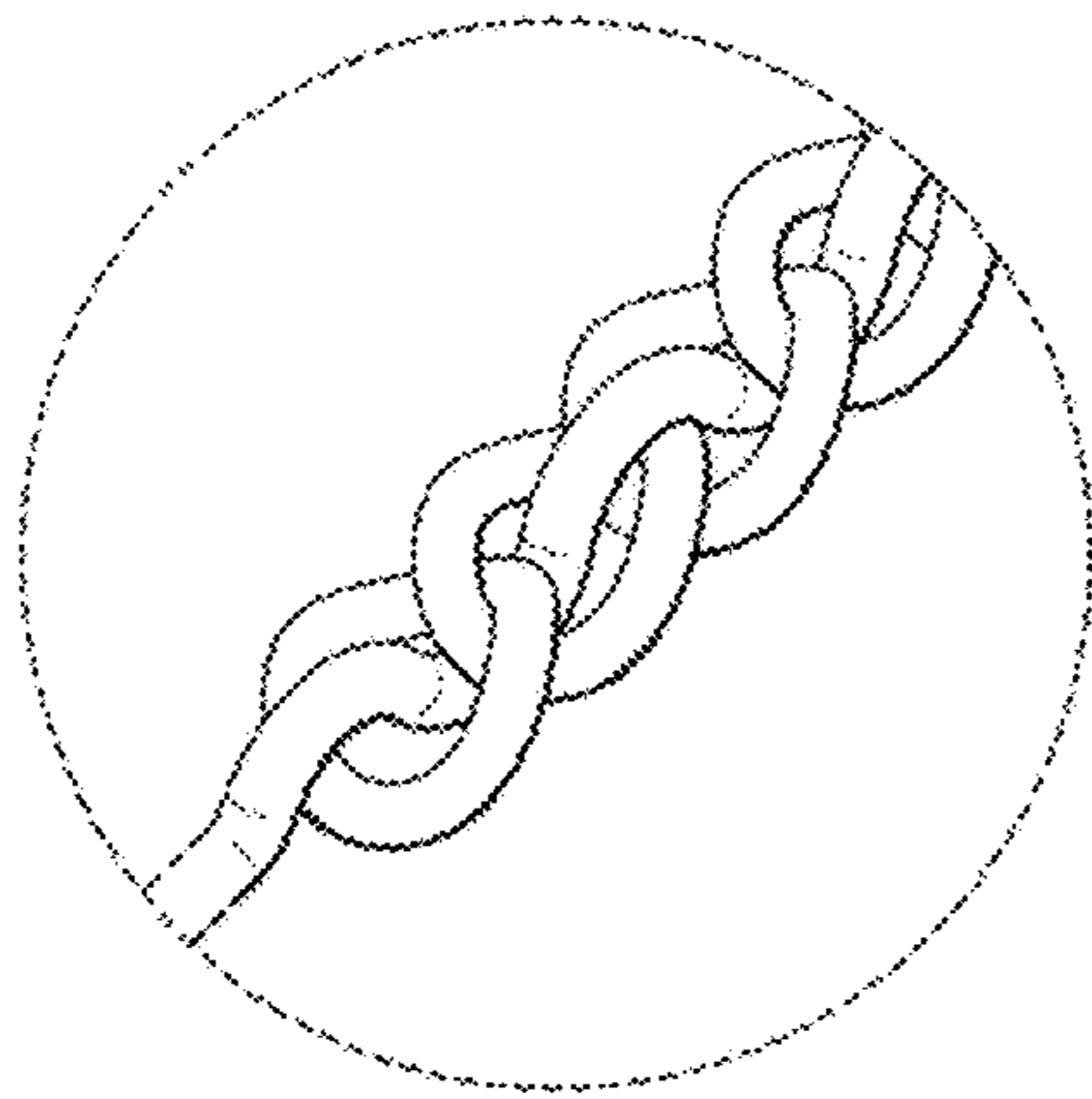

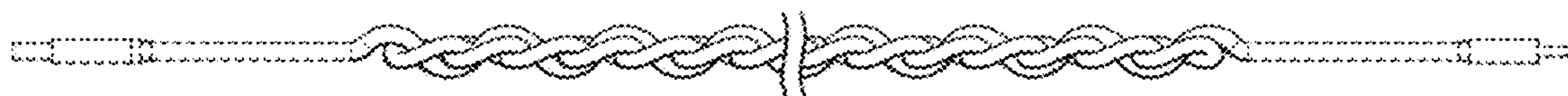
