DESCRIPTION

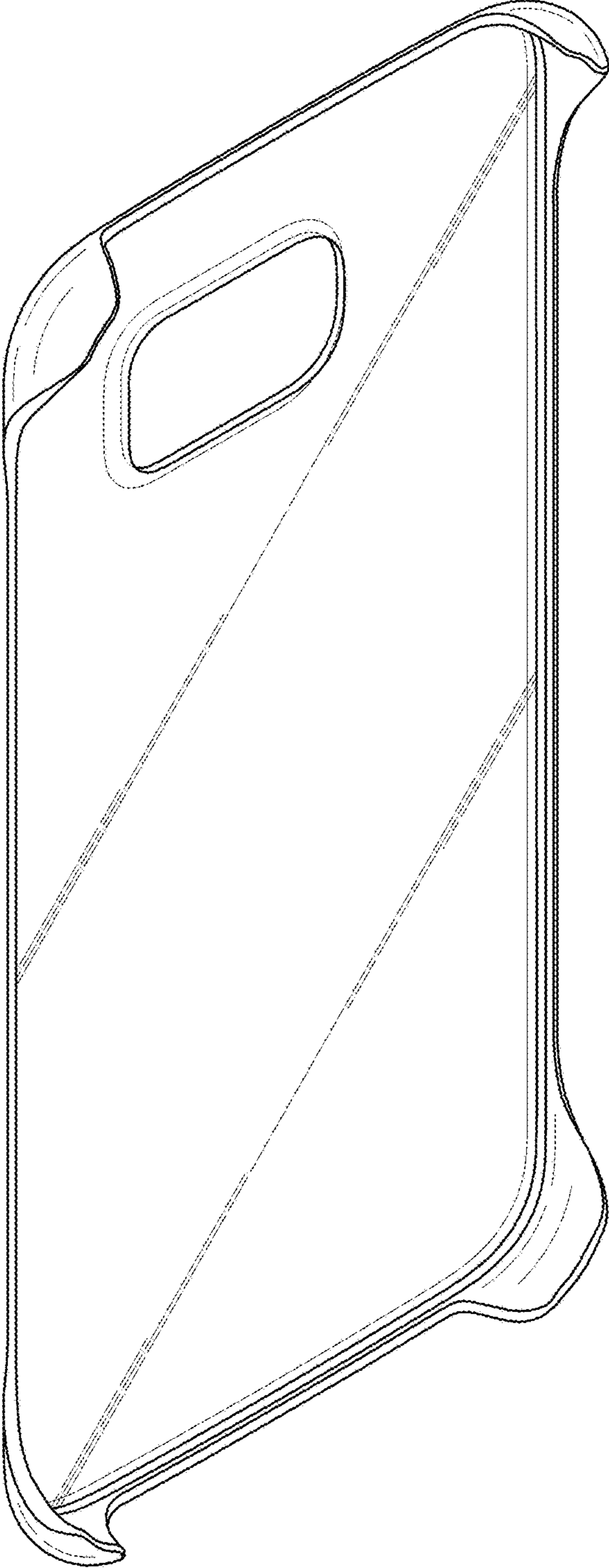

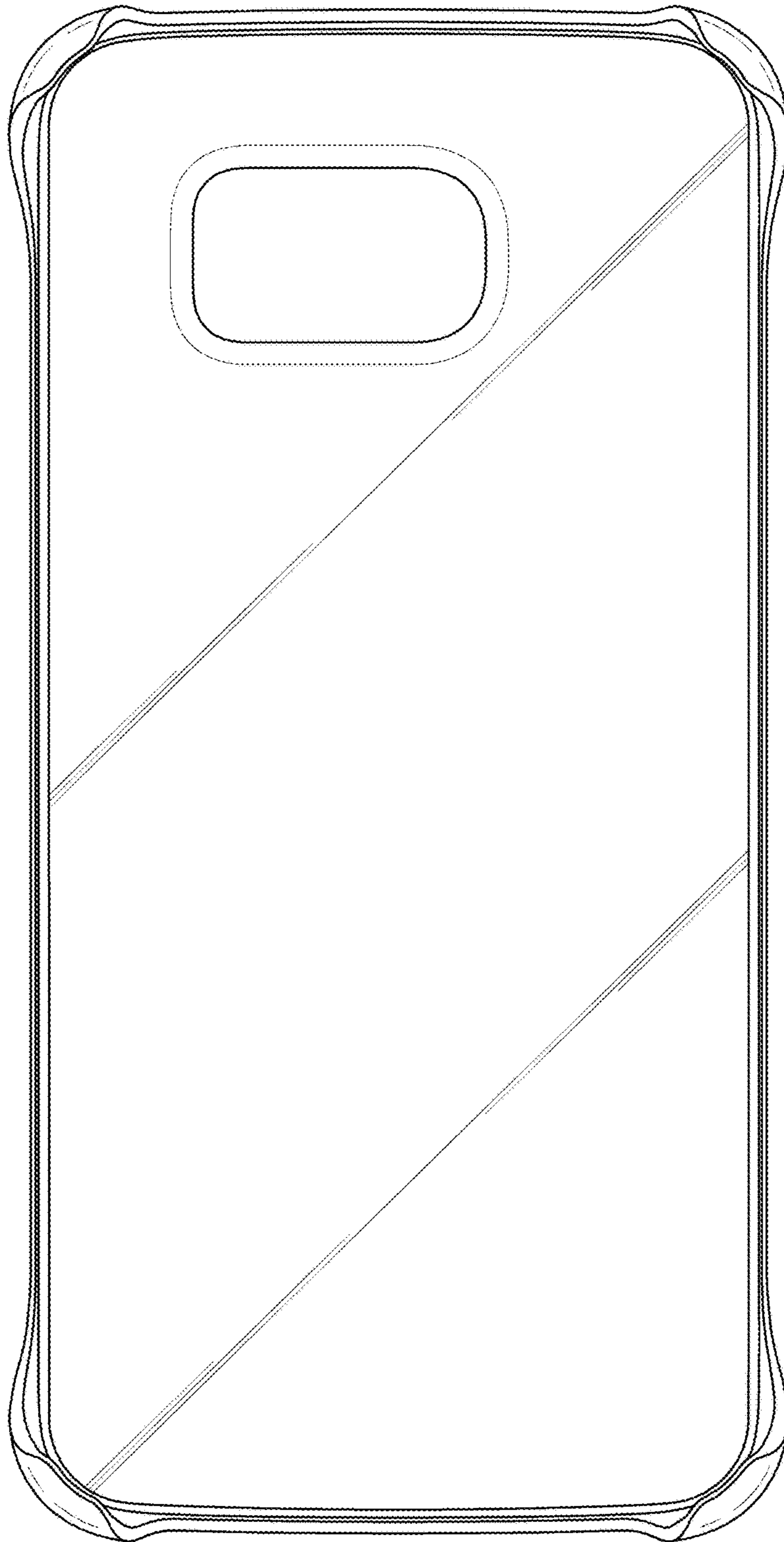

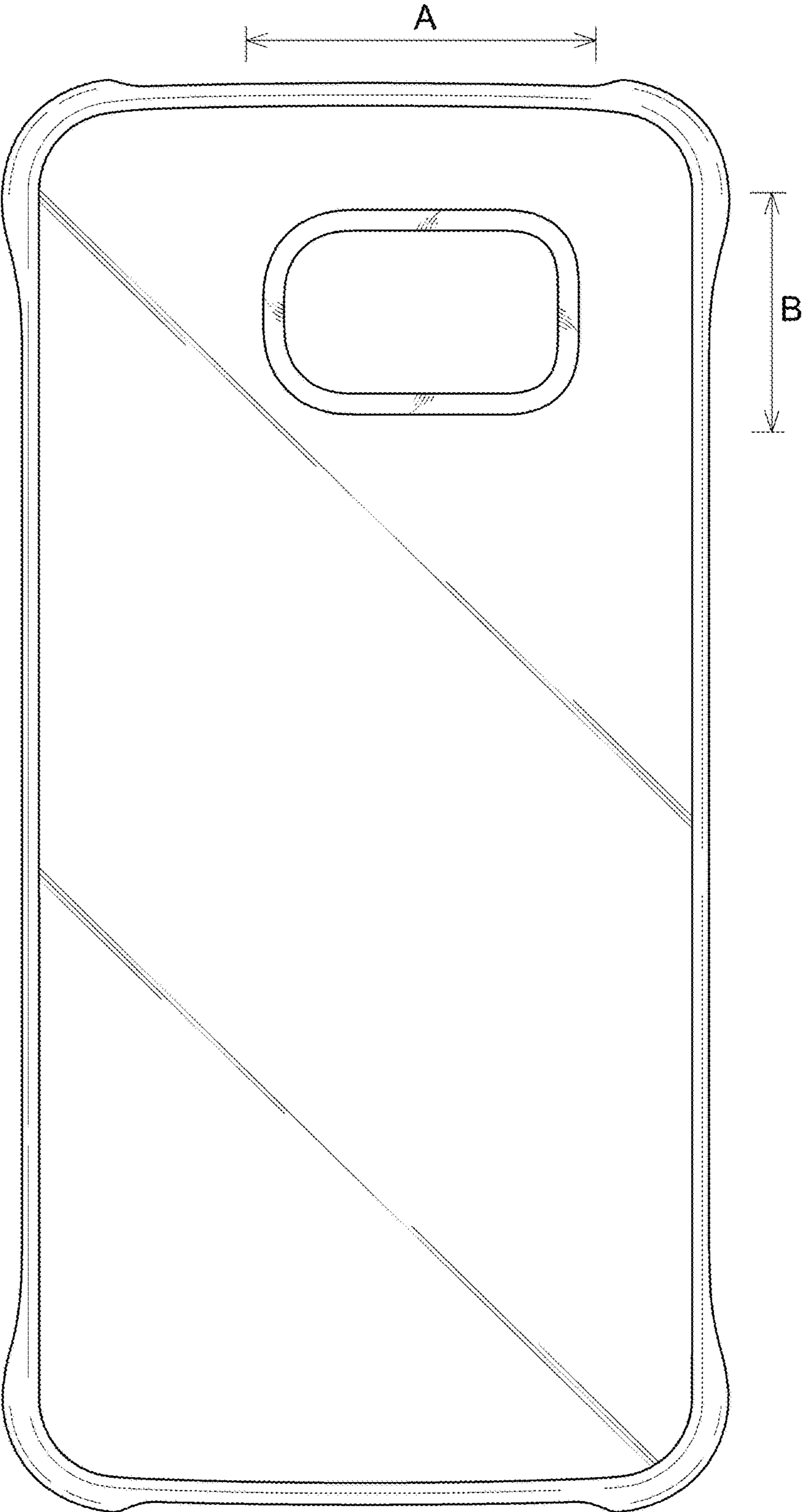

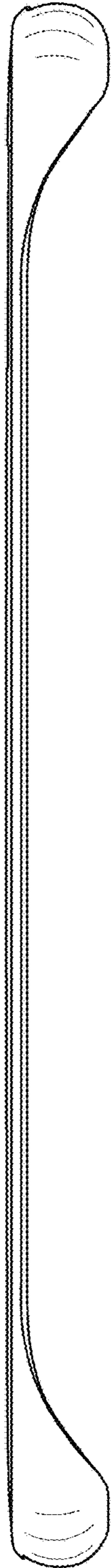

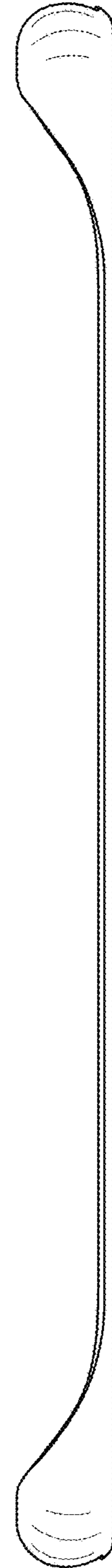

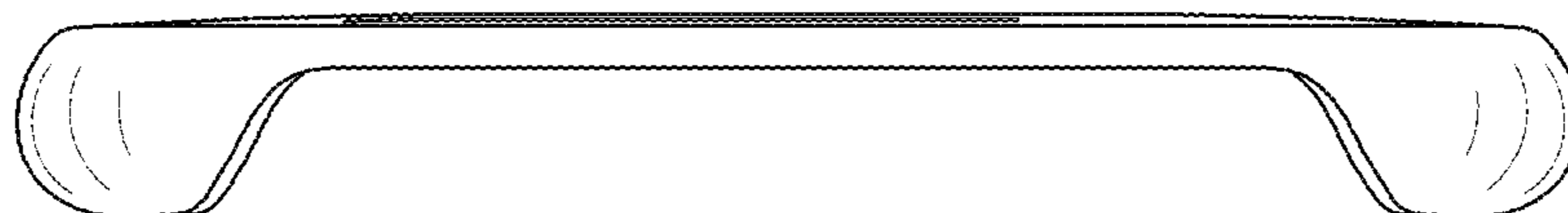

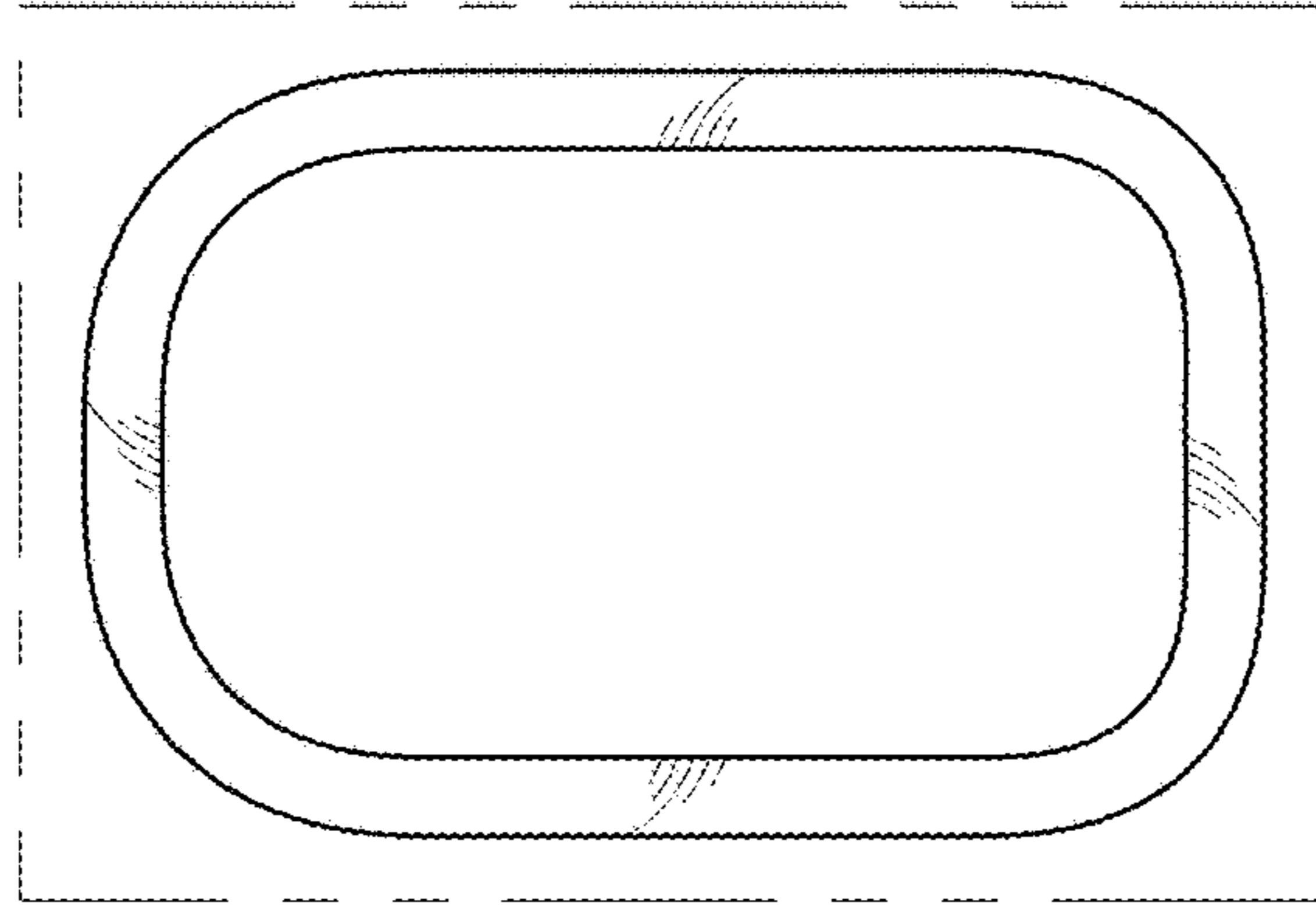

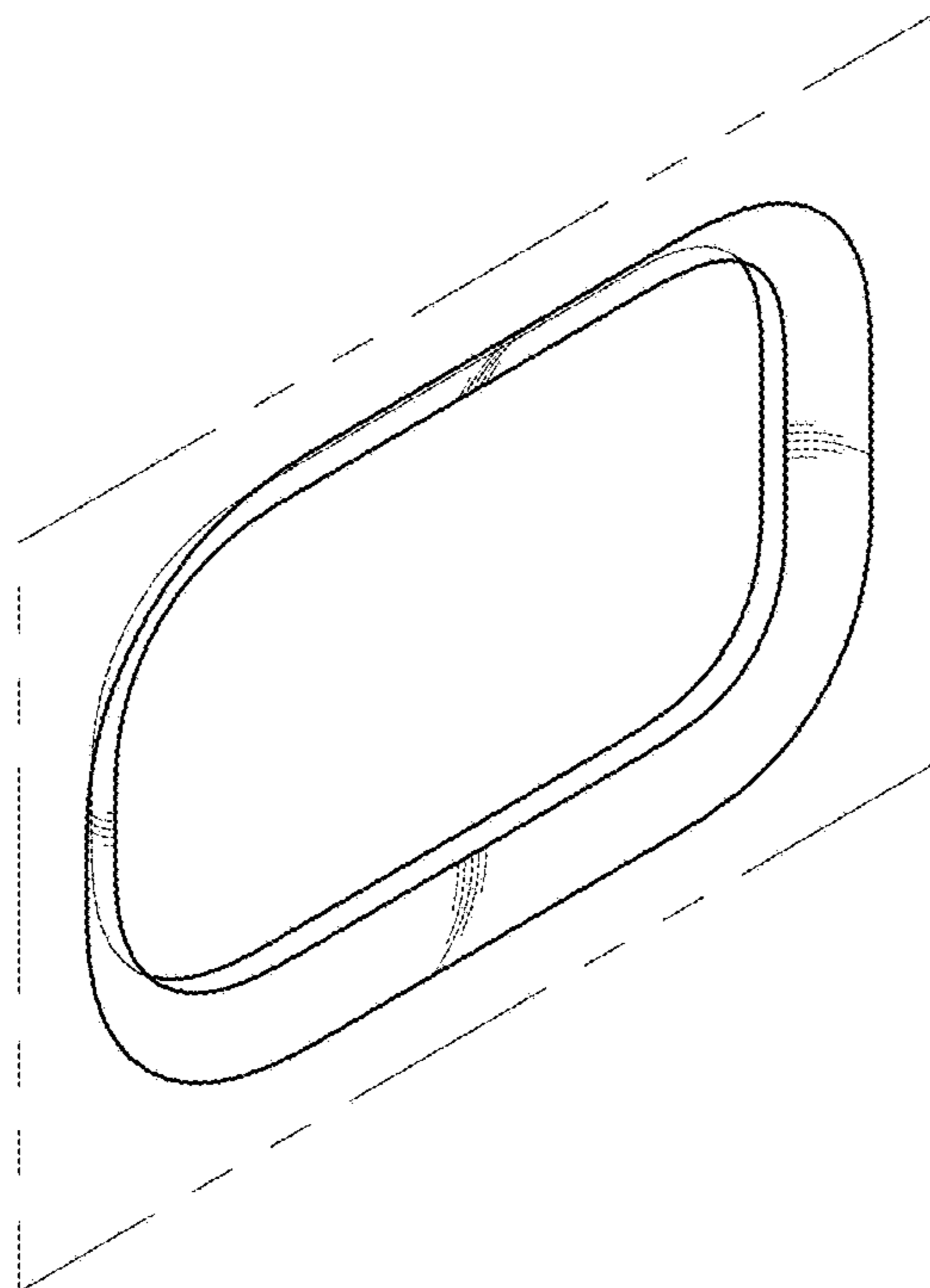

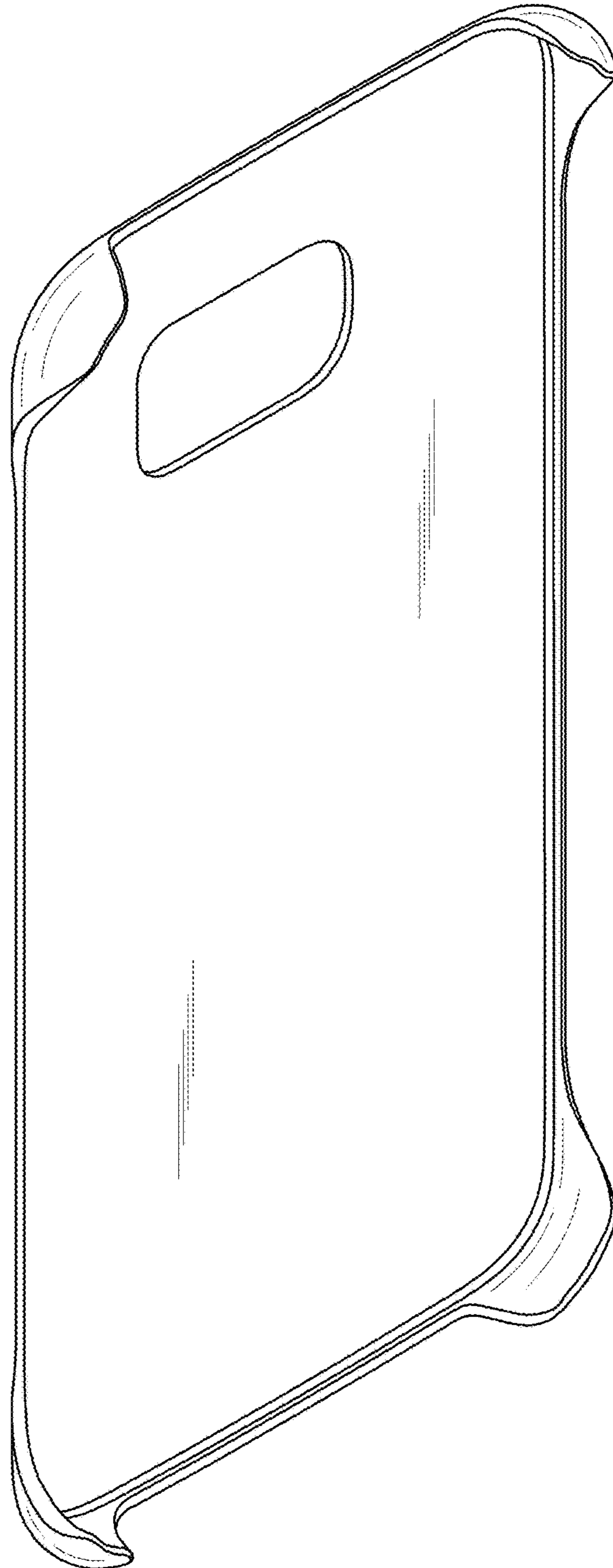

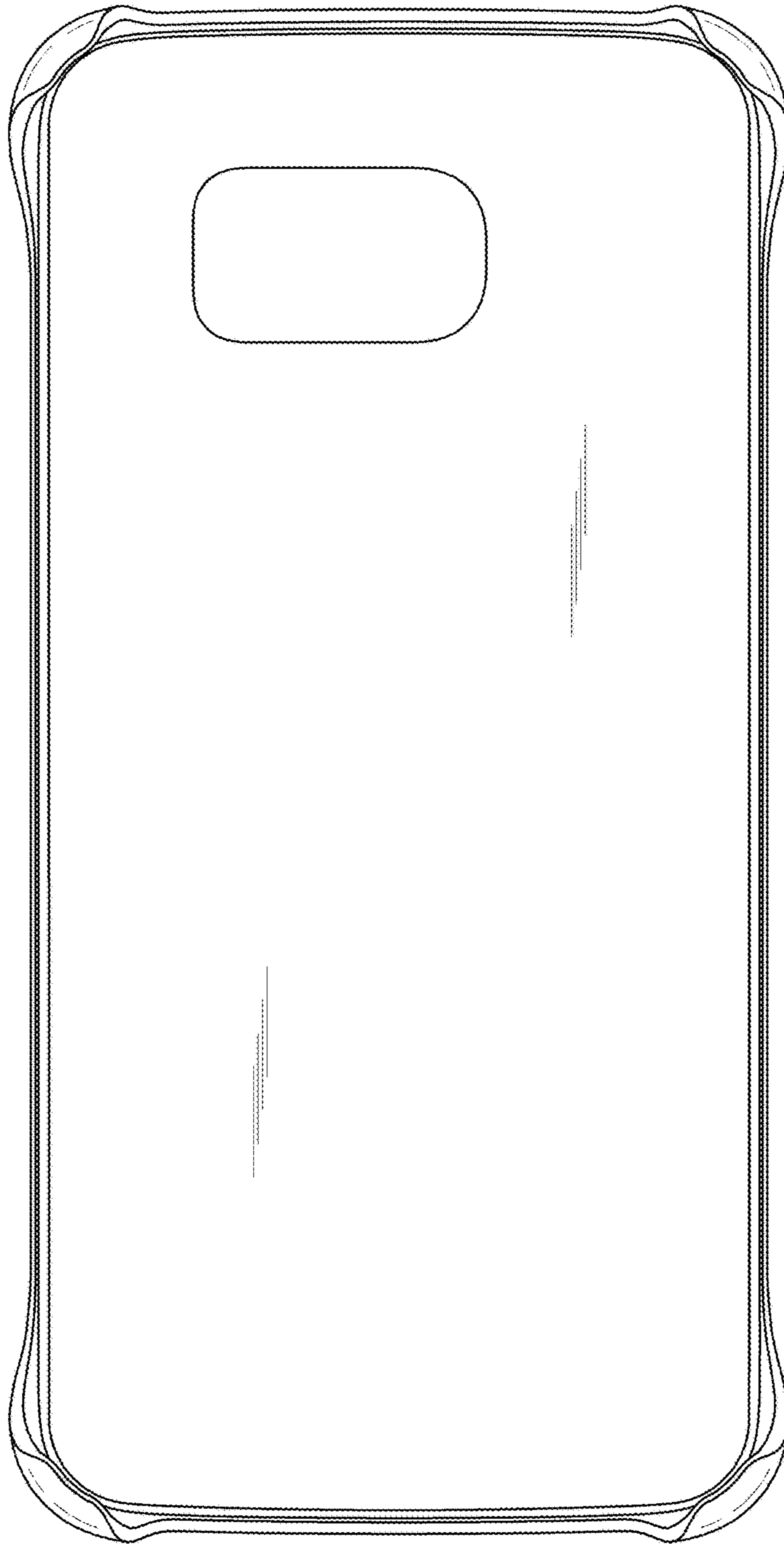

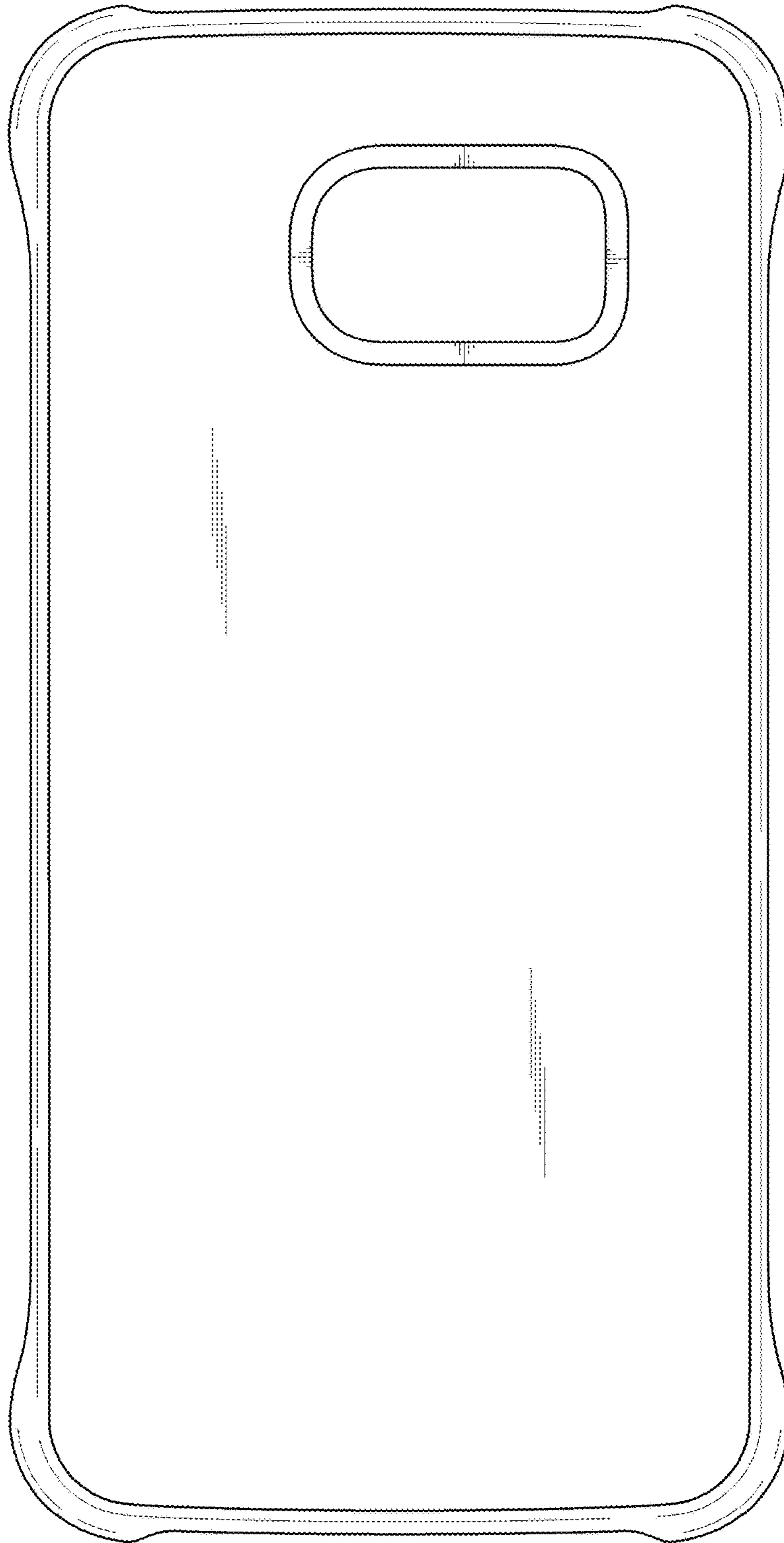

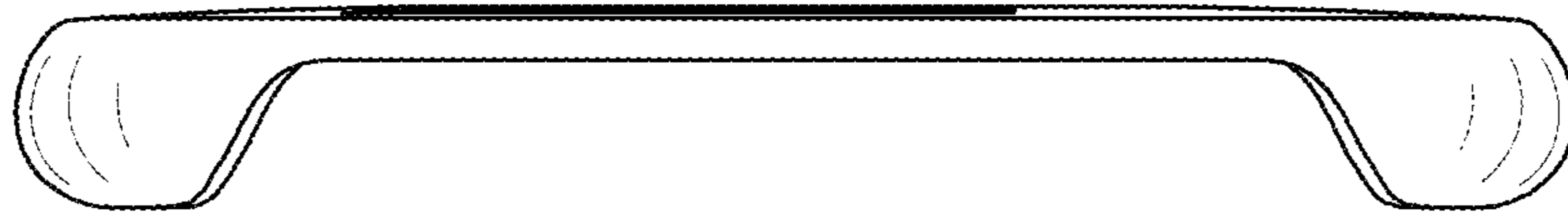

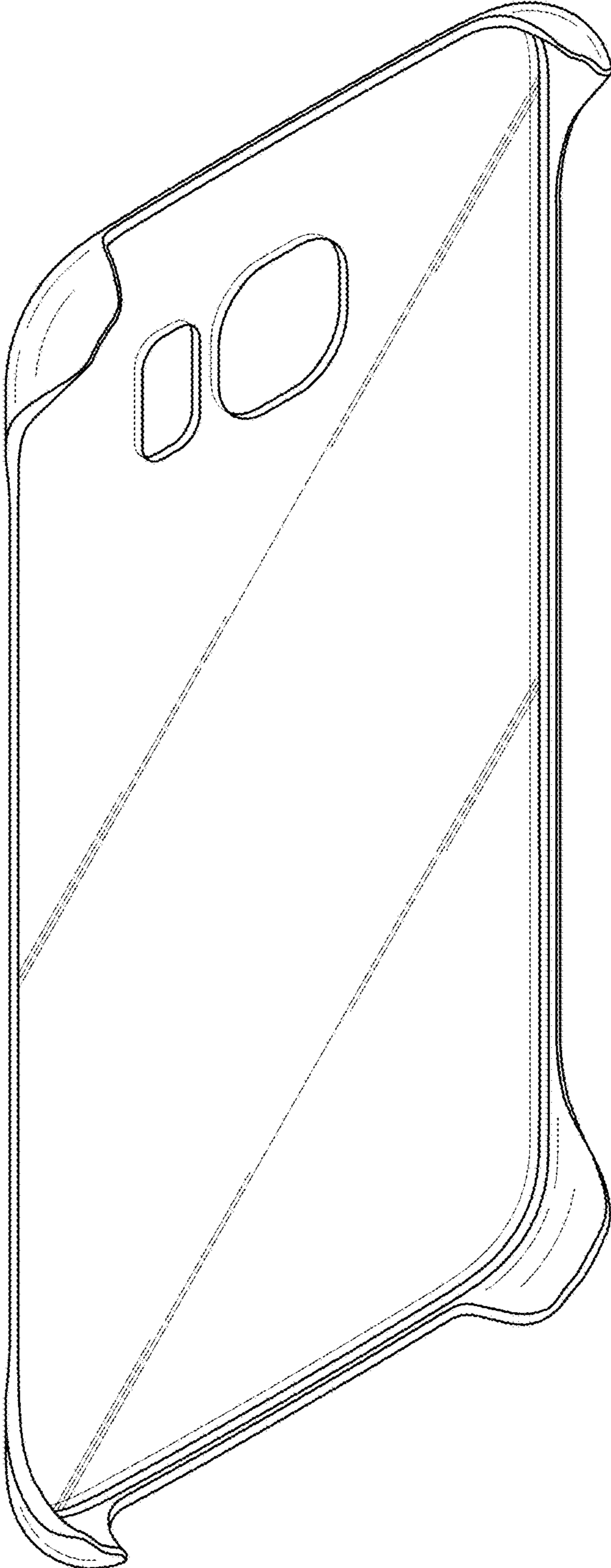

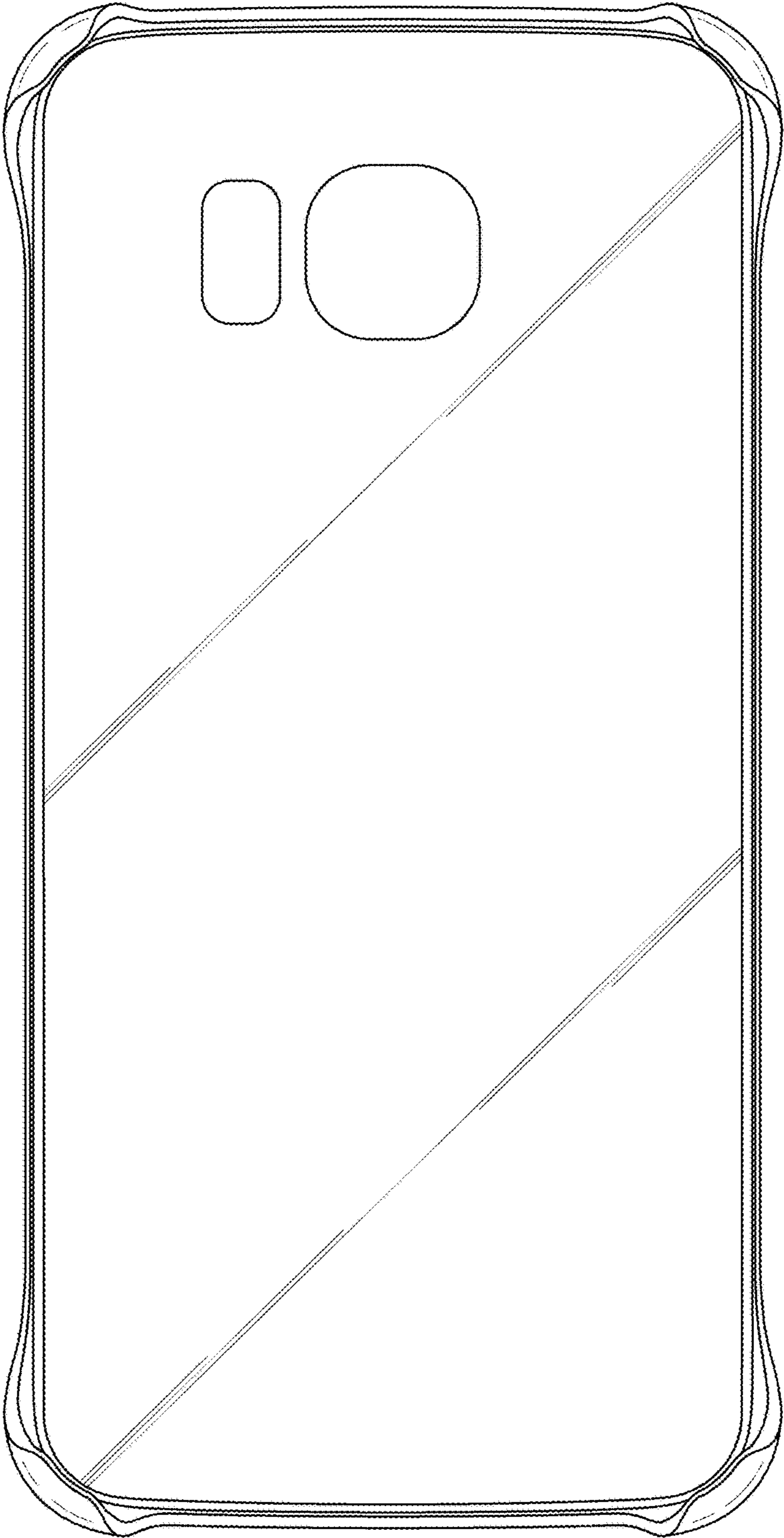

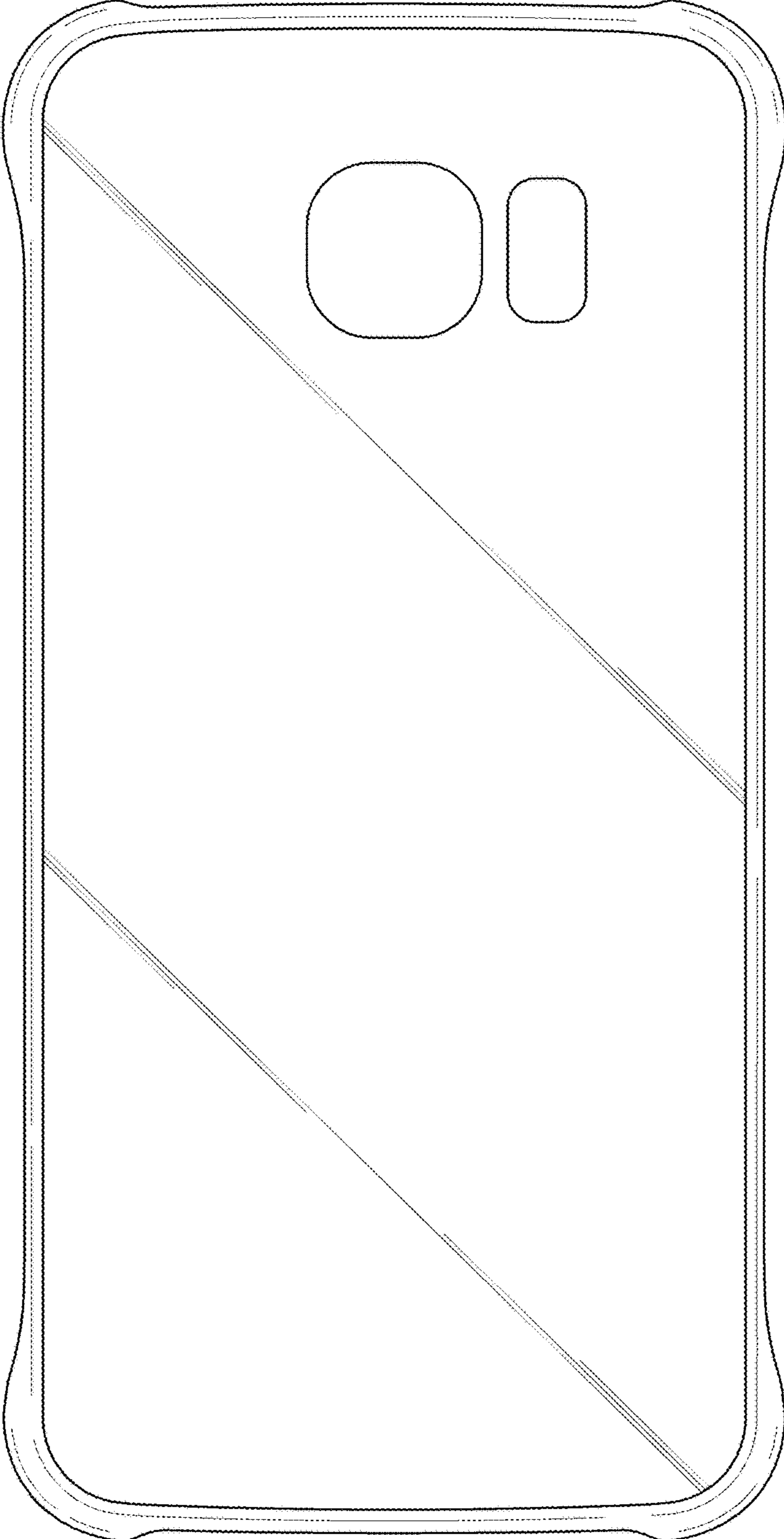

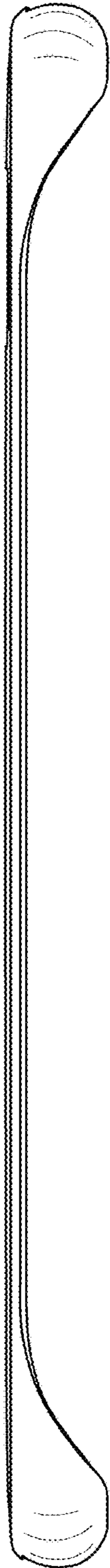

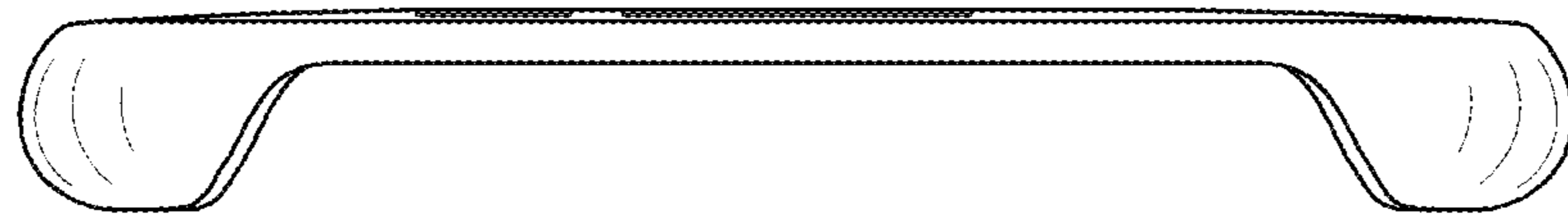

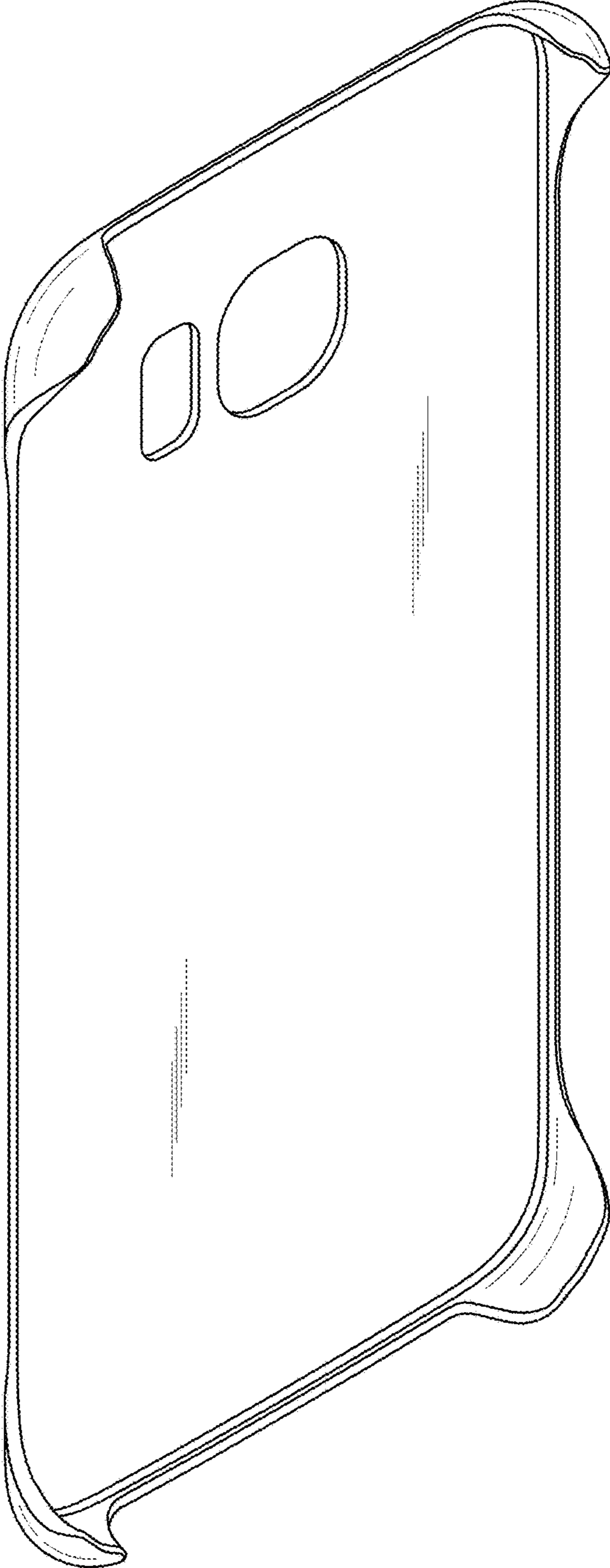

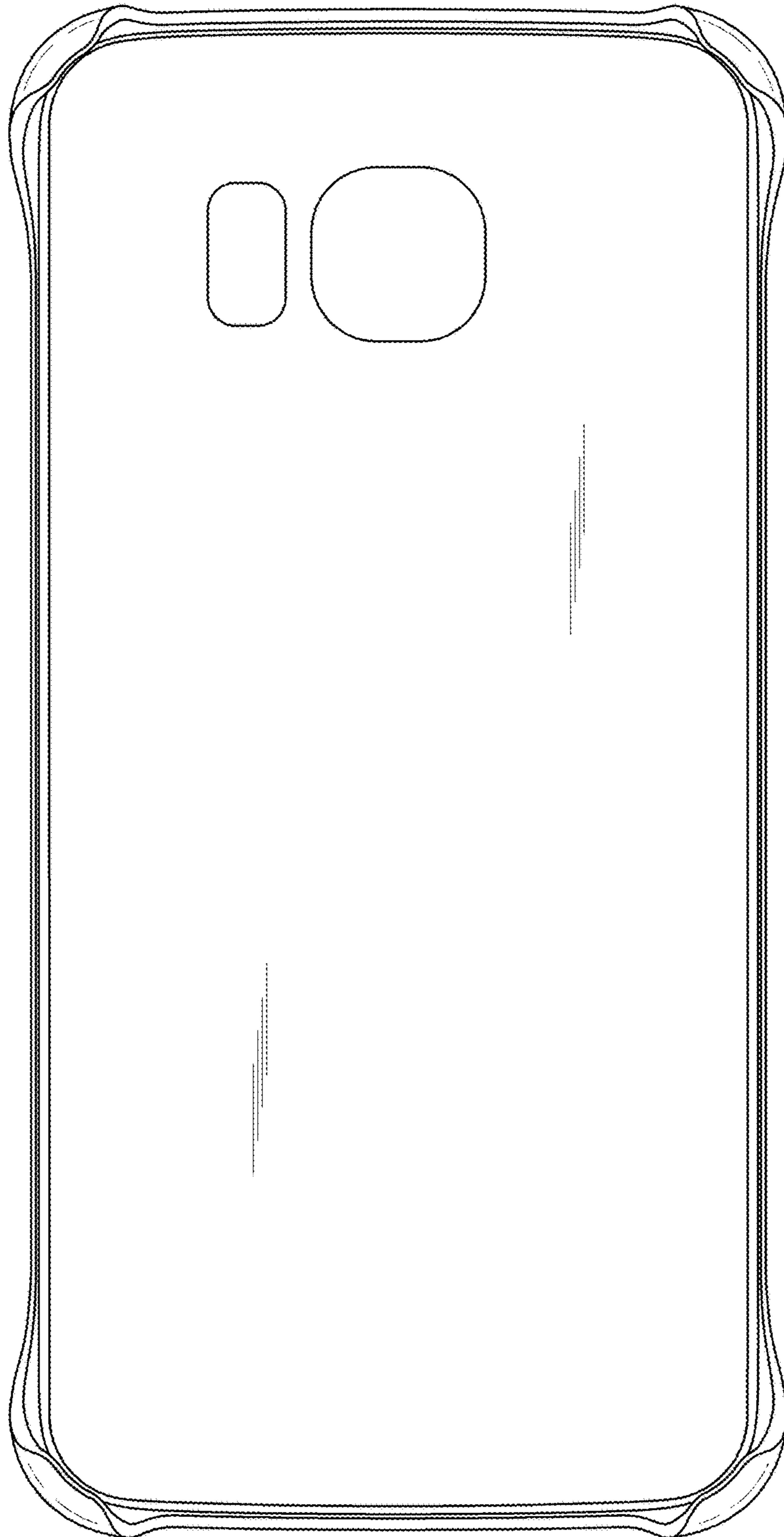

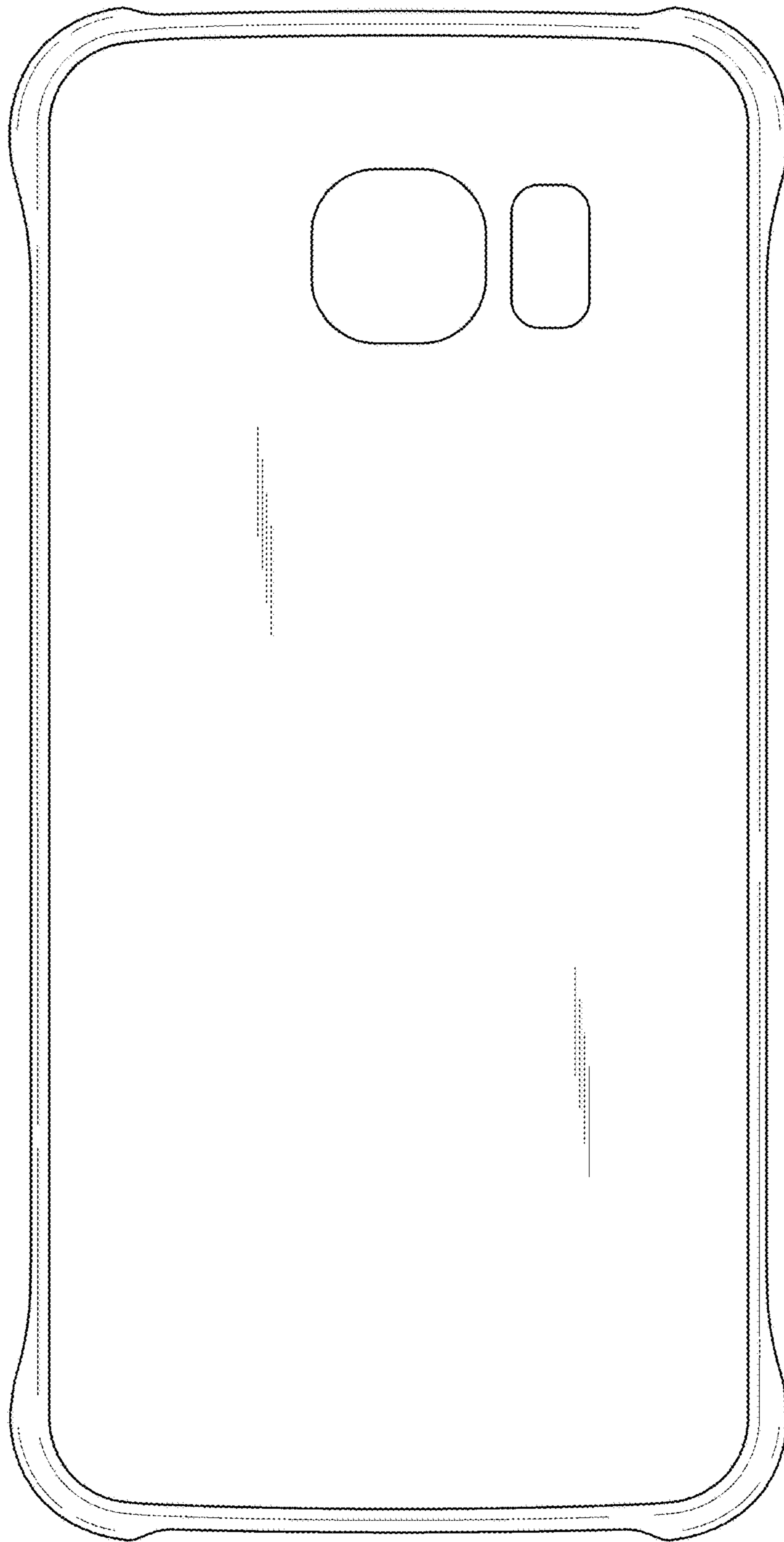

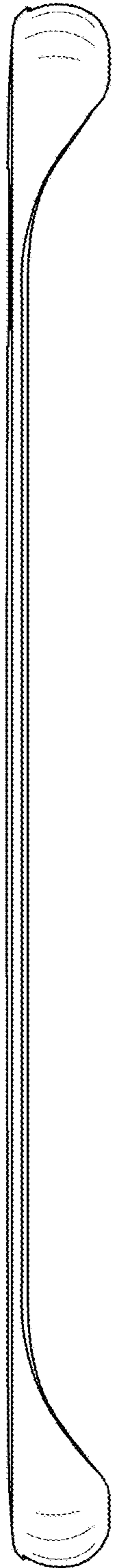

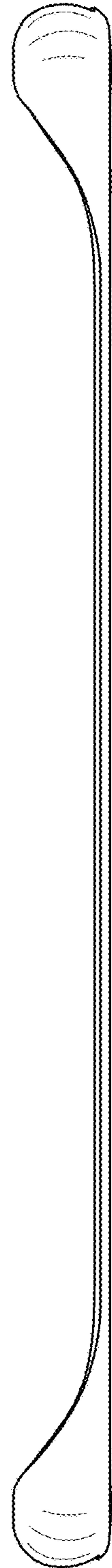
