The ornamental design for a kickstand hinge, as shown and described.

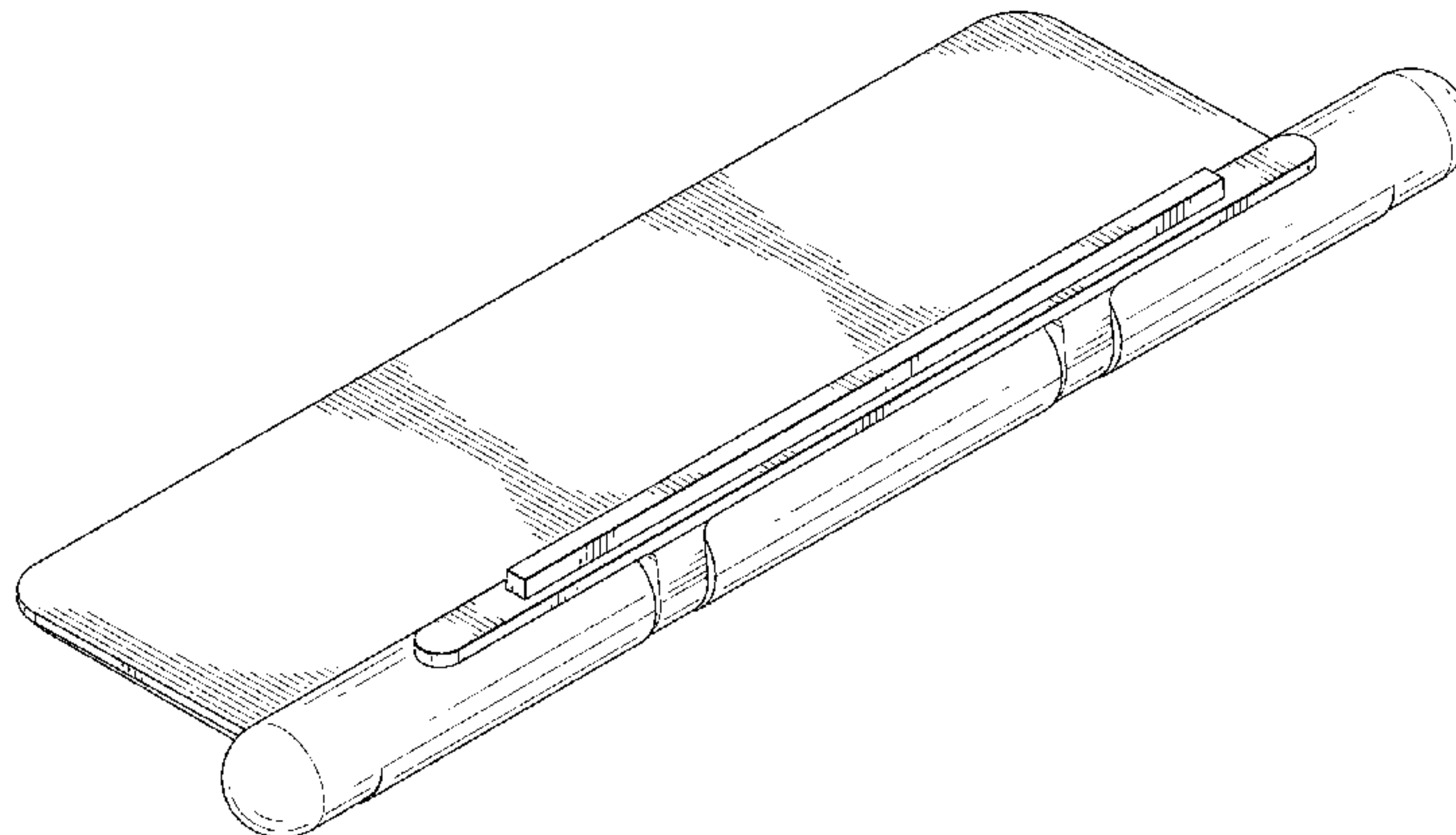
DESCRIPTION

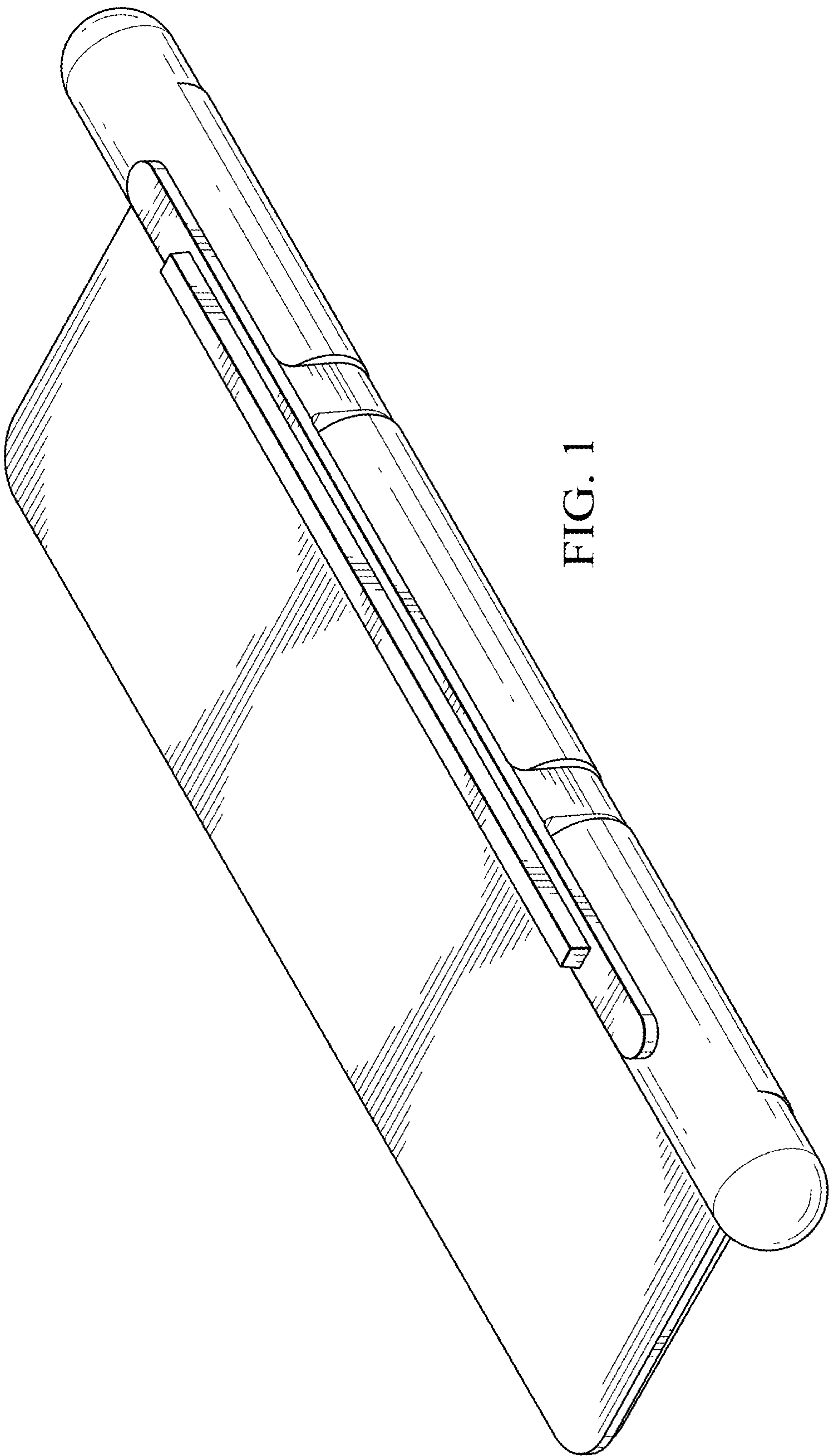

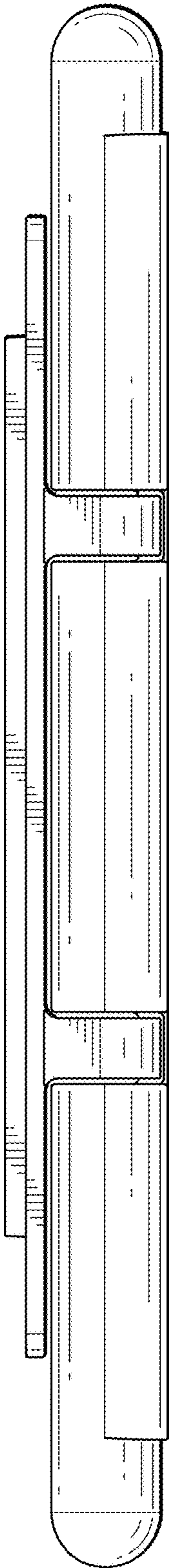

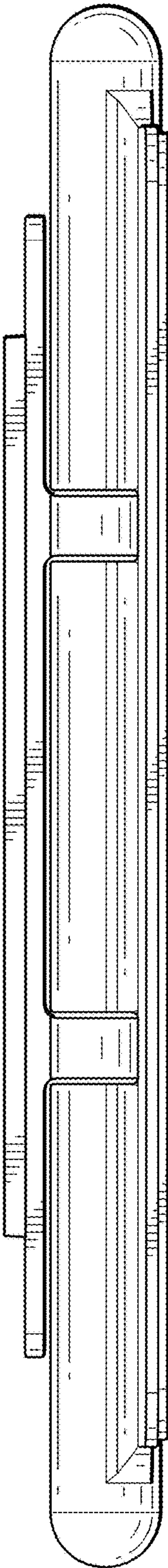

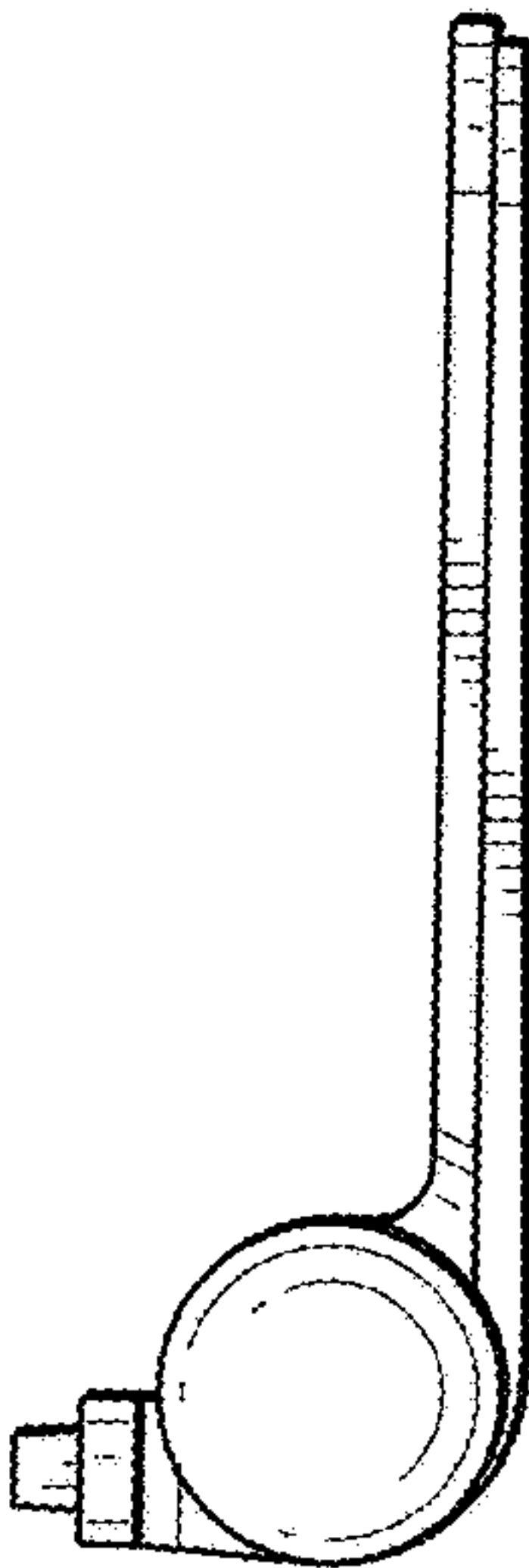

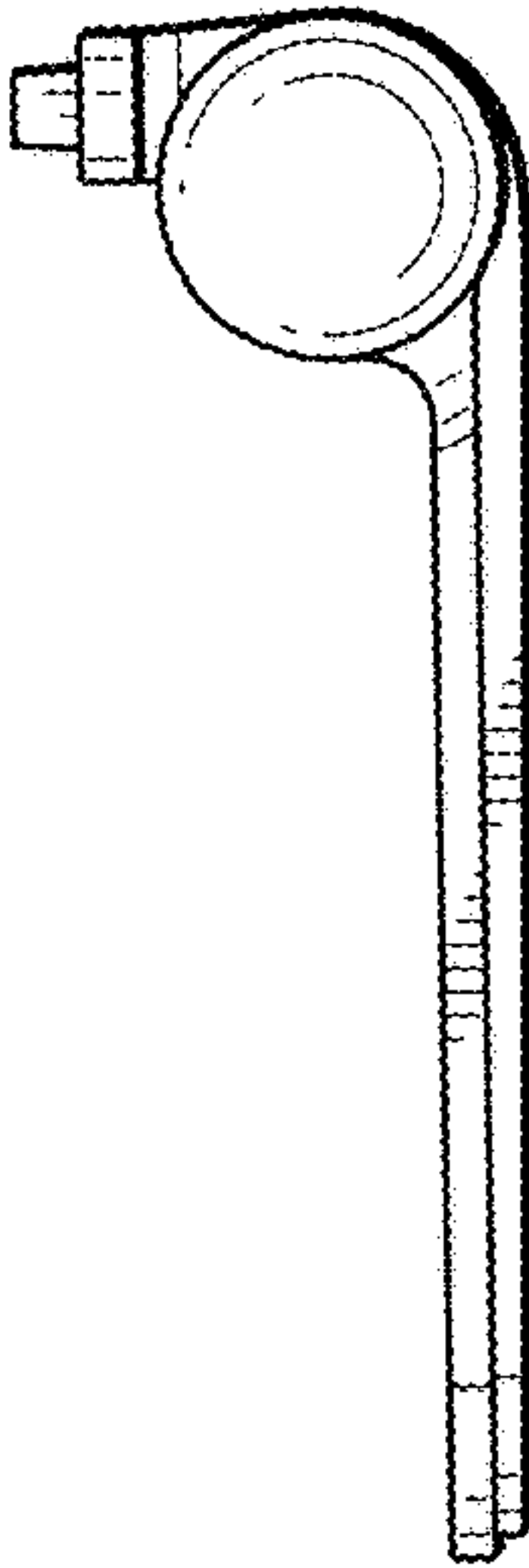

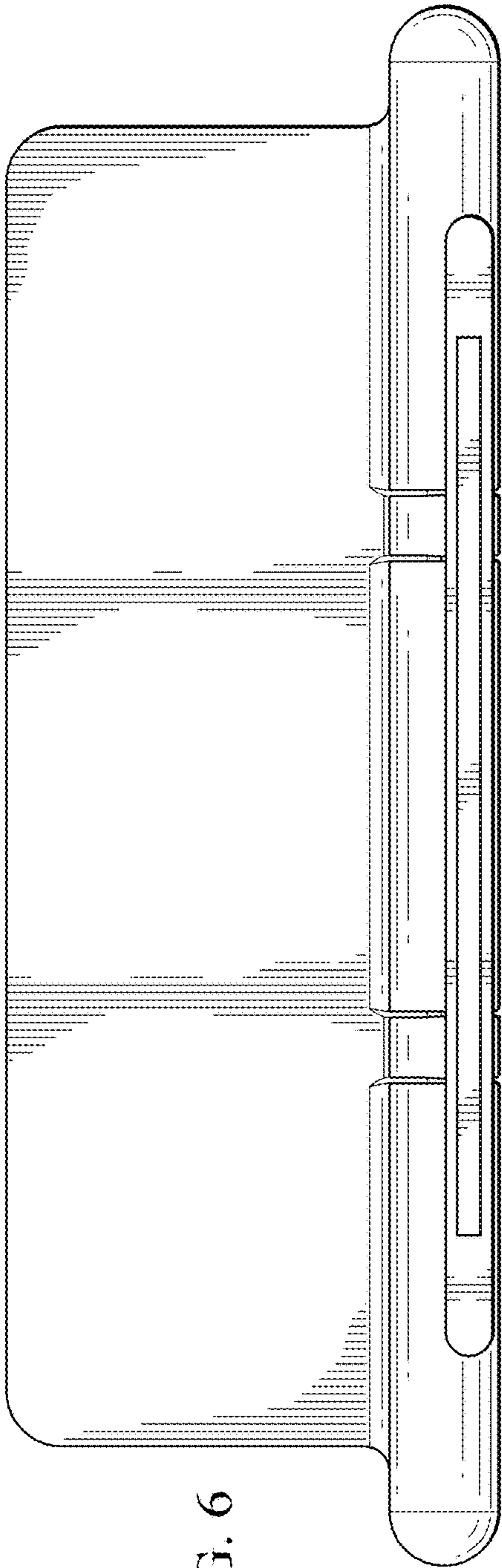

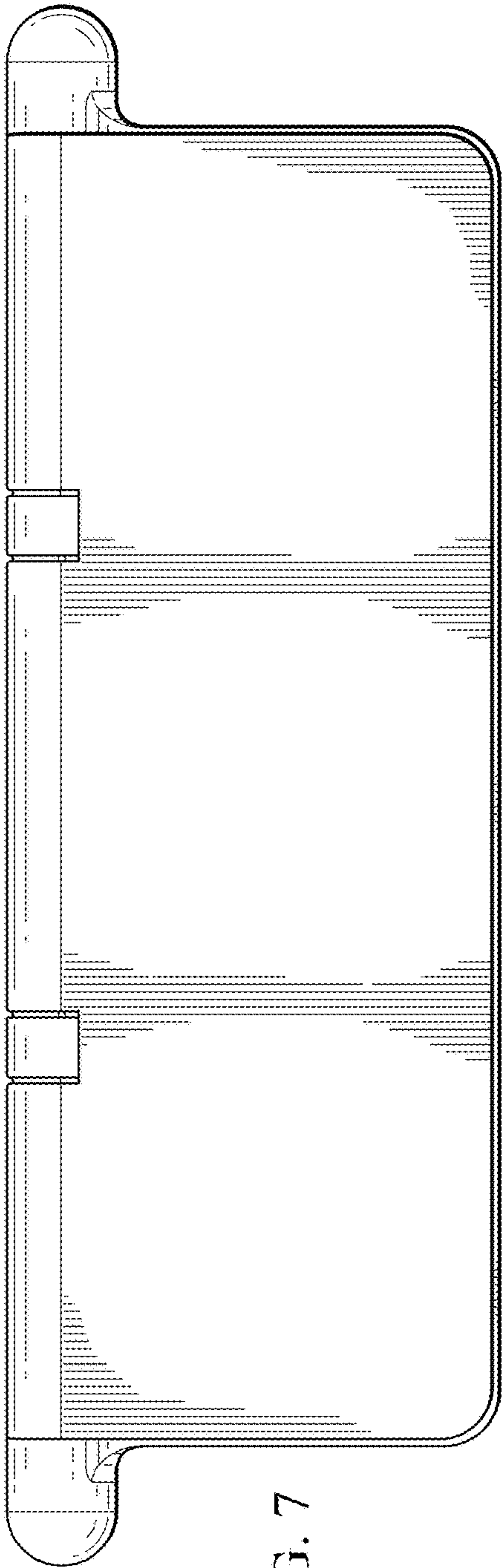

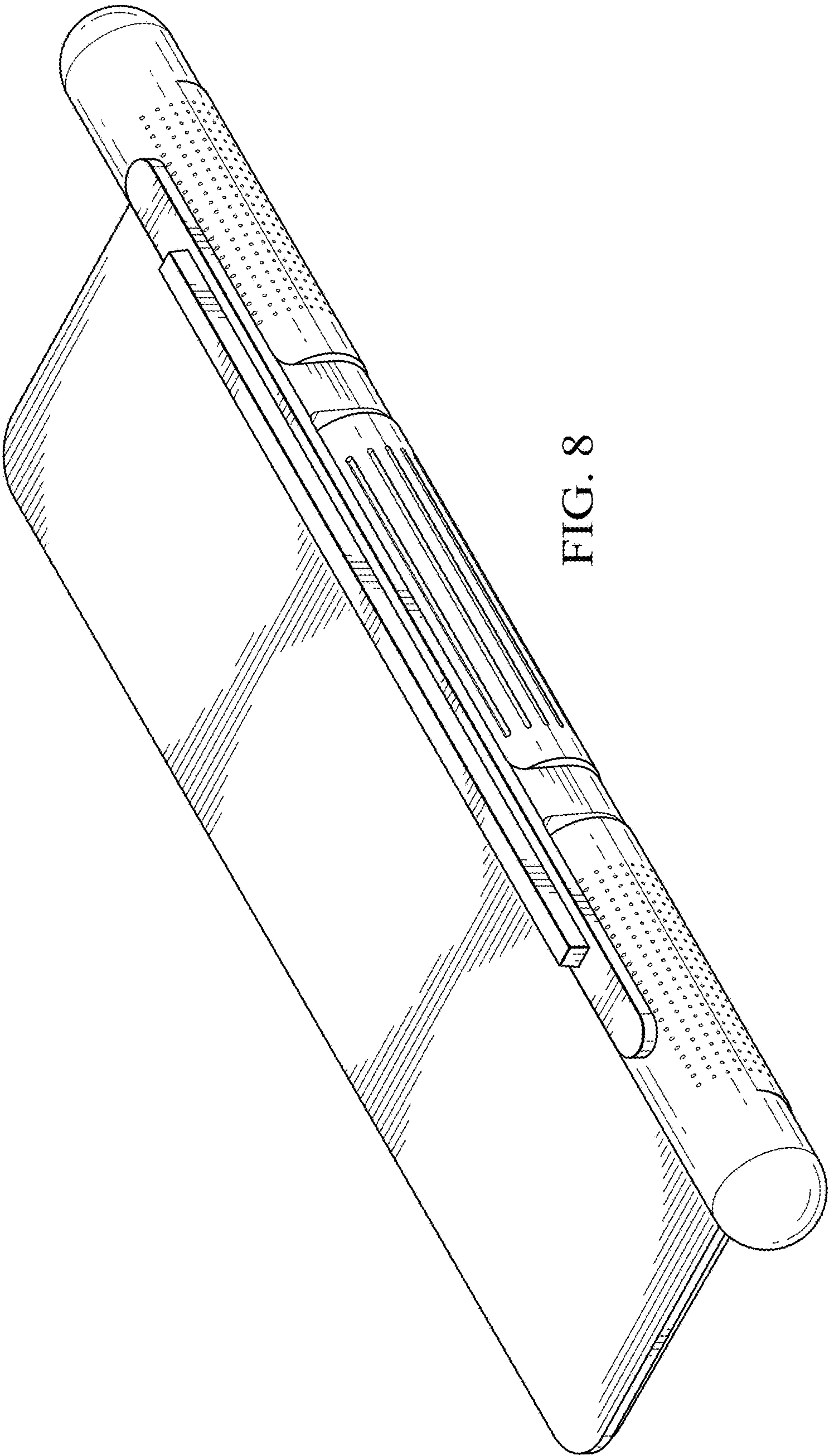

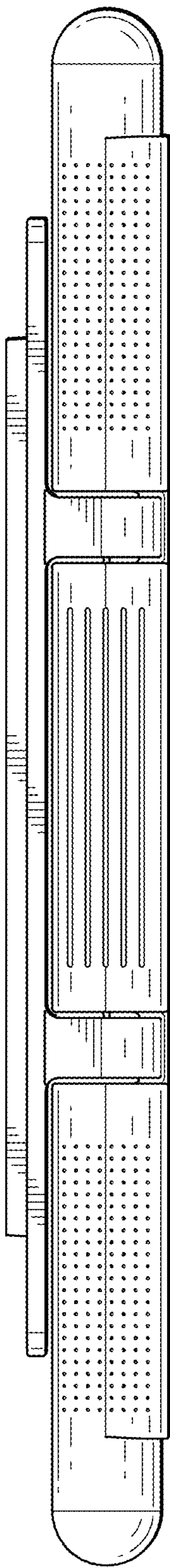

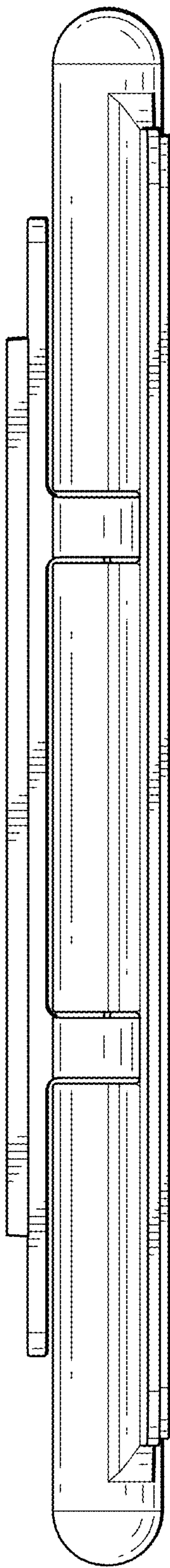

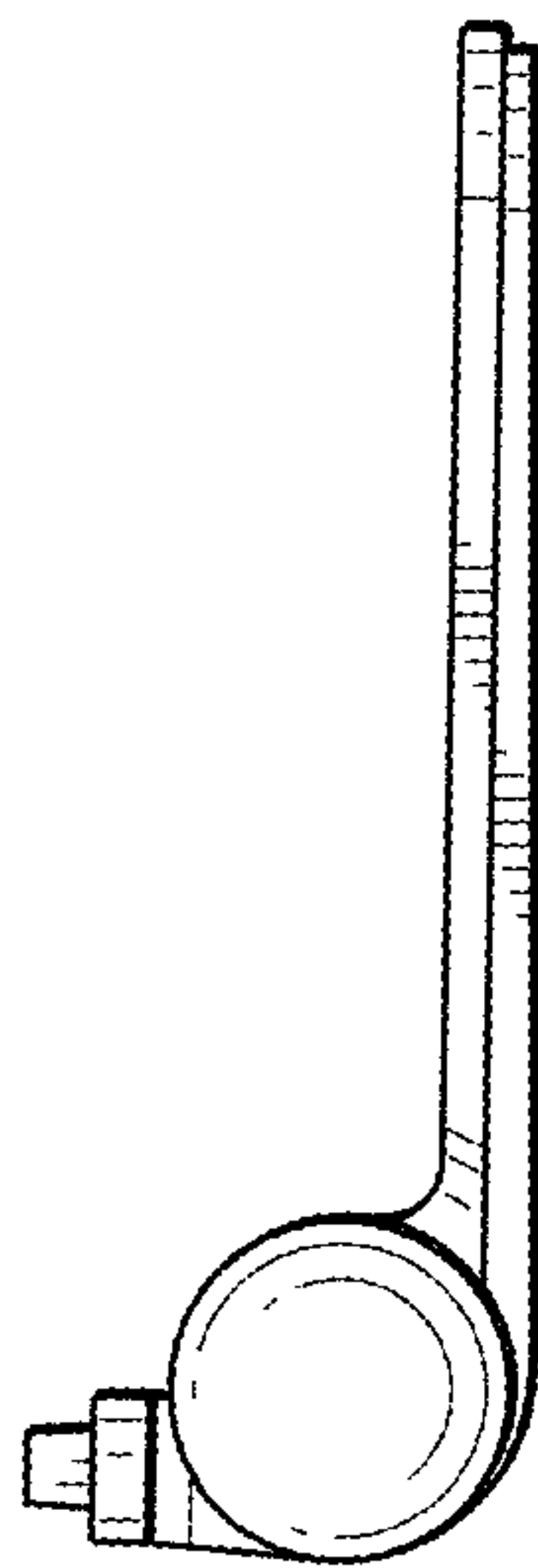

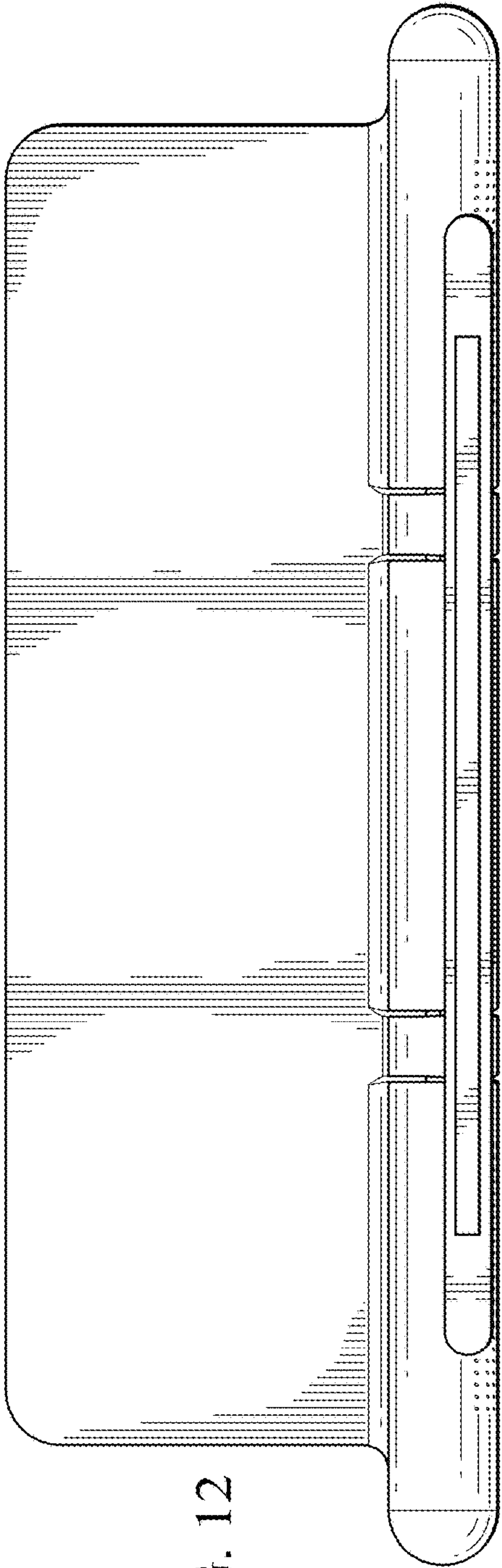

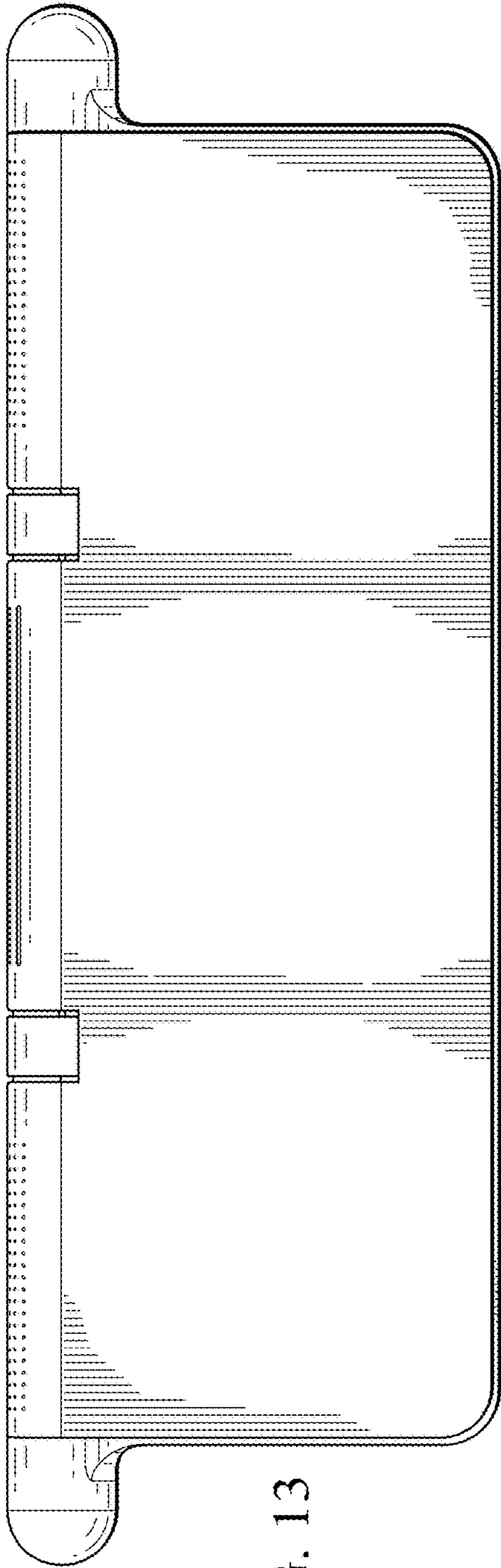

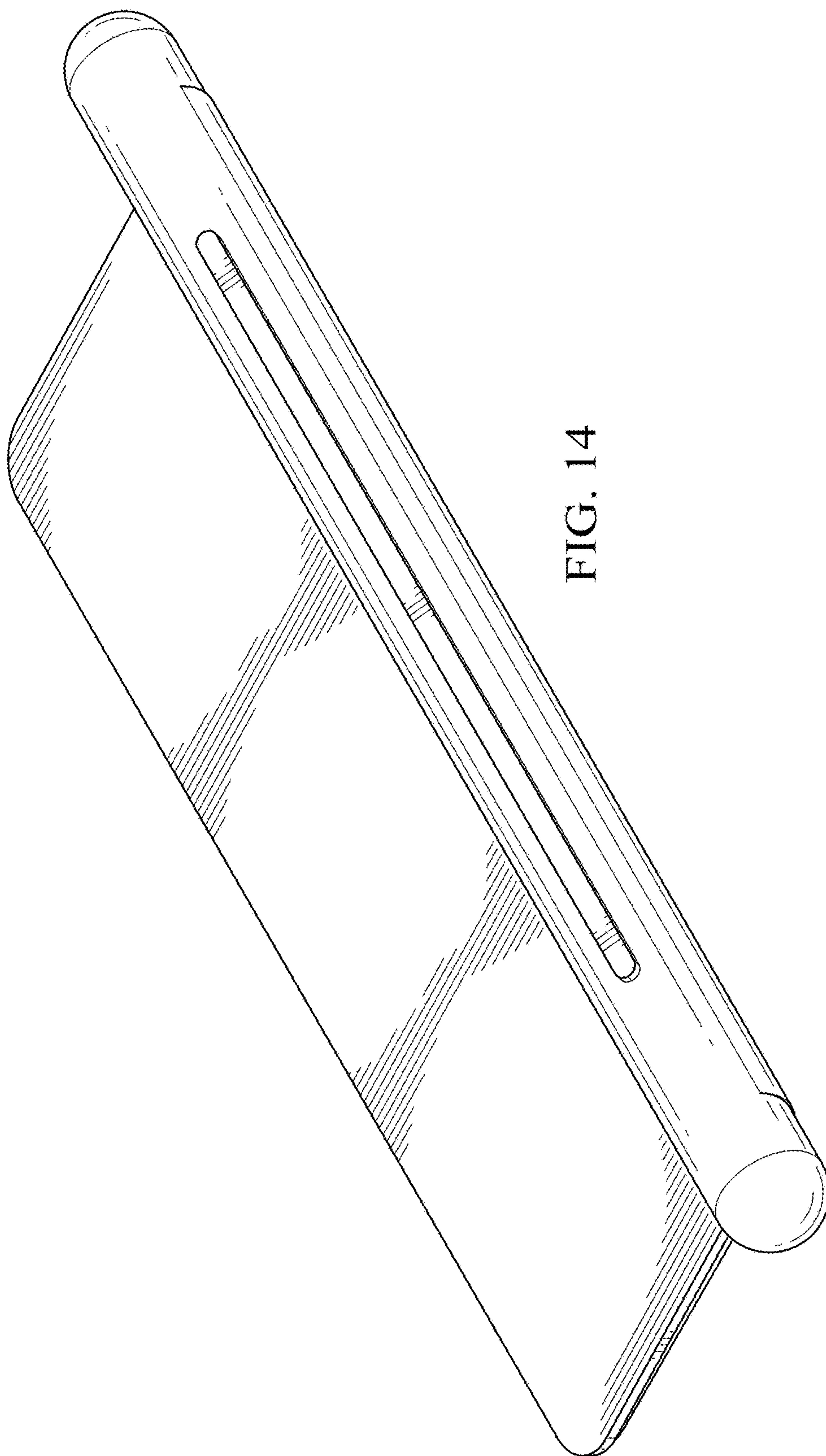

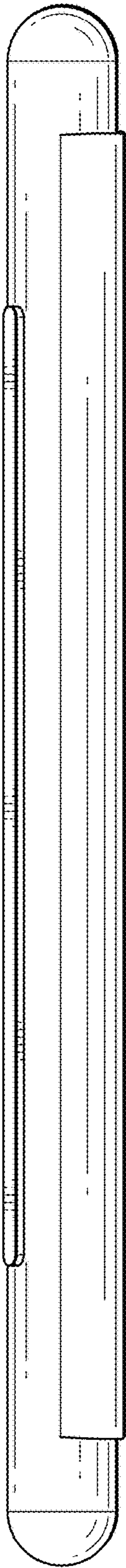

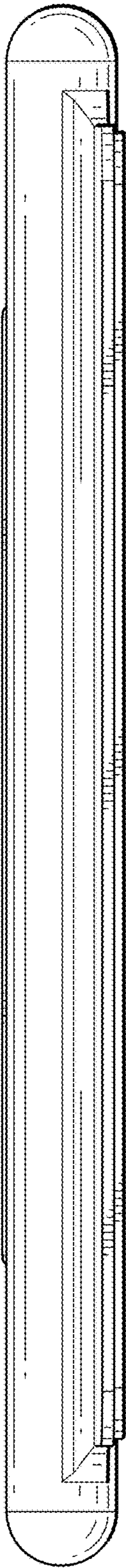

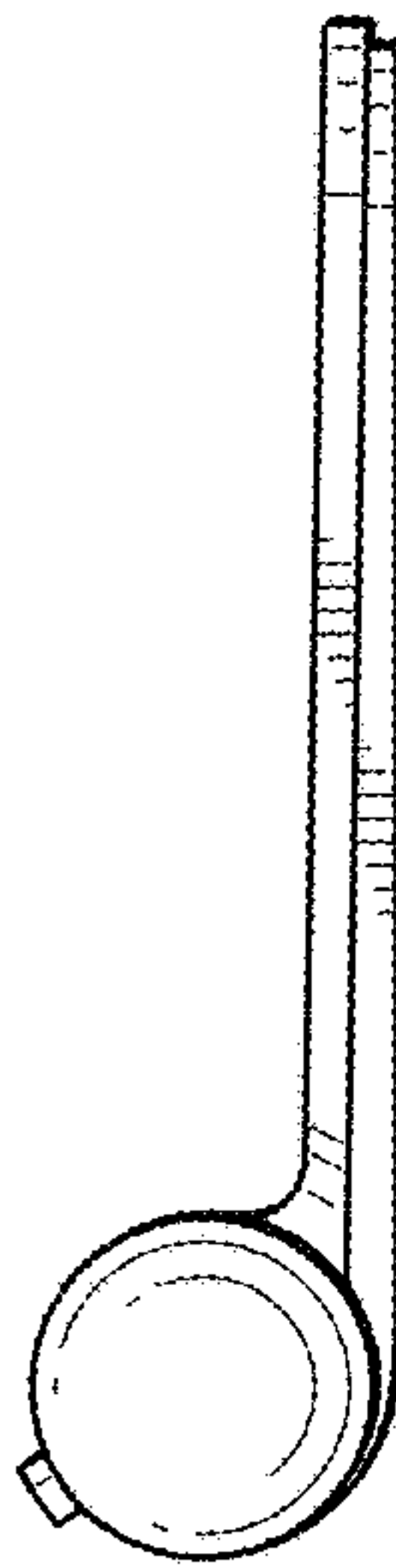

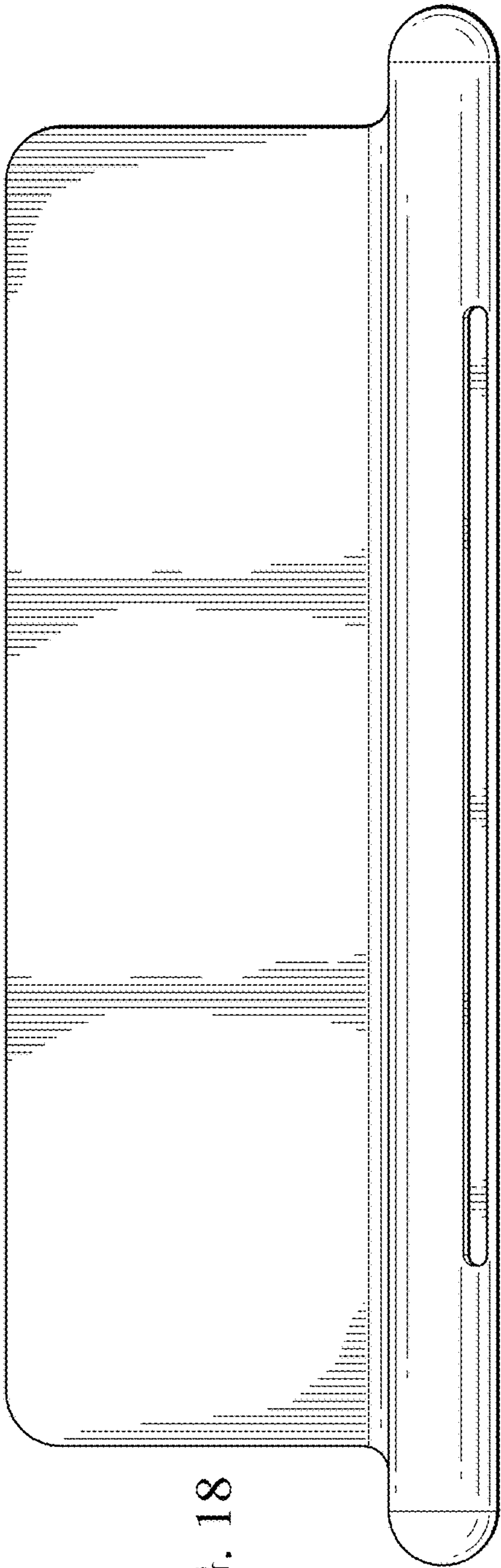

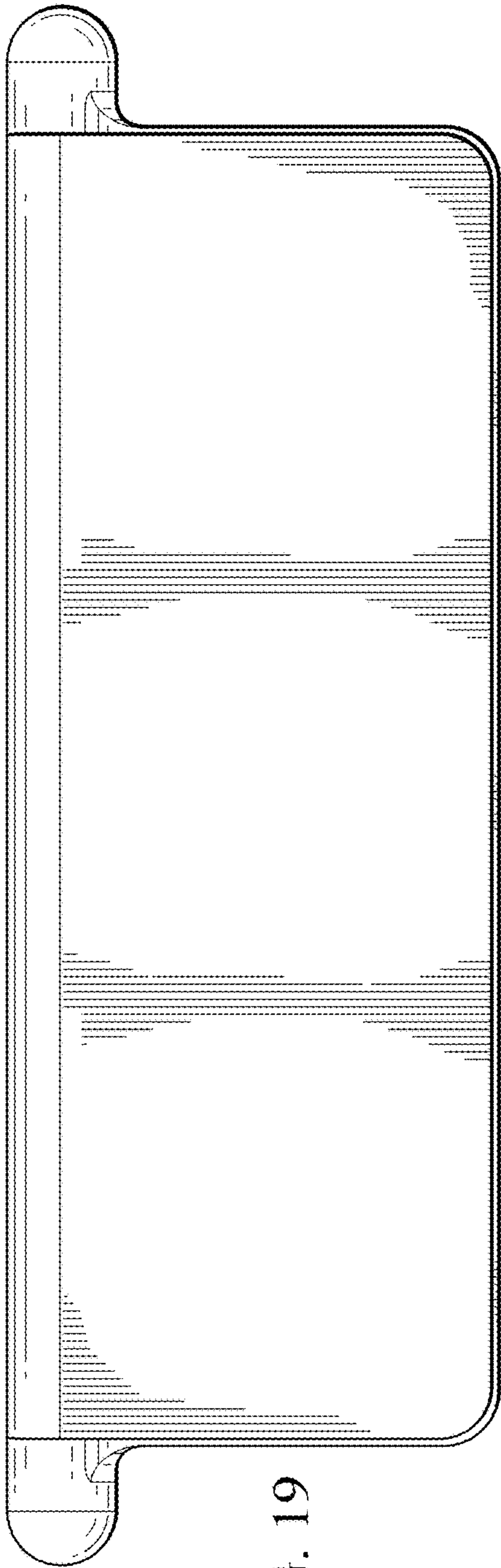

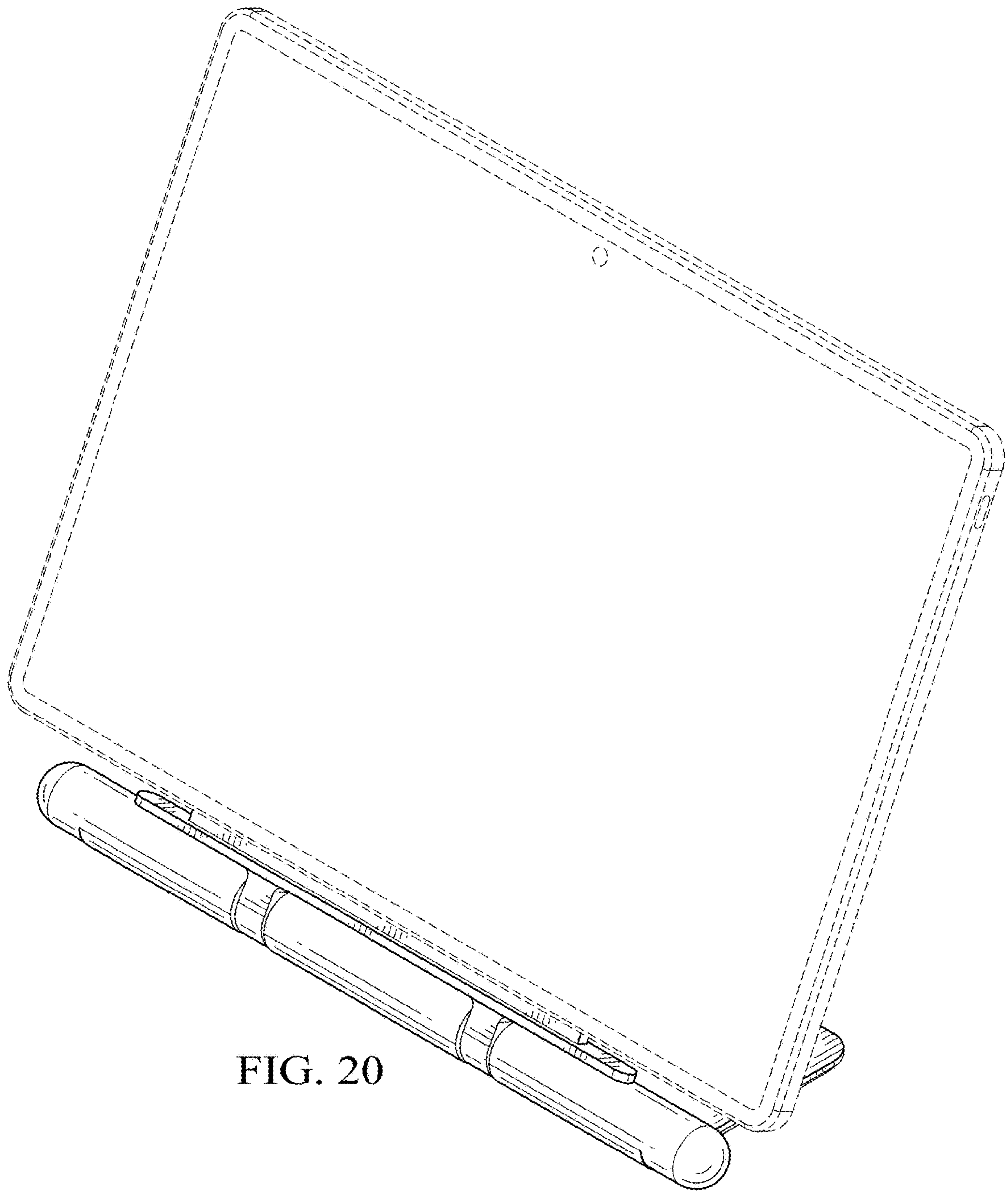

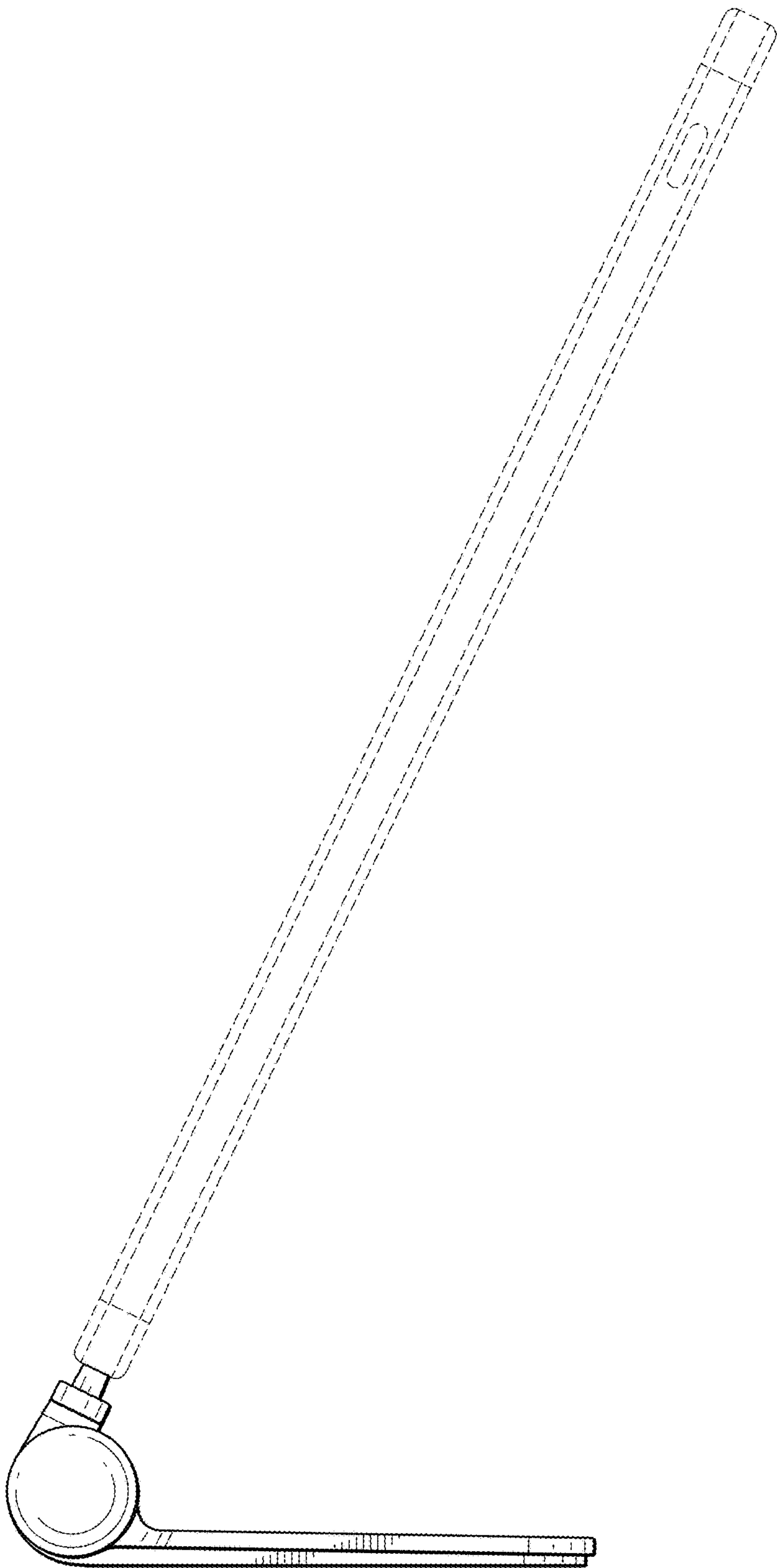

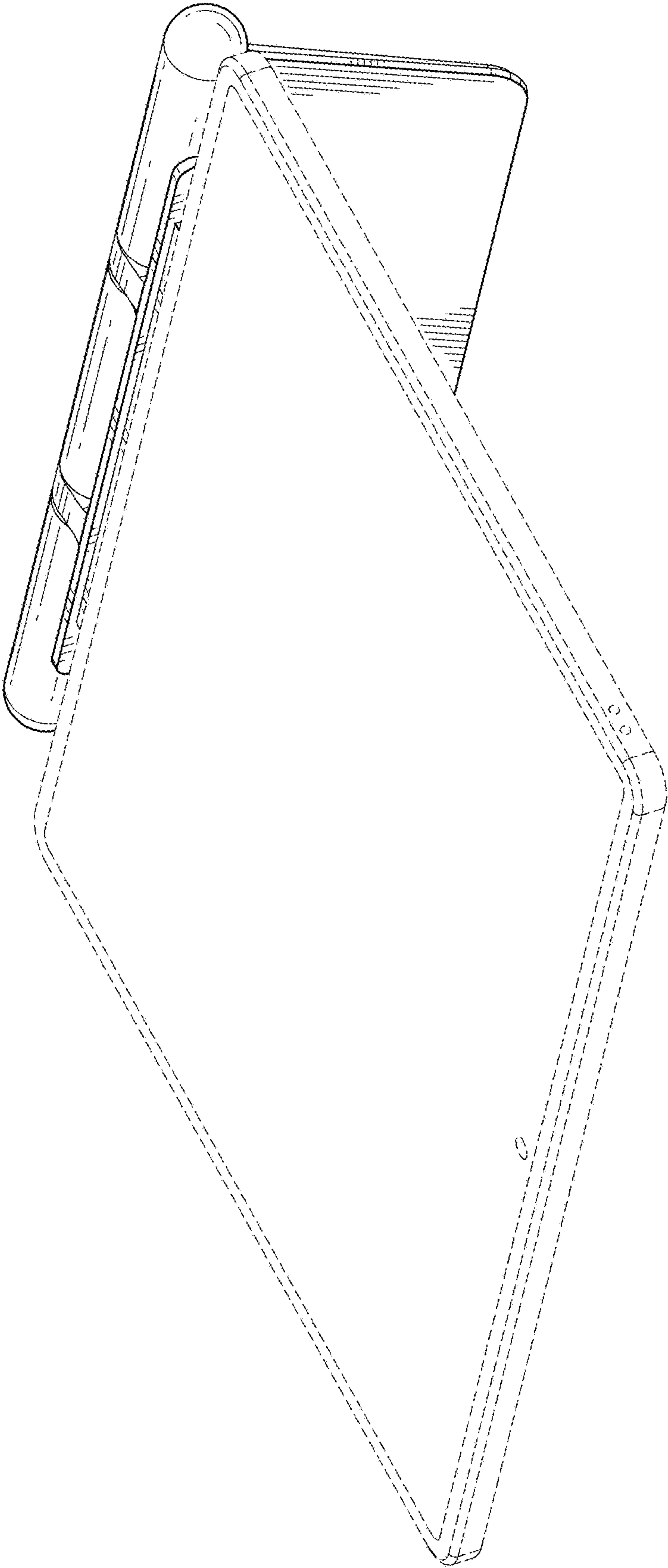

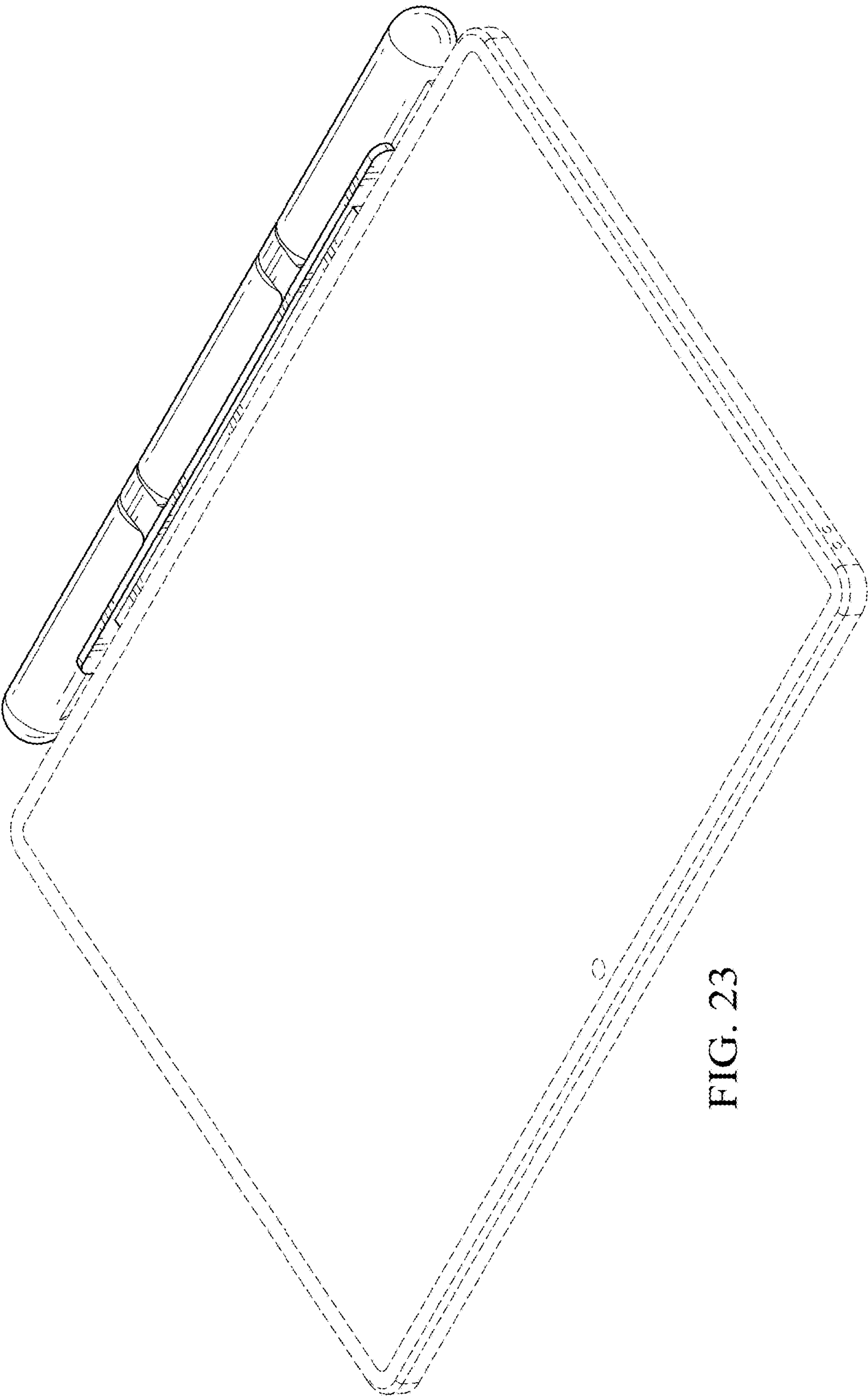

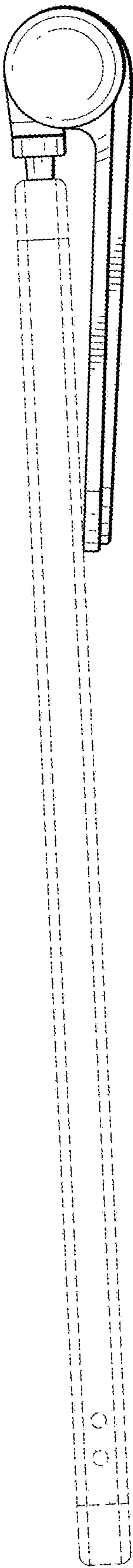

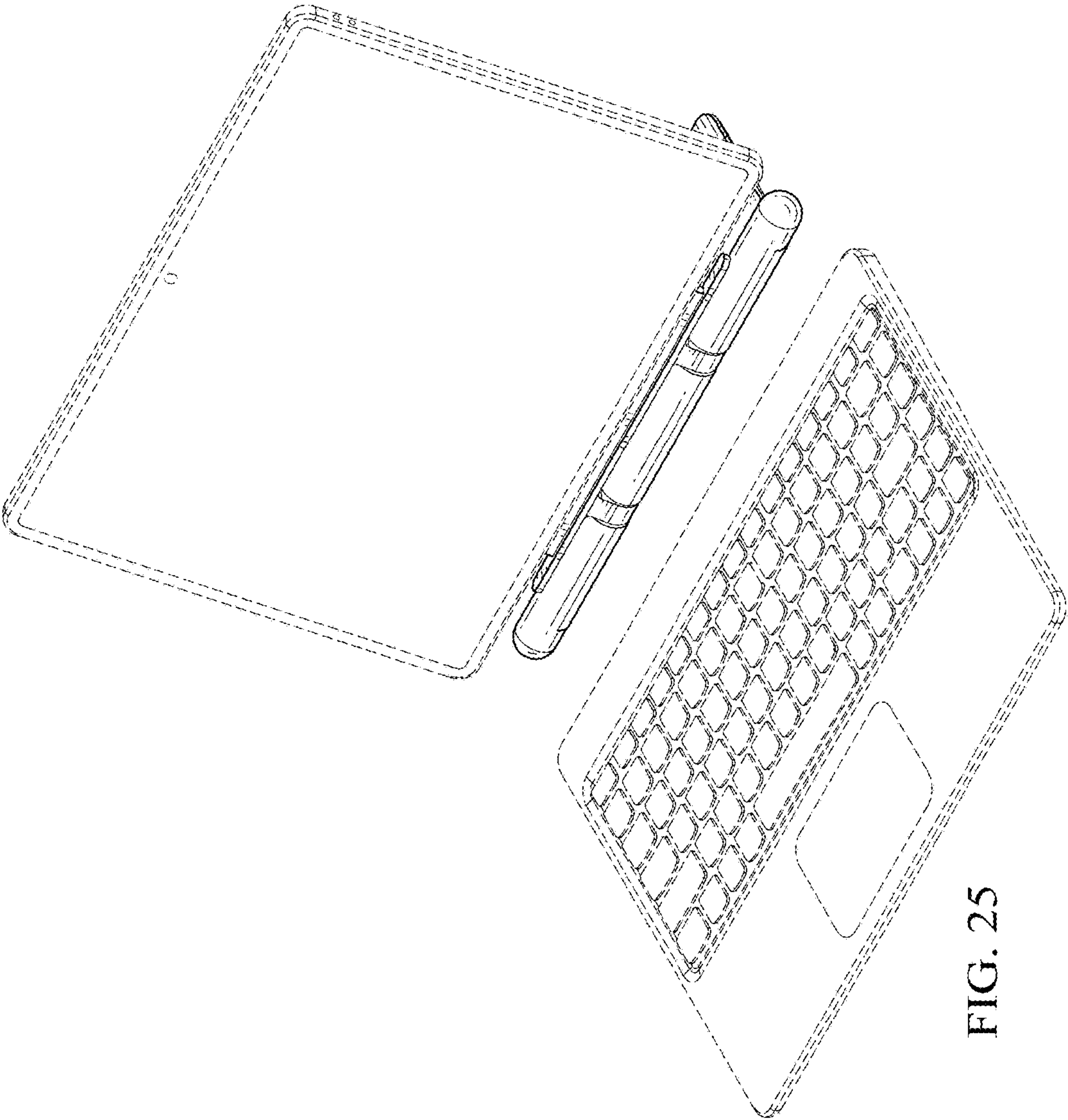

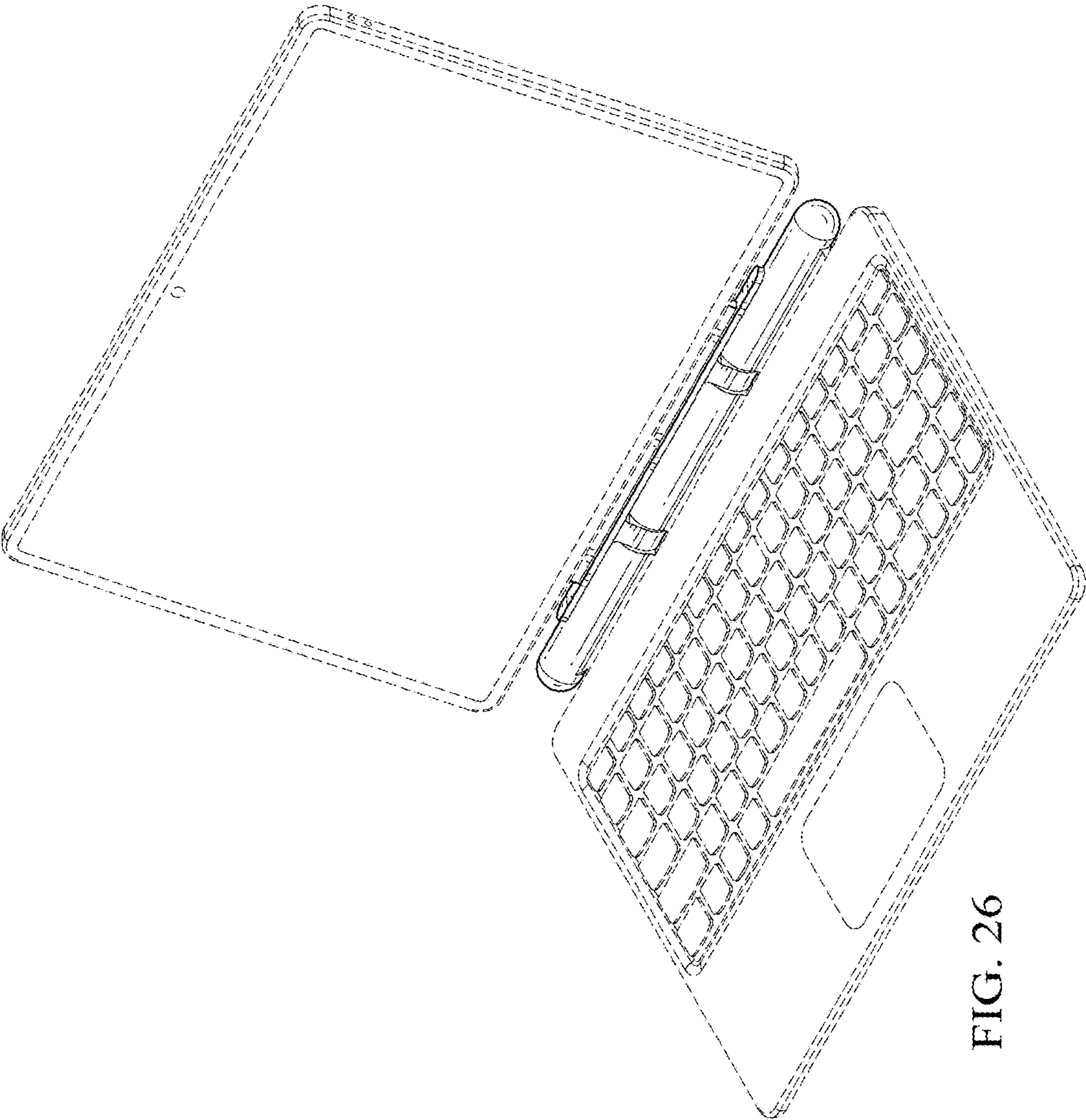

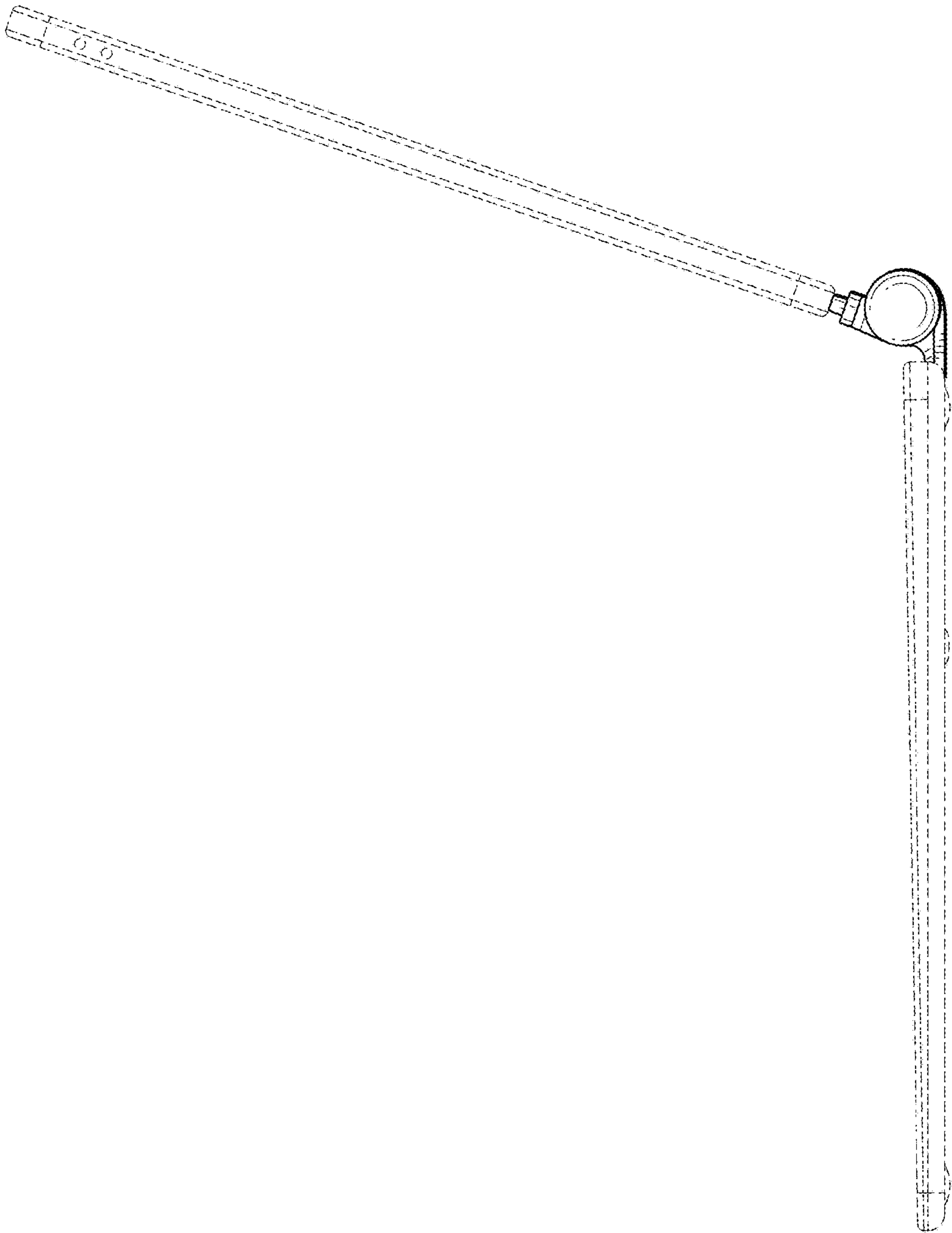

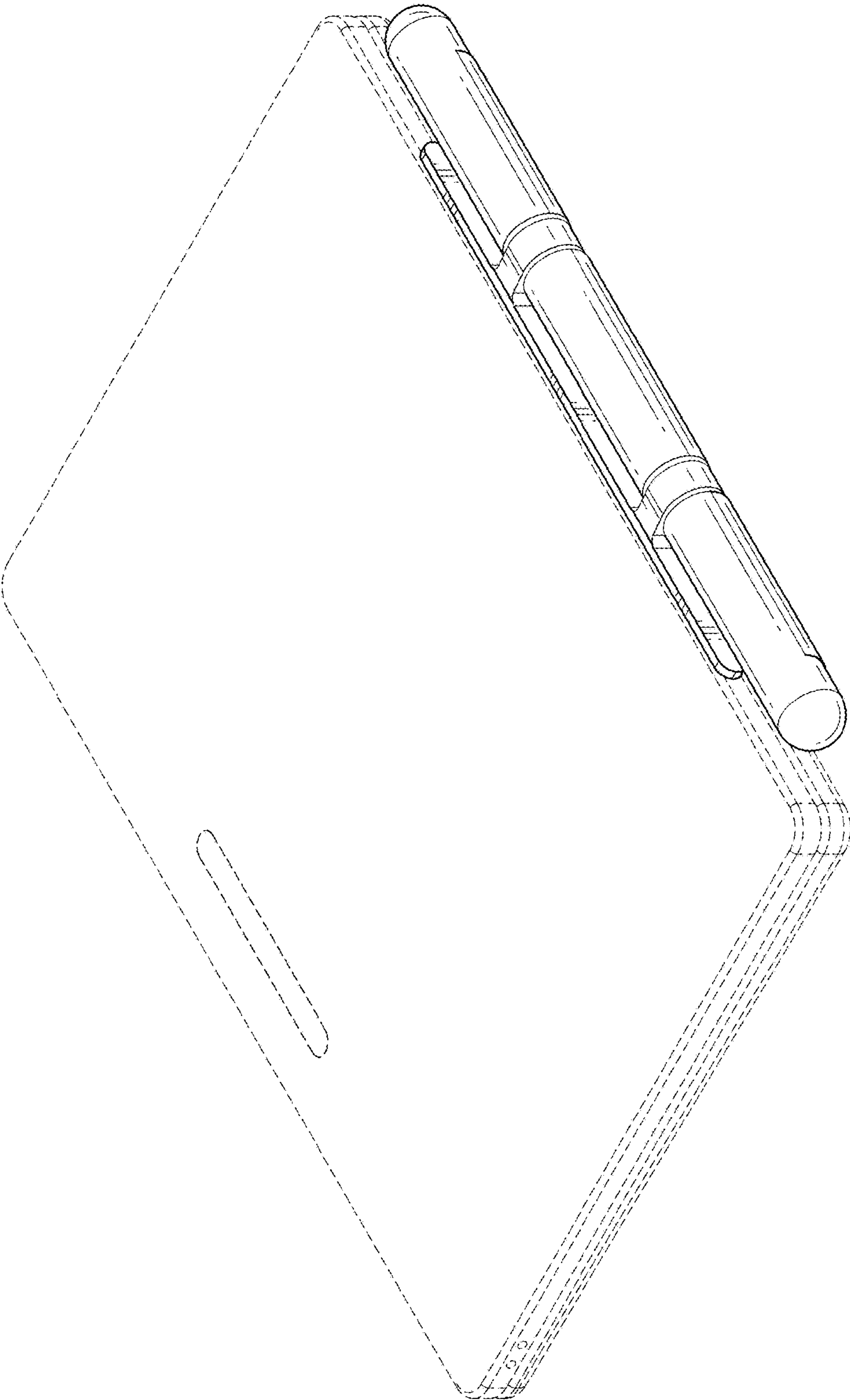

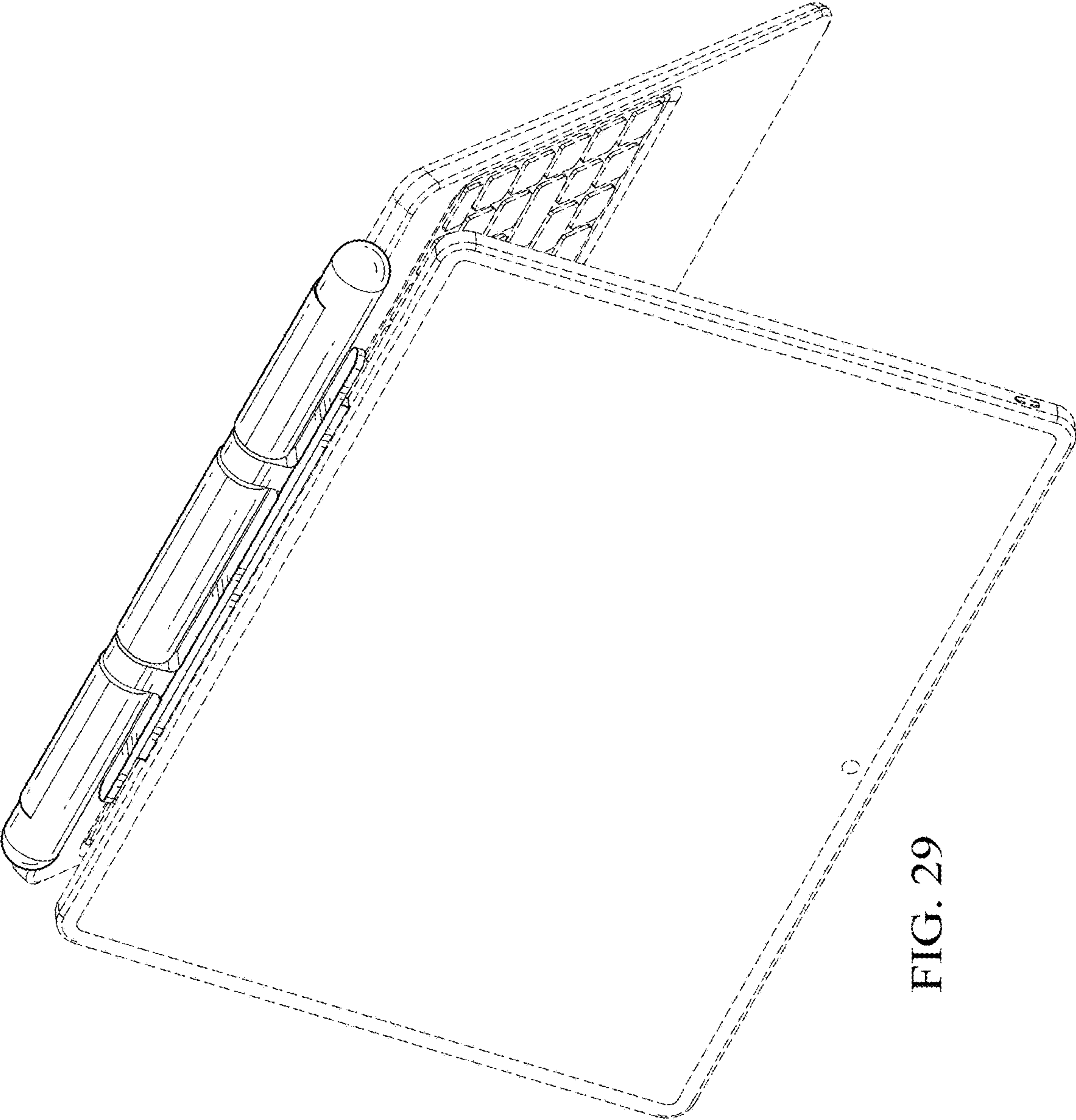

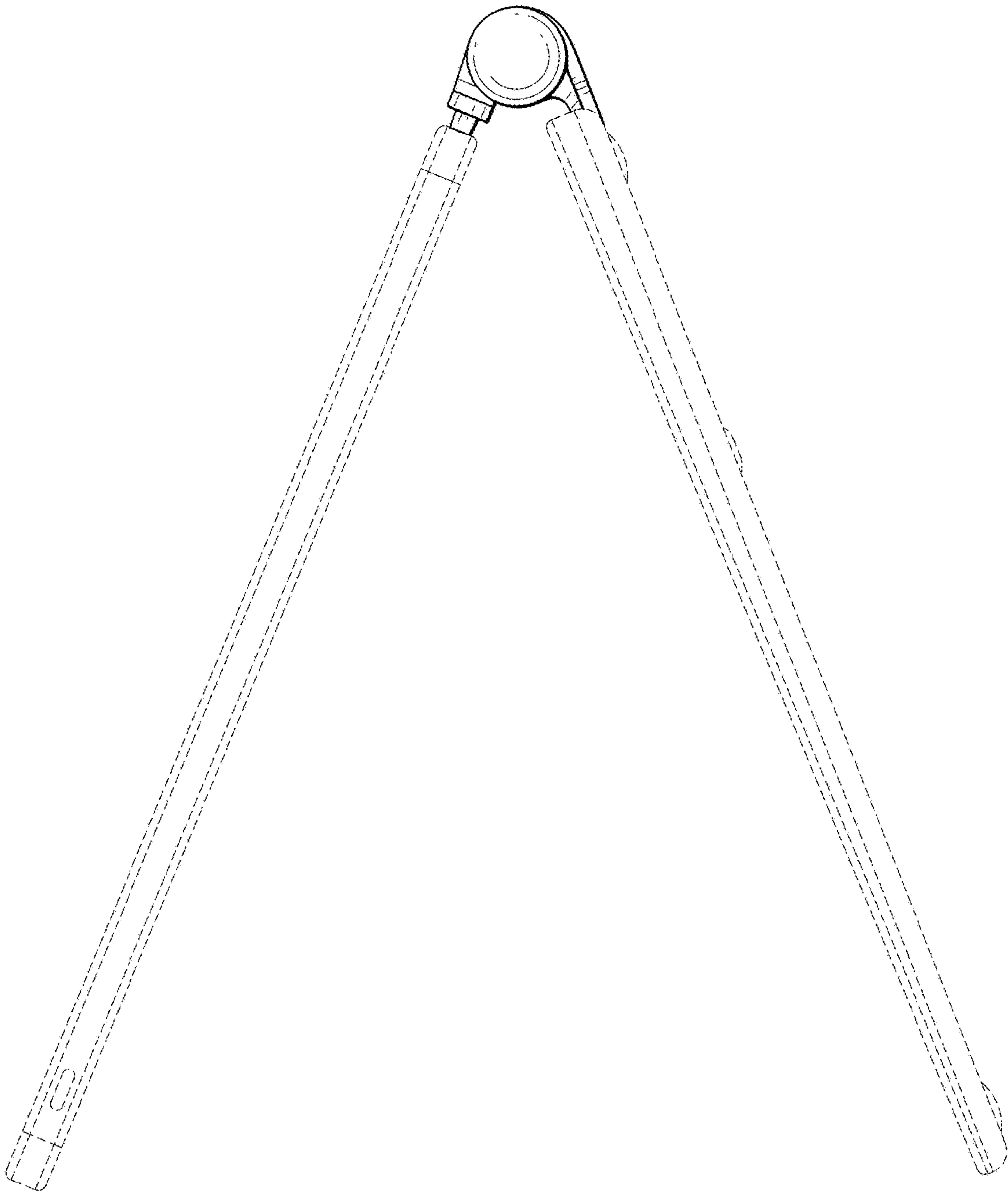
