(57) **CLAIM**

The ornamental design for a display screen with set of graphical user interface icons, as shown and described.

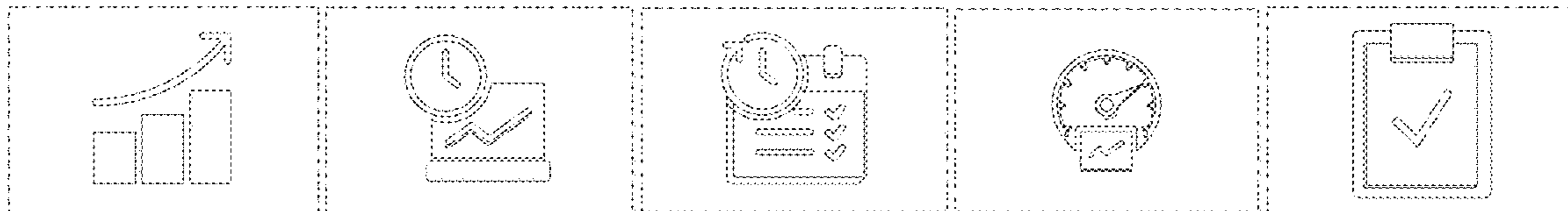
DESCRIPTION

FIG. 1 is a front view of a display screen with set of graphical user interface icons, showing the new design; FIG. 2 is a front view of a display screen with set of graphical user interface icons, showing the new design, in an alternate configuration; FIG. 3 is a front view of an icon from the set of graphical user interface icons, shown in isolation; and FIG. 4 is a front view of a second icon from the set of graphical user interface icons, shown in isolation; and FIG. 5 is a front view of a third icon from the set of graphical user interface icons, shown in isolation; and FIG. 6 is a front view of a fourth icon from the set of graphical user interface icons, shown in isolation; and, FIG. 7 is a front view of a fifth icon from the set of graphical user interface icons, shown in isolation.

The claim is directed to the collective appearance of the set of icons shown in FIG. 1 or 2, but no claim is made to the arrangement or order of the set of graphical user interface icons on the display screen.

The broken lines show the display screen, and form no part of the claimed design.

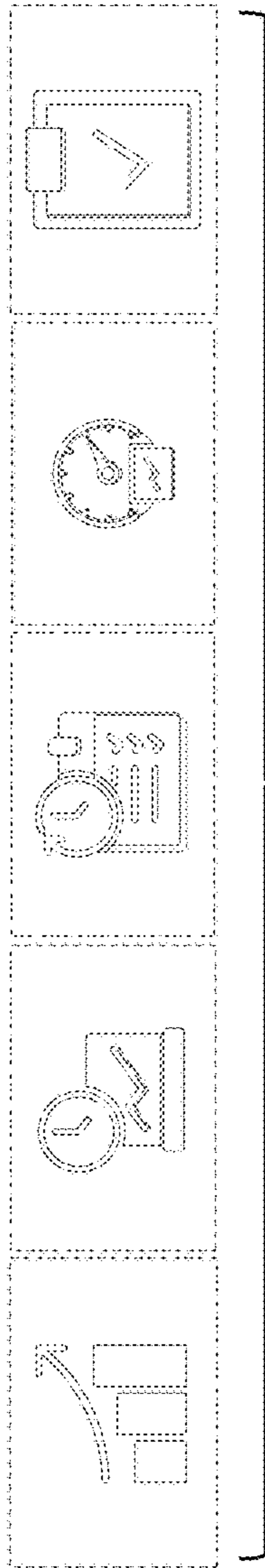

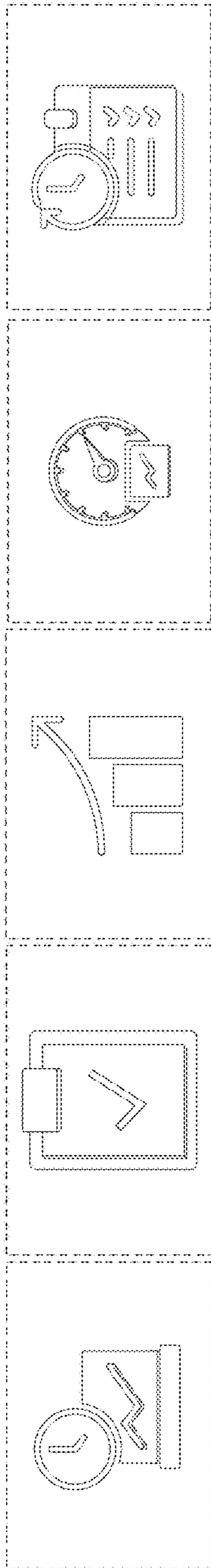

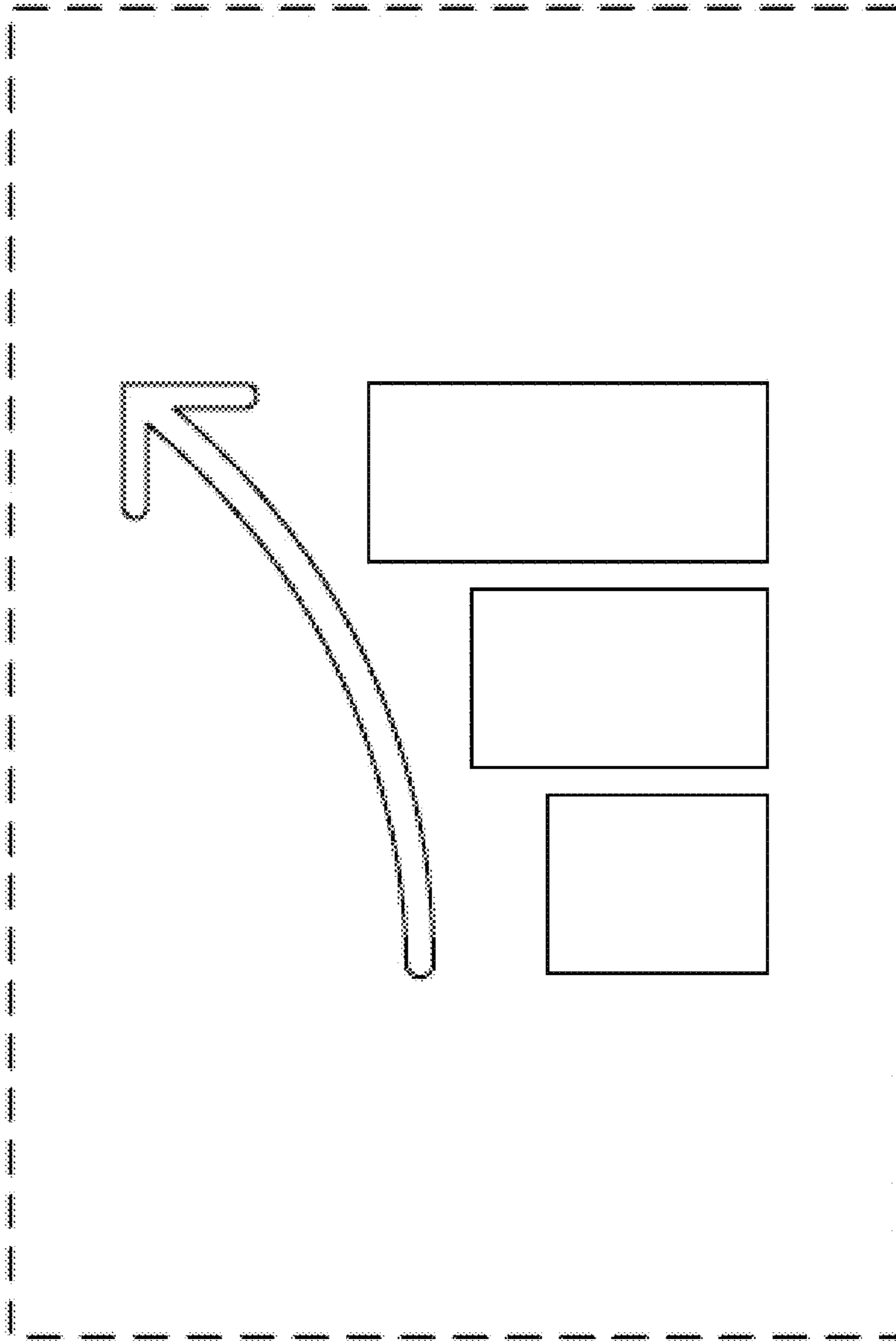

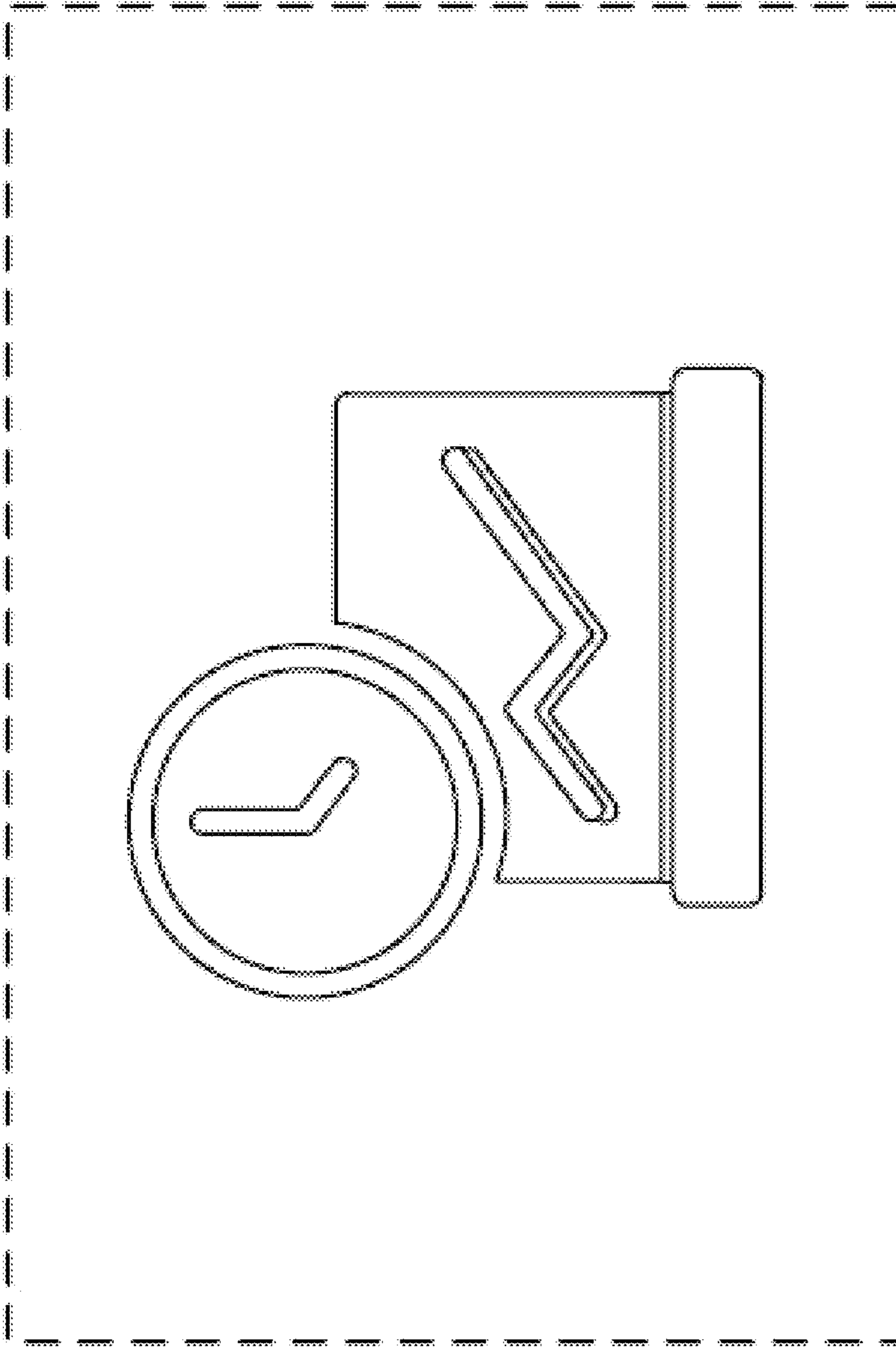

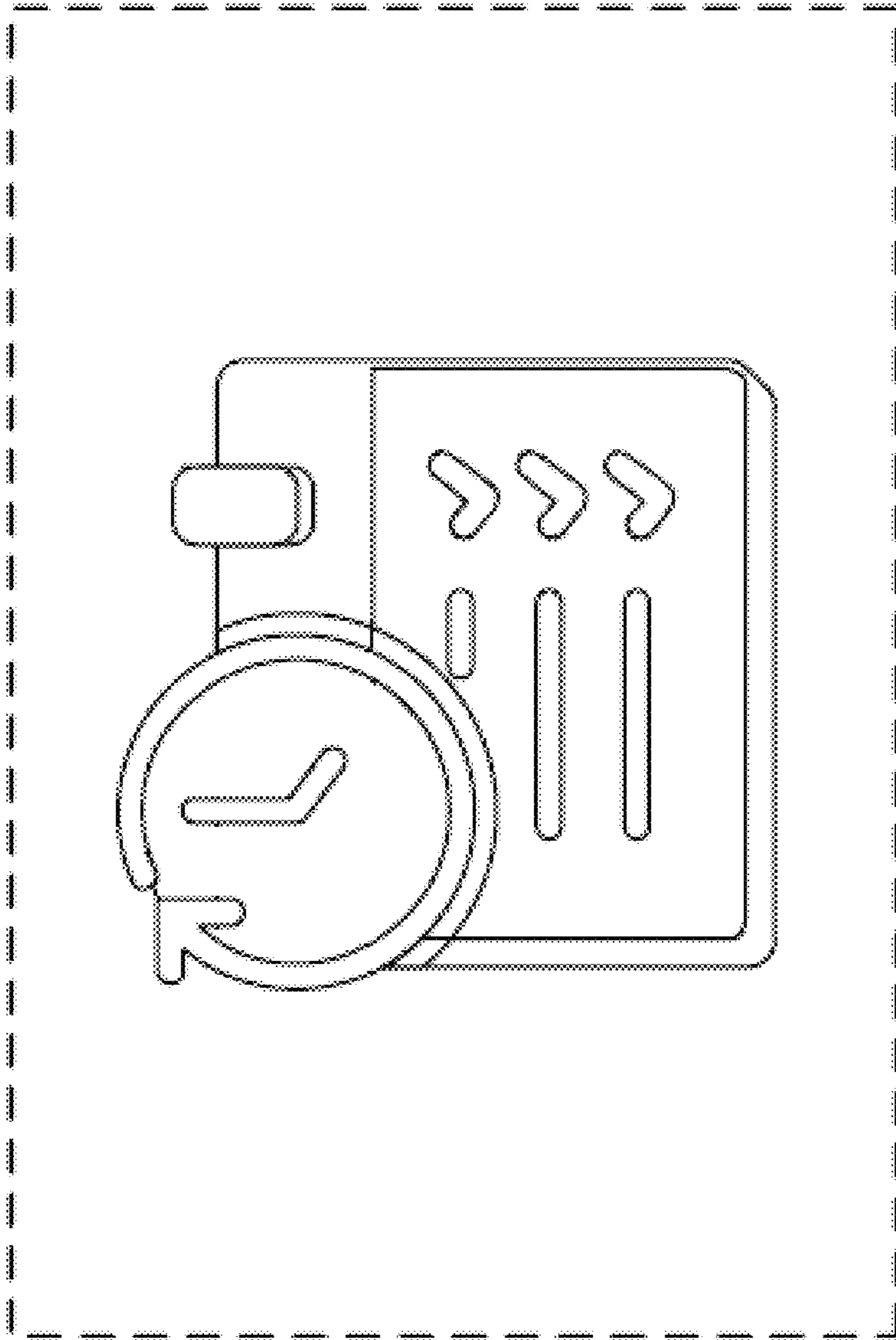

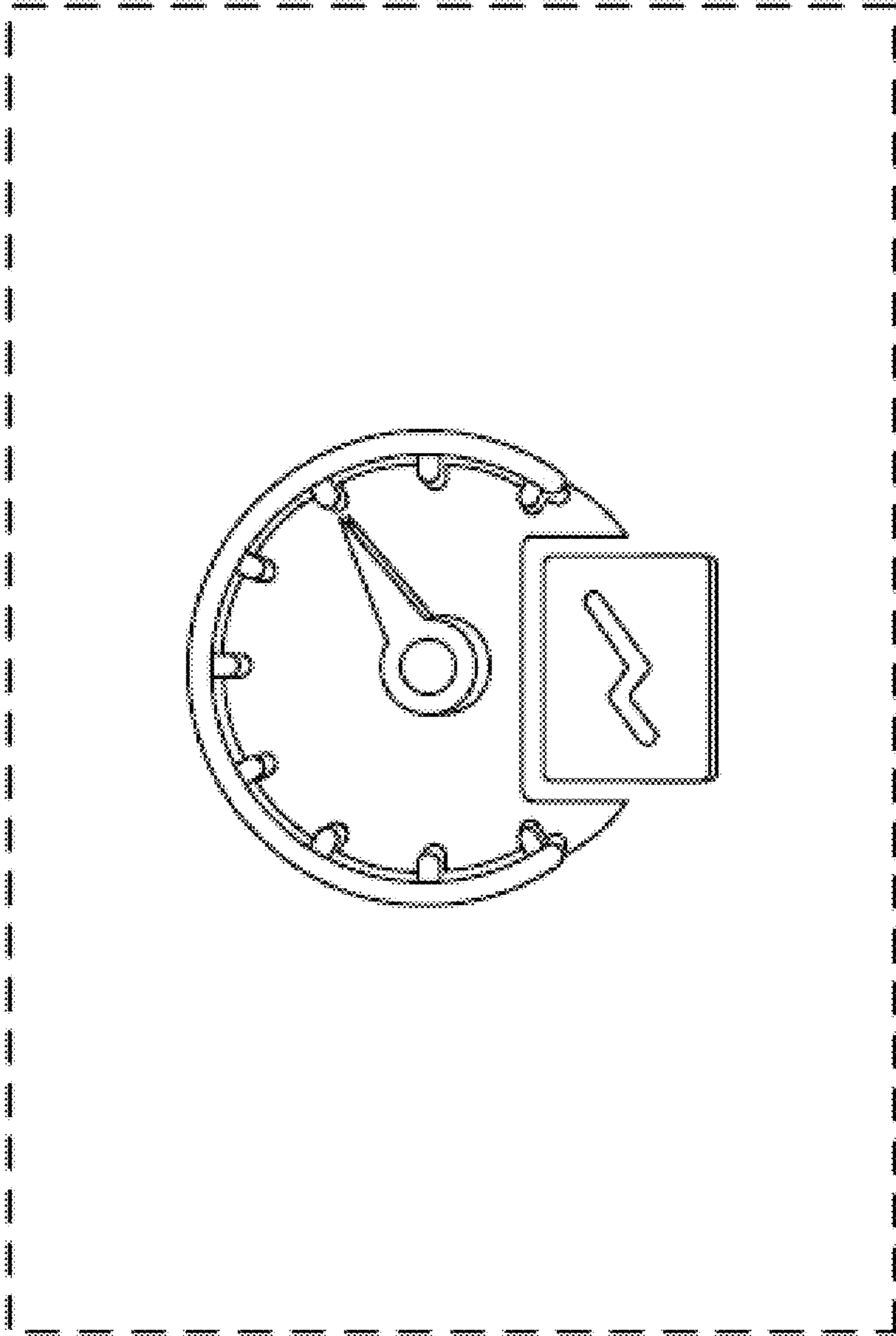

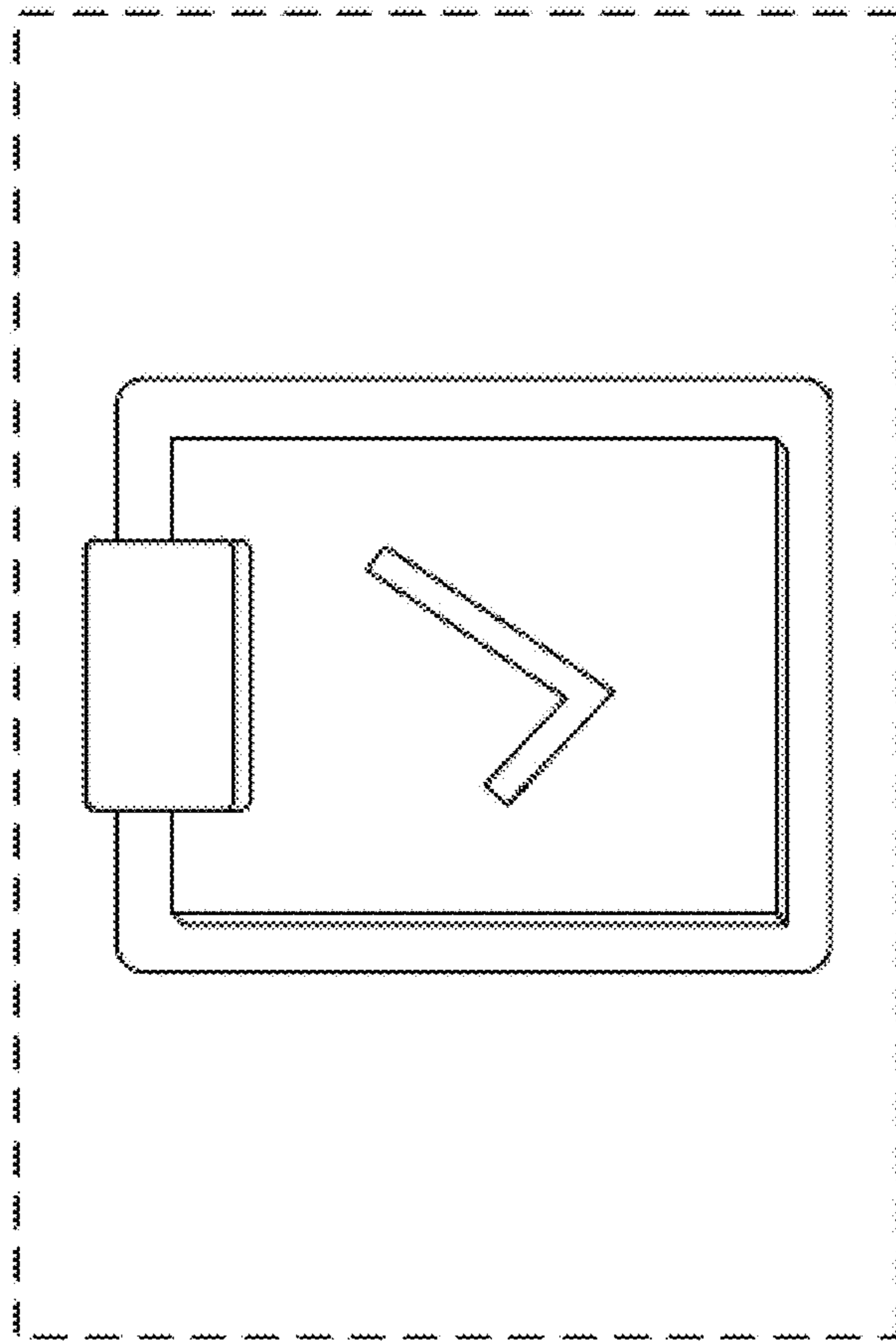
